The rear view is the same as the front view after being rotated 180 degrees clockwise, so the rear view is omitted; the right view is symmetrical to the left view, so the right view is omitted; the top and bottom views are the same as the front view, so the top and bottom views are omitted. The red box with the indication "A" shown in reproduction 1.1 is an enlarged view of the tire shown in reproduction 1.4.
