(57) **CLAIM**

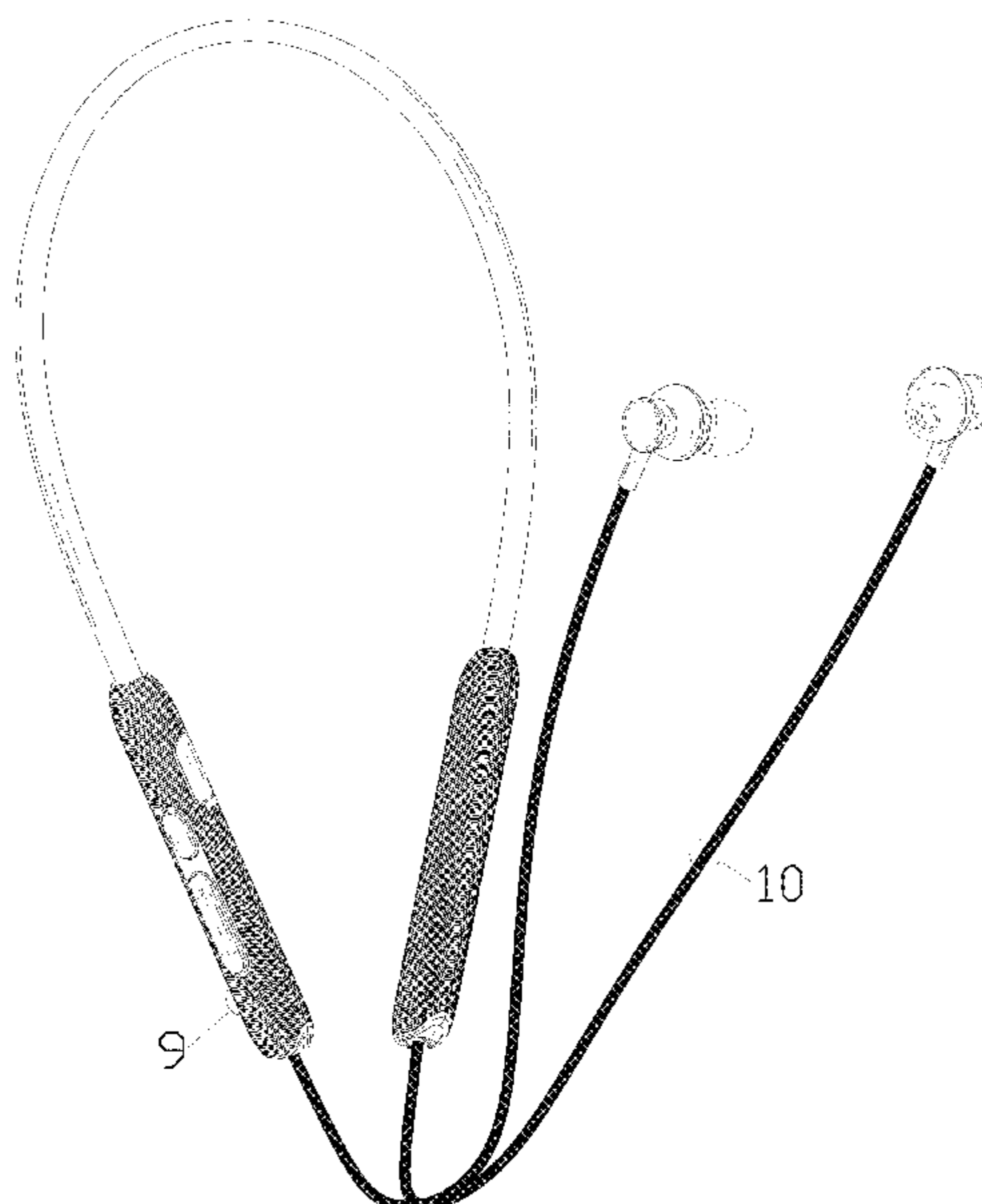
The ornamental design for neckband headphones, as shown and described.

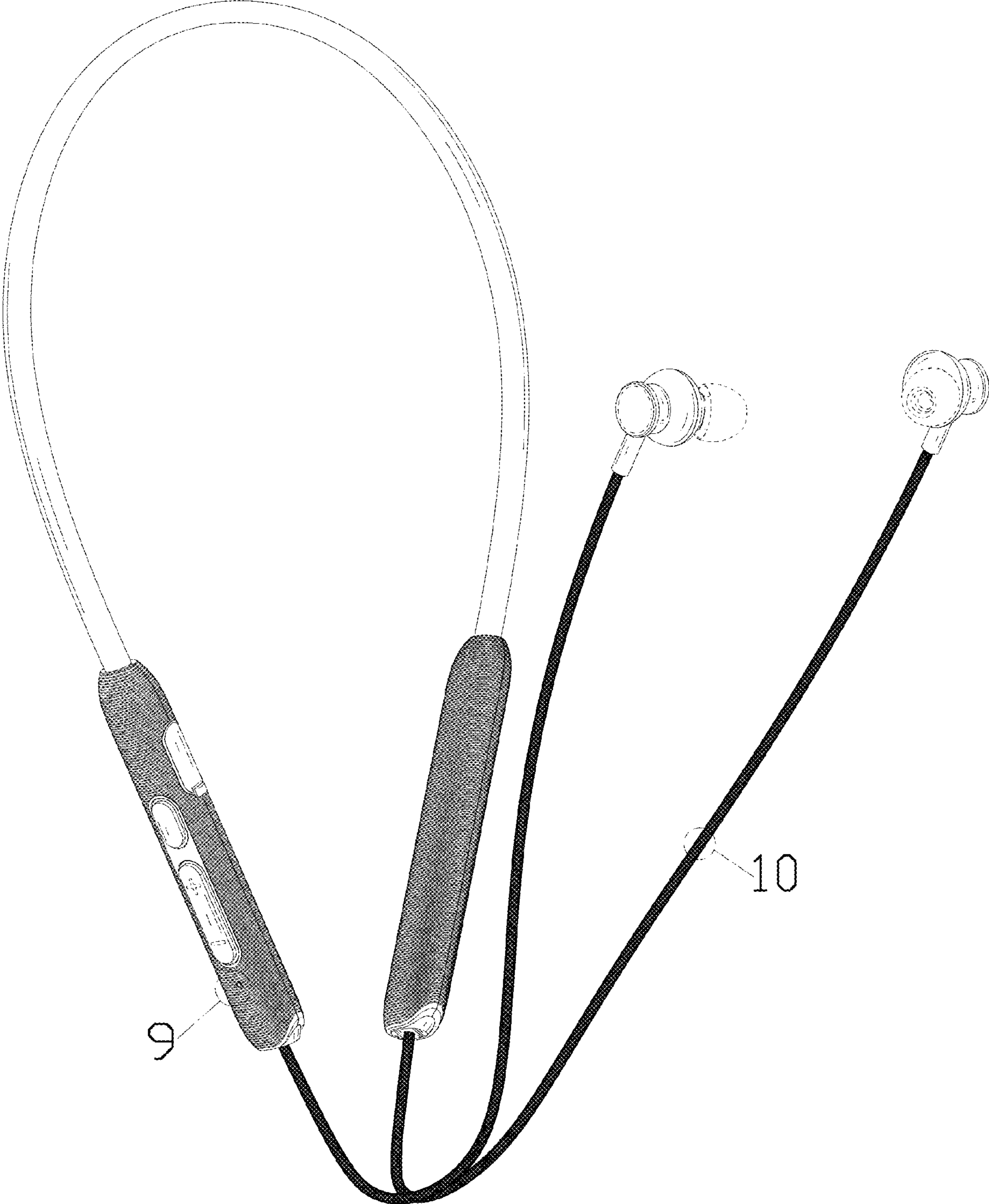

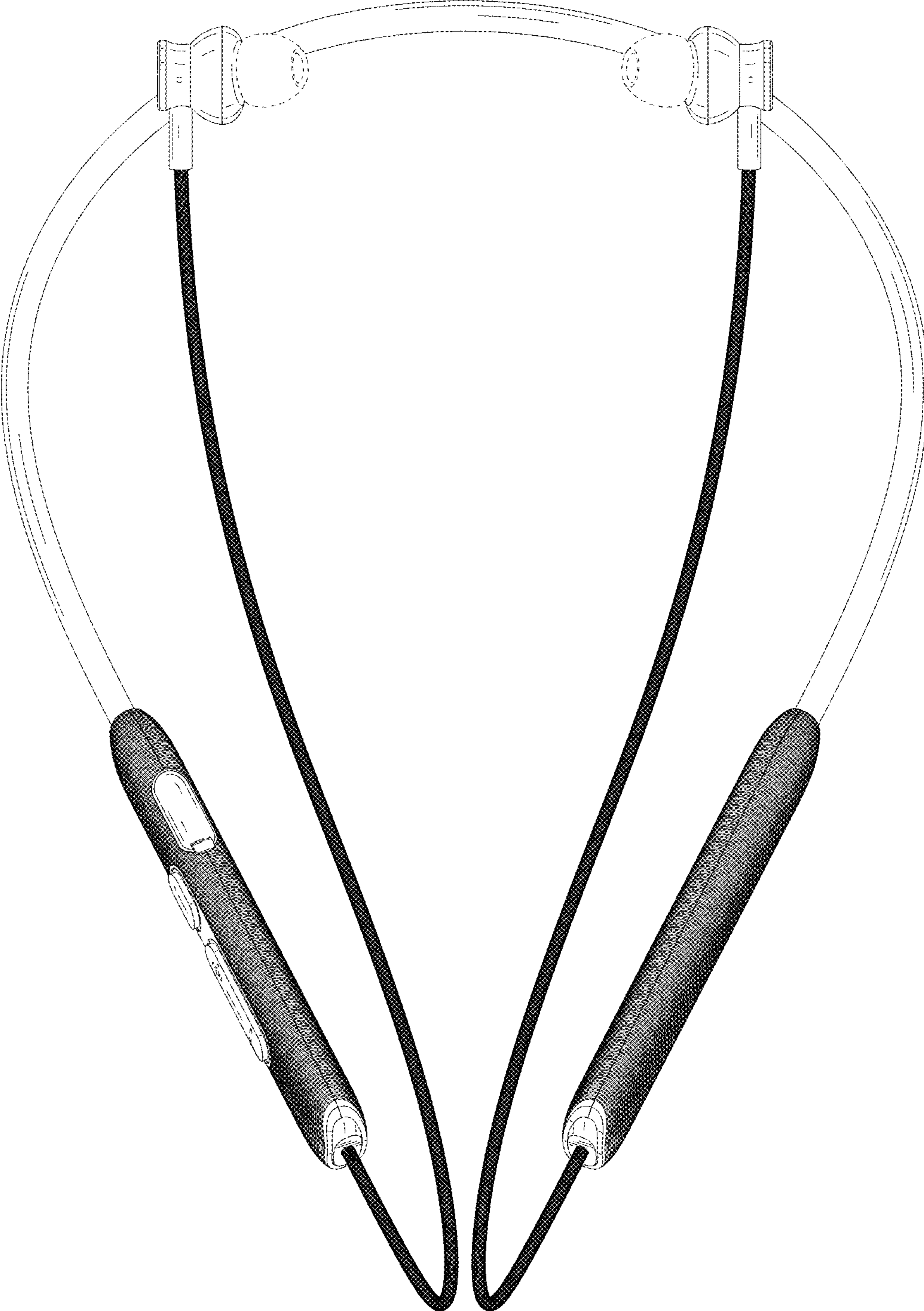

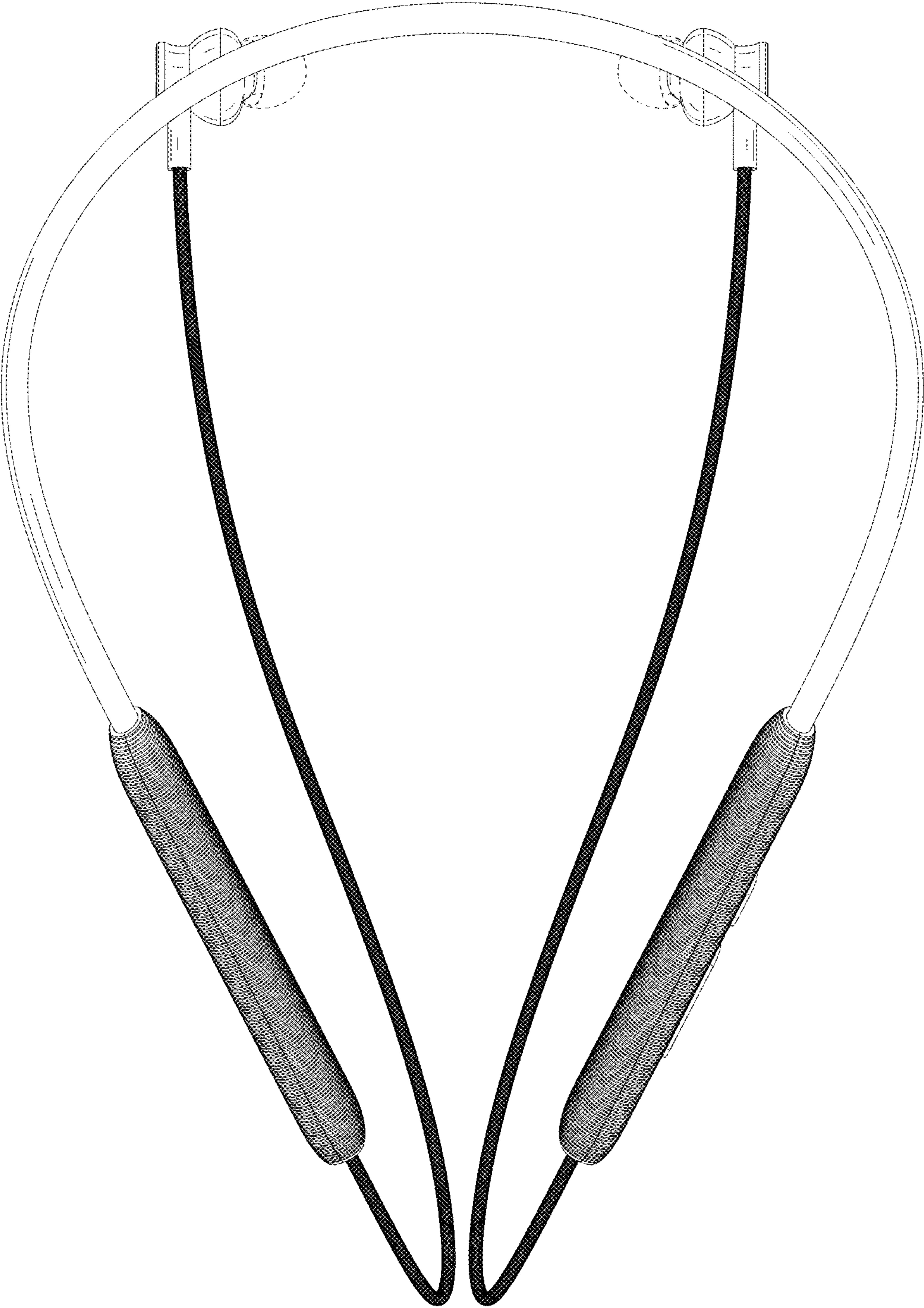

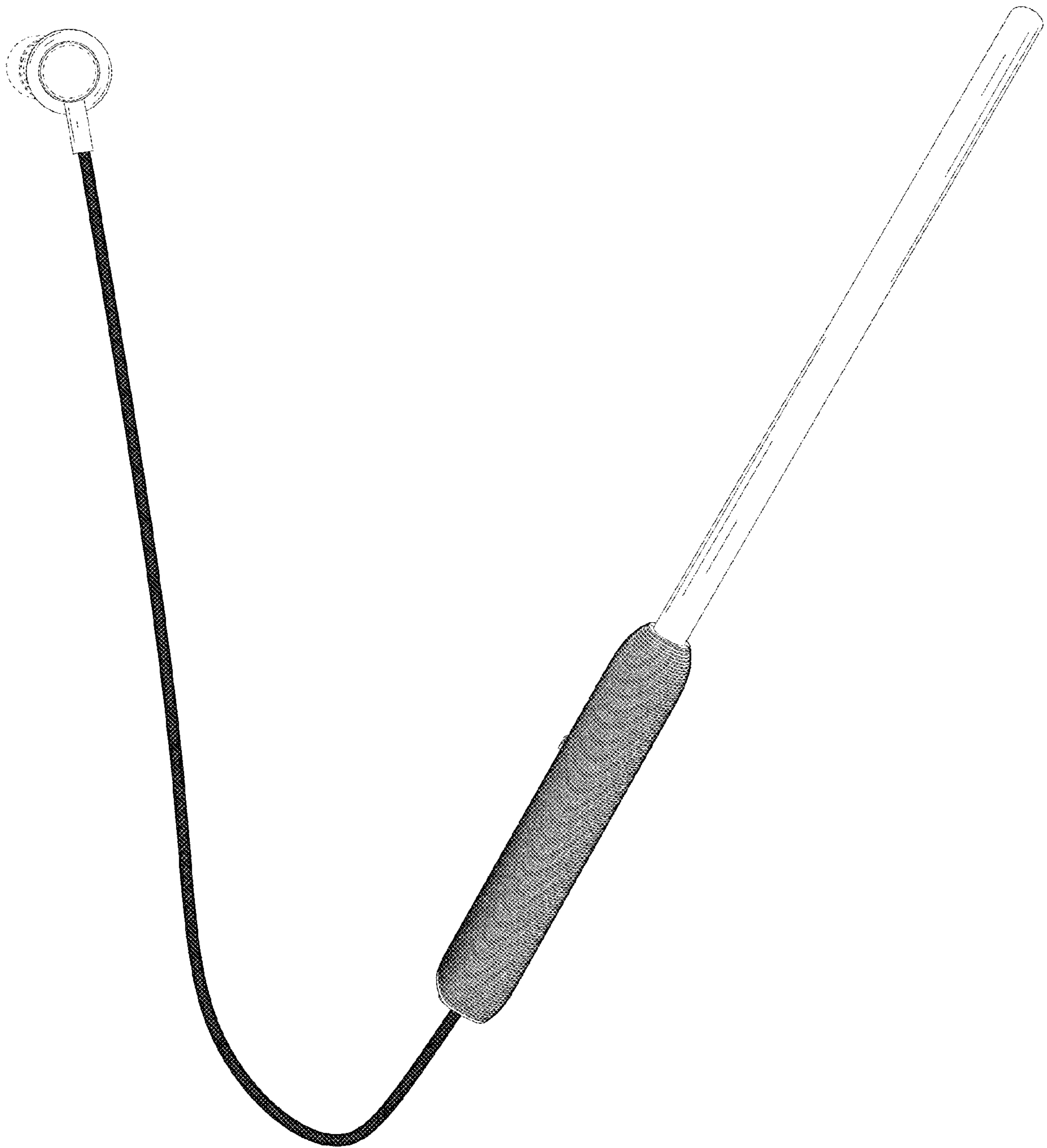

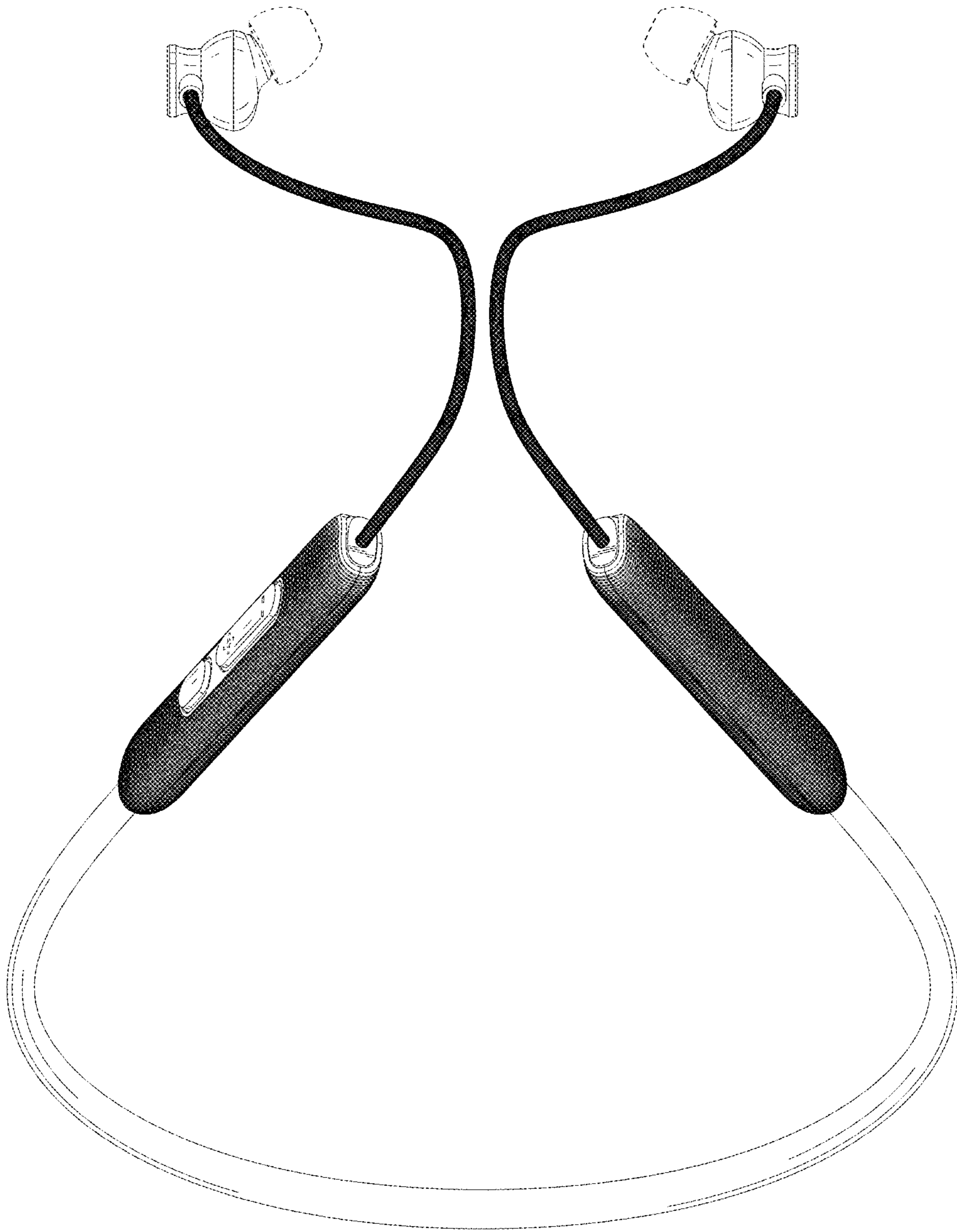

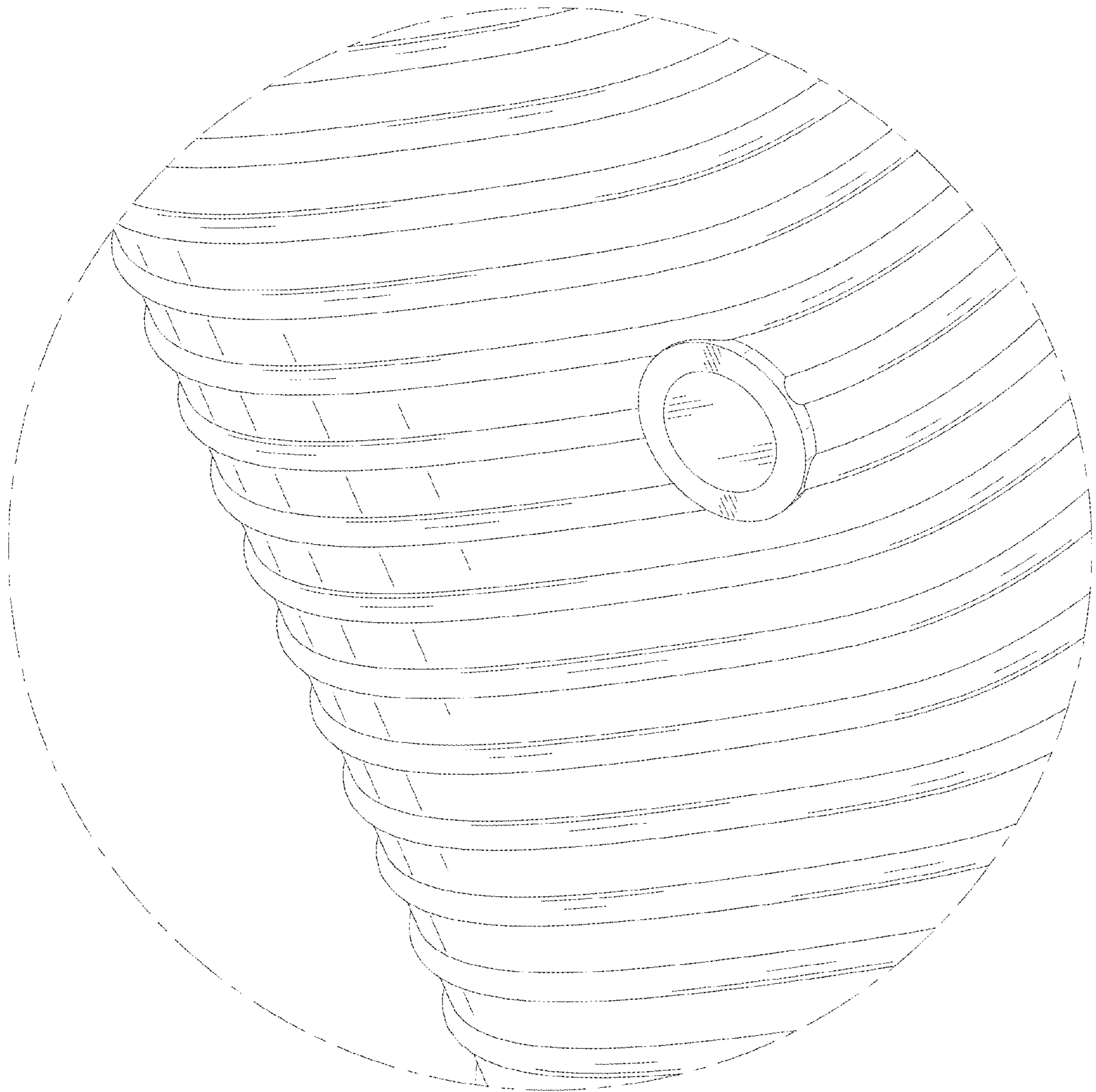

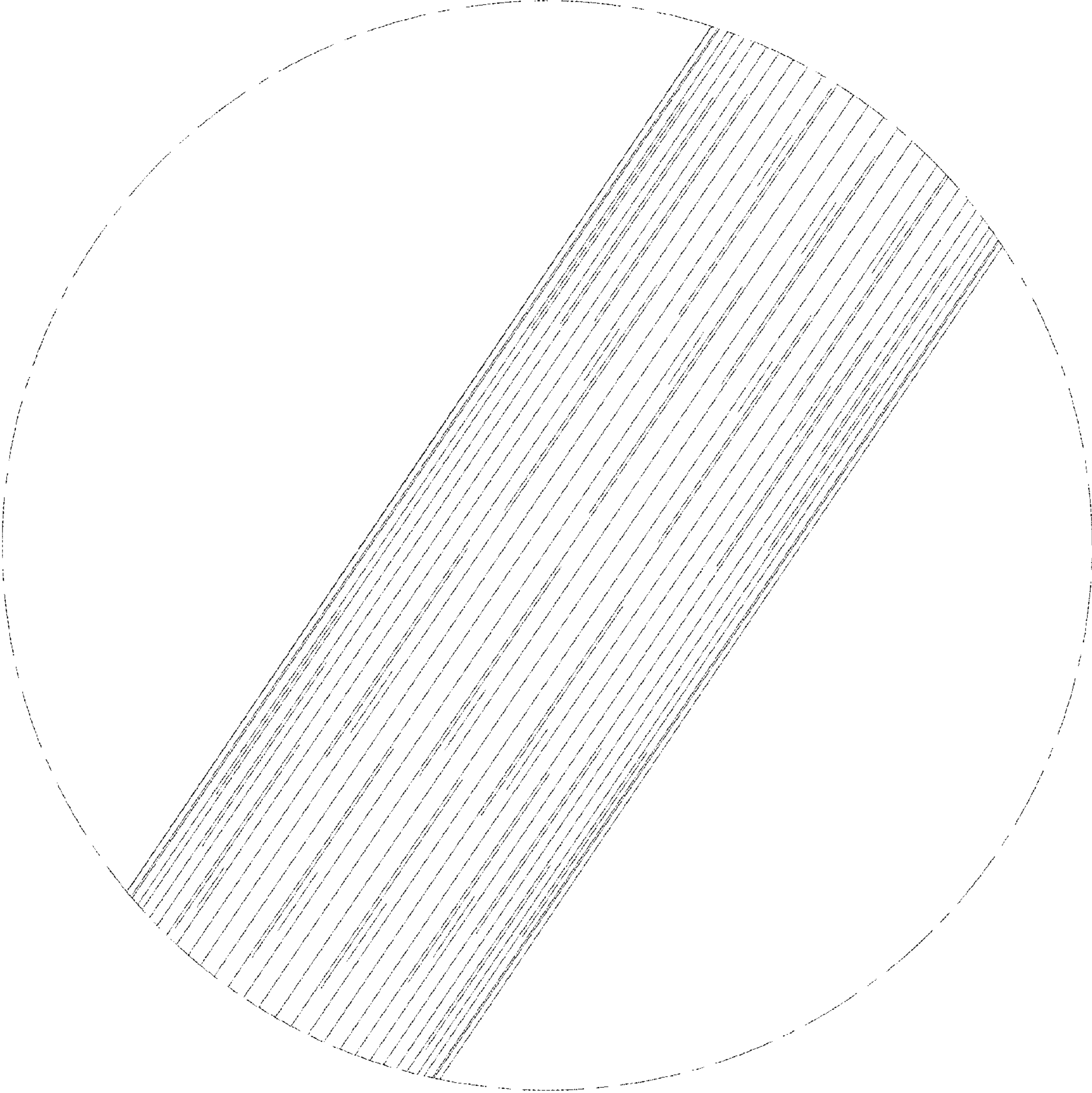
