(57) **CLAIM**

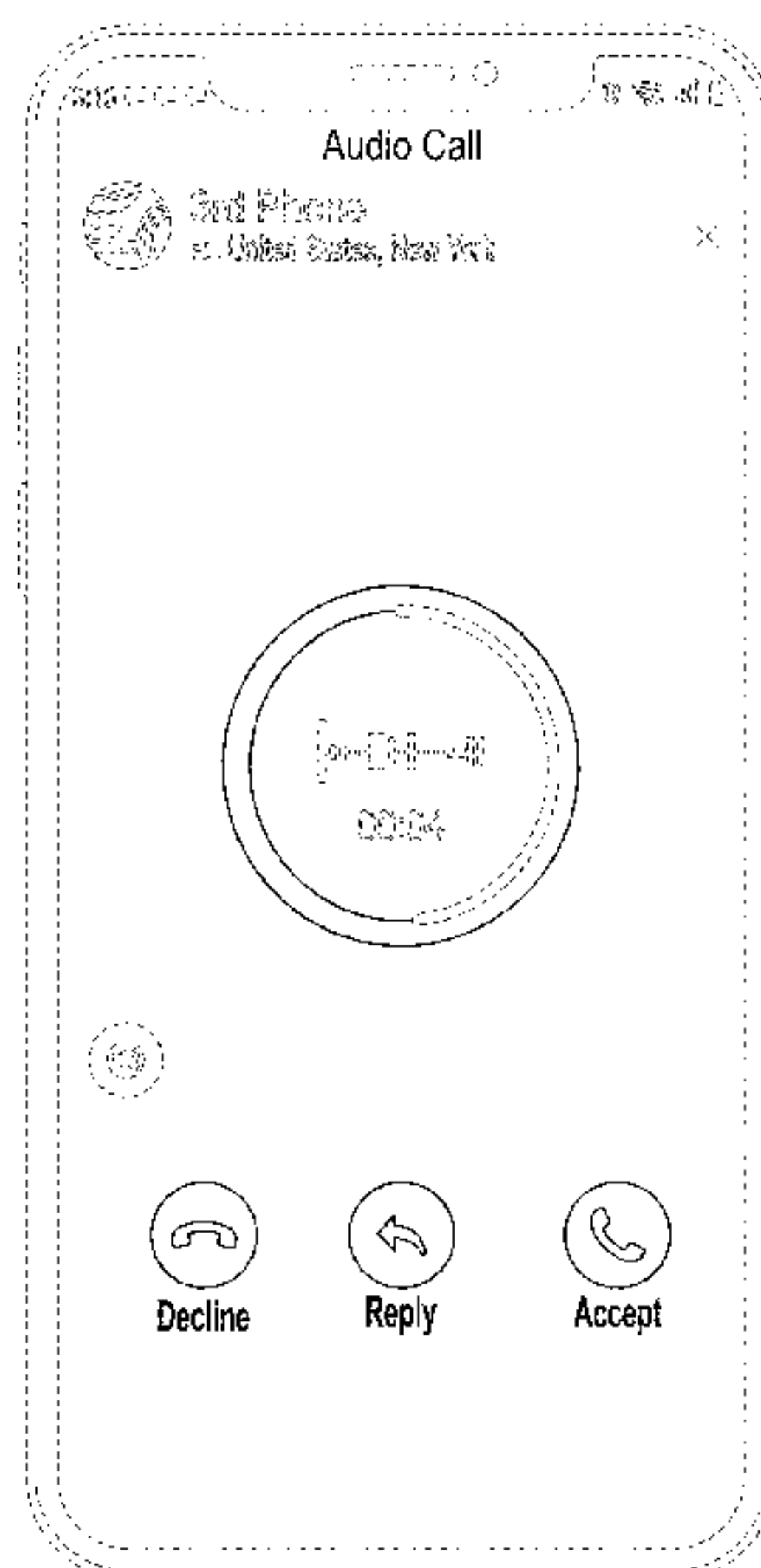
The ornamental design for a smartphone display with personalized audio invitation graphical user interface, as shown and described.
