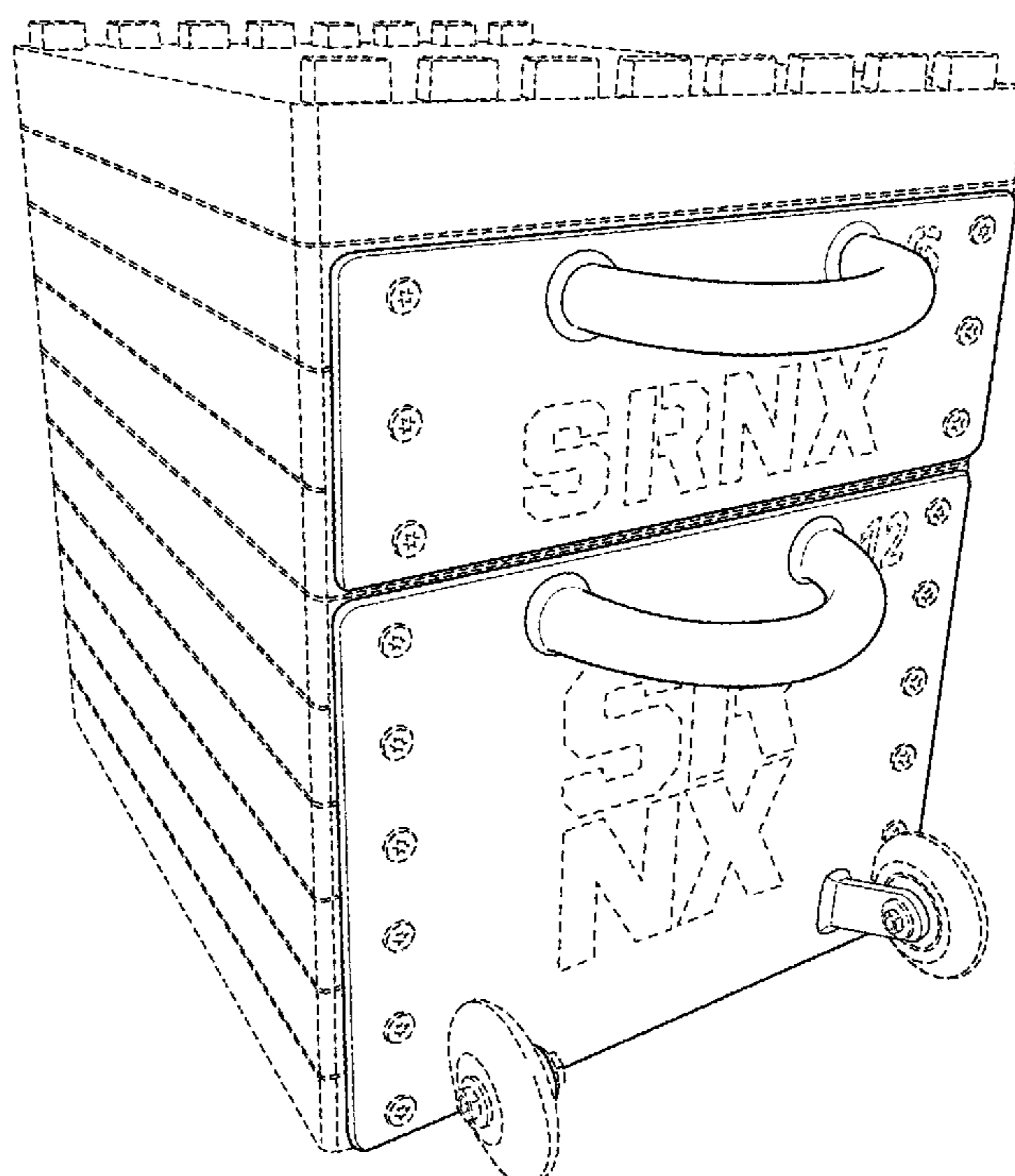
(57) **CLAIM**

The ornamental design for a block plate apparatus system, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a block plate apparatus system including short and tall block plate apparatuses attached to blocks shown for context; FIG. 2 is a front view of a short block plate apparatus; FIG. 3 is a back view of a short block plate apparatus; FIG. 4 is a left-side view of a short block plate apparatus, the right-side view is a mirror image thereof; FIG. 5 is a top view of a short block plate apparatus, the bottom view is a mirror image thereof; FIG. 6 is a front view of a tall block plate apparatus; FIG. 7 is a back view of a tall block plate apparatus; FIG. 8 is a left-side view of a tall block plate apparatus, the right-side view is a mirror image thereof; and, FIG. 9 is a top view of a tall block plate apparatus, the bottom view is a mirror image thereof. The broken line showing of portions of the block plate apparatus system forms no part of the claim.

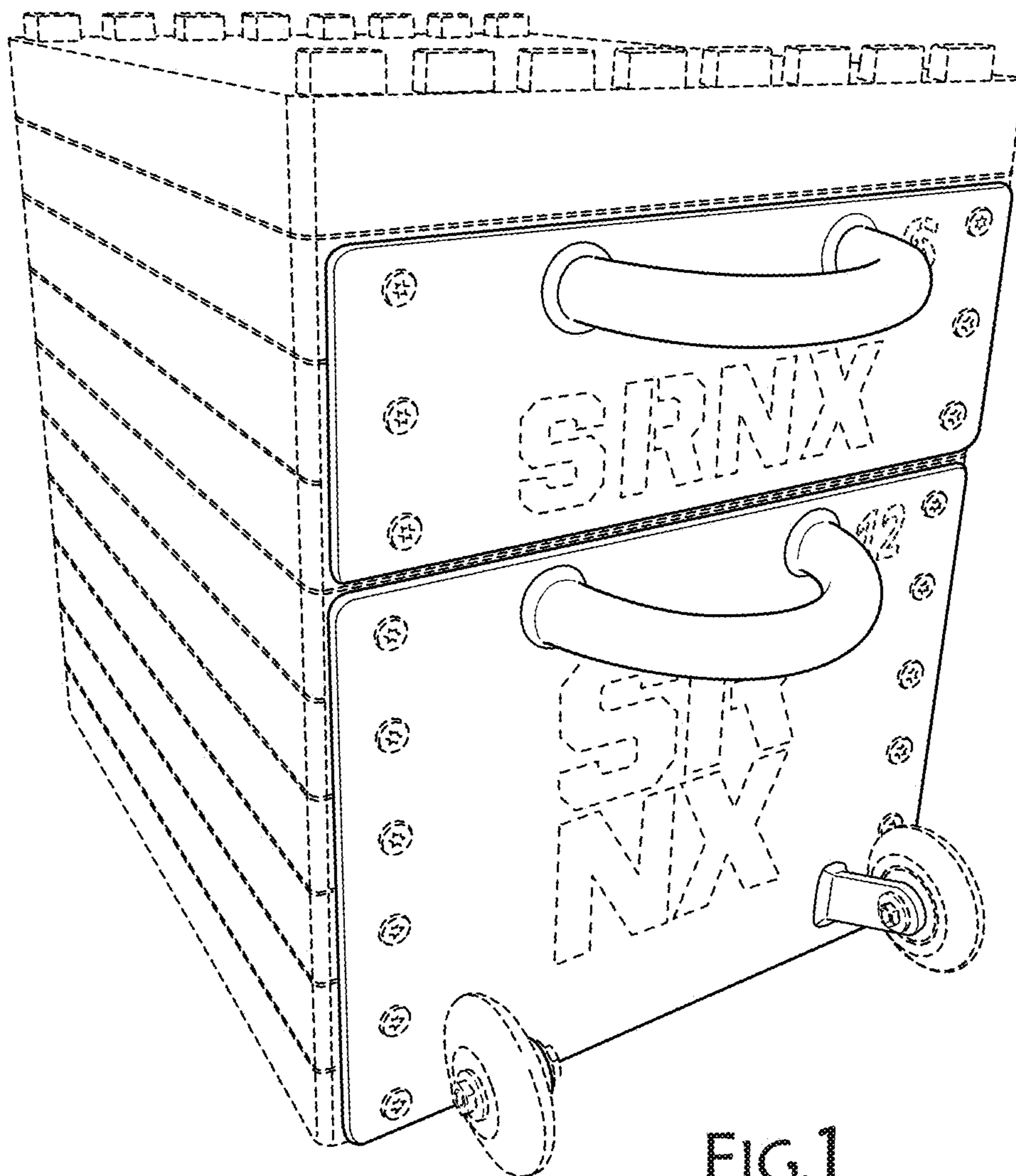

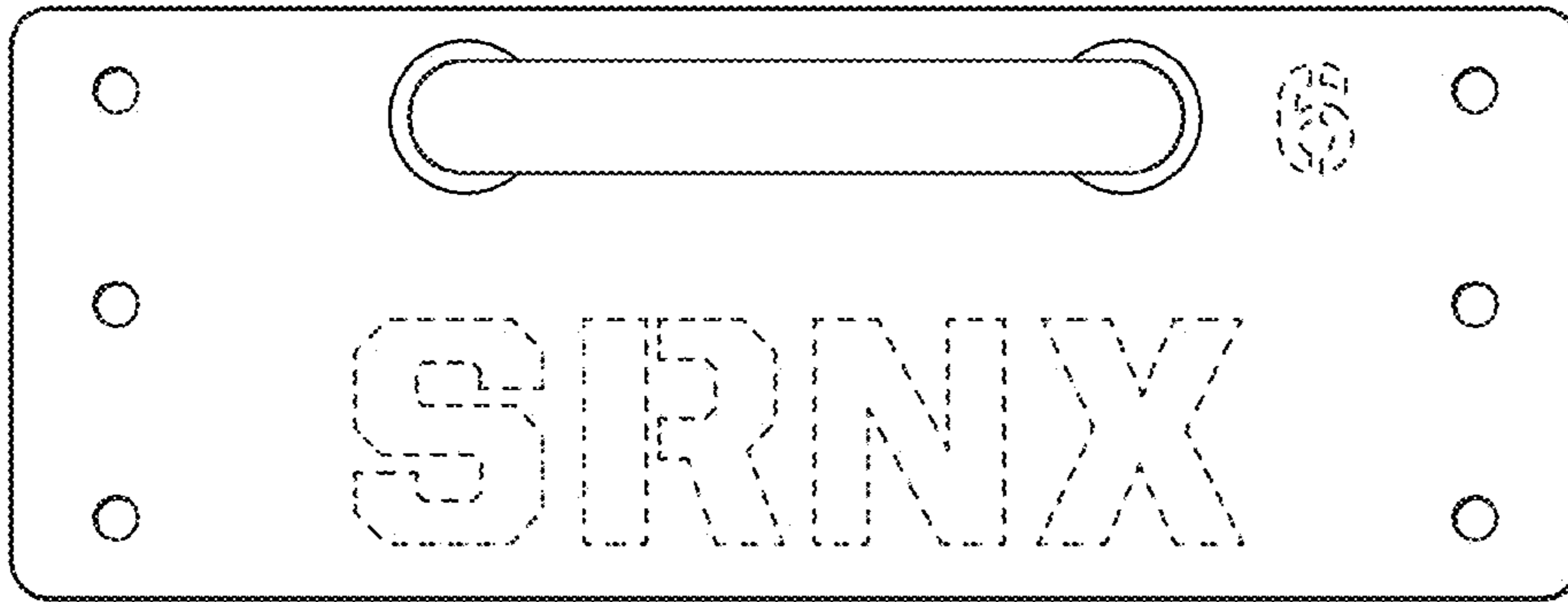

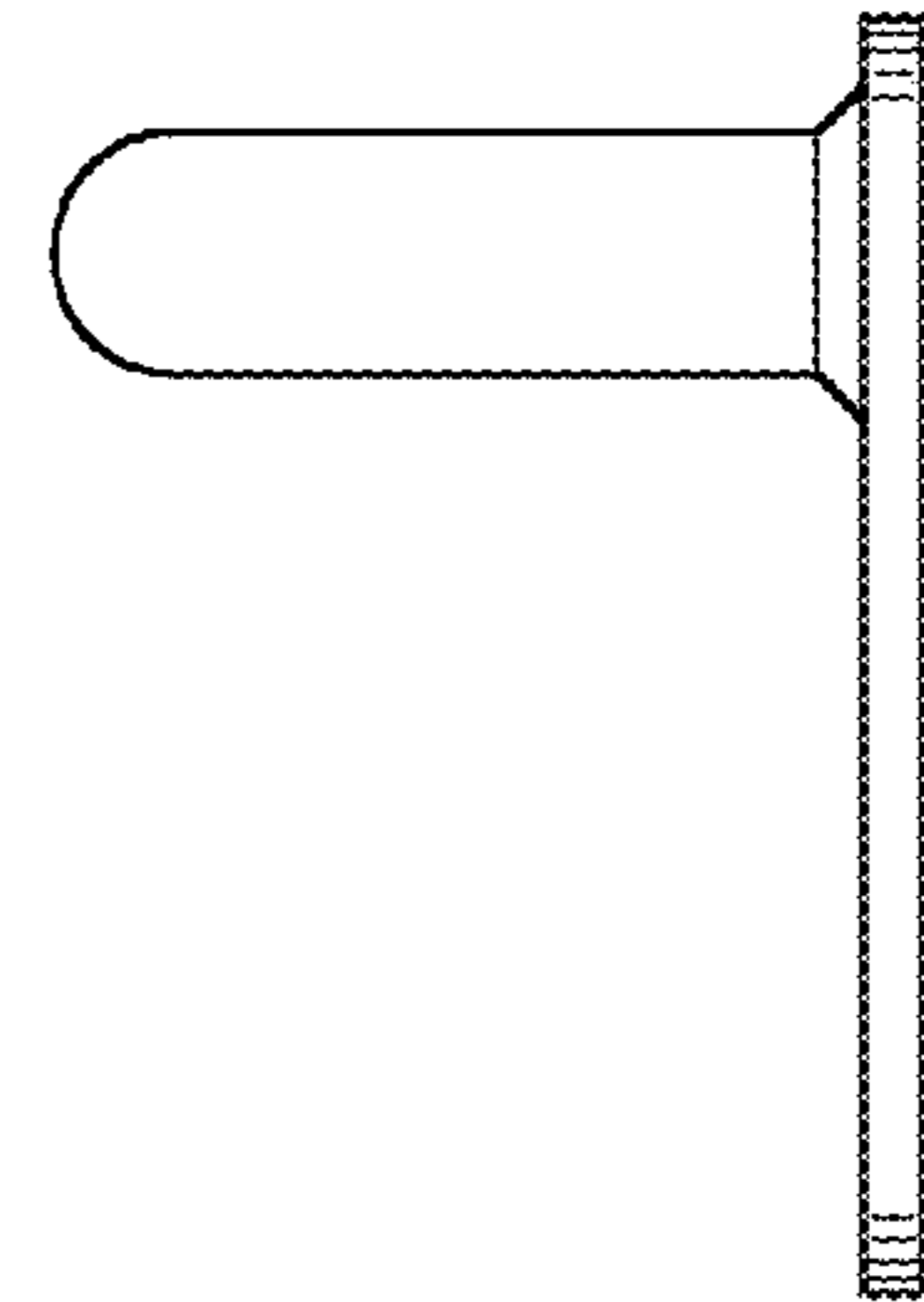

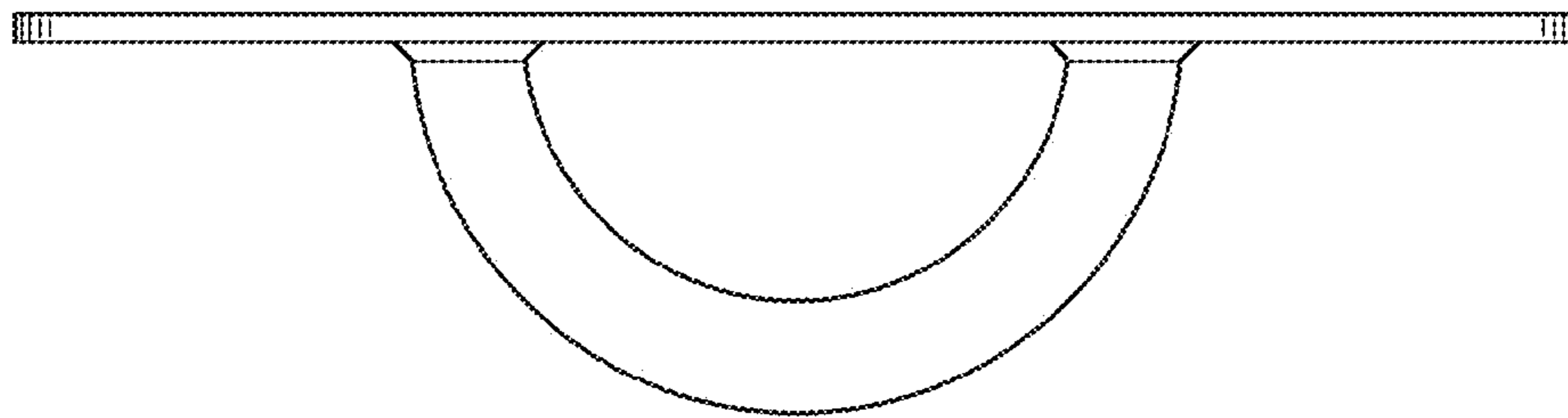

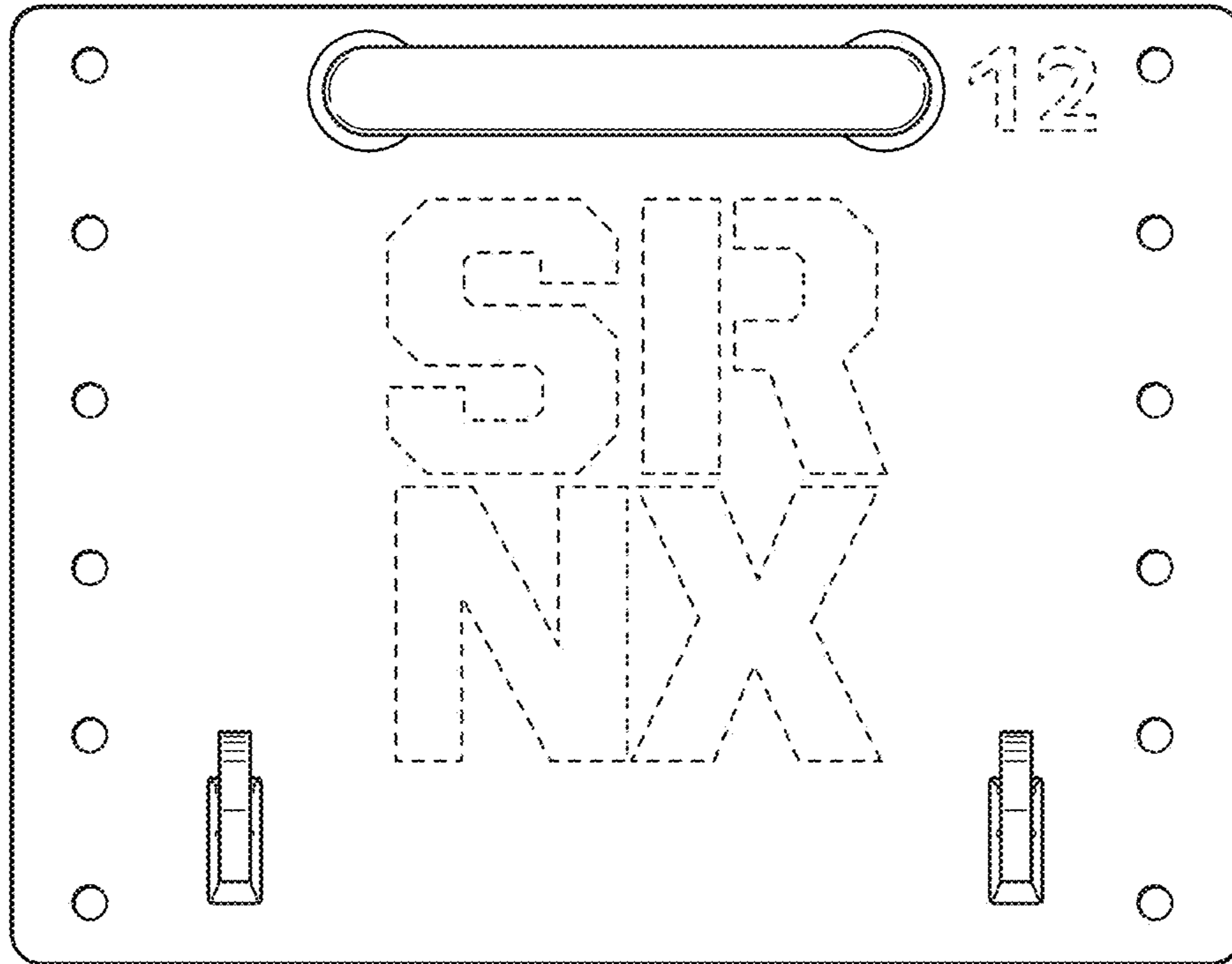

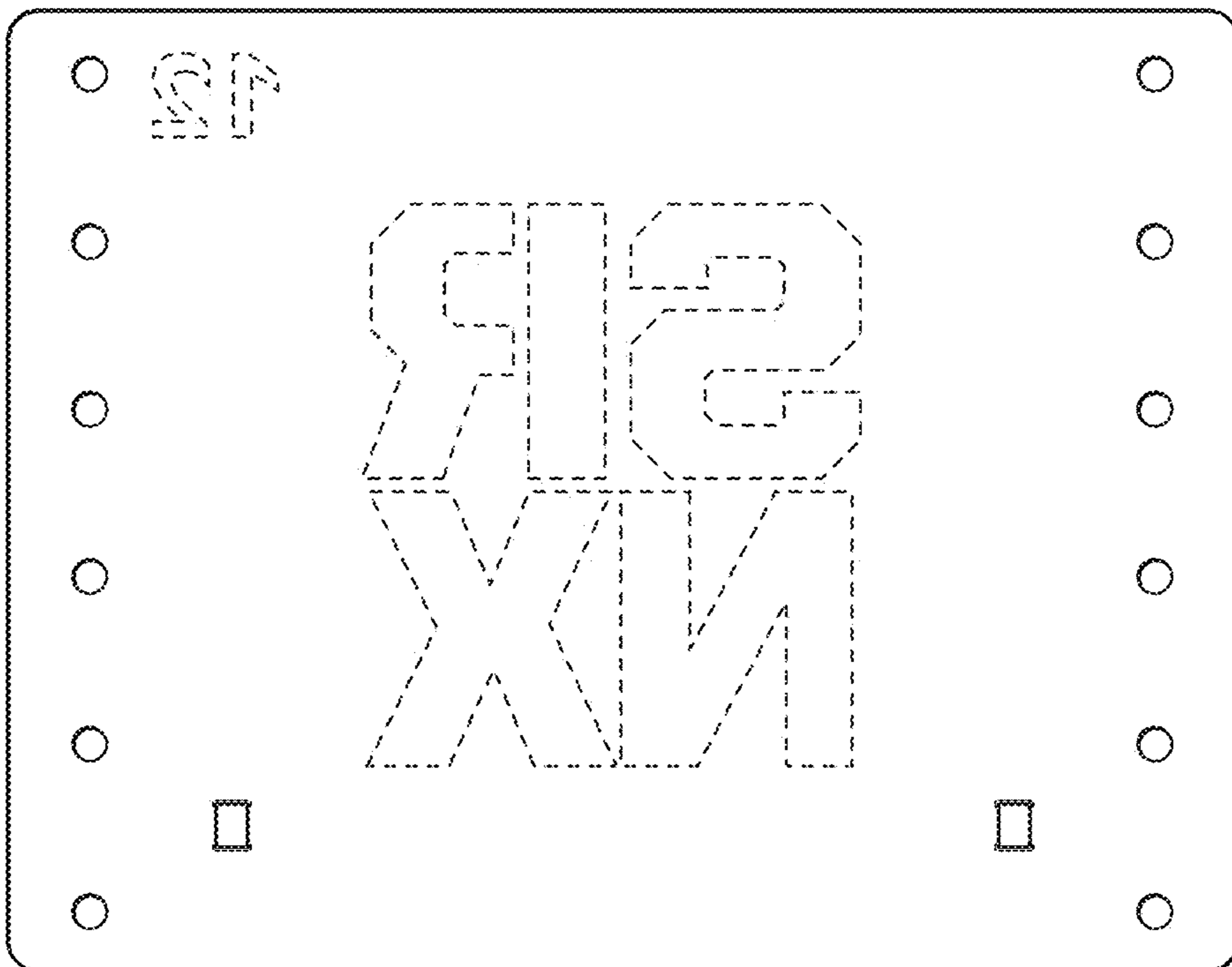

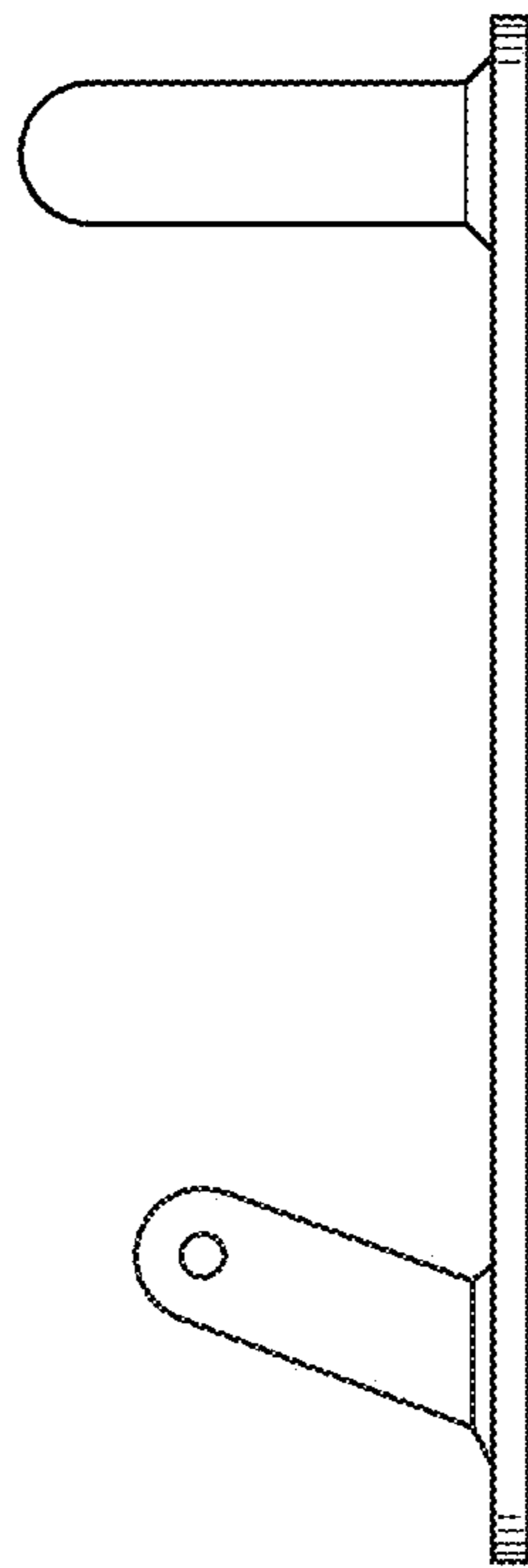
