FIG. 1.12 is a bottom view thereof;

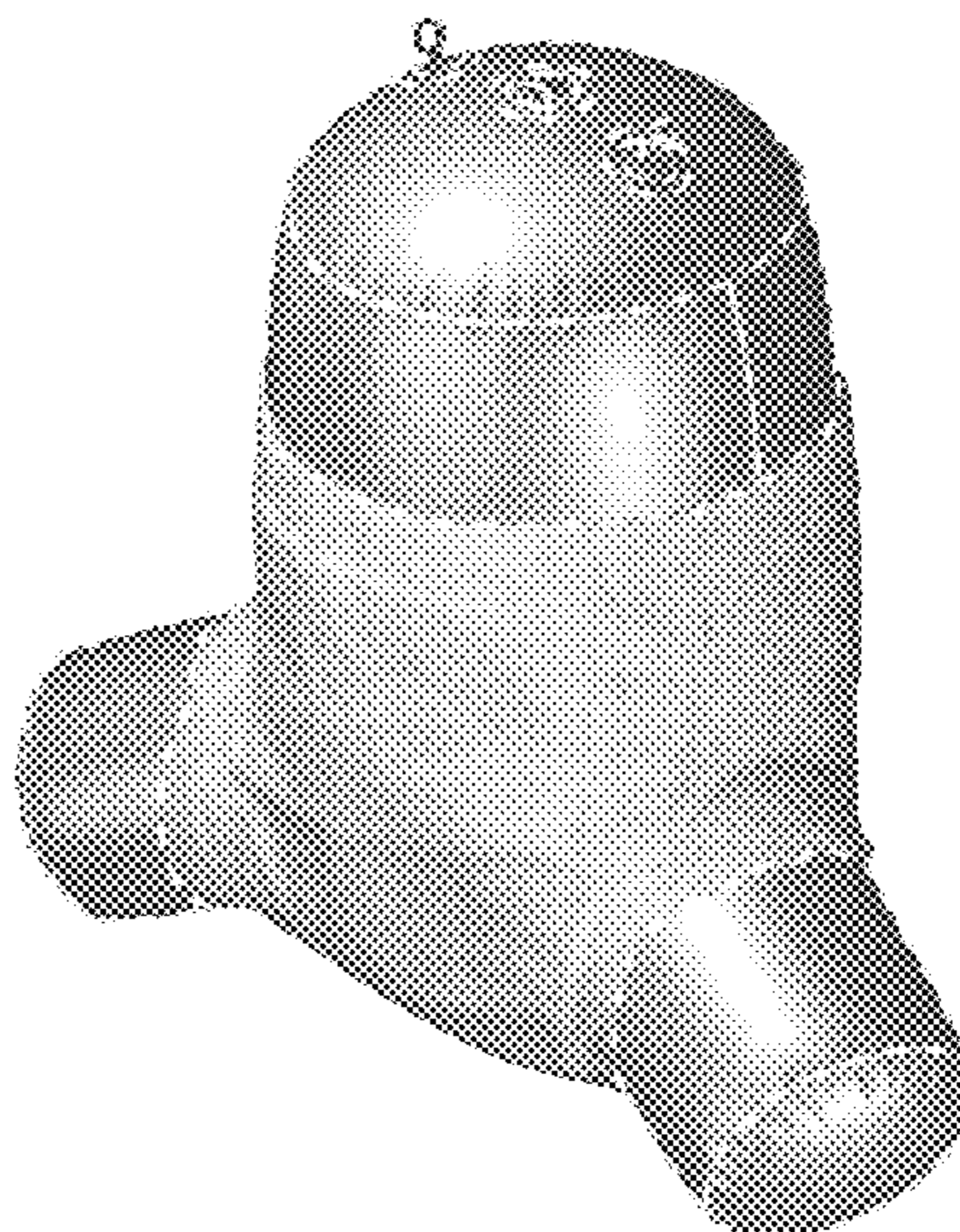
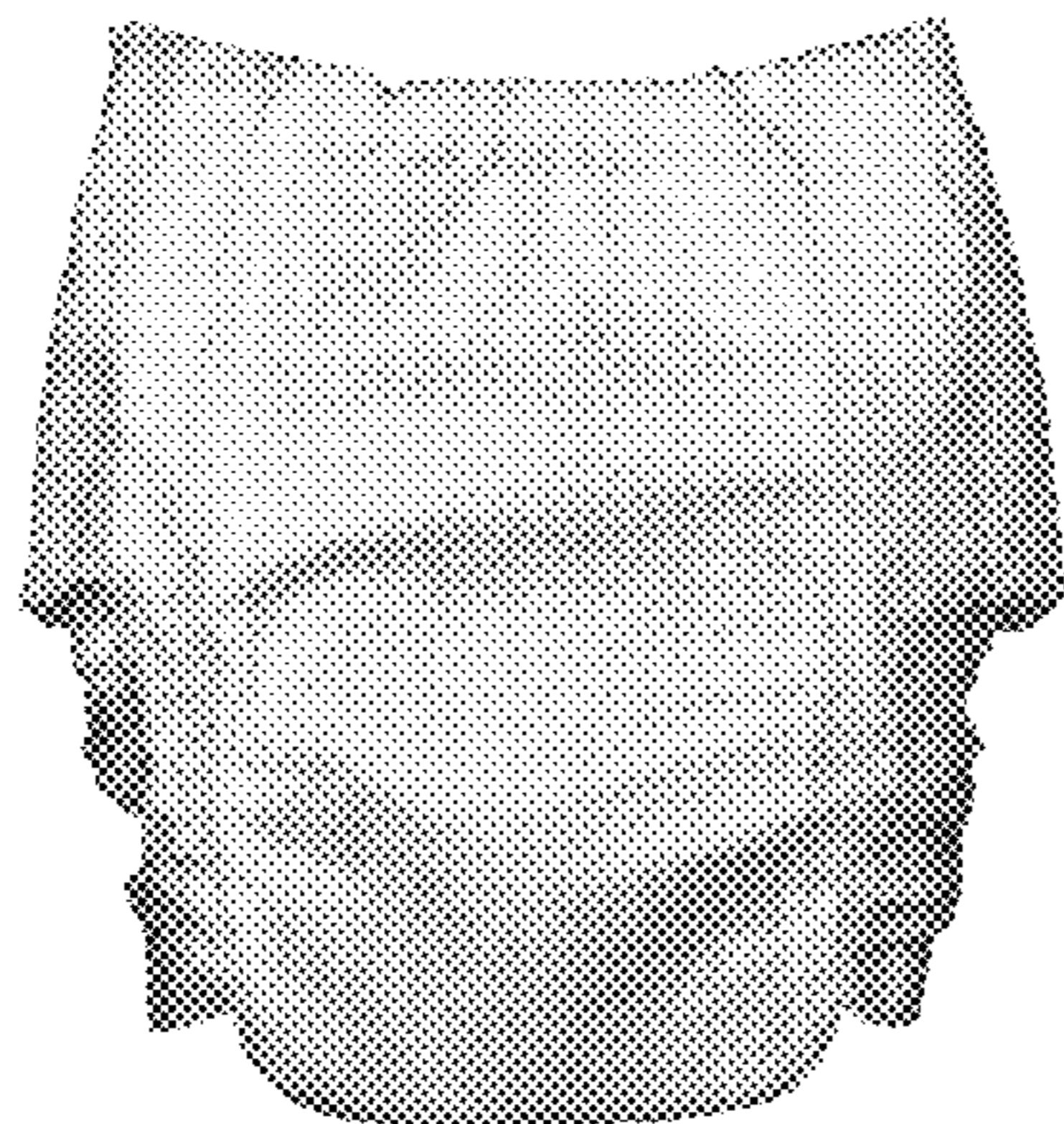

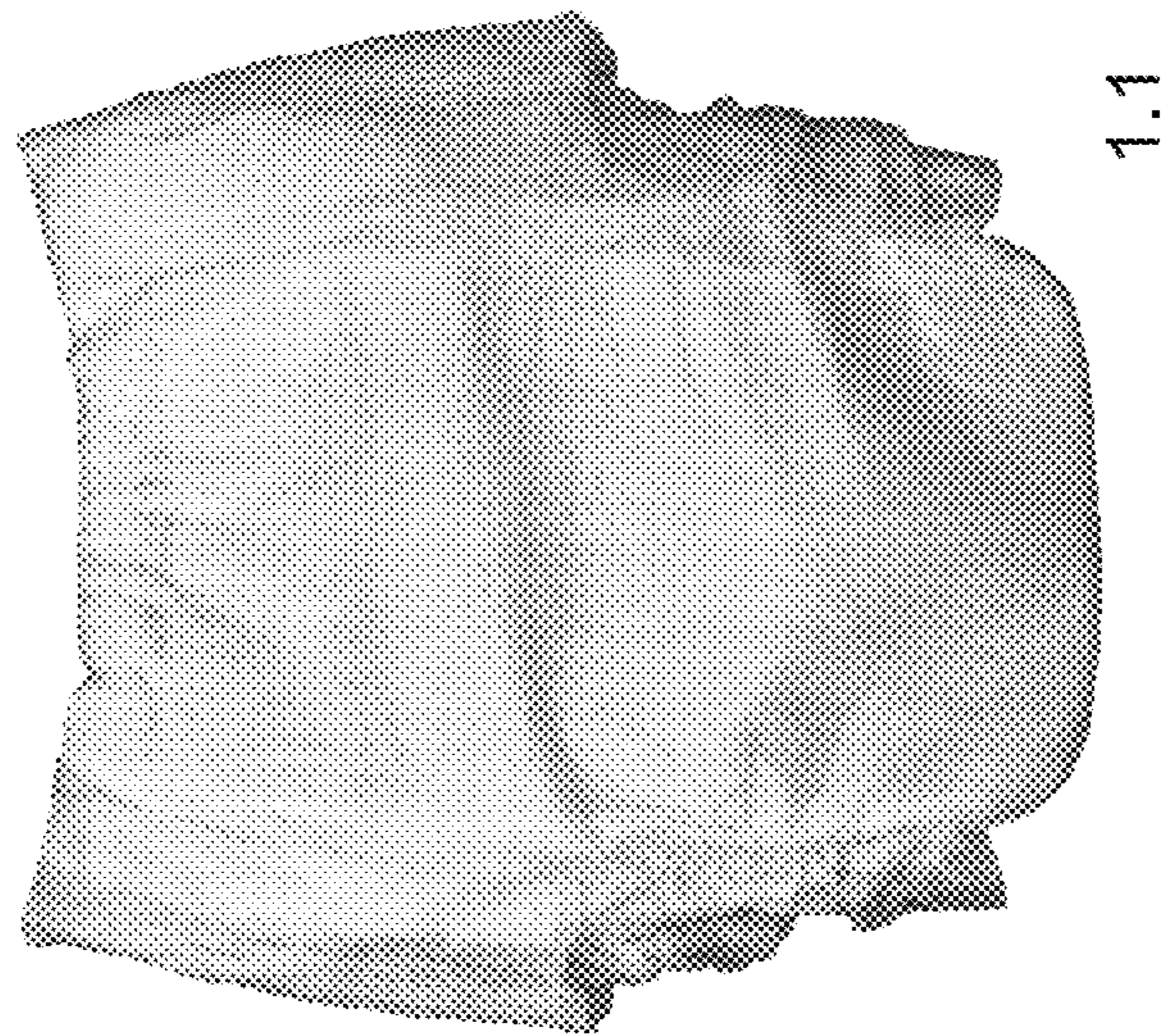

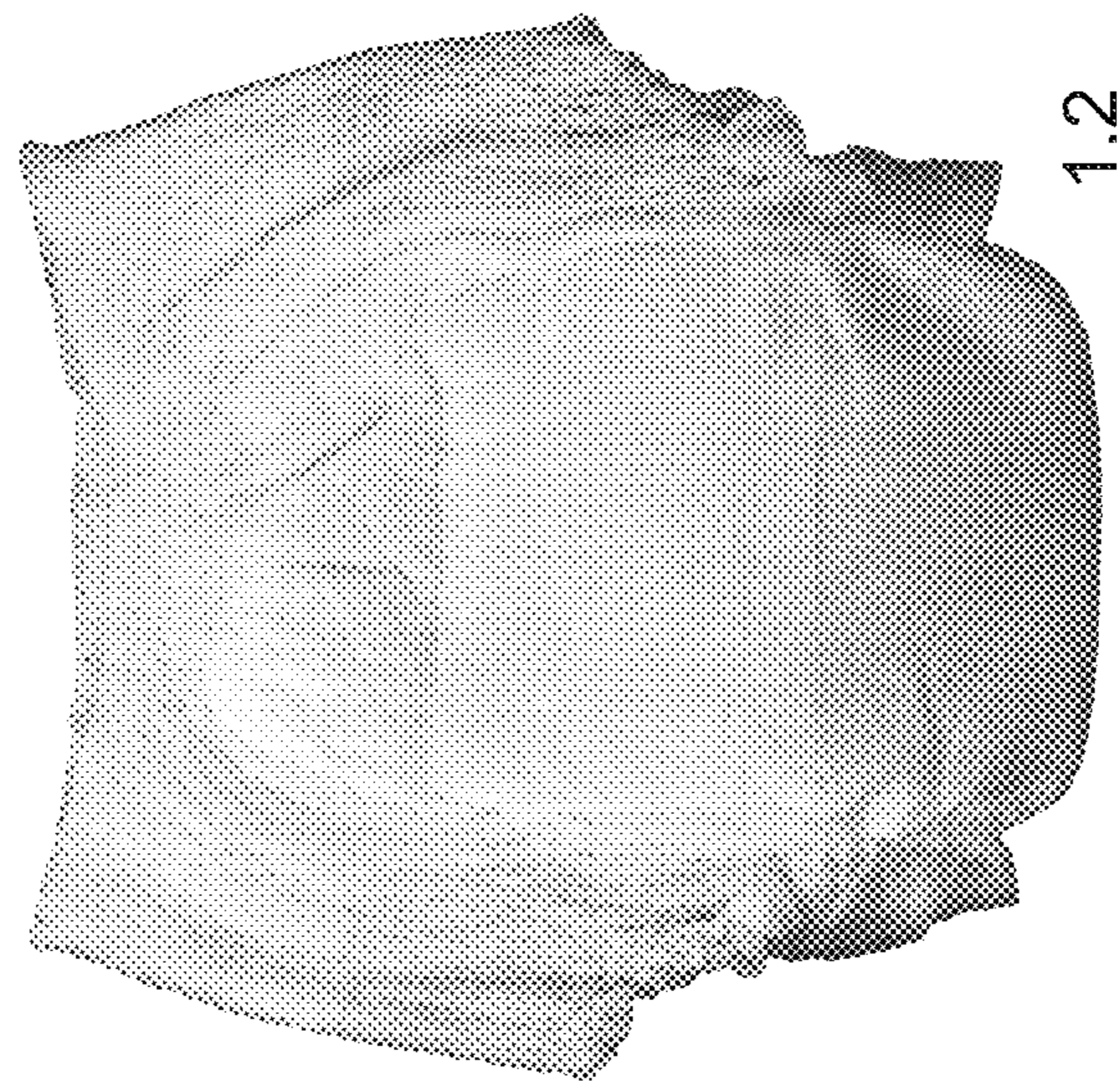

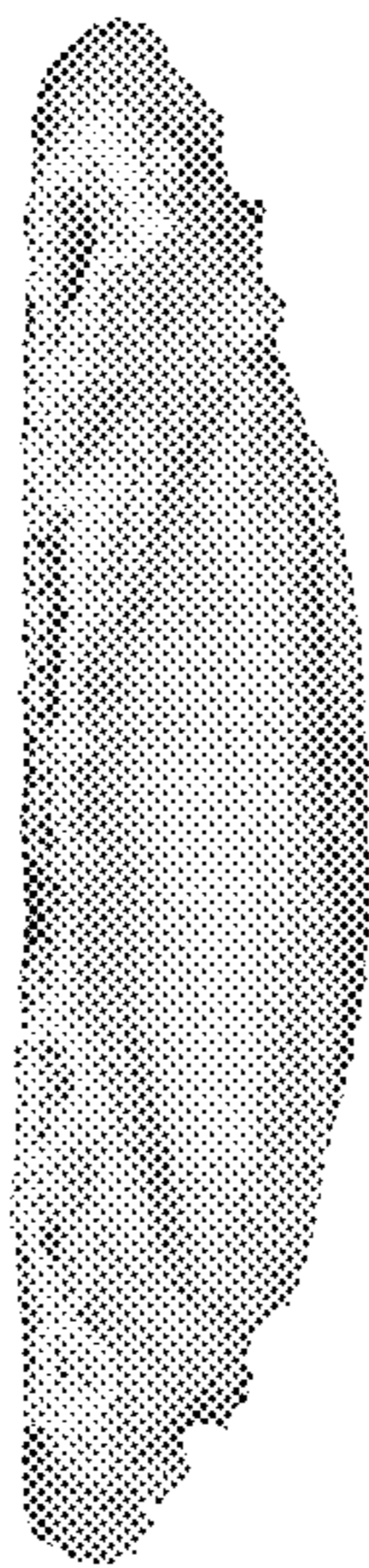

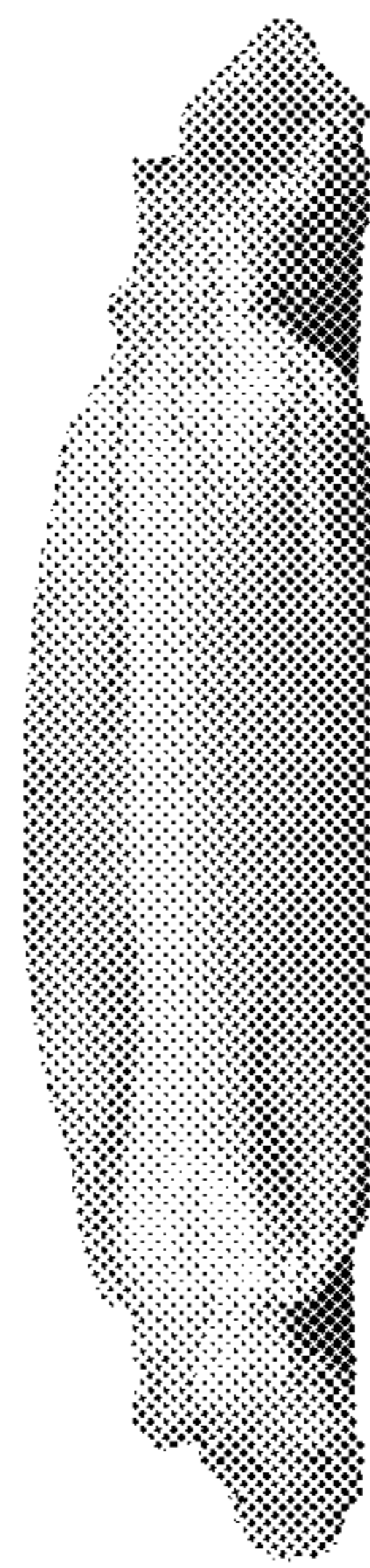




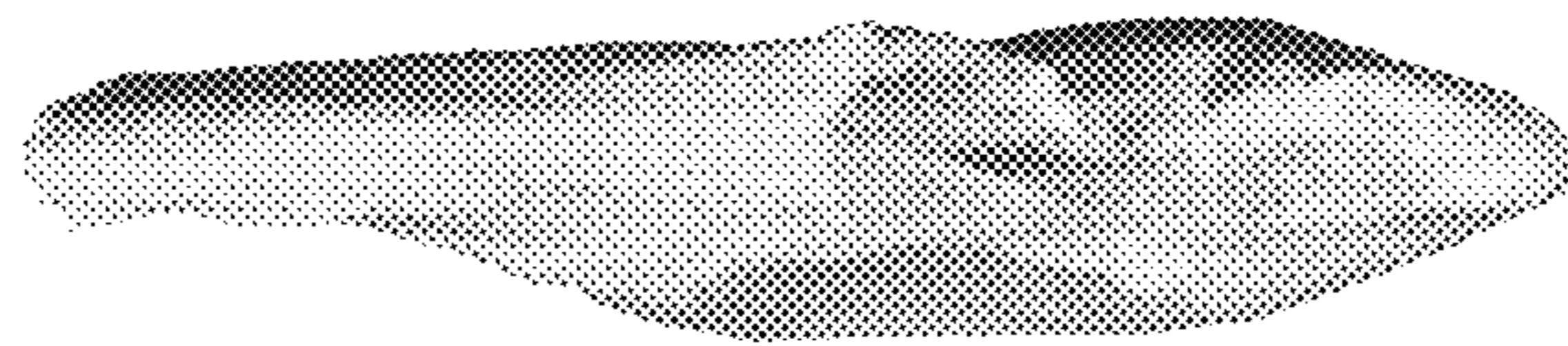




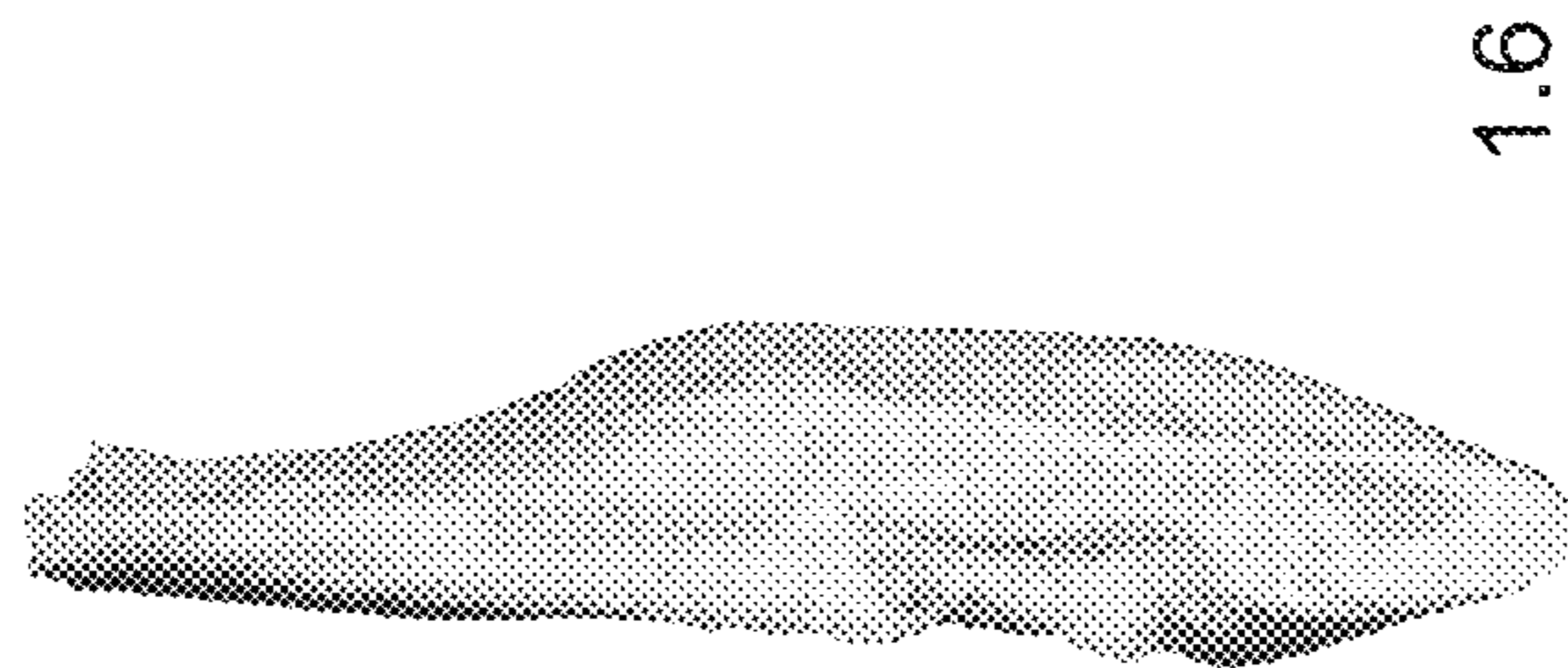

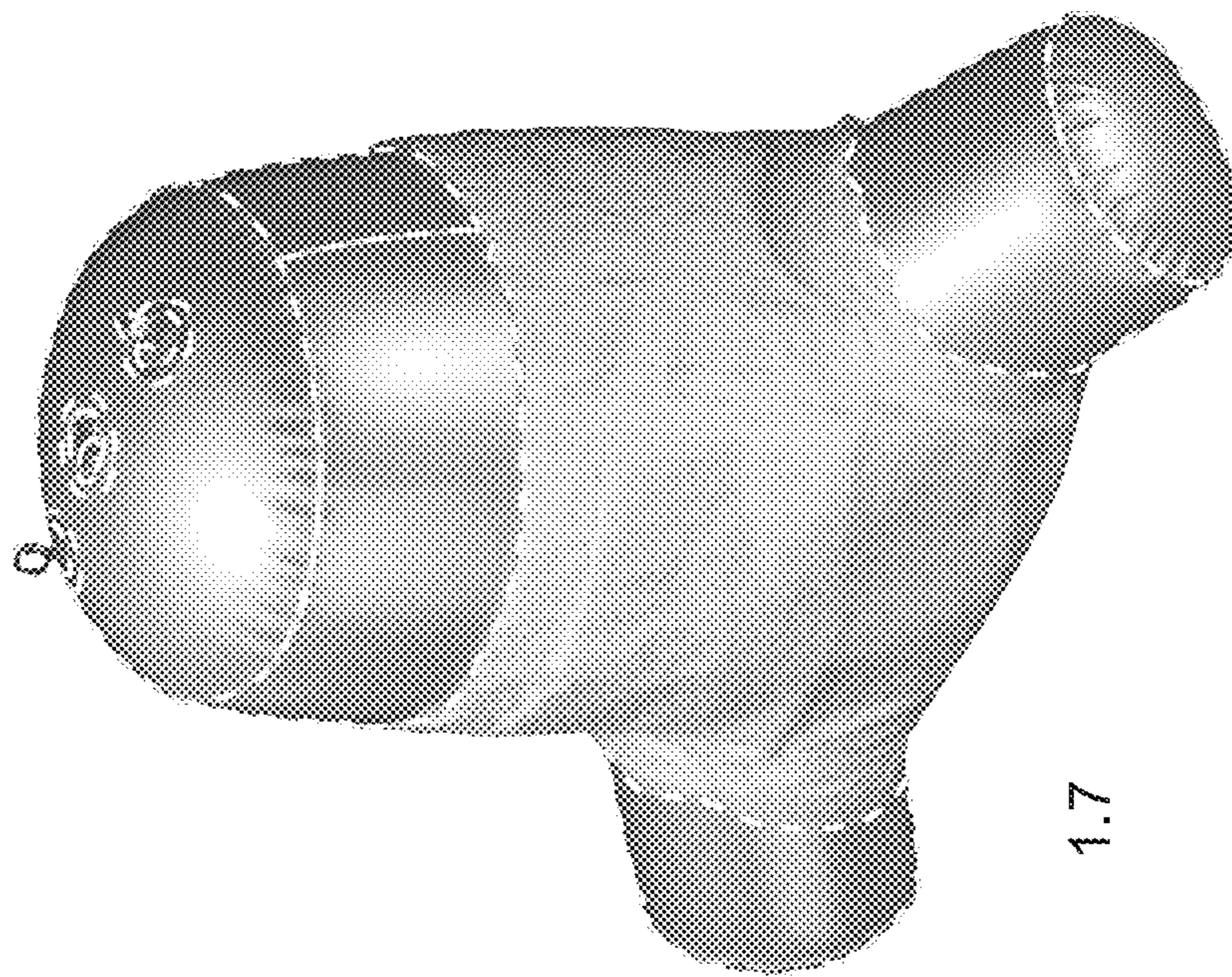


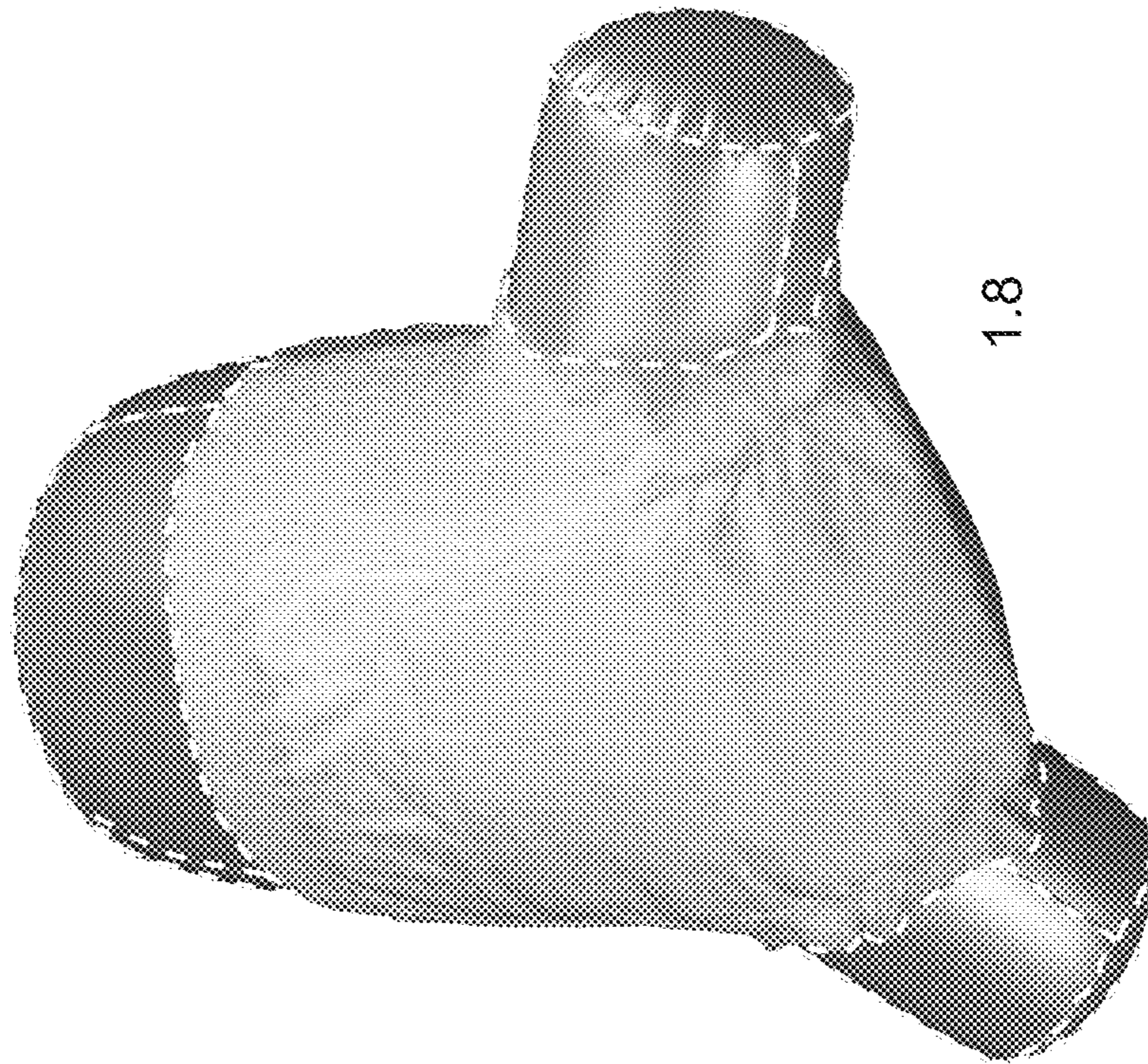

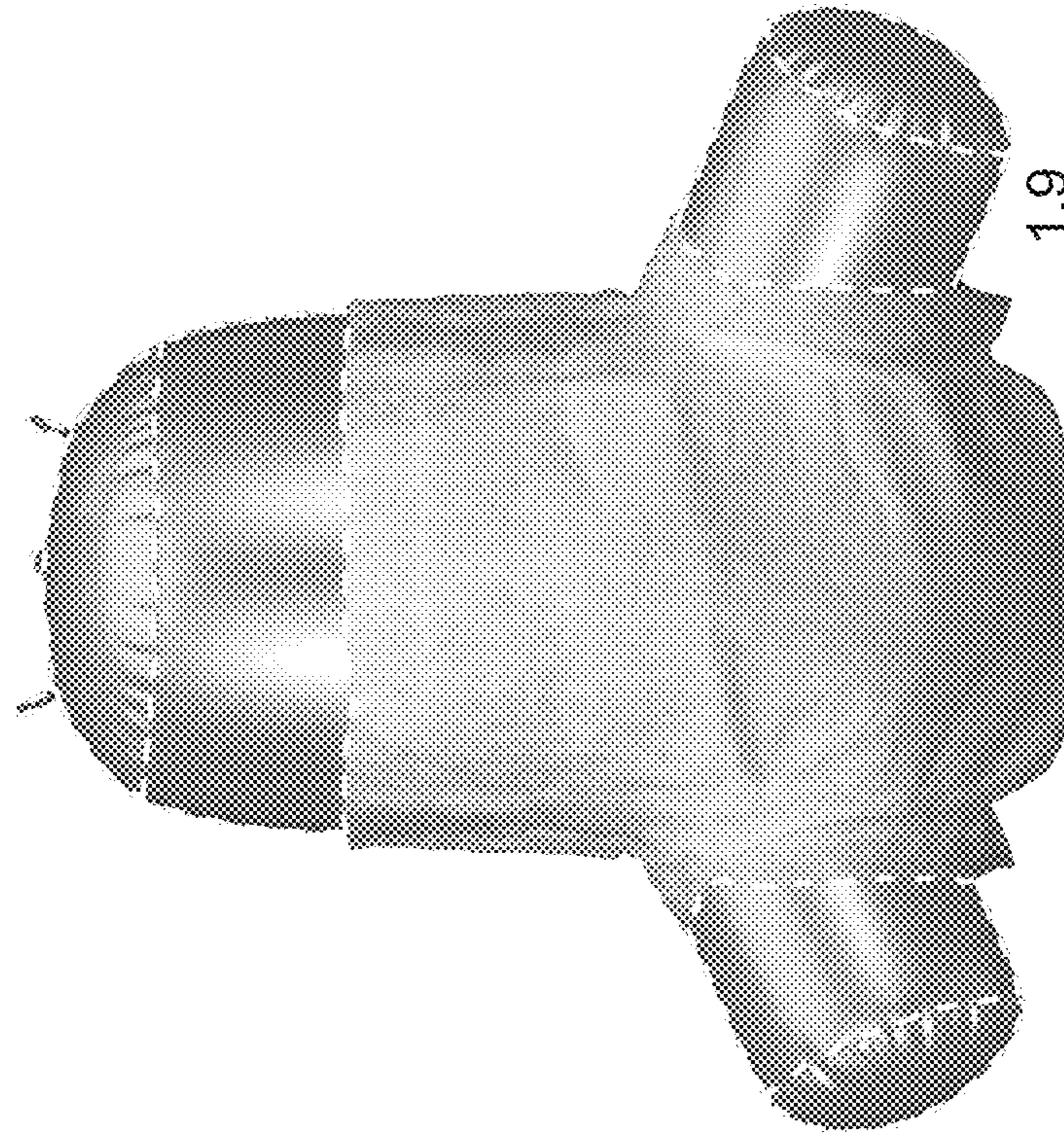


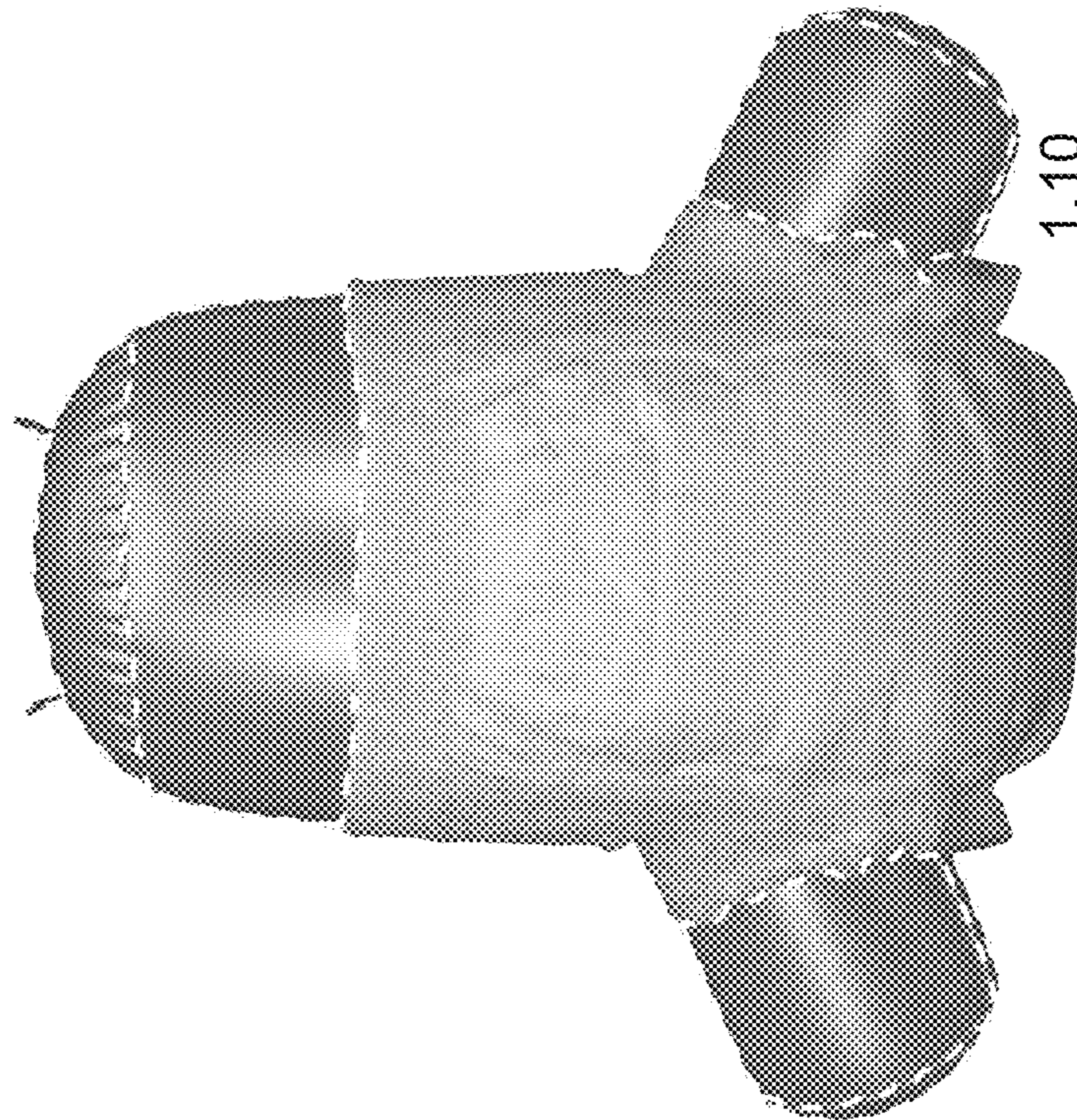

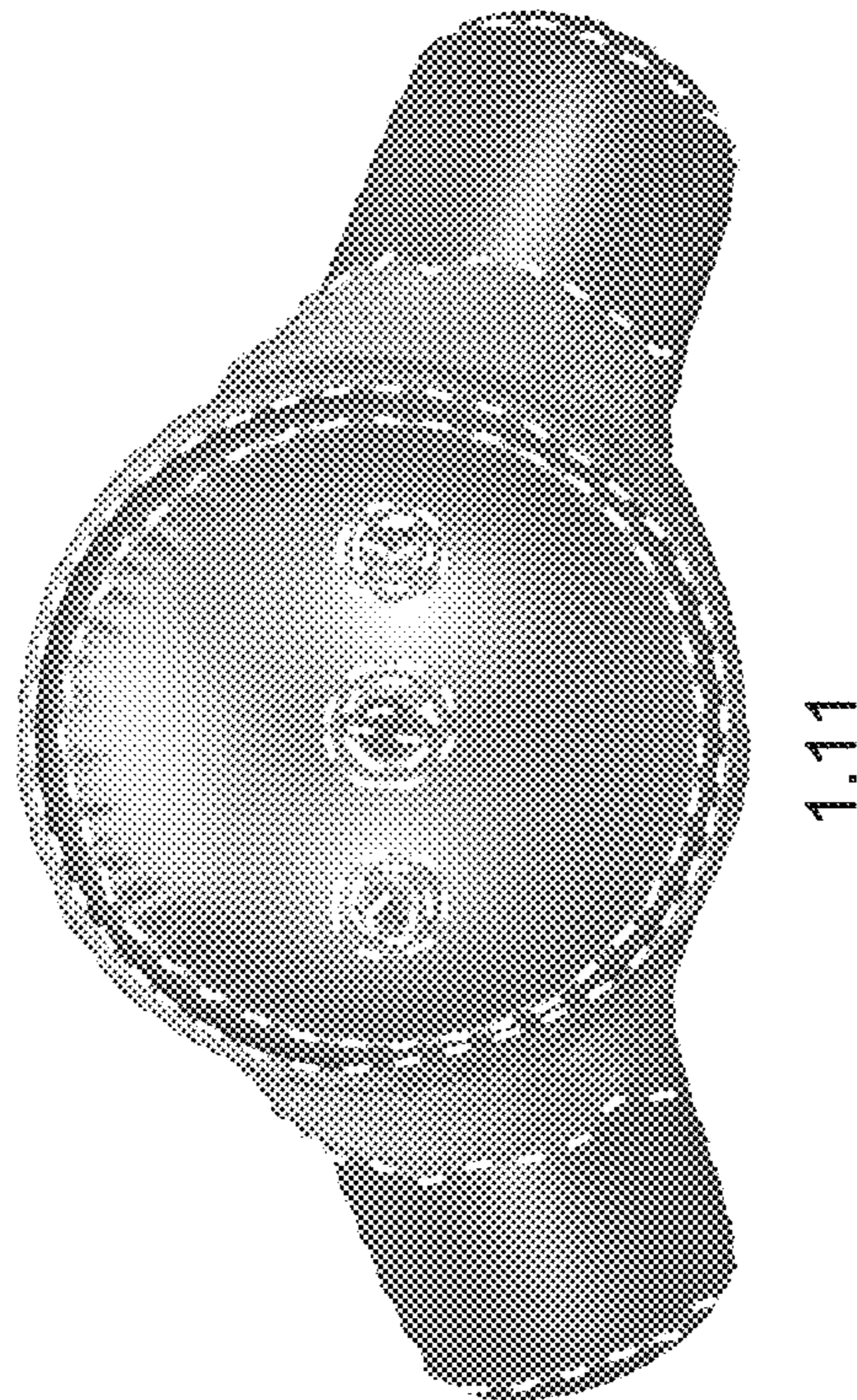


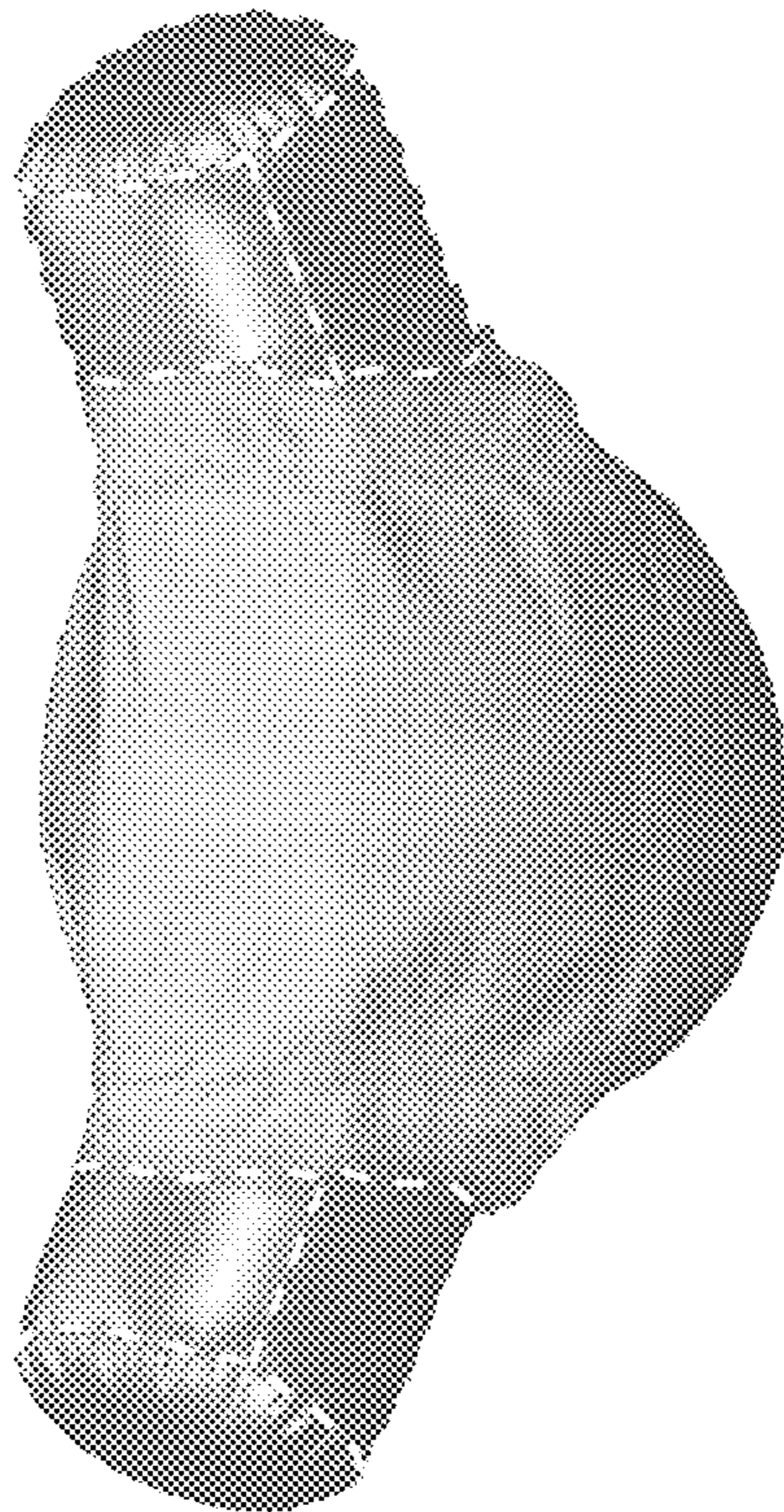




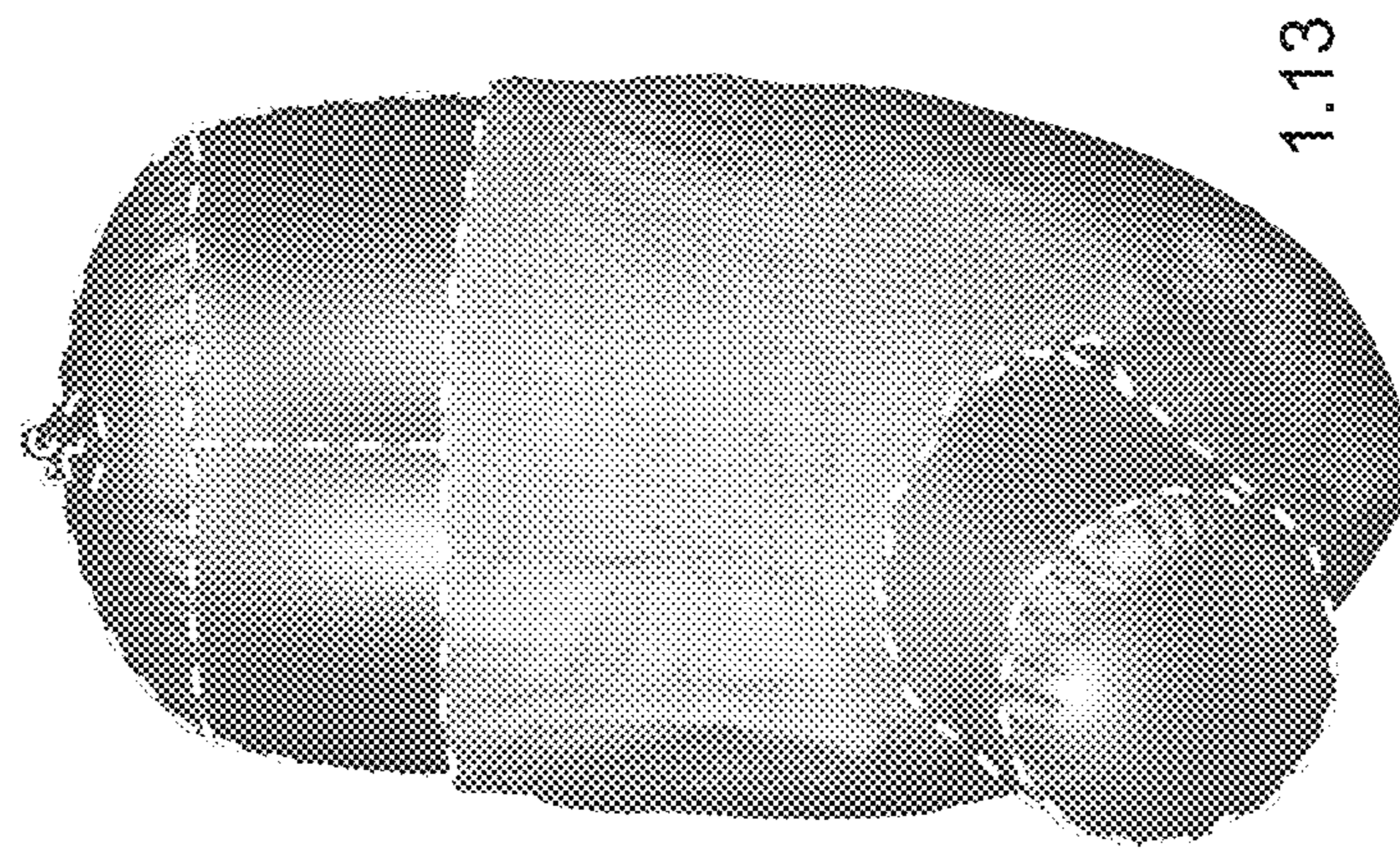


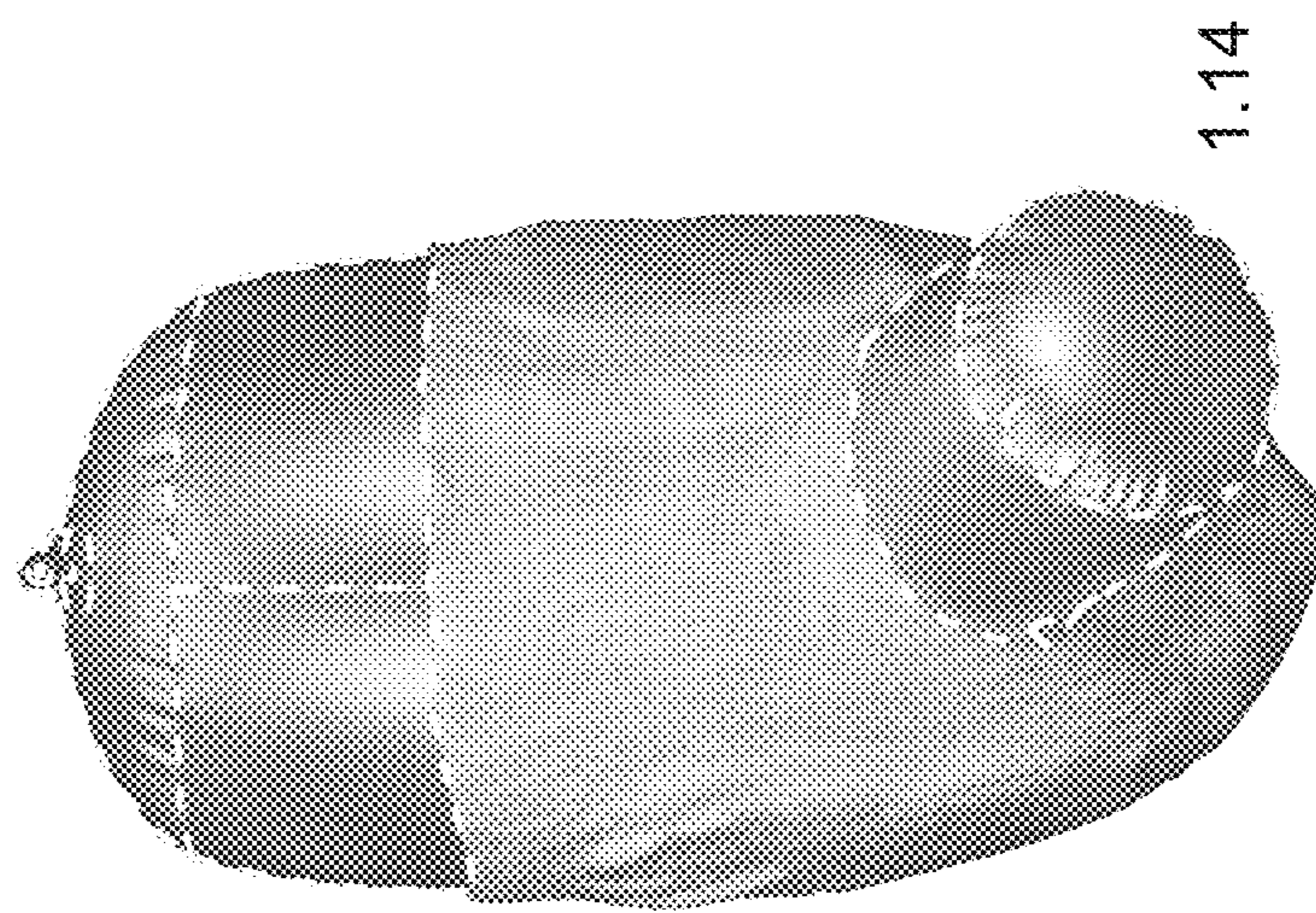


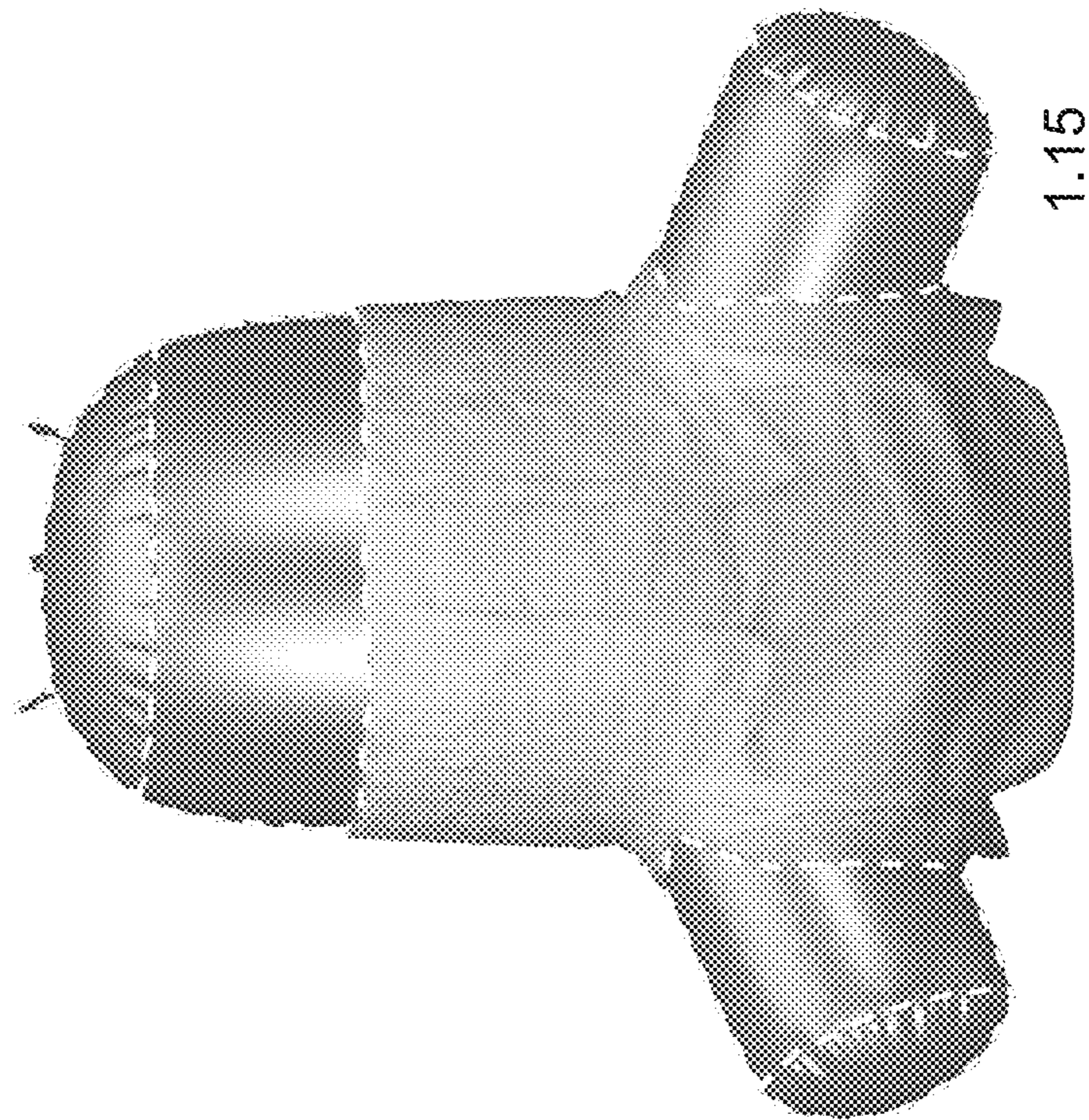
