DESCRIPTION

FIG. 14 is a bottom view thereof;

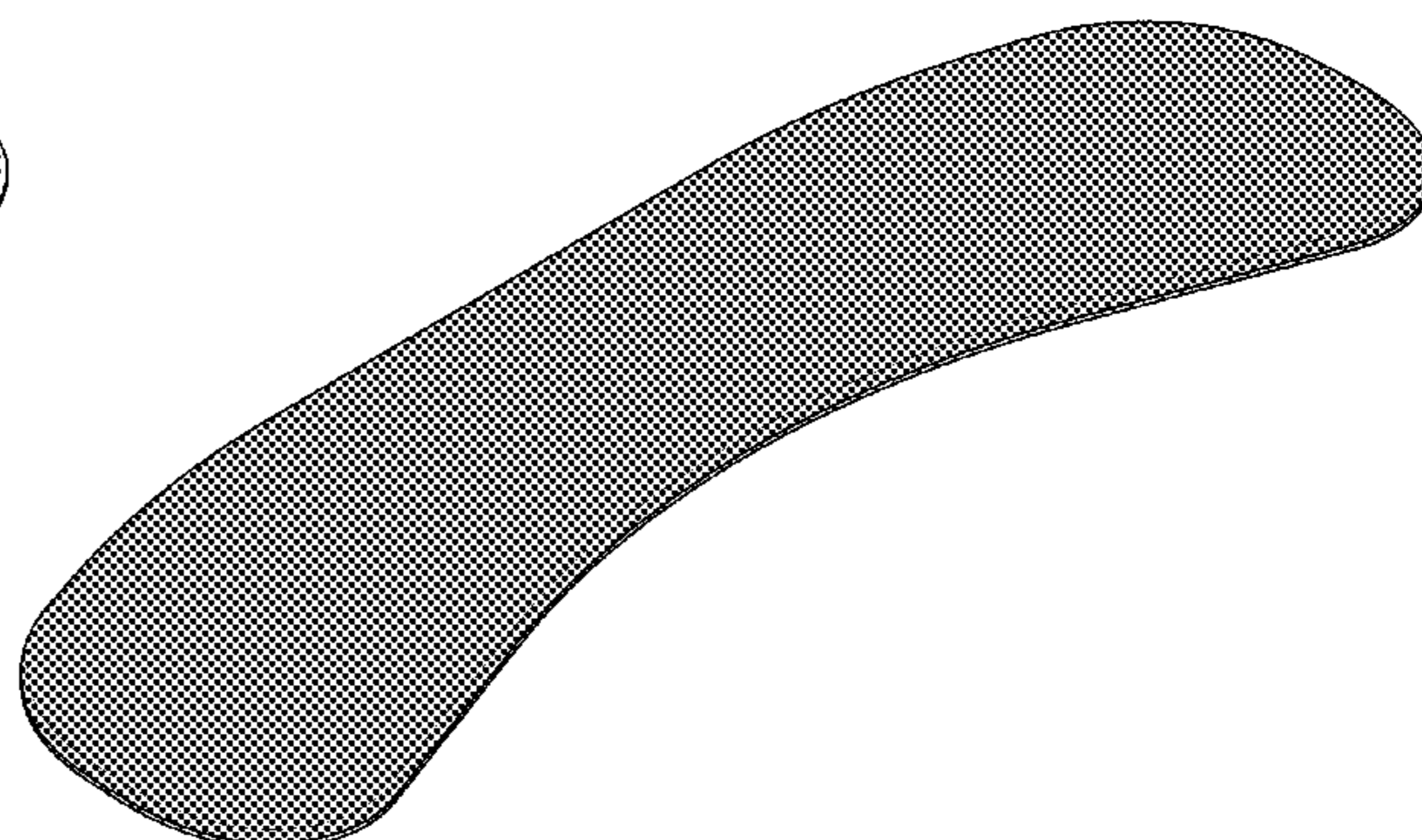
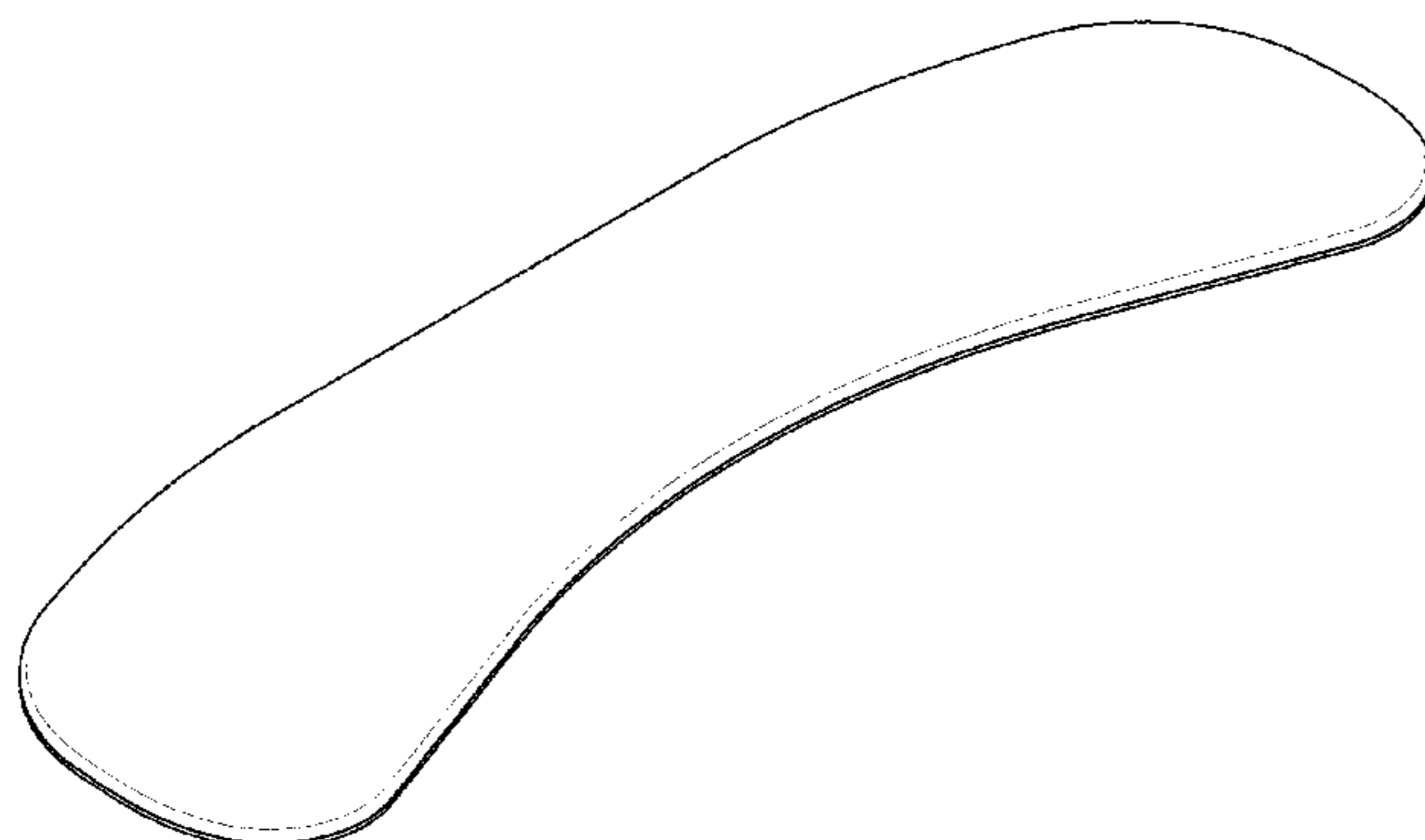
FIG. 15 is a left side view thereof; and,

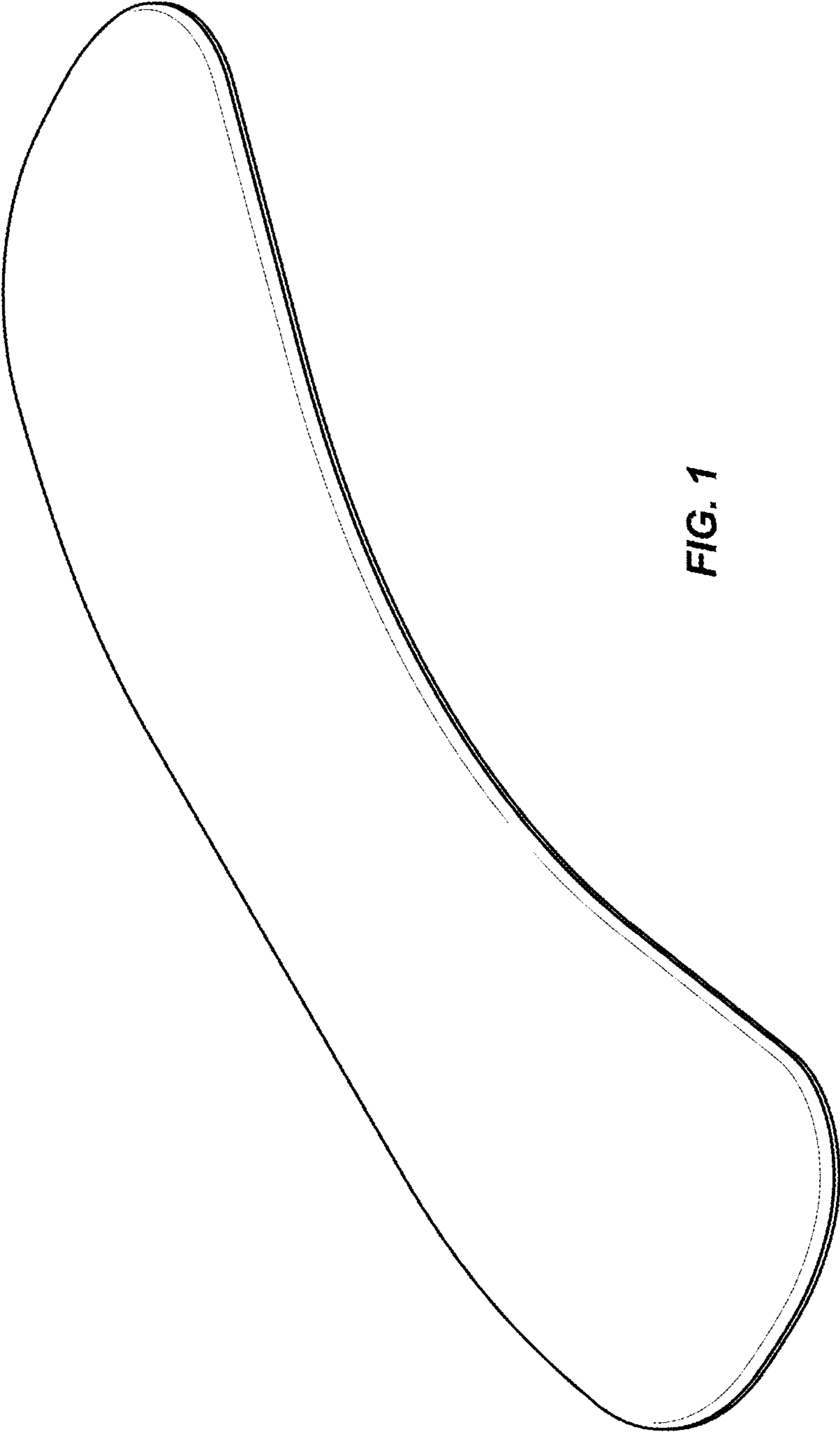
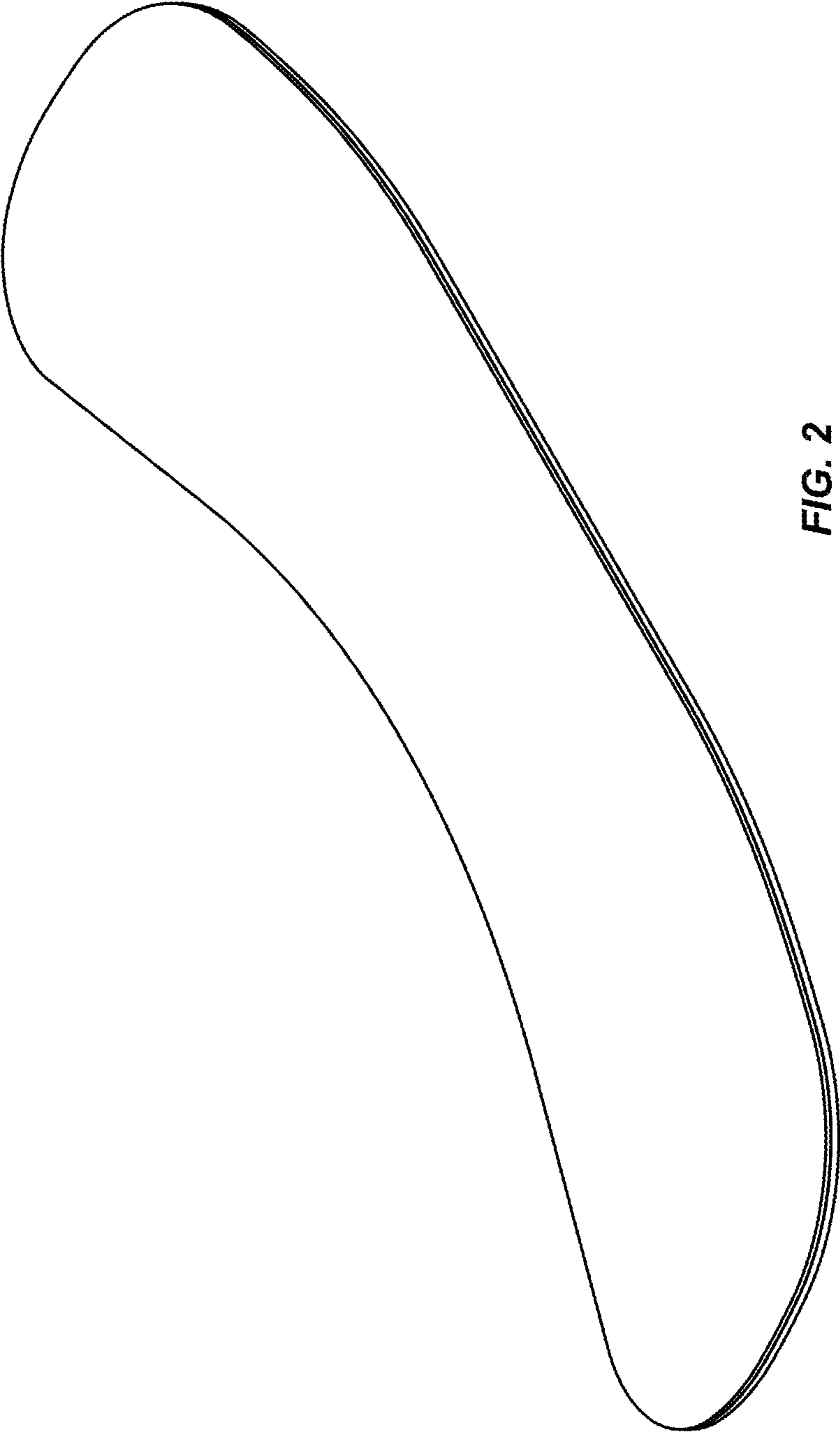

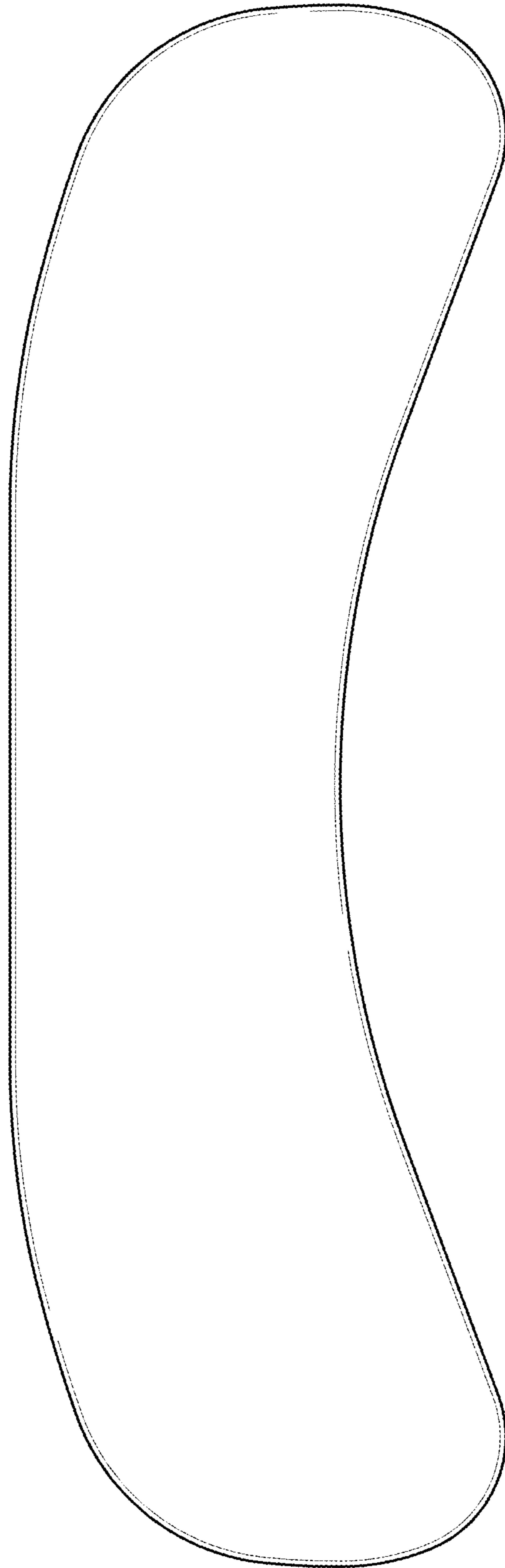

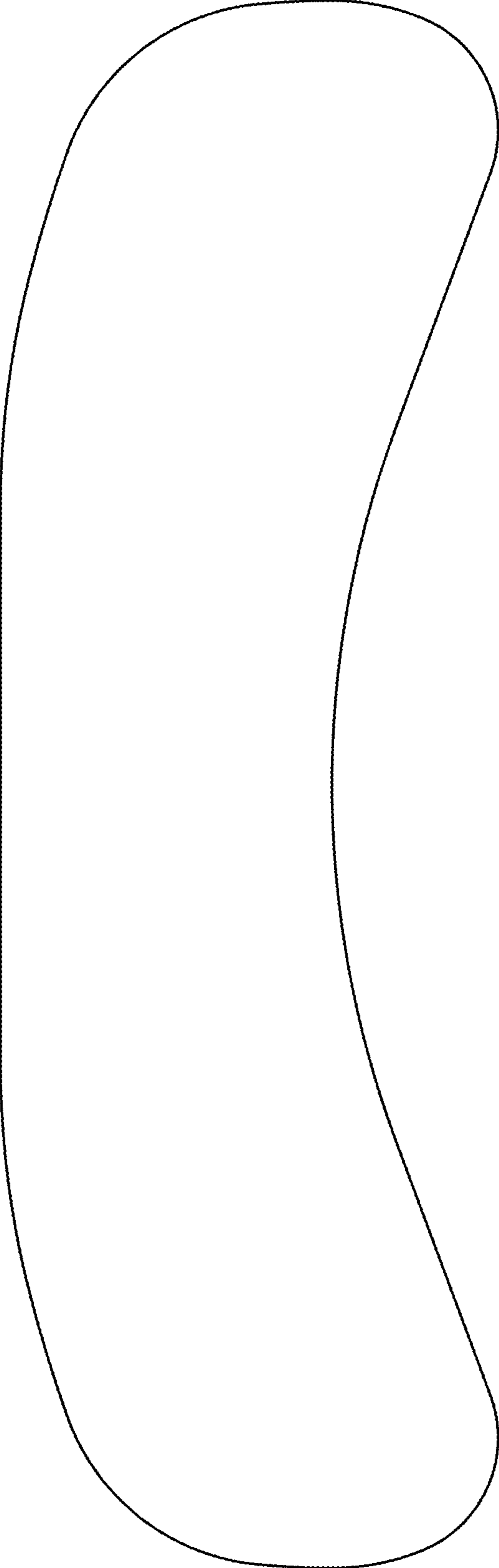

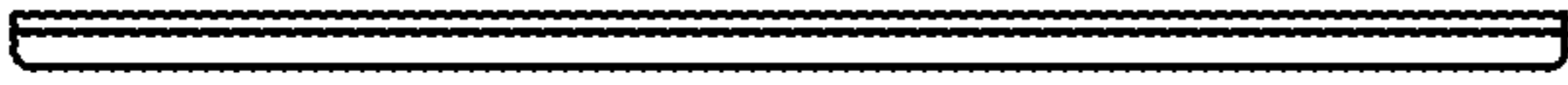

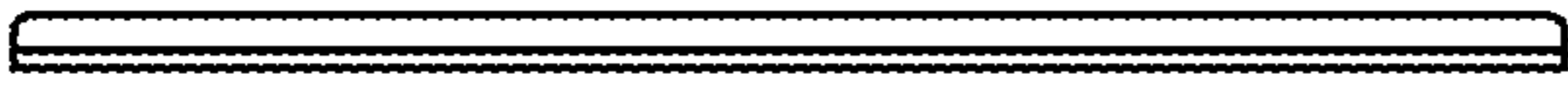

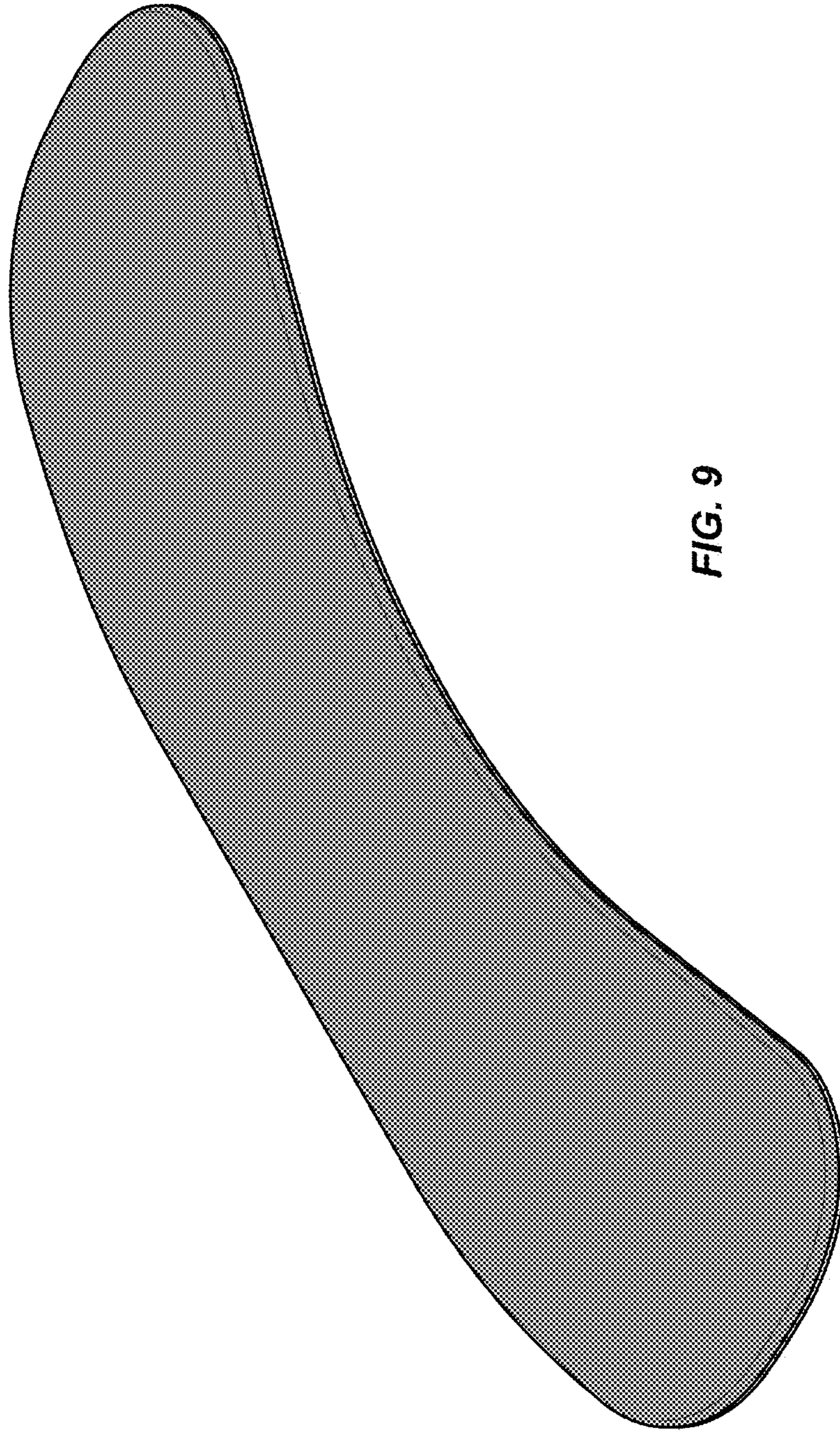

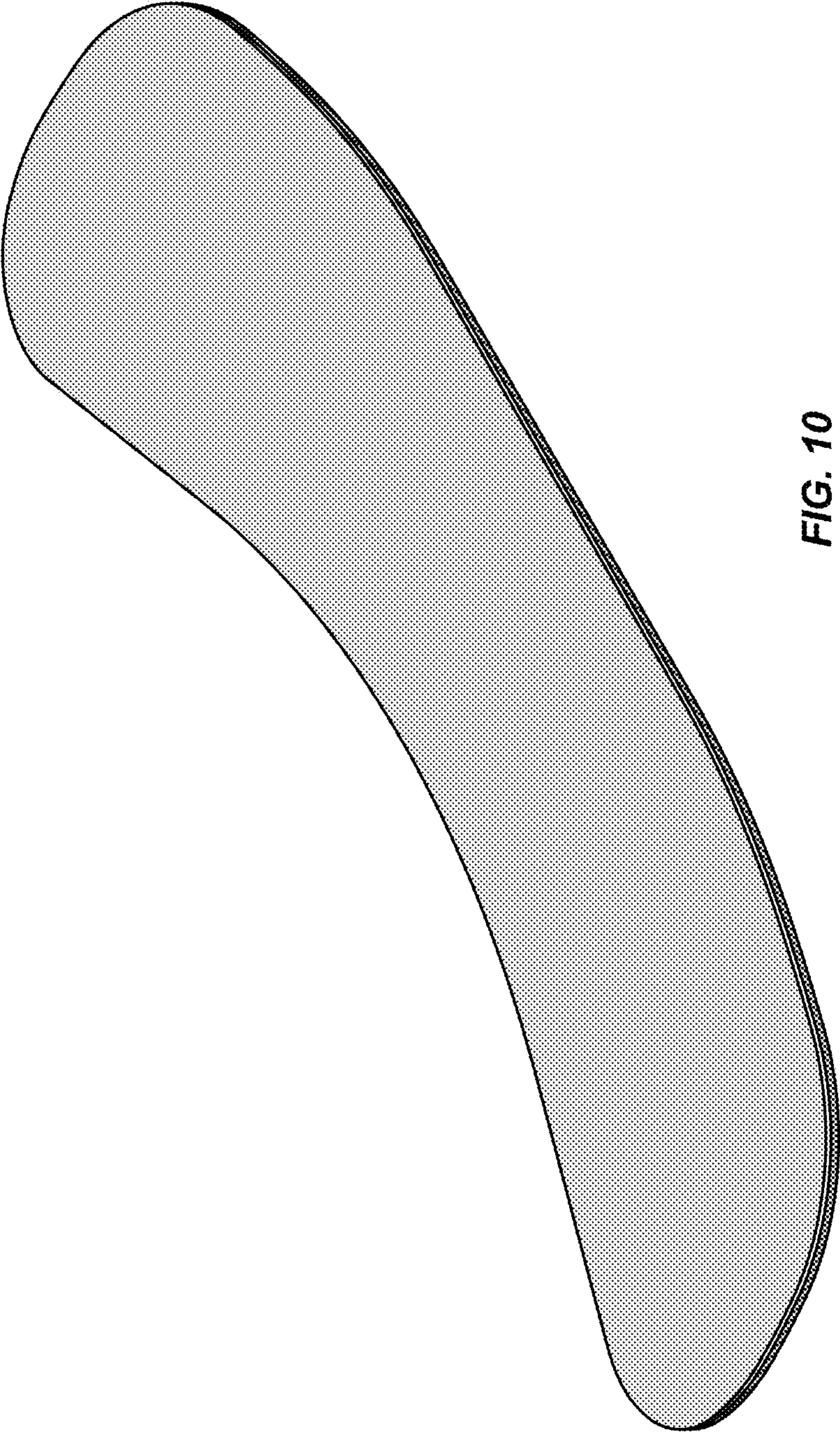

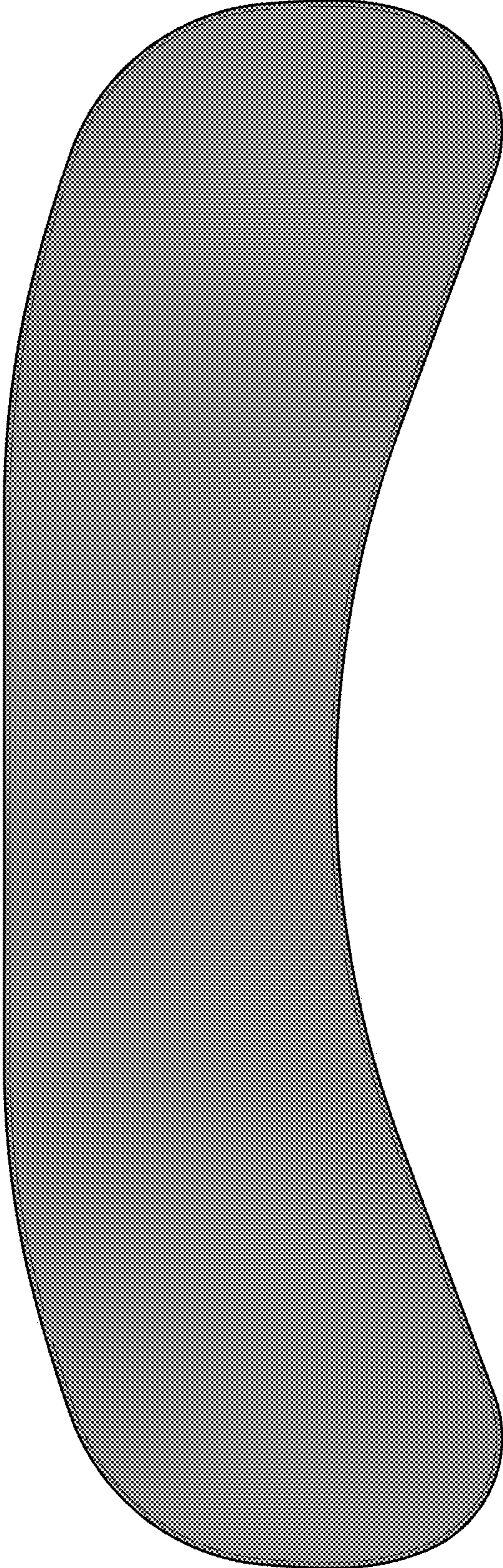

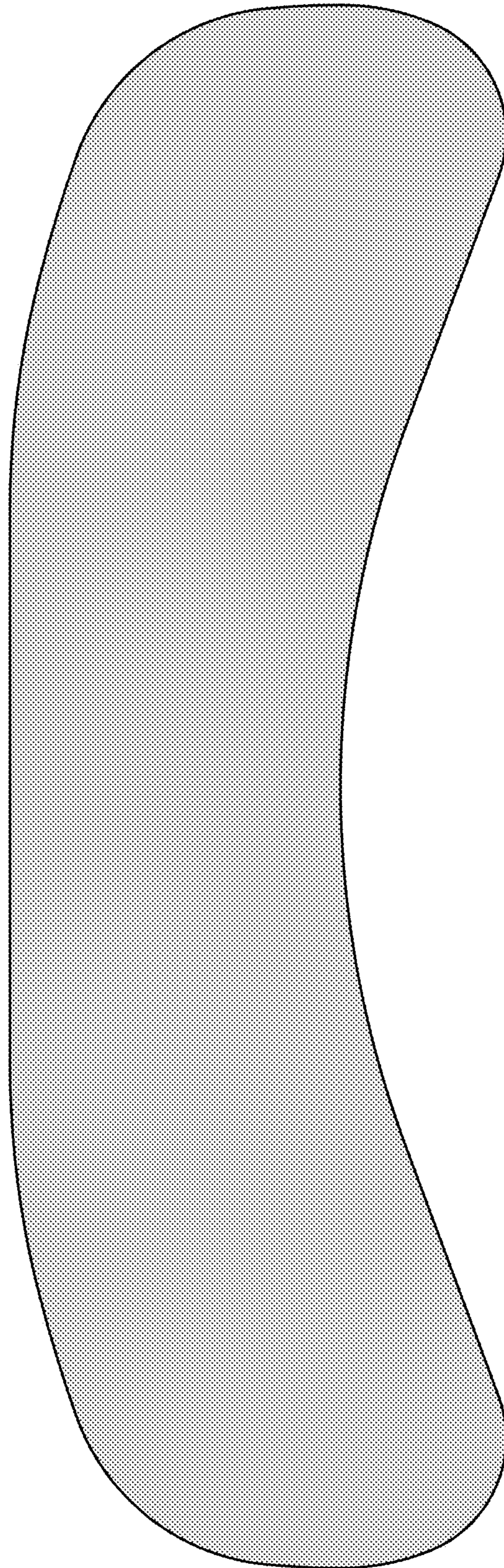
