**DESCRIPTION**

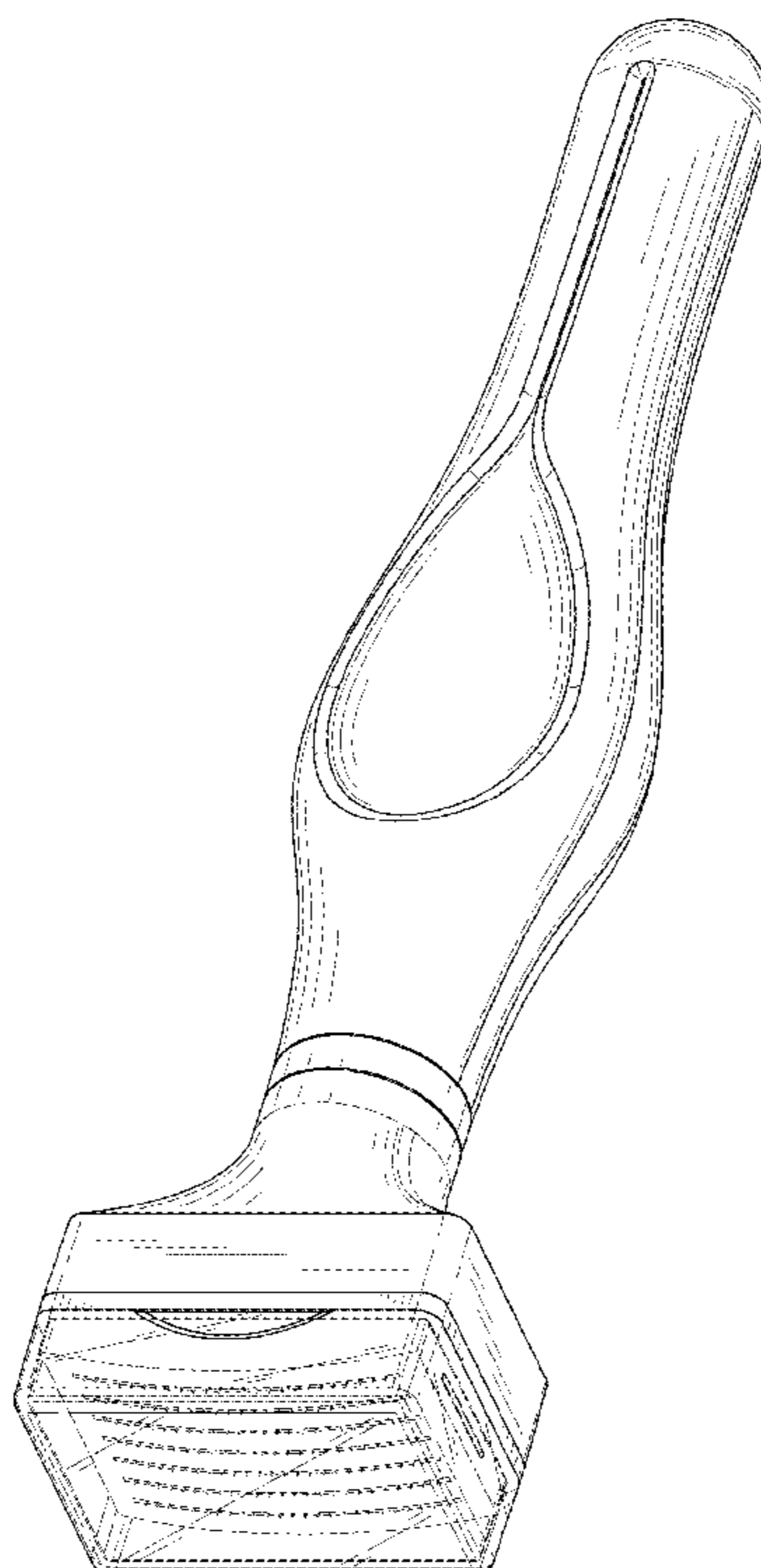
FIG. 1 is a front, right, and bottom perspective view of a skin care device, showing my design.

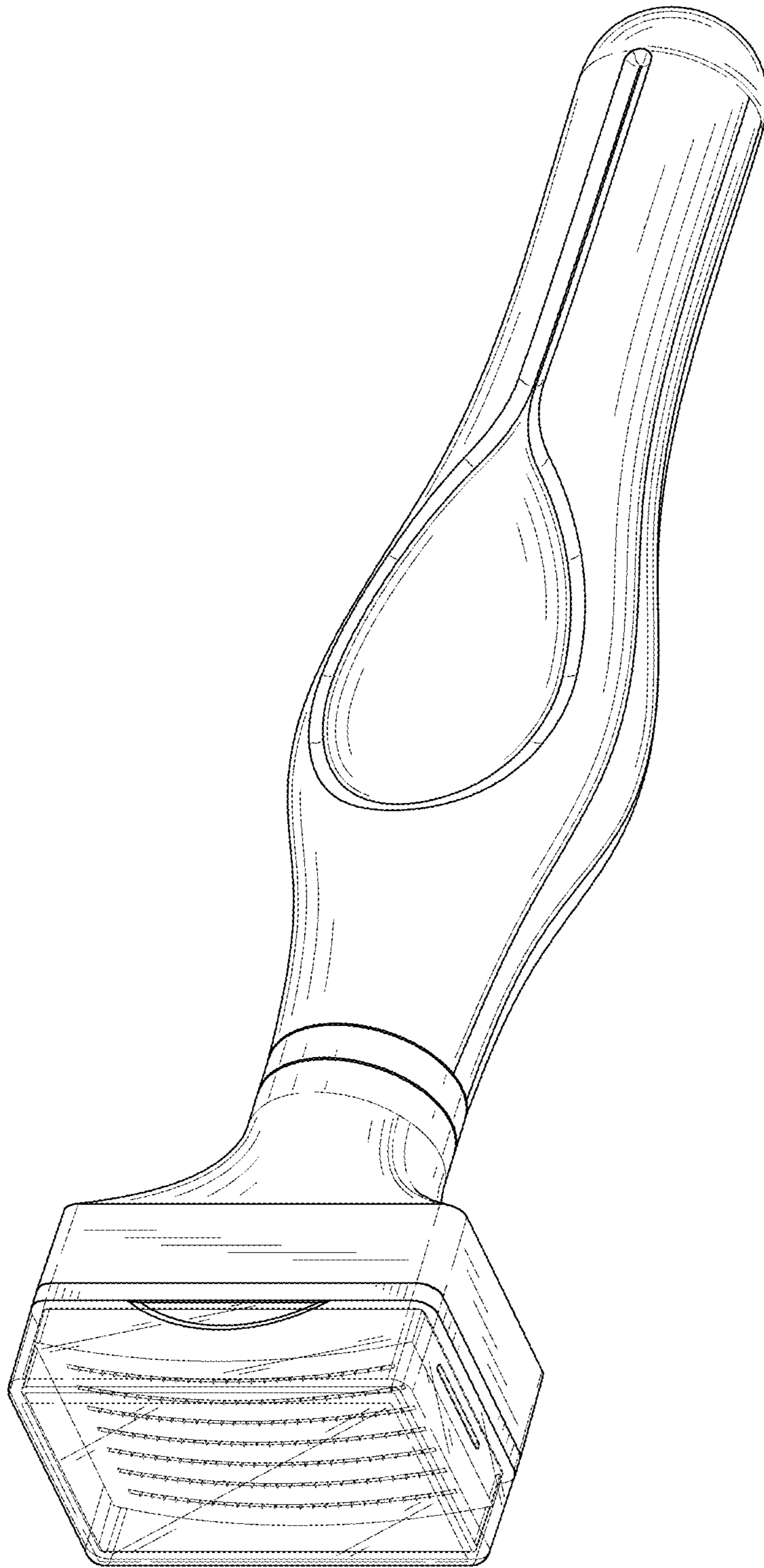

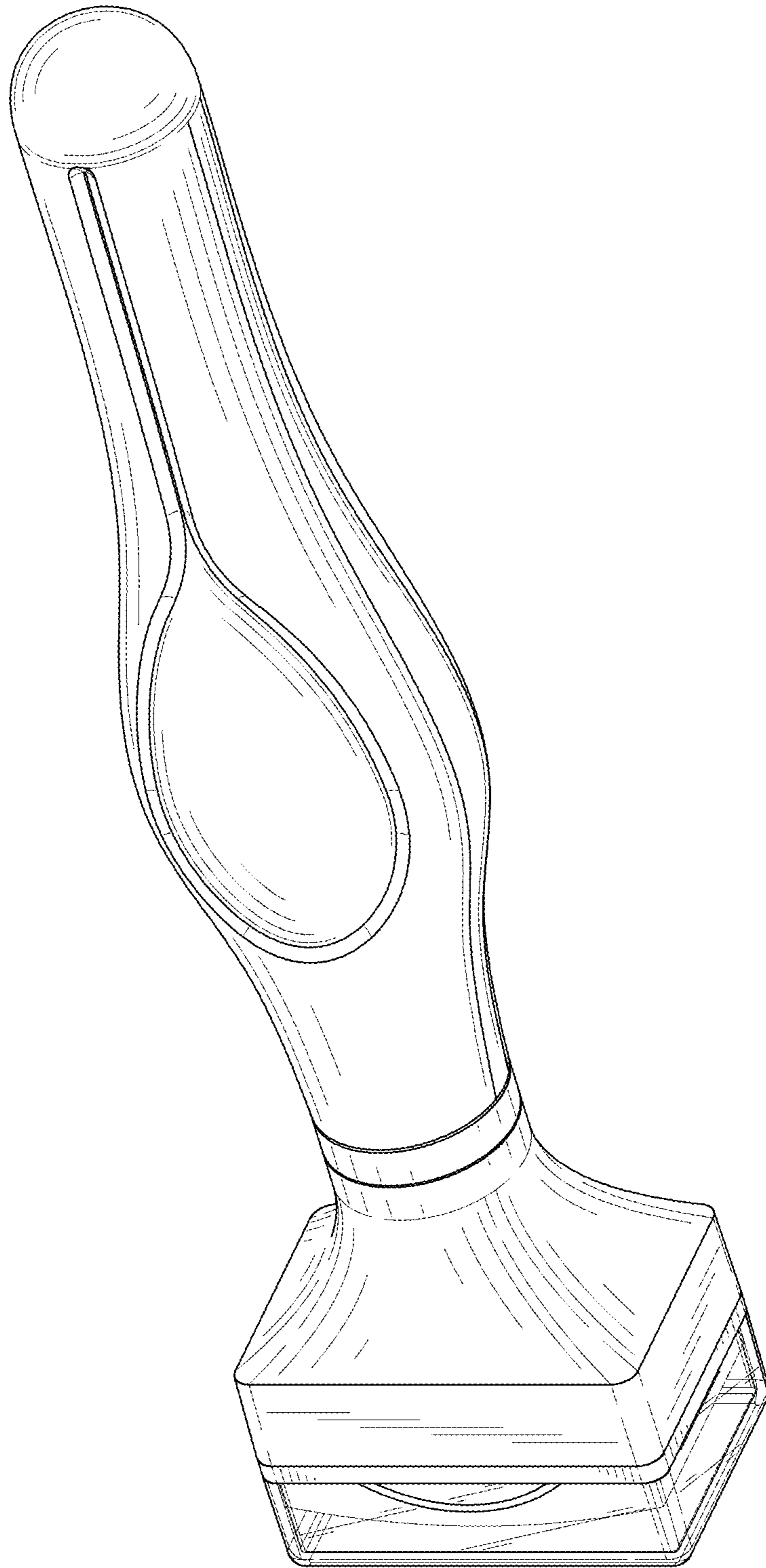

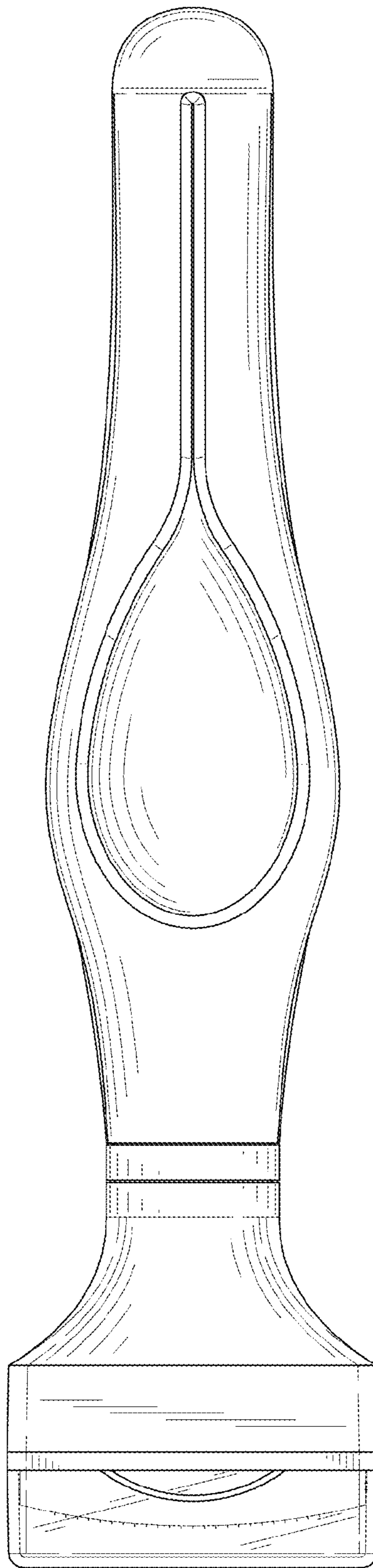

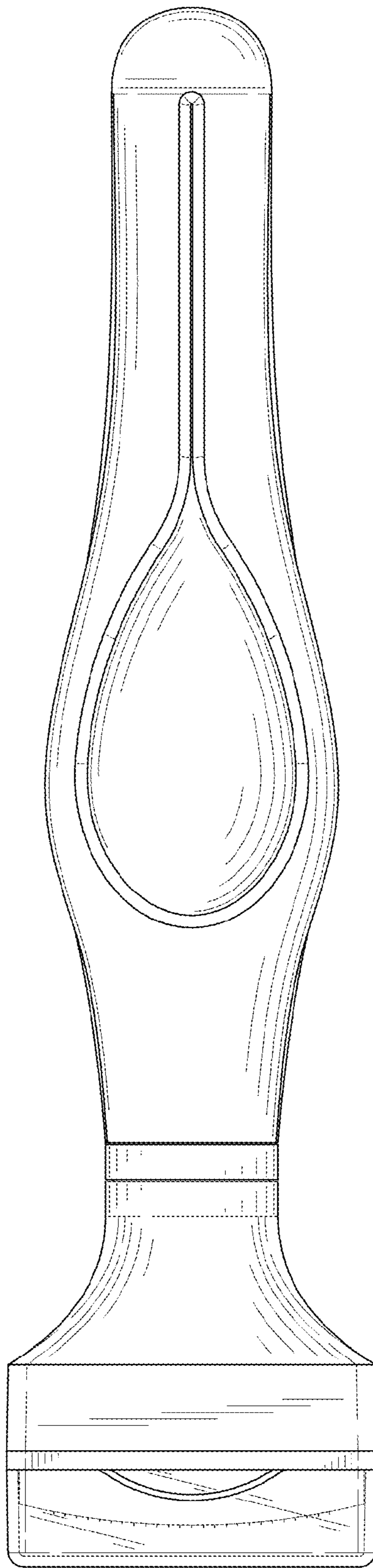

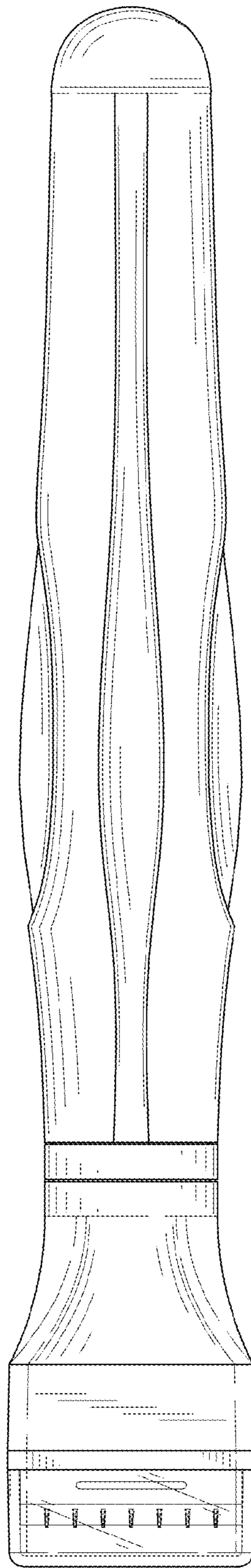

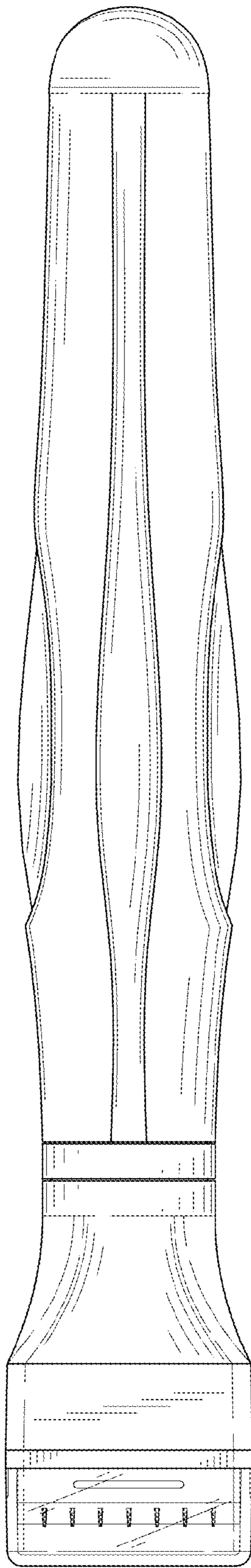

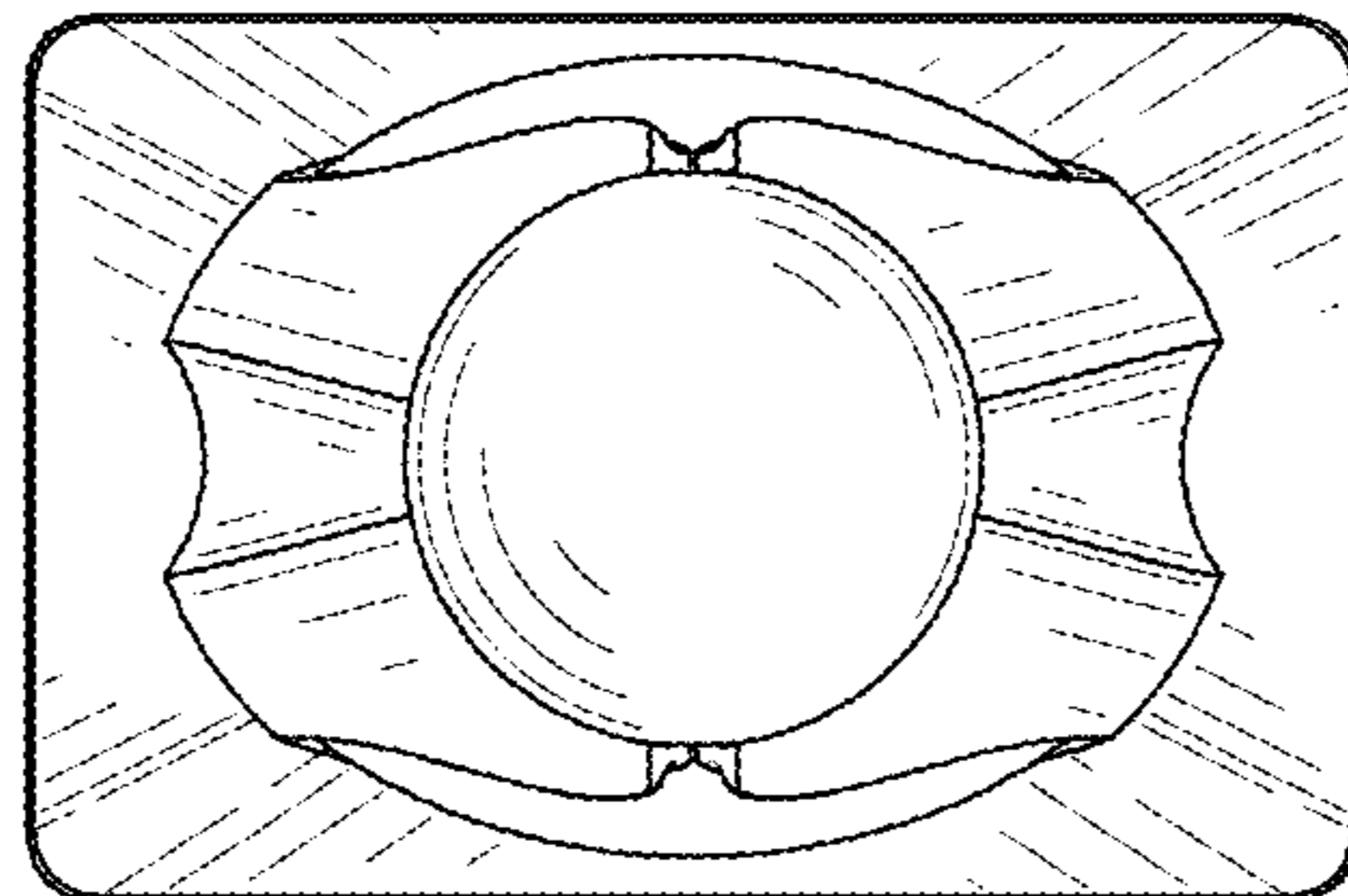

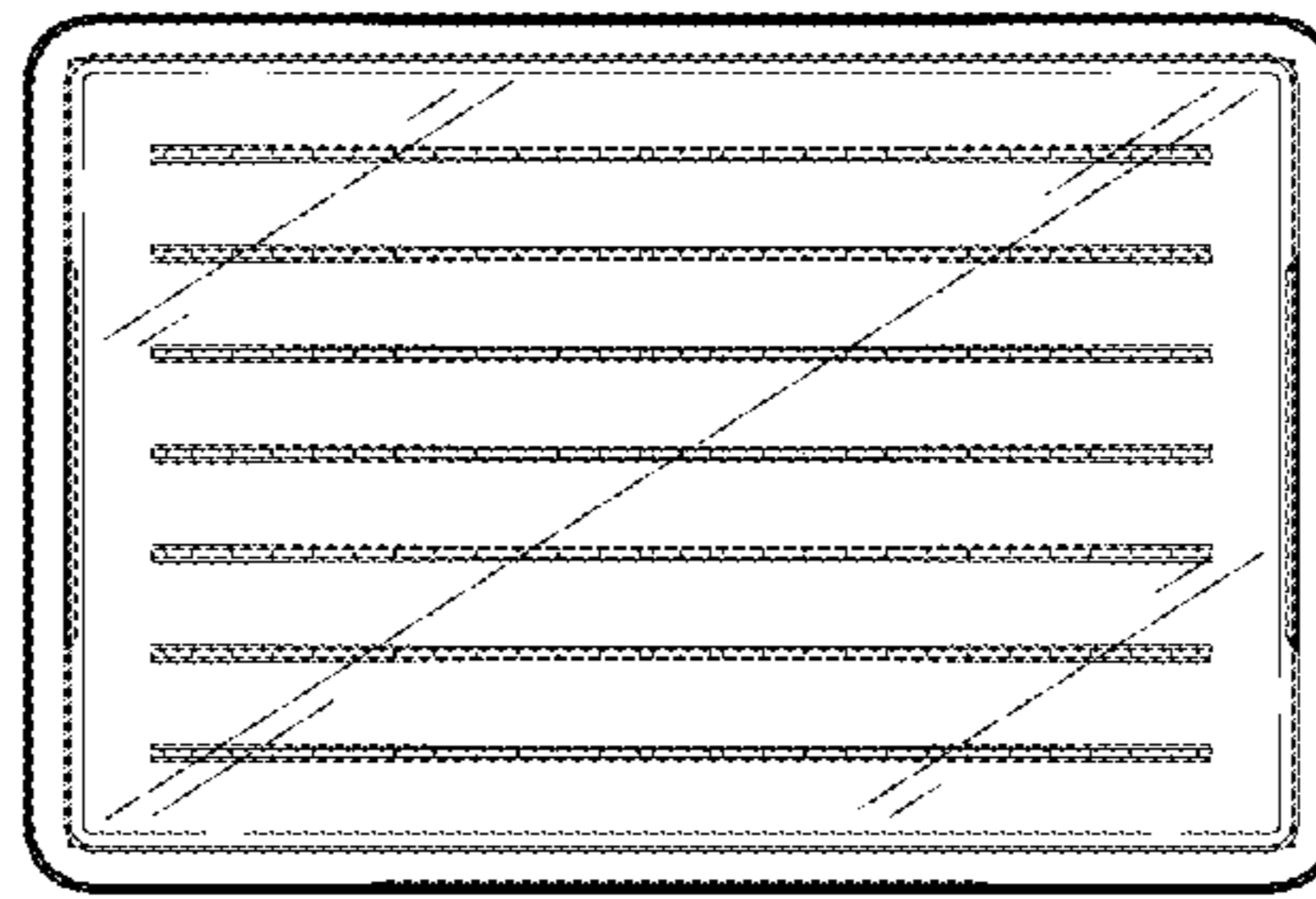

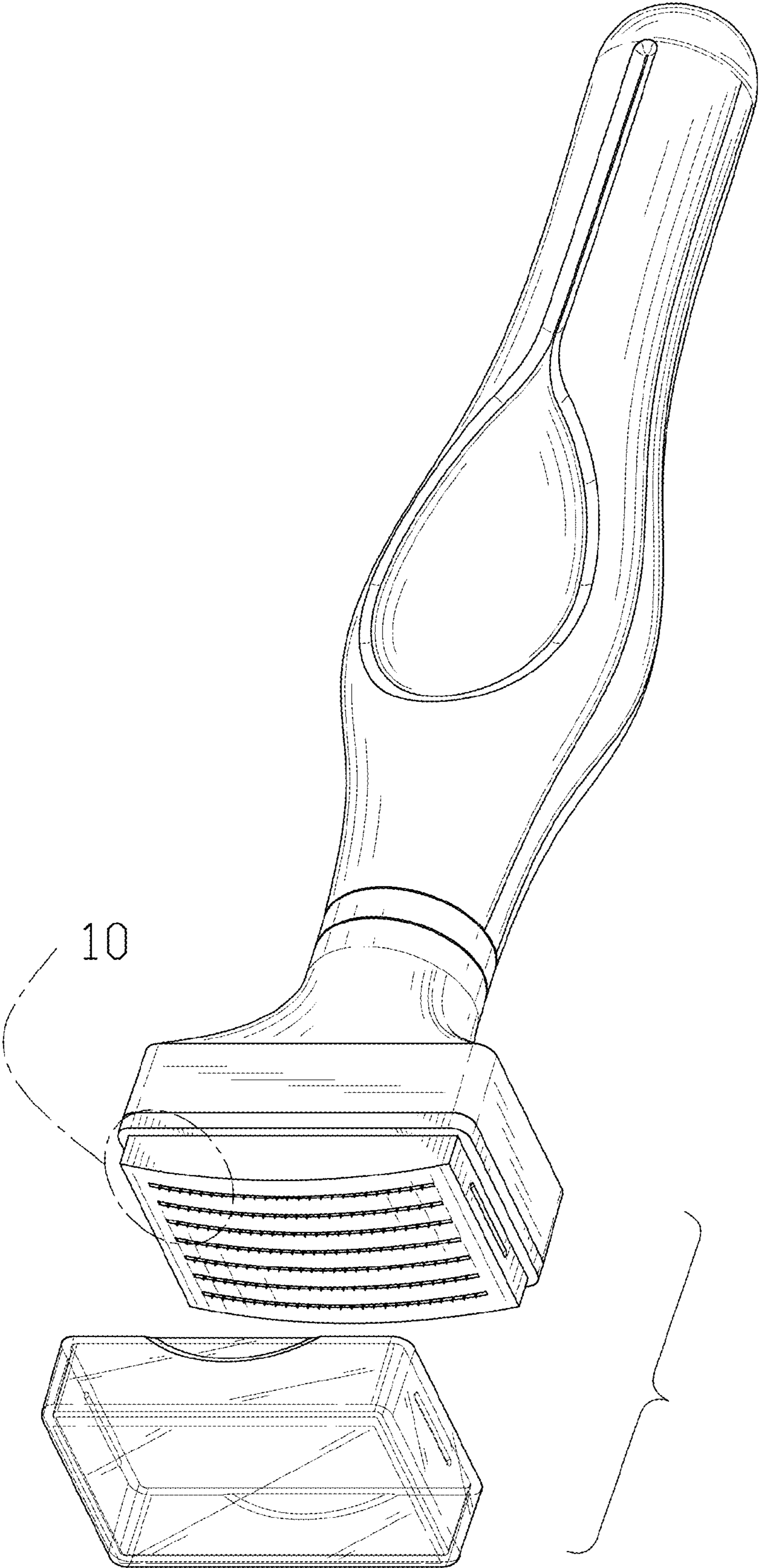

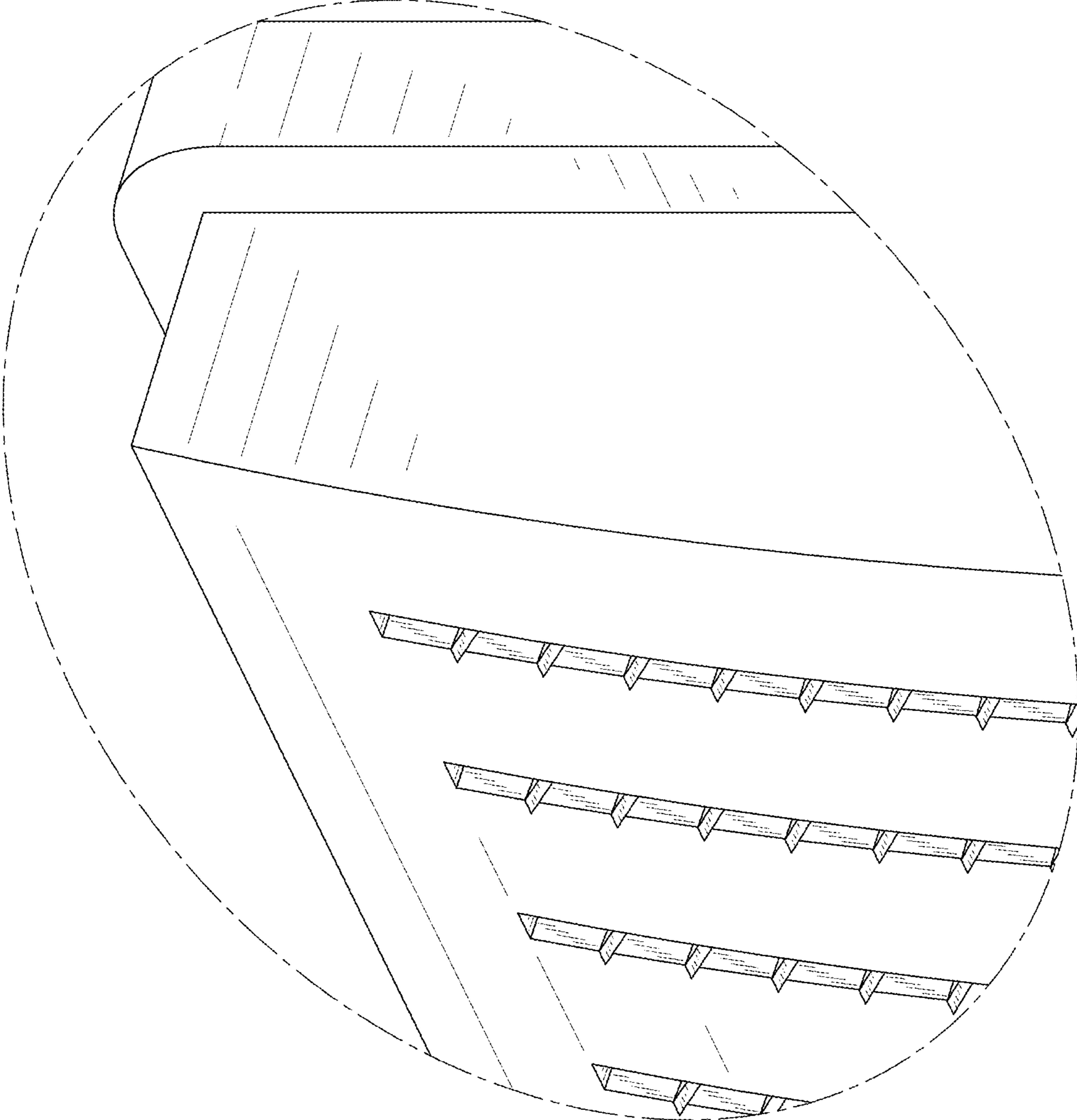
