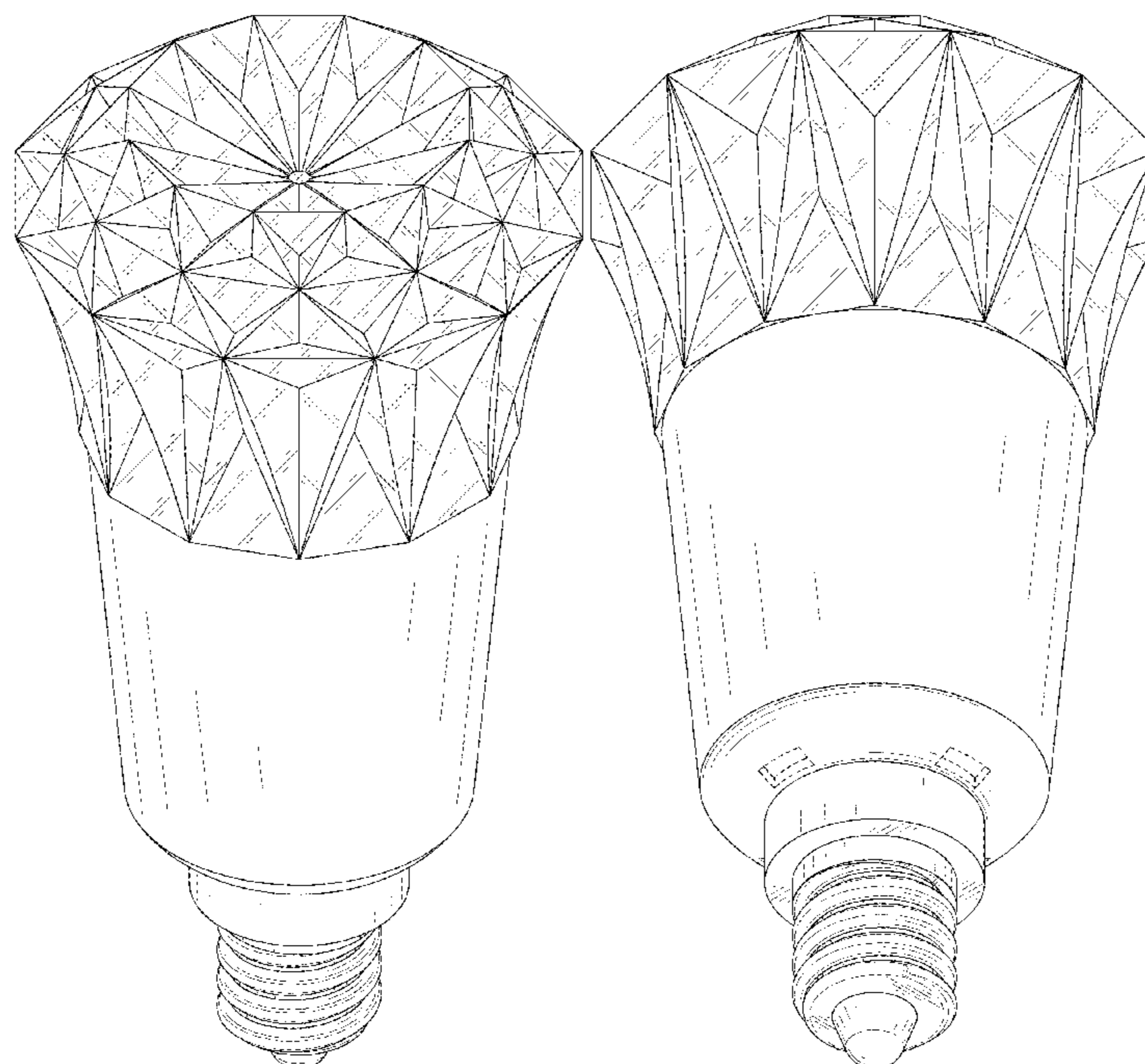
(57) **CLAIM**

The ornamental design for a LED bulb, as shown and described.

DESCRIPTION

FIG. 1 is a front, right and top perspective view of a LED bulb, showing my design.

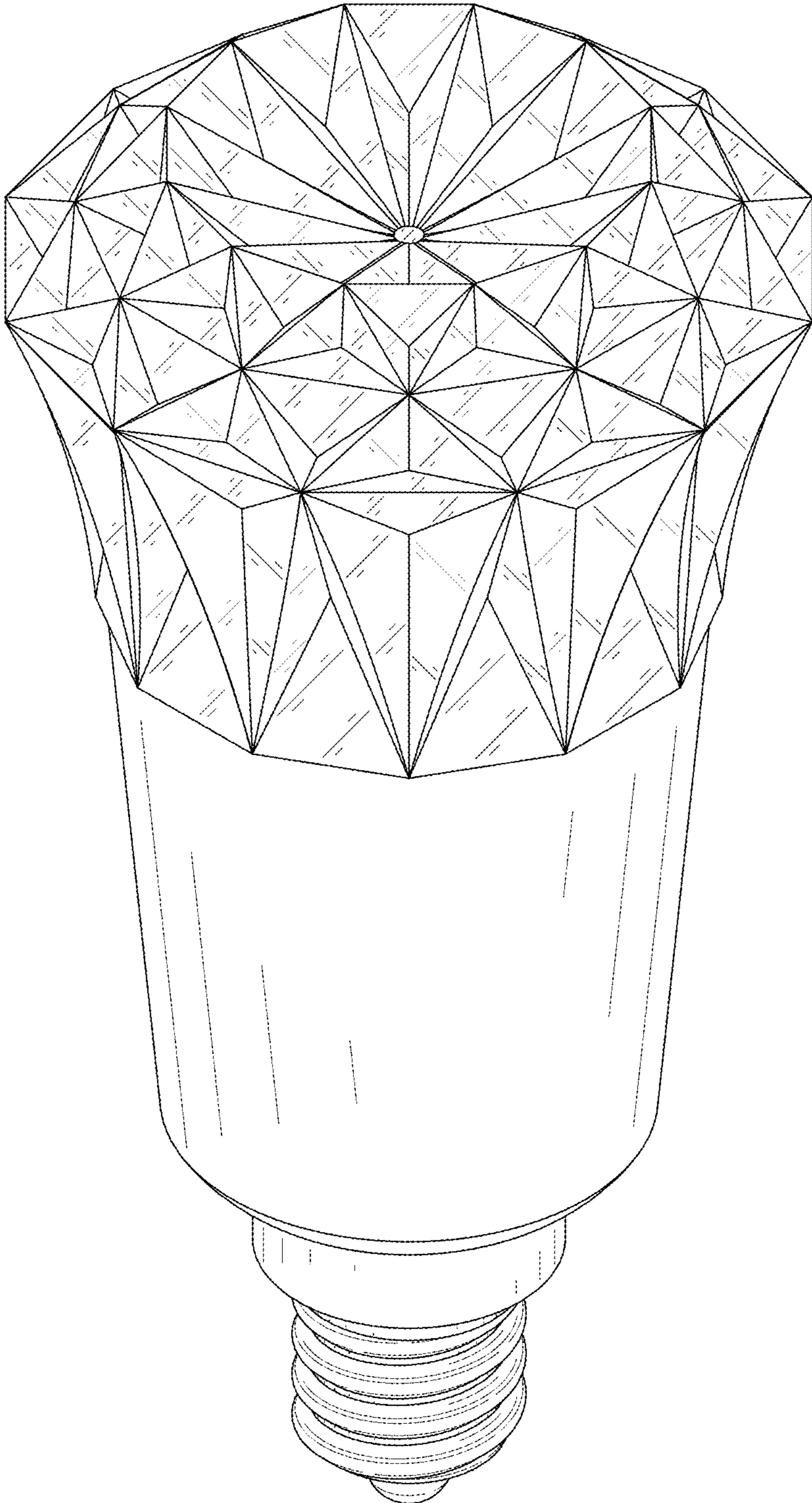

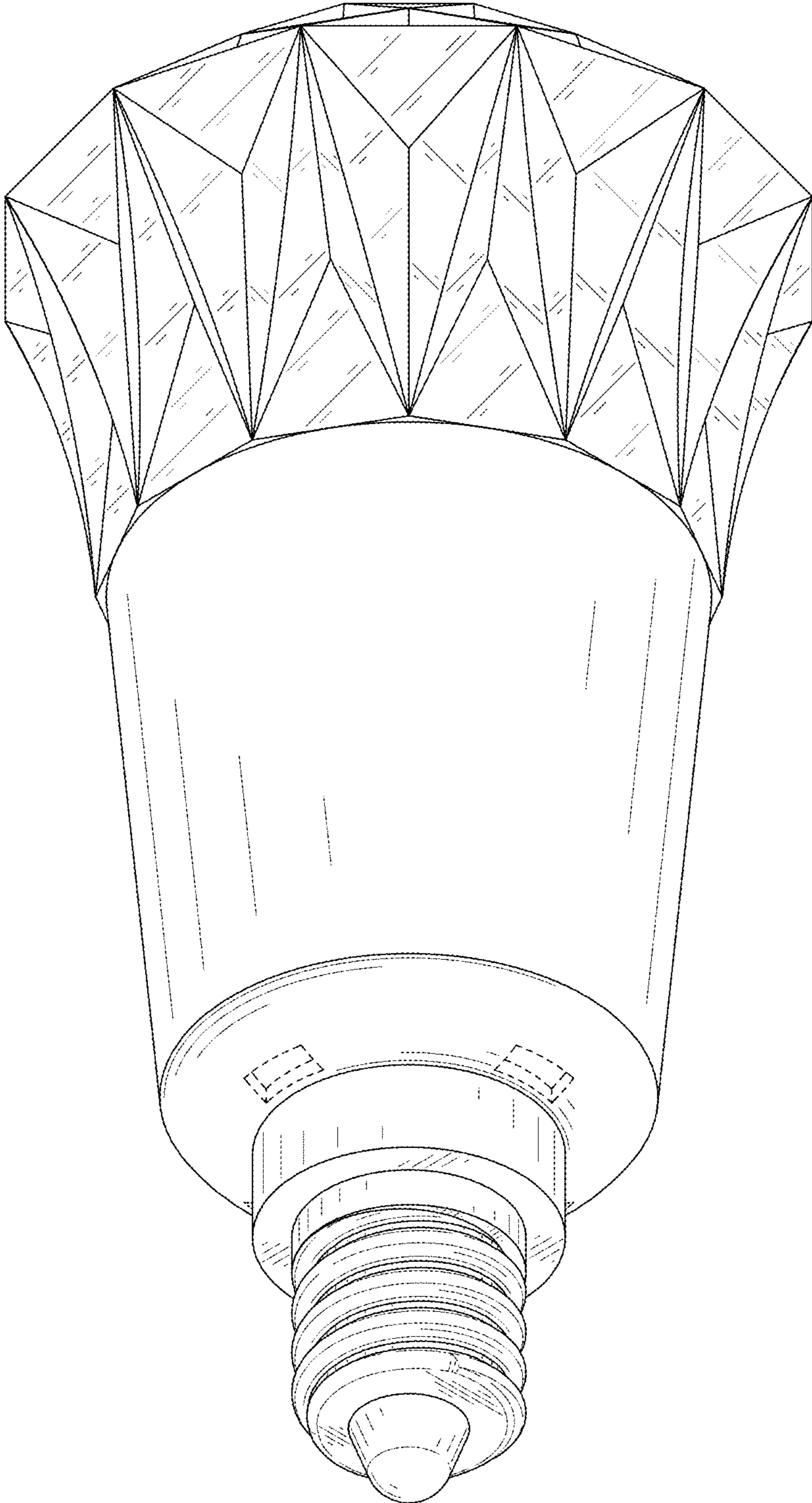

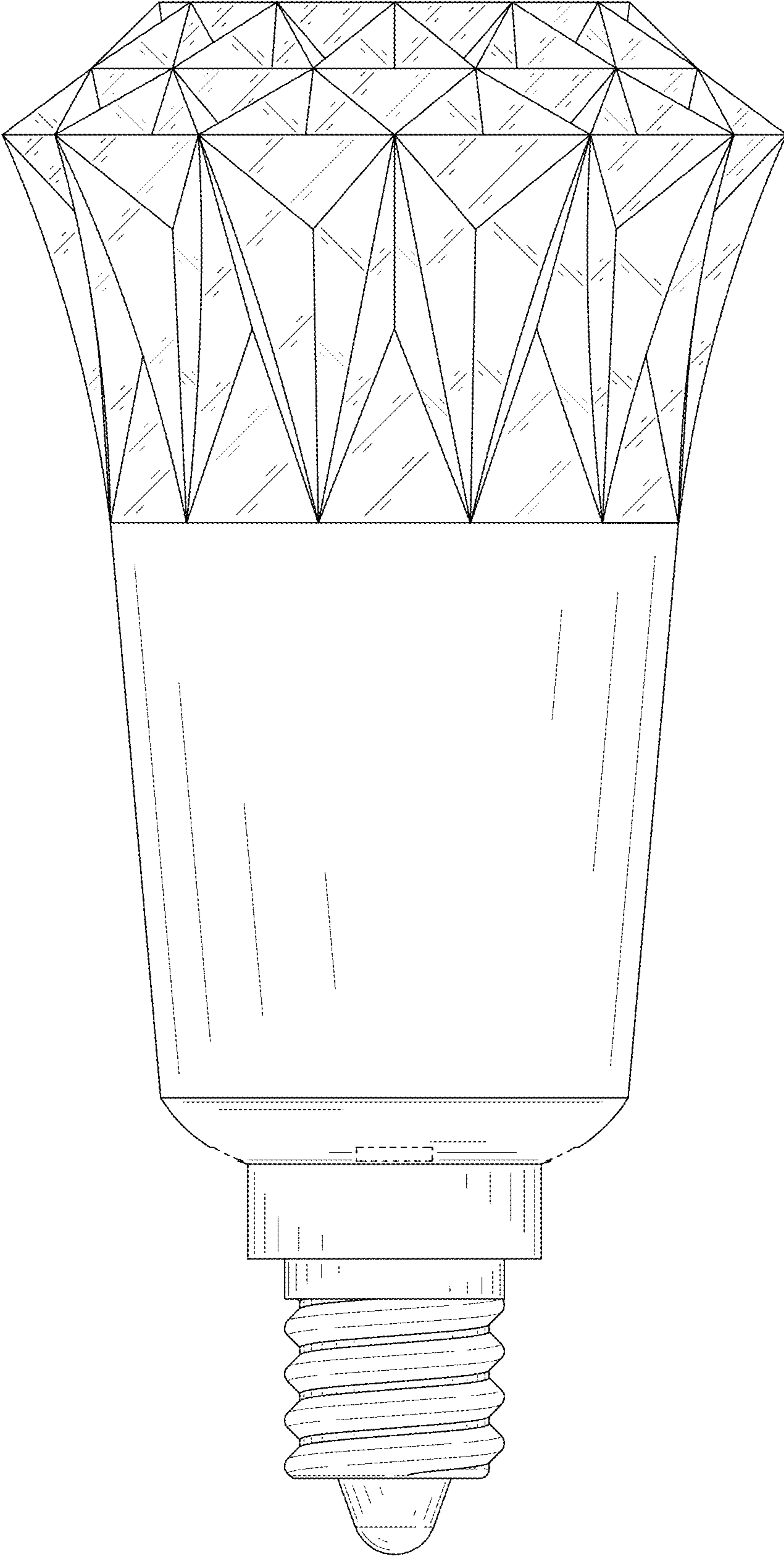

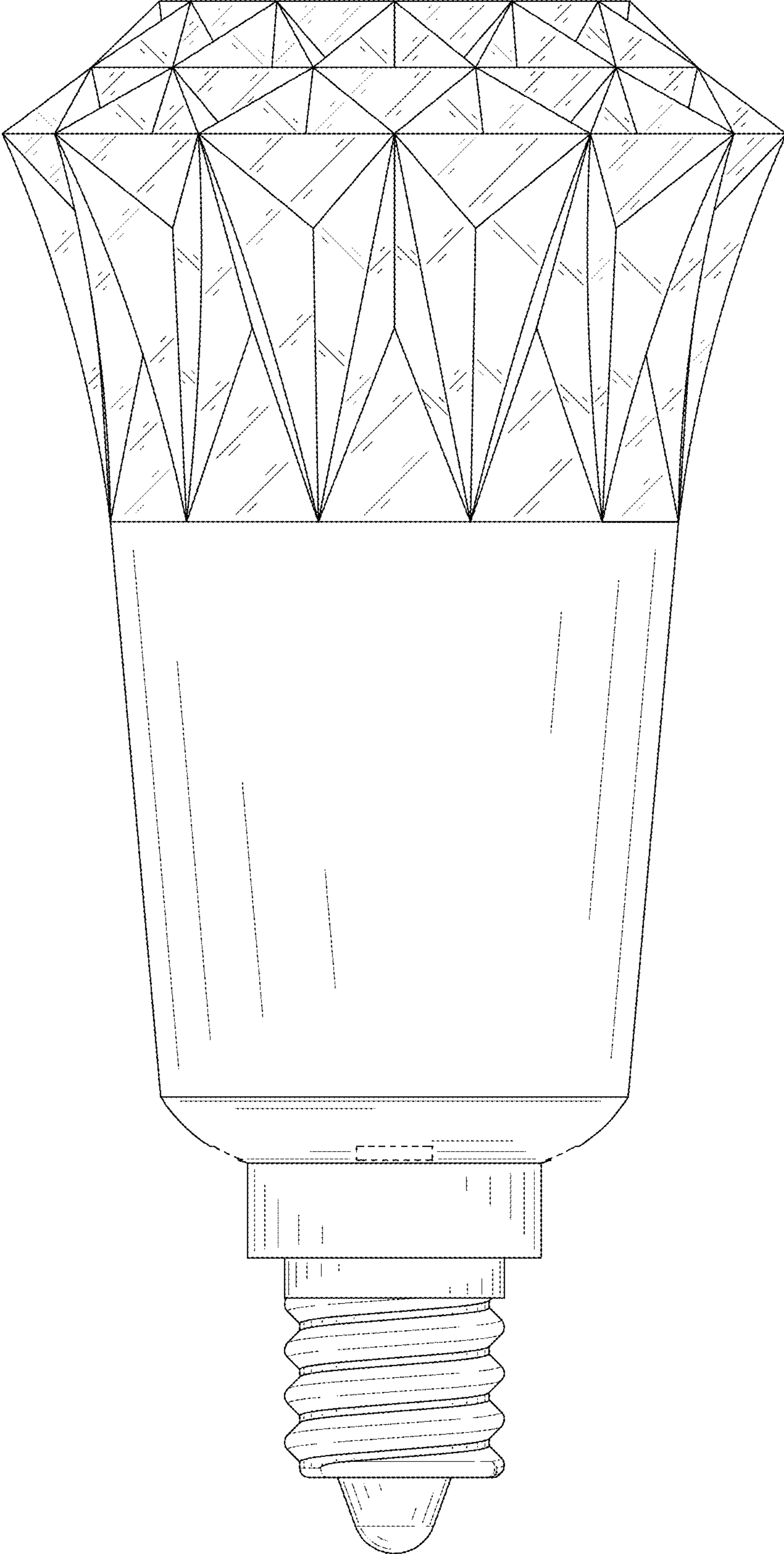

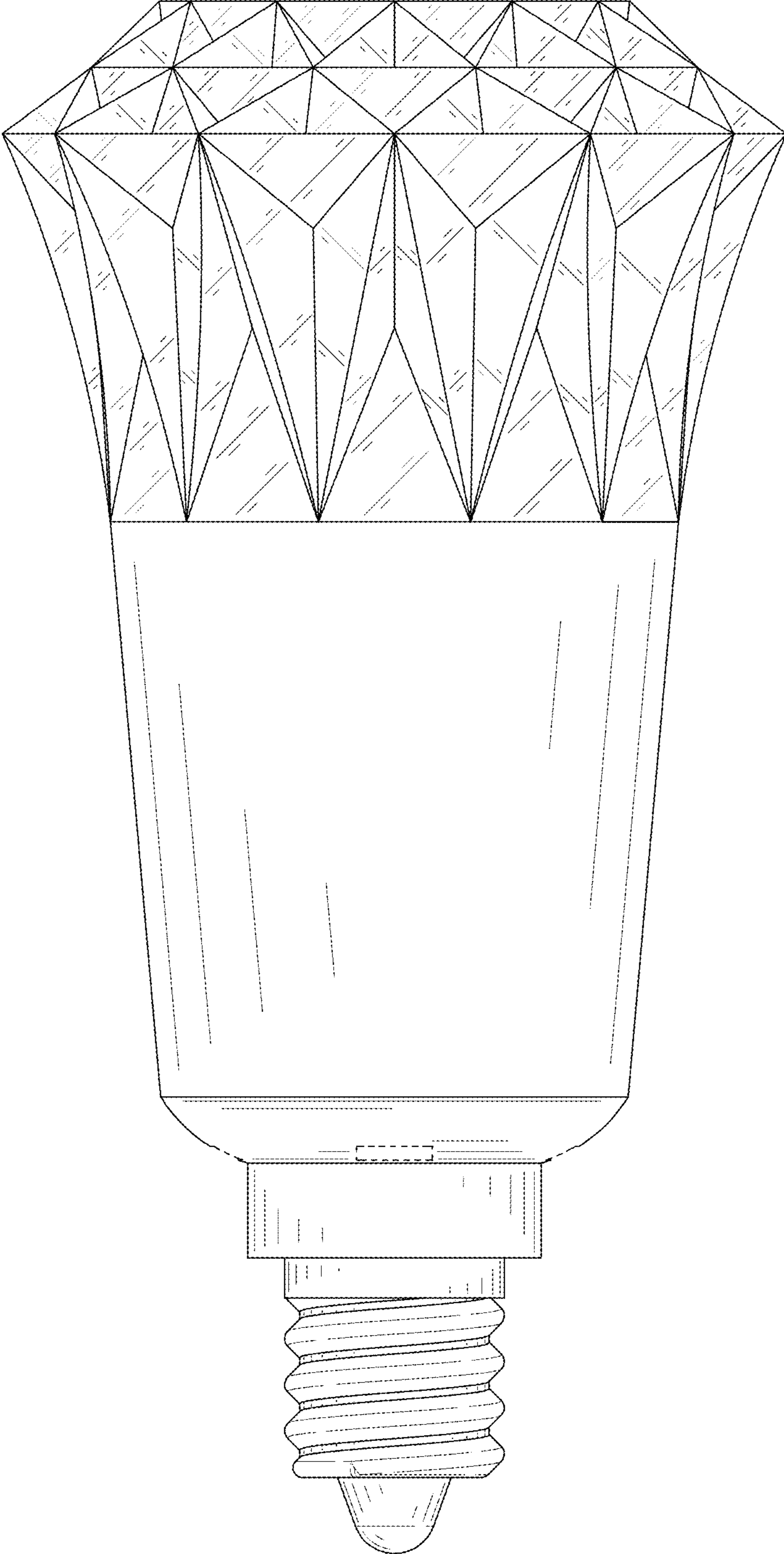

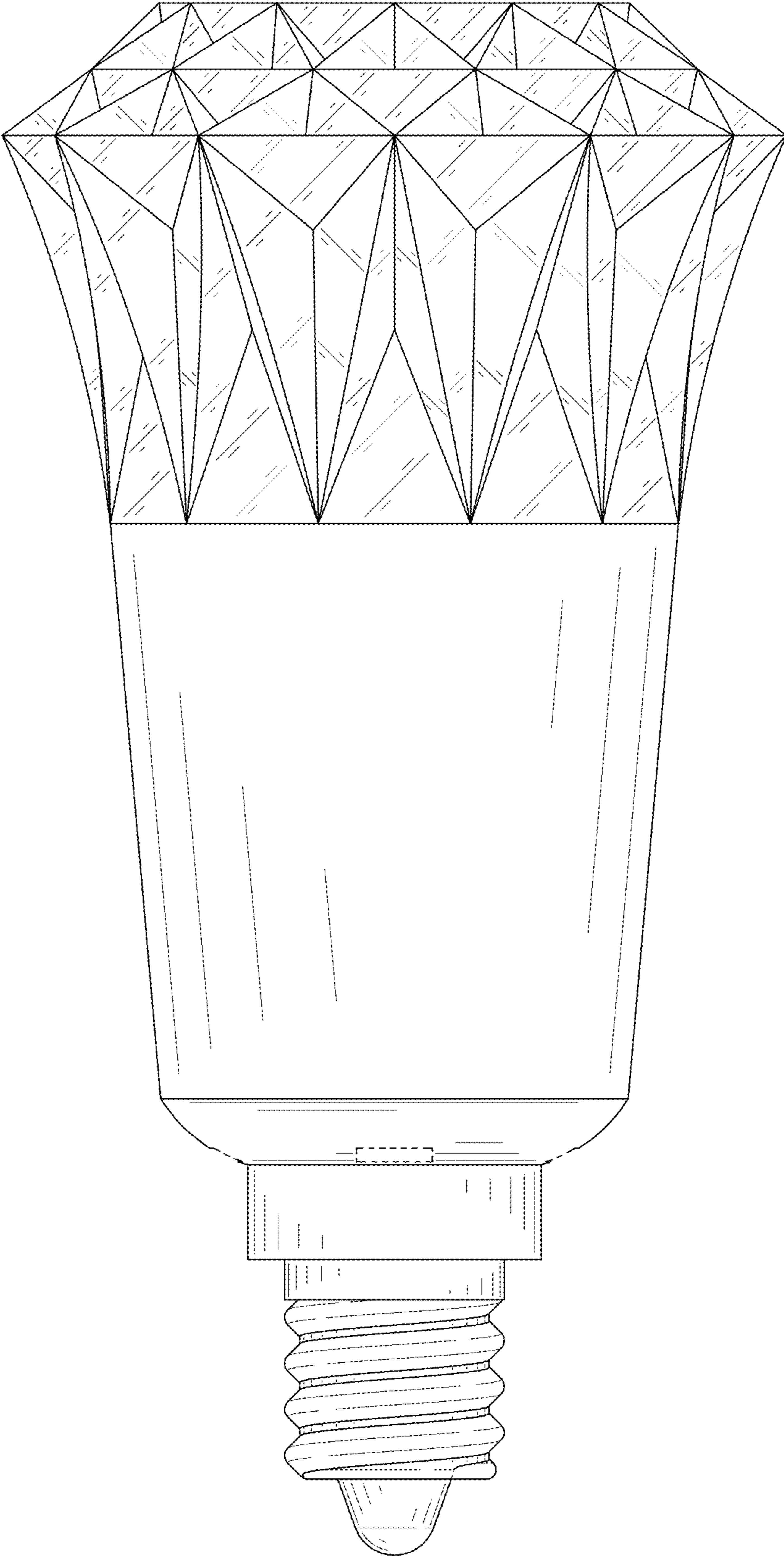

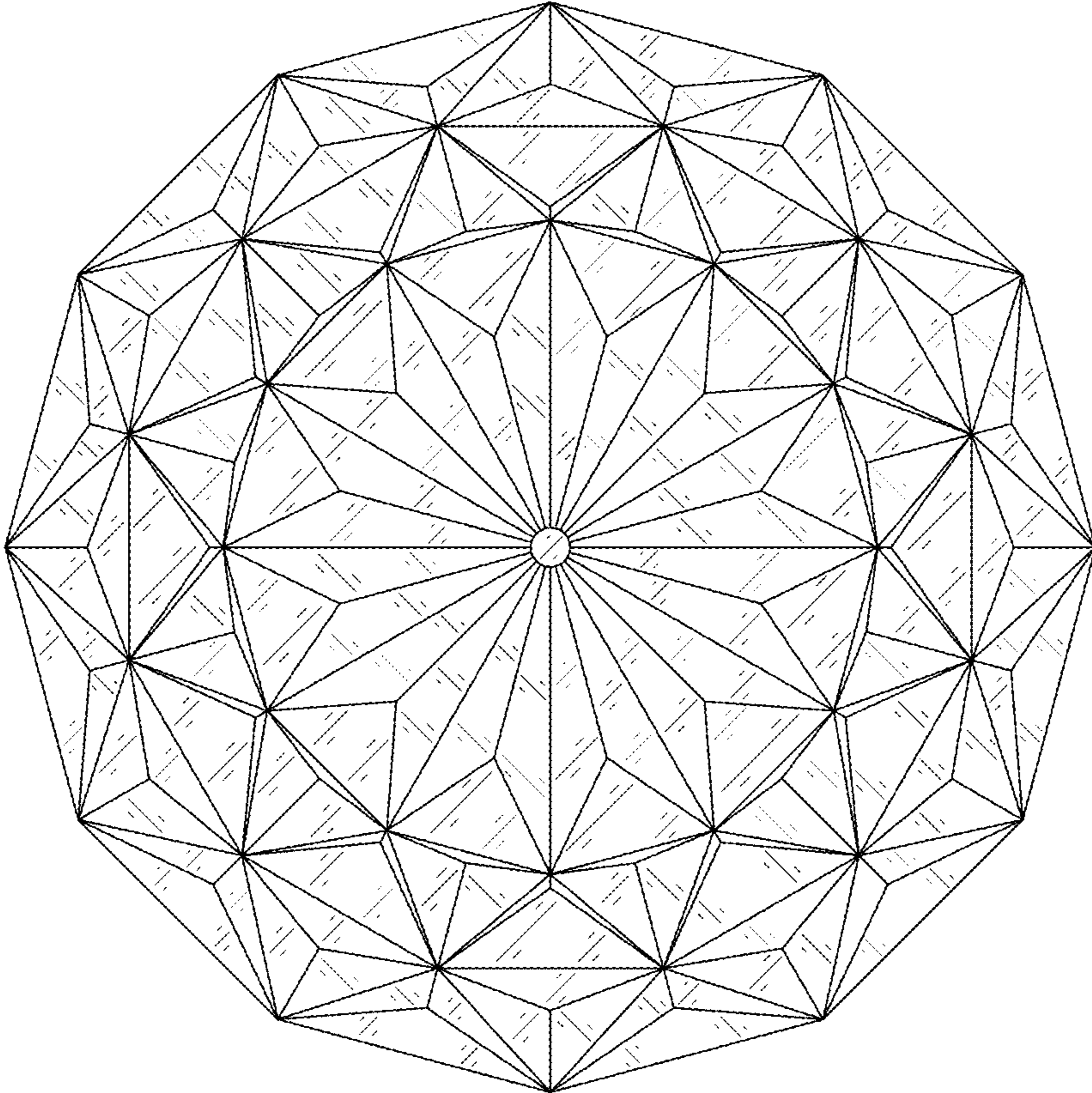

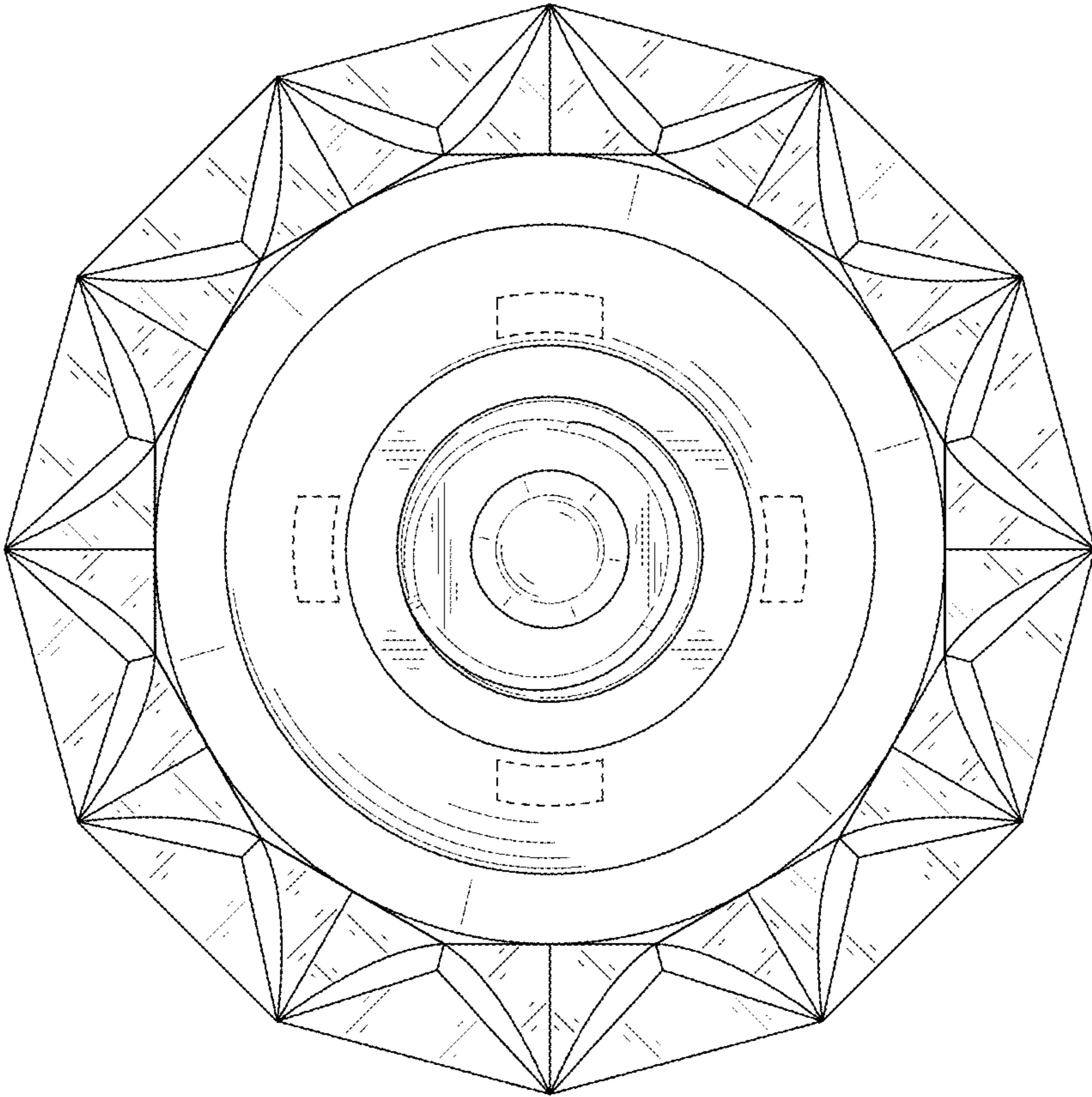
