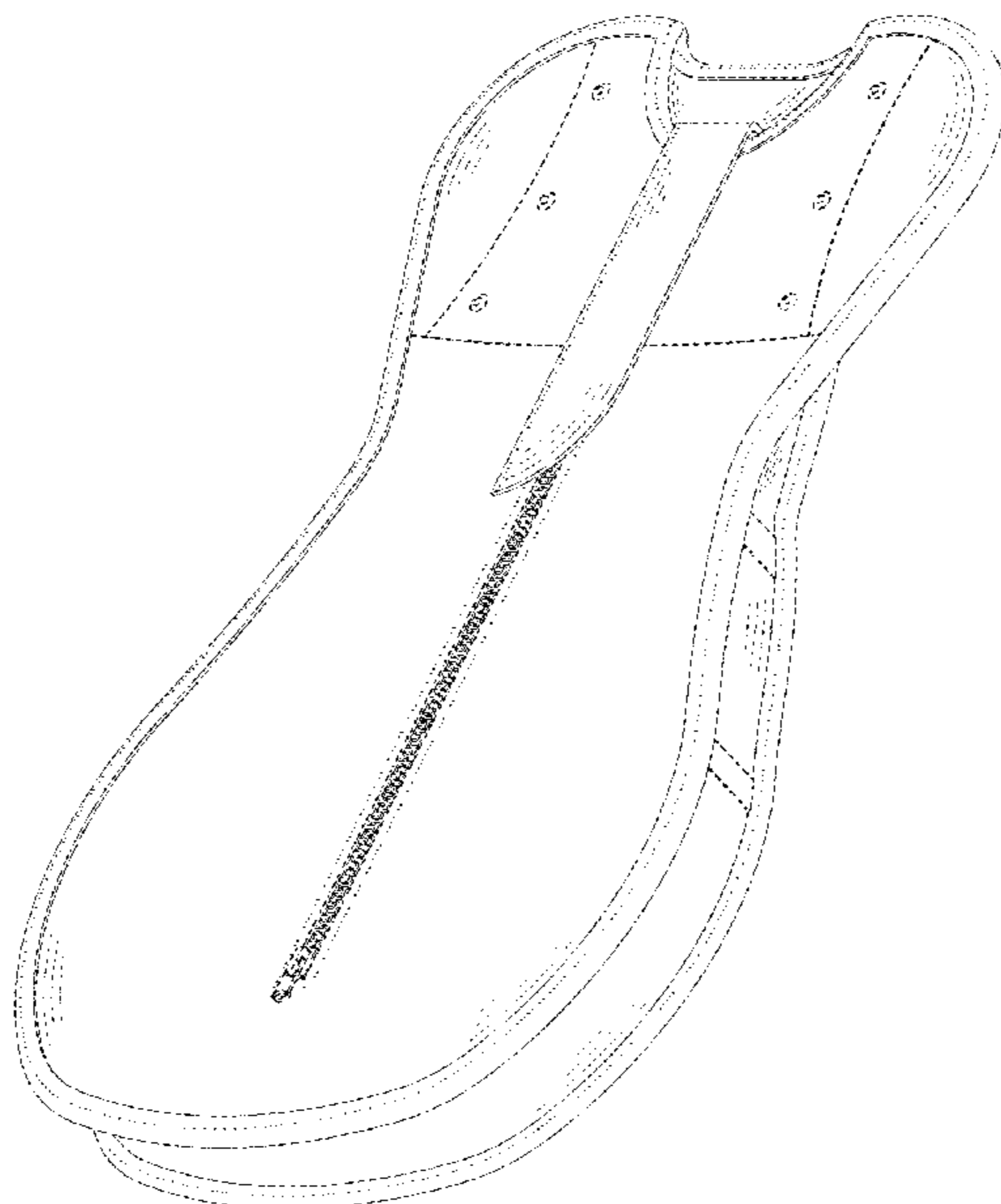
(57) **CLAIM**

The ornamental design for a baby swaddle, as shown and described.

DESCRIPTION

FIG. 1 is a front, bottom and right side perspective view of a baby swaddle, showing my new design;
FIG. 2 is a front, bottom and left side perspective view thereof;
FIG. 3 is a front, top and left side perspective view thereof;
FIG. 4 is a front elevational view thereof; and,
FIG. 5 is a back elevational view thereof.
The broken lines shown in the drawings illustrate portions of the baby swaddle that form no part of the claimed design. The dot lines depict stitching of the baby swaddle that do not form part of the claimed design.

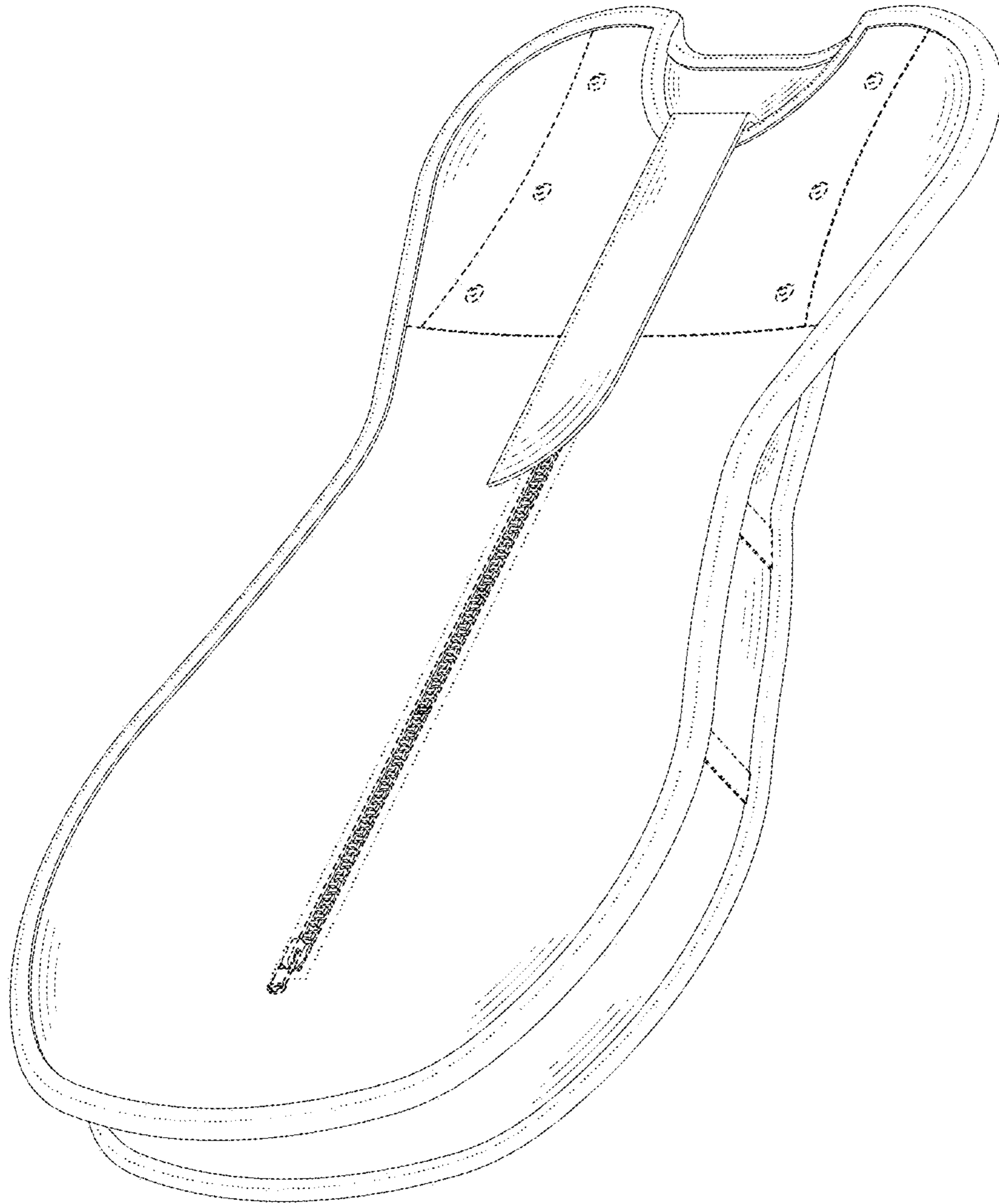

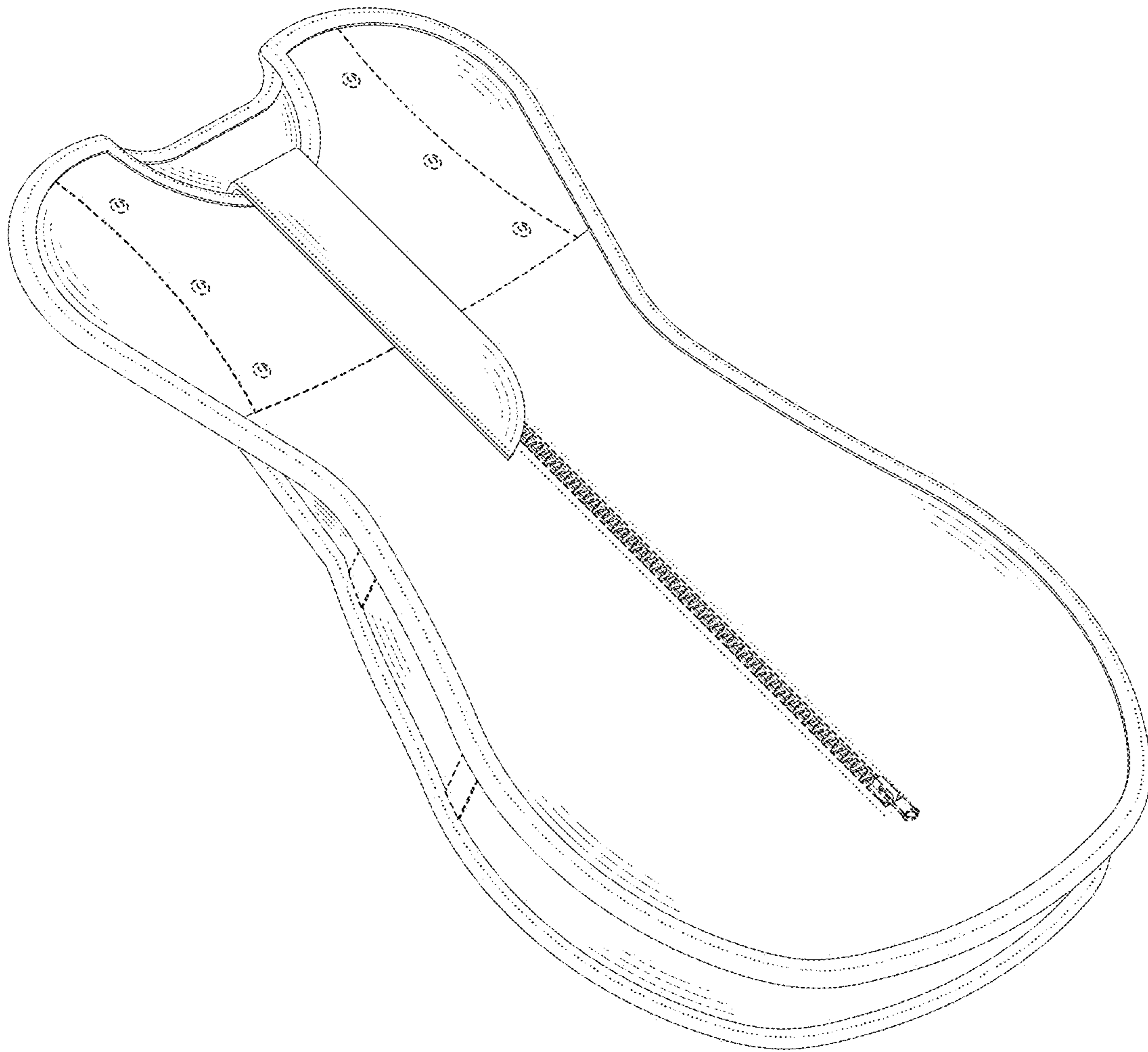

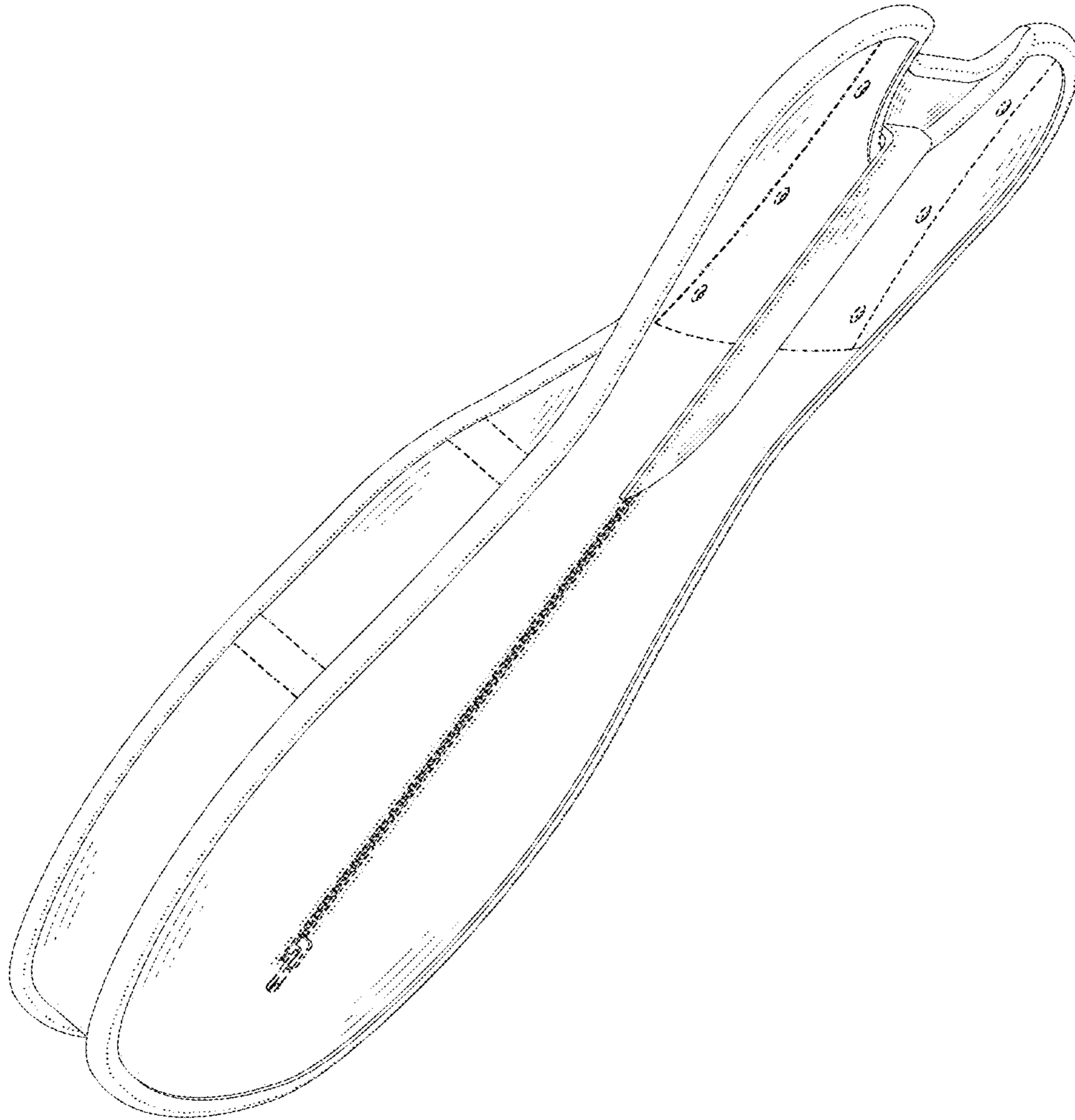

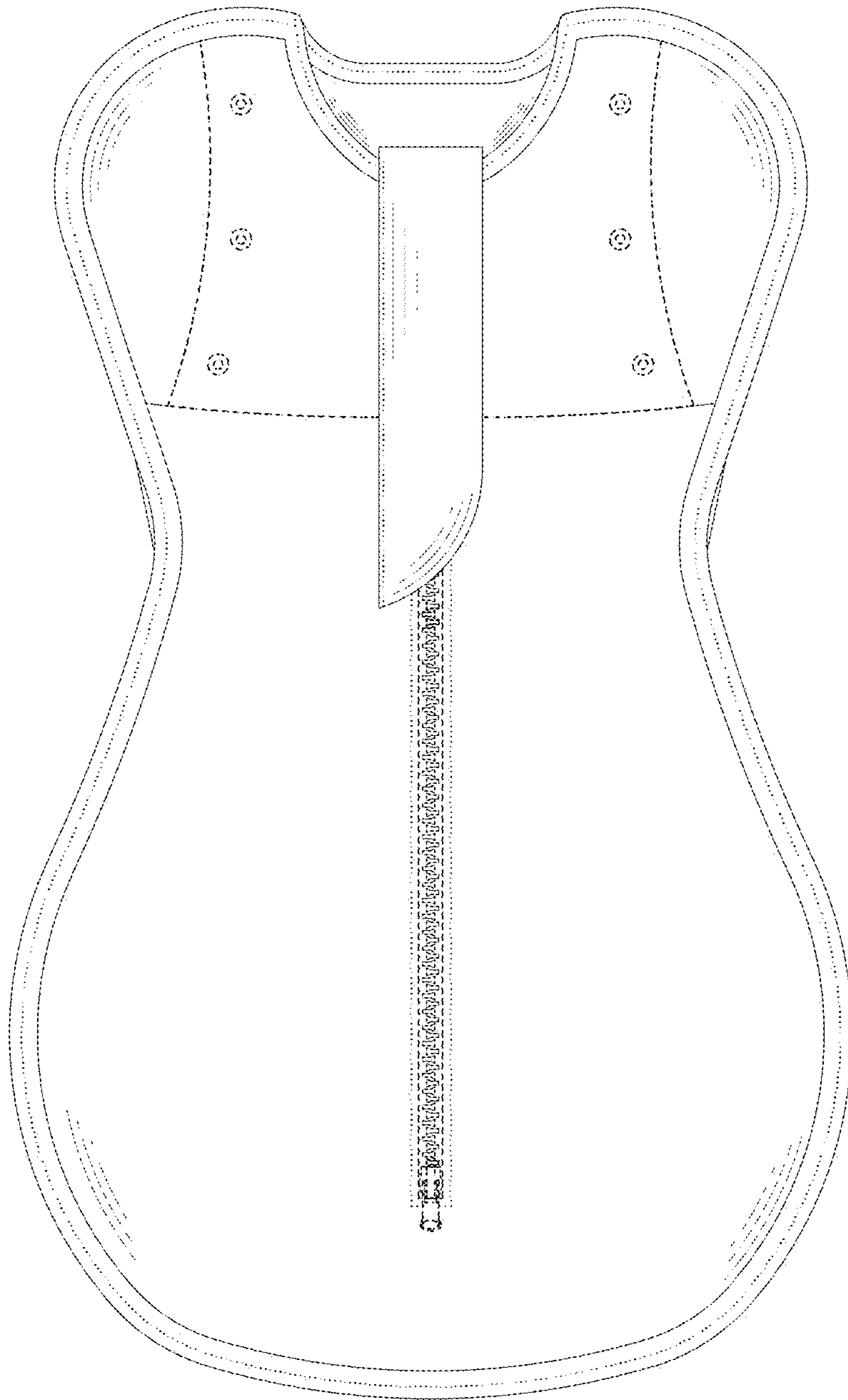

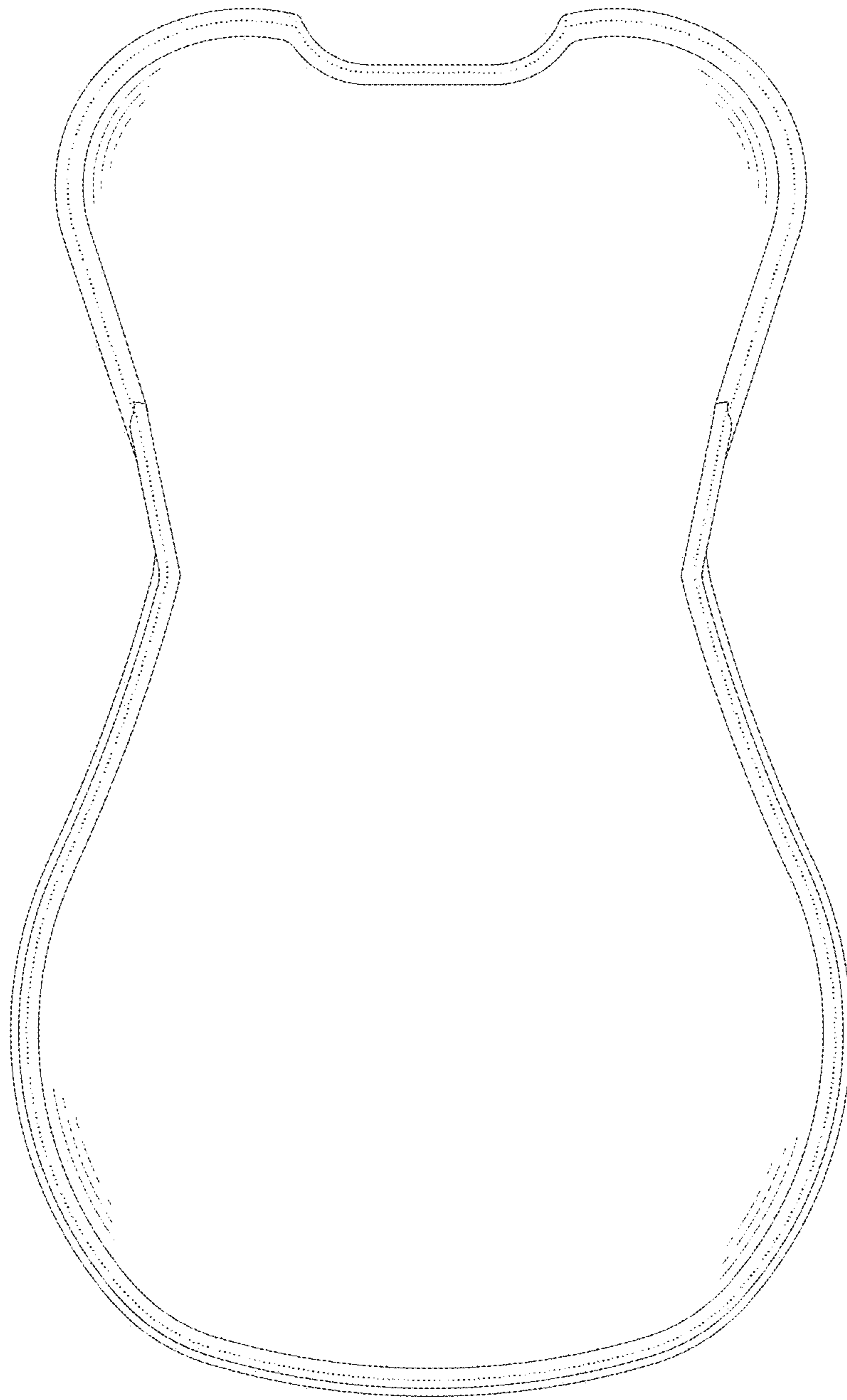
