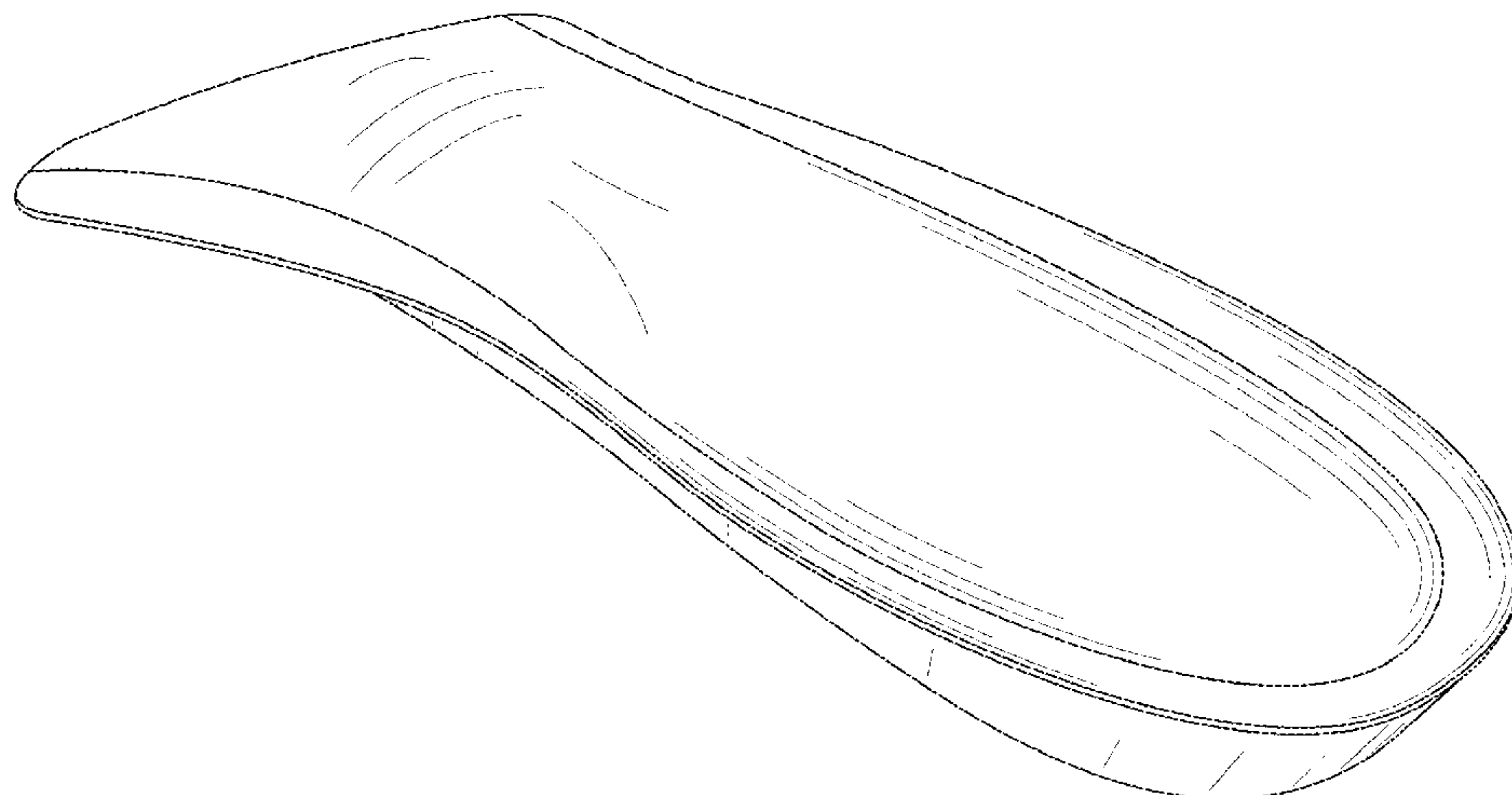


FIG. 17 is an outer-side view of the footbed of FIG. 14.

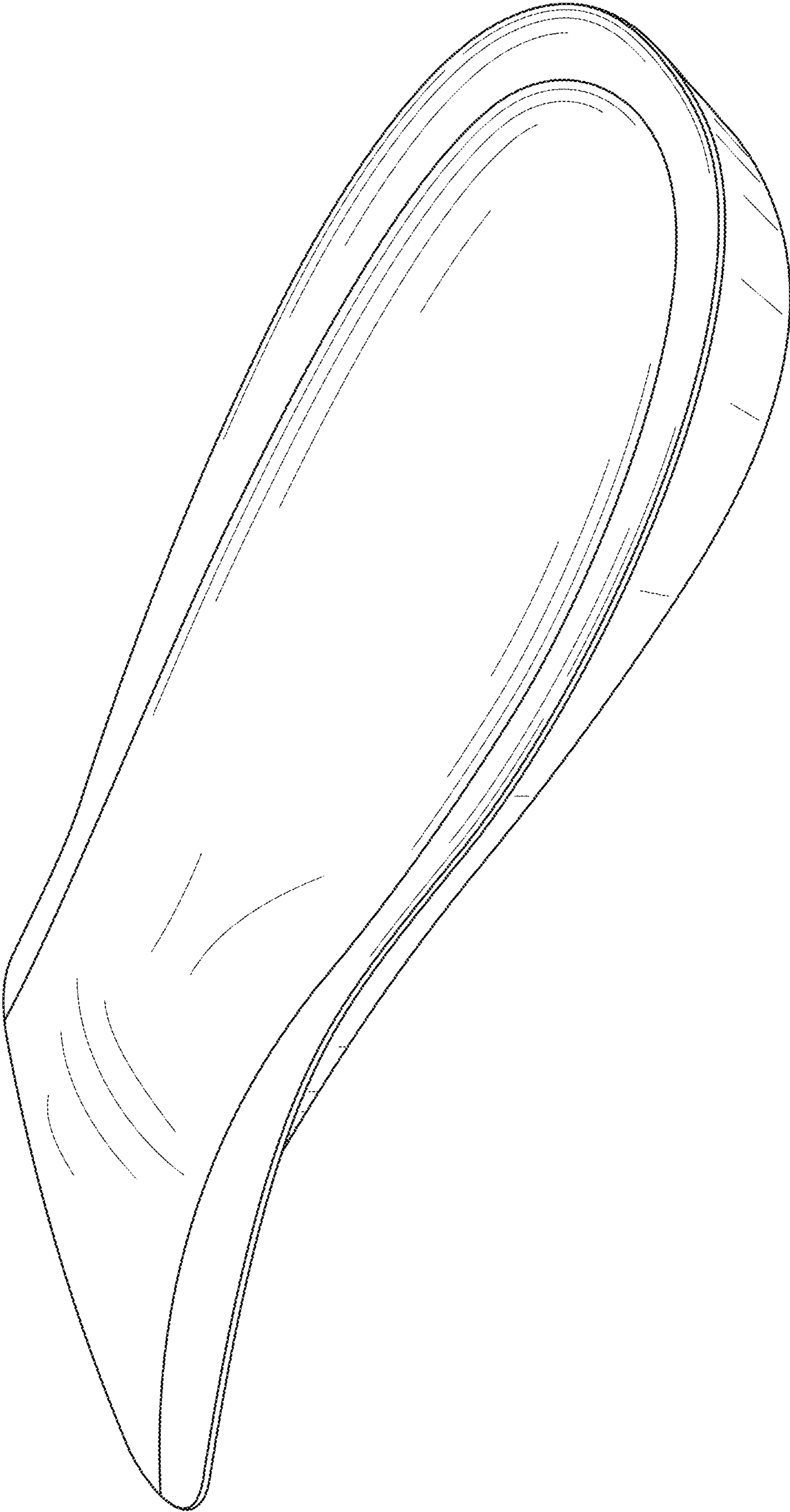

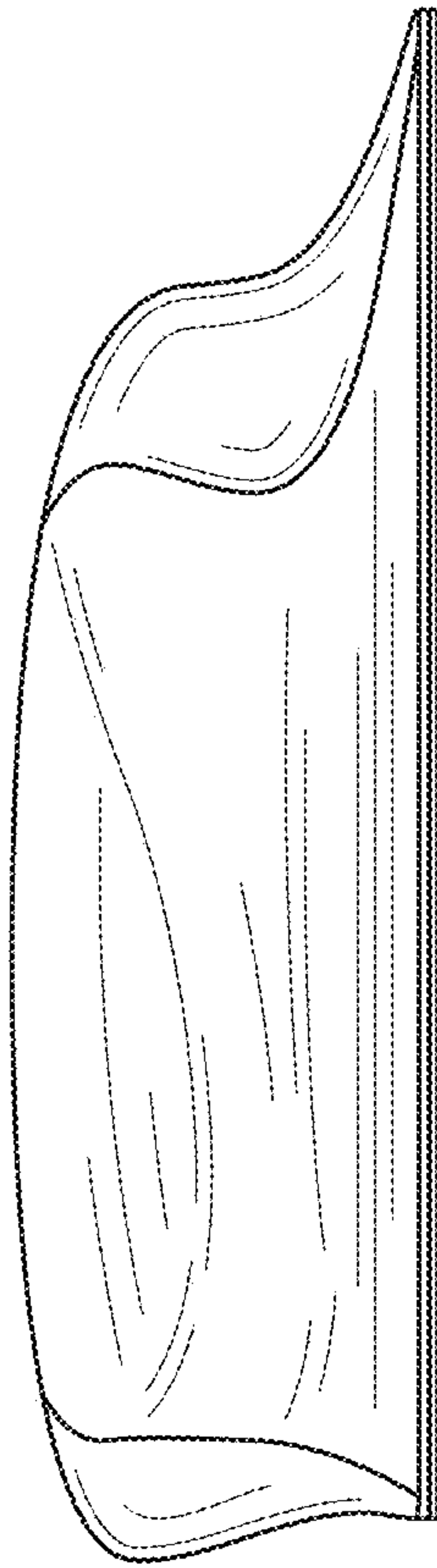

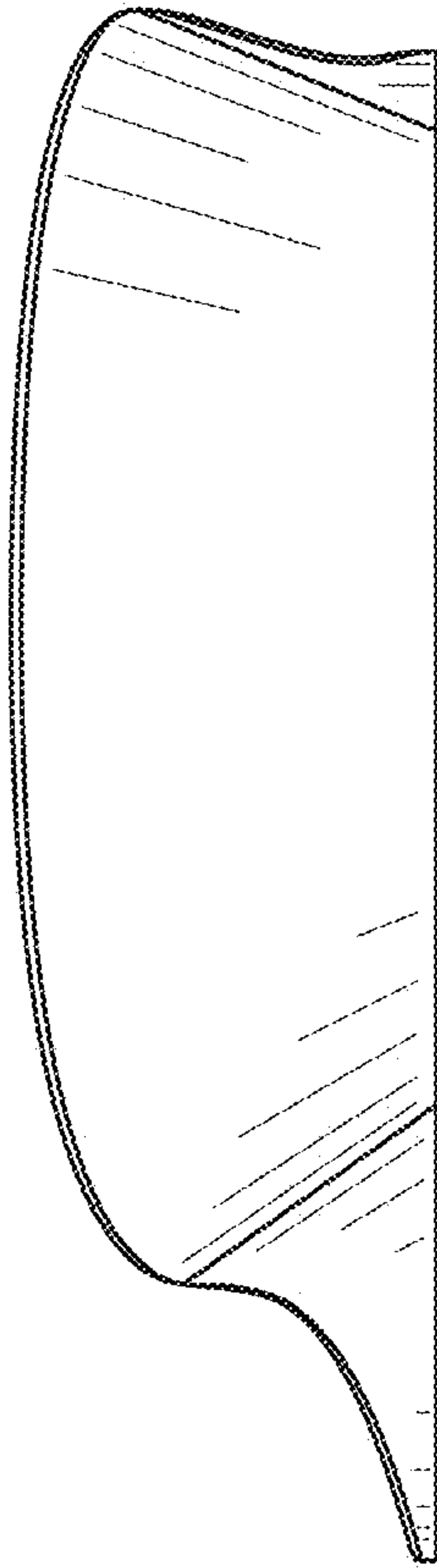

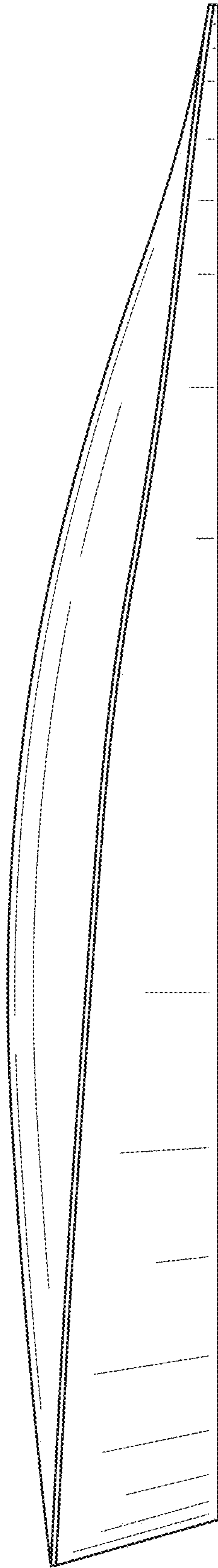

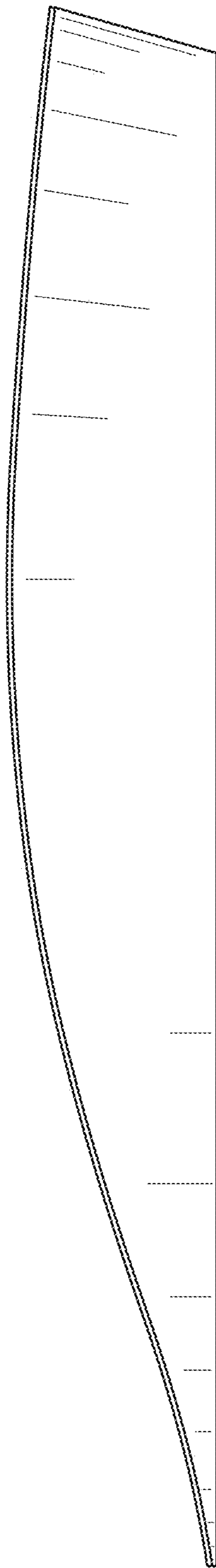

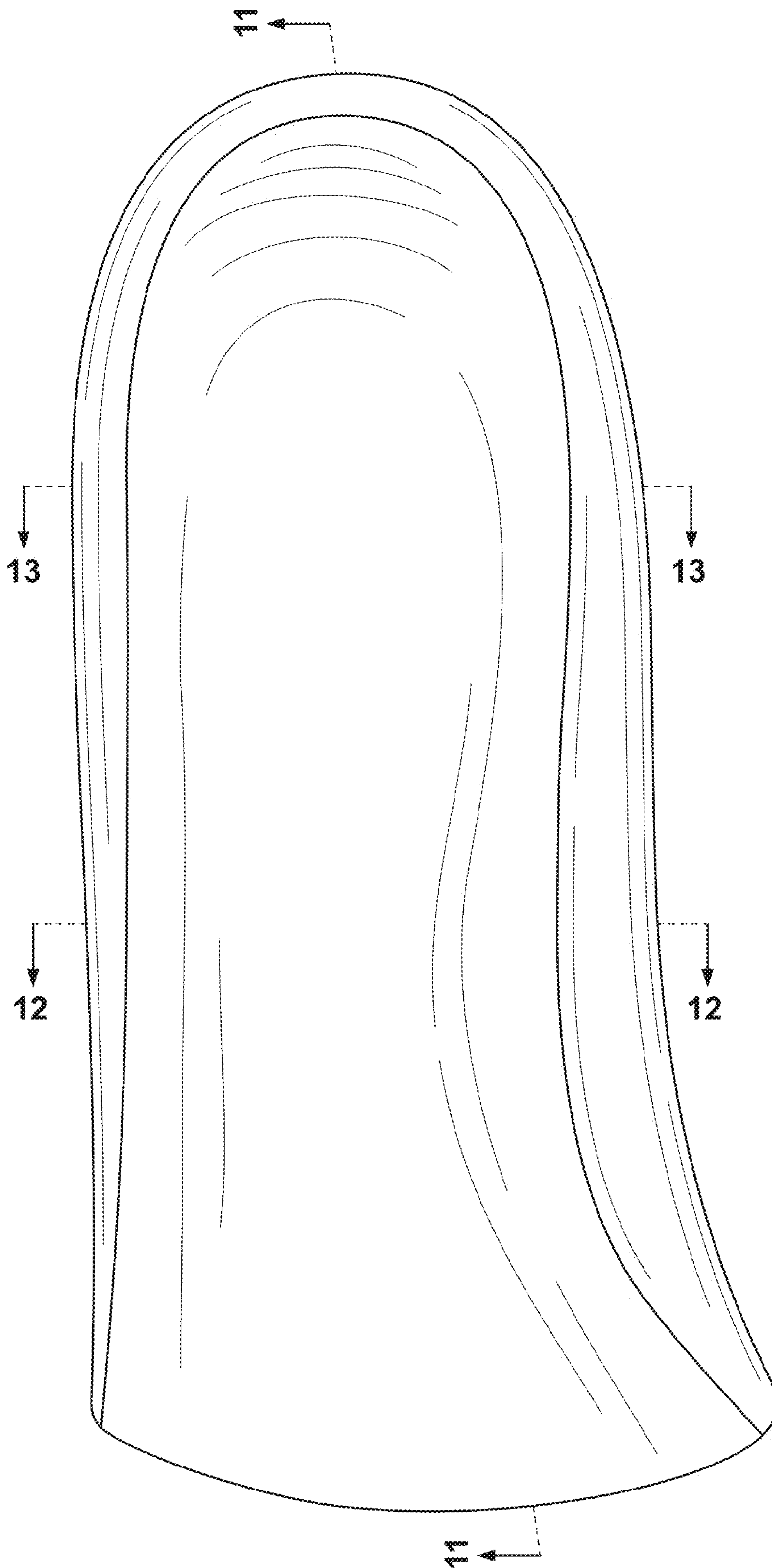

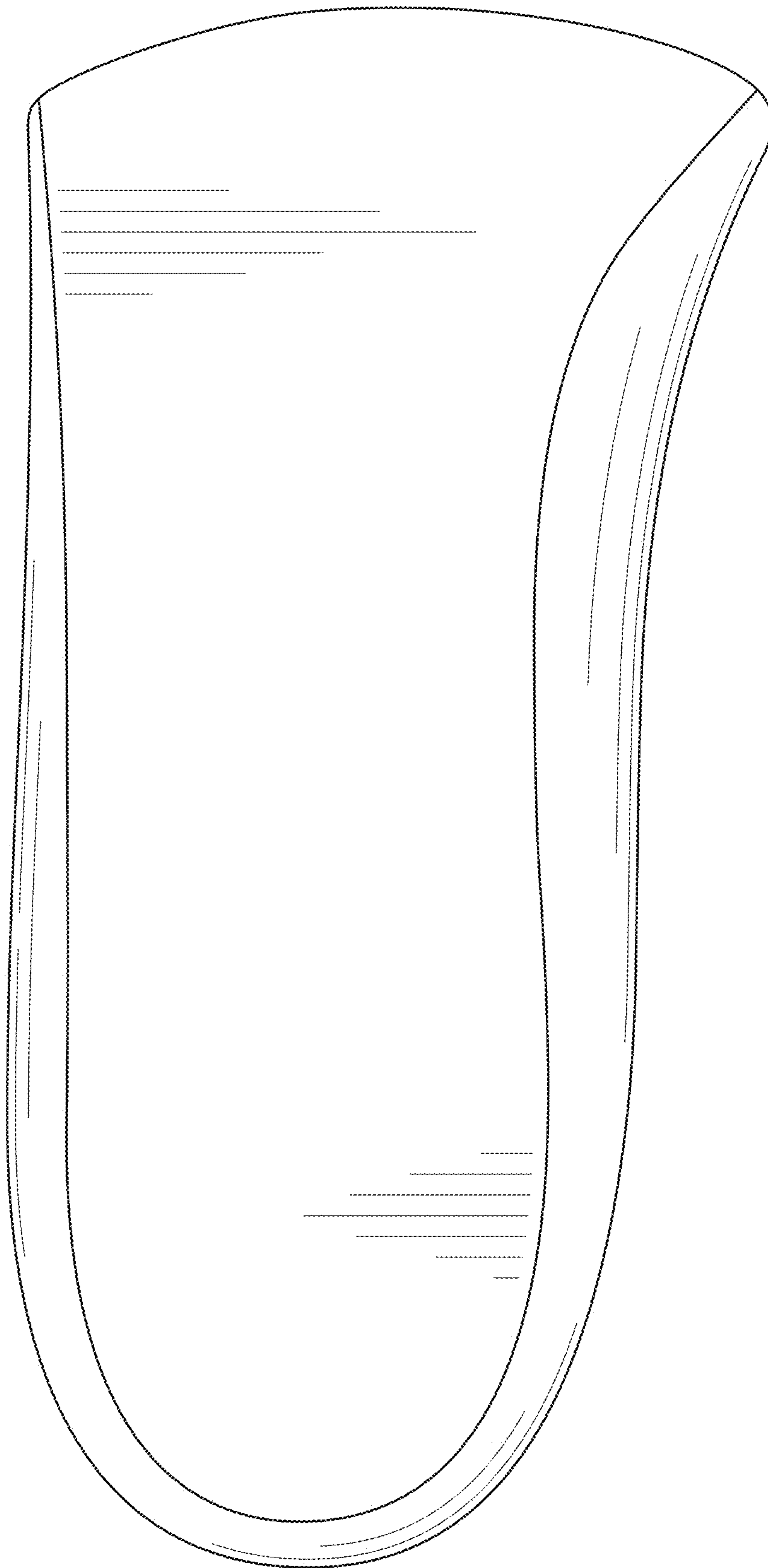

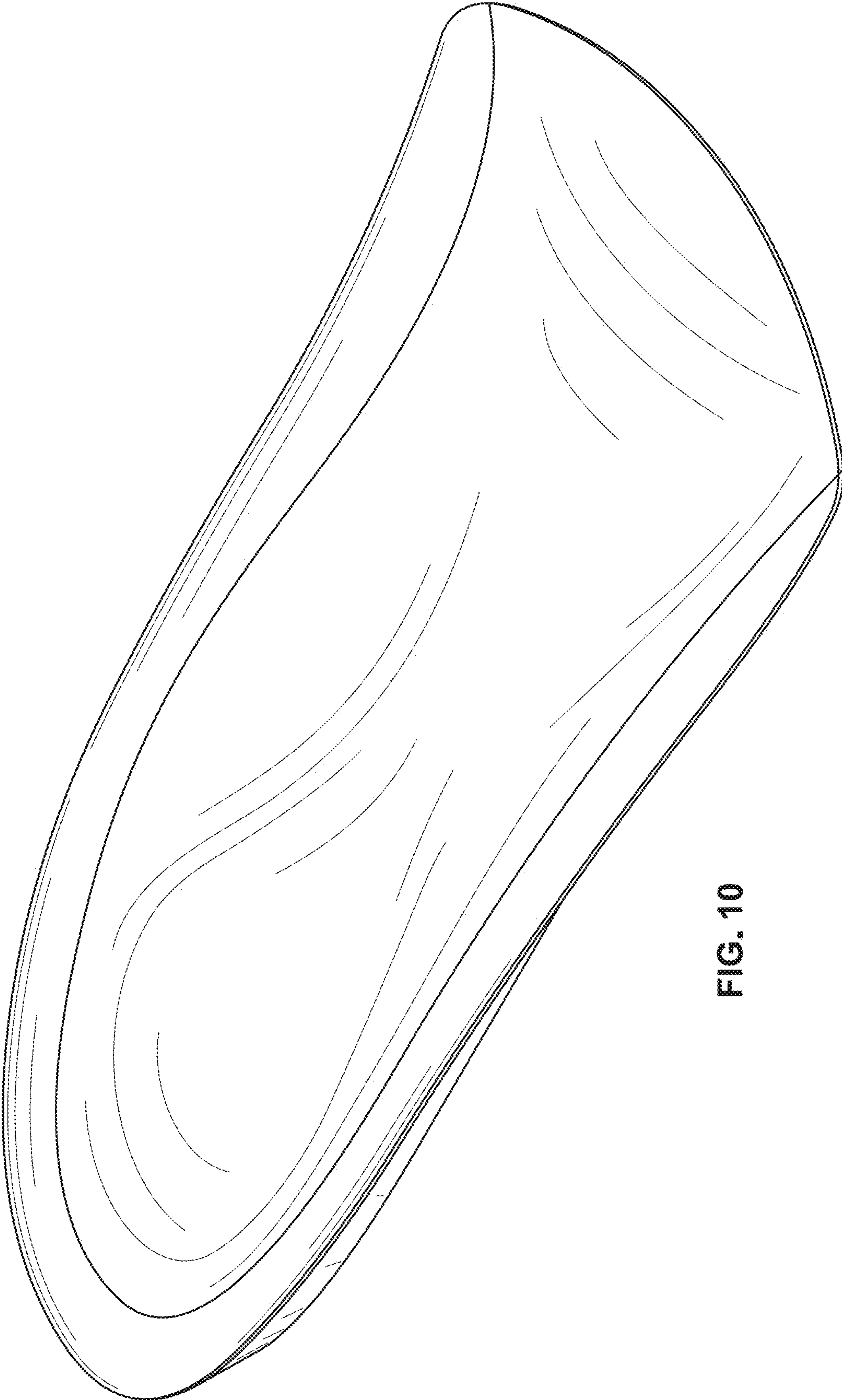

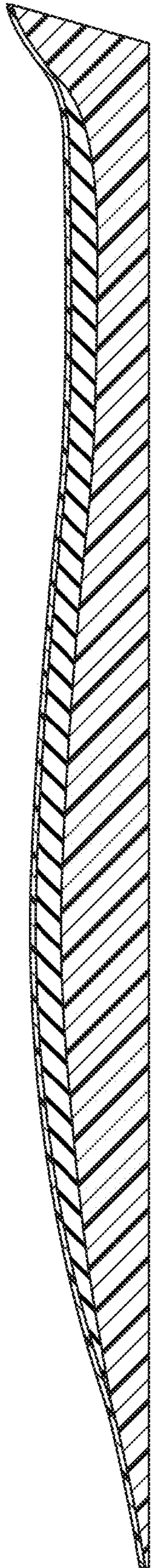

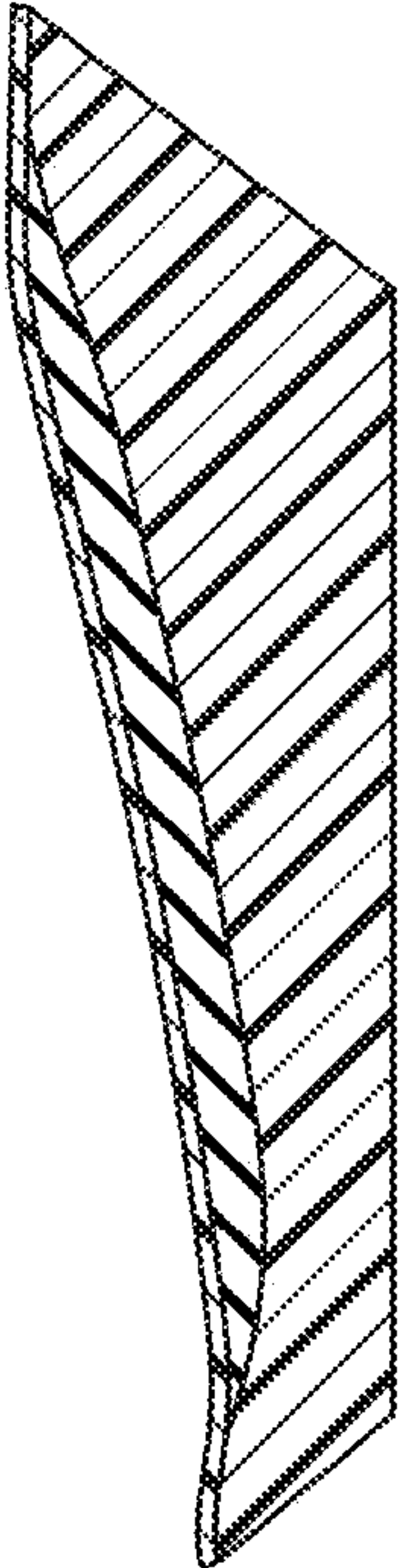

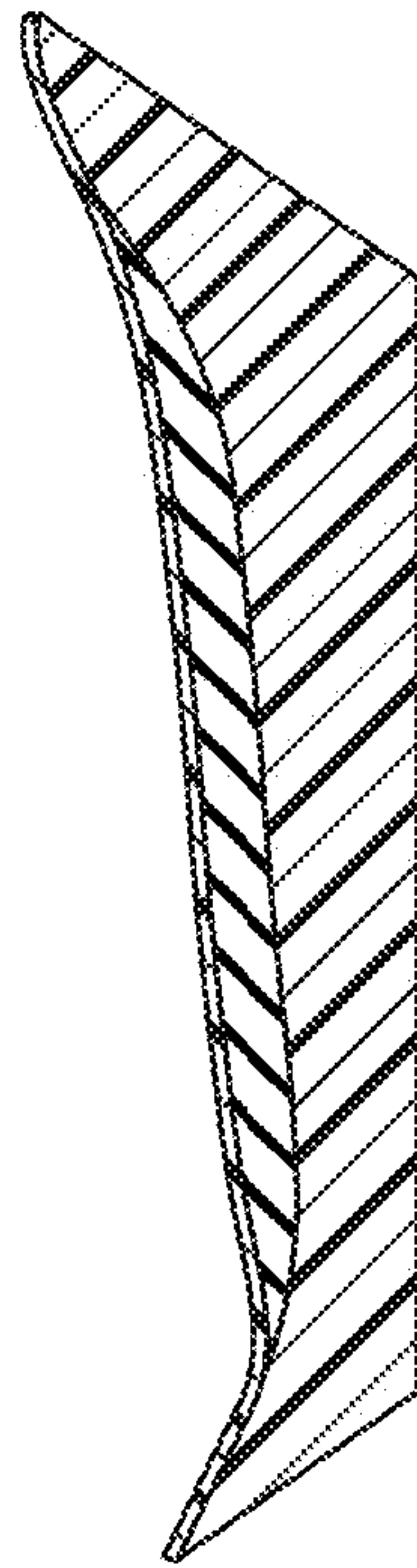

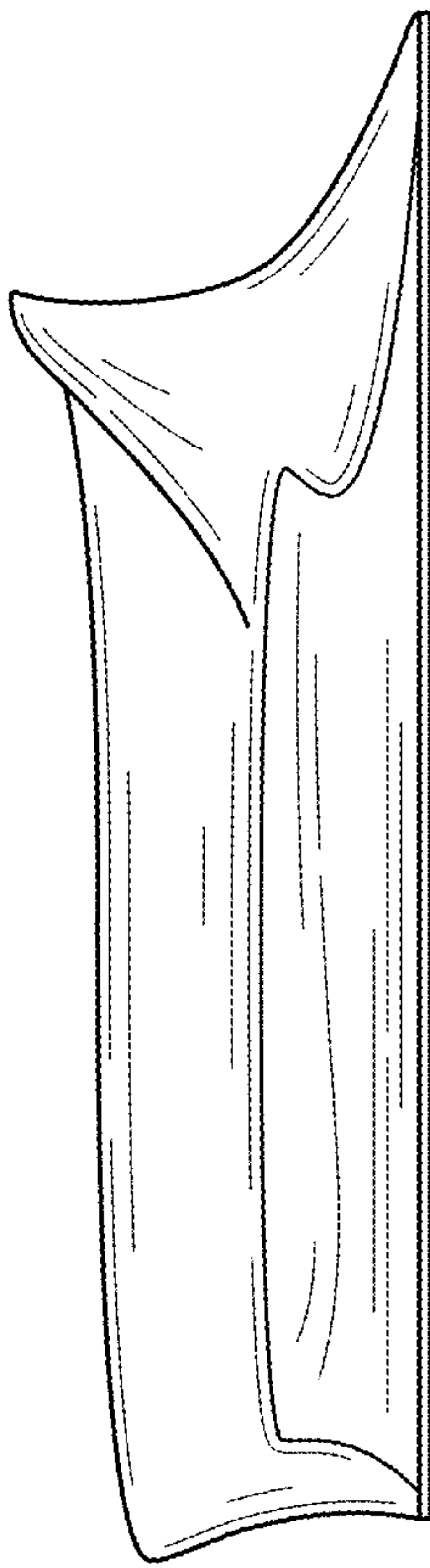

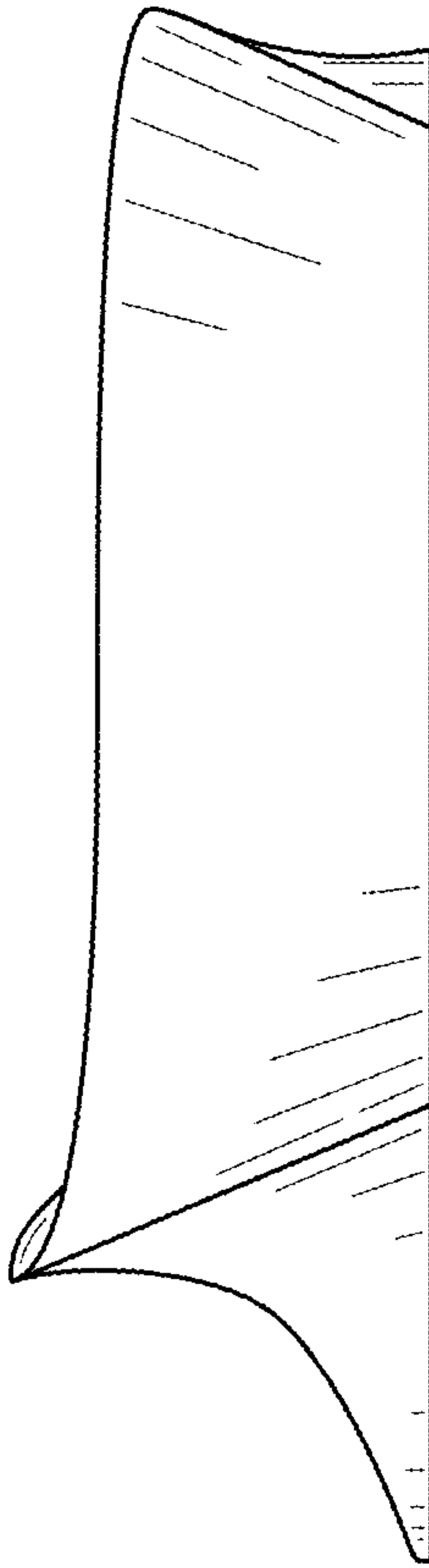

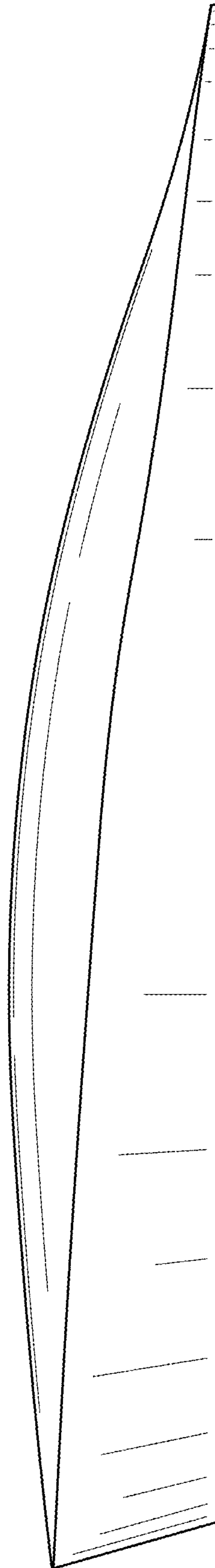

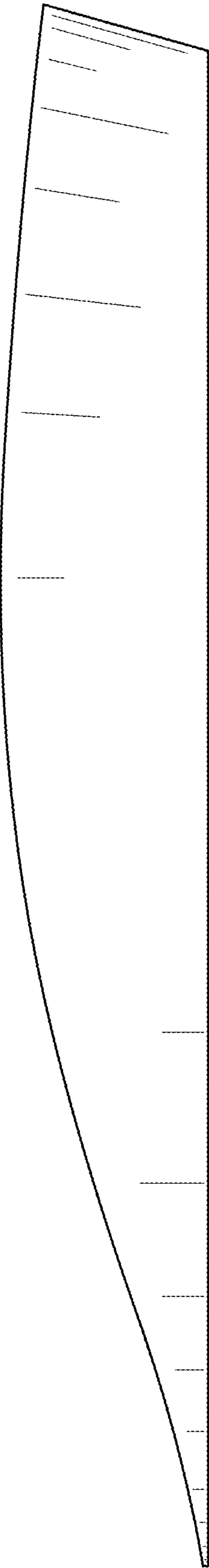

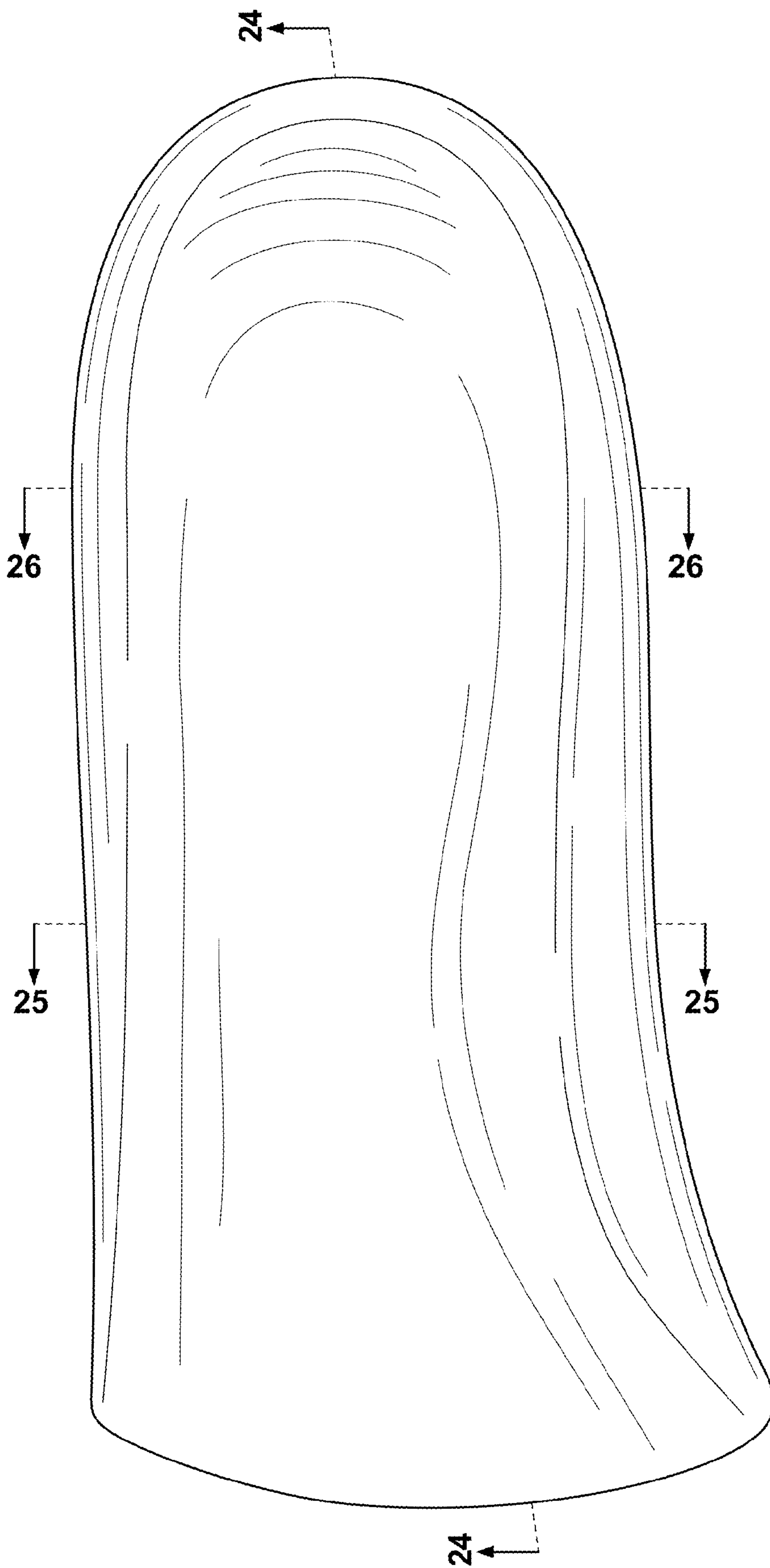

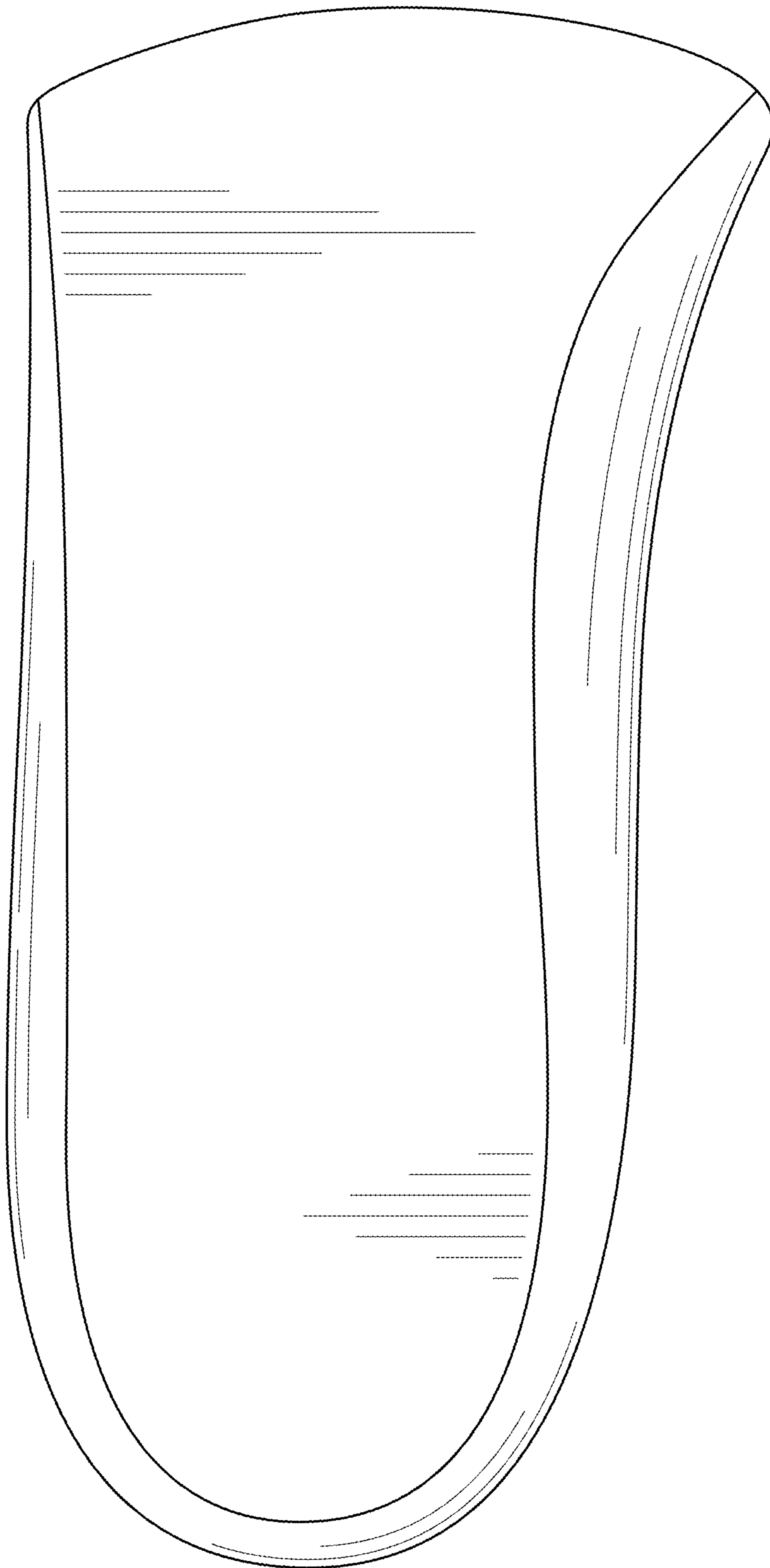

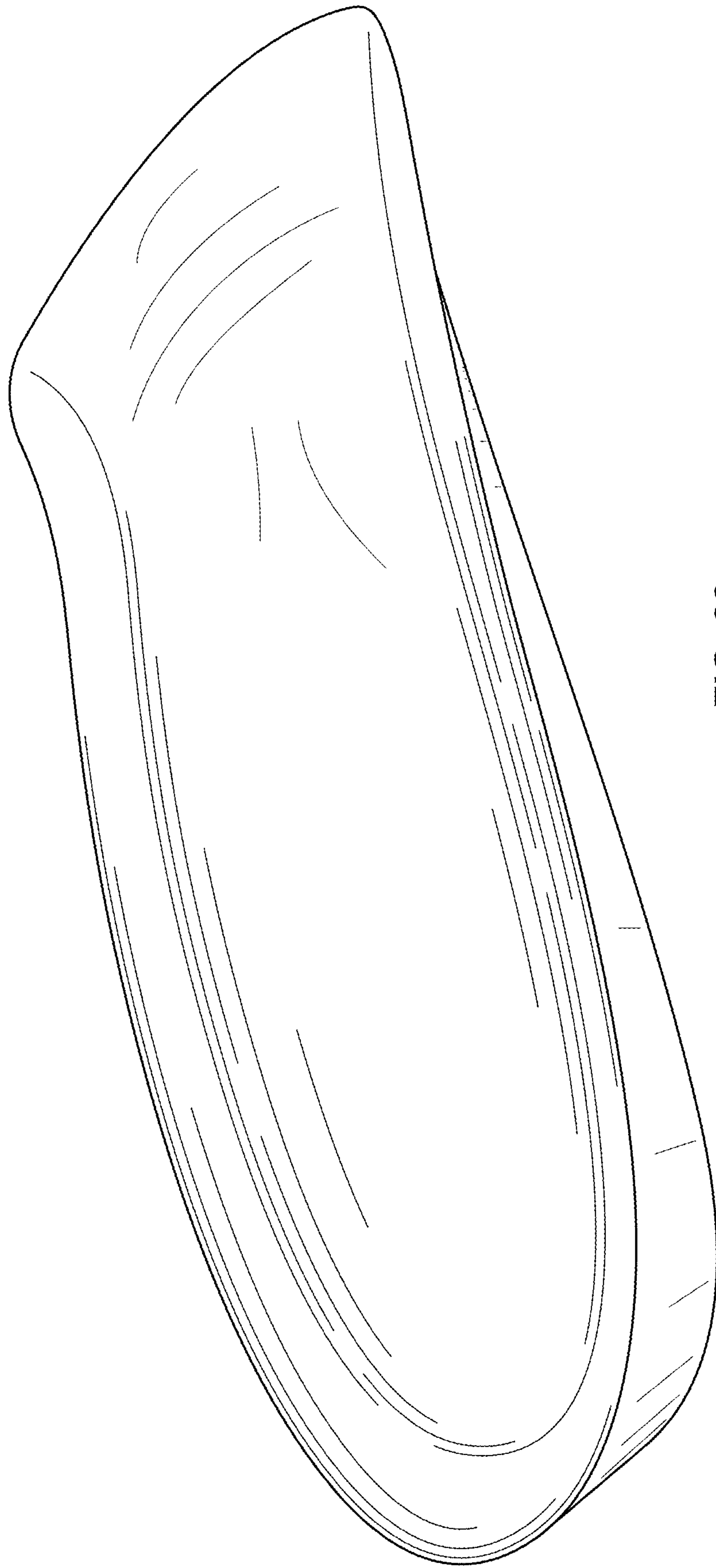

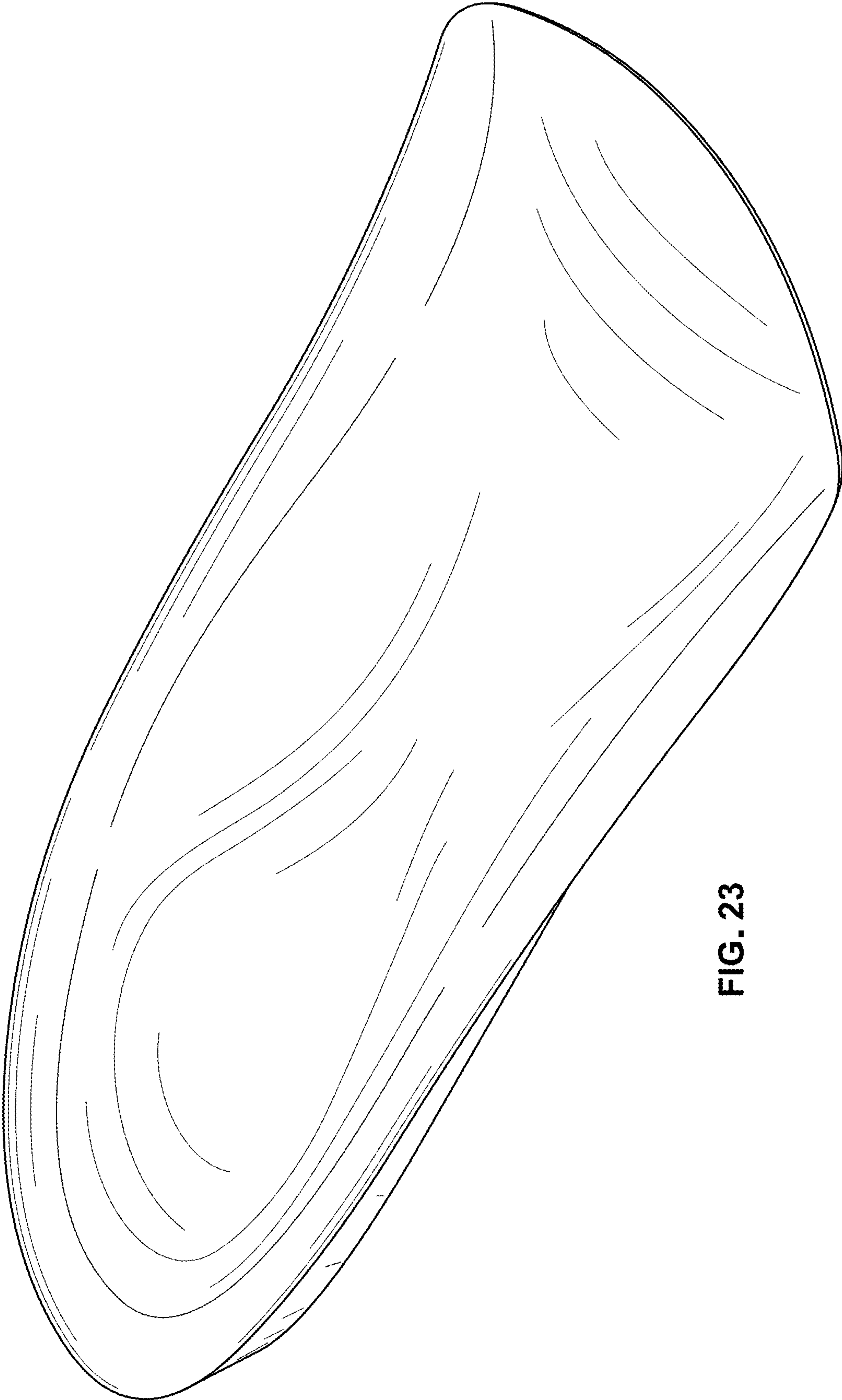

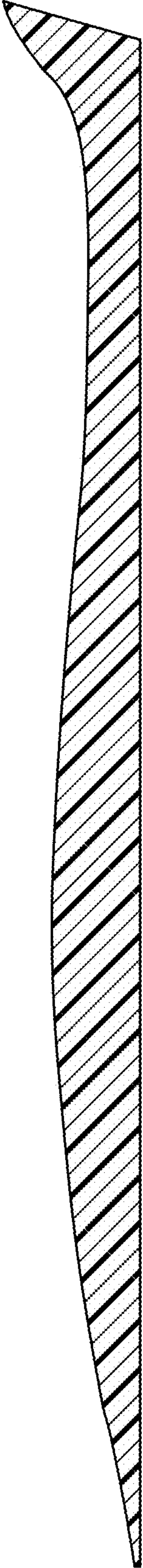

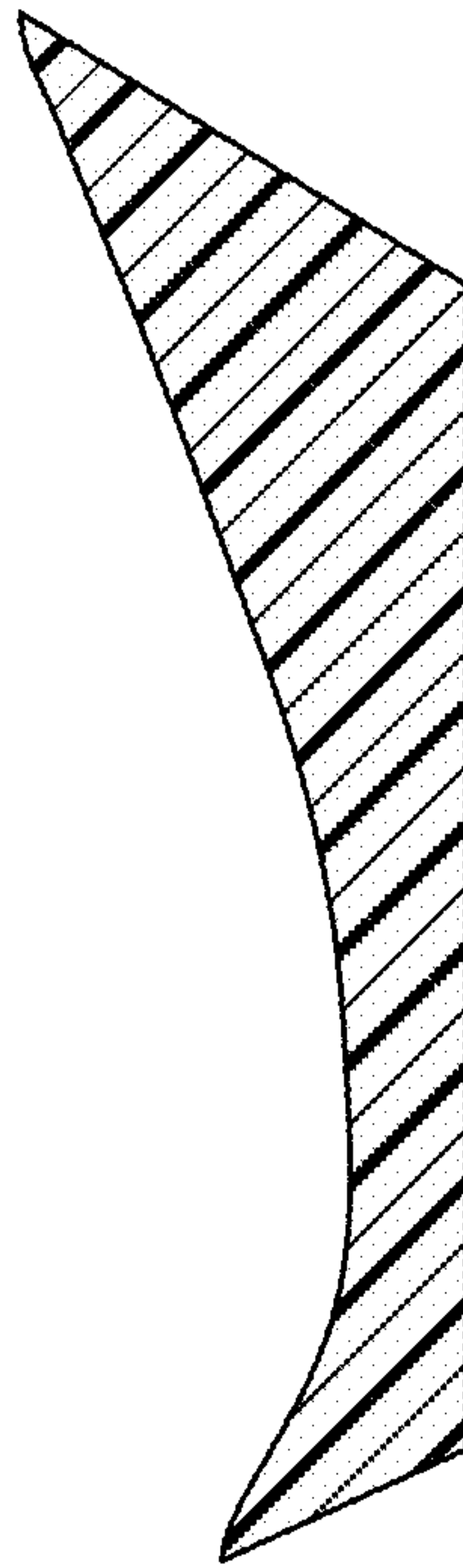

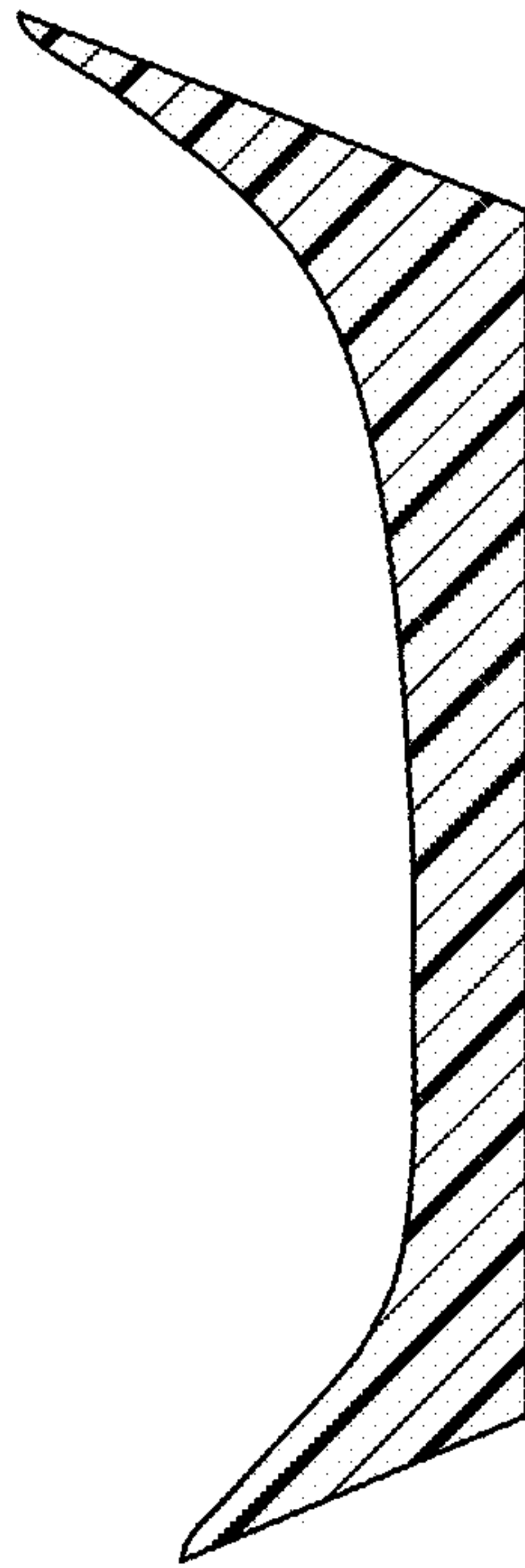
