FIG. 7 is a top view thereof.

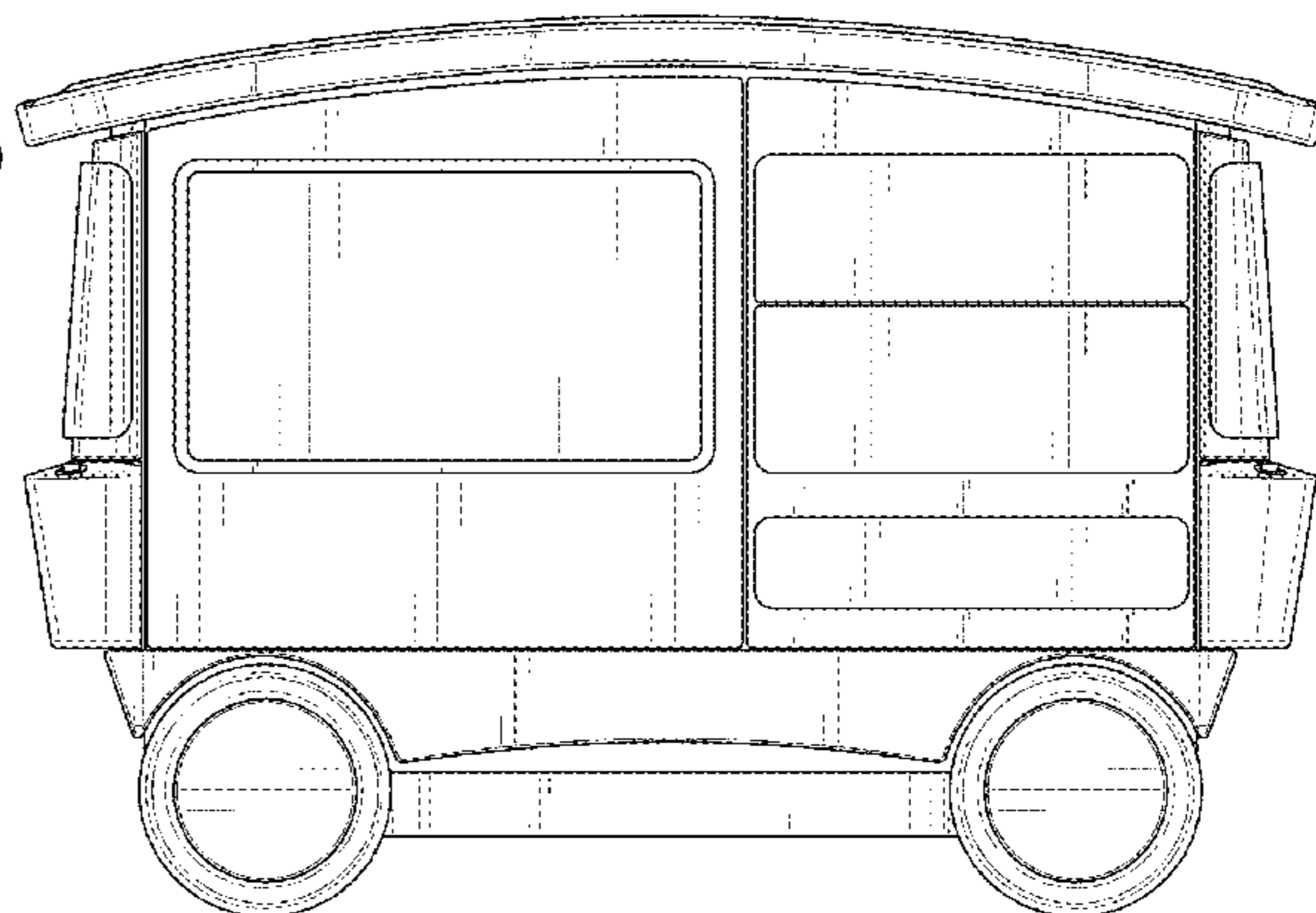
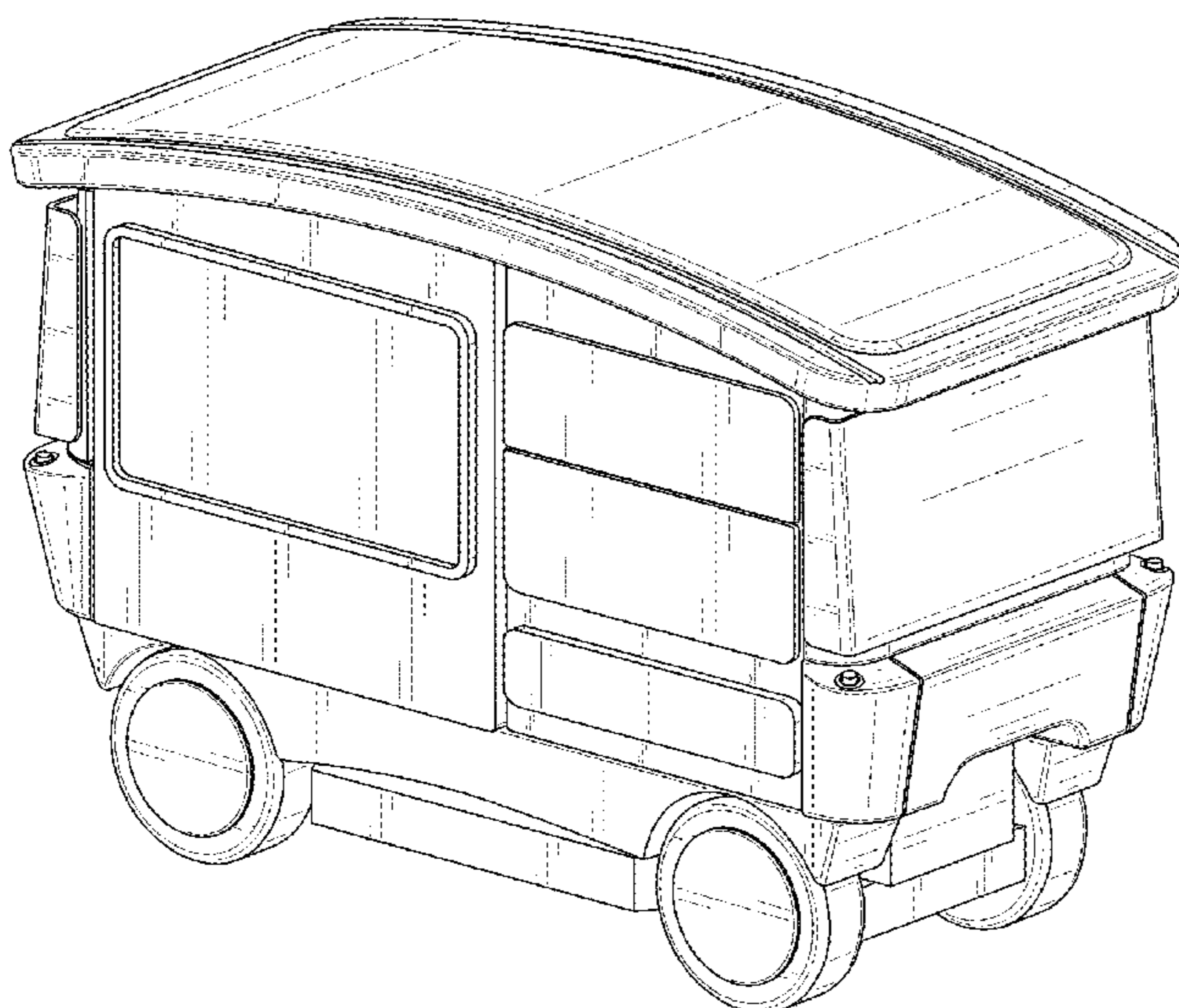
FIG. 8 is another perspective view of the vending mobile in

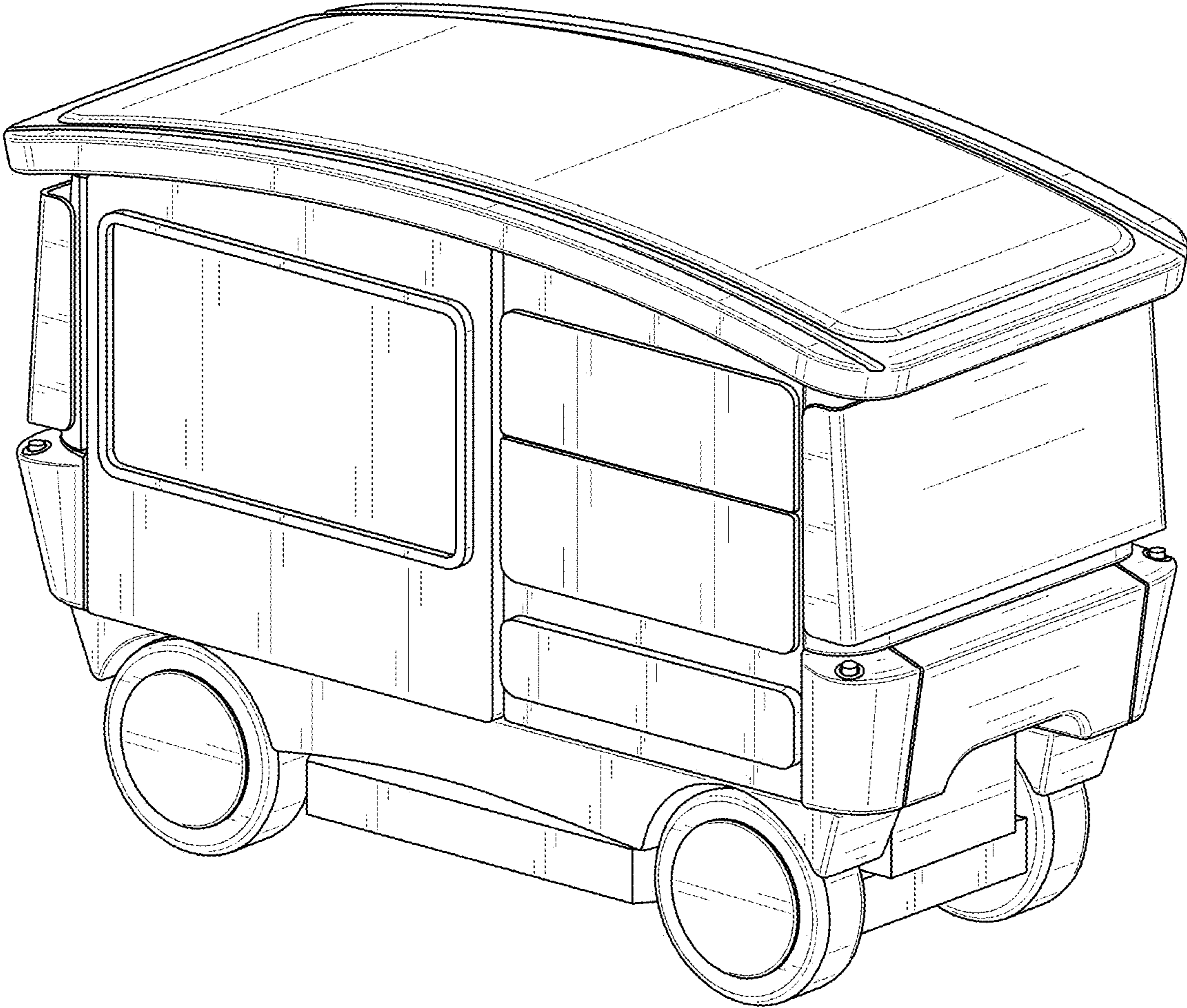

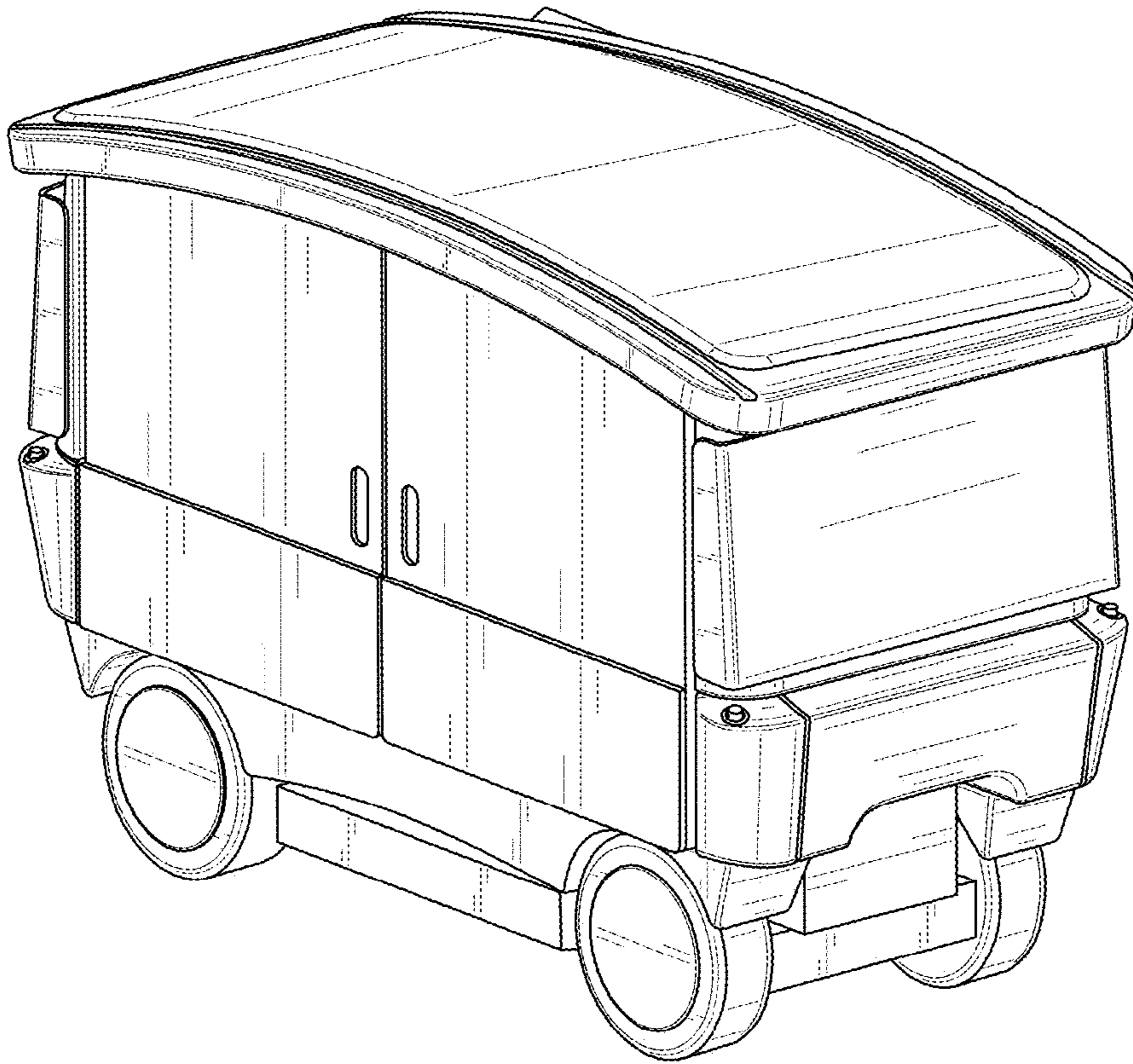

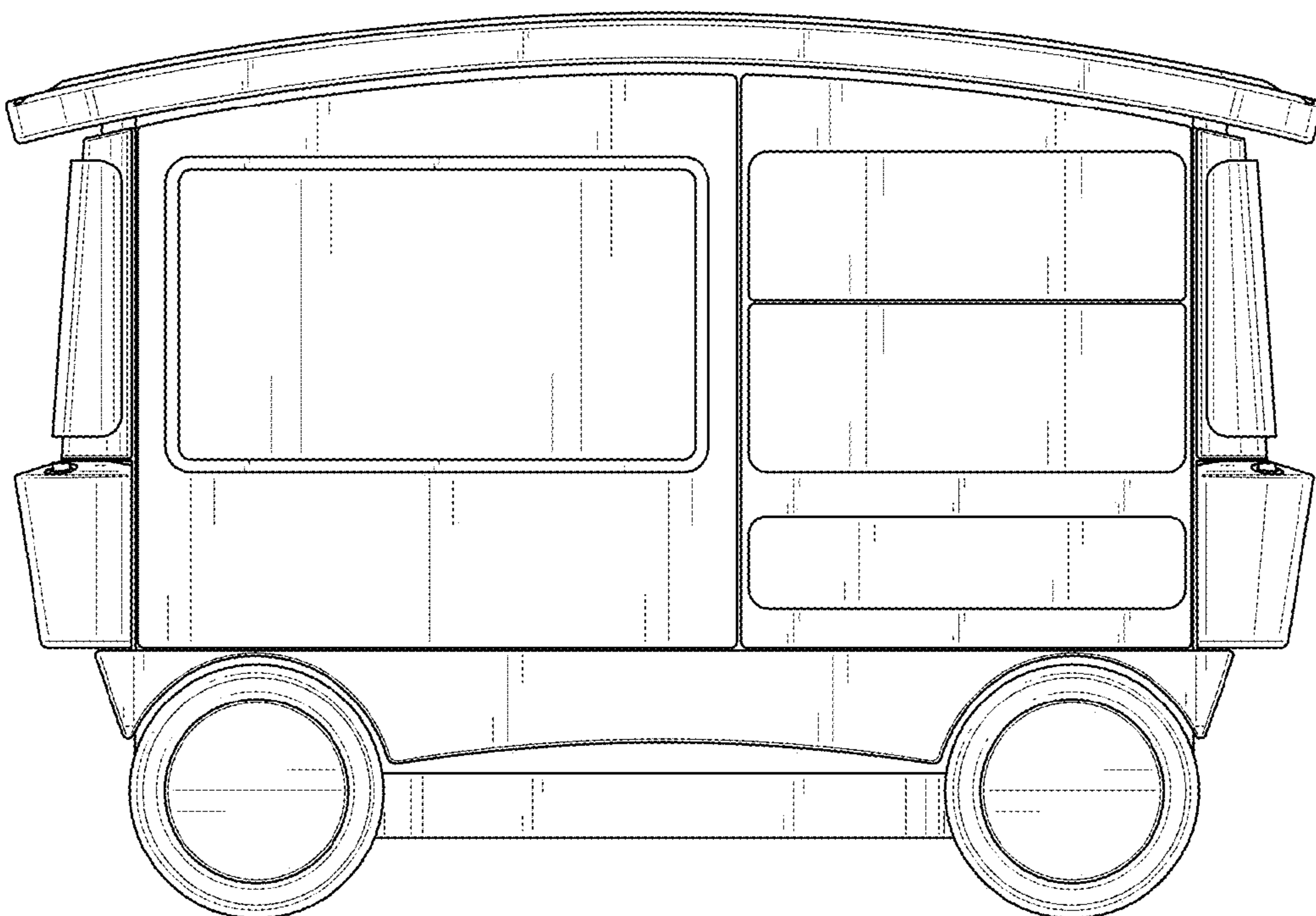

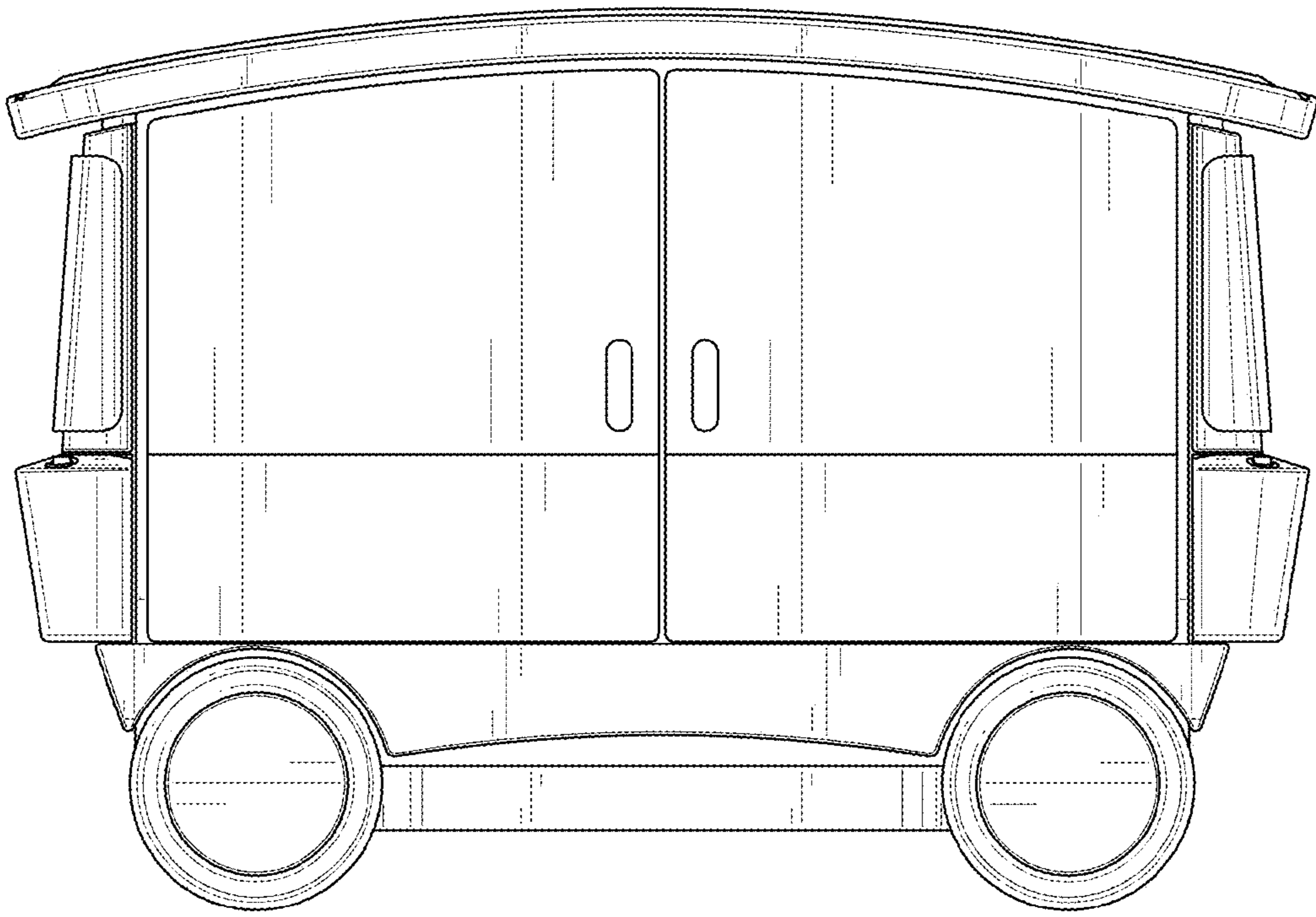

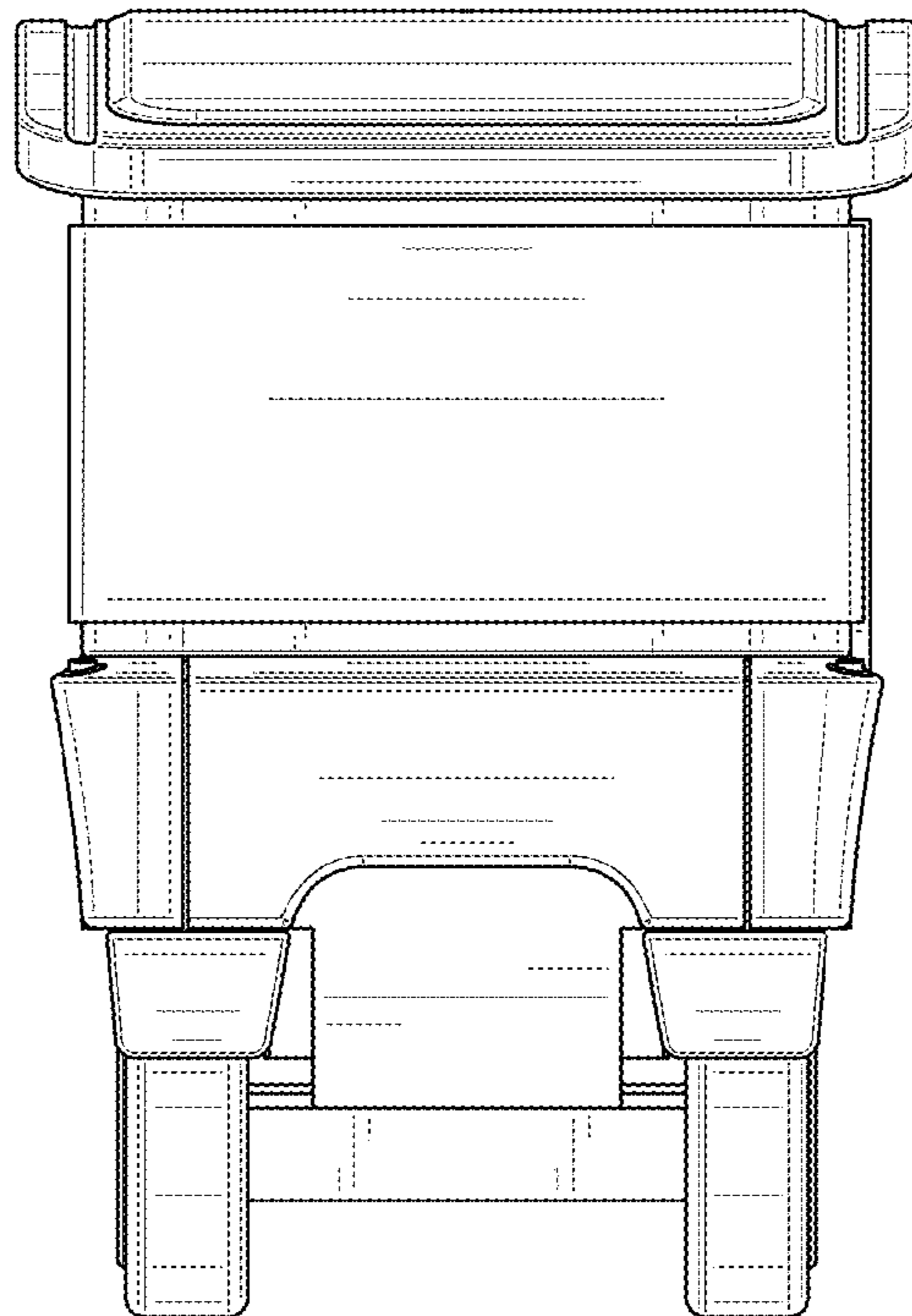

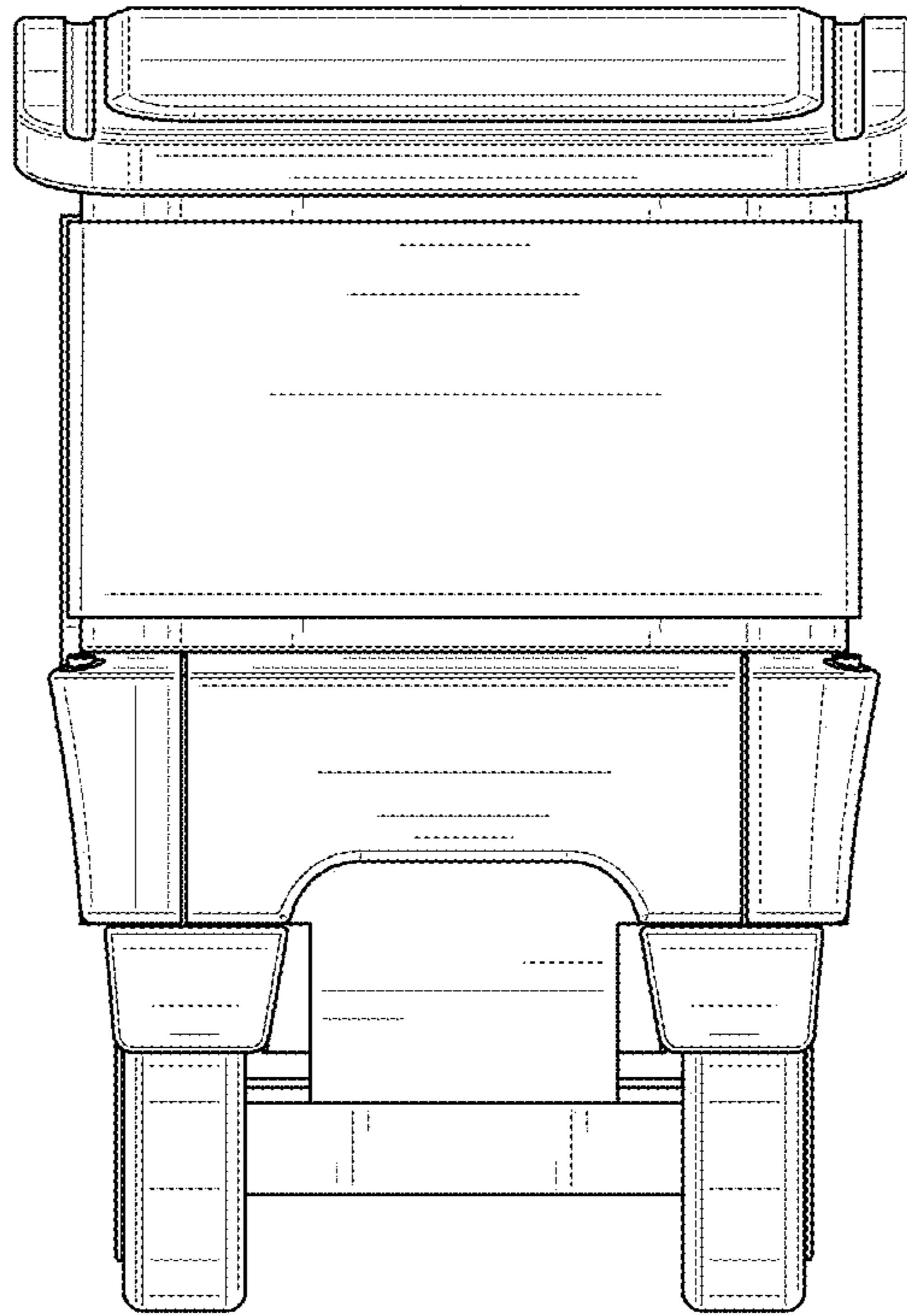

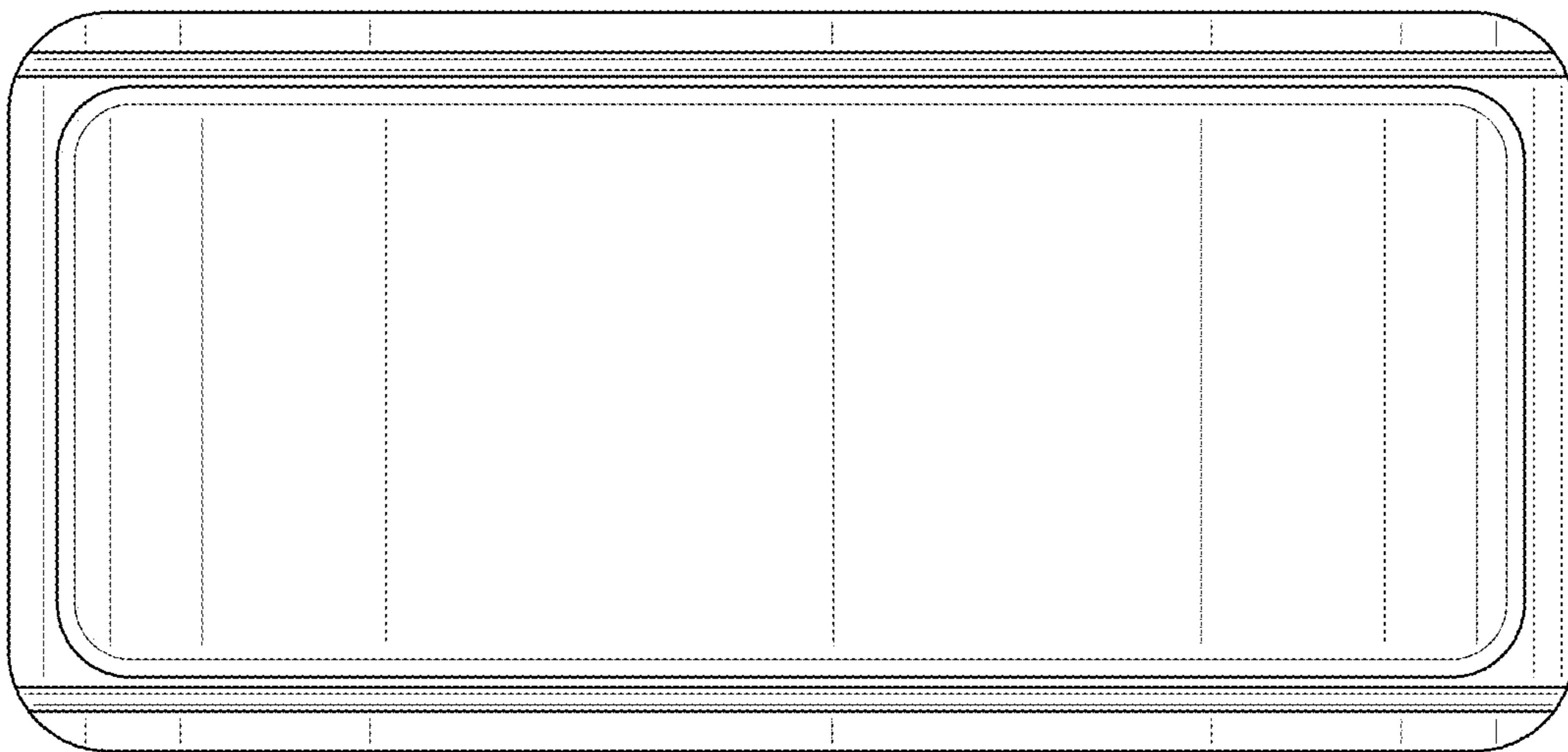

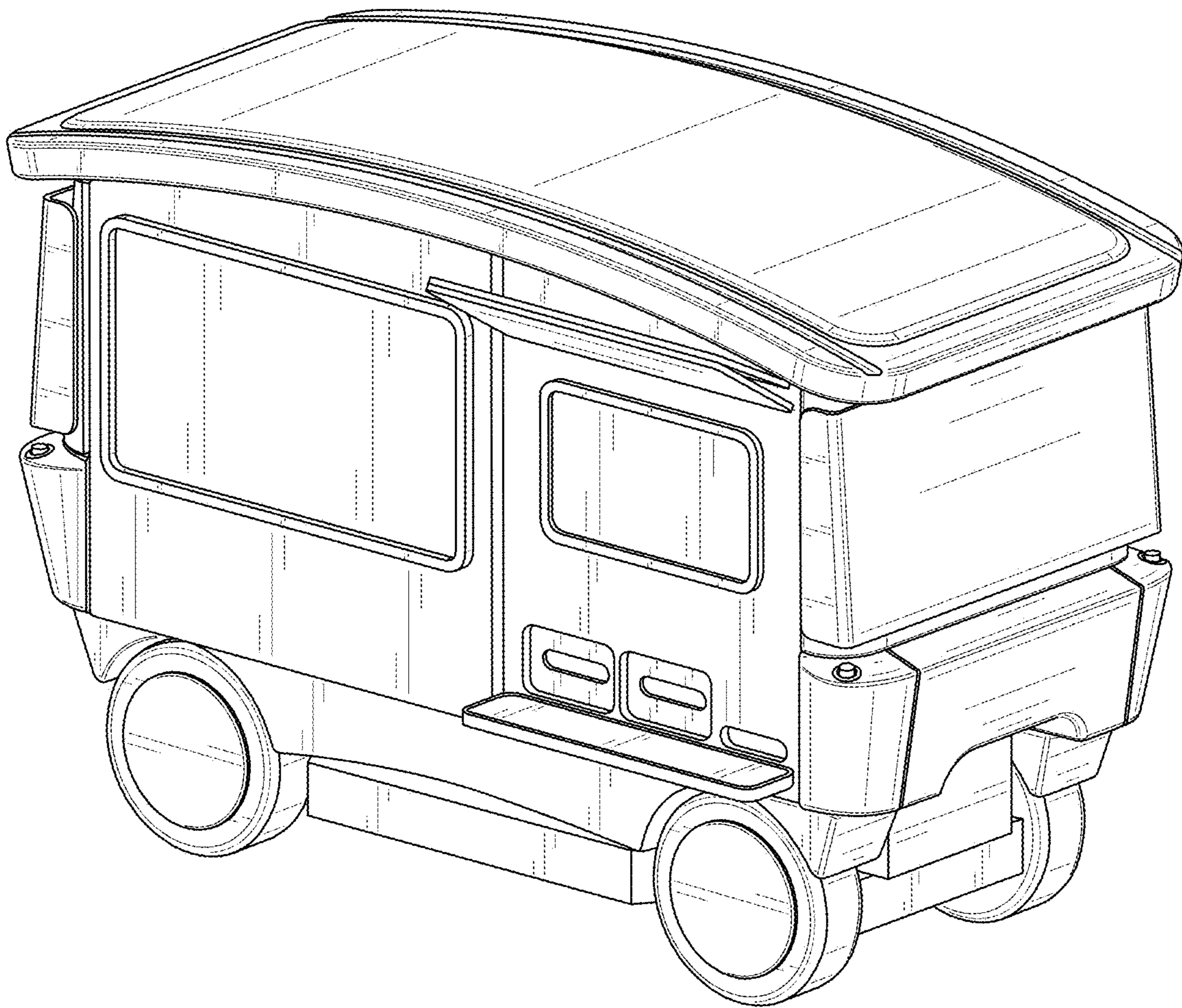

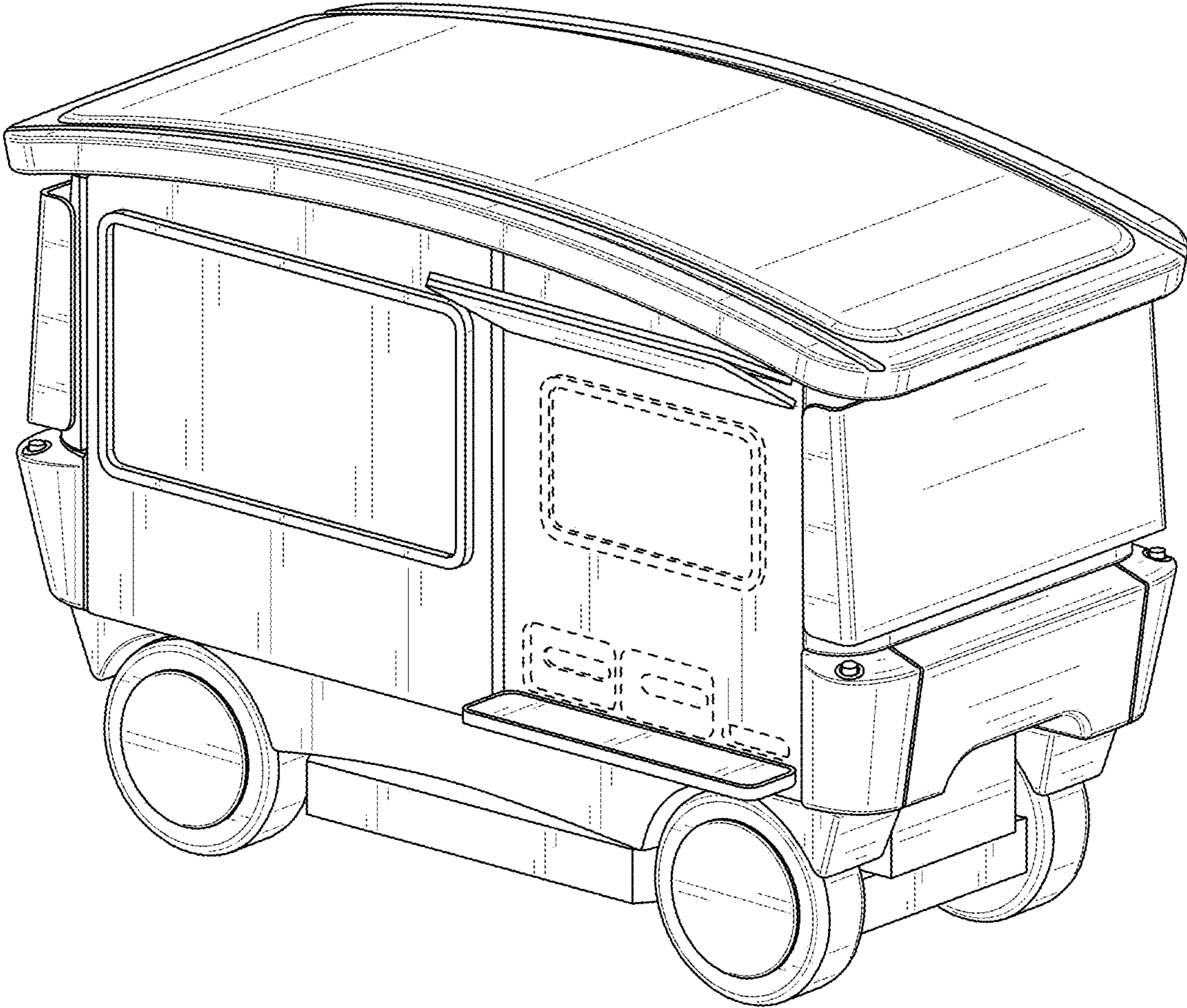
