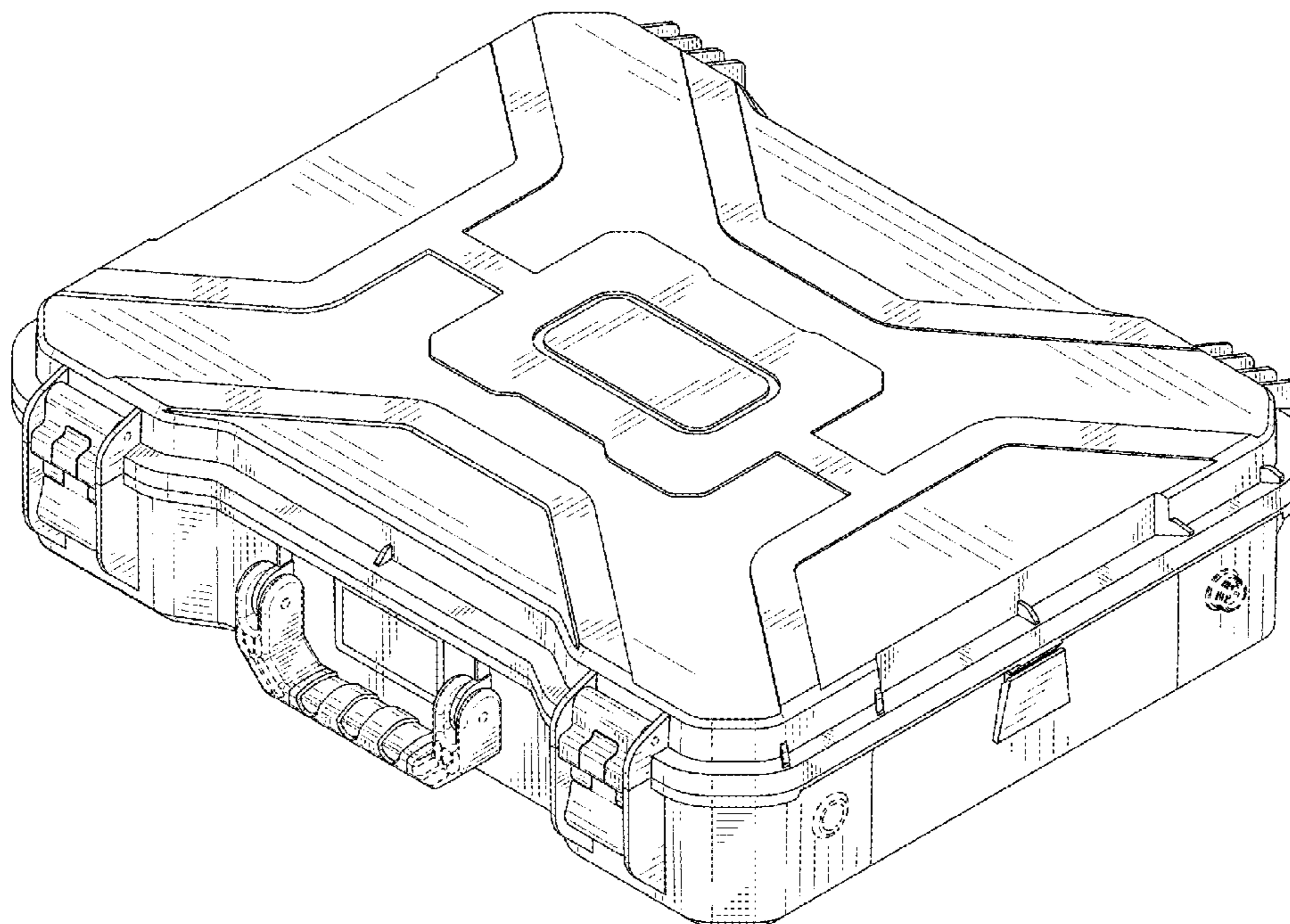
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top, front and right side perspective view of a portable power station showing my new design;

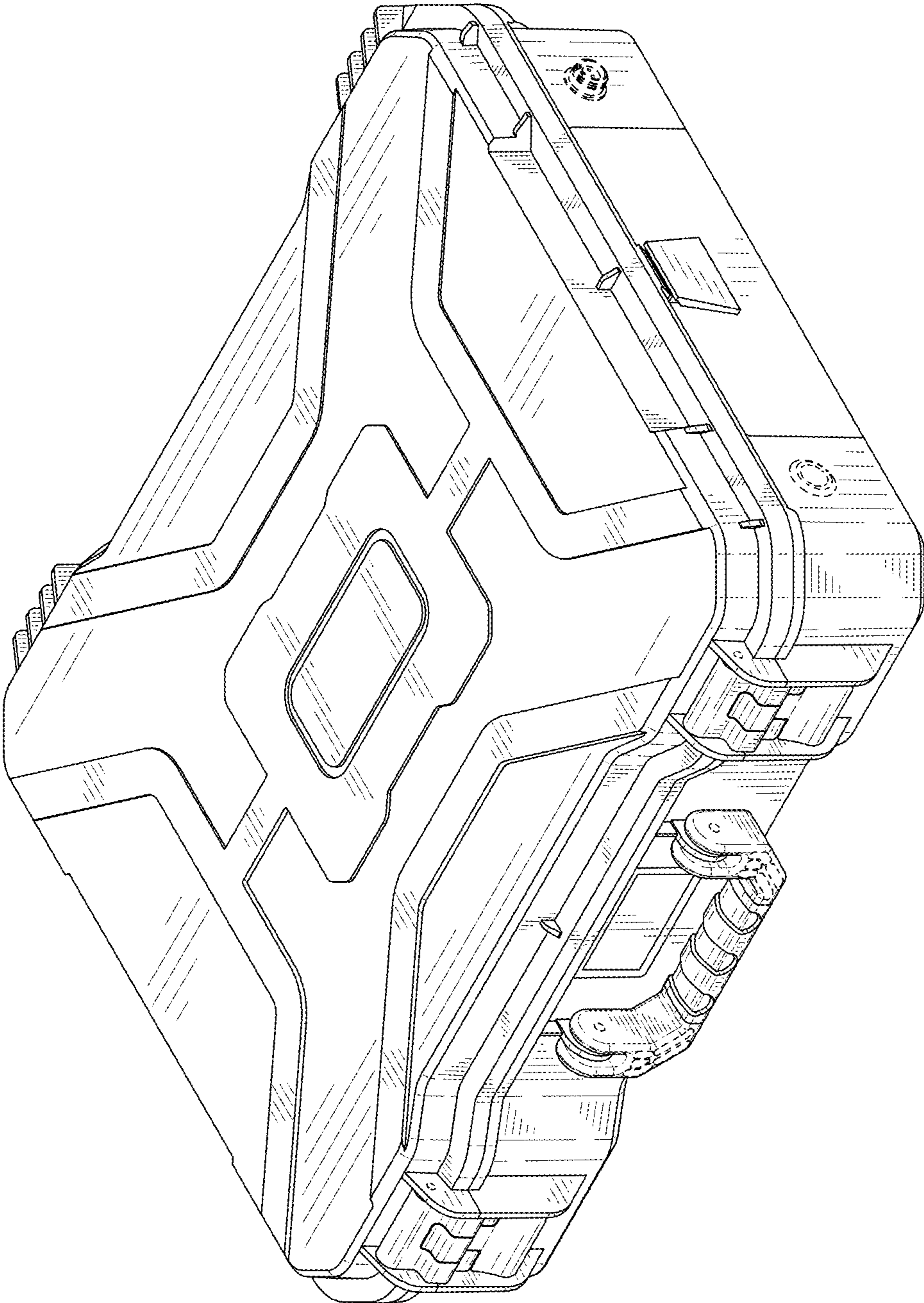

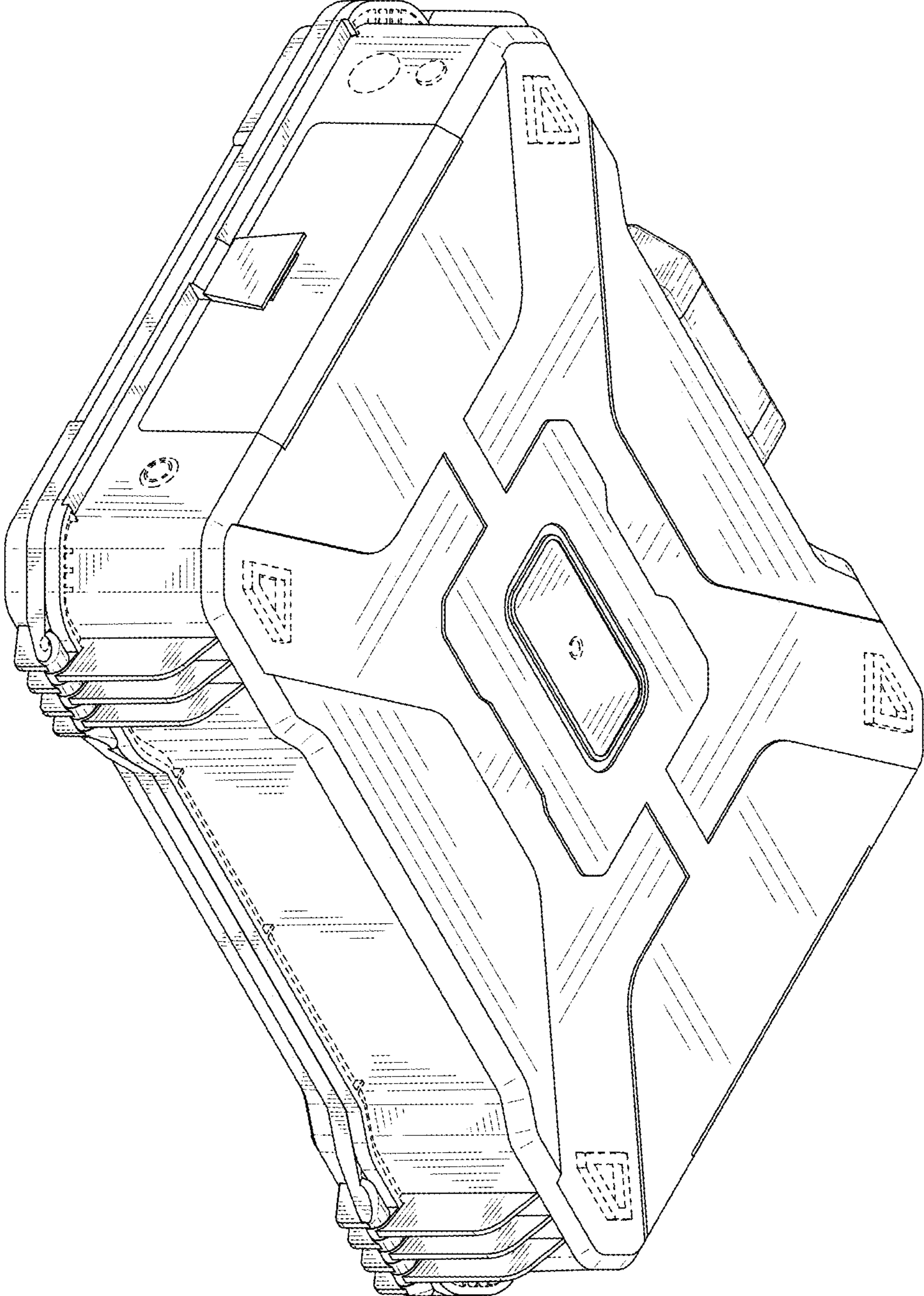

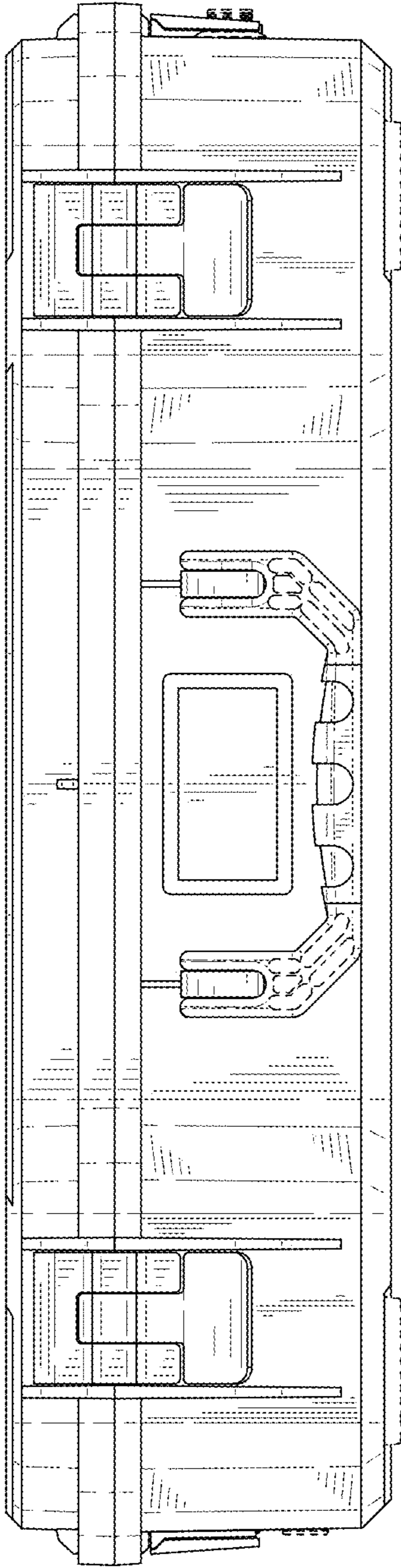

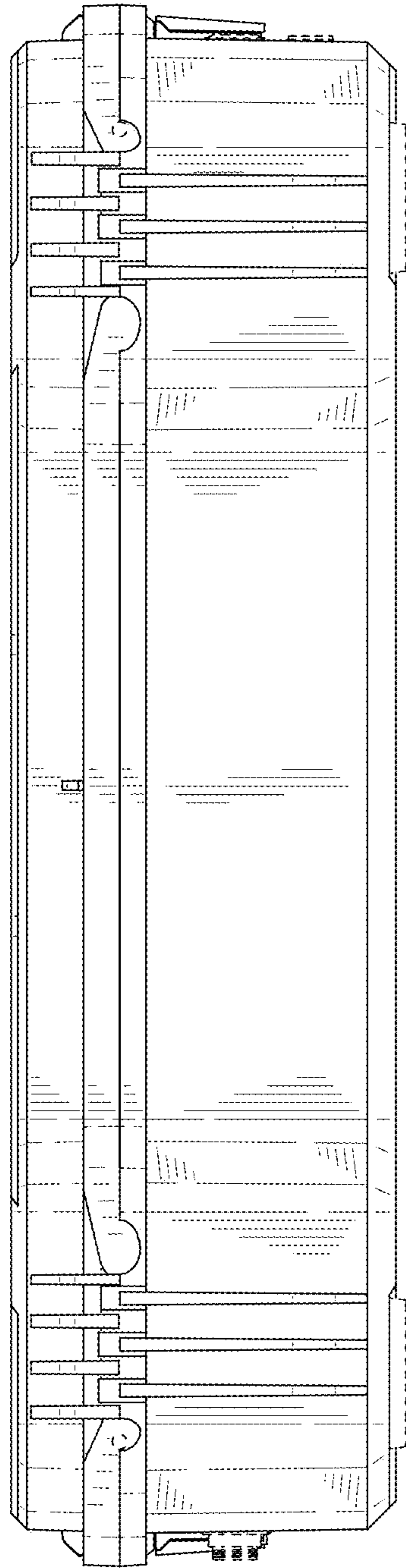

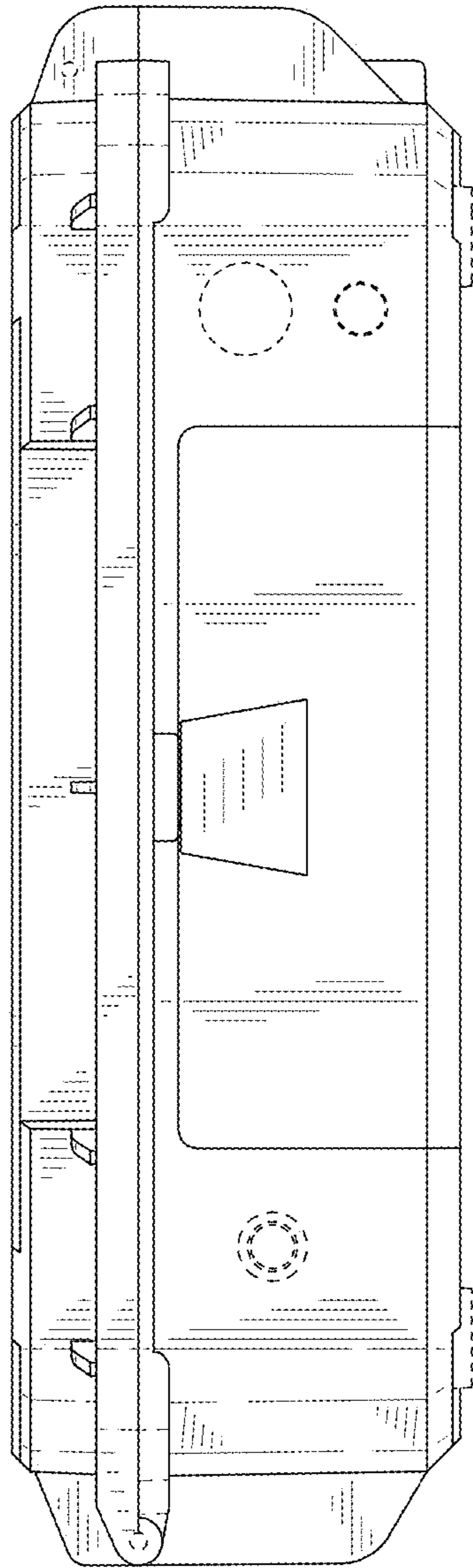

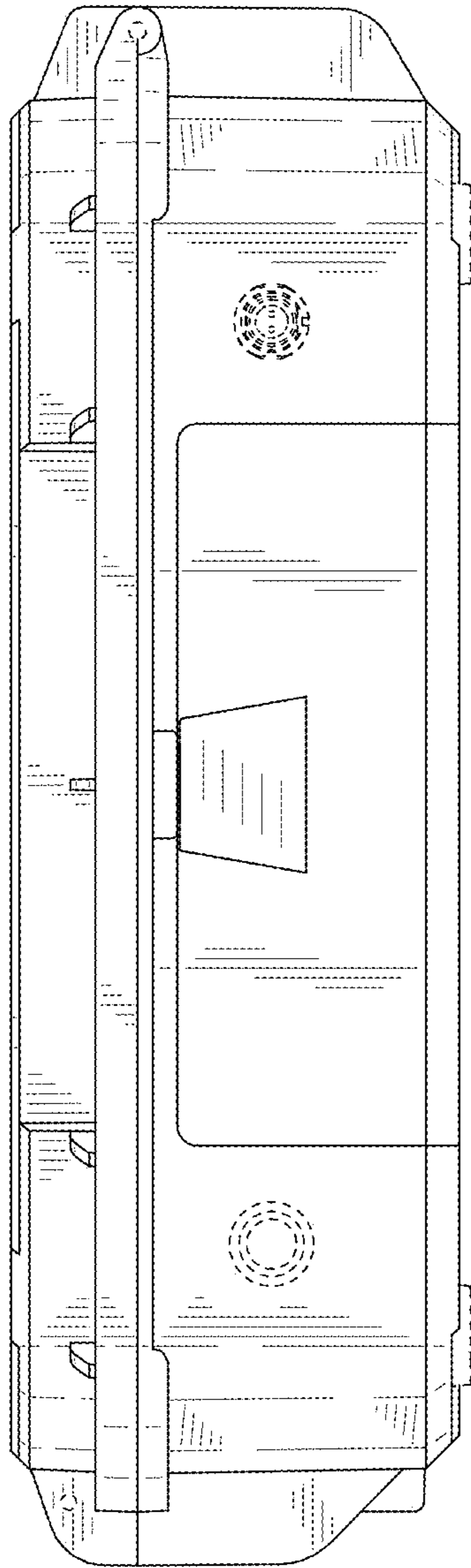

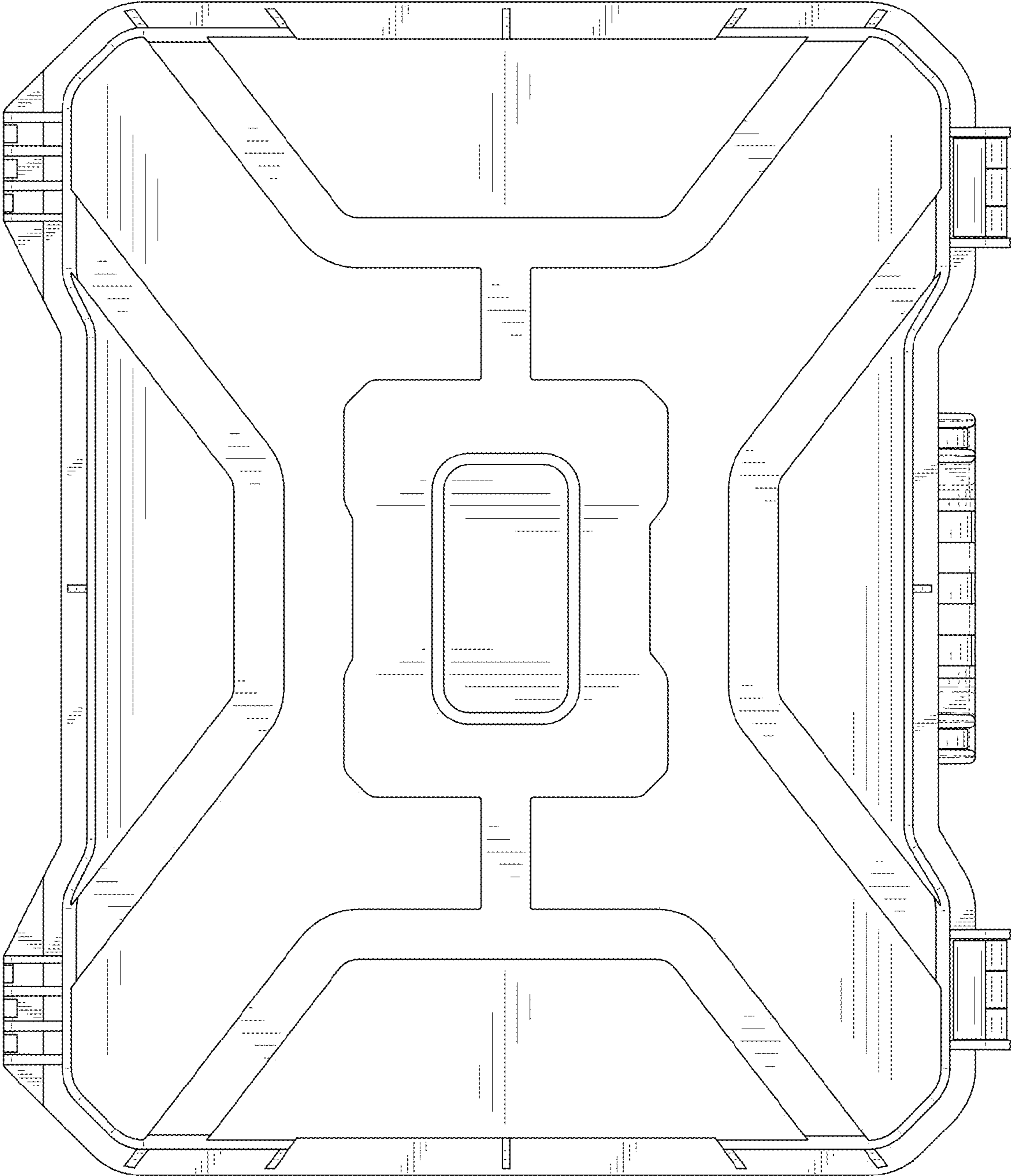

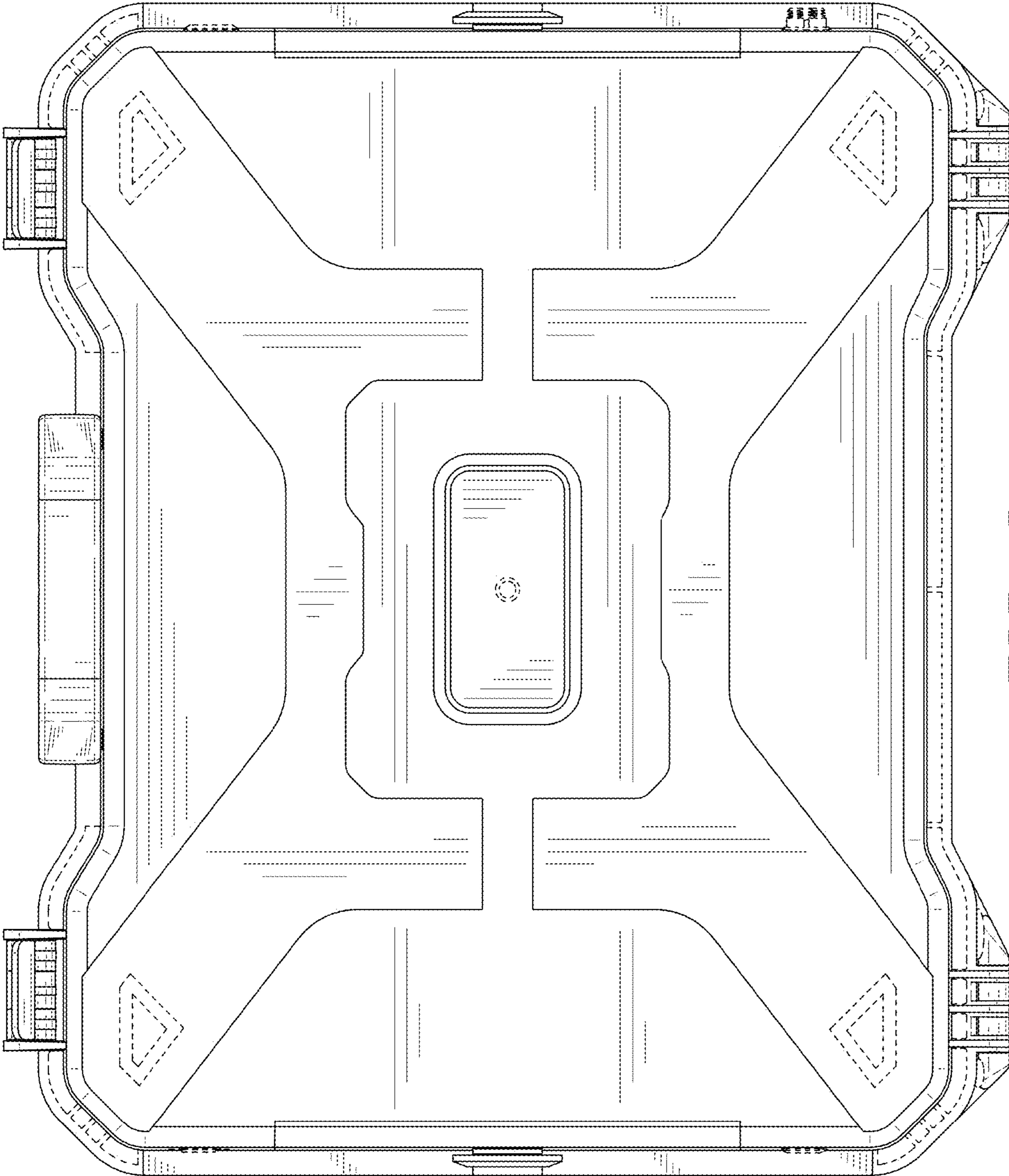
