FIG. 4 is a side view thereof;

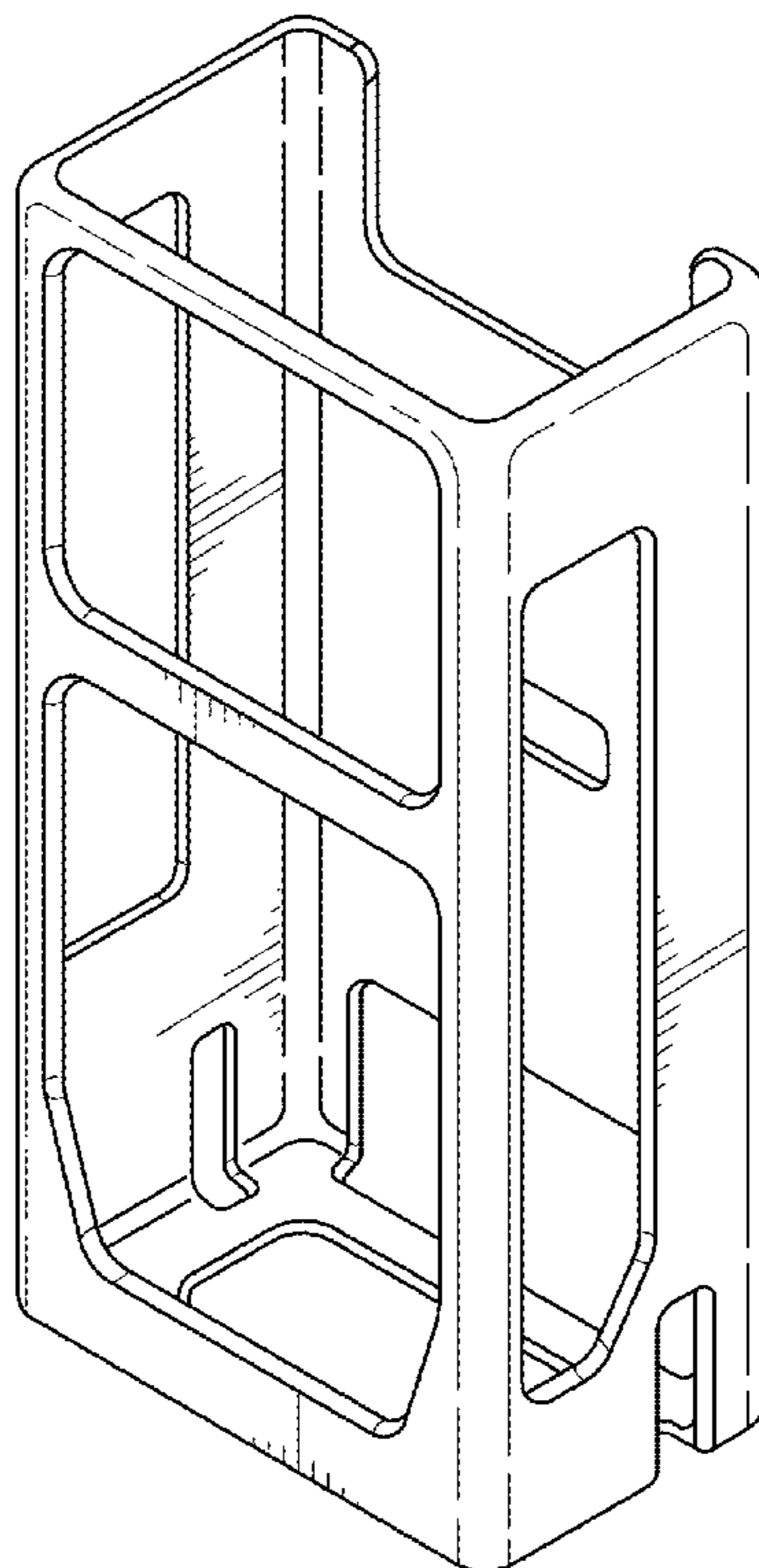
FIG. 5 a side view thereof for the side opposite that of FIG. 4;

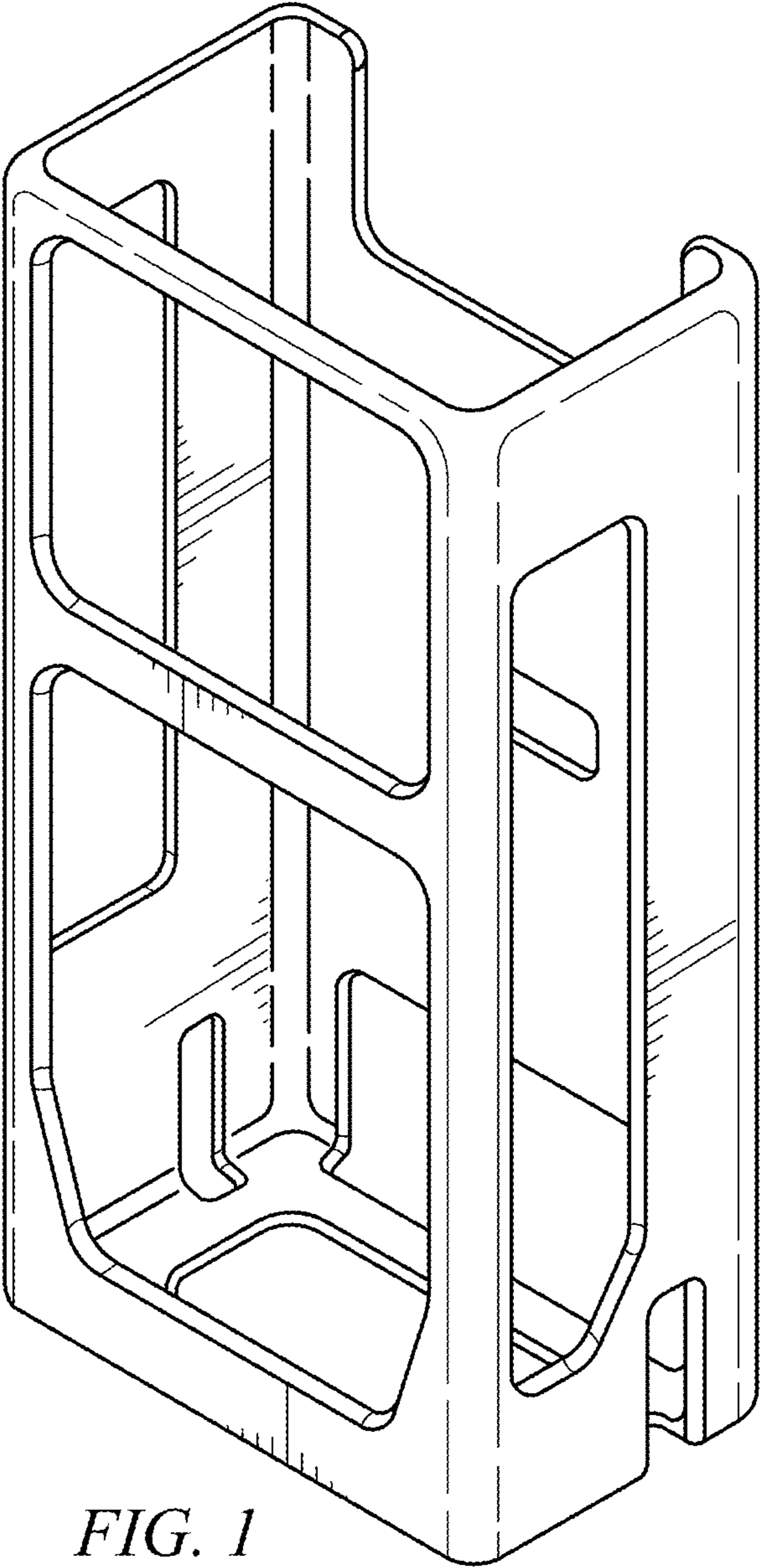

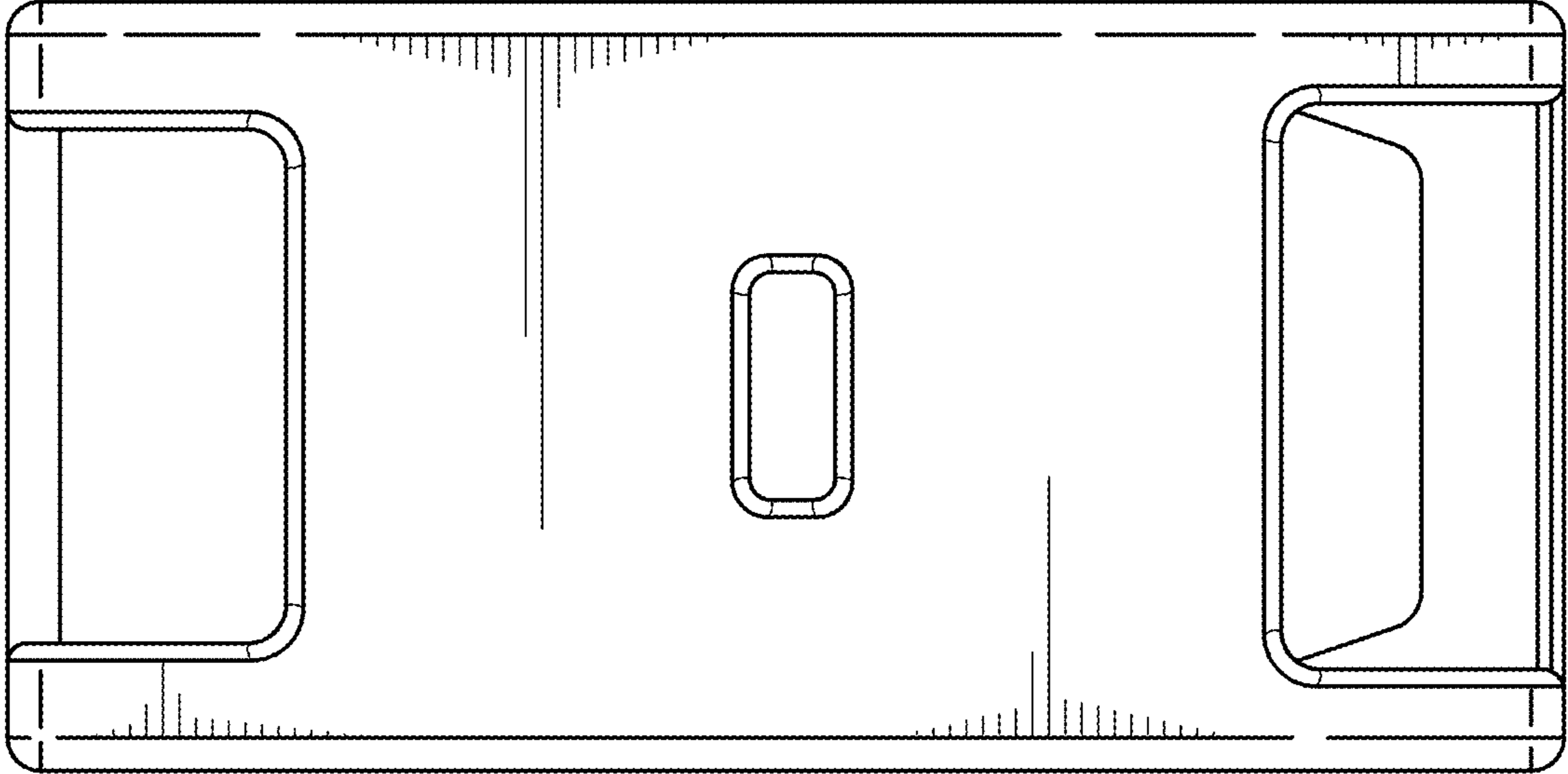

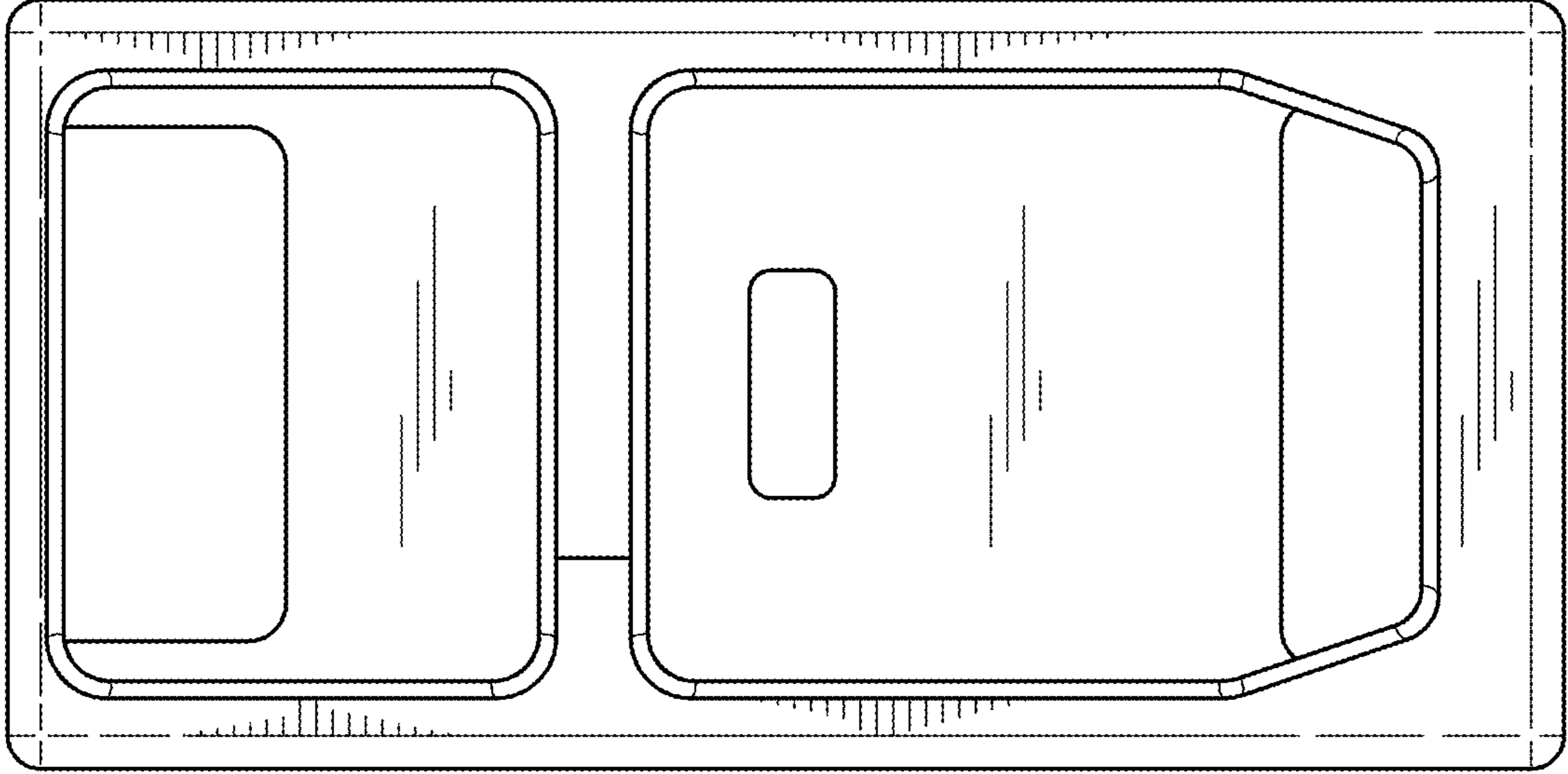

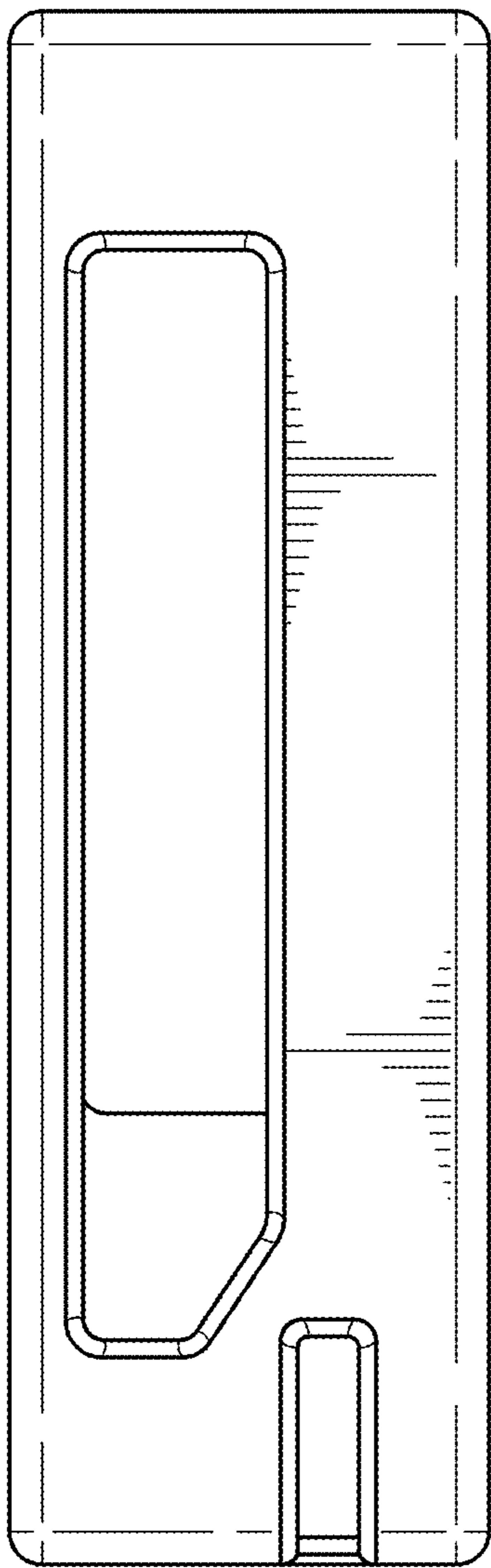

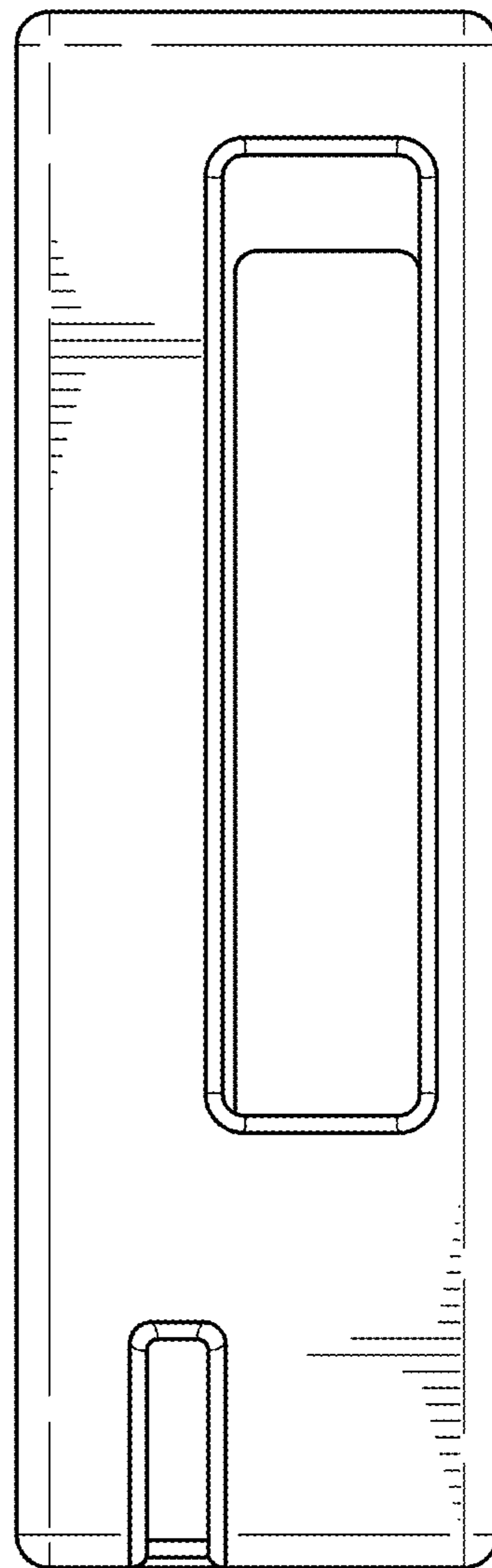

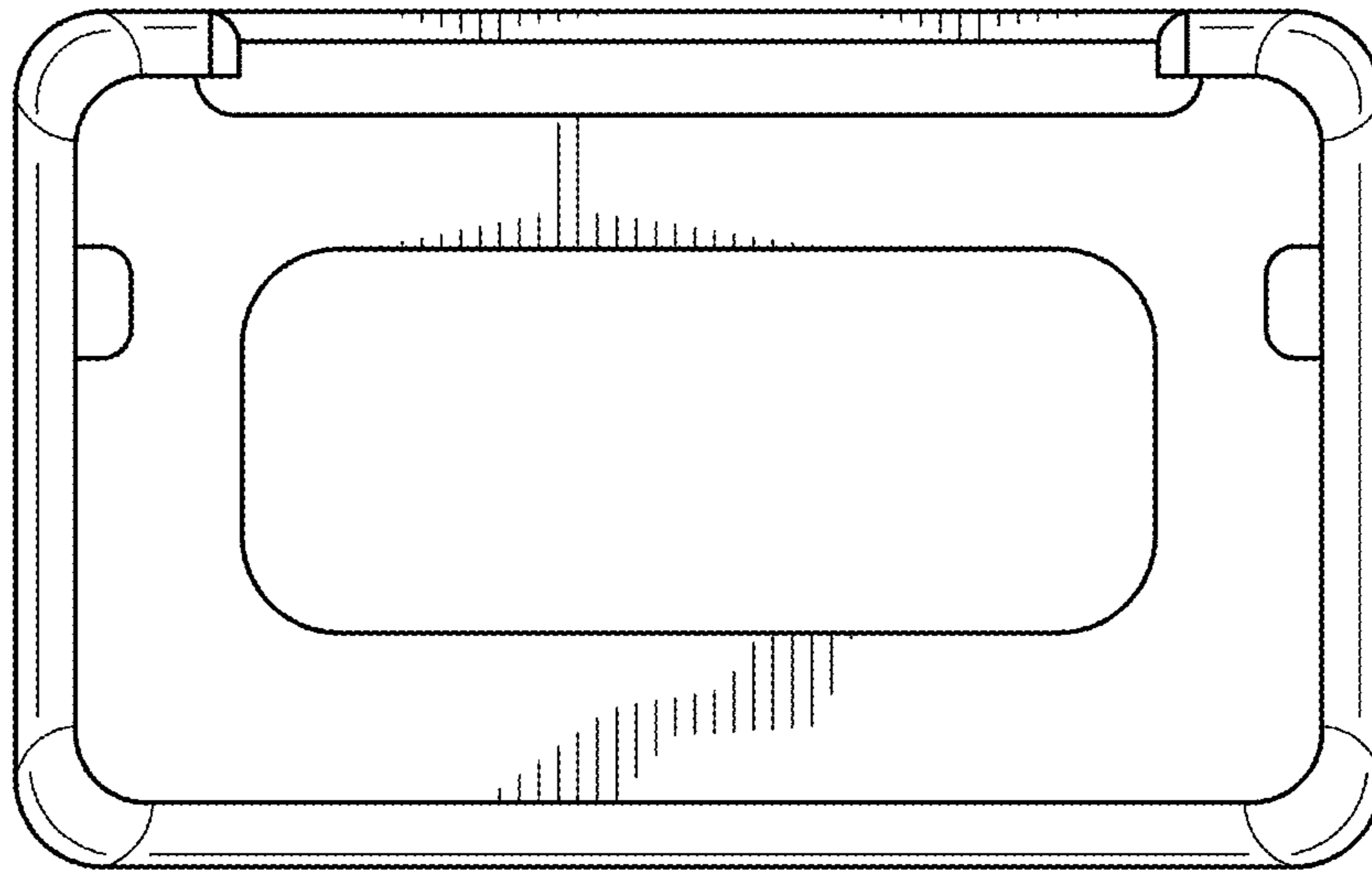

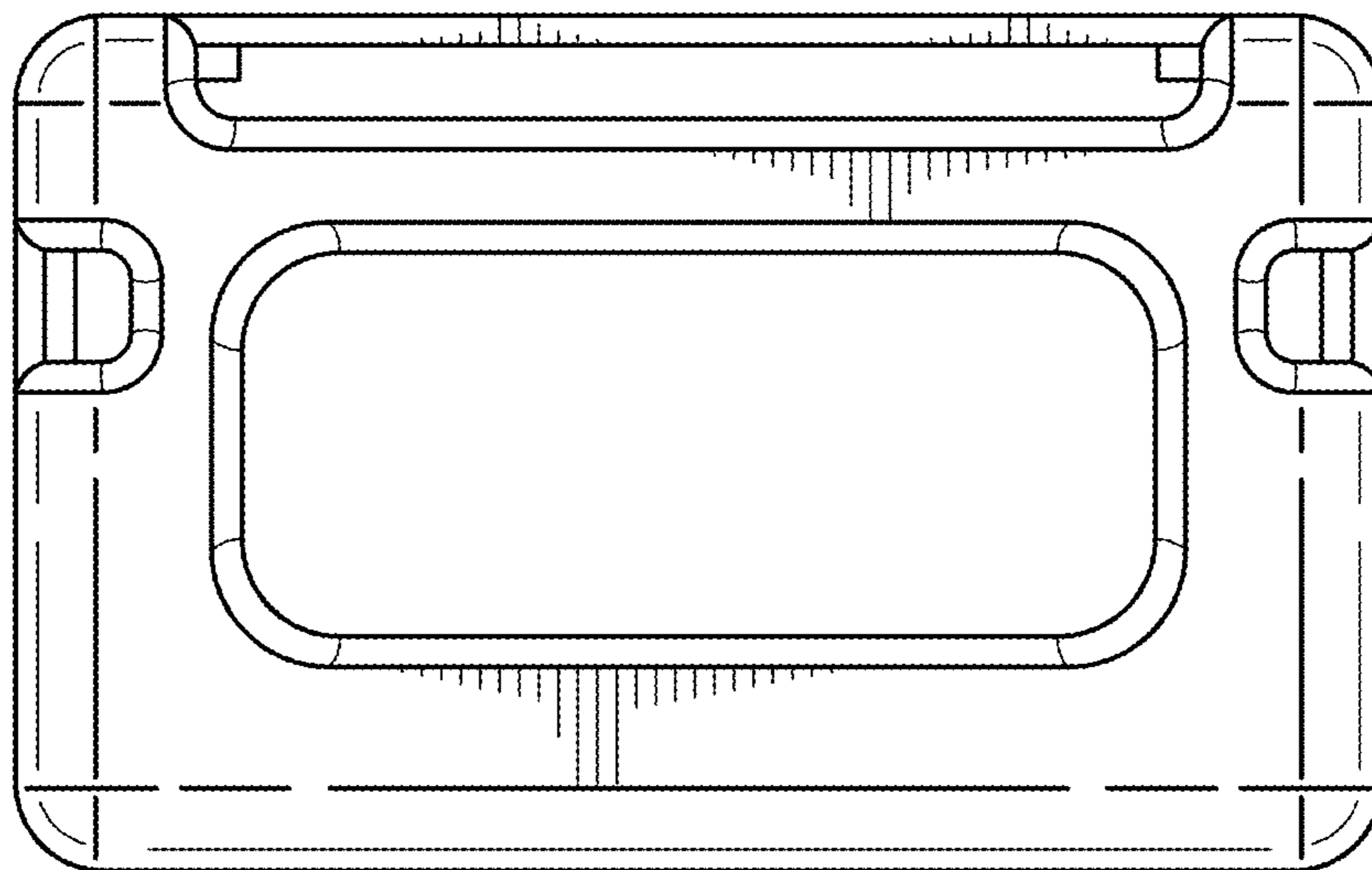
