(57) **CLAIM**

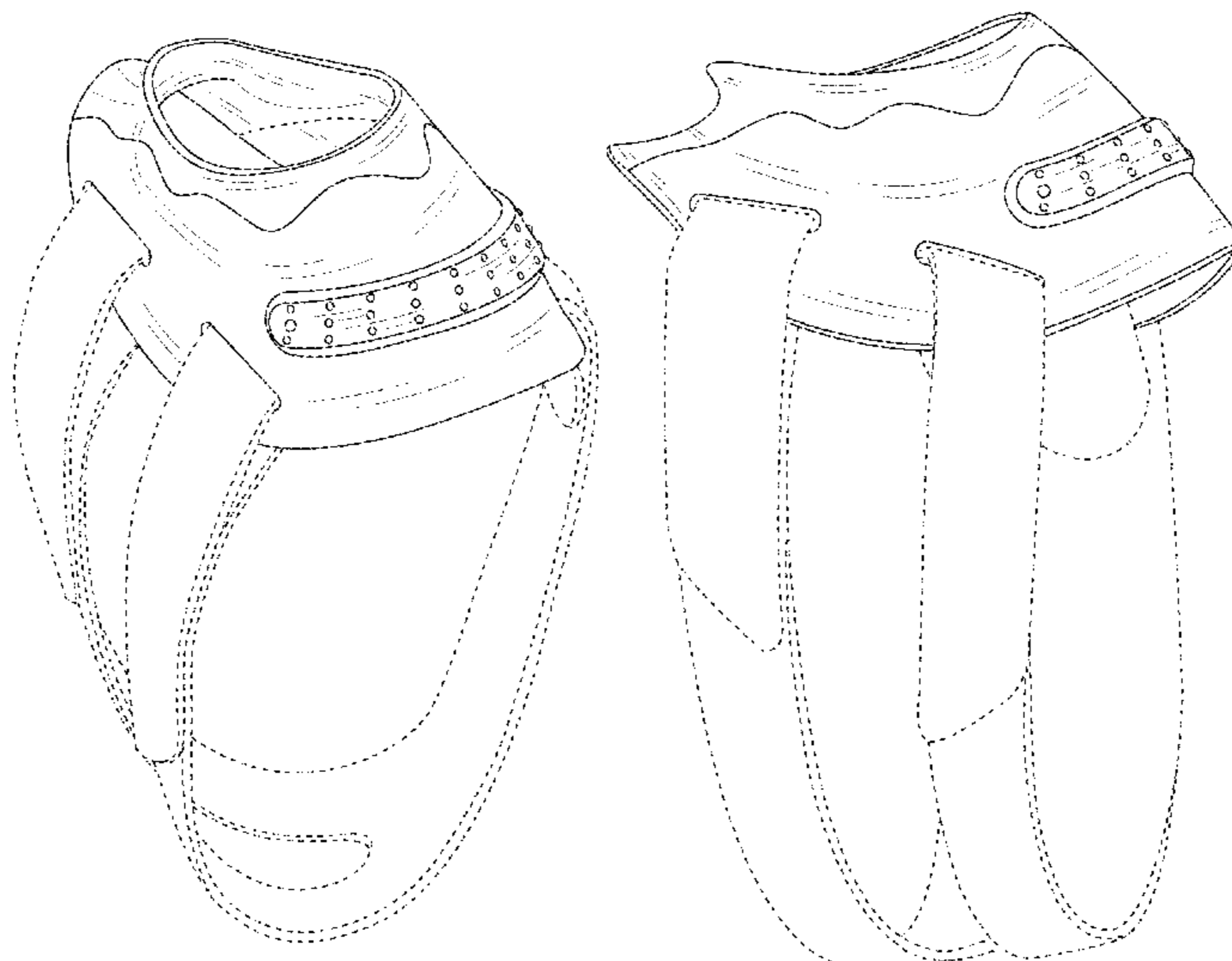
The ornamental design for a thumb brace, as shown and described.

DESCRIPTION

FIG. 1 is a top, front and right side perspective view of a thumb brace showing my new design;
FIG. 2 is a bottom, rear and left side perspective view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a left side elevational view thereof;
FIG. 7 is a top plan view thereof;
FIG. 8 is a bottom plan view thereof; and,
FIG. 9 is a perspective view showing the thumb brace in an alternative position.

The broken lines in the drawings illustrate portions of the thumb brace which form no part of the claimed design.

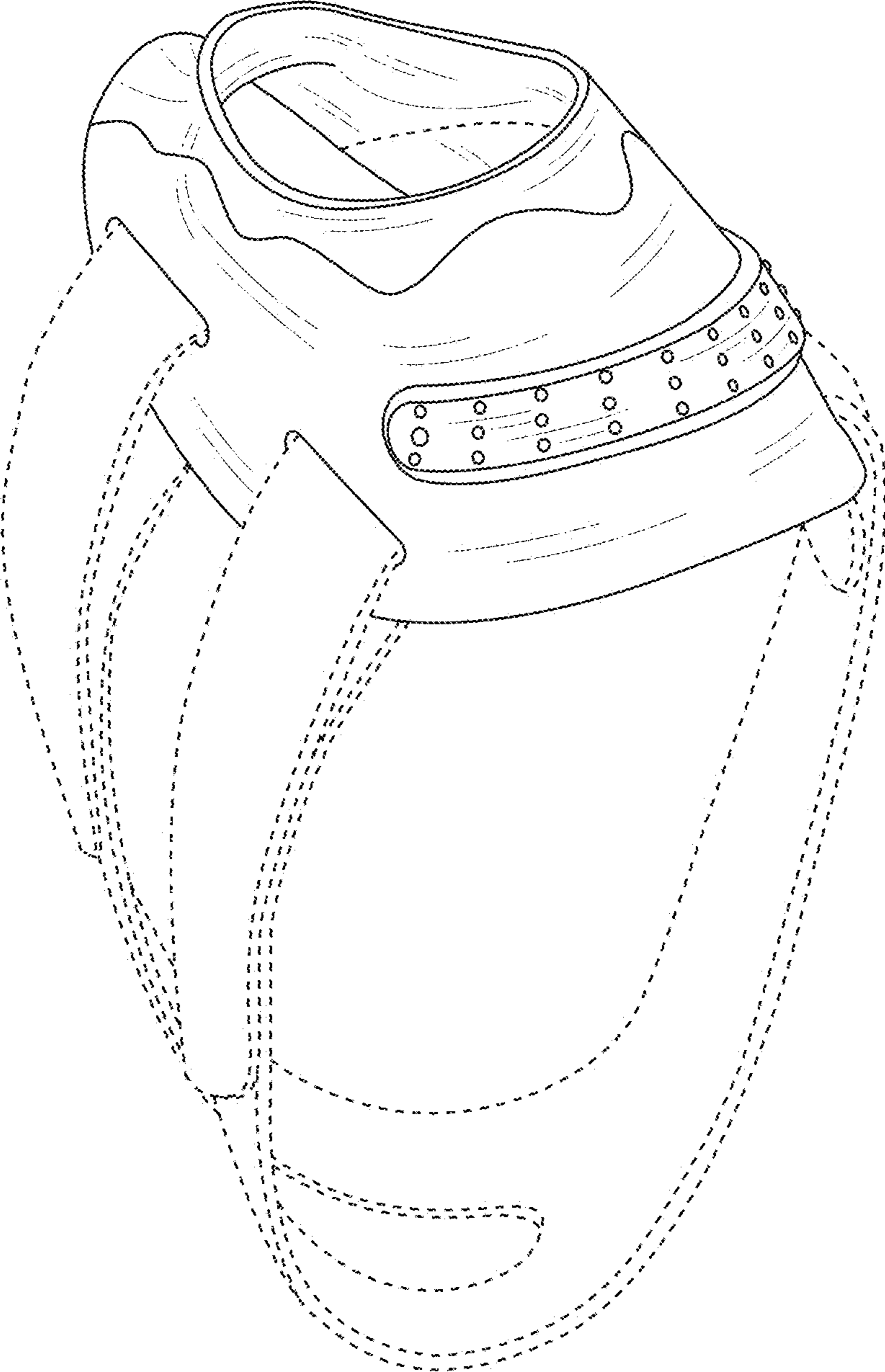

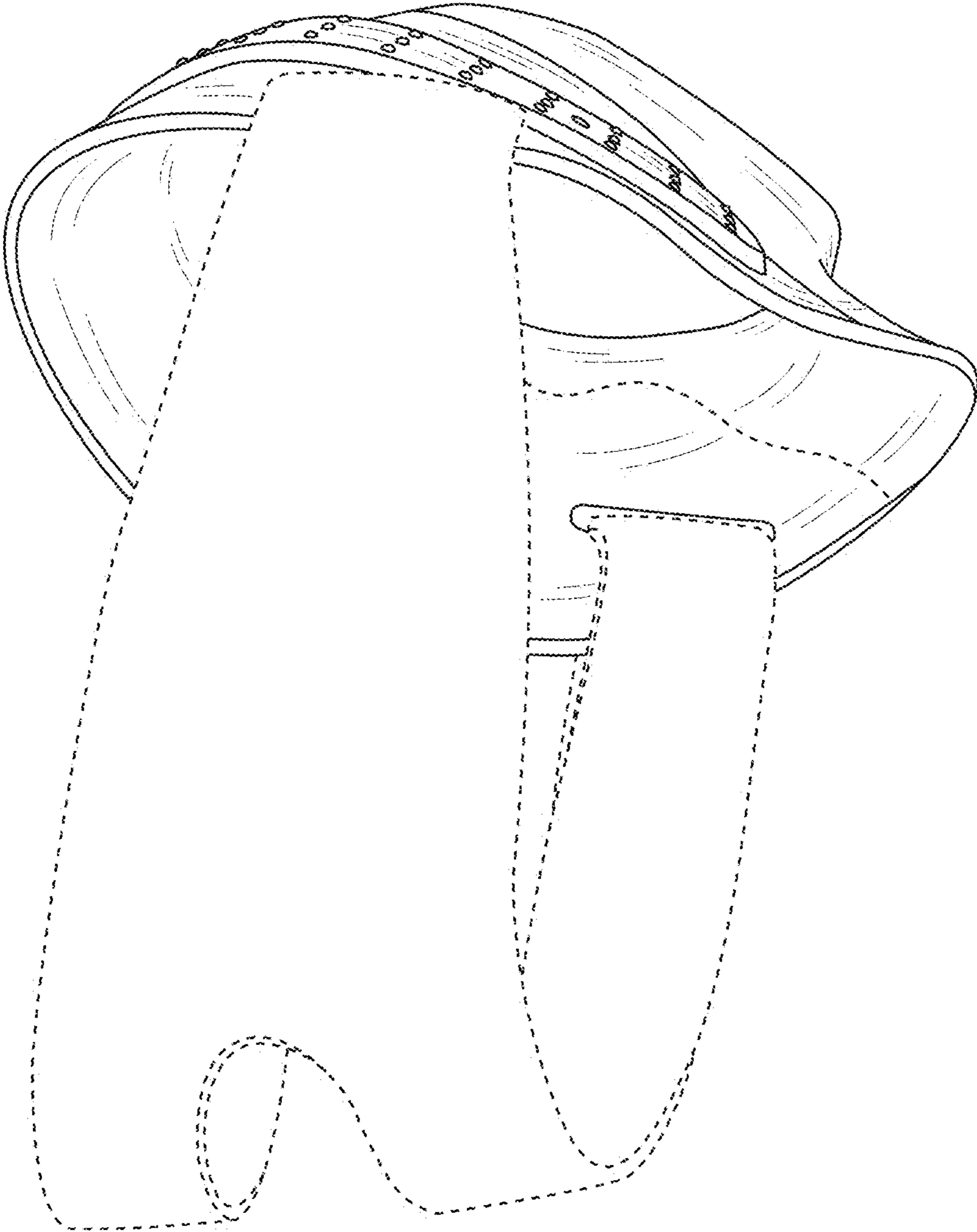

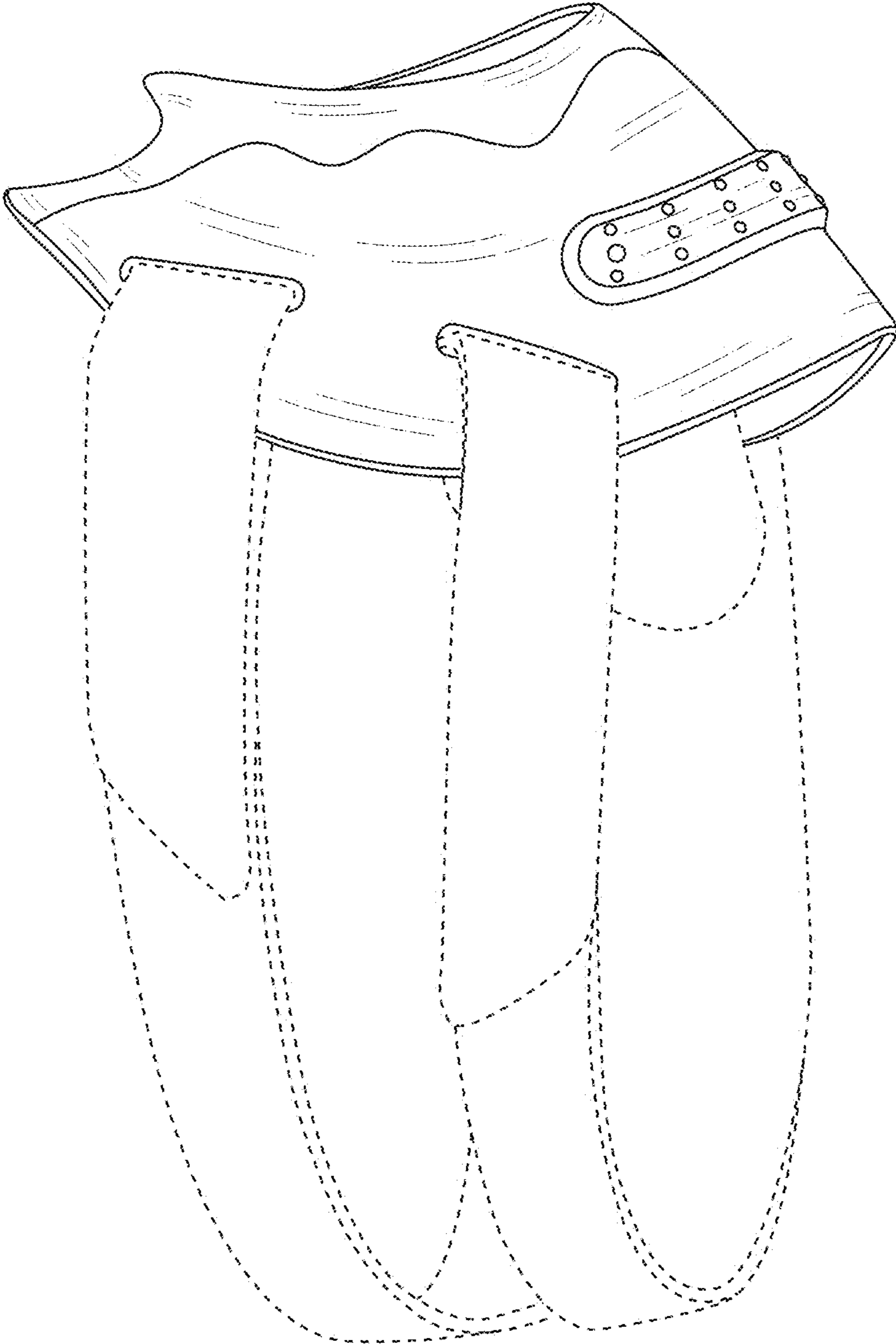

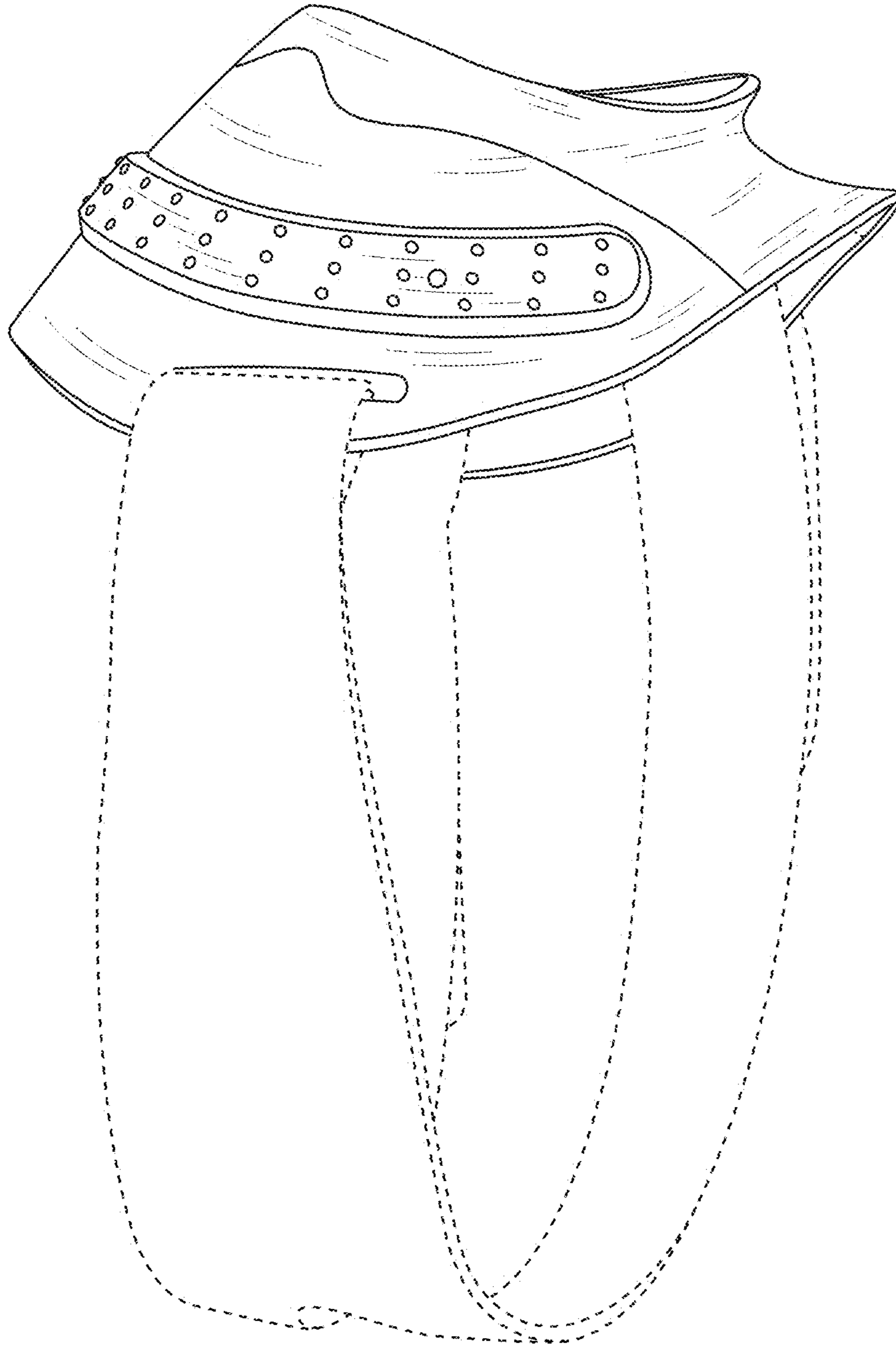

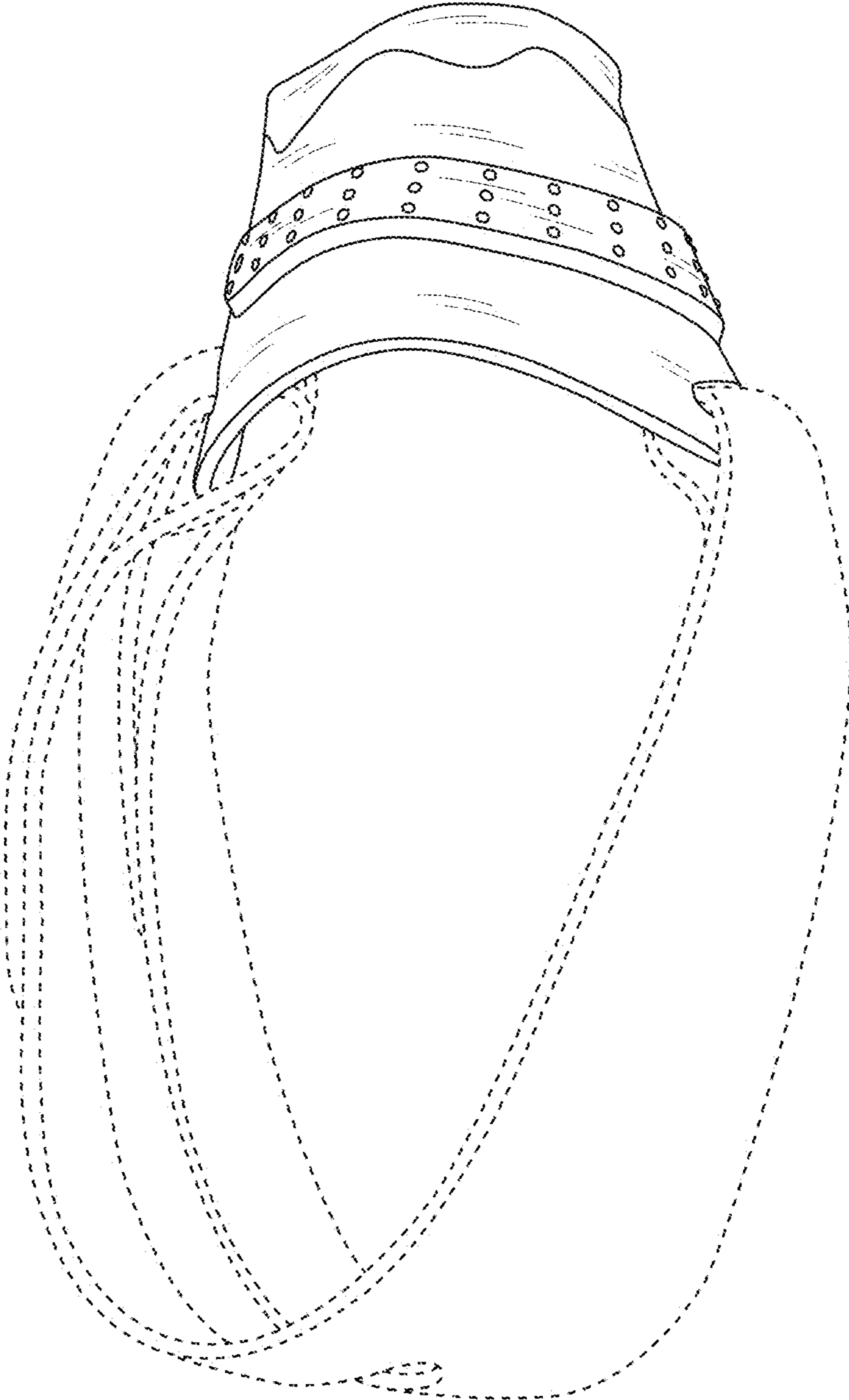

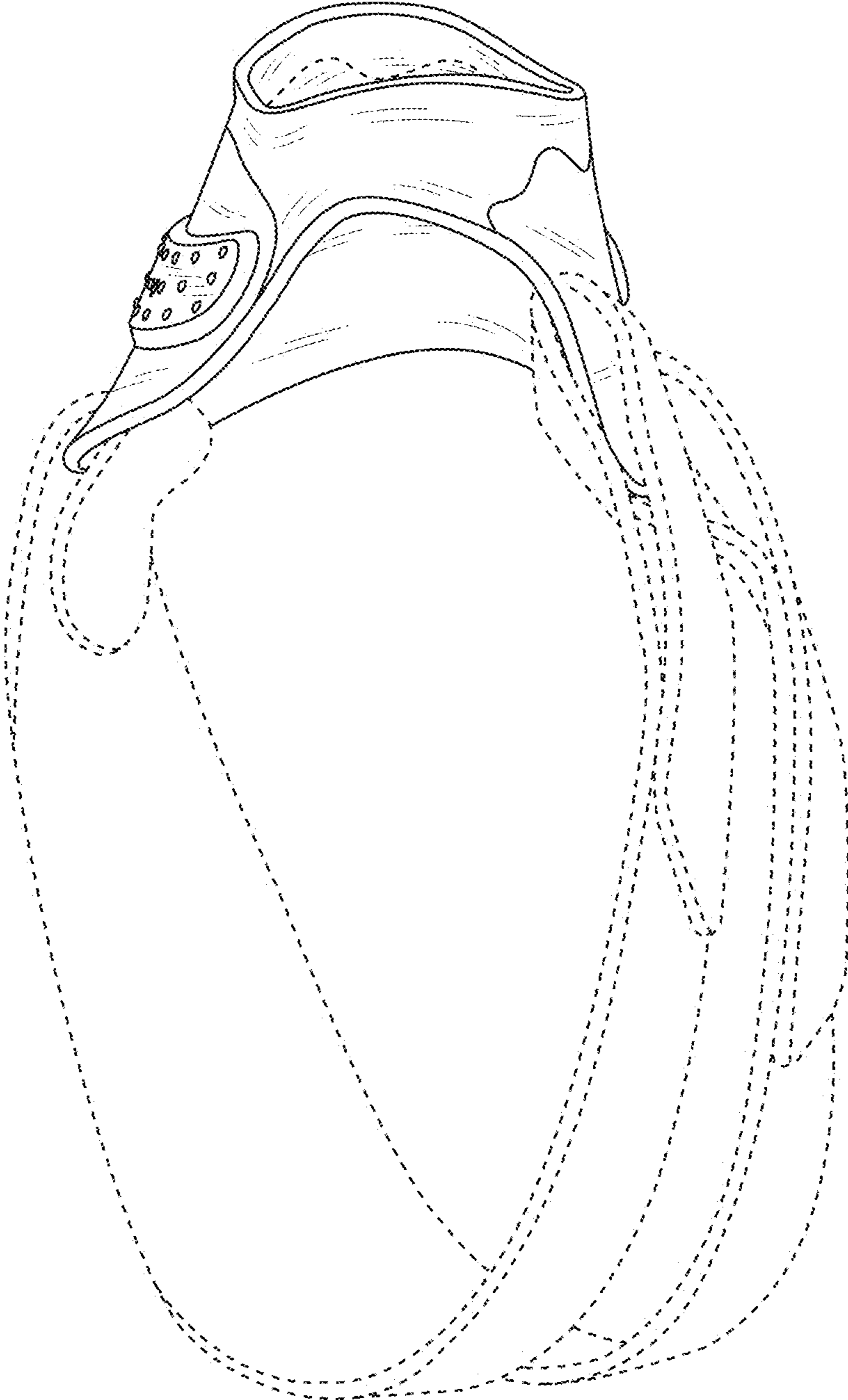

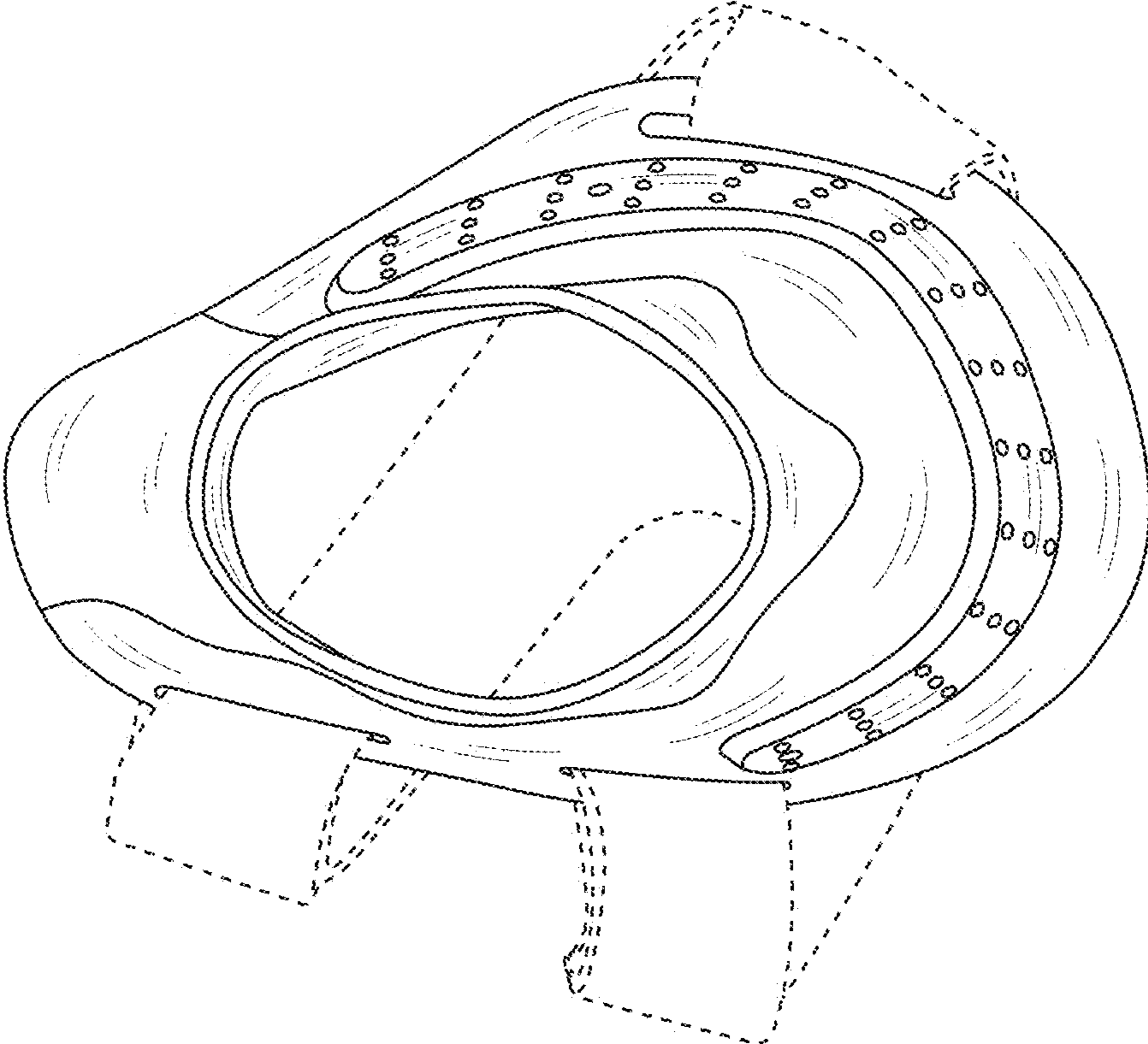

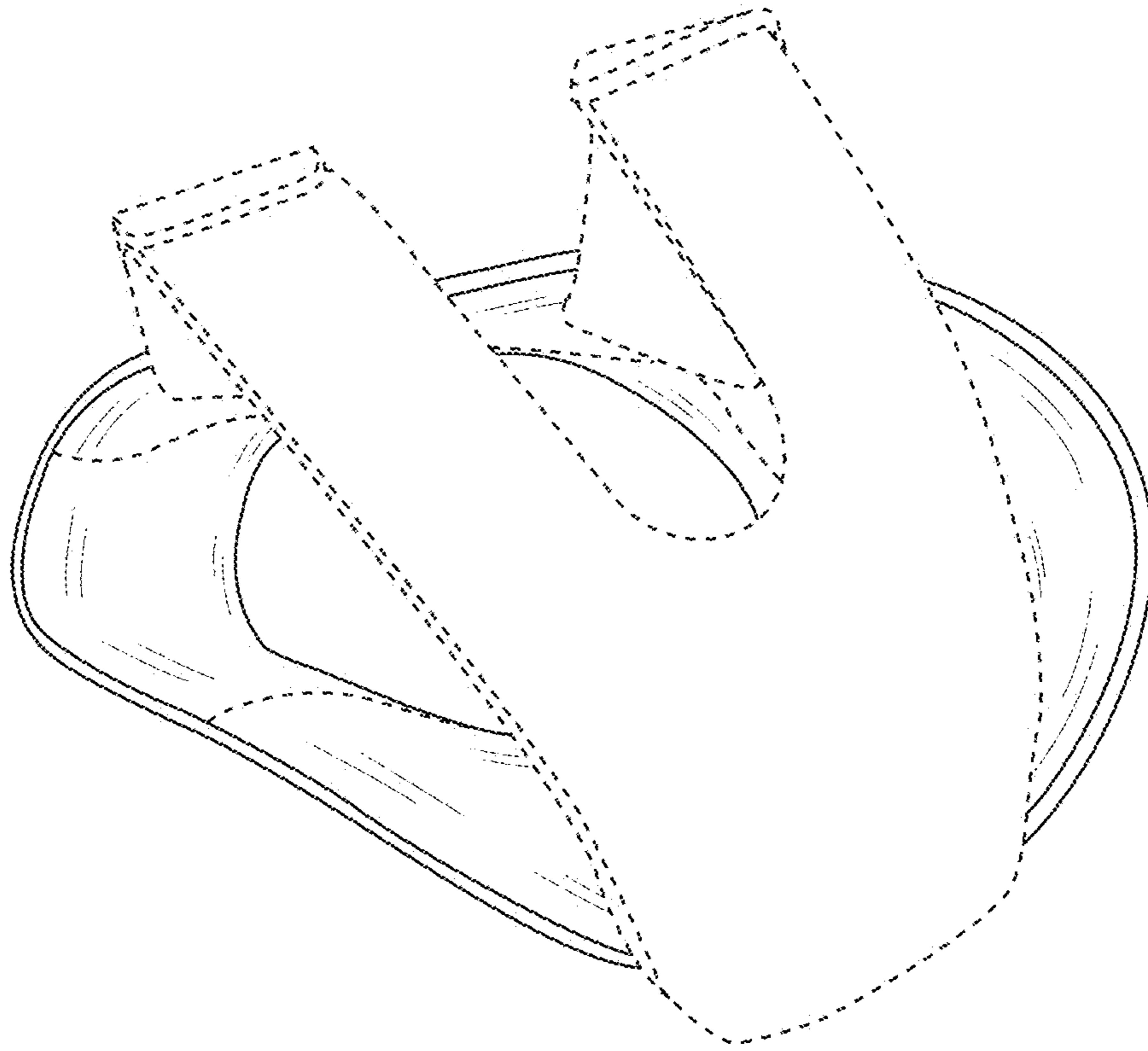

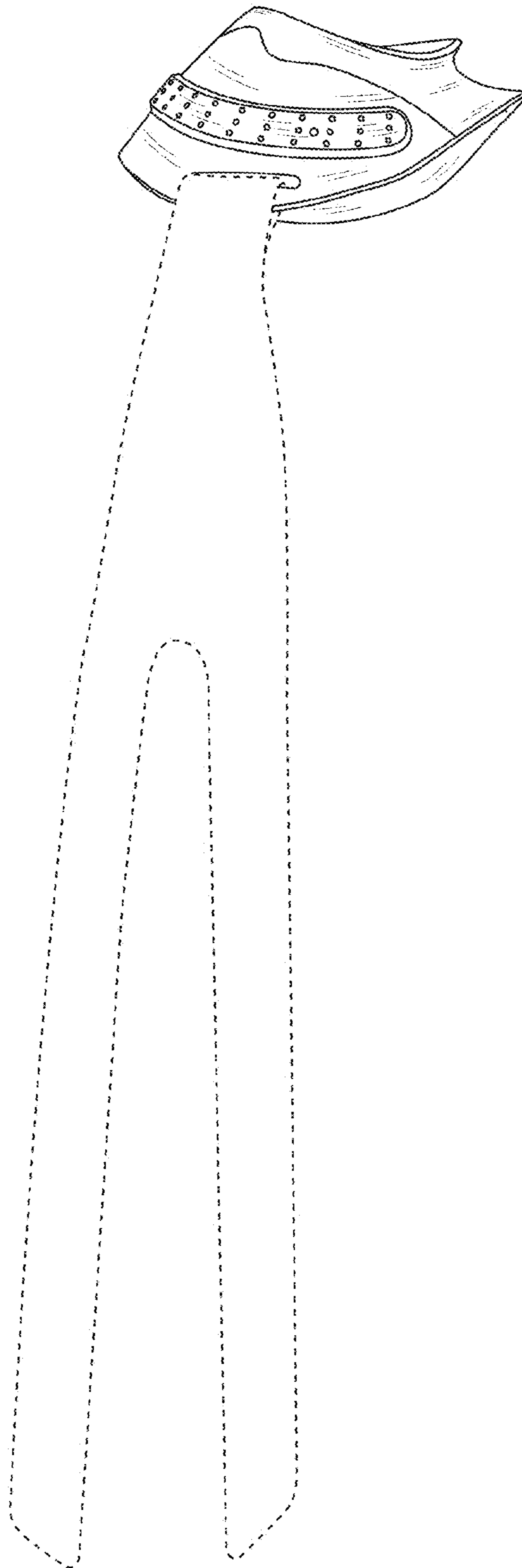
