The broken lines in the drawings illustrate portions of the guard device and form no part of the claimed design.

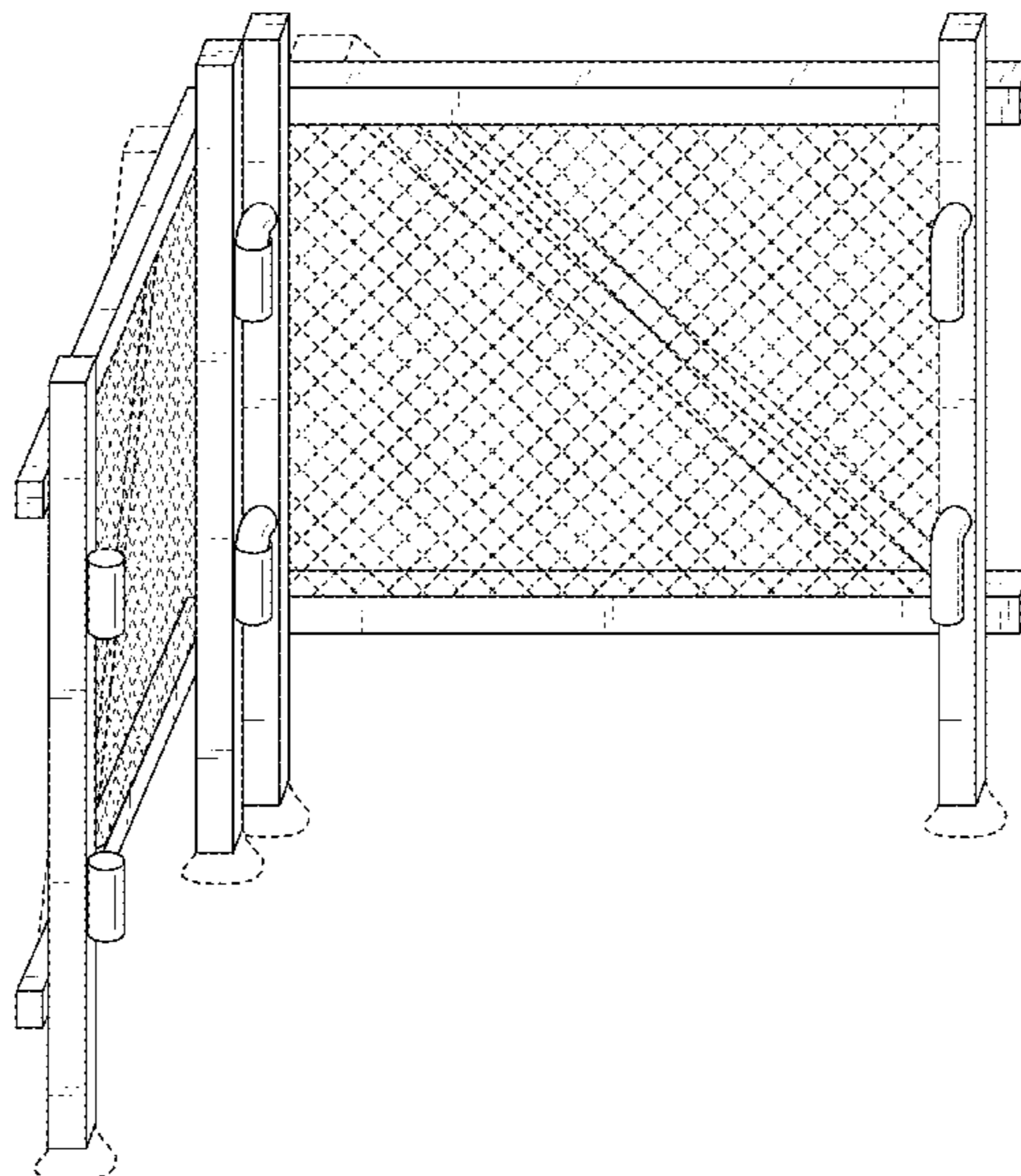

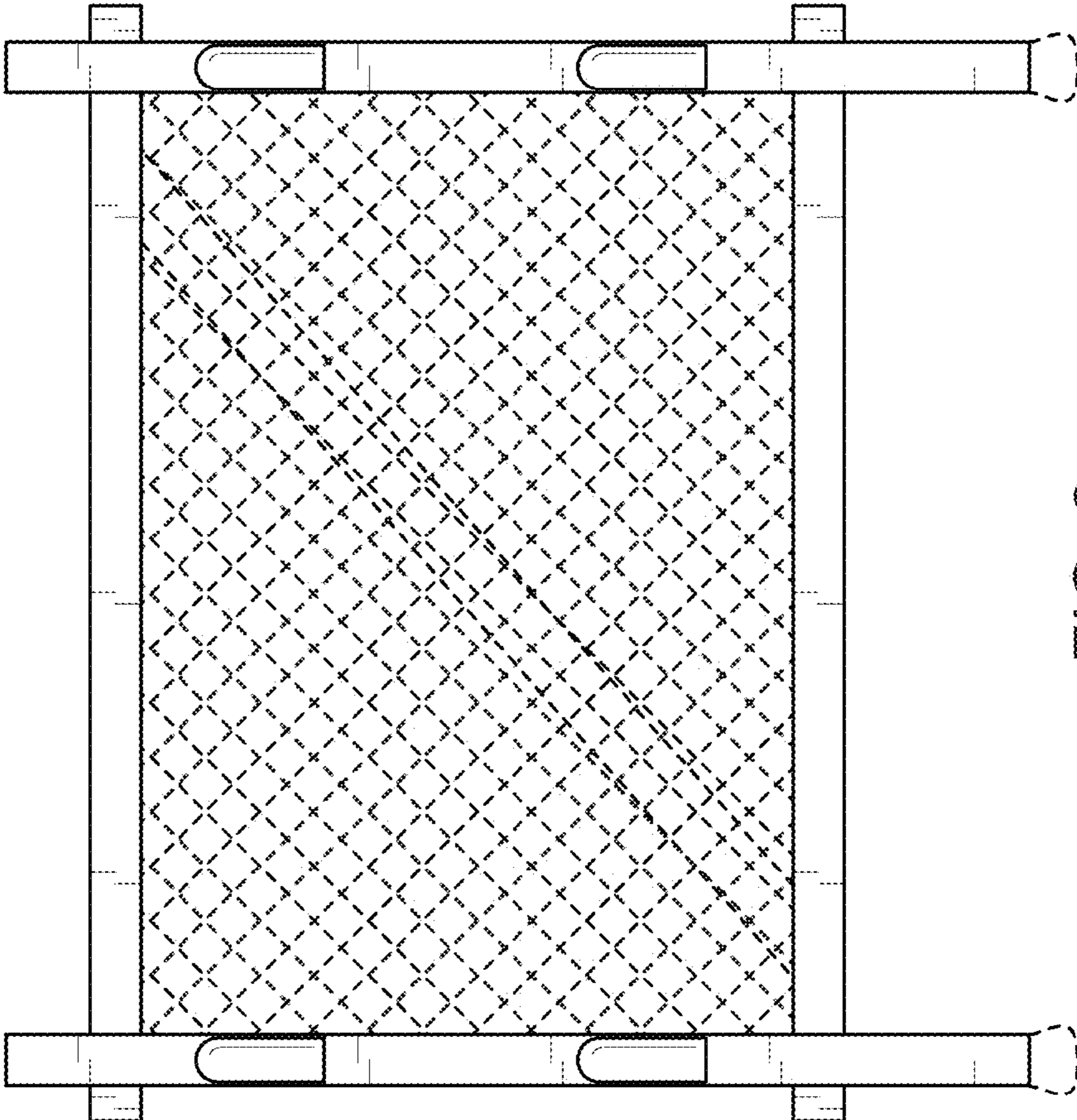

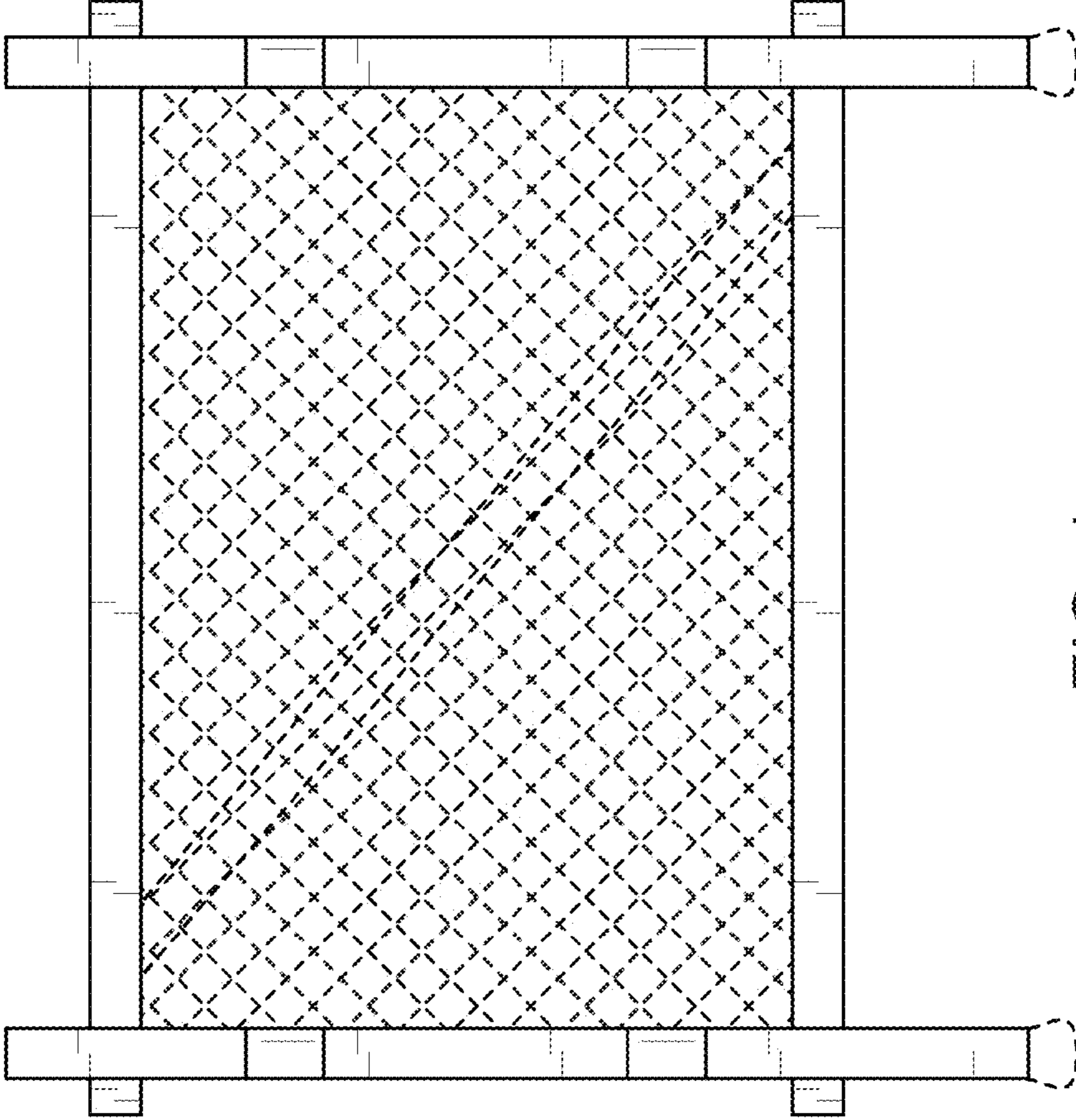

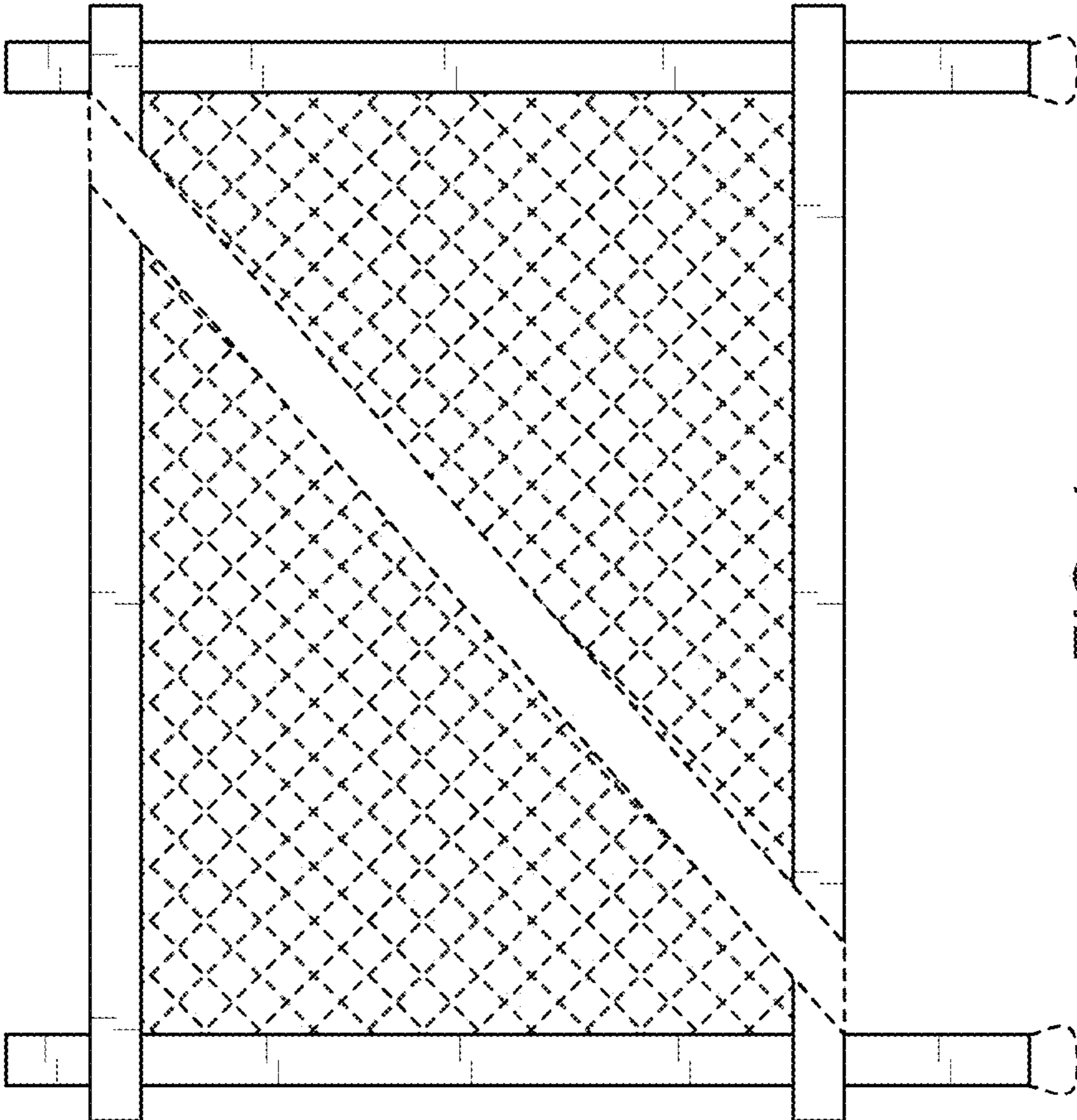

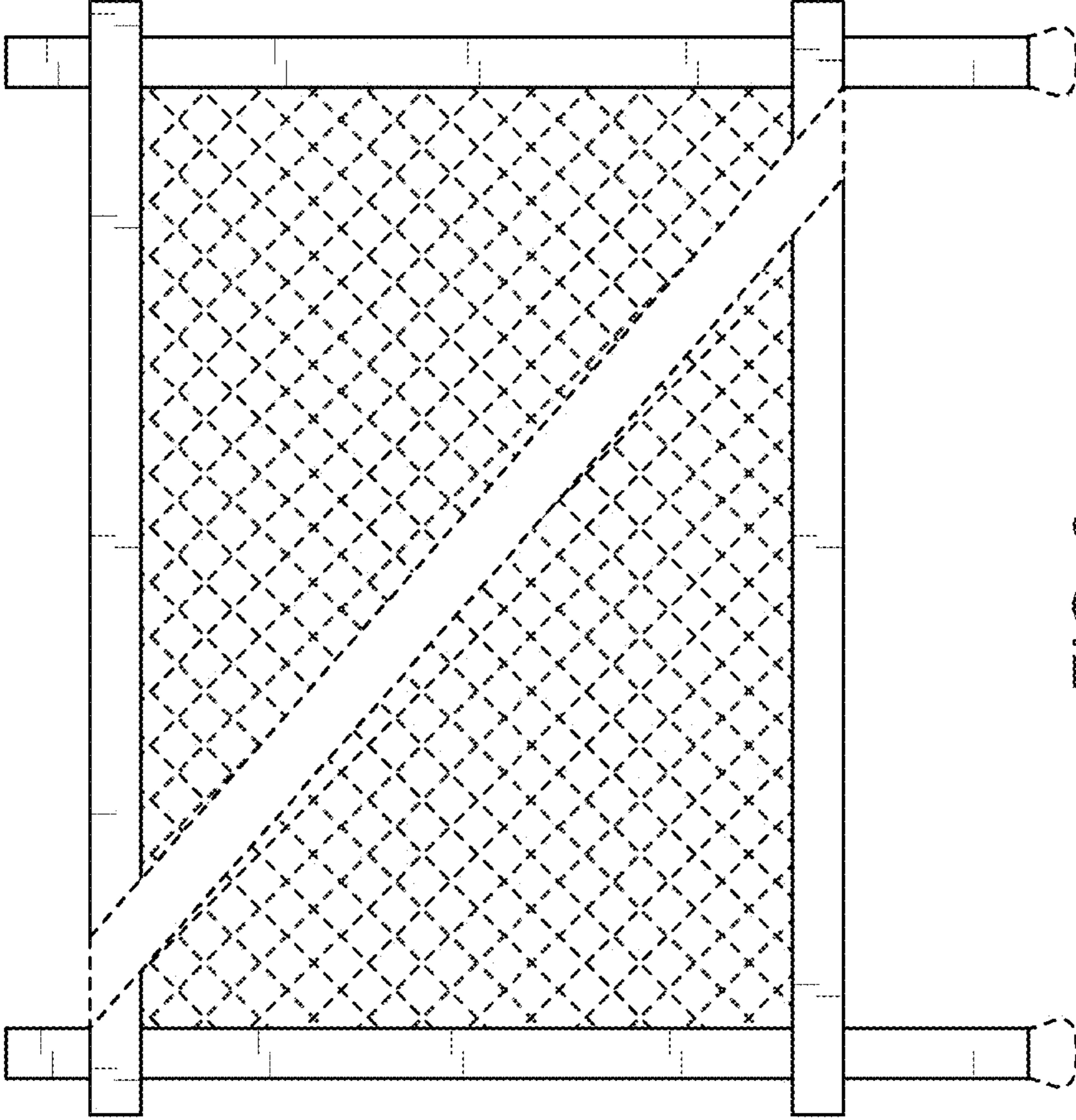

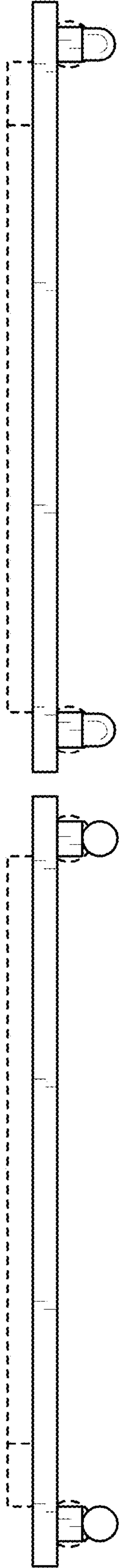

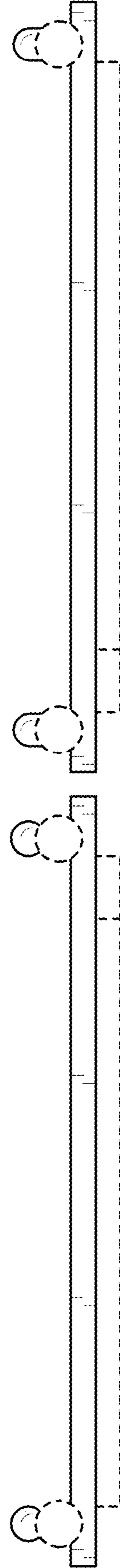

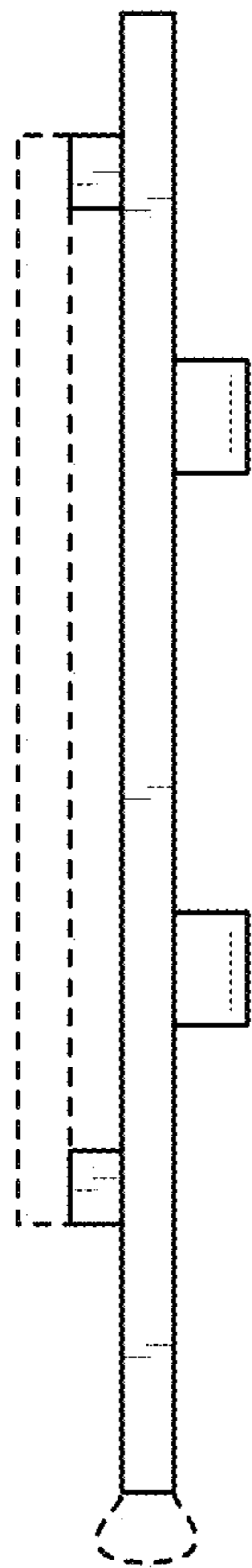

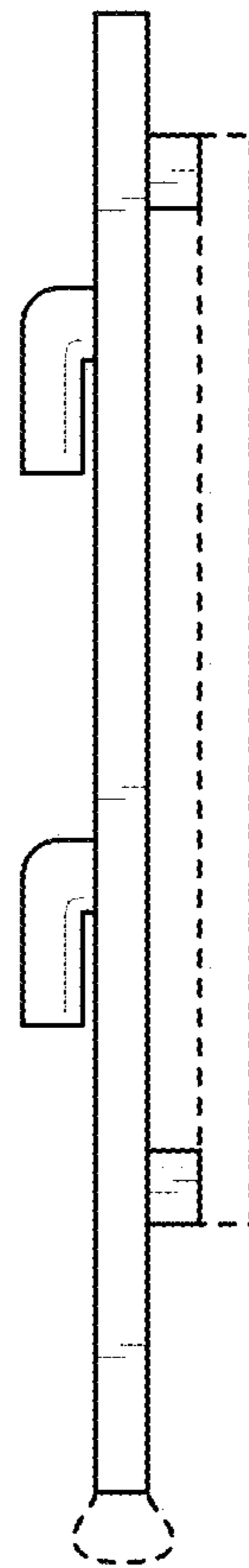

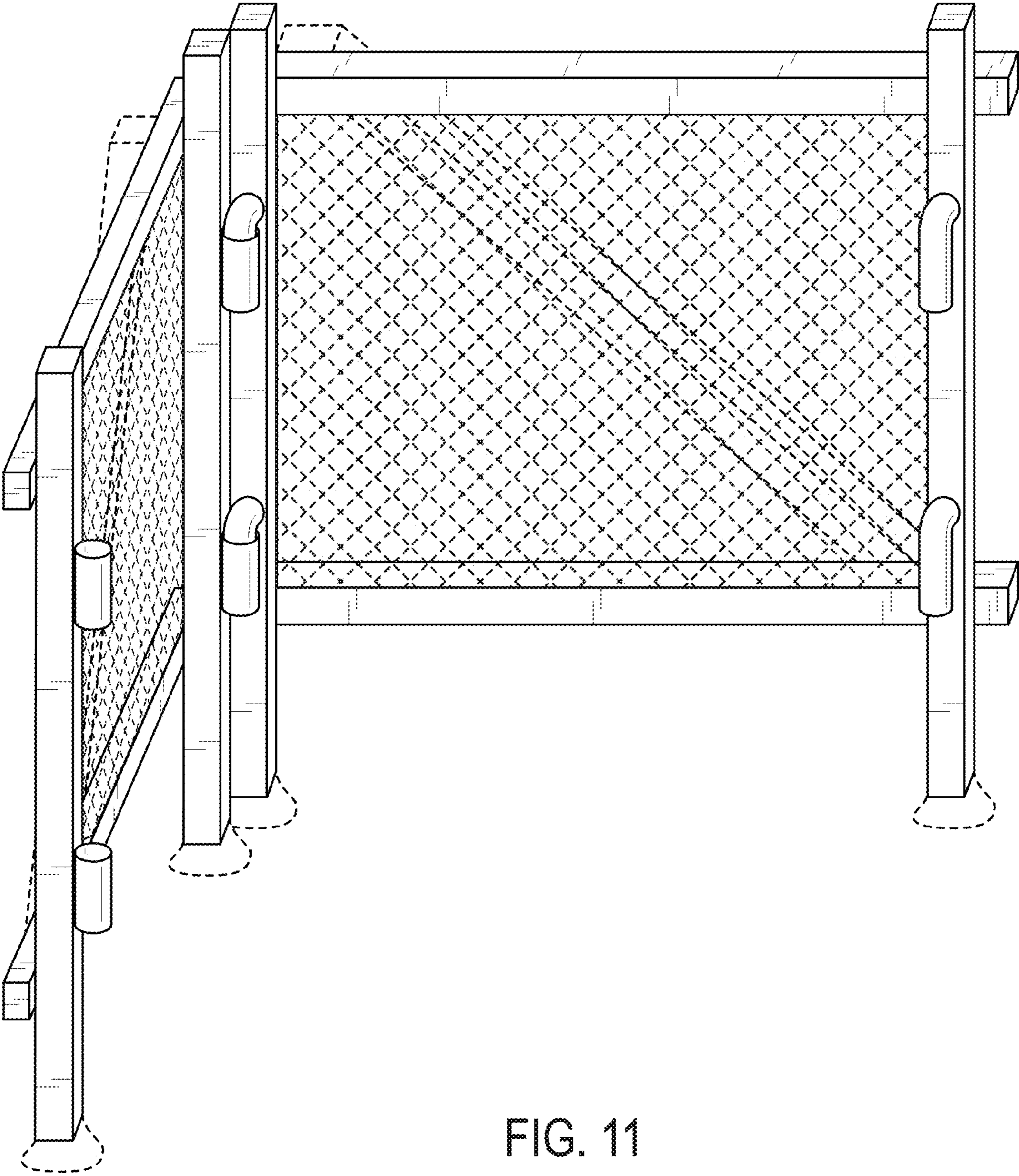
