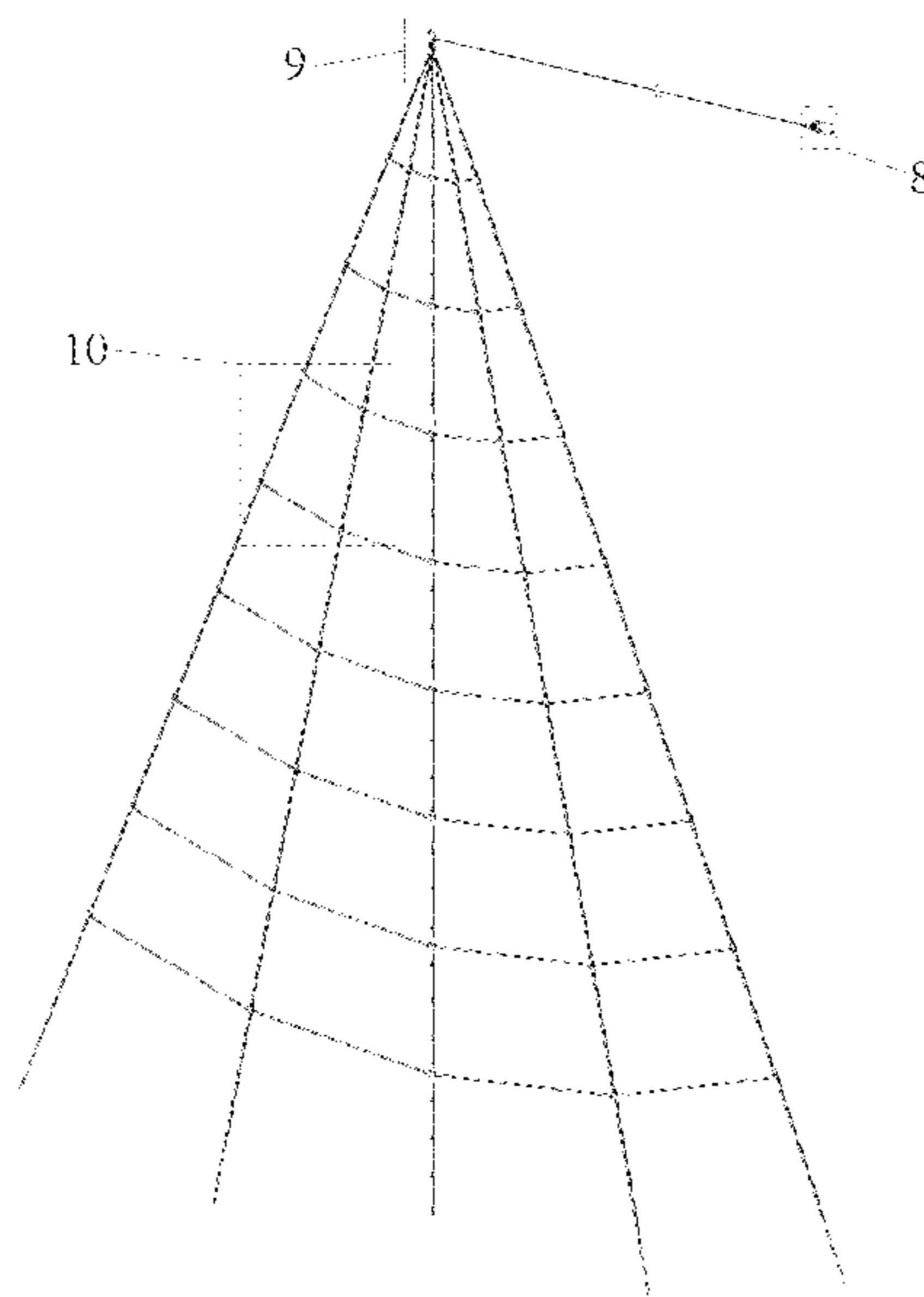
(57) **CLAIM**

The ornamental design for a spider web light, as shown and described.

DESCRIPTION

FIG. 1 is a front, right and top perspective view of a spider web light, showing my new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof;
FIG. 8 is an enlarged view of portion of FIG. 1 thereof;
FIG. 9 is an enlarged view of portion of FIG. 1 thereof; and,
FIG. 10 is an enlarged view of portion of FIG. 1 thereof.
The broken lines in the drawings illustrate the portions of the spider web light, which form no part of the claimed design. The additional broken lines in the figures are demarcating enlarged areas and form no part of the claimed design. The cable is shown with a symbolic break in its length. The appearance of any portion of the article between the break lines forms no part of the claimed design.

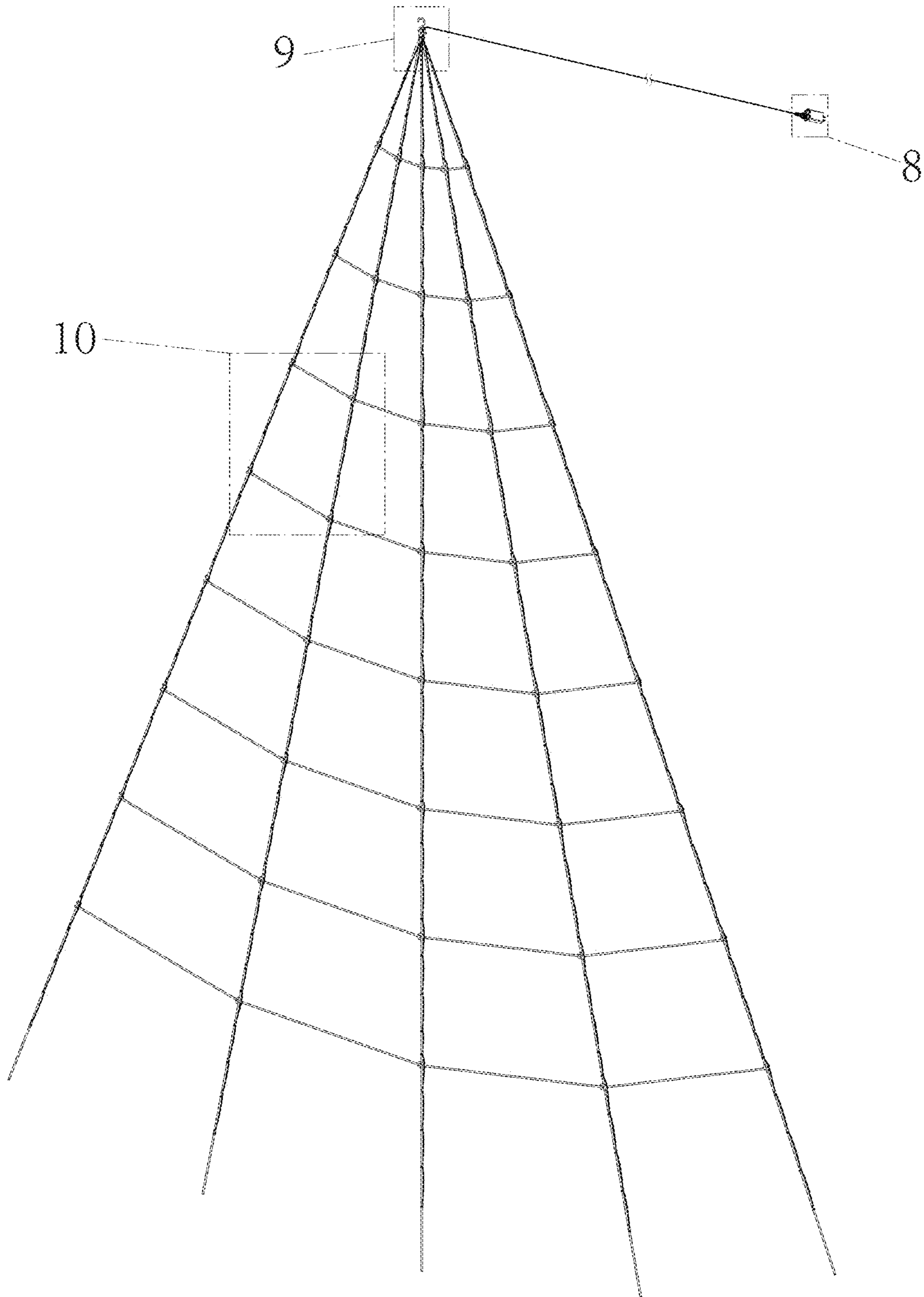

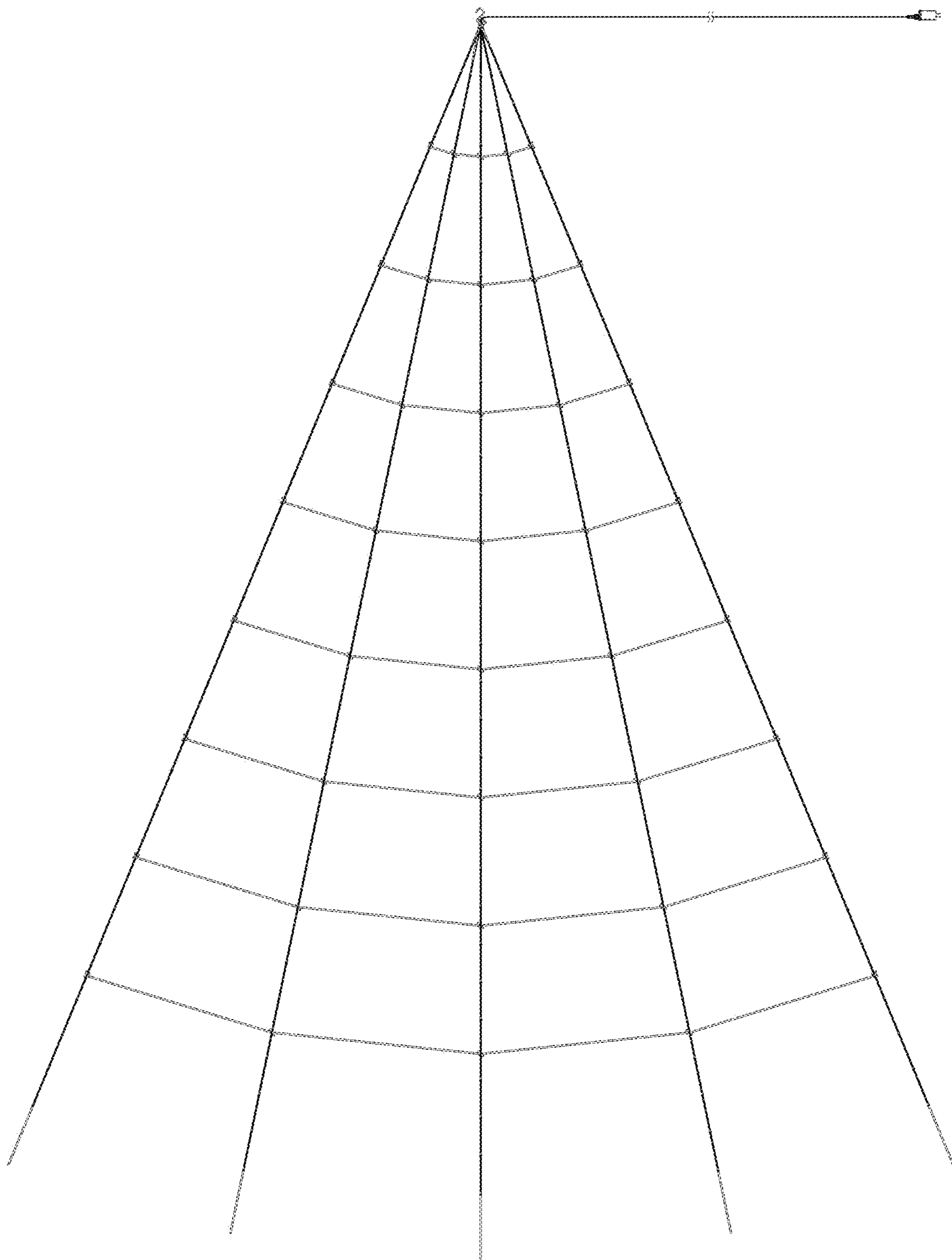

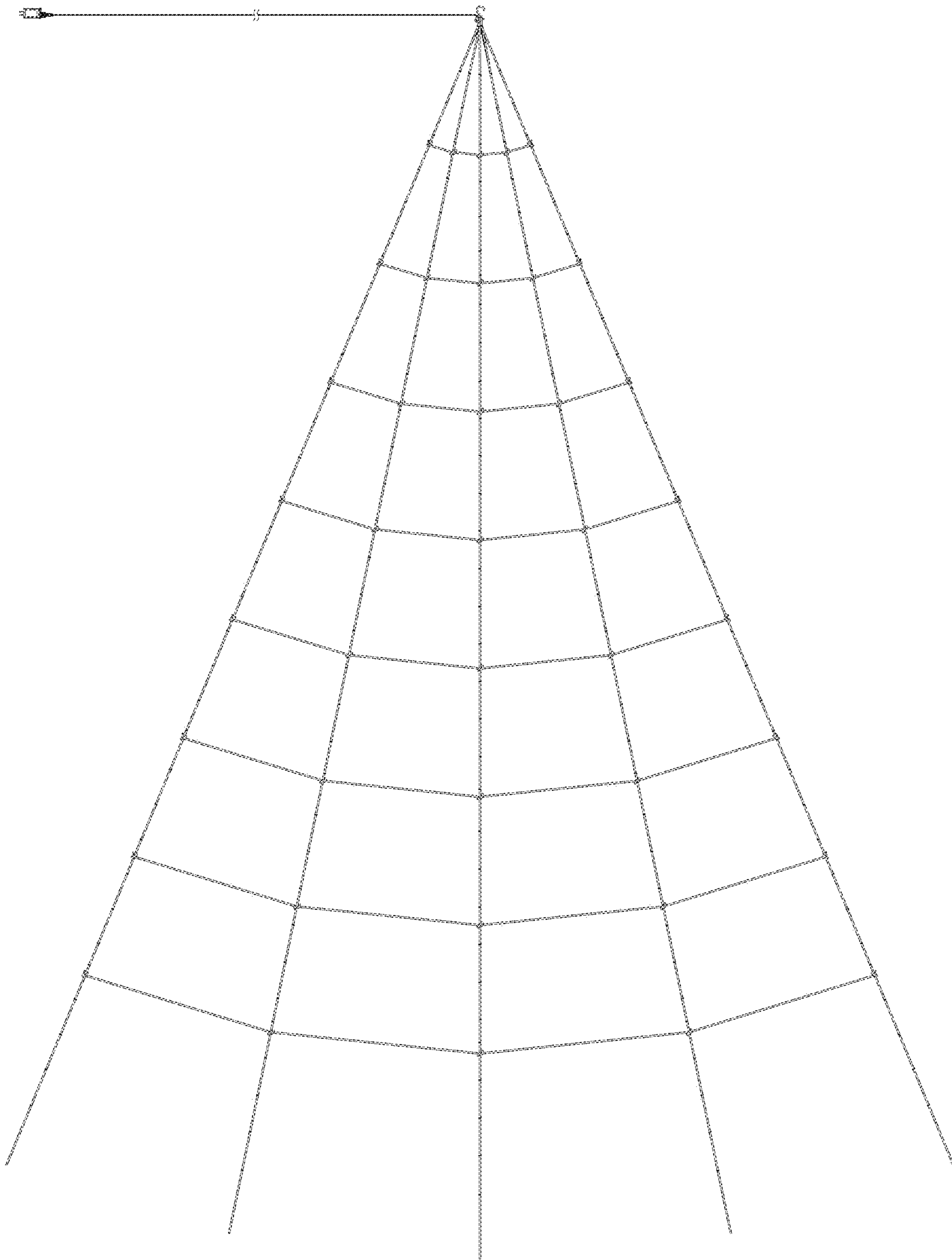

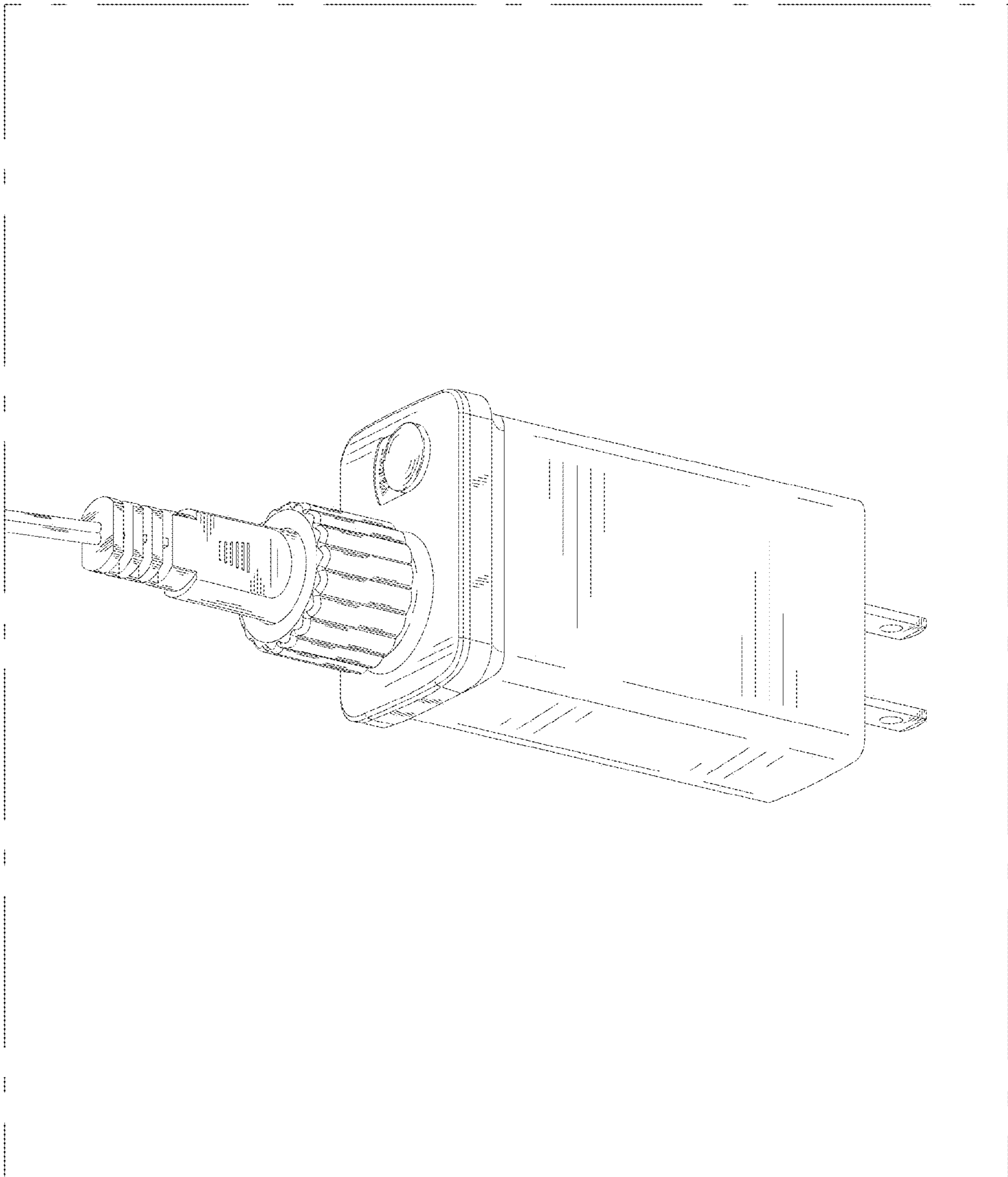

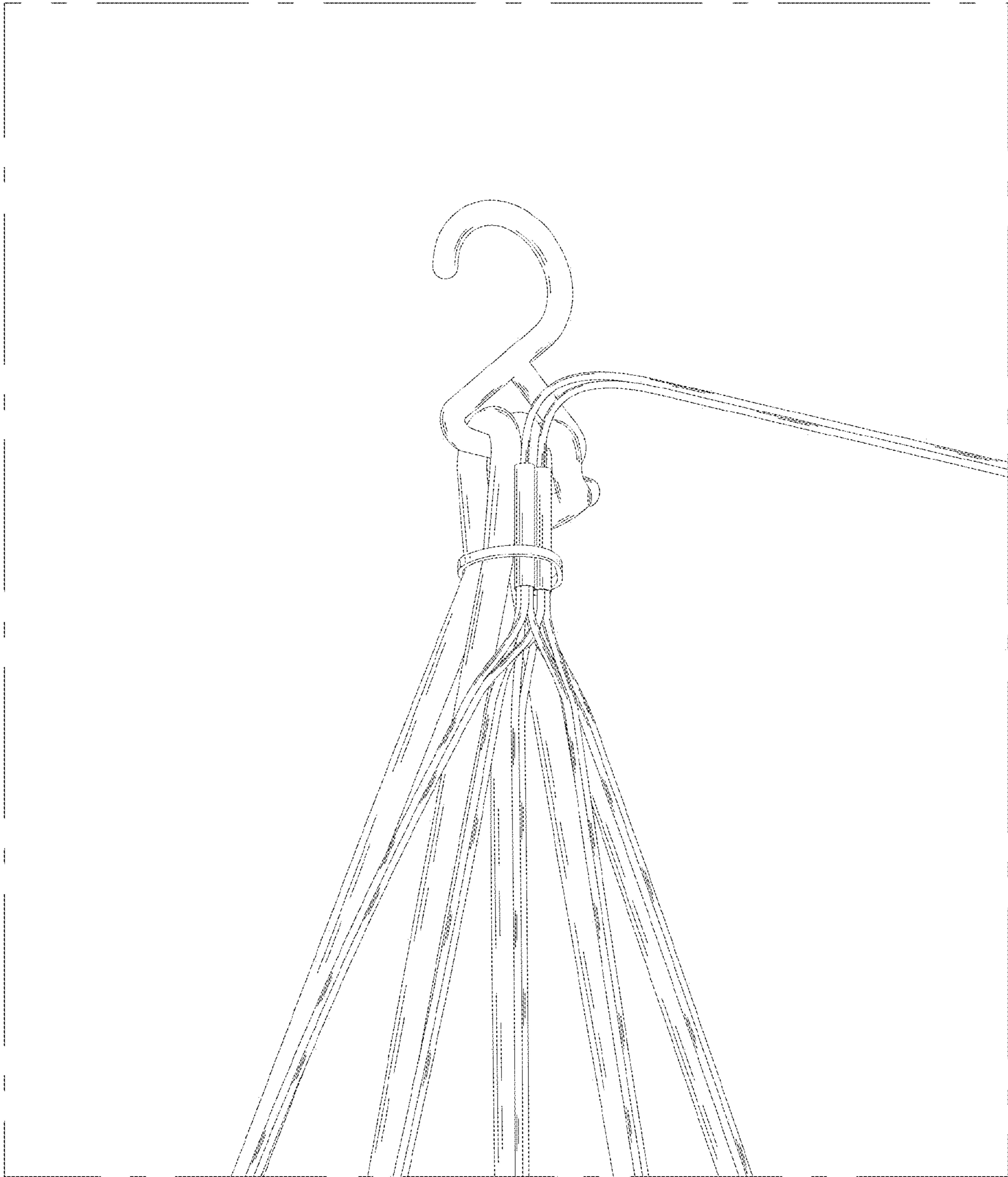

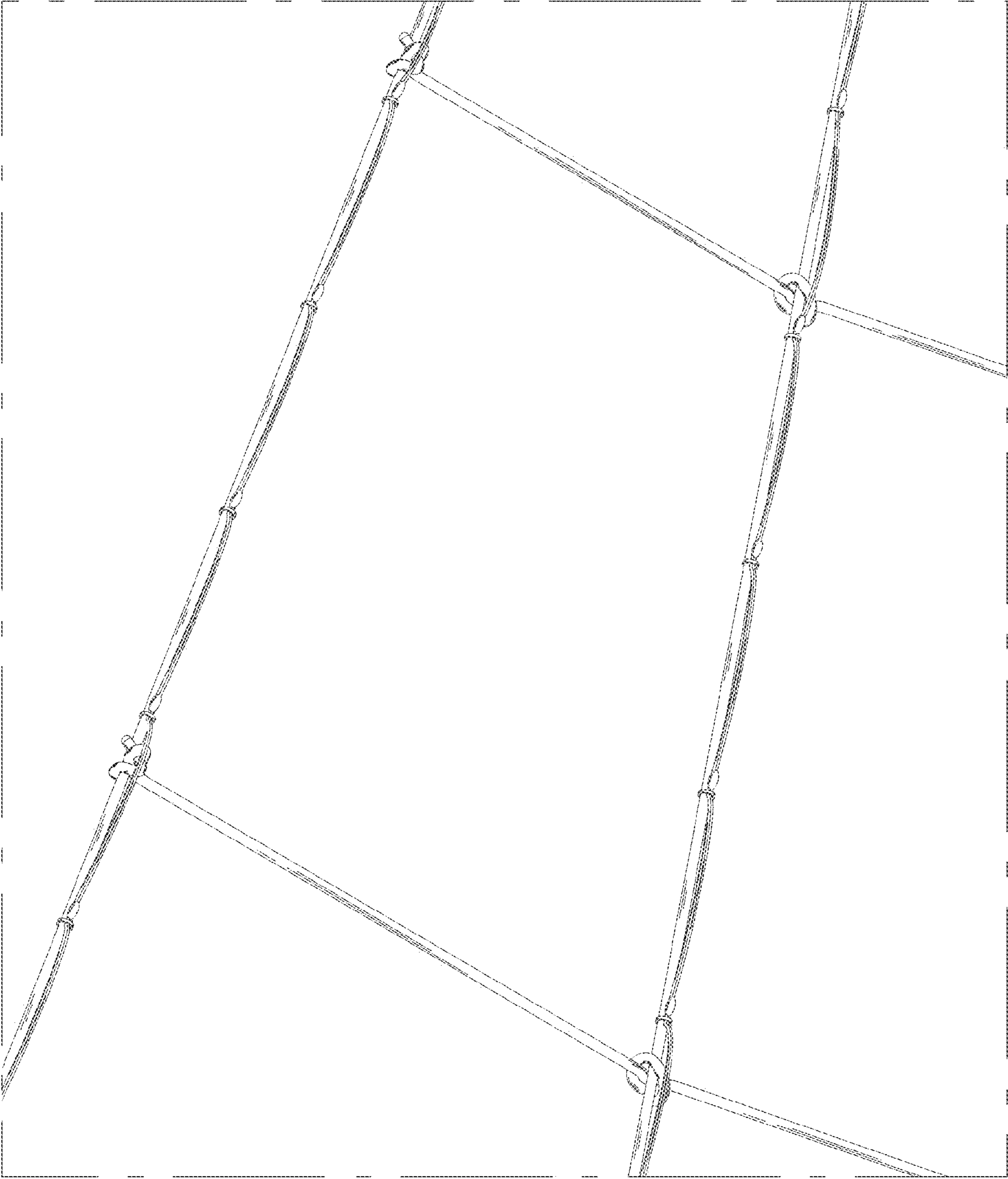
