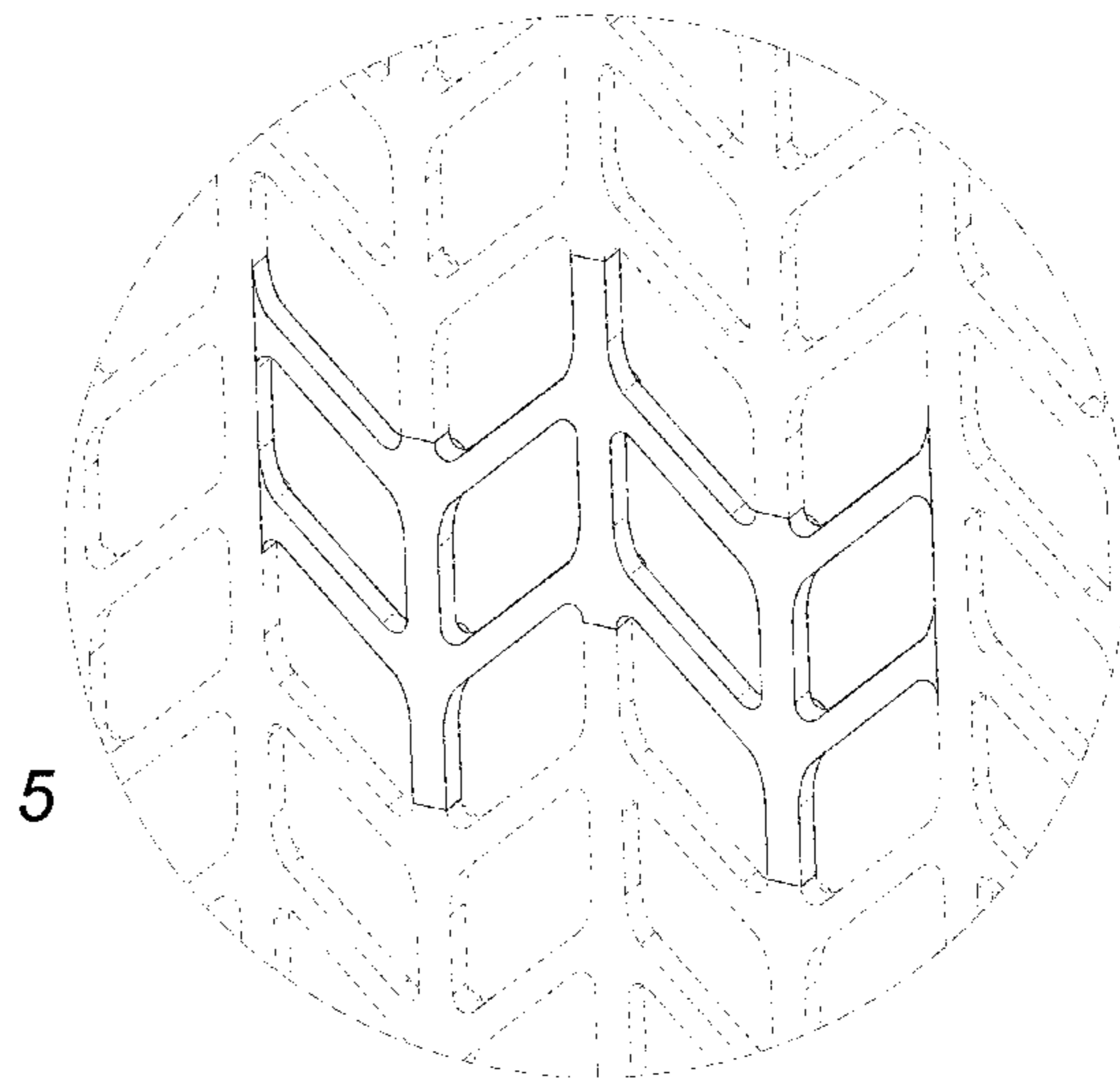
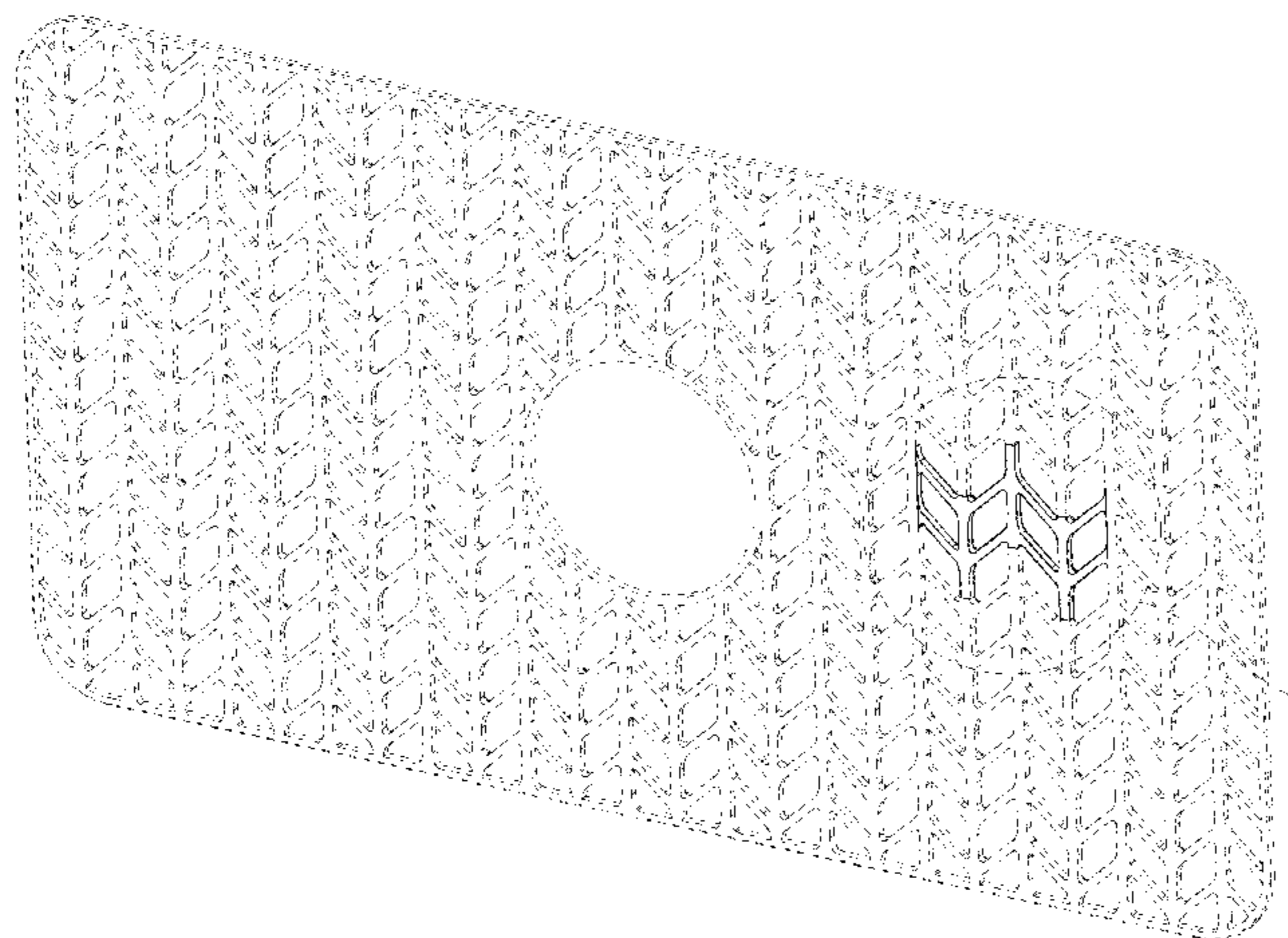
(57) **CLAIM**

The ornamental design for a sink mat, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a sink mat, showing my new design;
FIG. 2 is another perspective view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a partial enlarged view of FIG. 1;
FIG. 6 is a partial enlarged view of FIG. 2;

FIG. 8 is a partial enlarged view of FIG. 4.

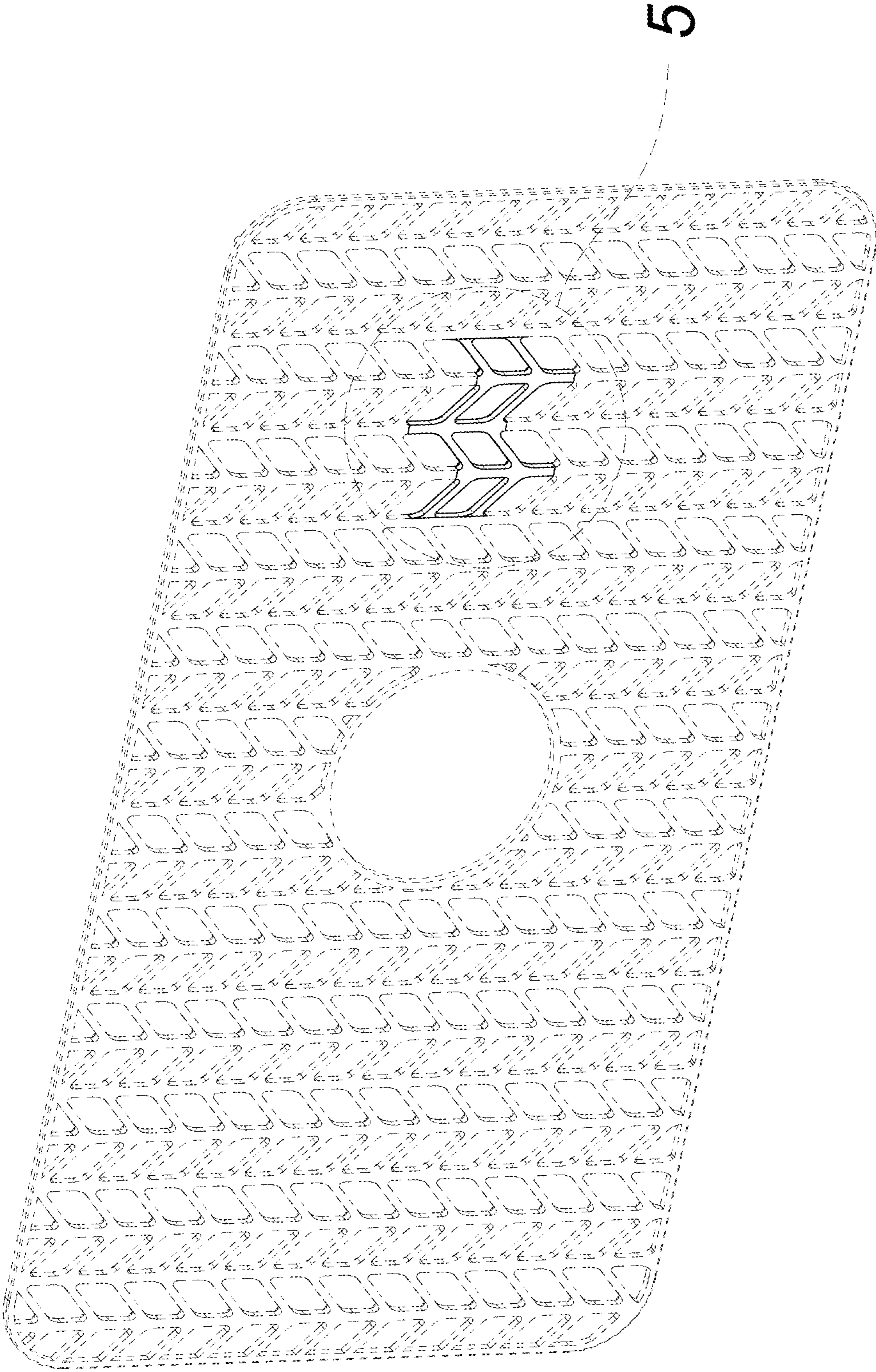

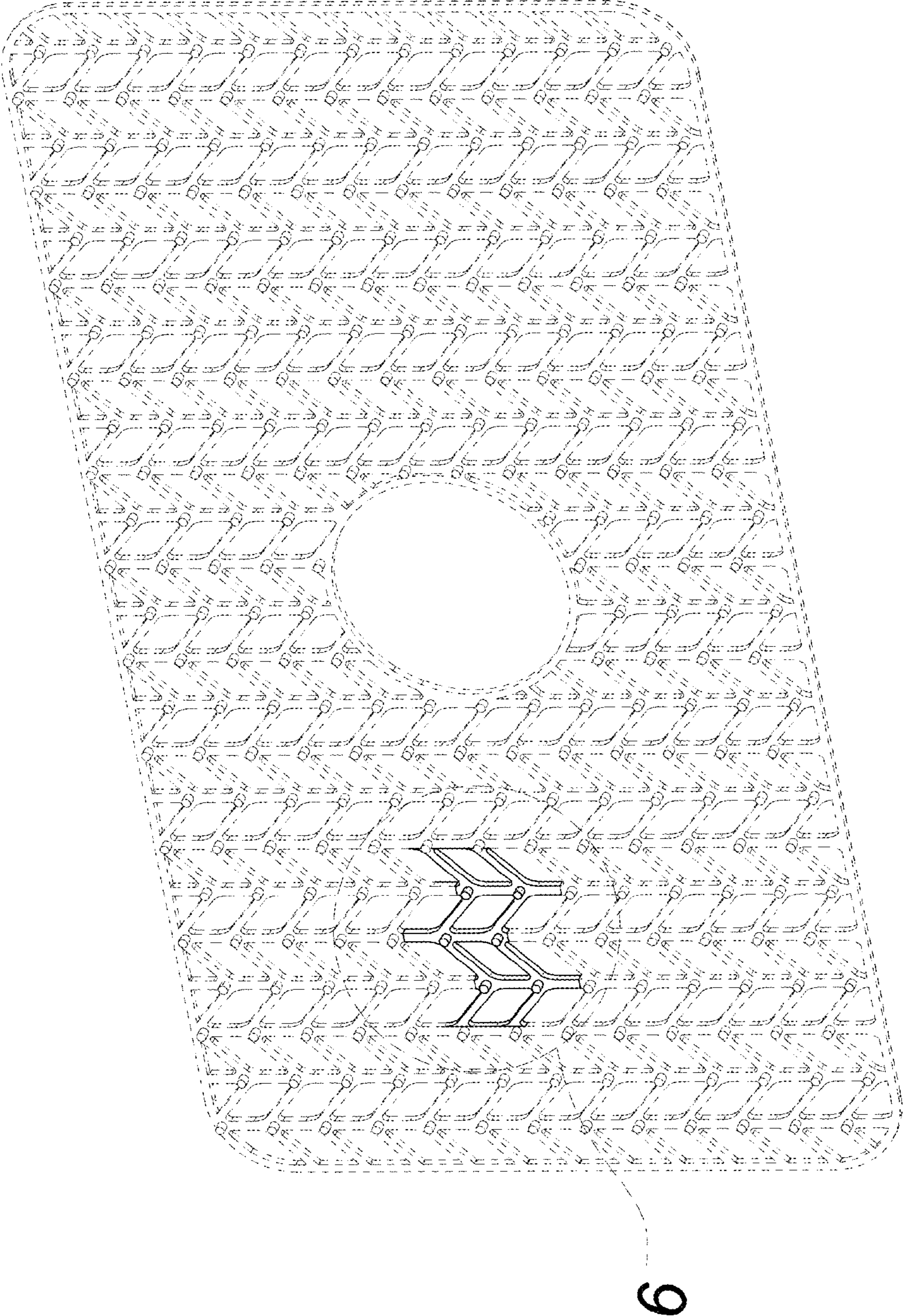
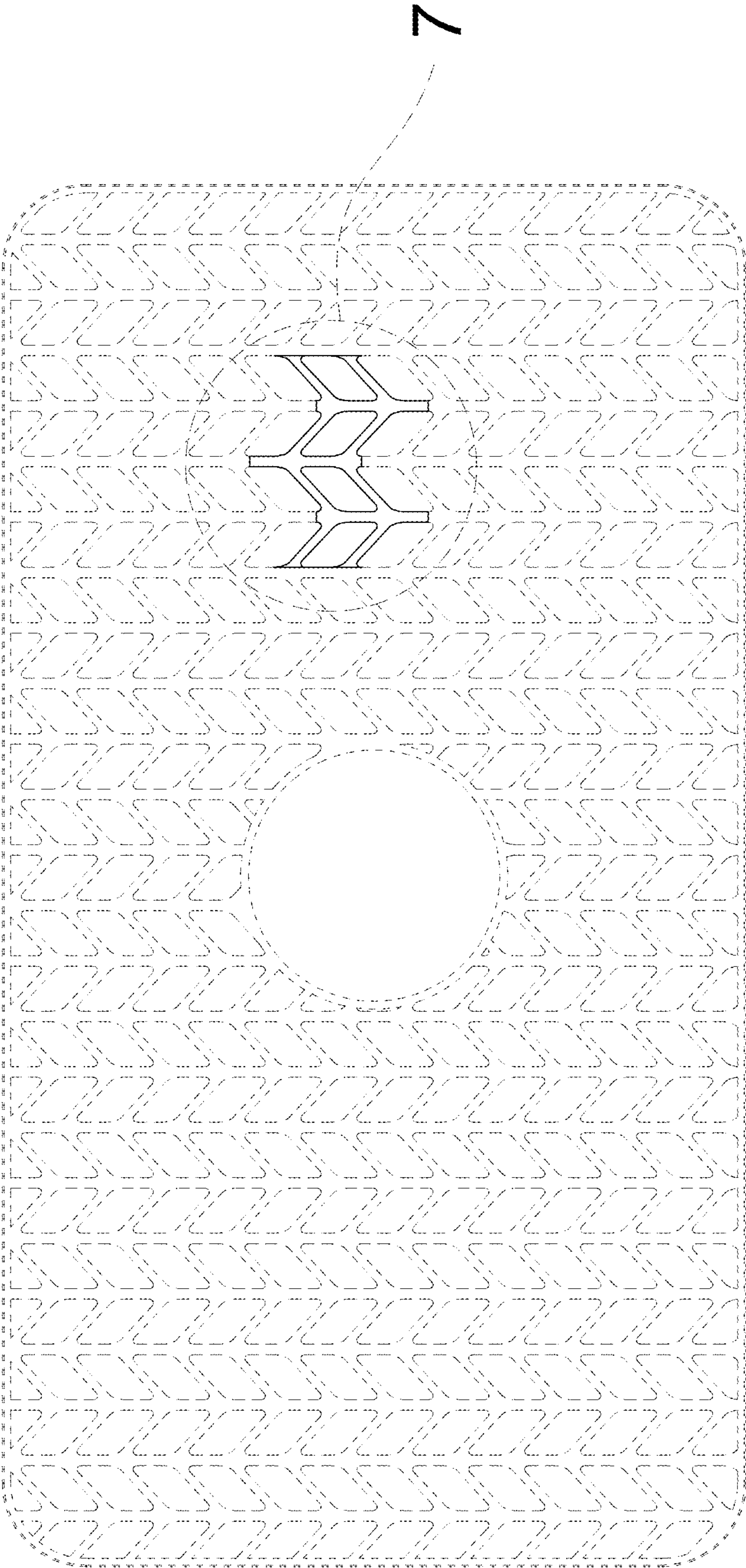

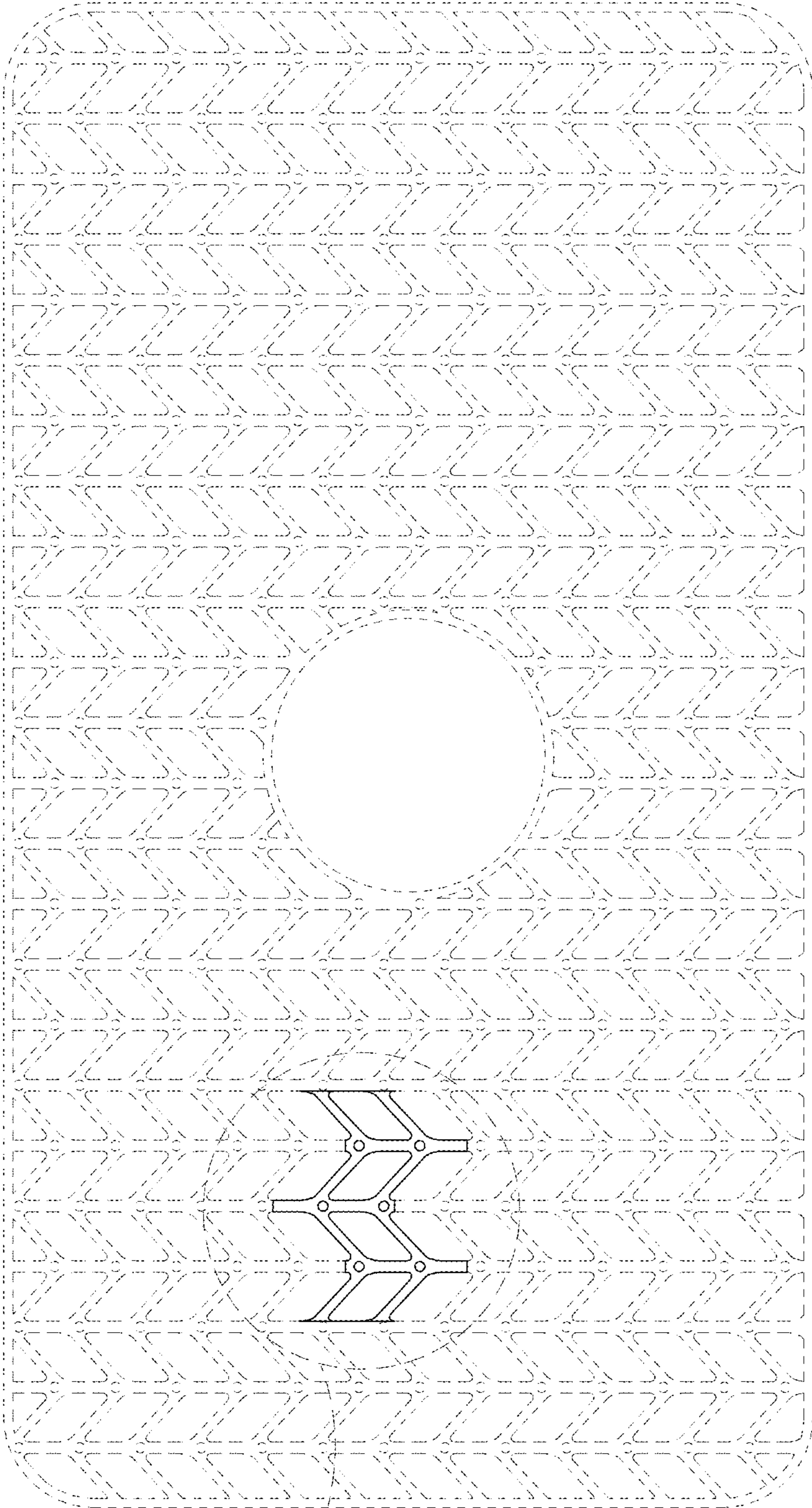

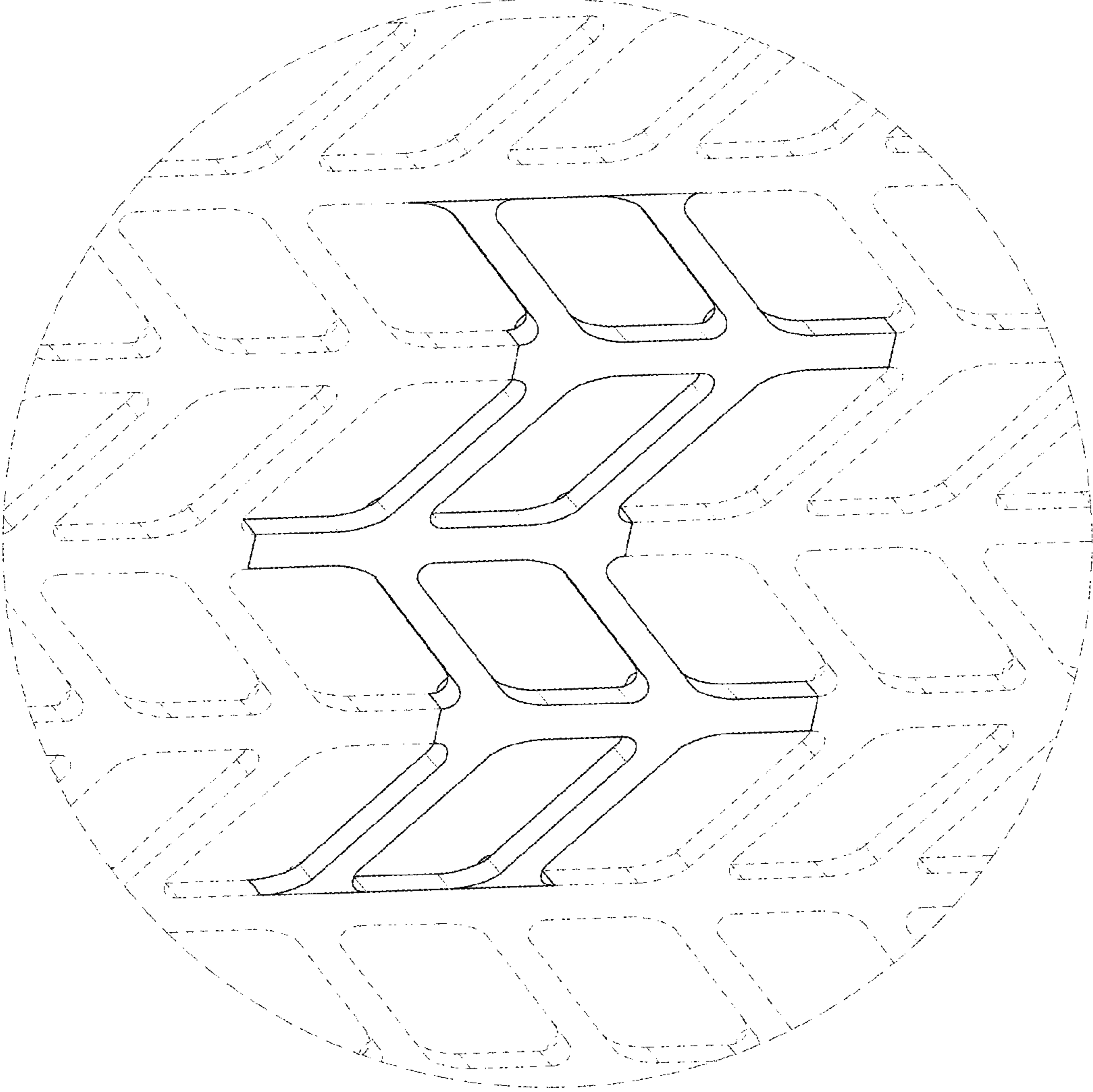

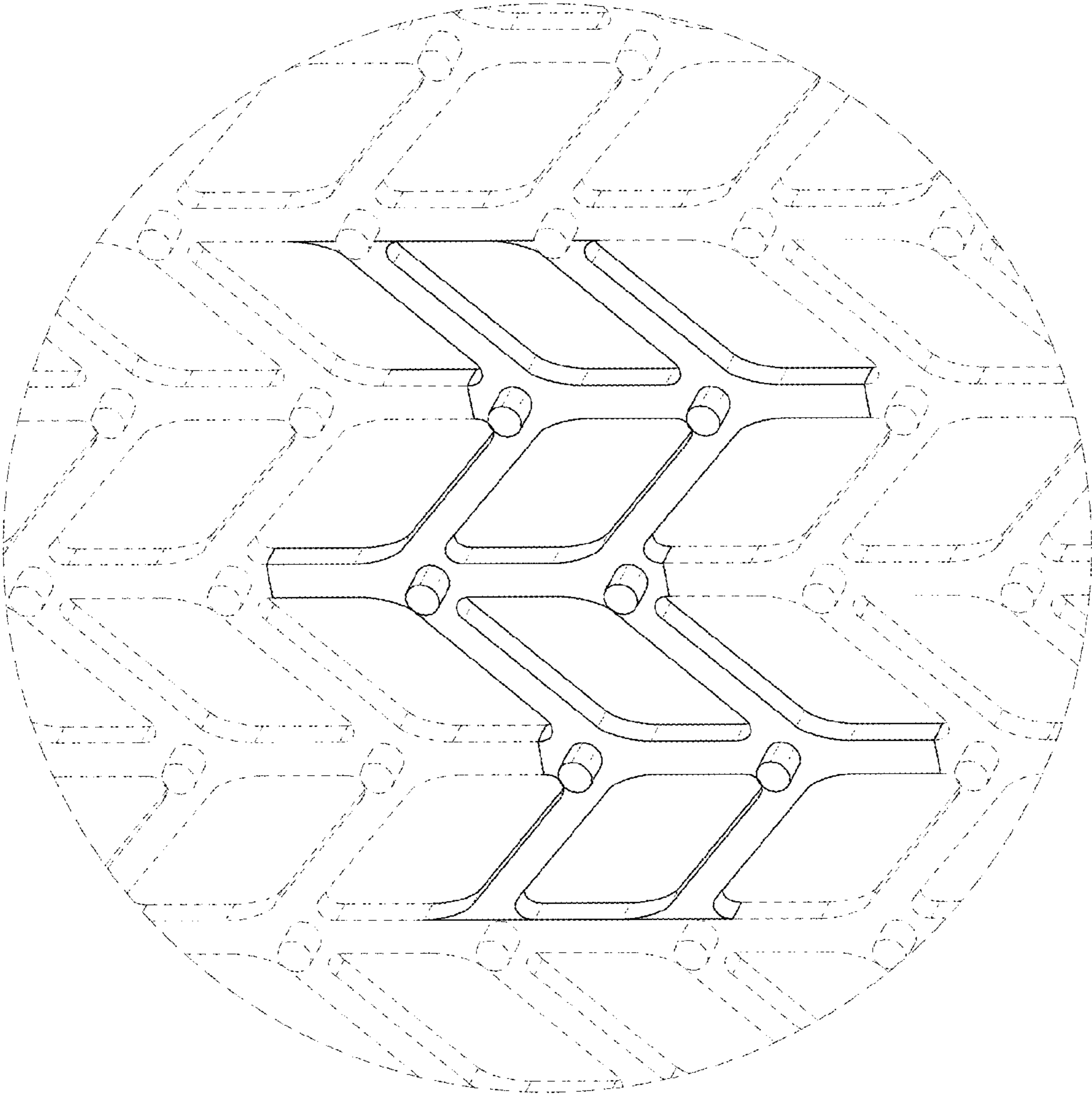

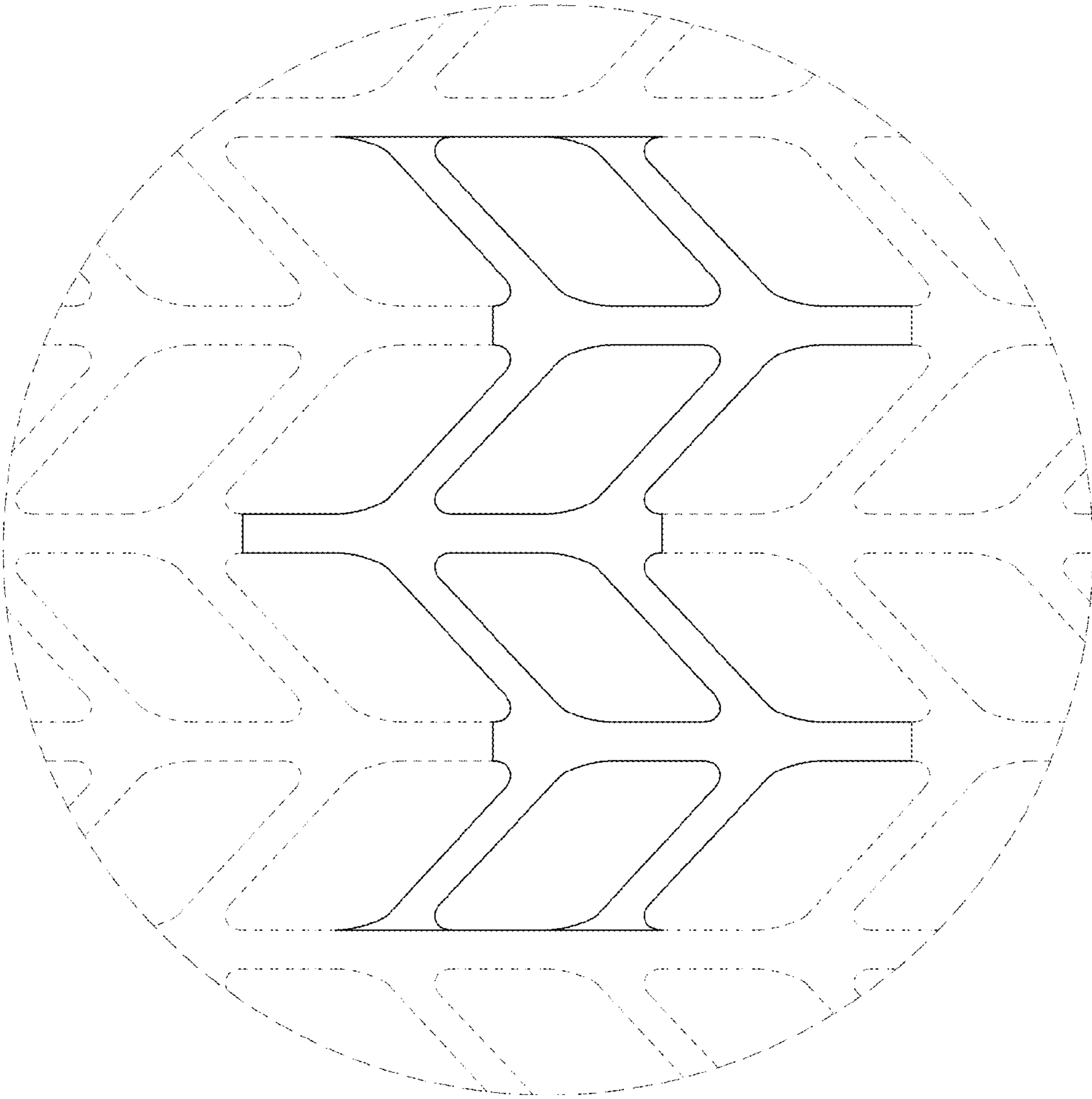

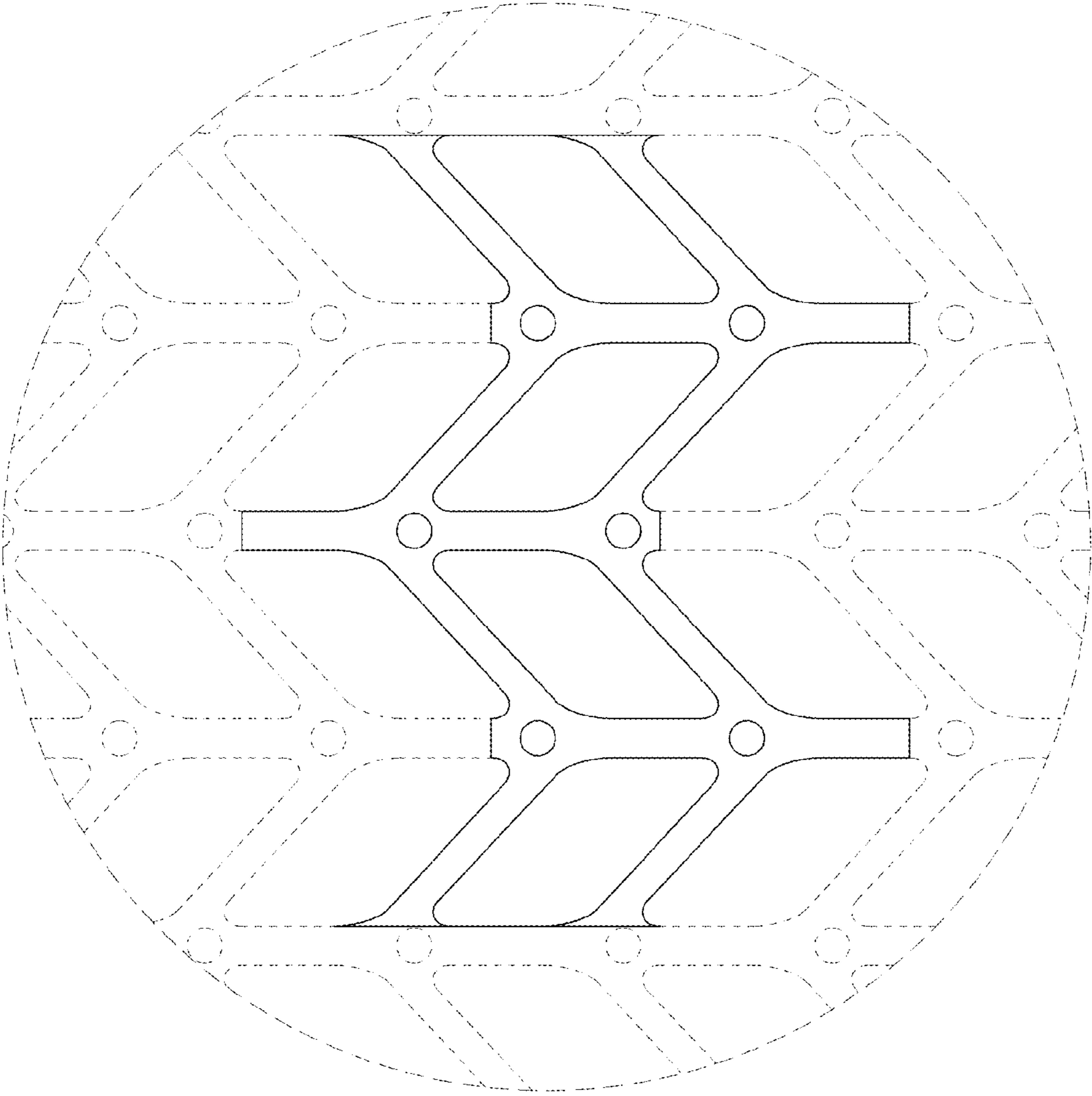
