FIG. 10 is a rear elevation view thereof;

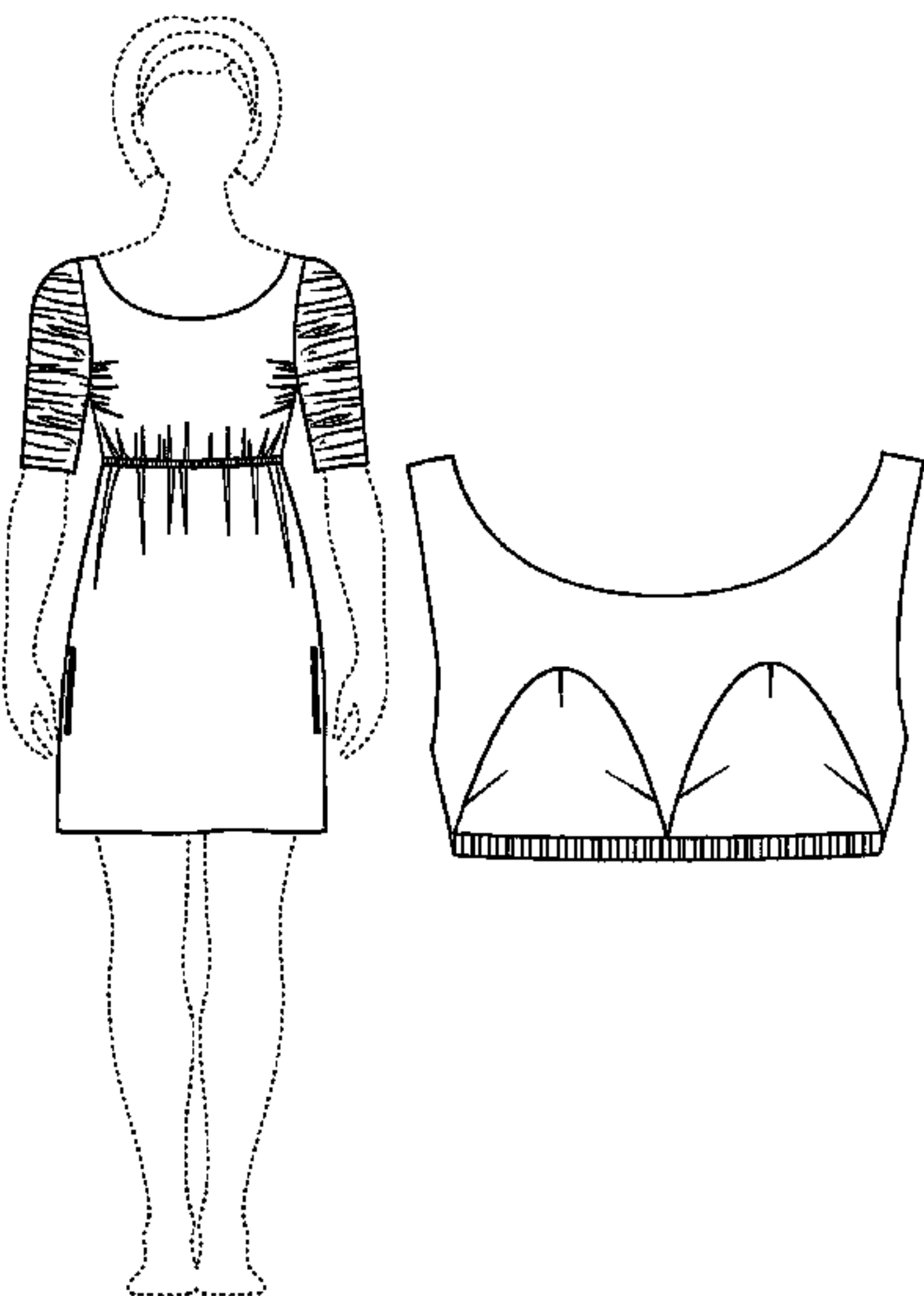

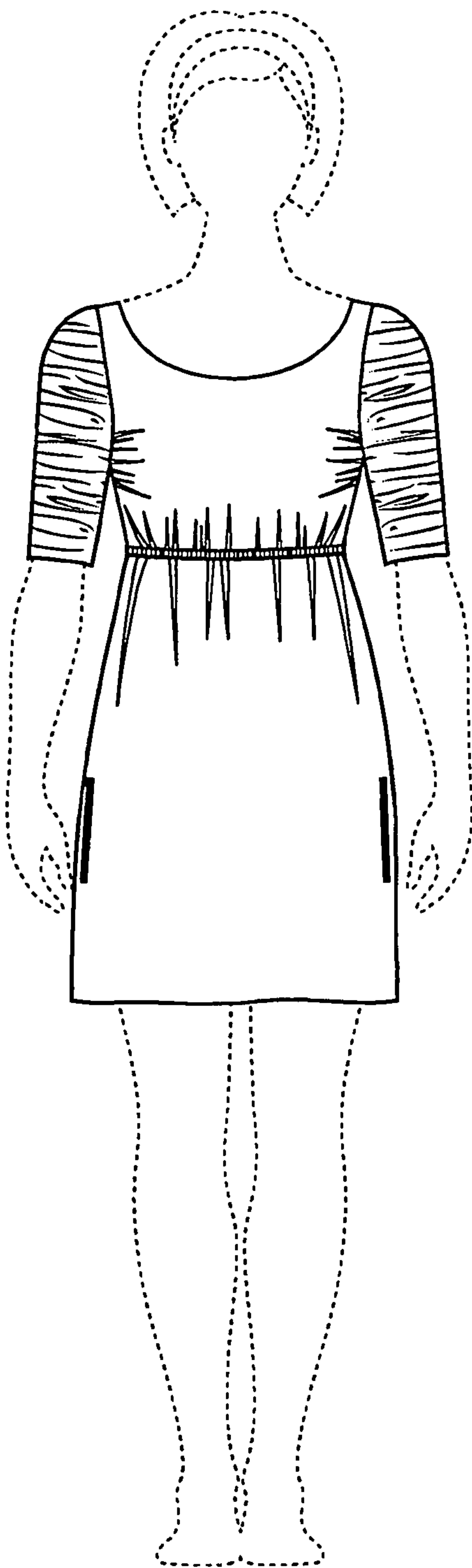

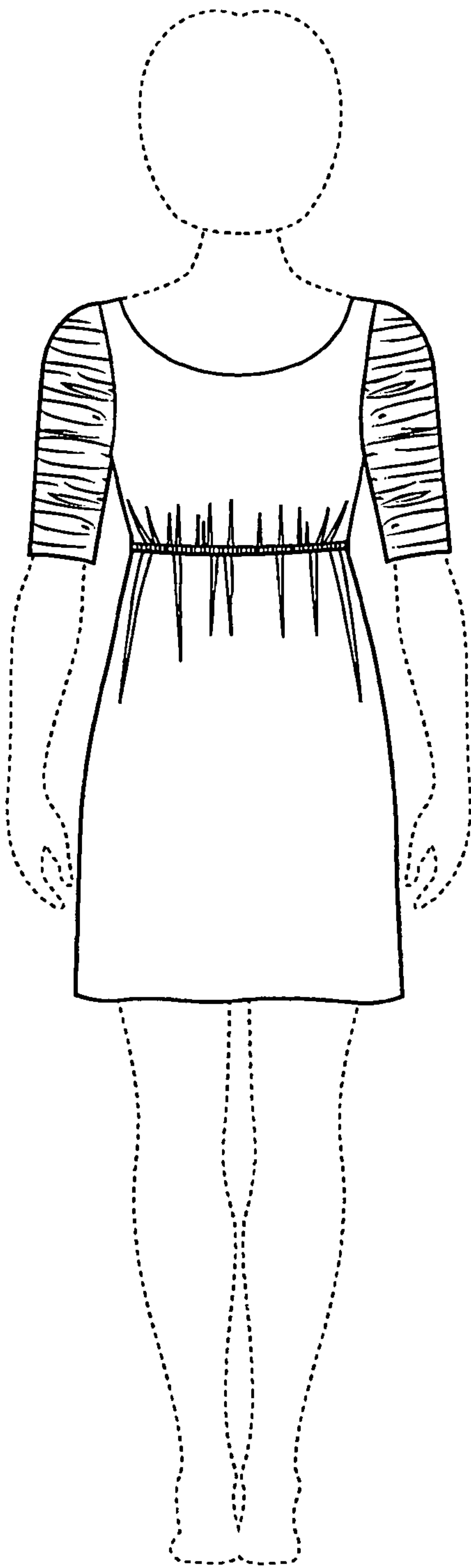

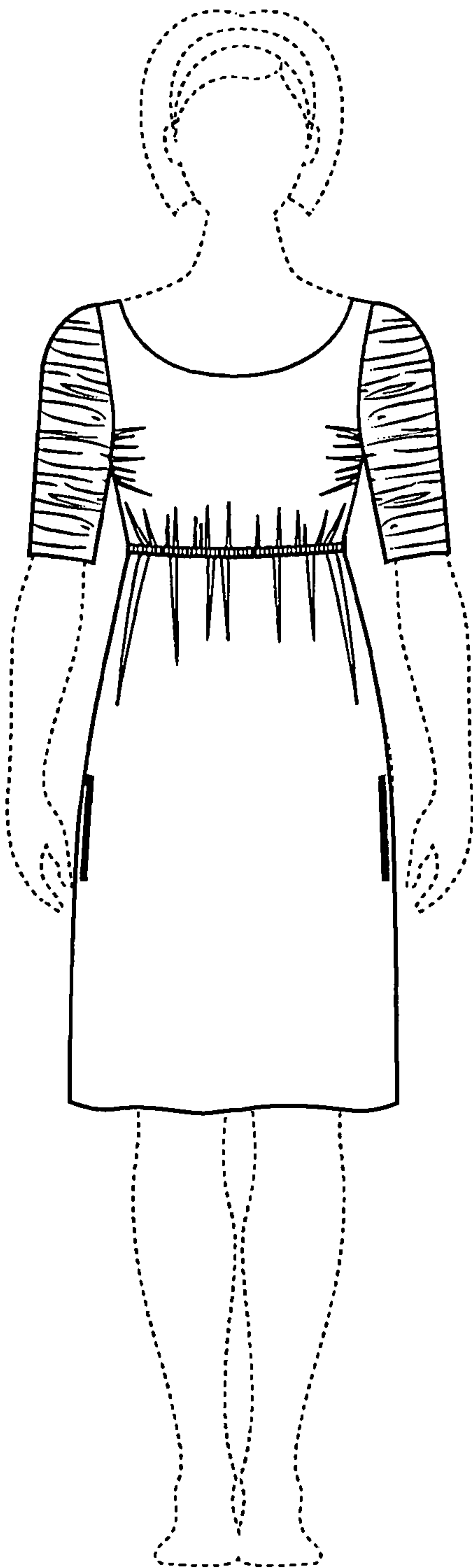

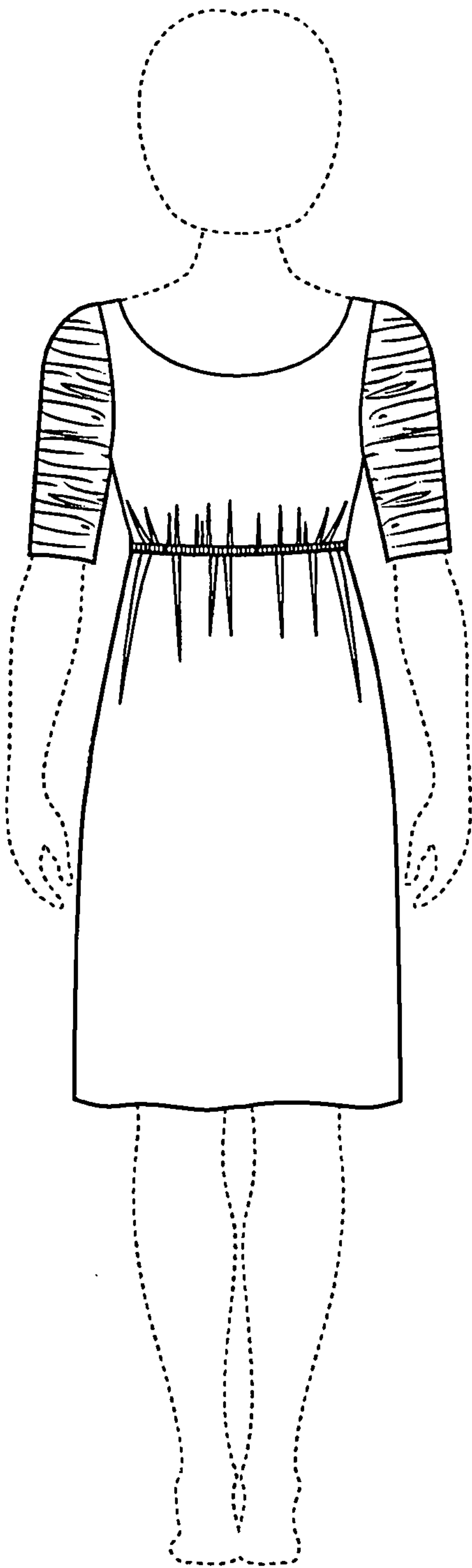

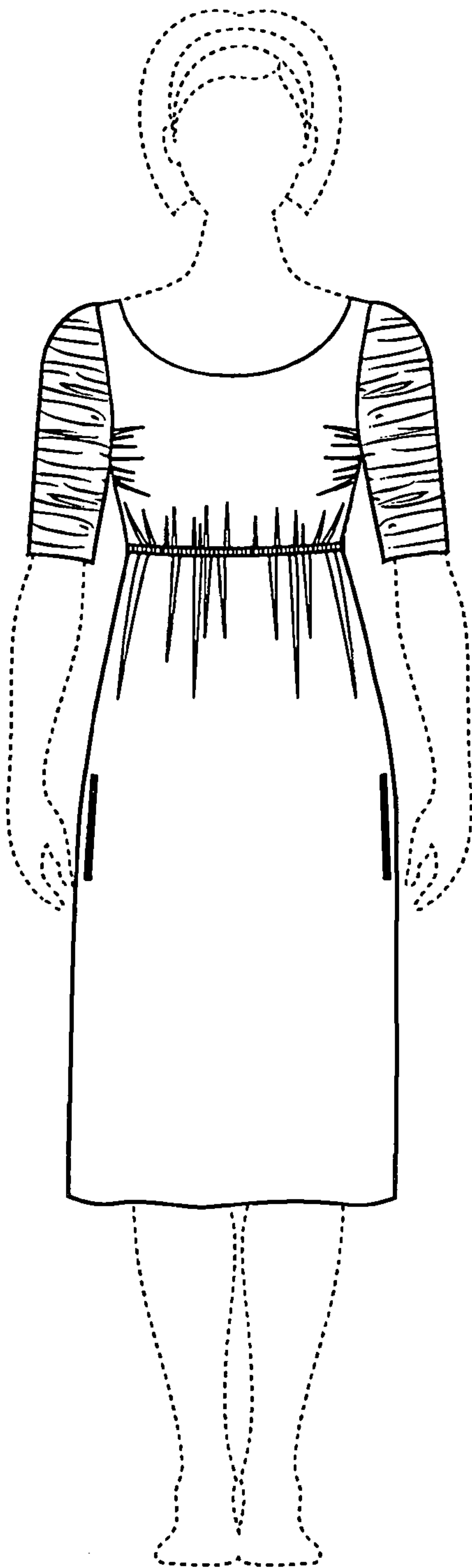

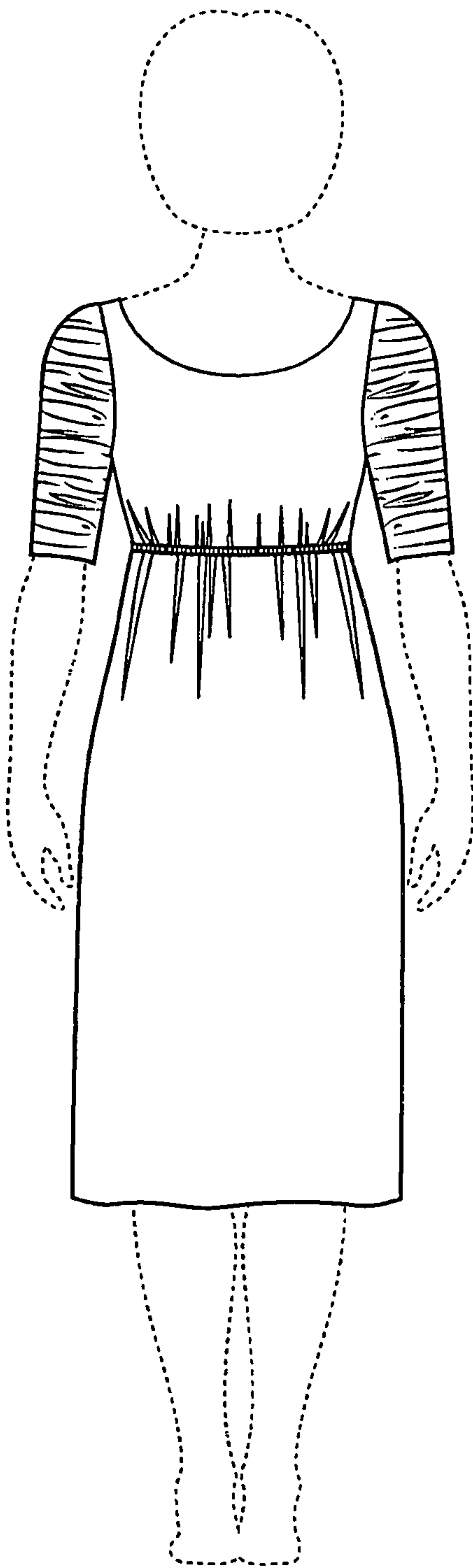

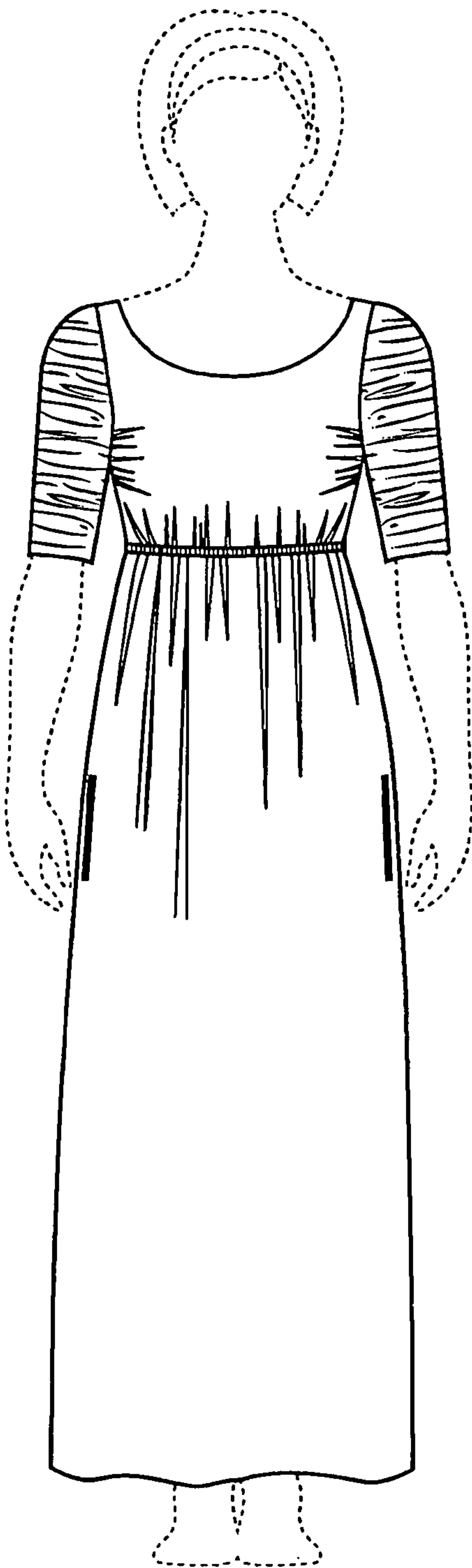

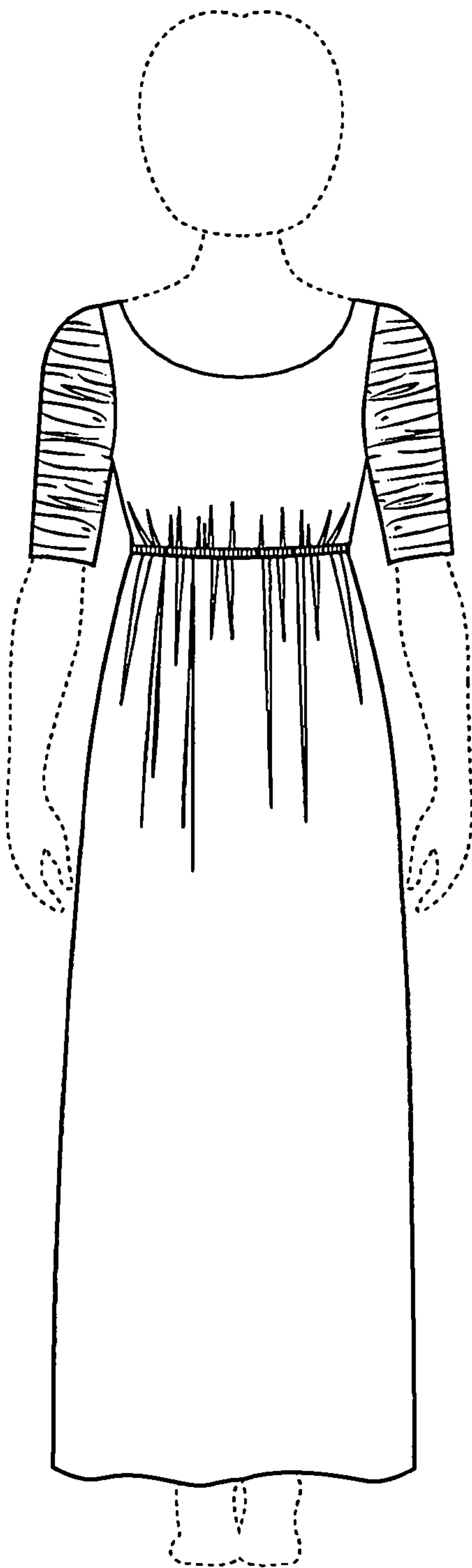

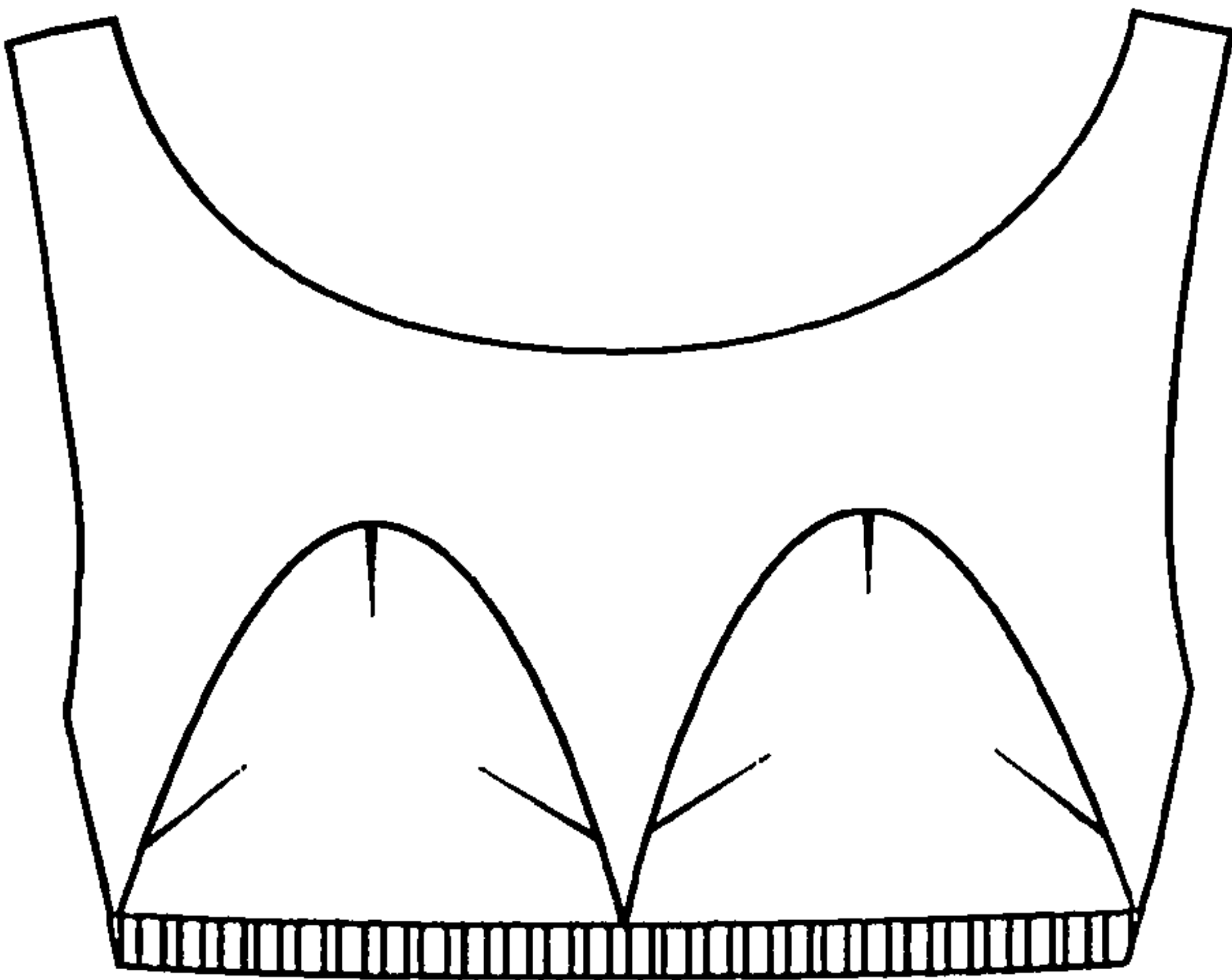

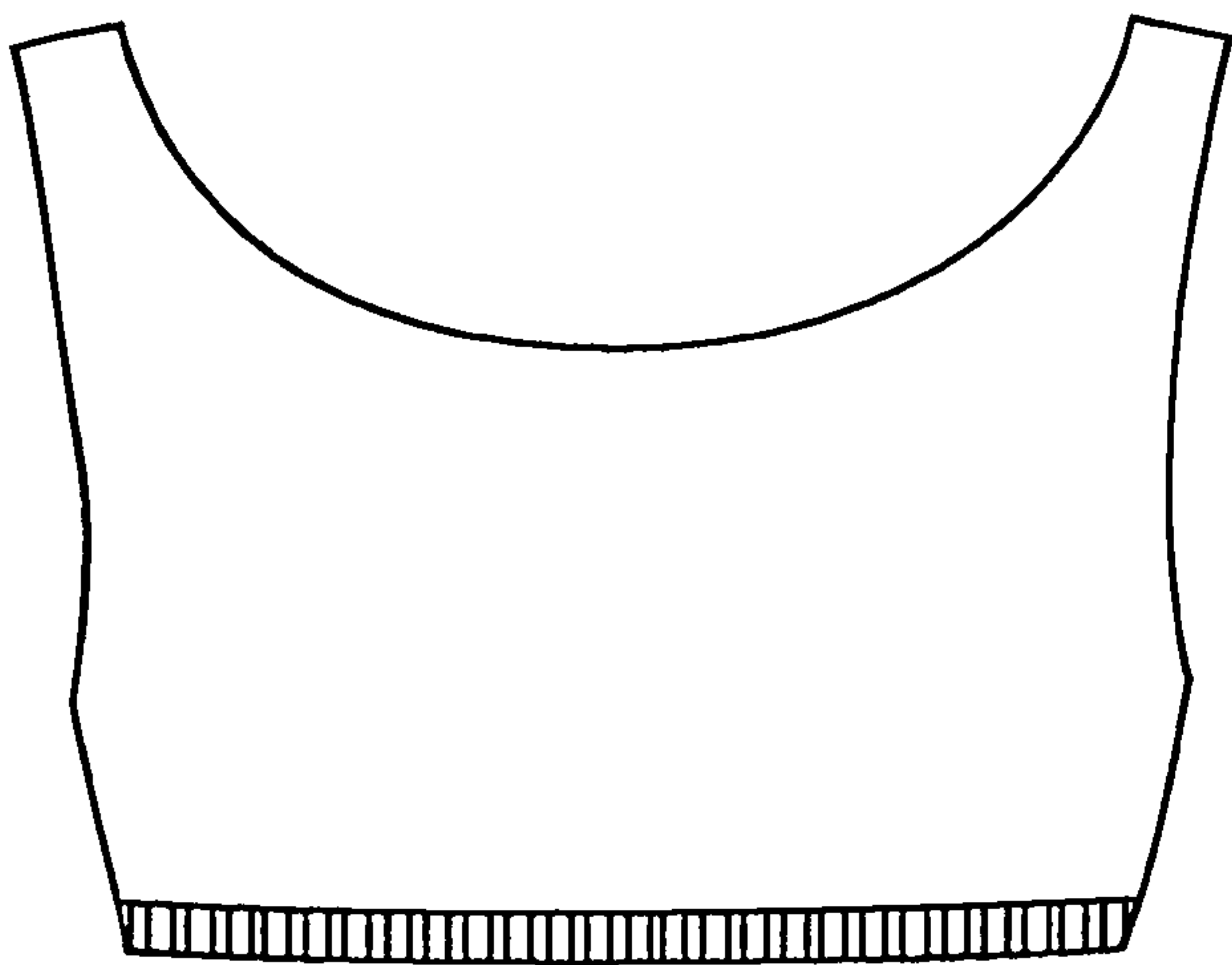

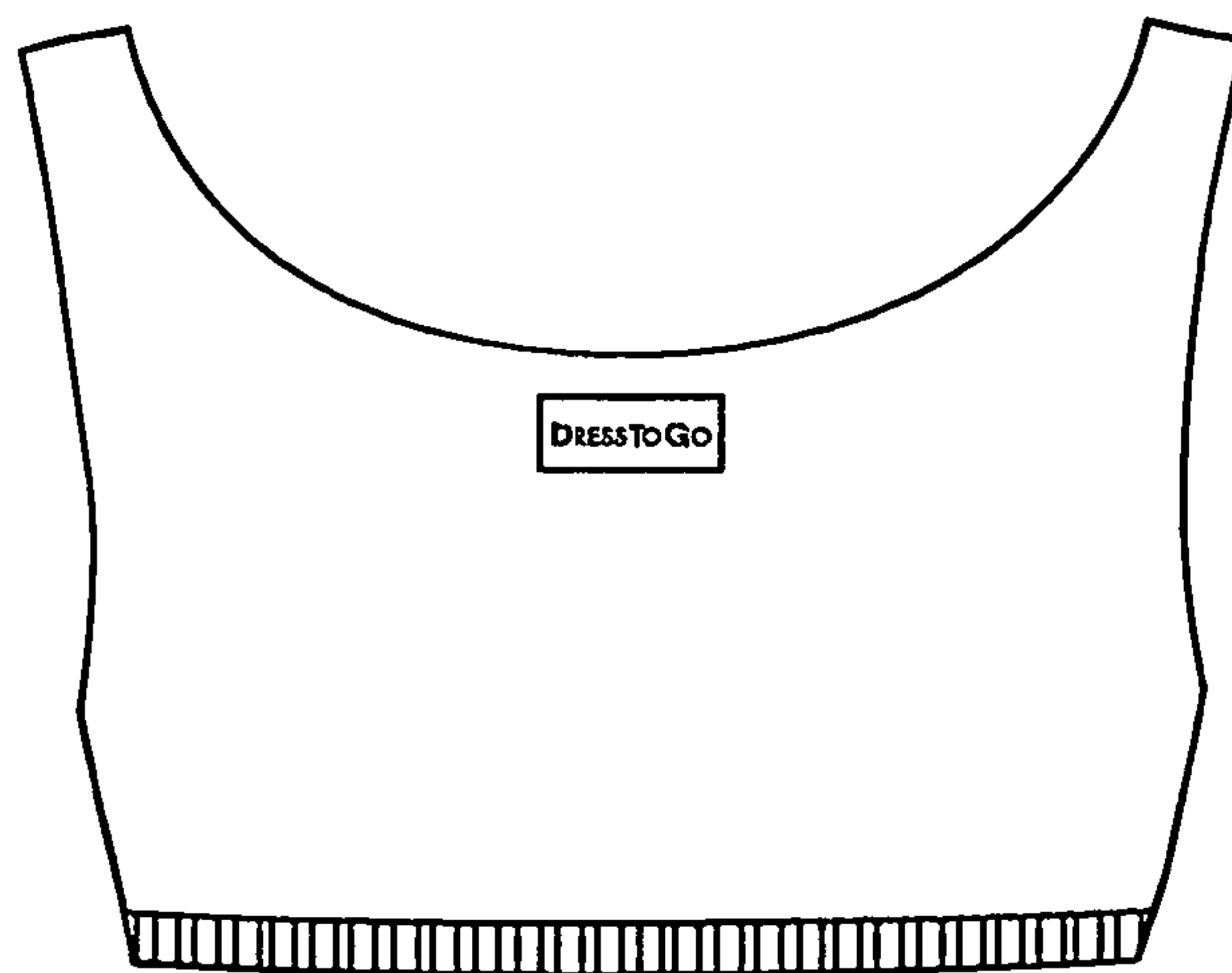
