DESCRIPTION

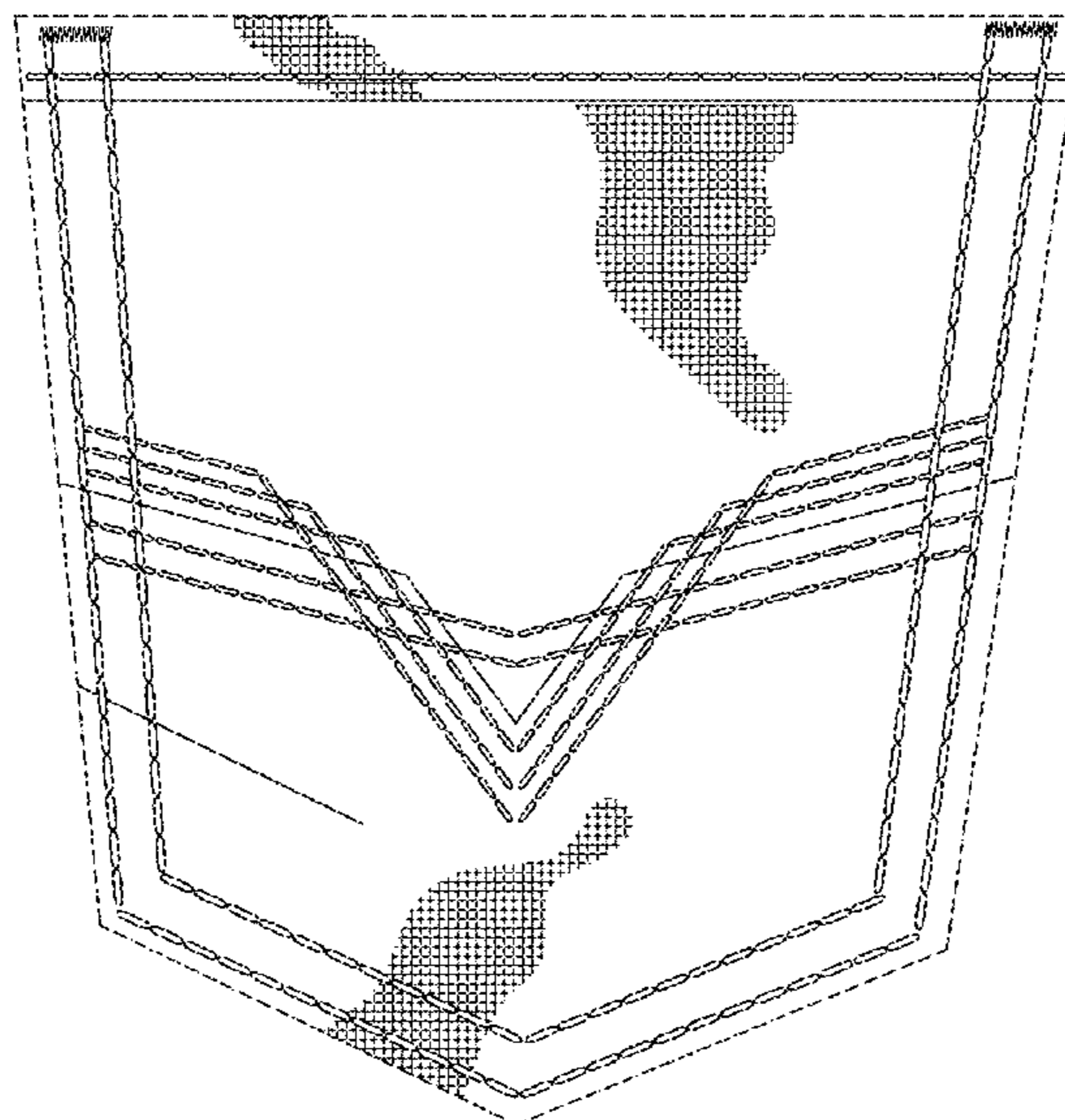
FIG. 1 is front view of a first embodiment of the pocket for jeans and the like showing my design;
FIG. 2 is a front view of a second embodiment of the pocket for jeans and the like showing my design;
FIG. 3 is a front view of a third embodiment of the pocket for jeans and the like showing my design; and,
FIG. 4 is a front view of a fourth embodiment of the pocket for jeans and the like showing my design.
The present design relates to a design of a pocket for jeans and the like. The designs shown in the first and second embodiments are mirror images of one another. In addition, the designs shown in the third and fourth embodiments are mirror images of one another. The outer periphery of the pocket shown in broken lines forms no part of the claimed design.

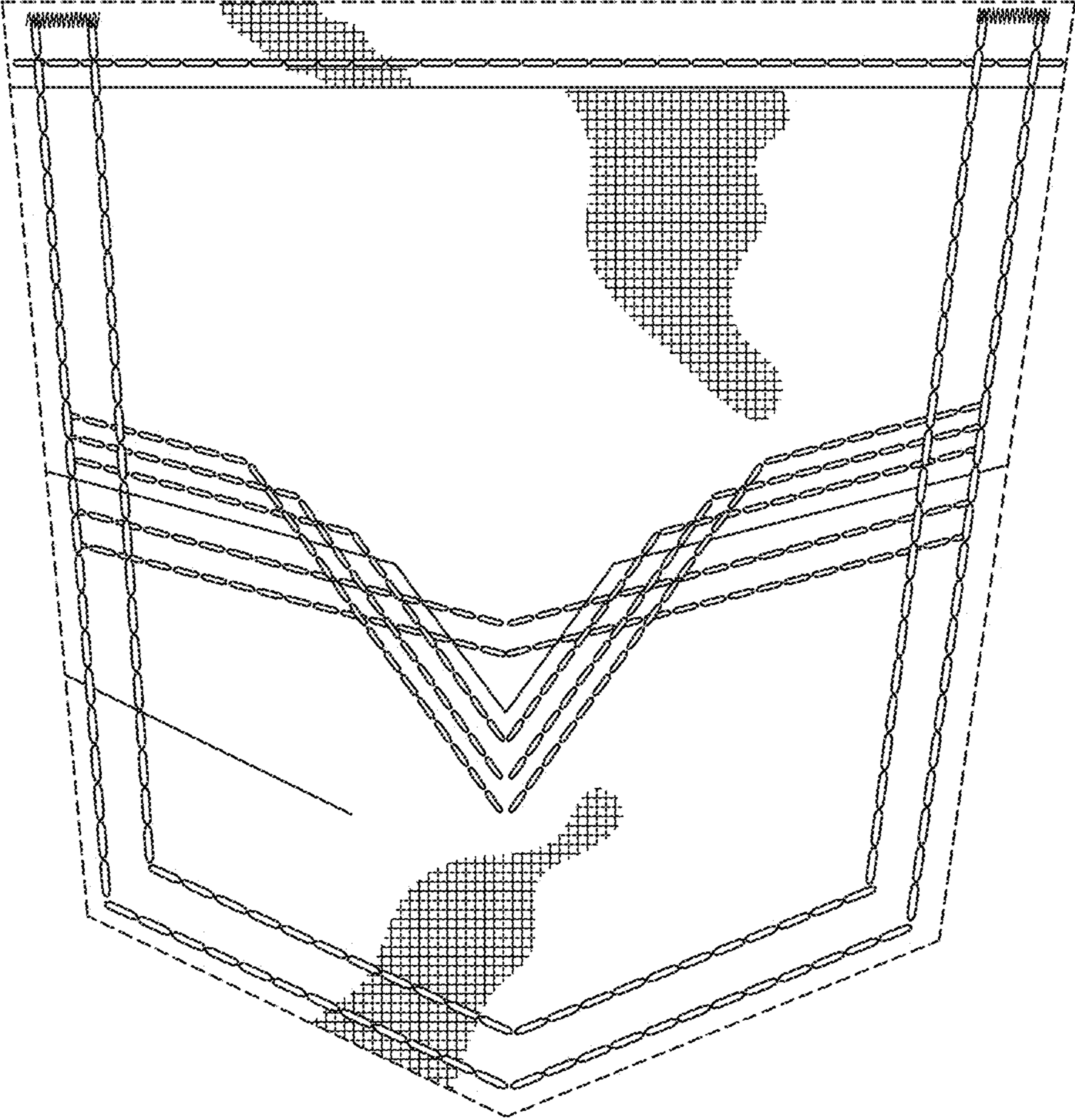

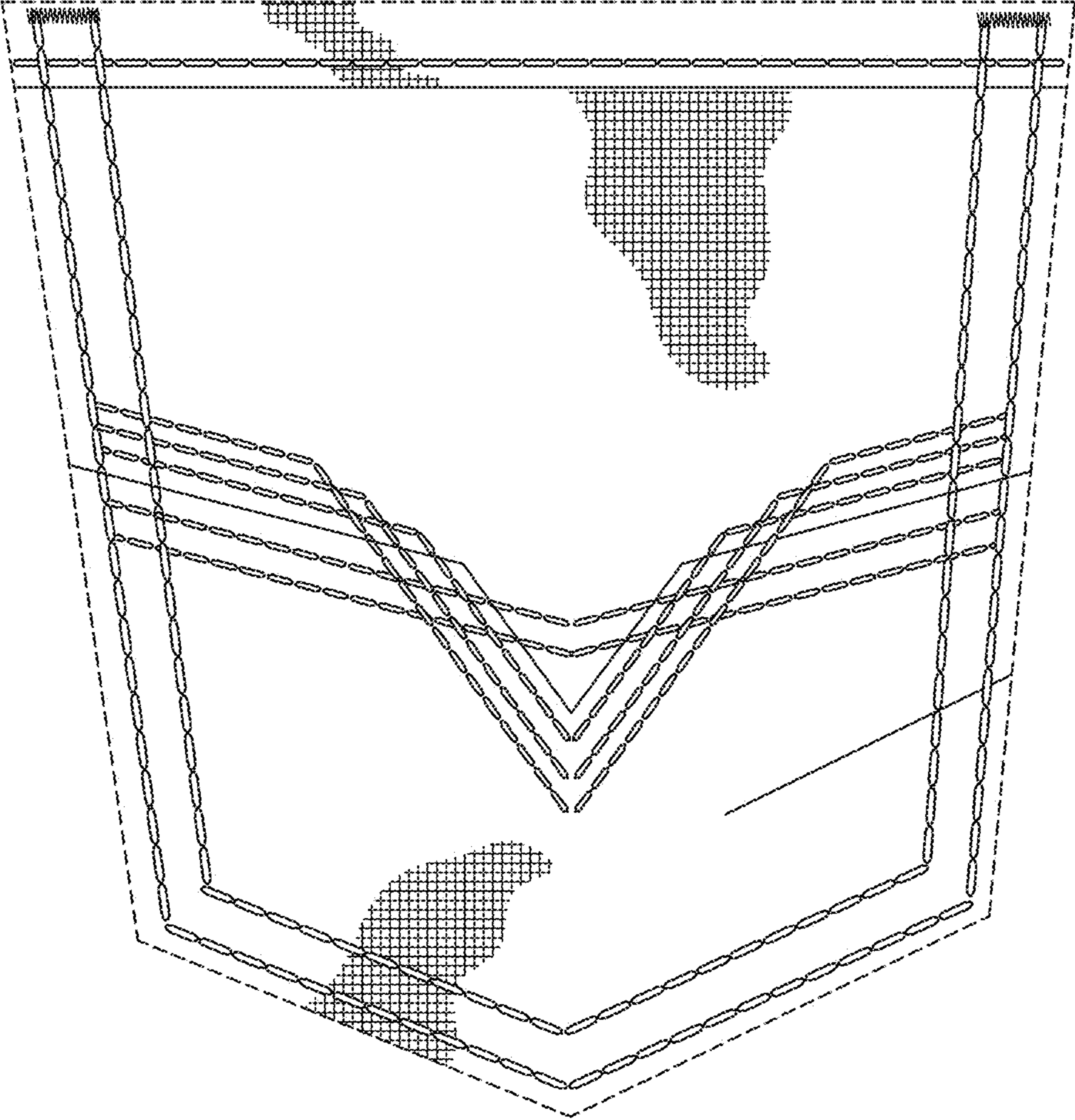

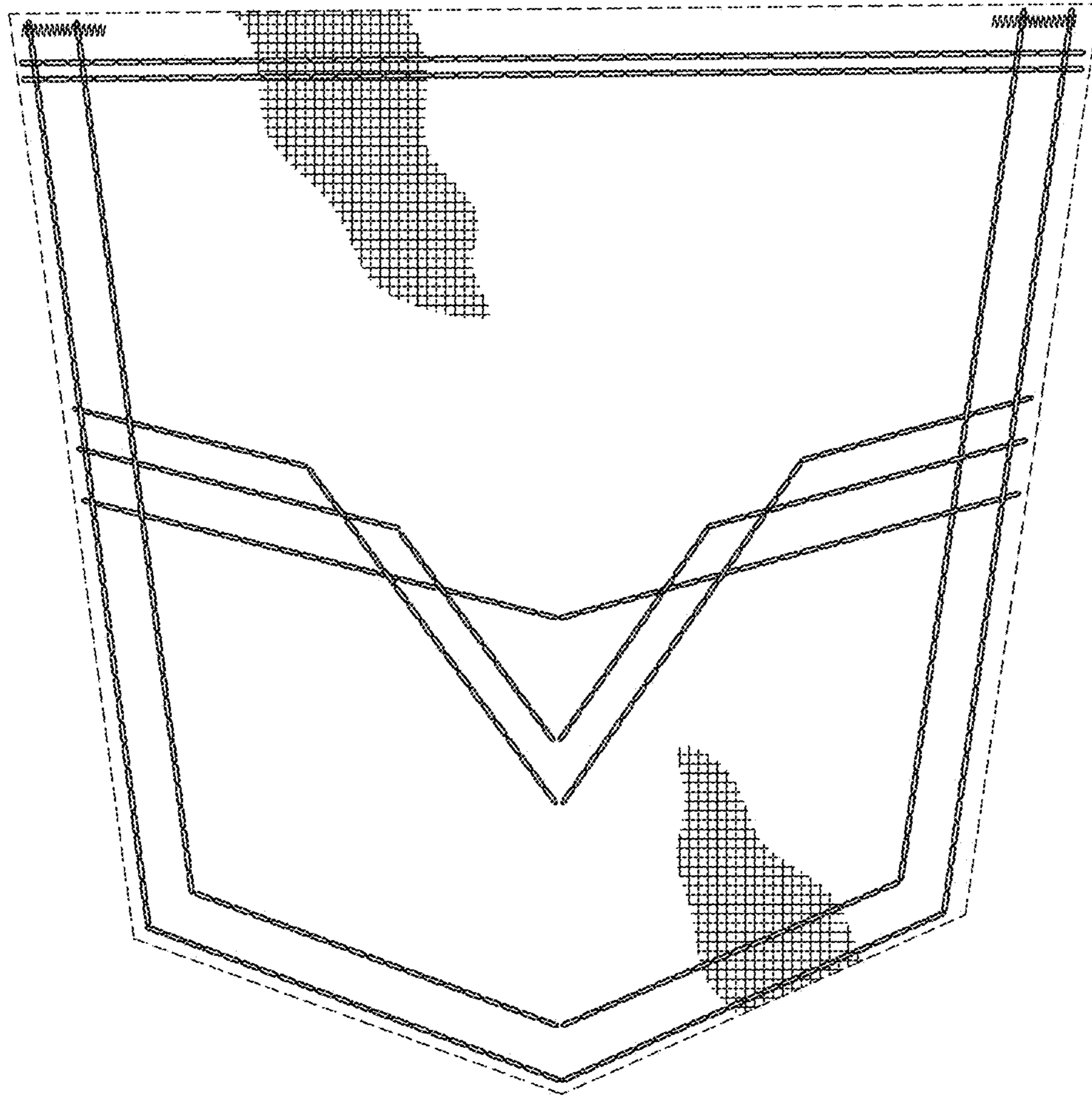

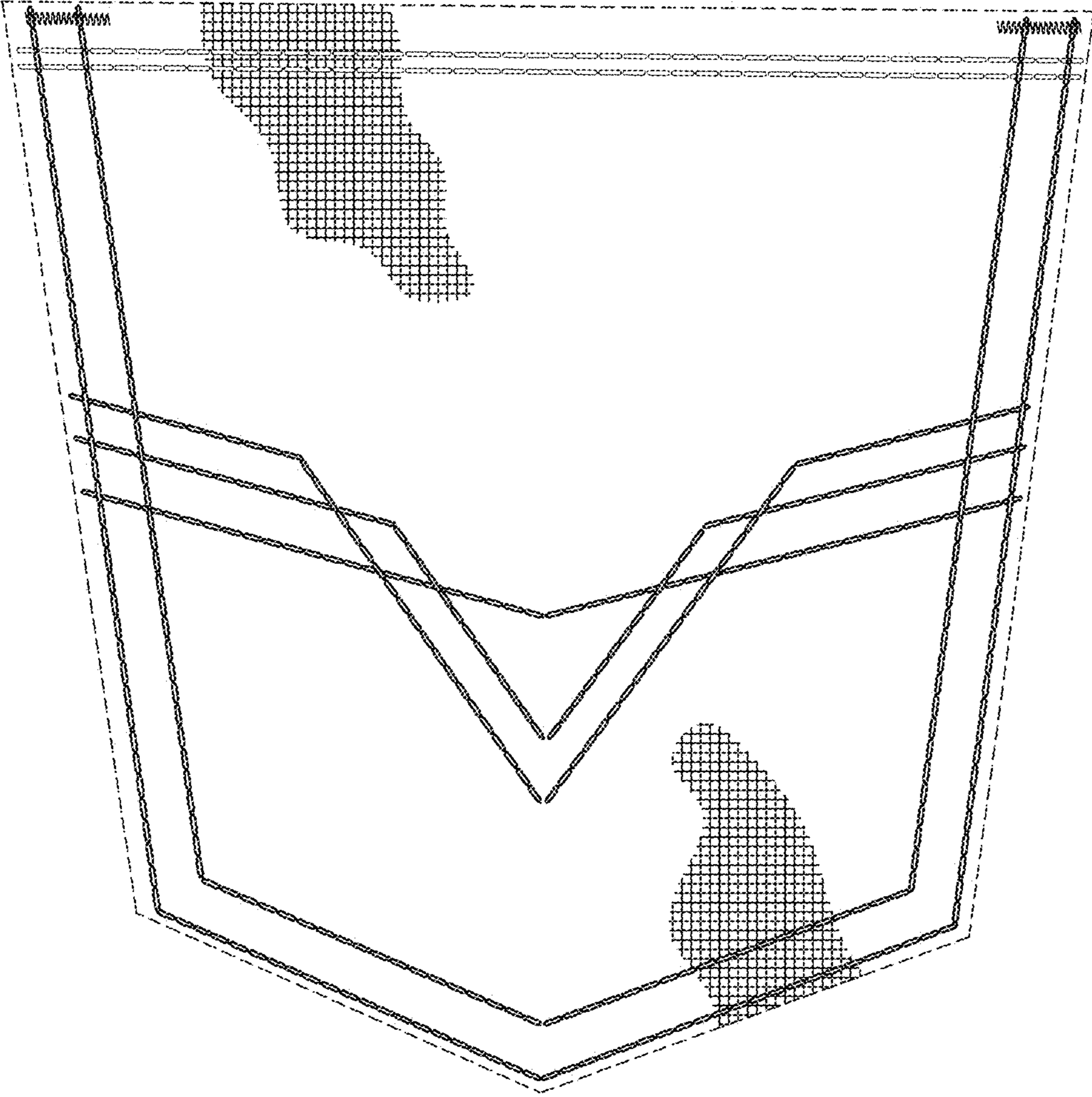
