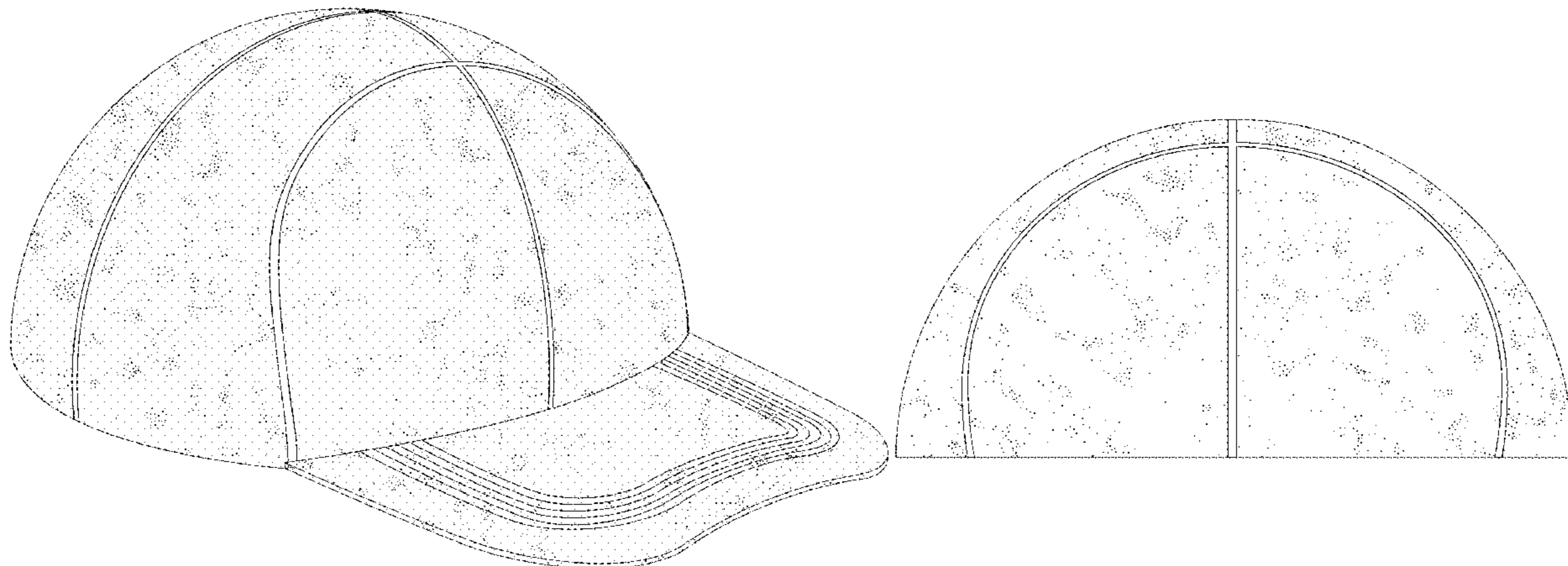
The ornamental design for a cap, as shown and described.

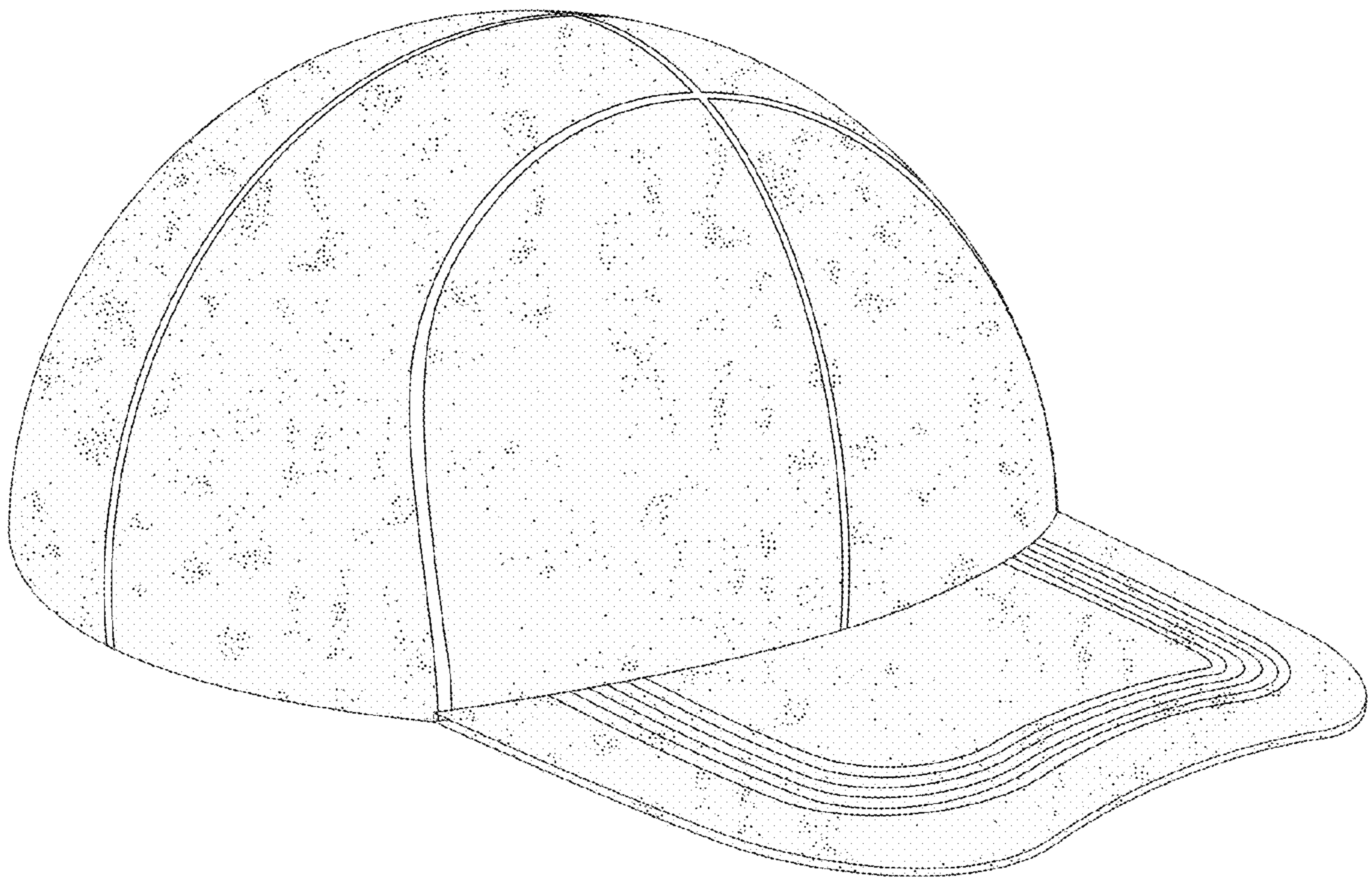

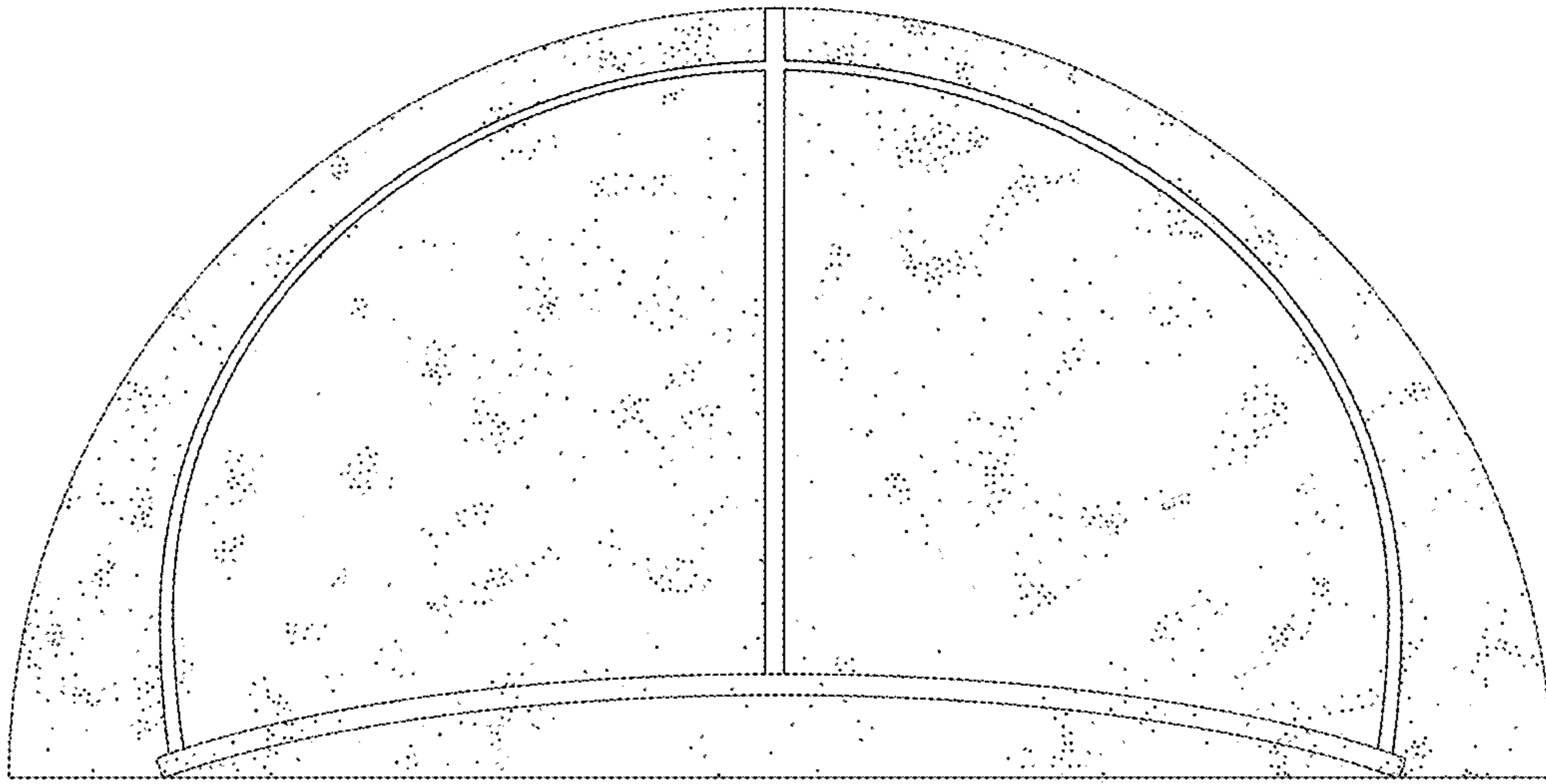

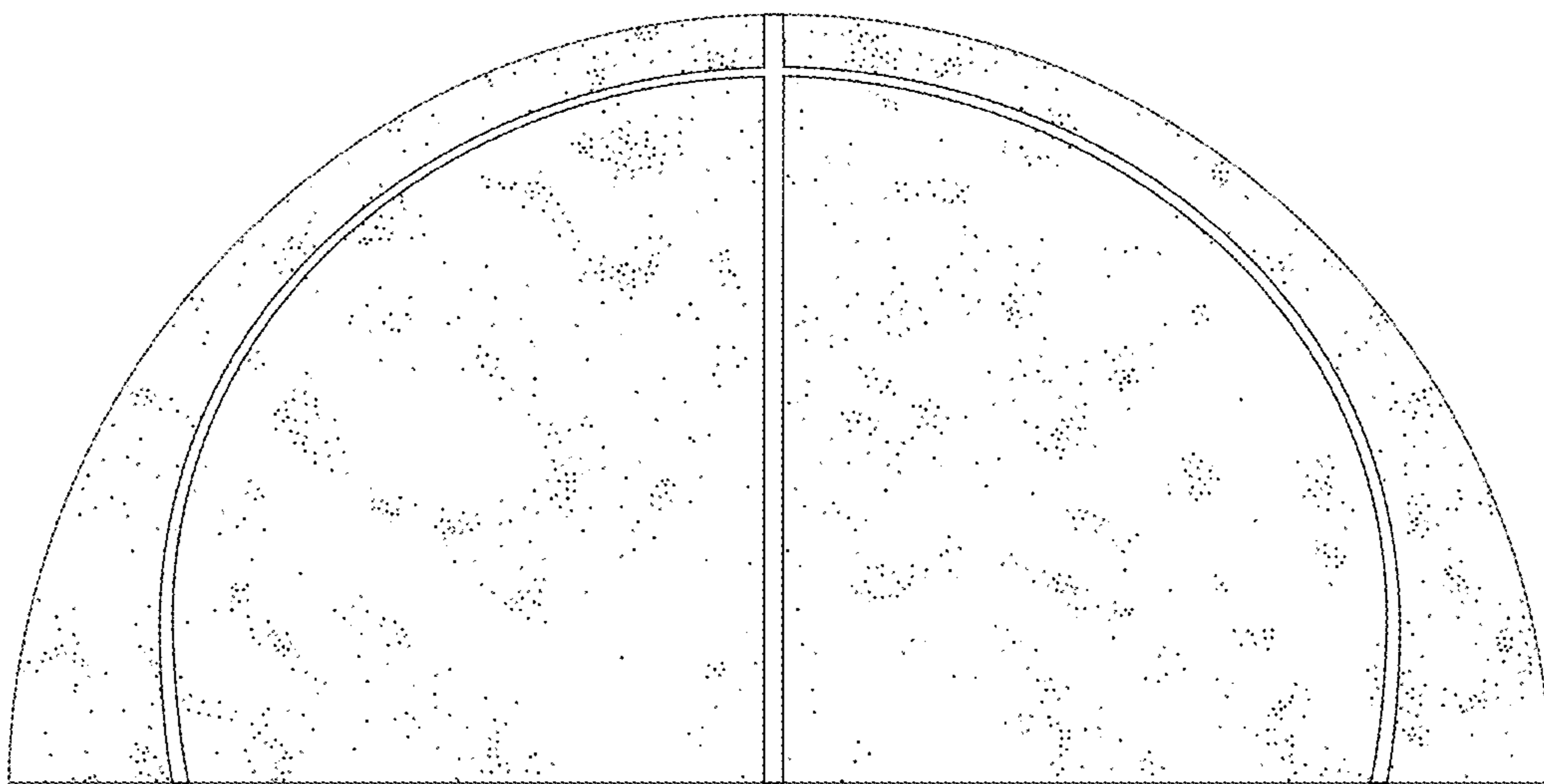

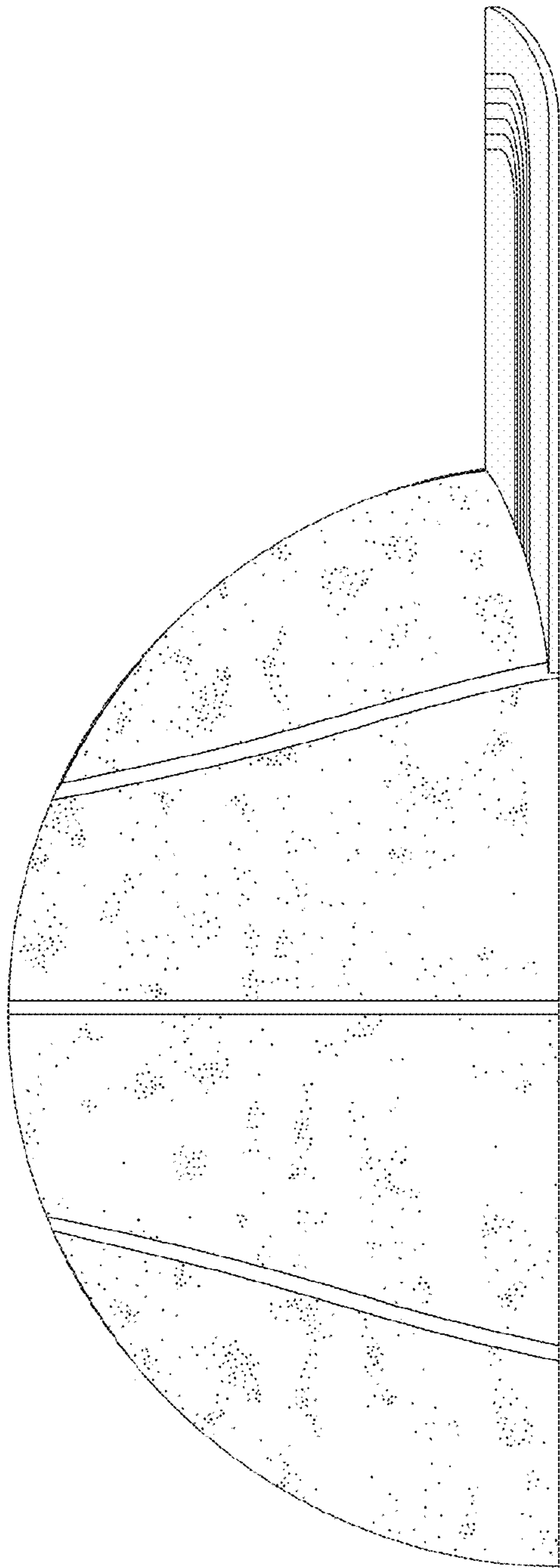

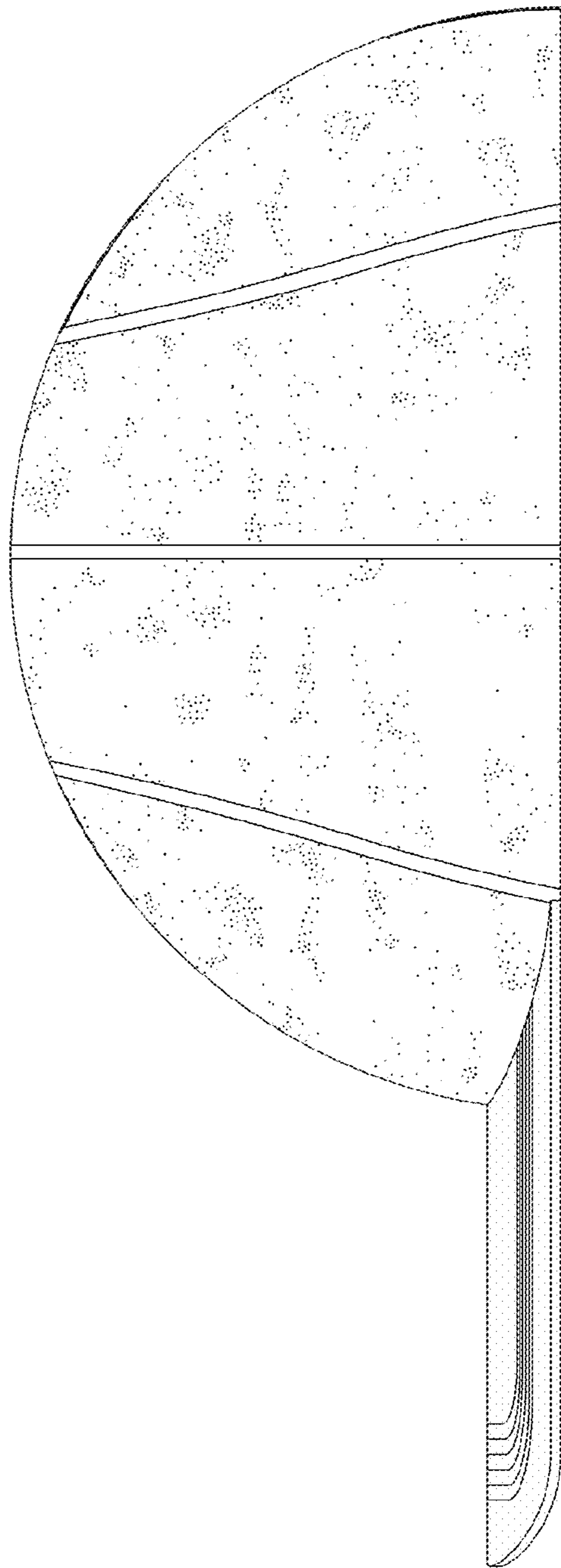

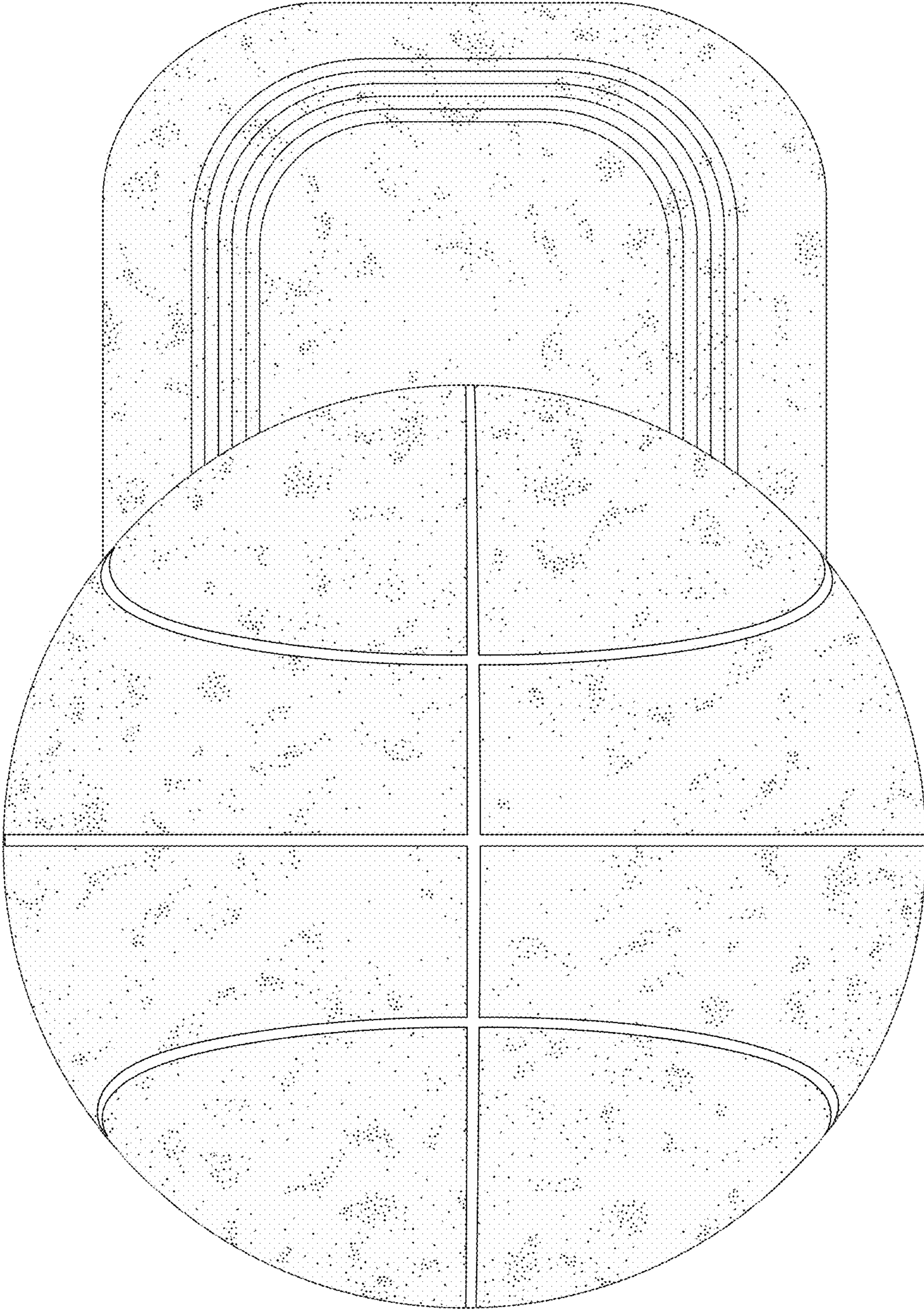

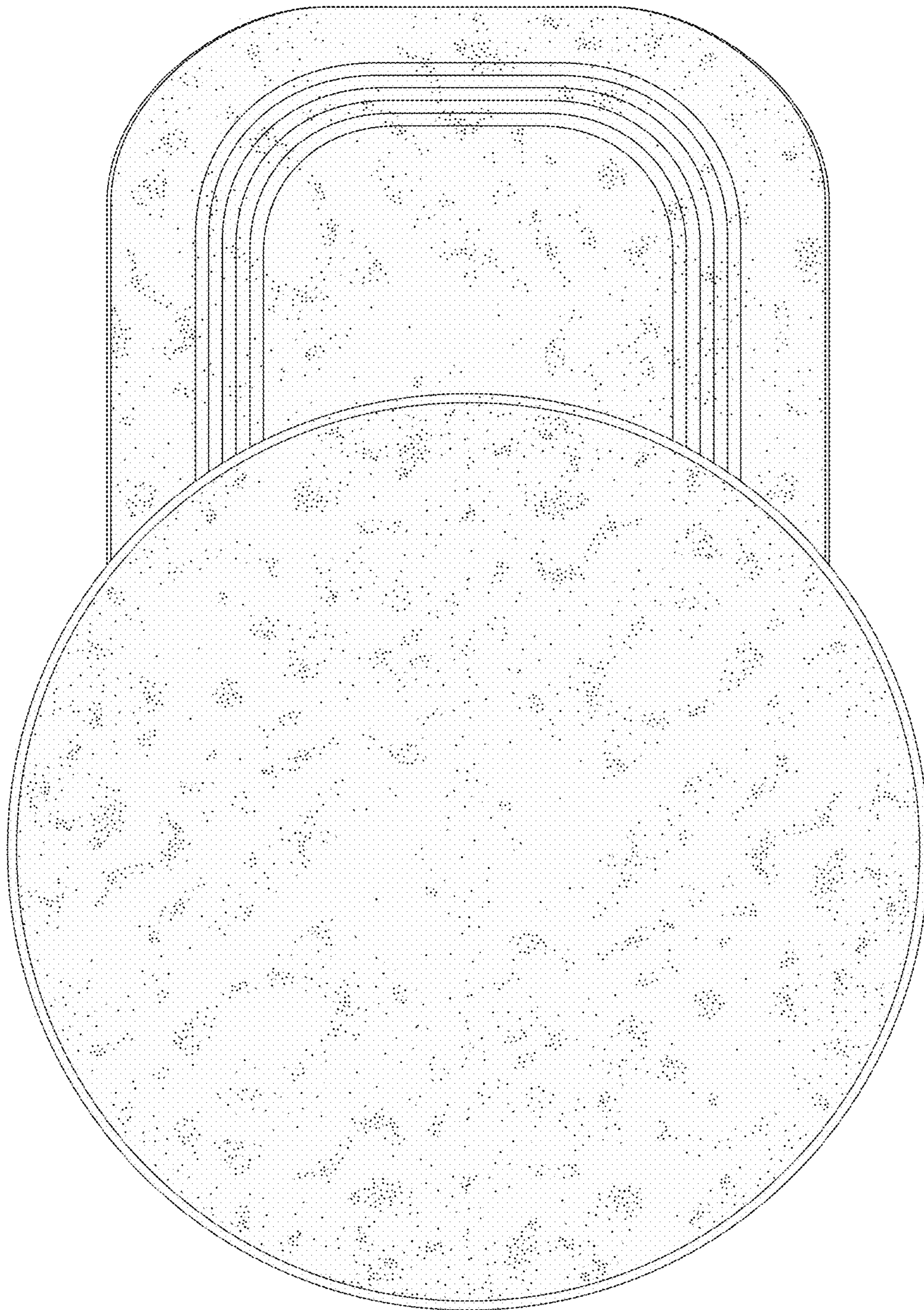
