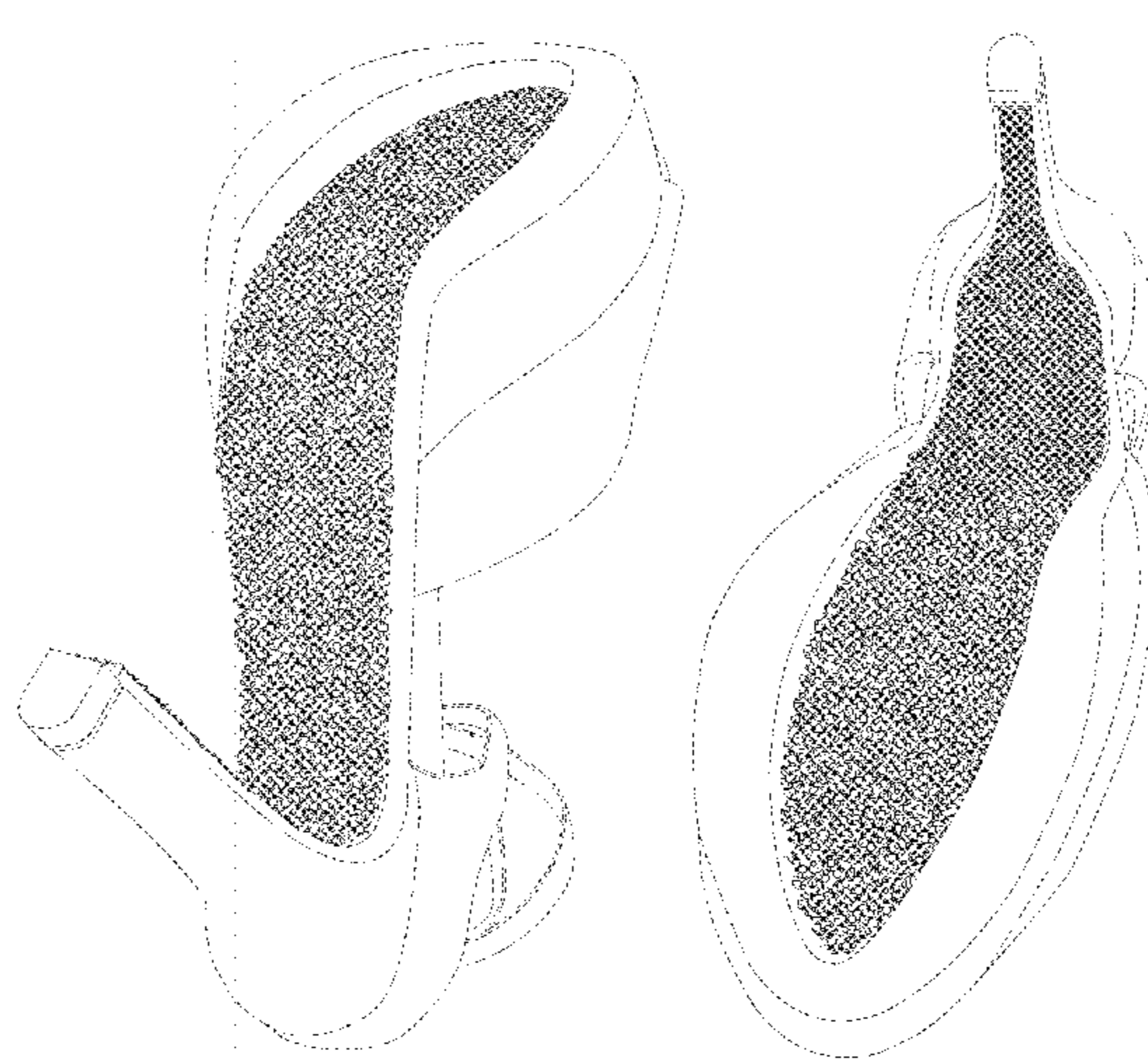

The ornamental design for a shoe sole with rock crystal design, as shown and described.

DESCRIPTION

FIG. 1 is a bottom perspective view of a shoe sole with rock crystal design, in accordance with my new design;

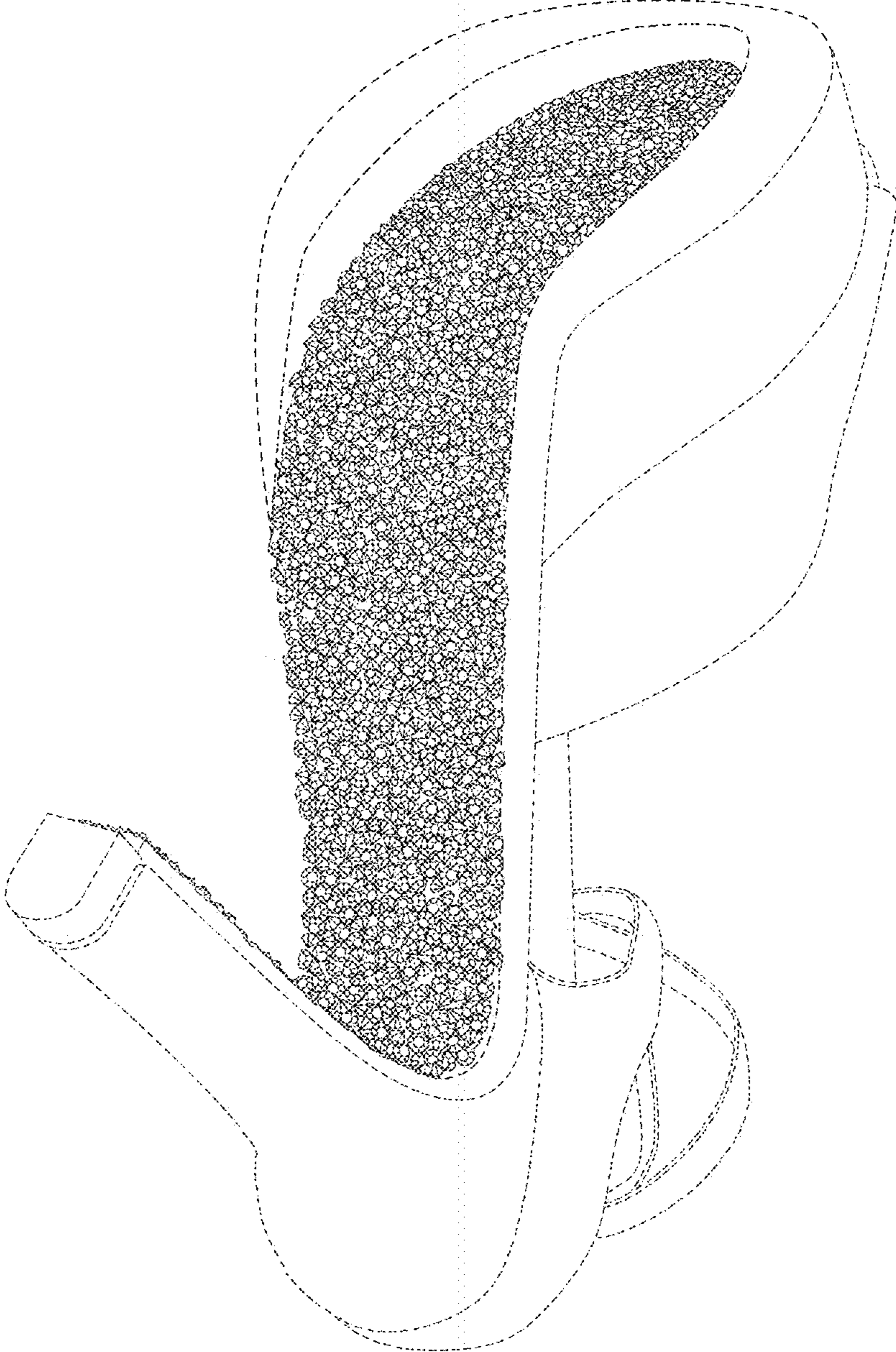

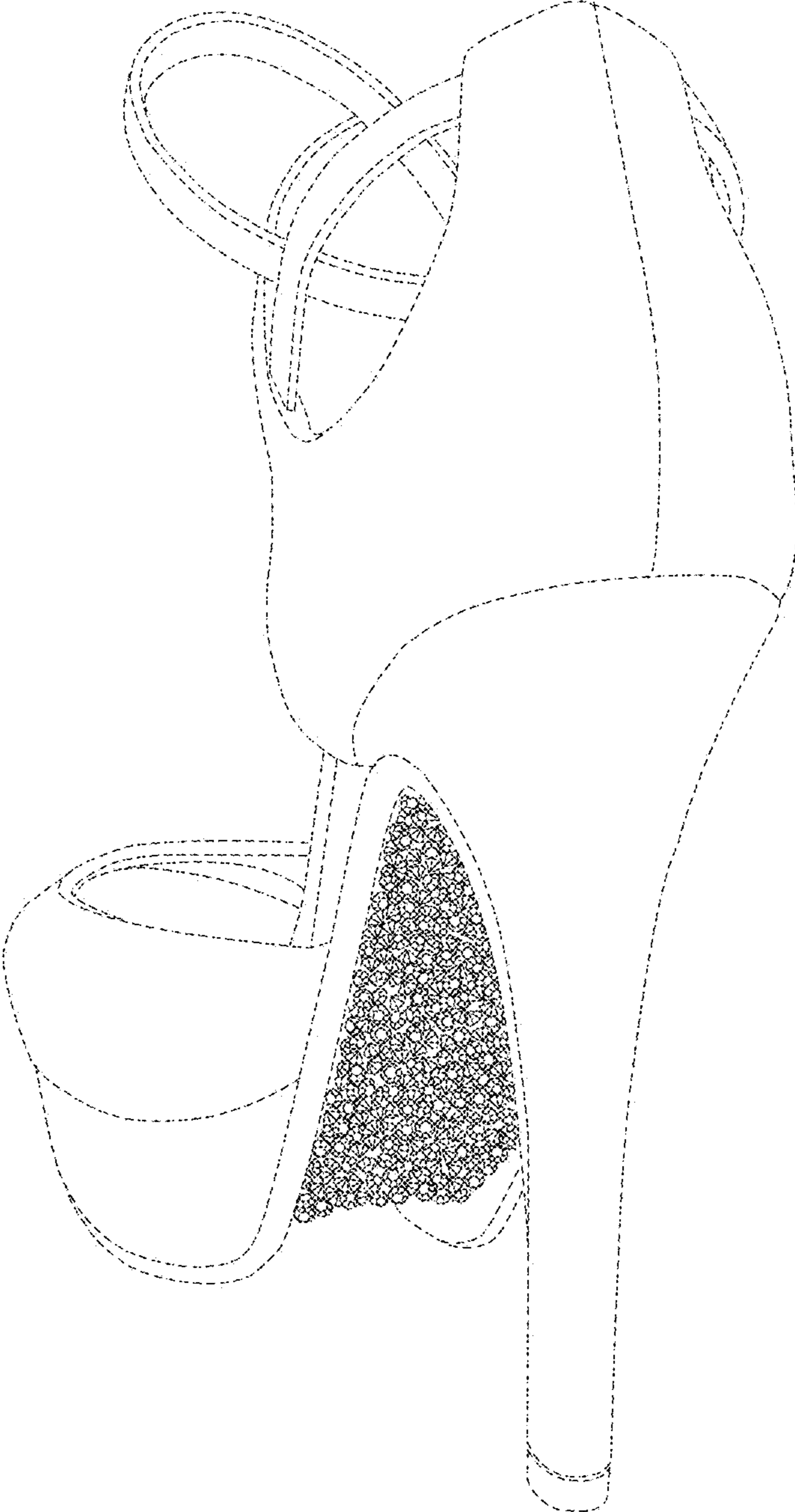

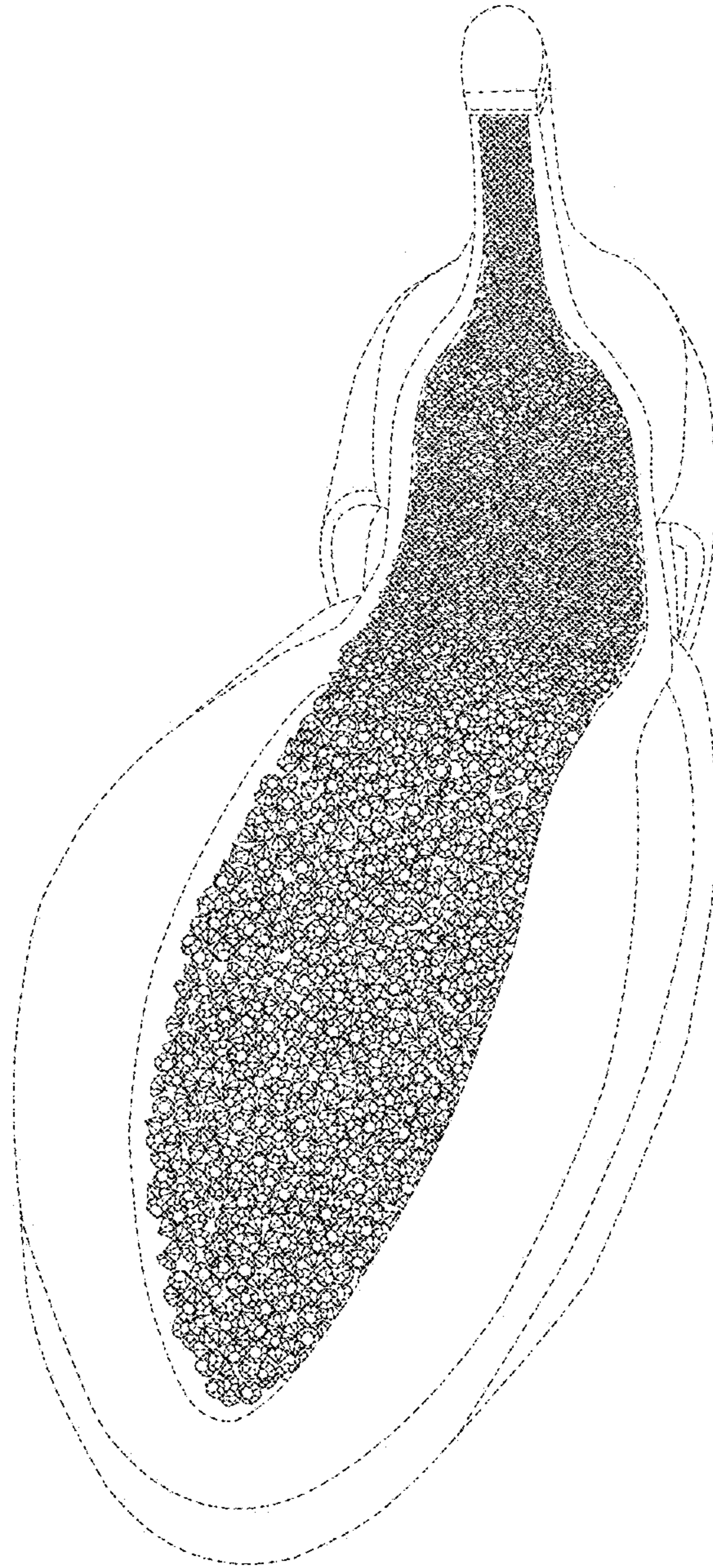

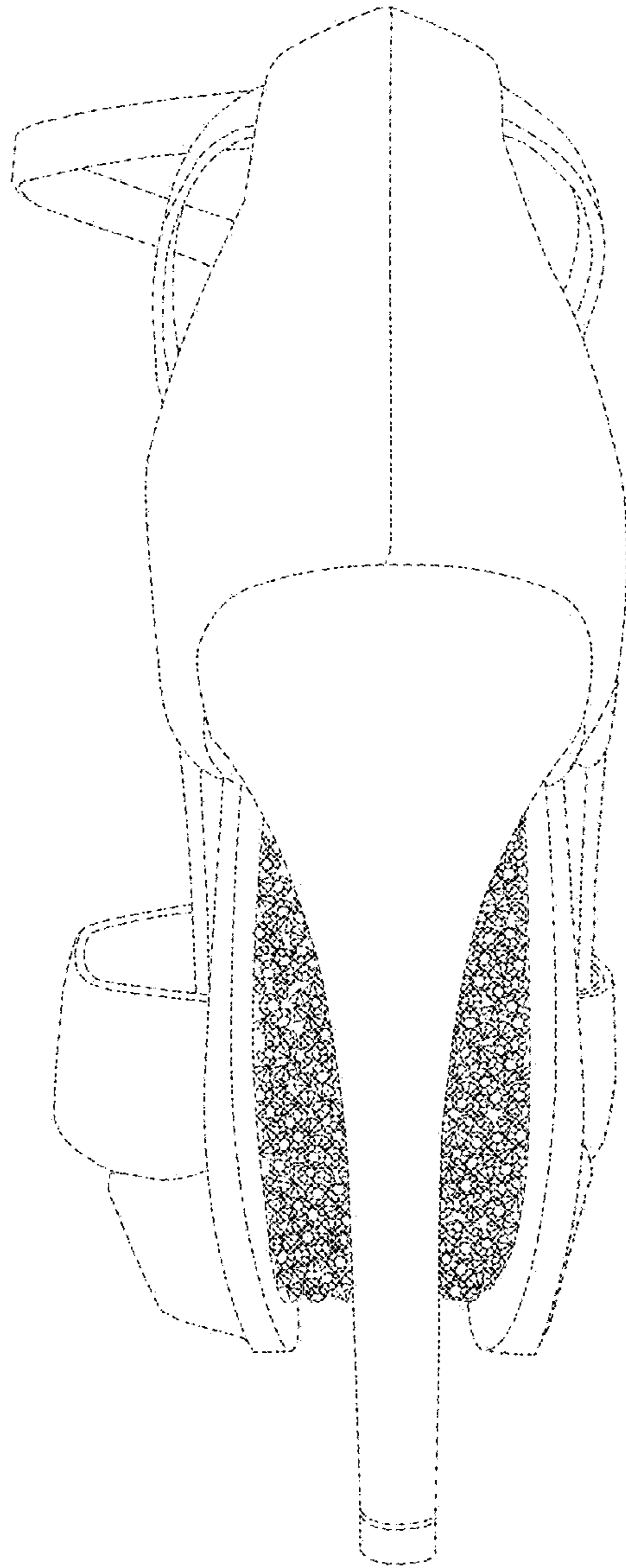

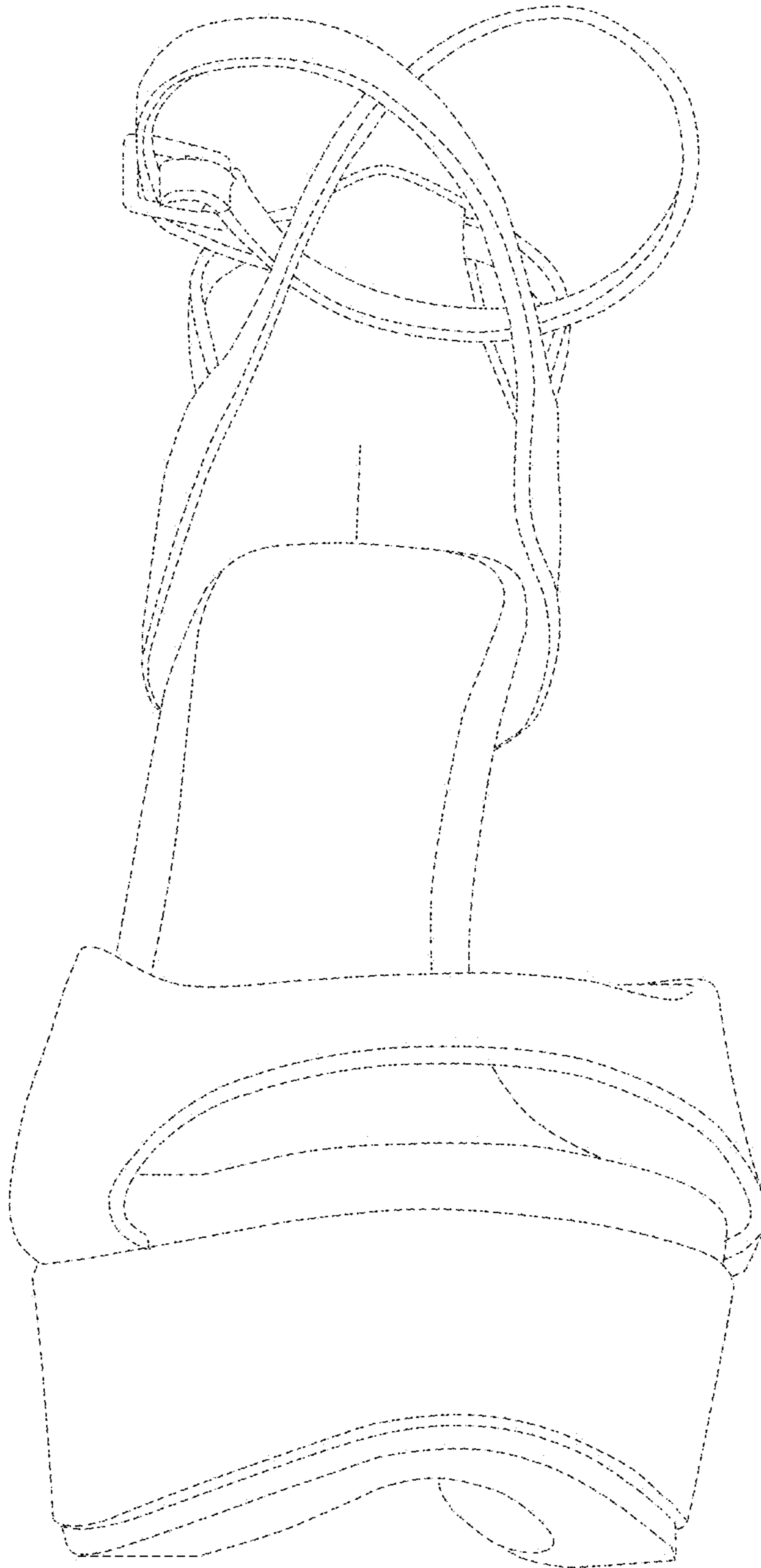

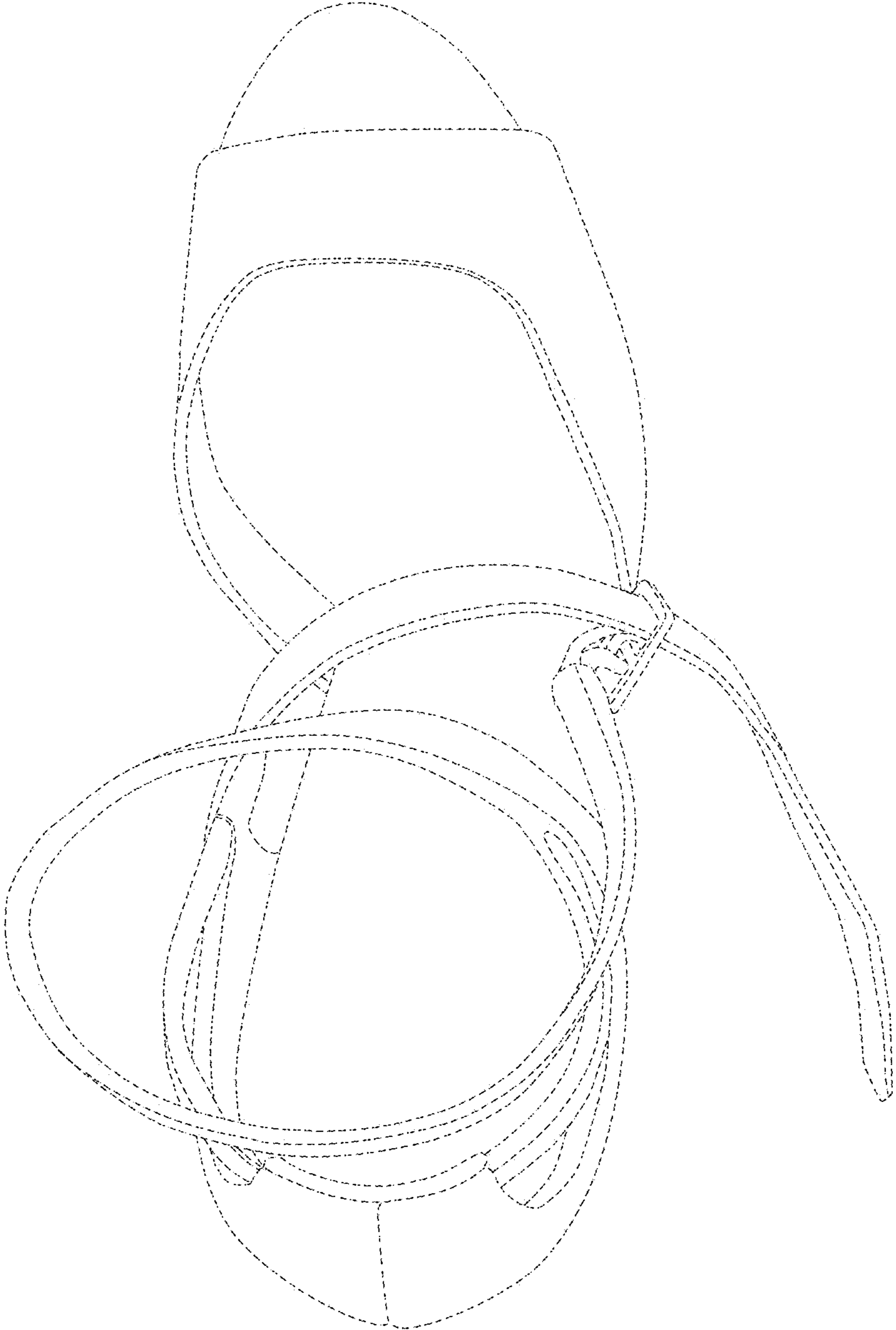
