**DESCRIPTION**

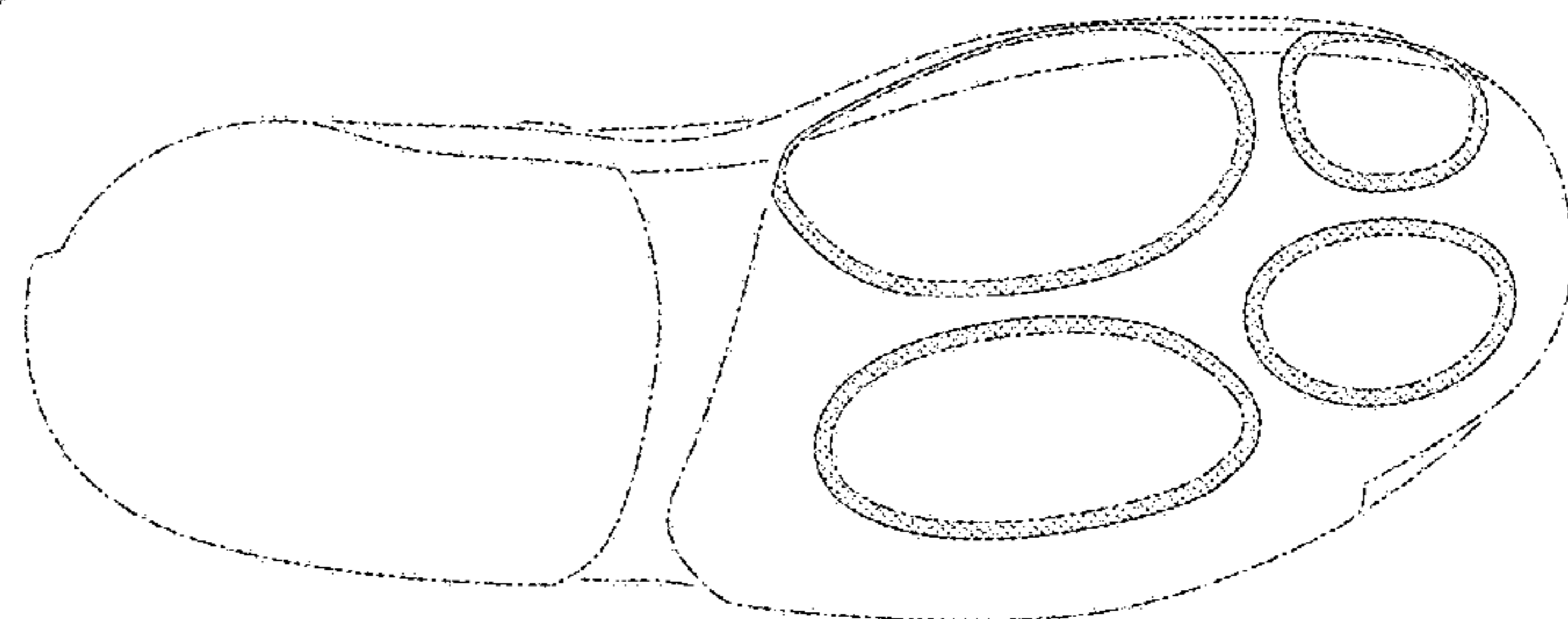
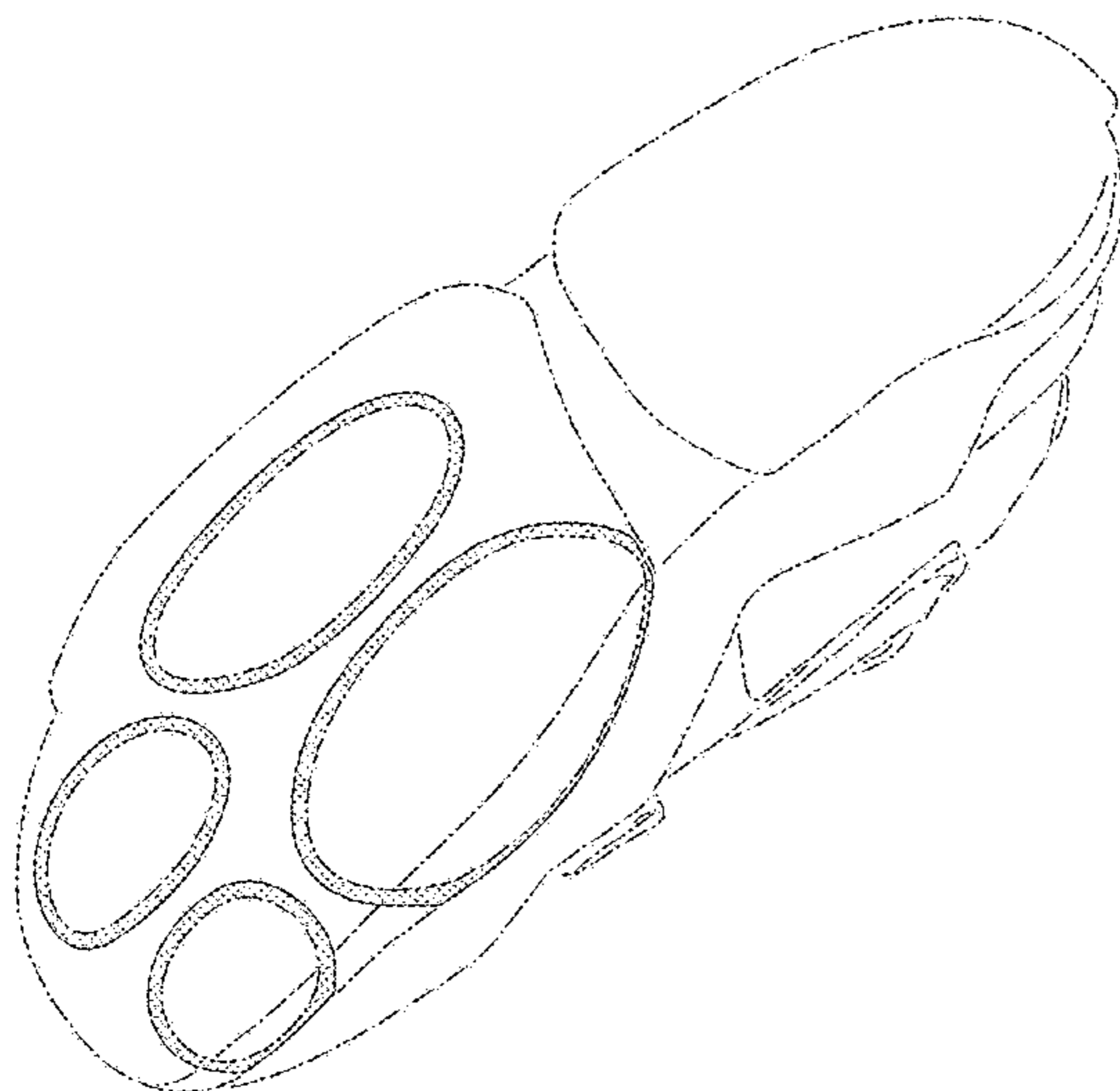
FIG. 1 is a bottom front perspective view of a shoe showing our new design;

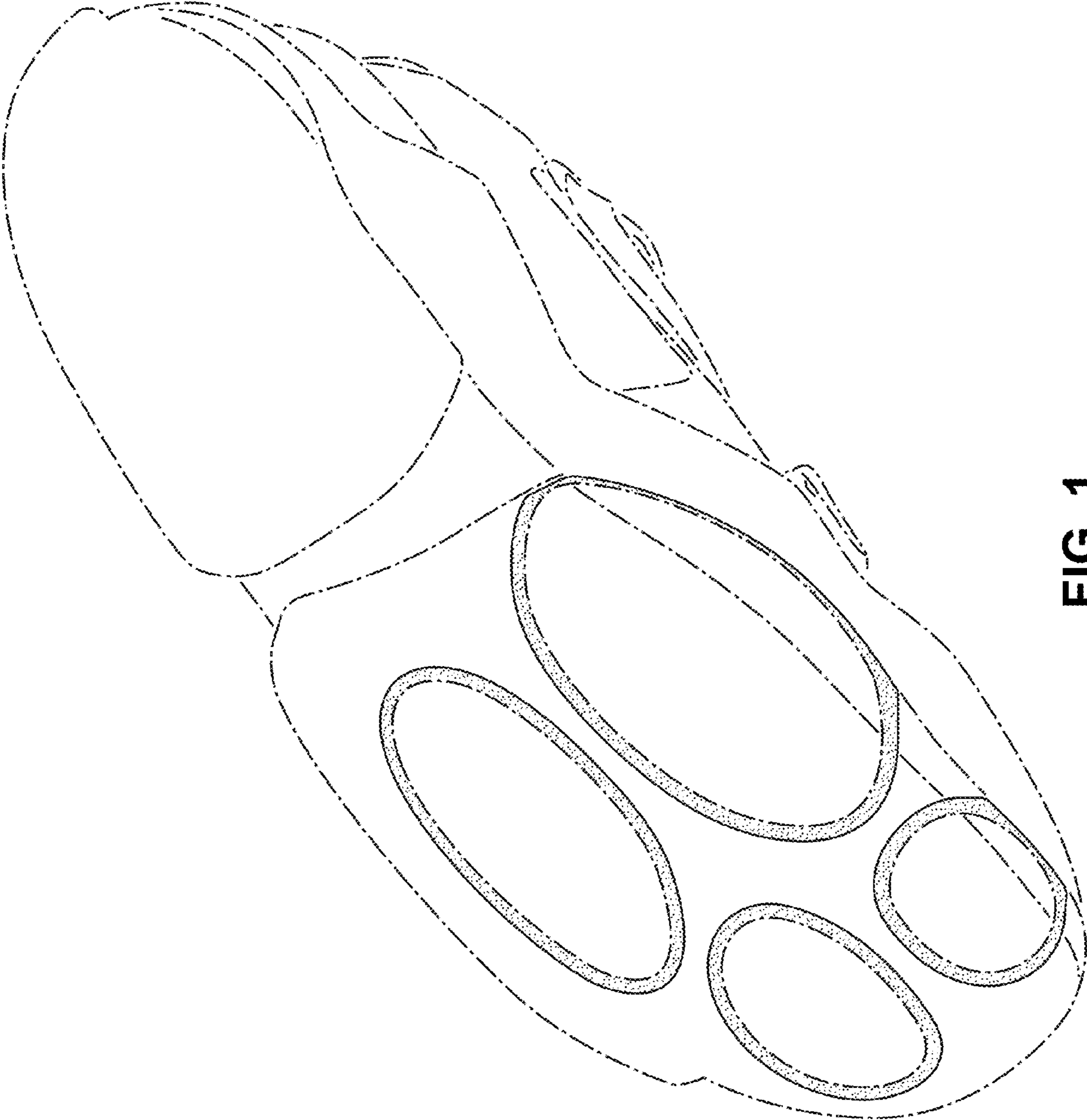

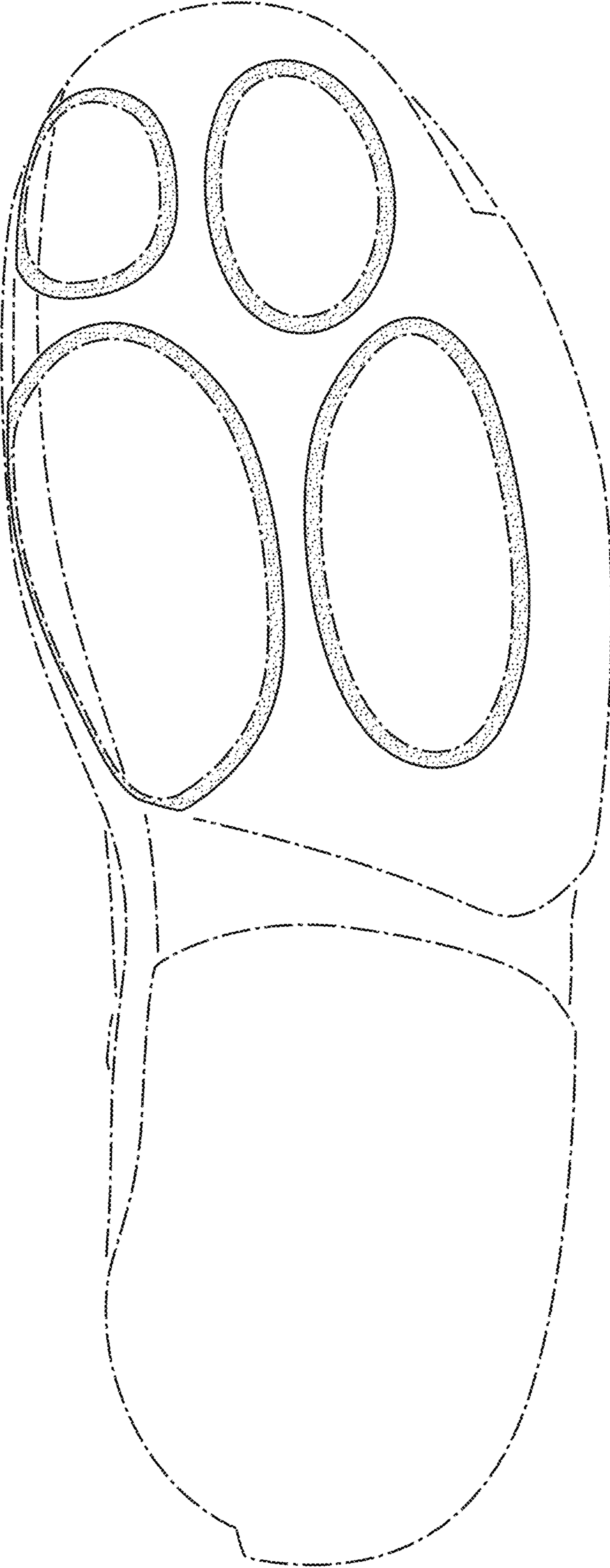

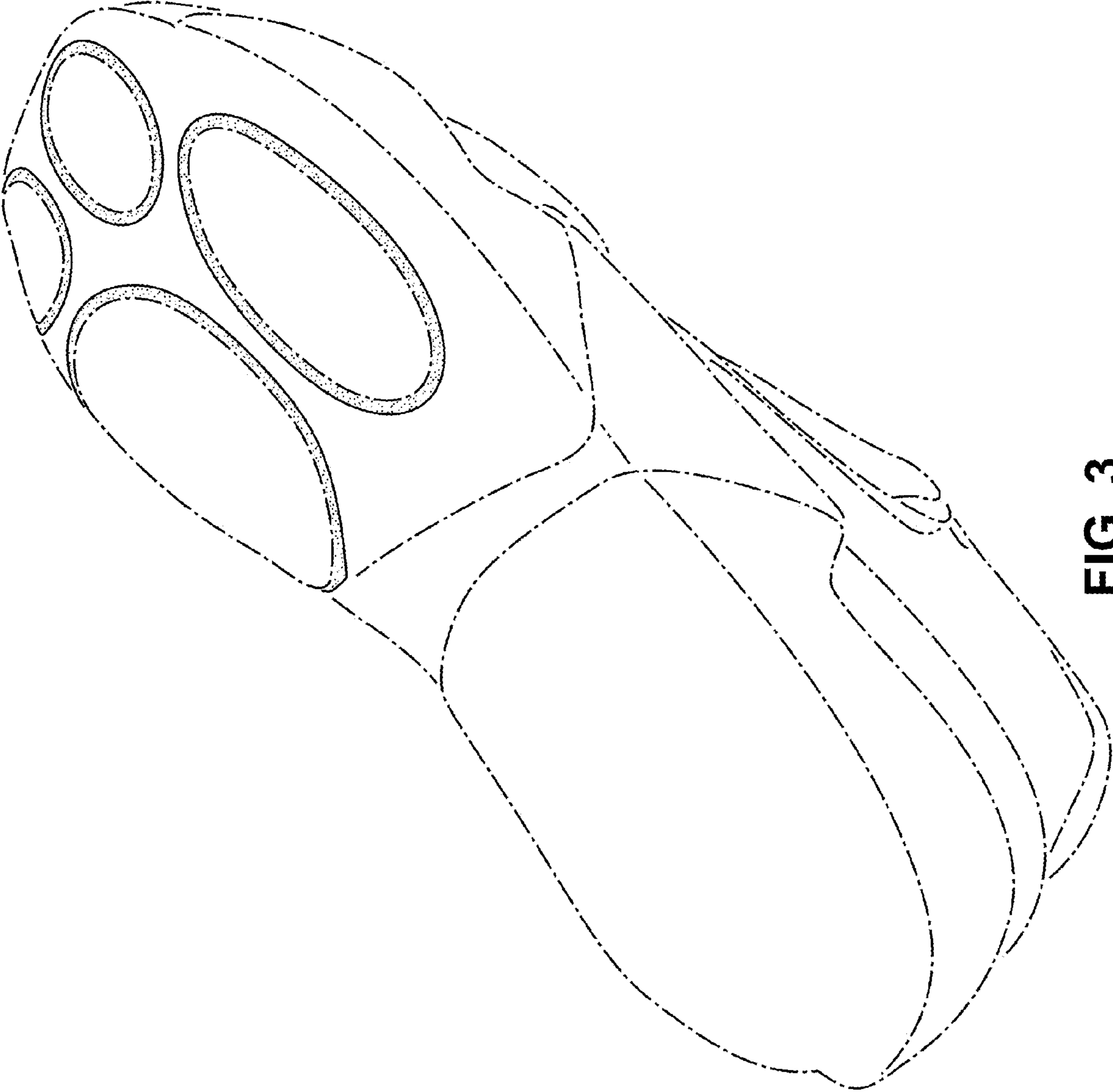
