DESCRIPTION

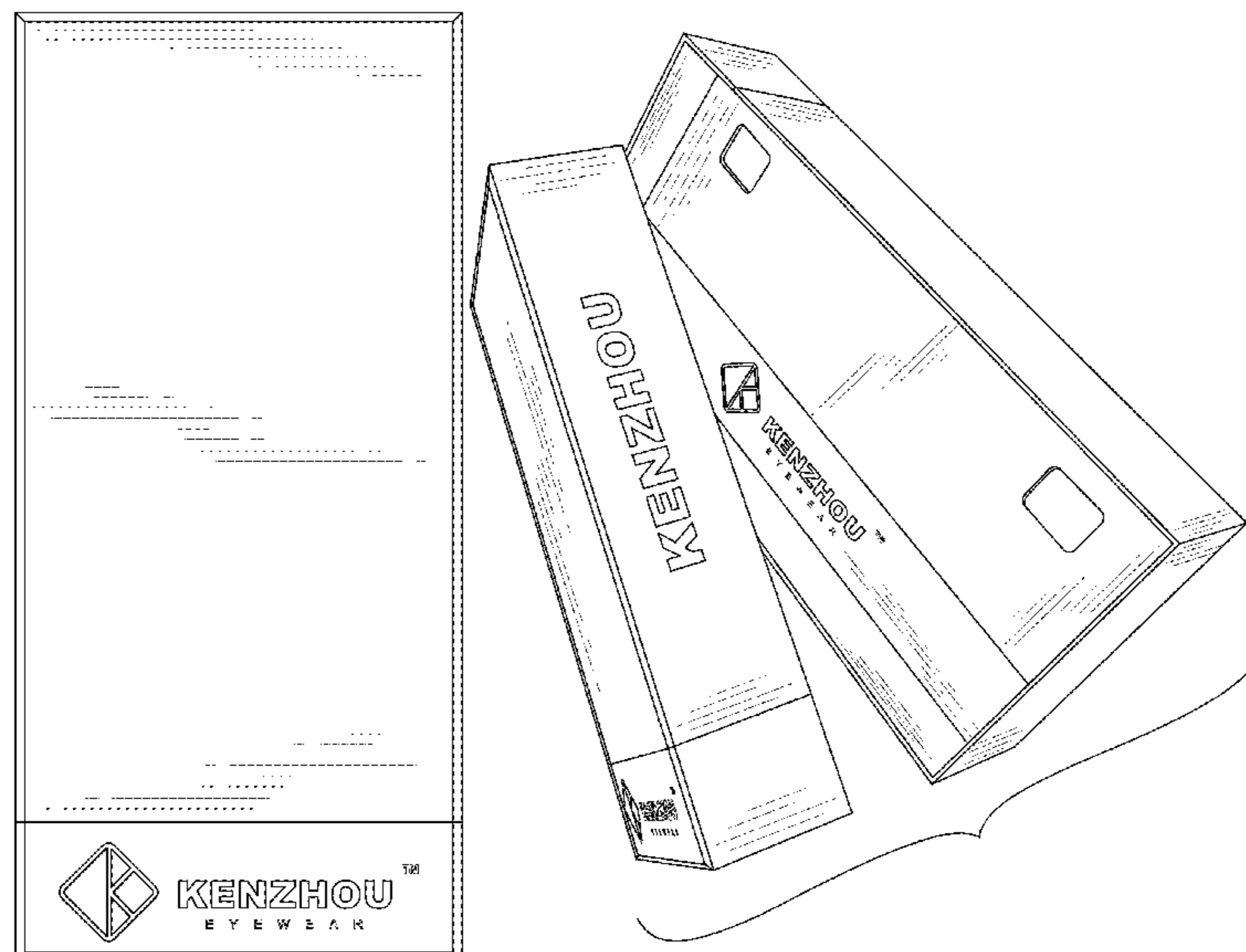
FIG. 1 is a perspective view of a package for glasses showing my new design;

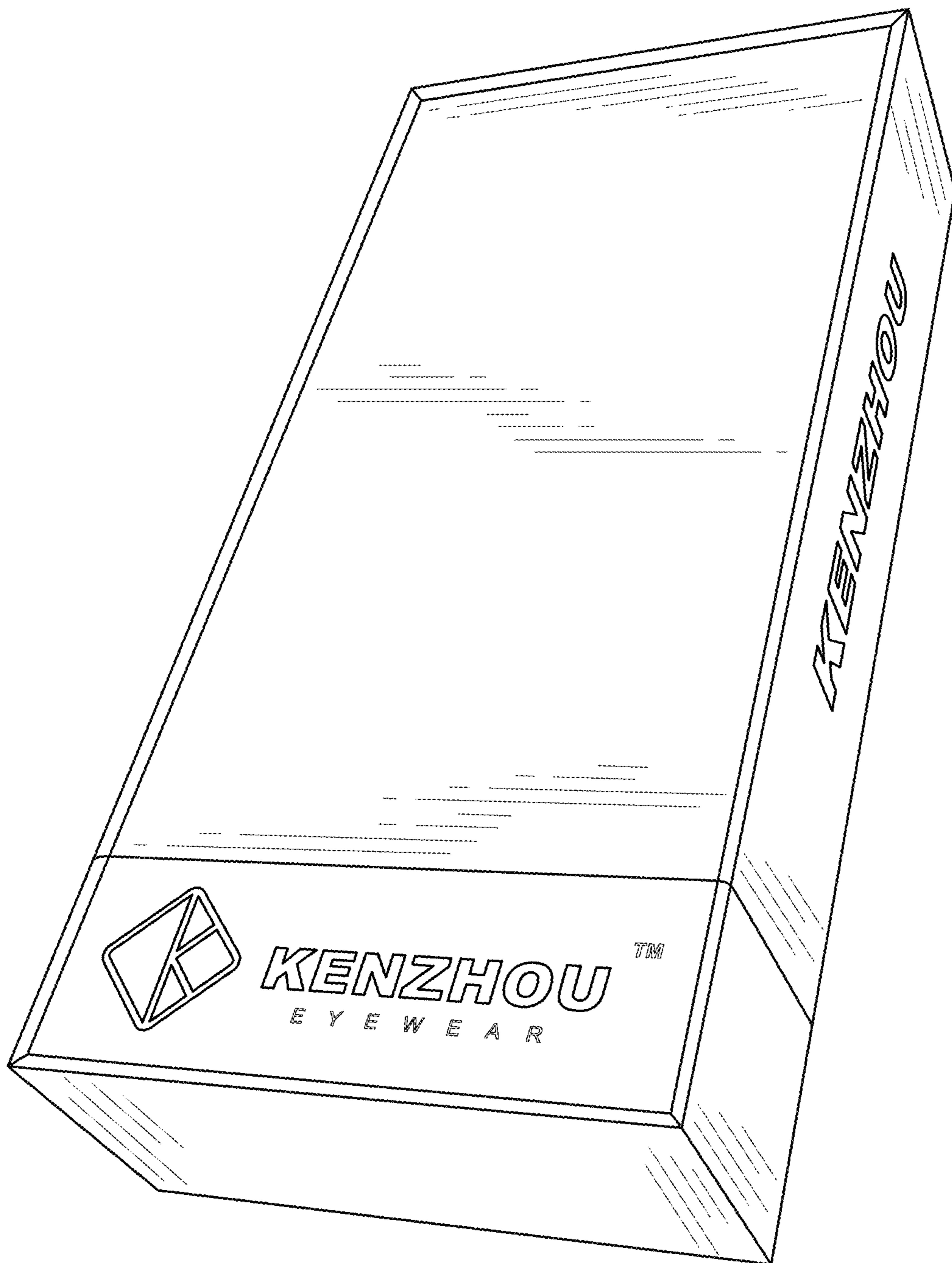

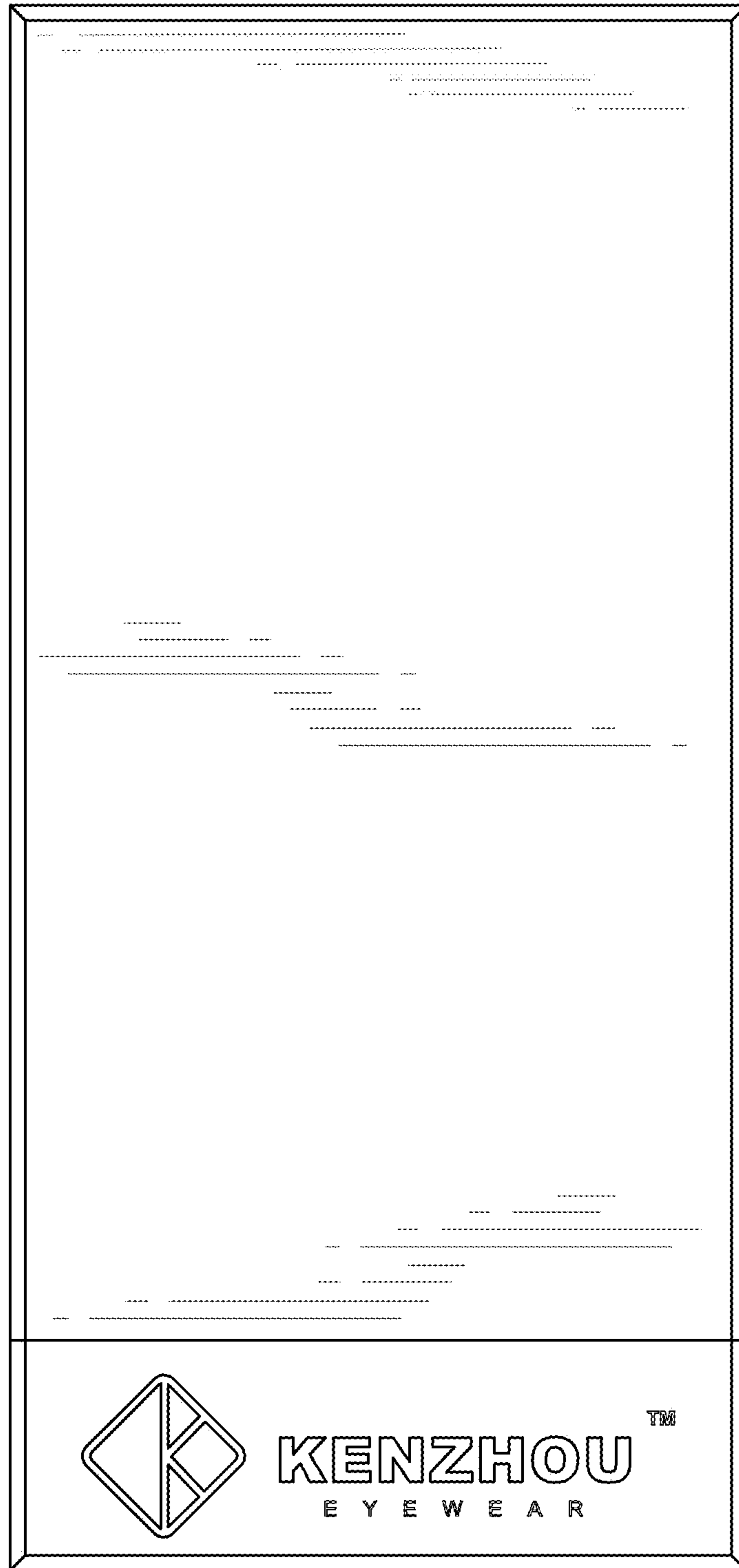

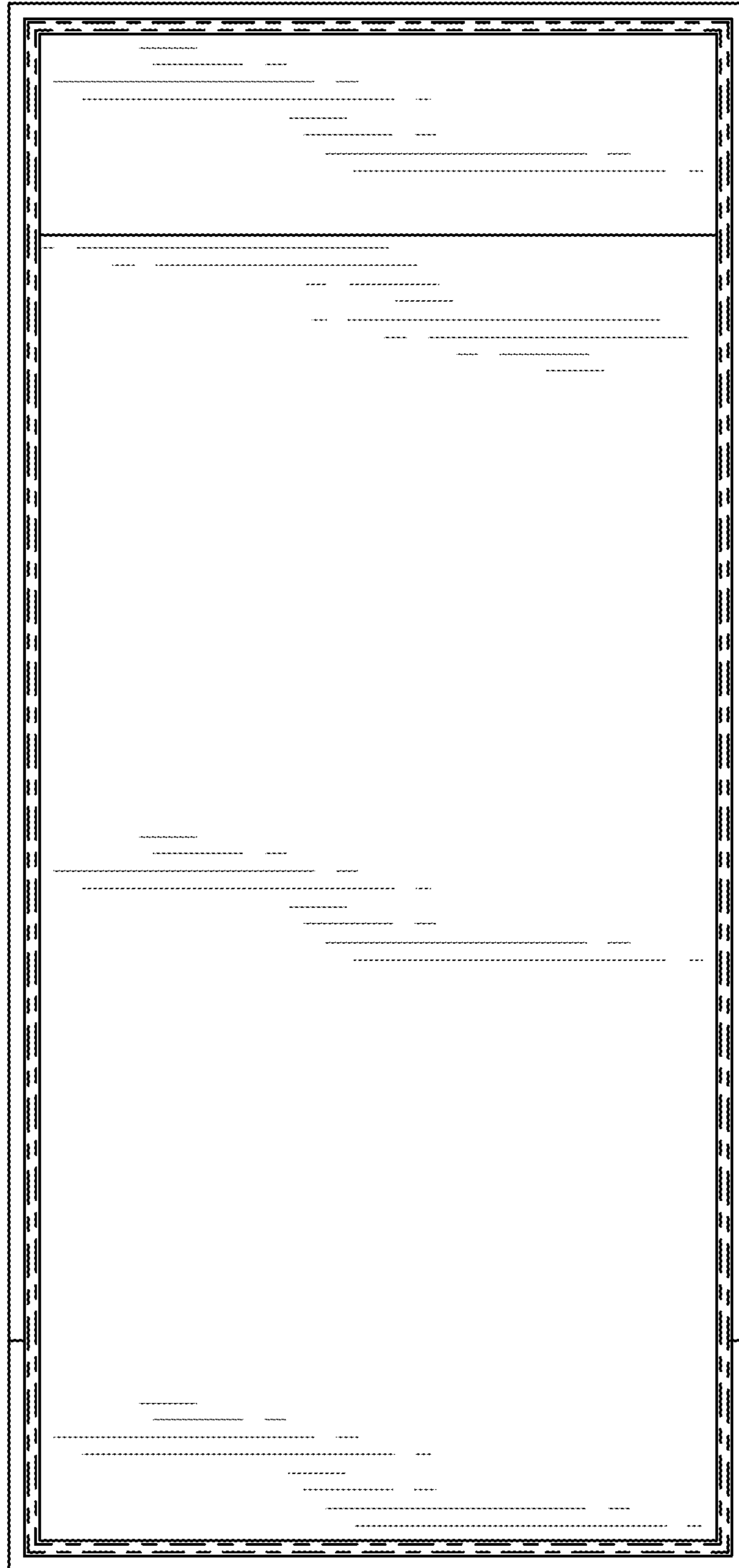

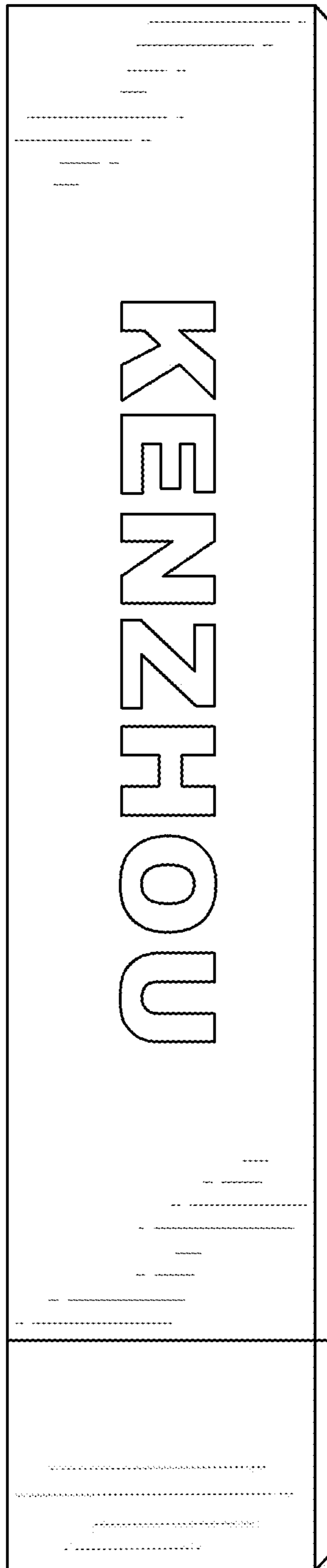

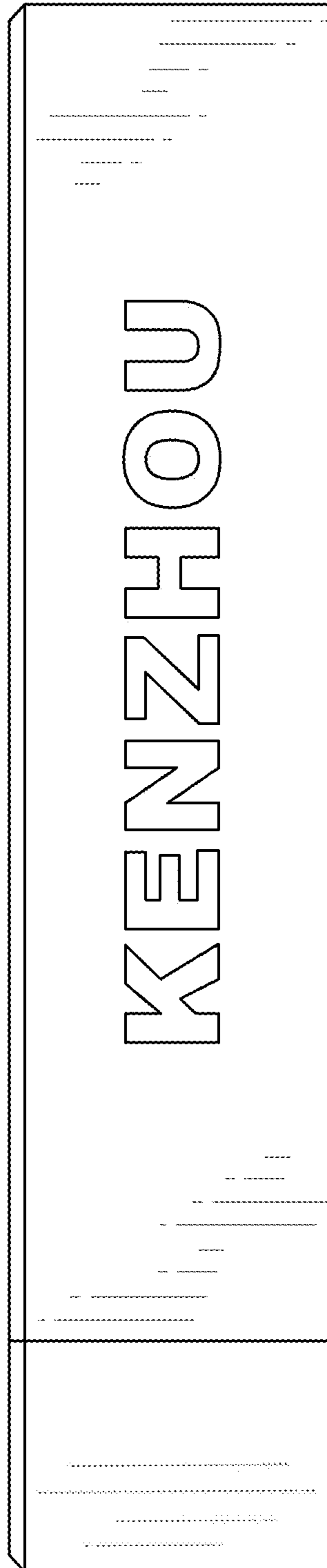

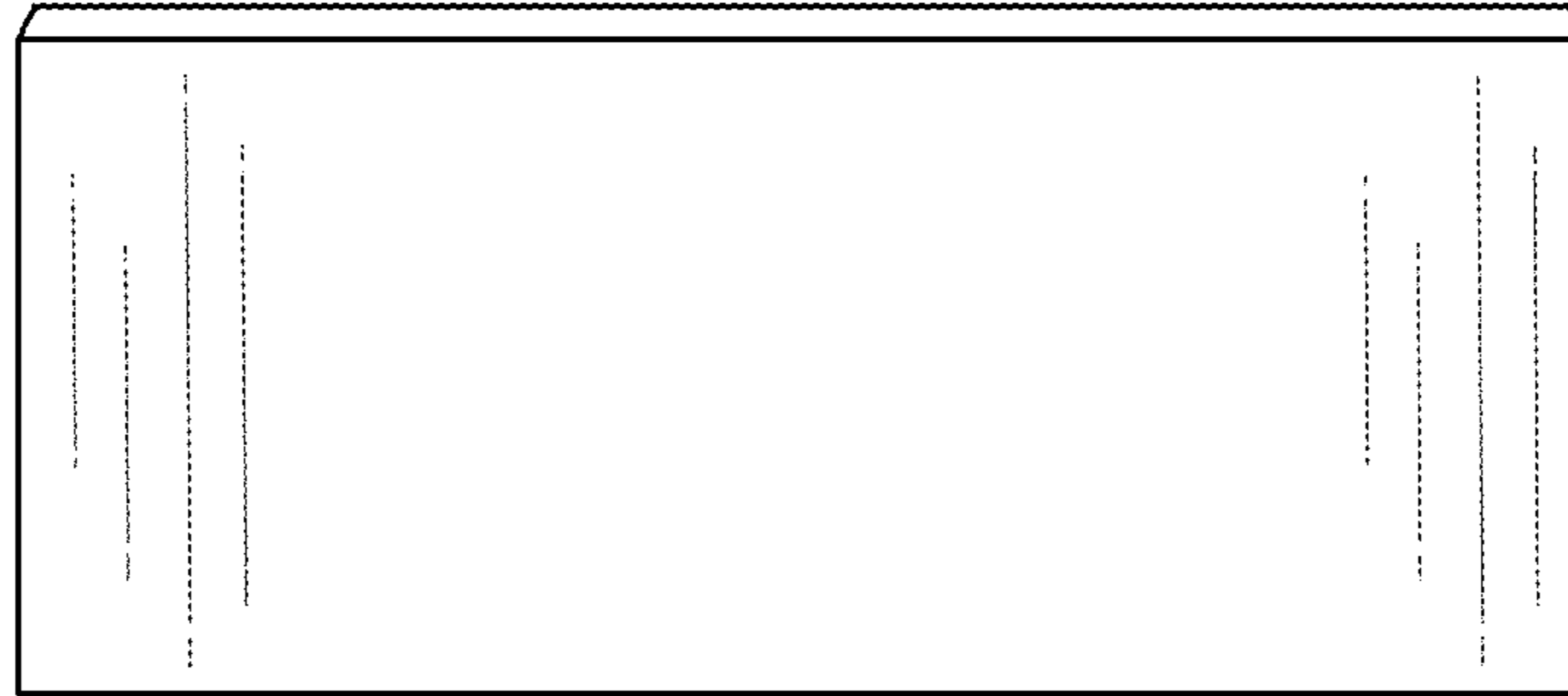

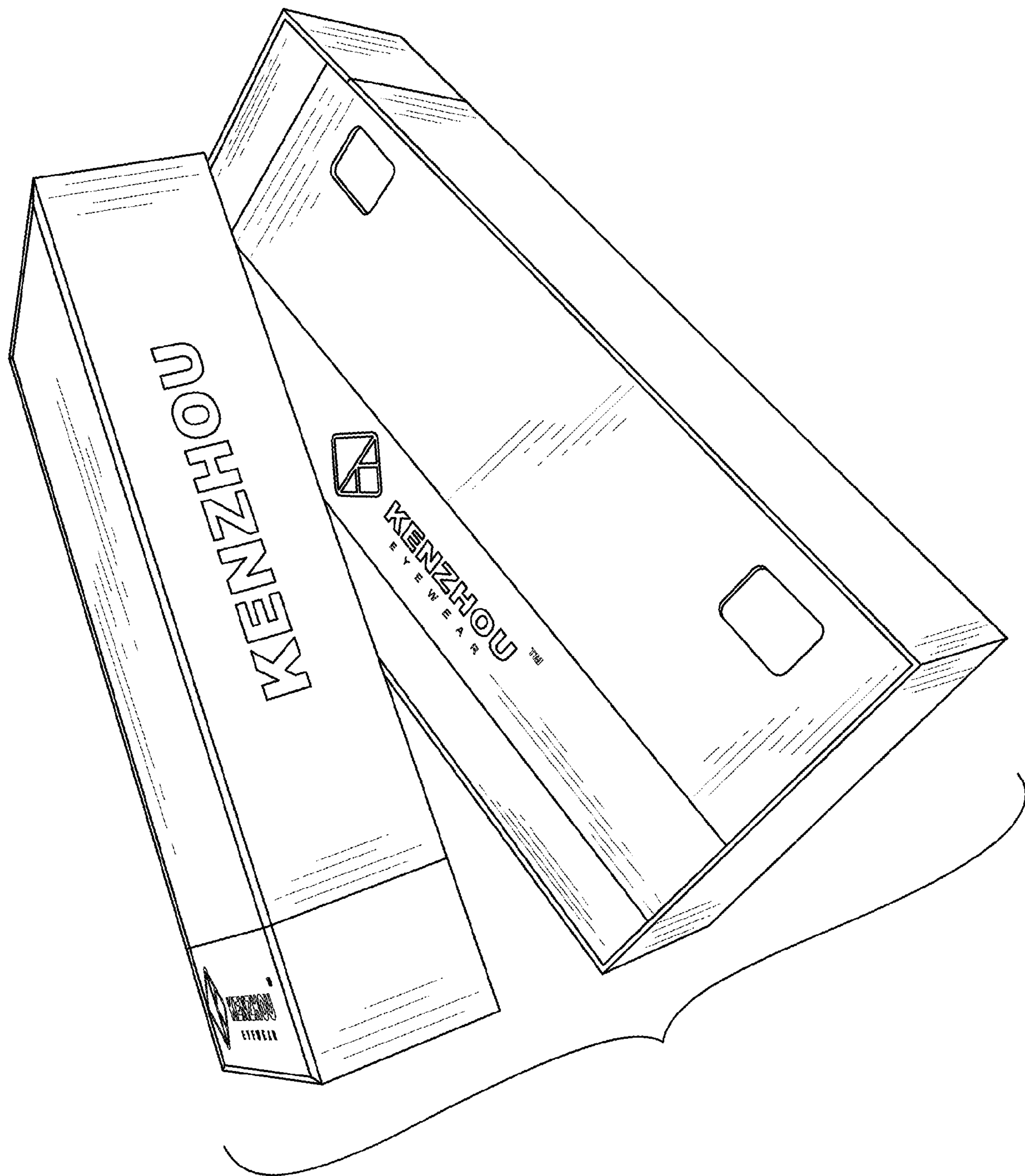

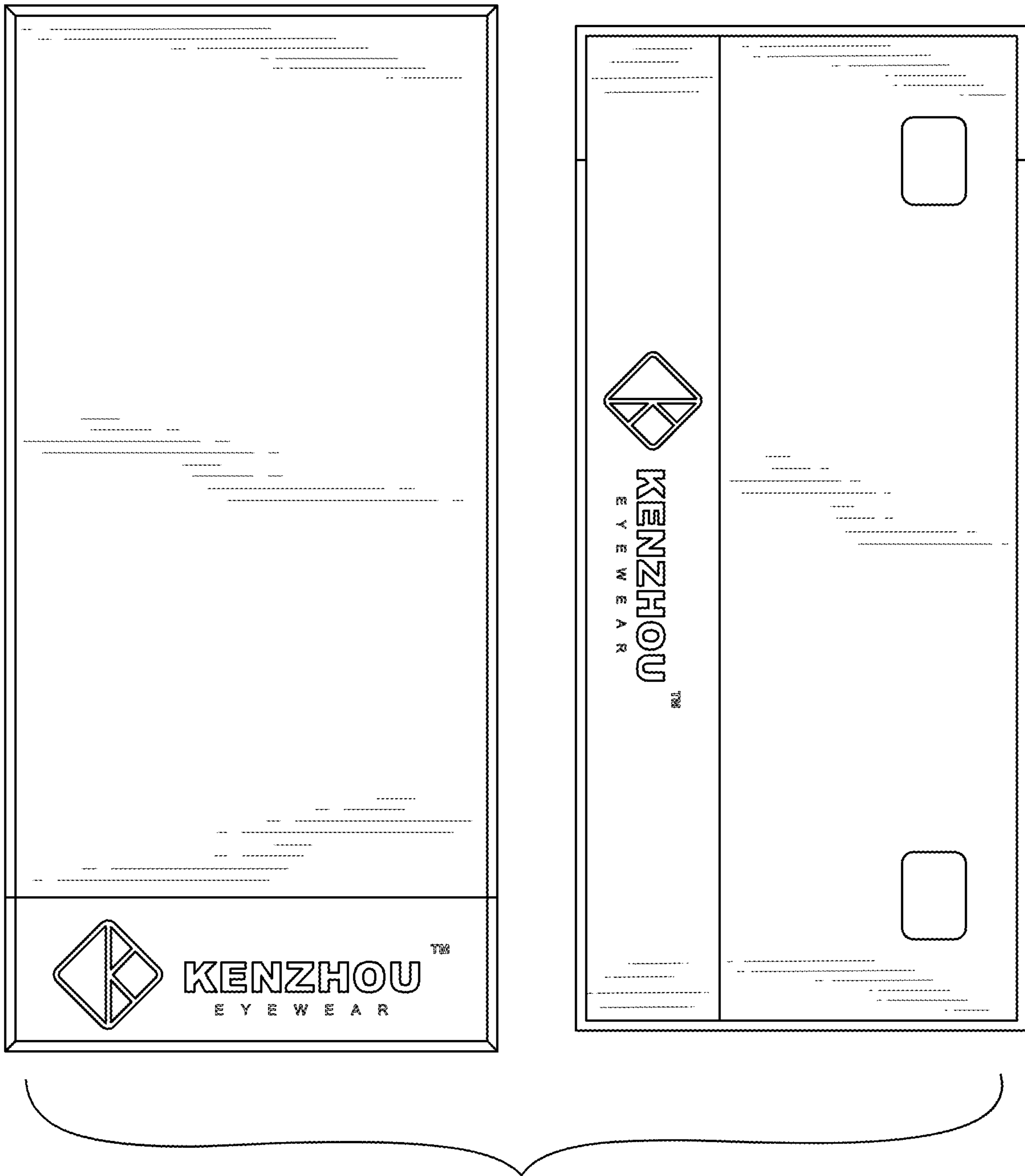
