The ornamental design for a golf bag, as shown and described.

DESCRIPTION

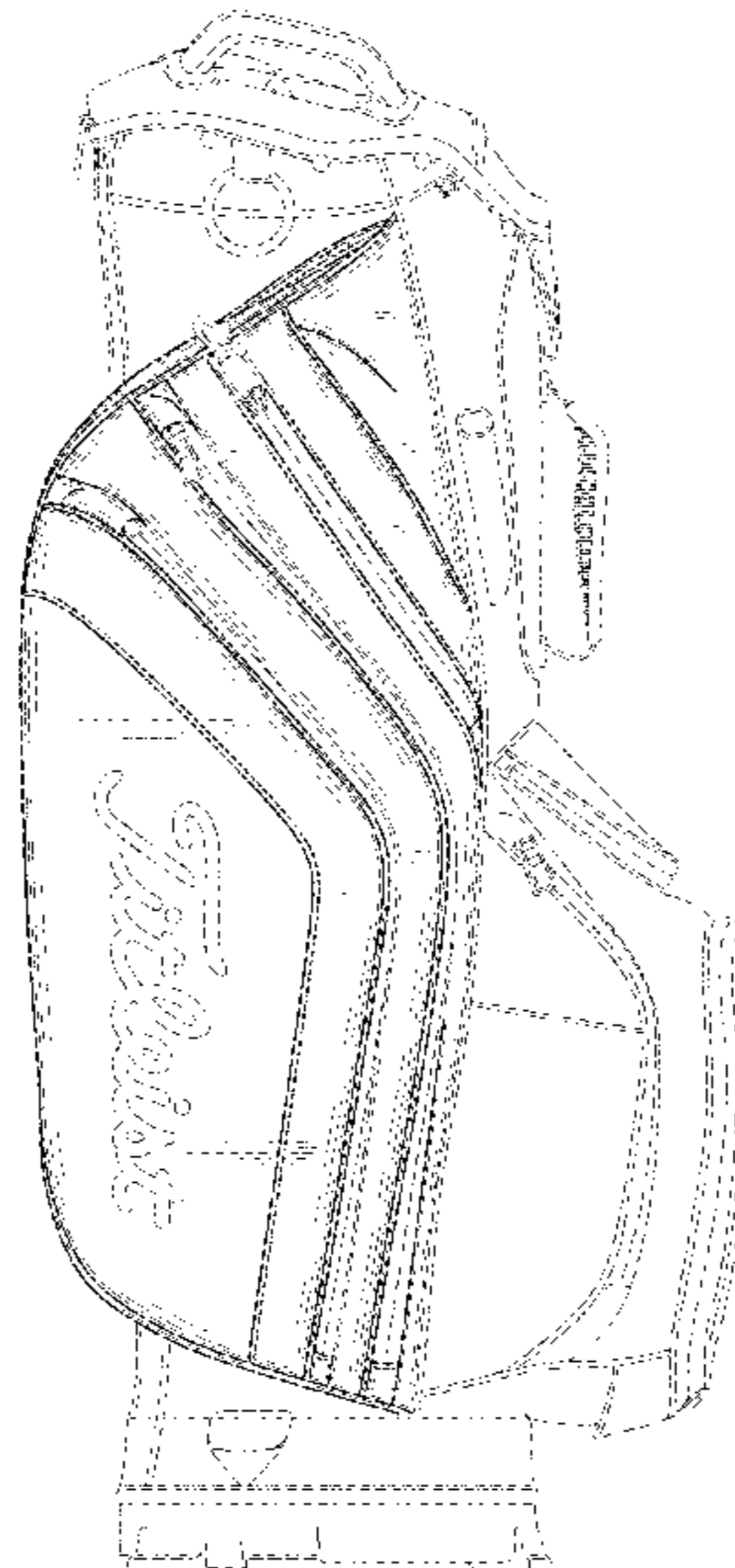
FIG. 1 is a perspective view of a golf bag showing our new design;
FIG. 2 is a front view of the golf bag thereof;
FIG. 3 is a first side view of the golf bag thereof;
FIG. 4 is a second side view of the golf bag thereof;
FIG. 5 is a rear view of the golf bag thereof;
FIG. 6 is a top plan view of the golf bag thereof; and,
FIG. 7 is a bottom plan view of the golf bag thereof.
In FIGS. 1-7, the thinner wider spaced broken lines showing portions of the golf bag are for purposes of illustrating environment and form no part of the claimed design. The heavier closer spaced broken lines shown on the golf bag side pockets are representative of stitching that forms part of the claimed design. The thinner wider spaced broken lines showing the logos, “TITLEIST” is a registered mark of the Acushnet Company, form no part of the claimed design.

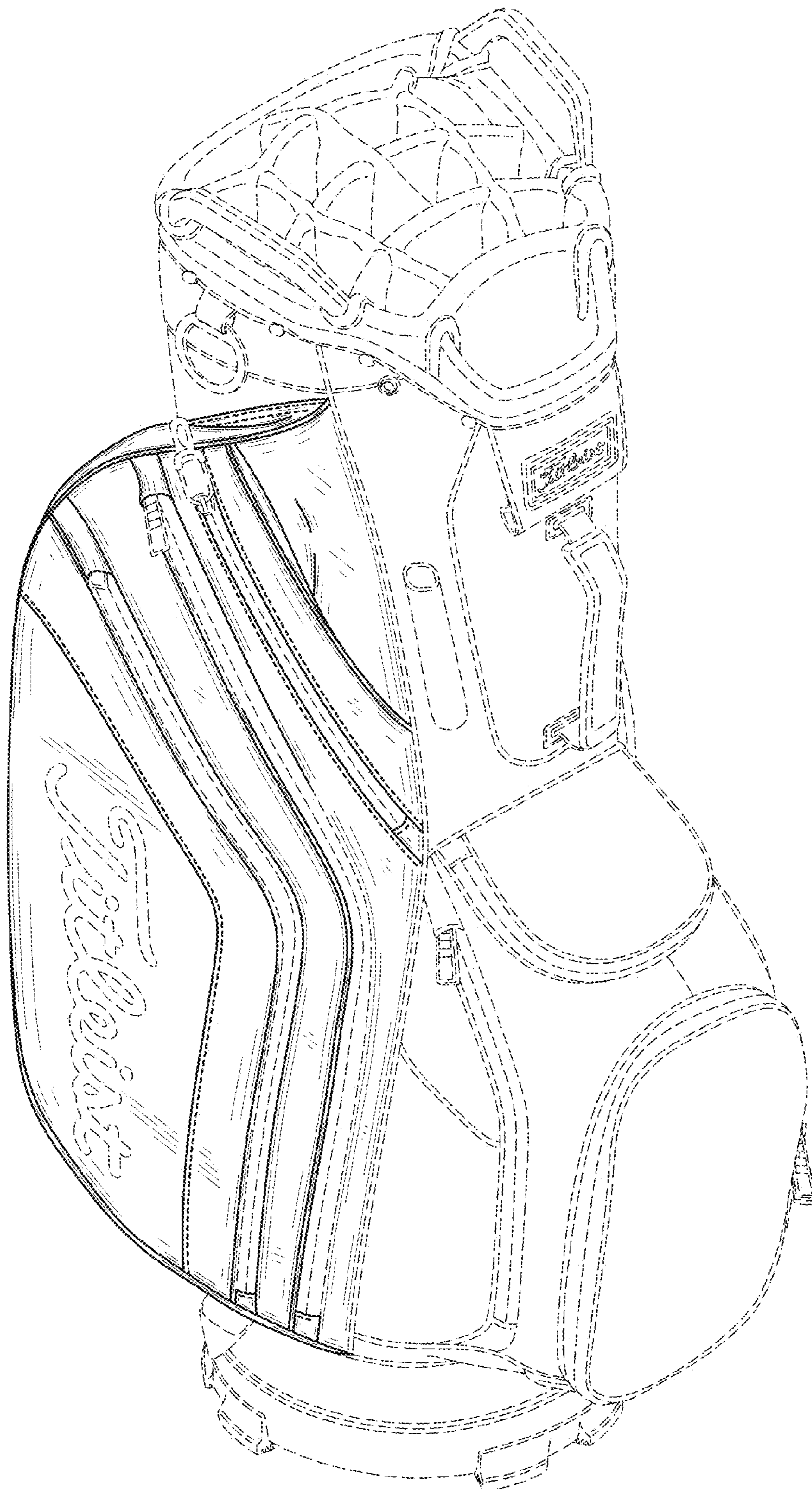

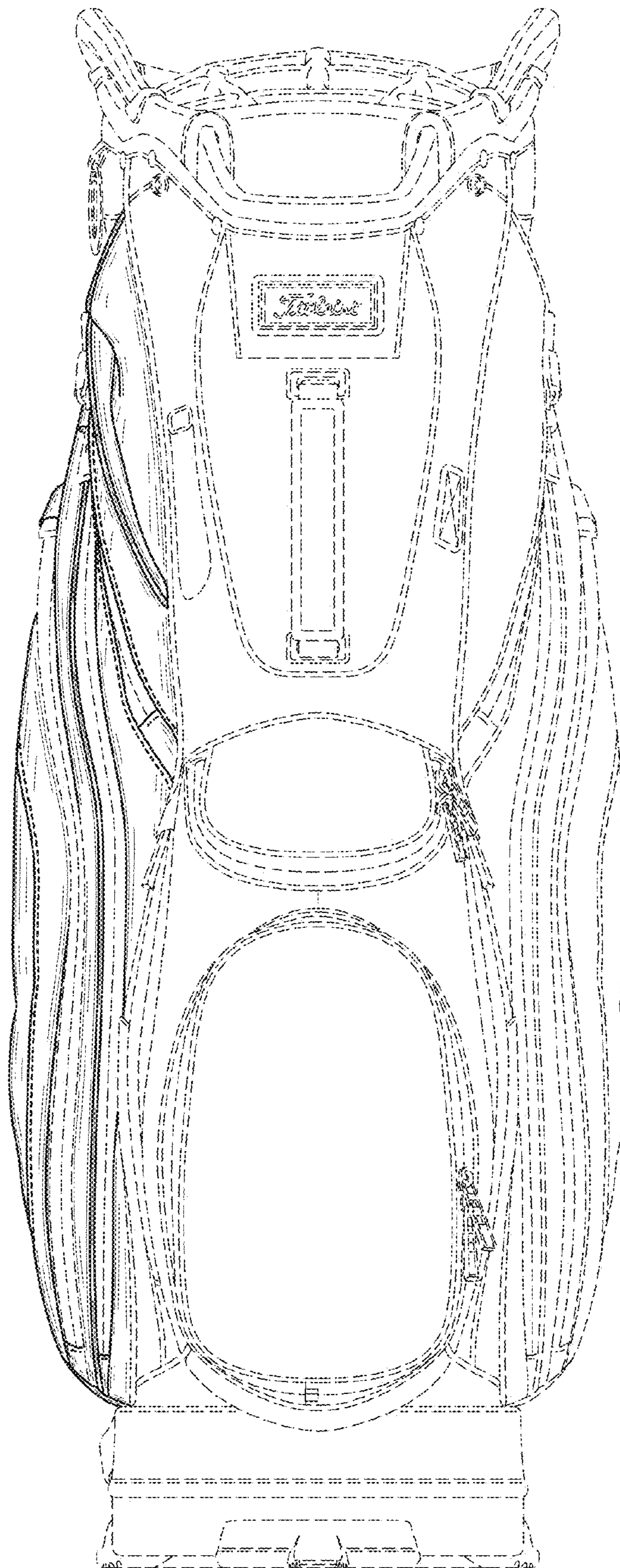

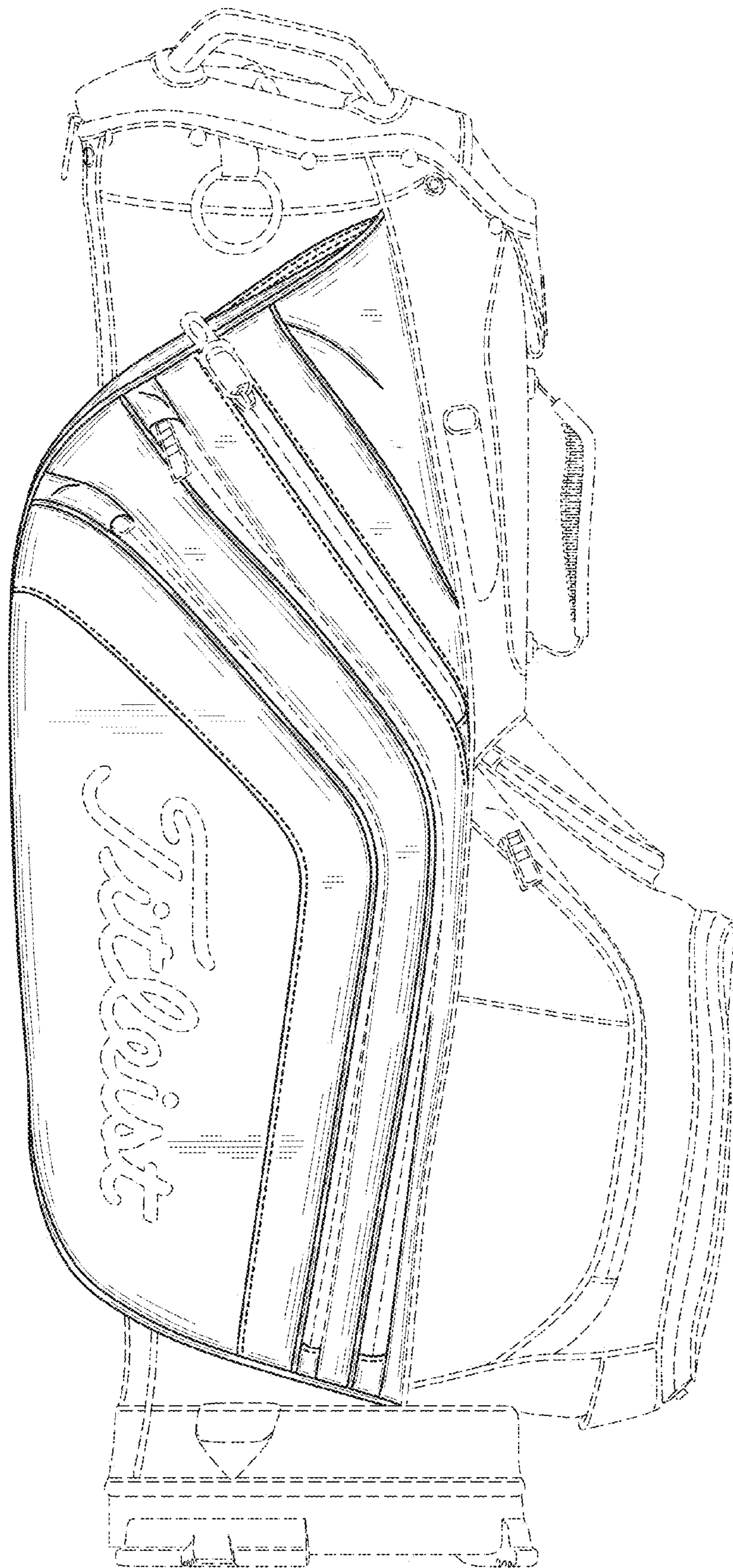

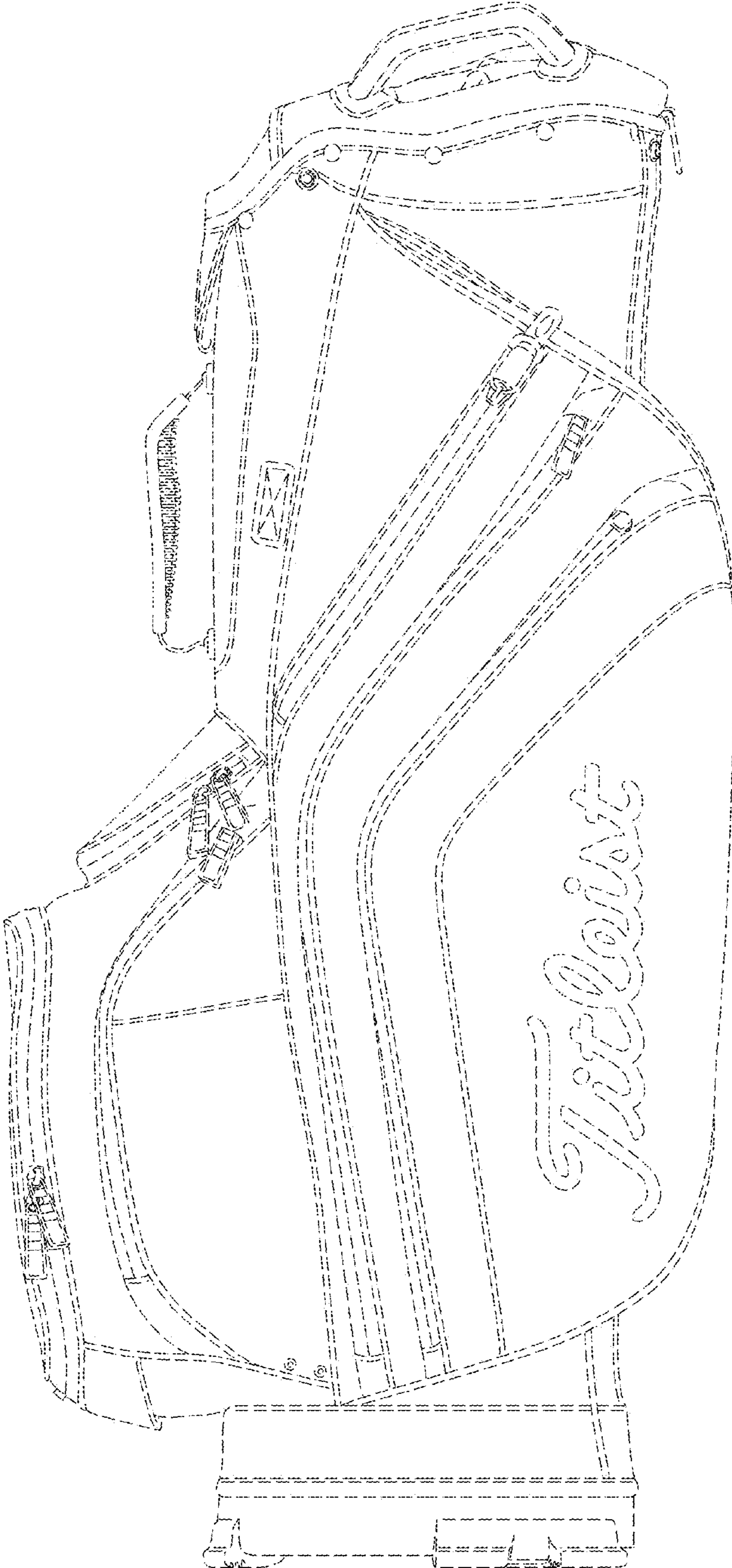

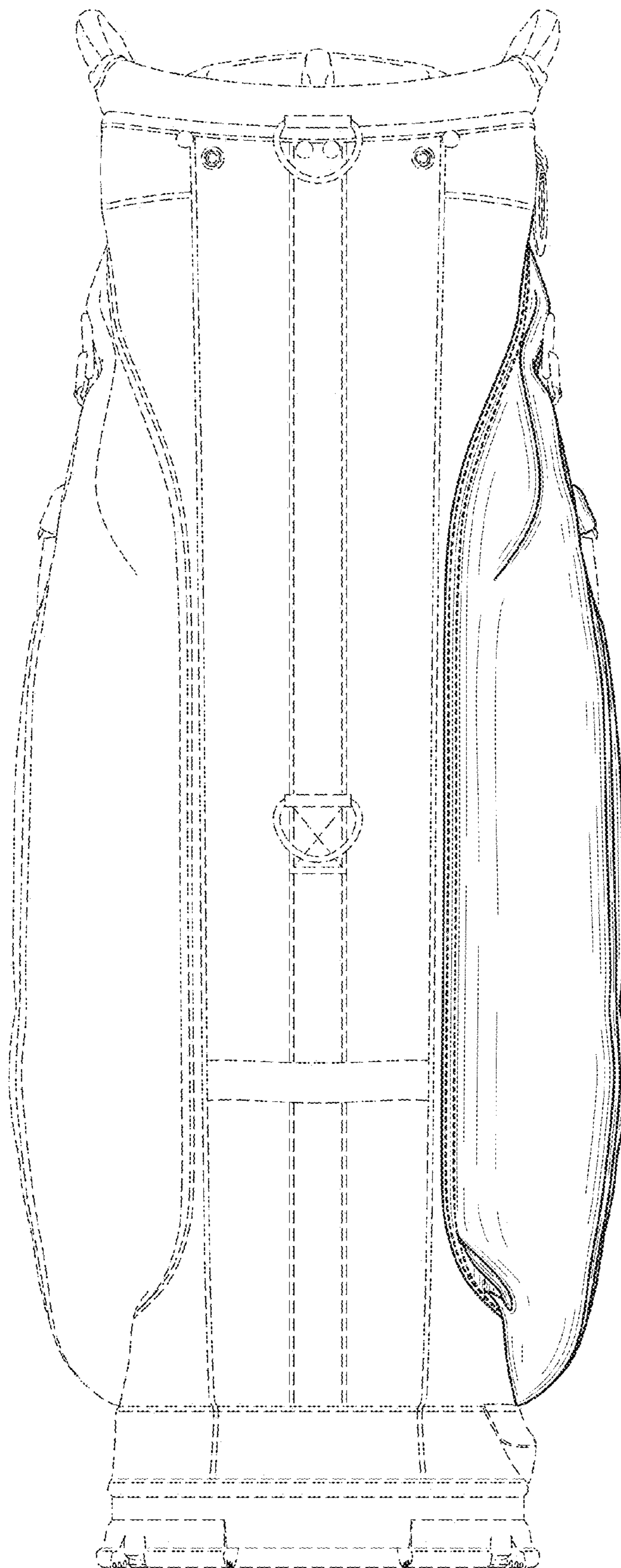

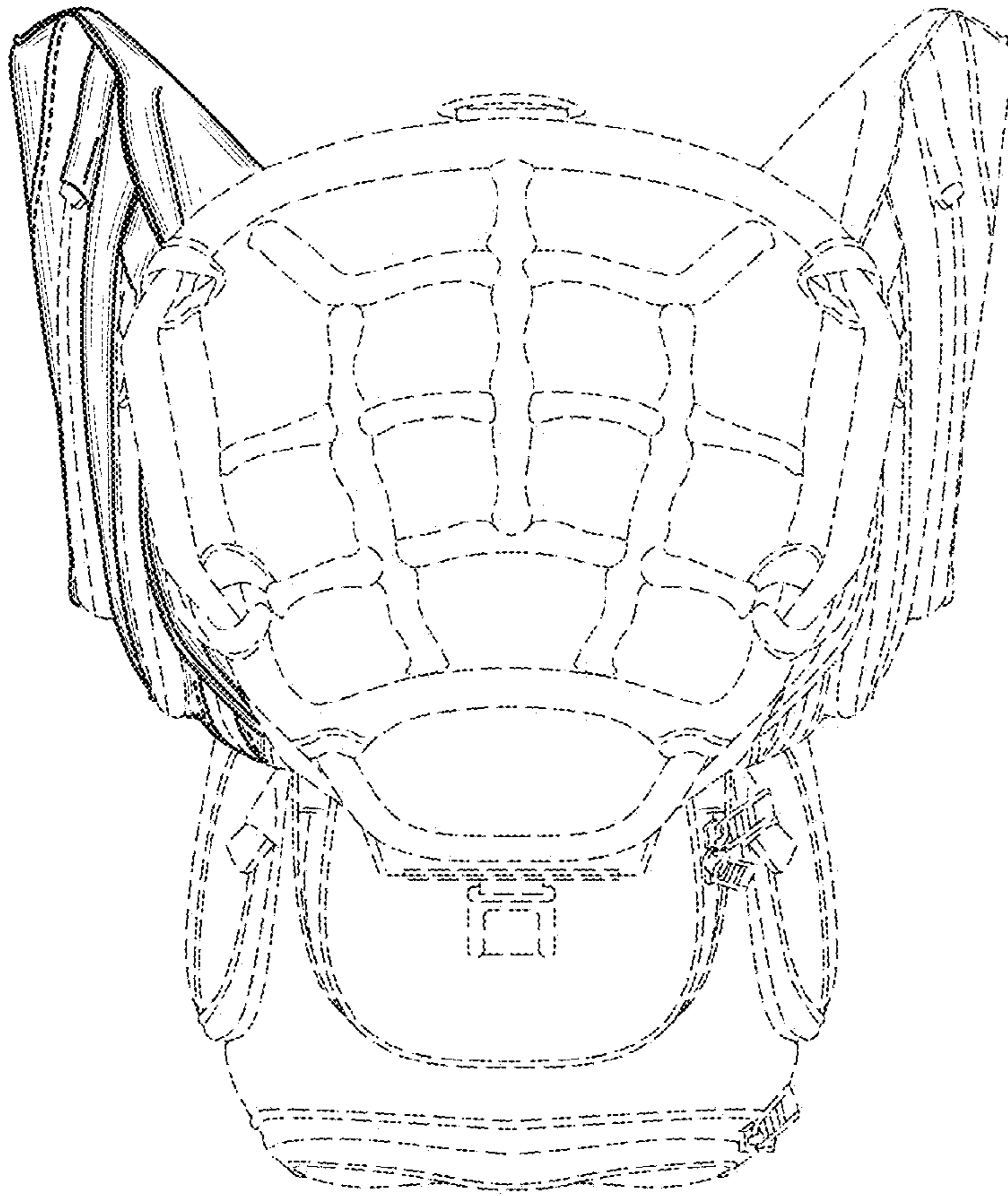

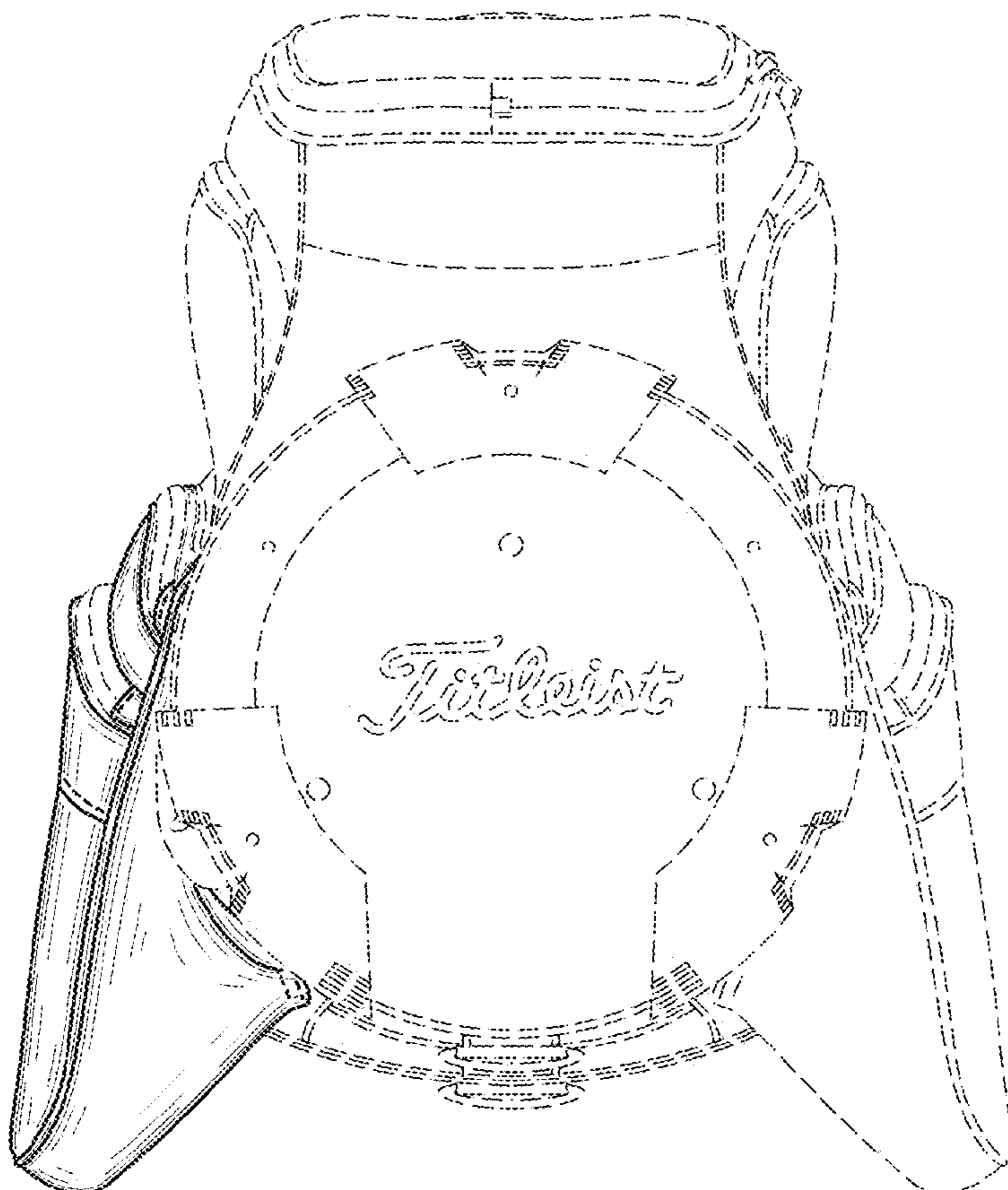
