FIG. 11 is a bottom perspective view thereof;

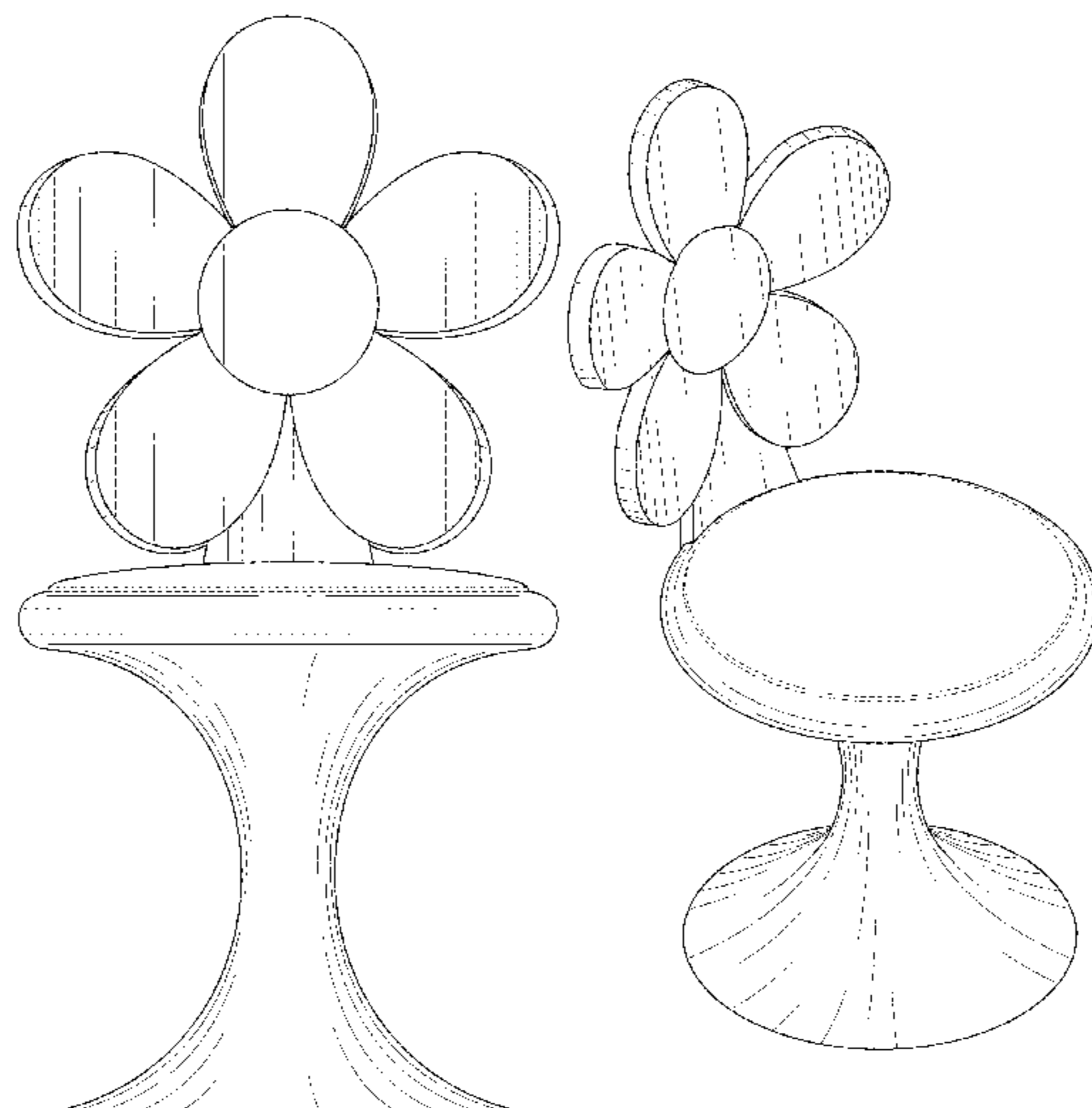
FIG. 12 is an alternate bottom perspective view thereof;

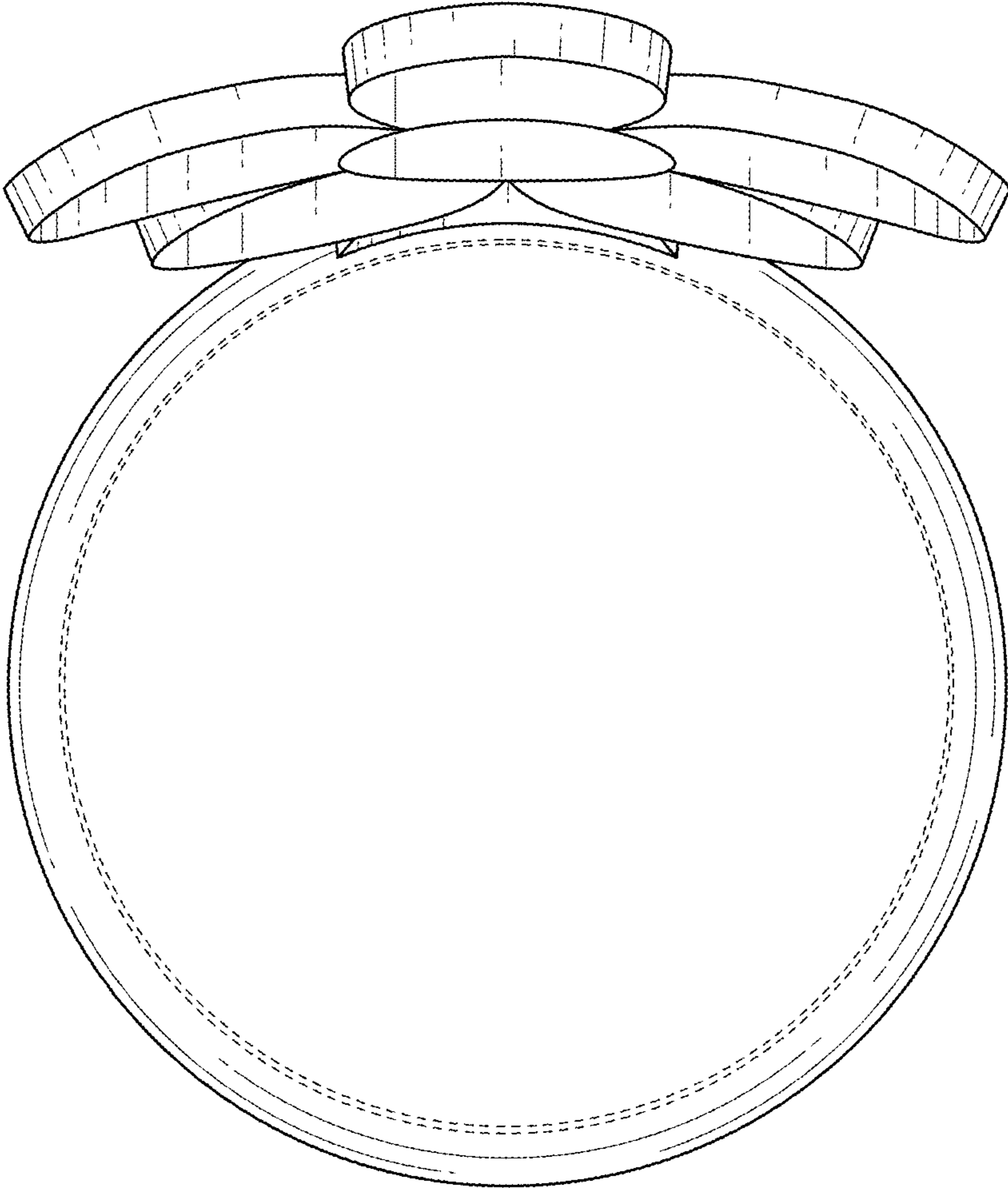

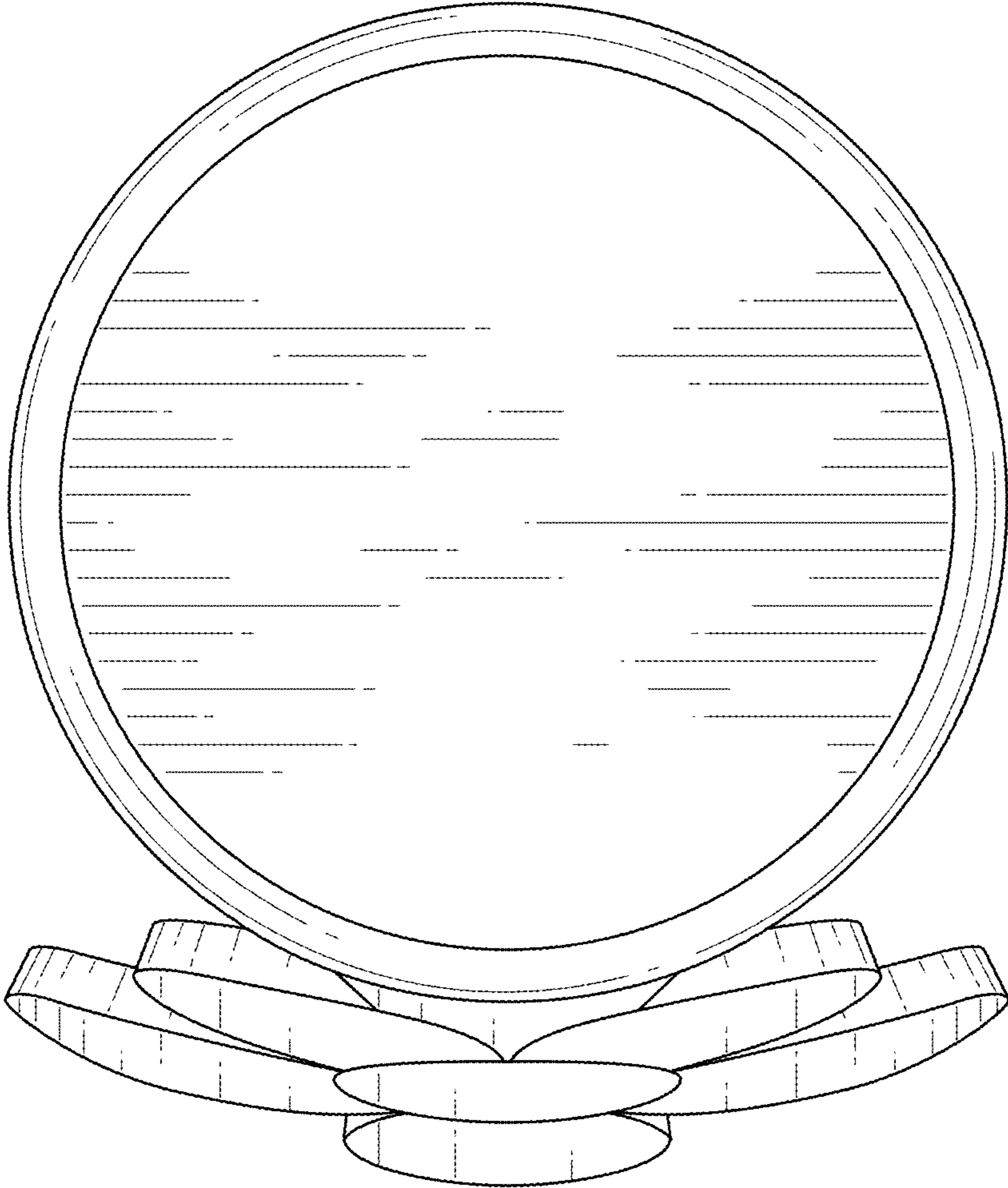

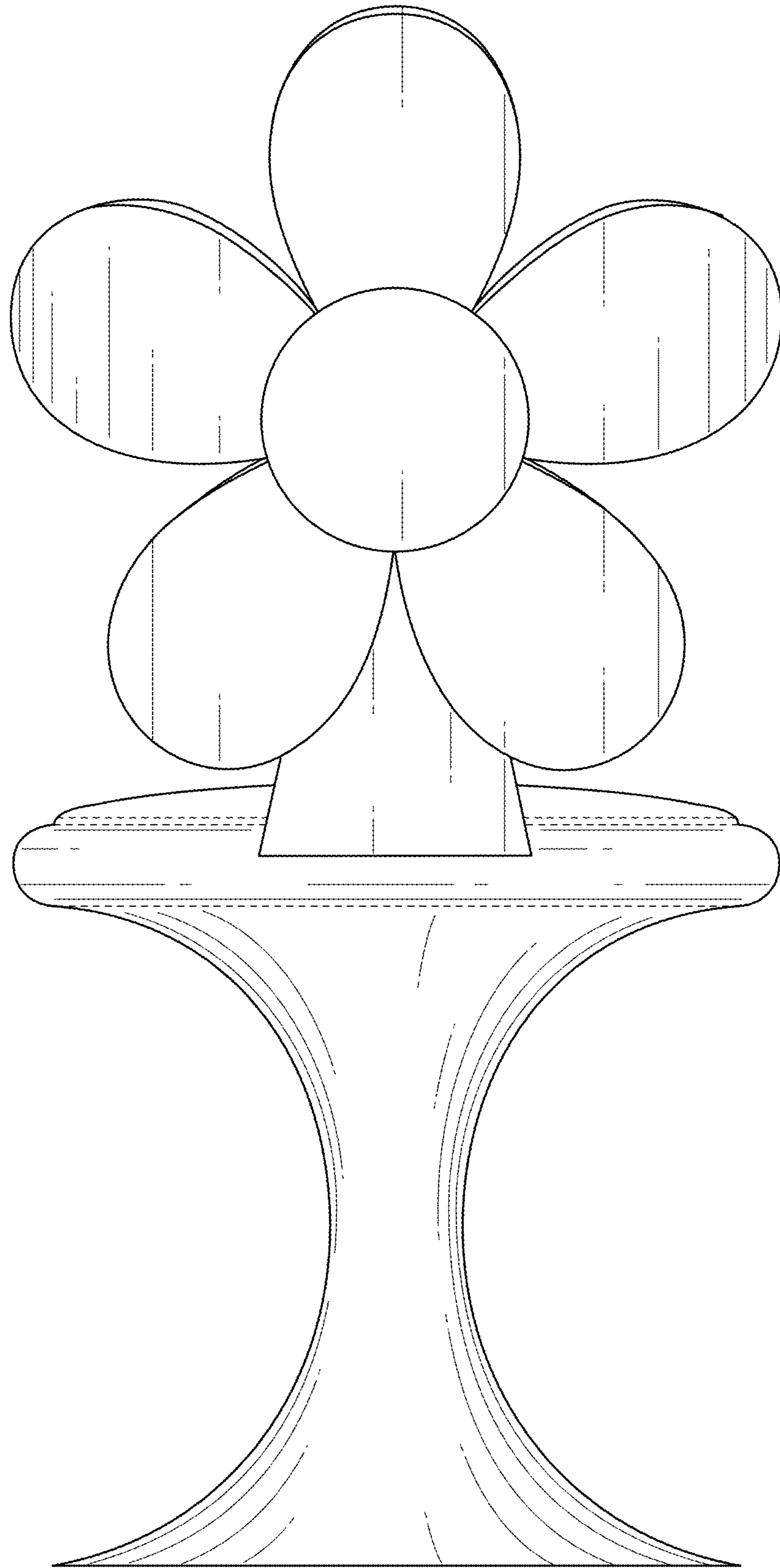

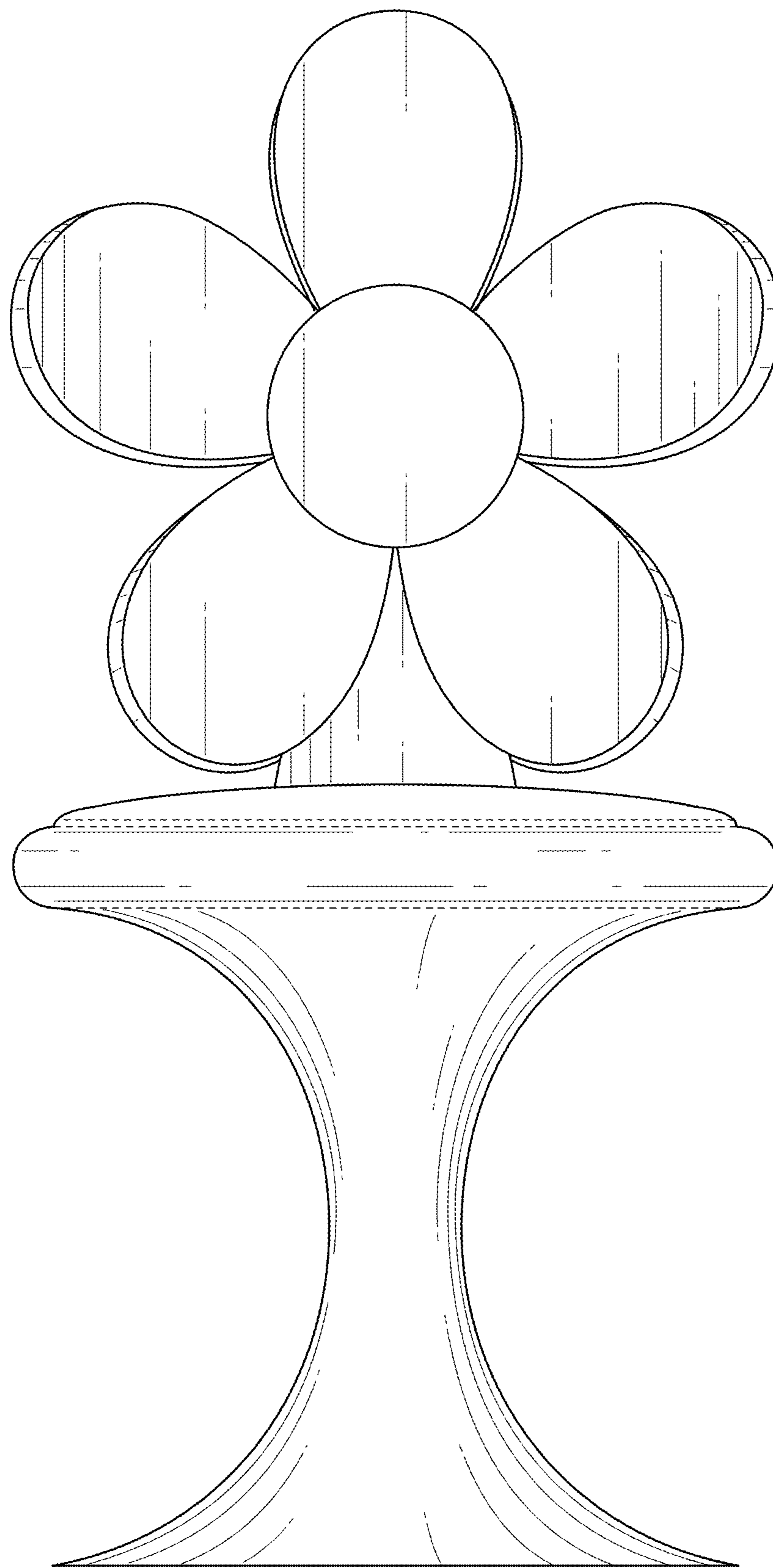

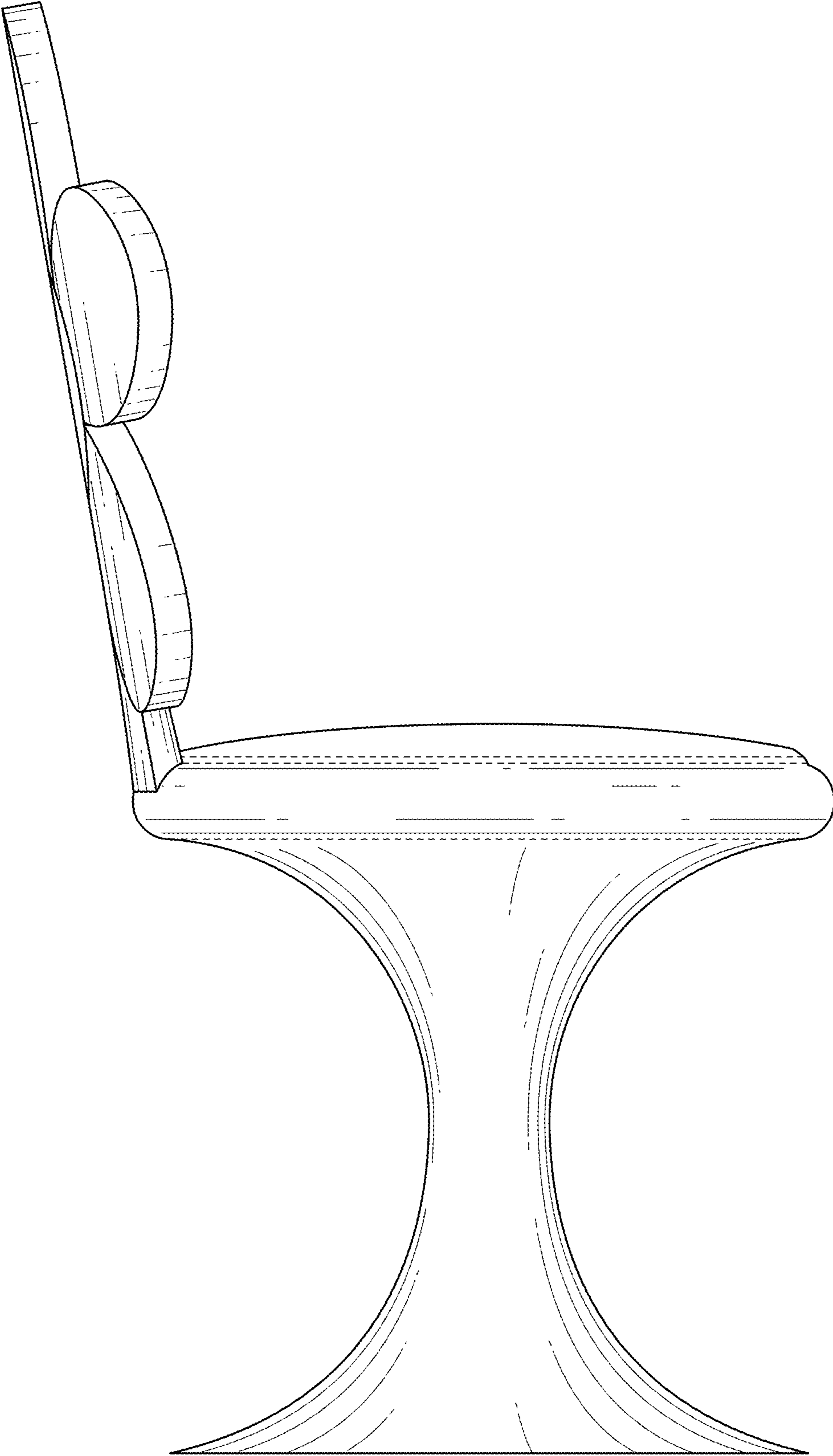

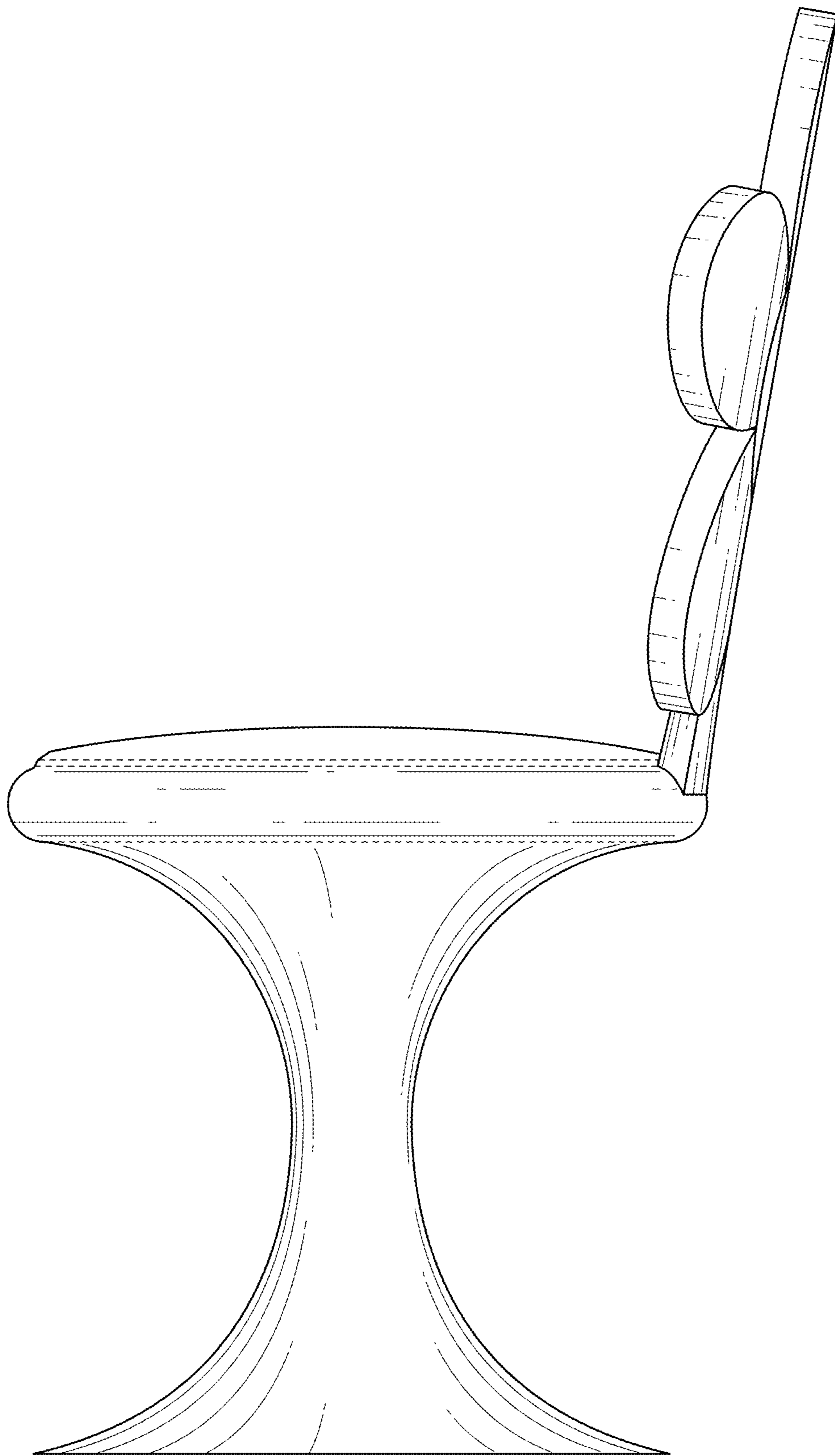

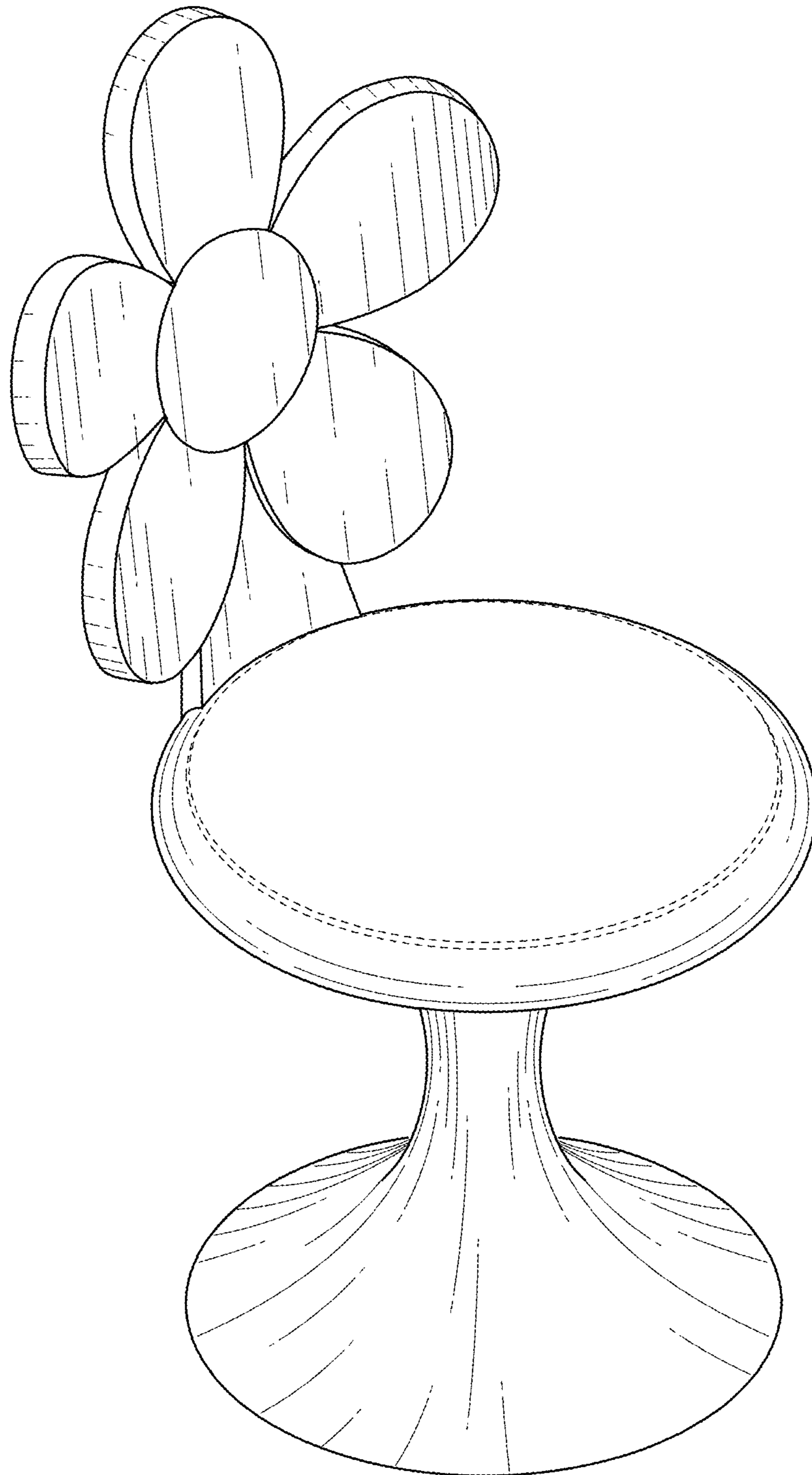

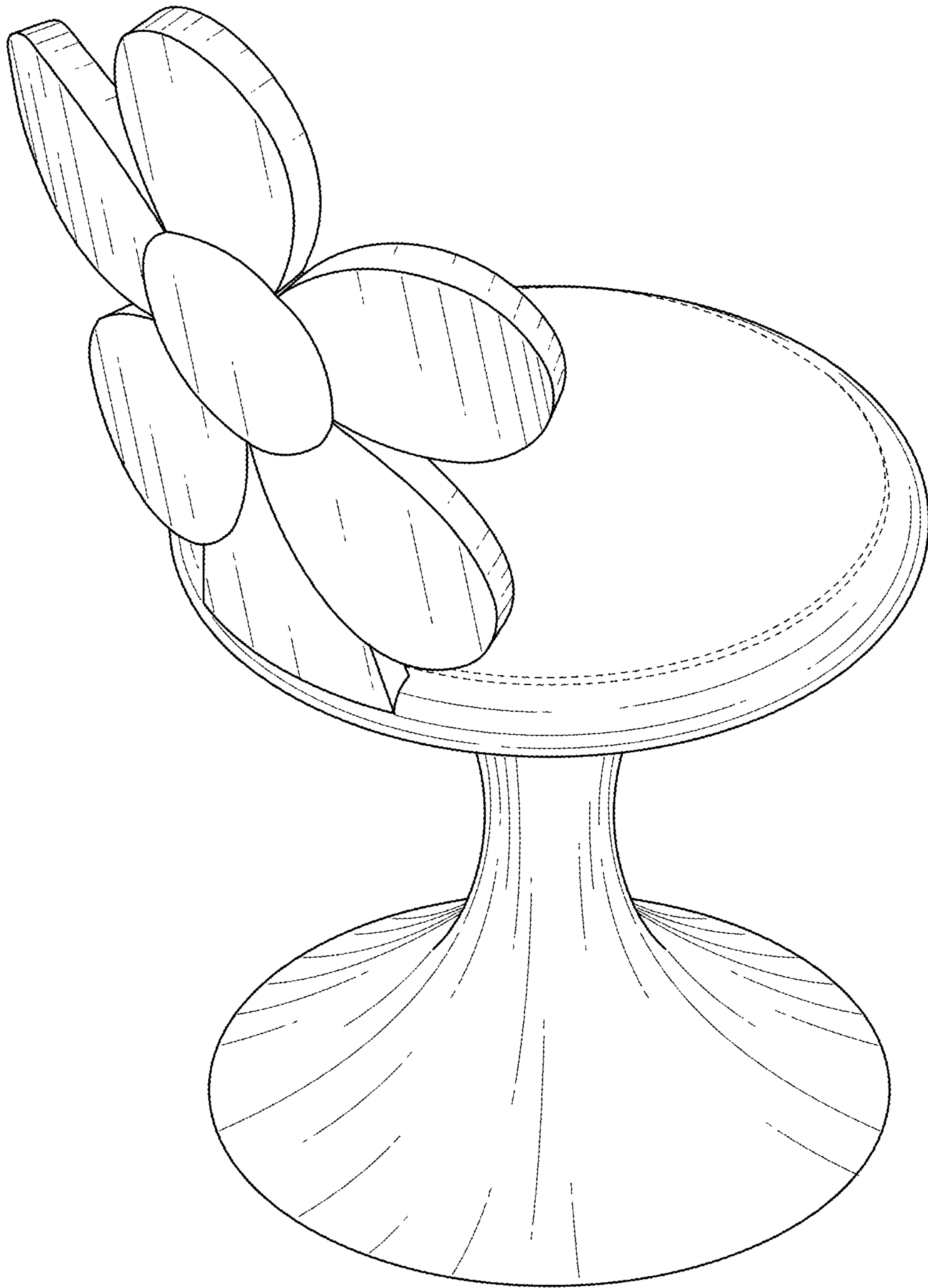

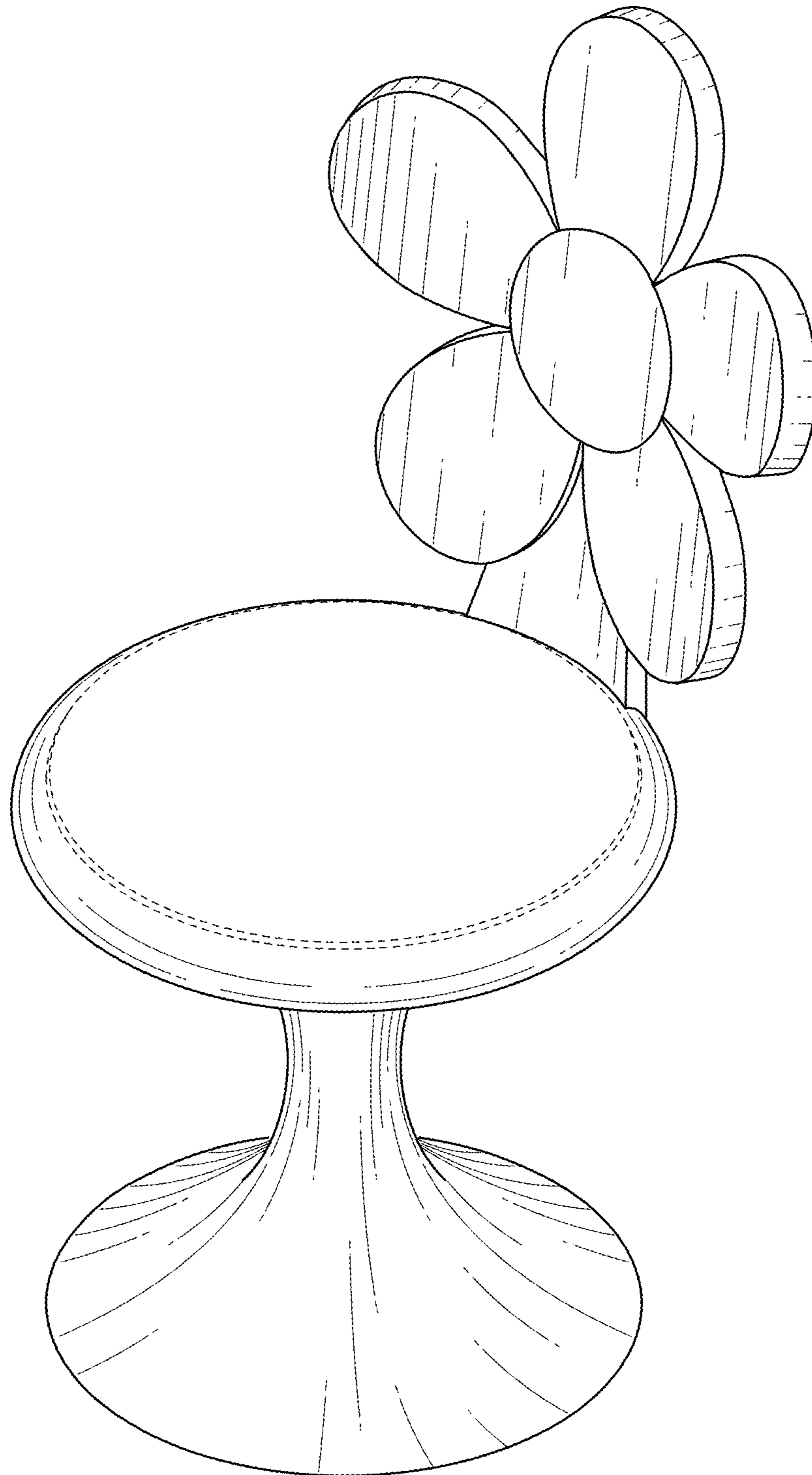

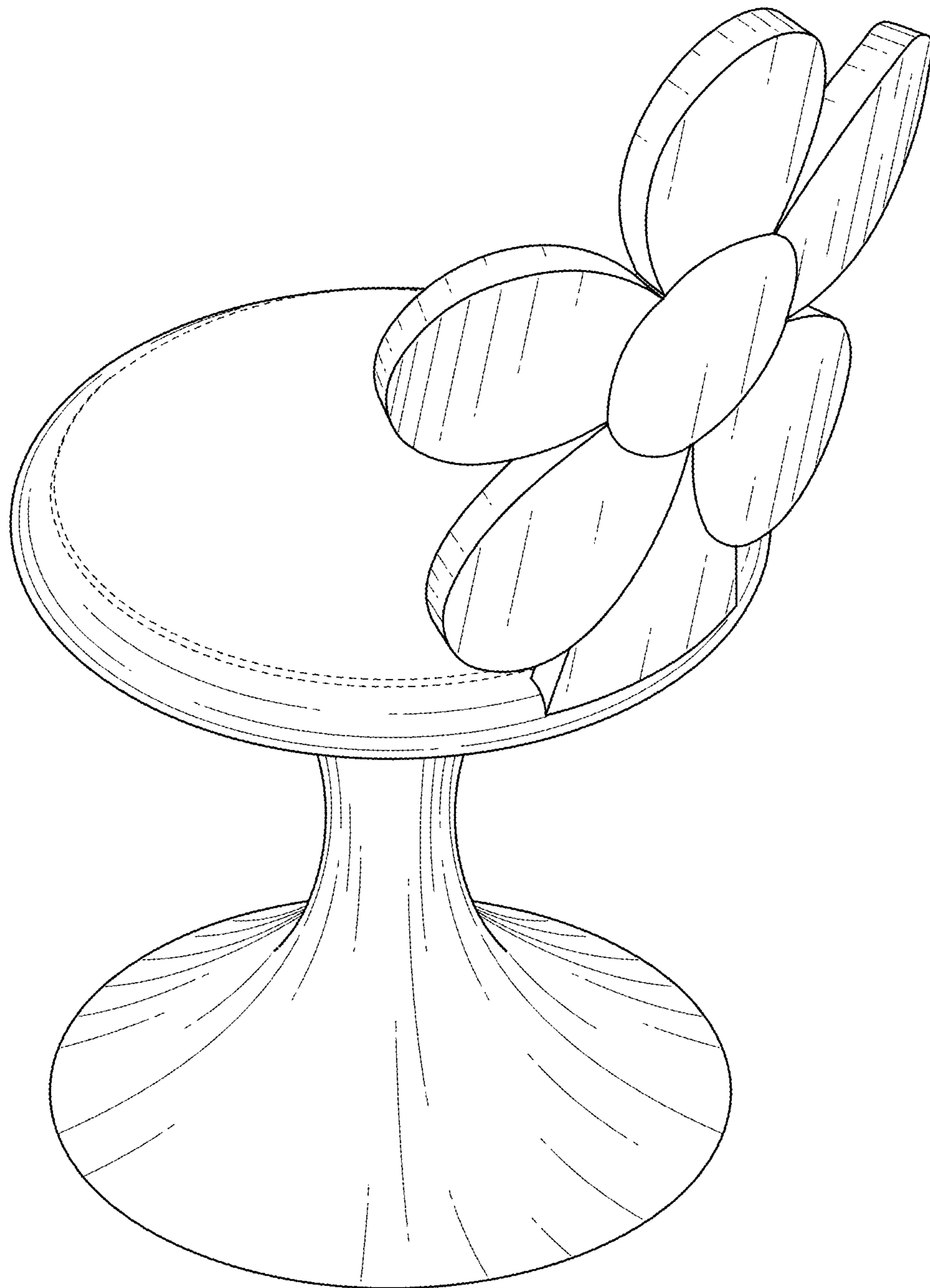

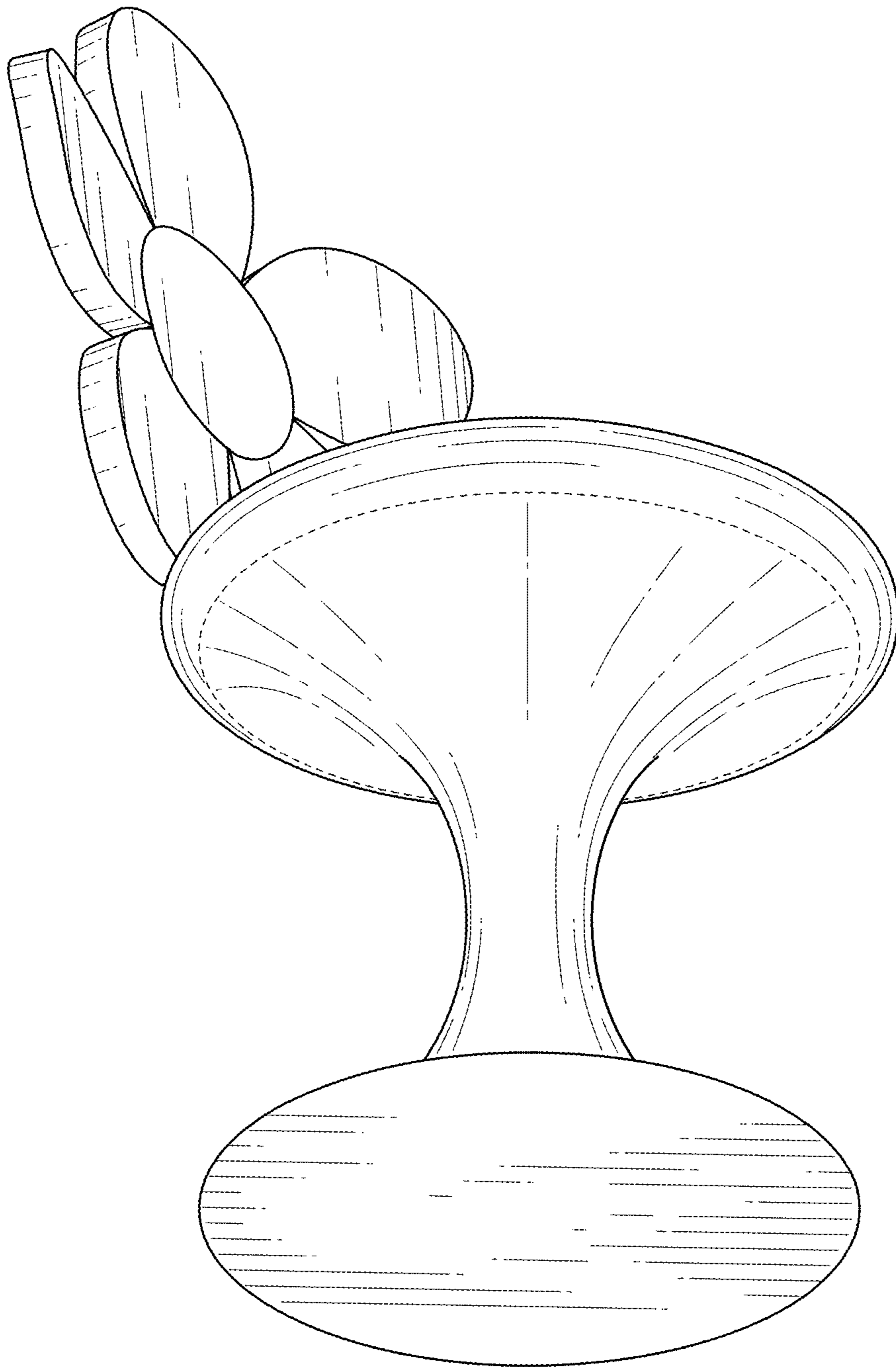

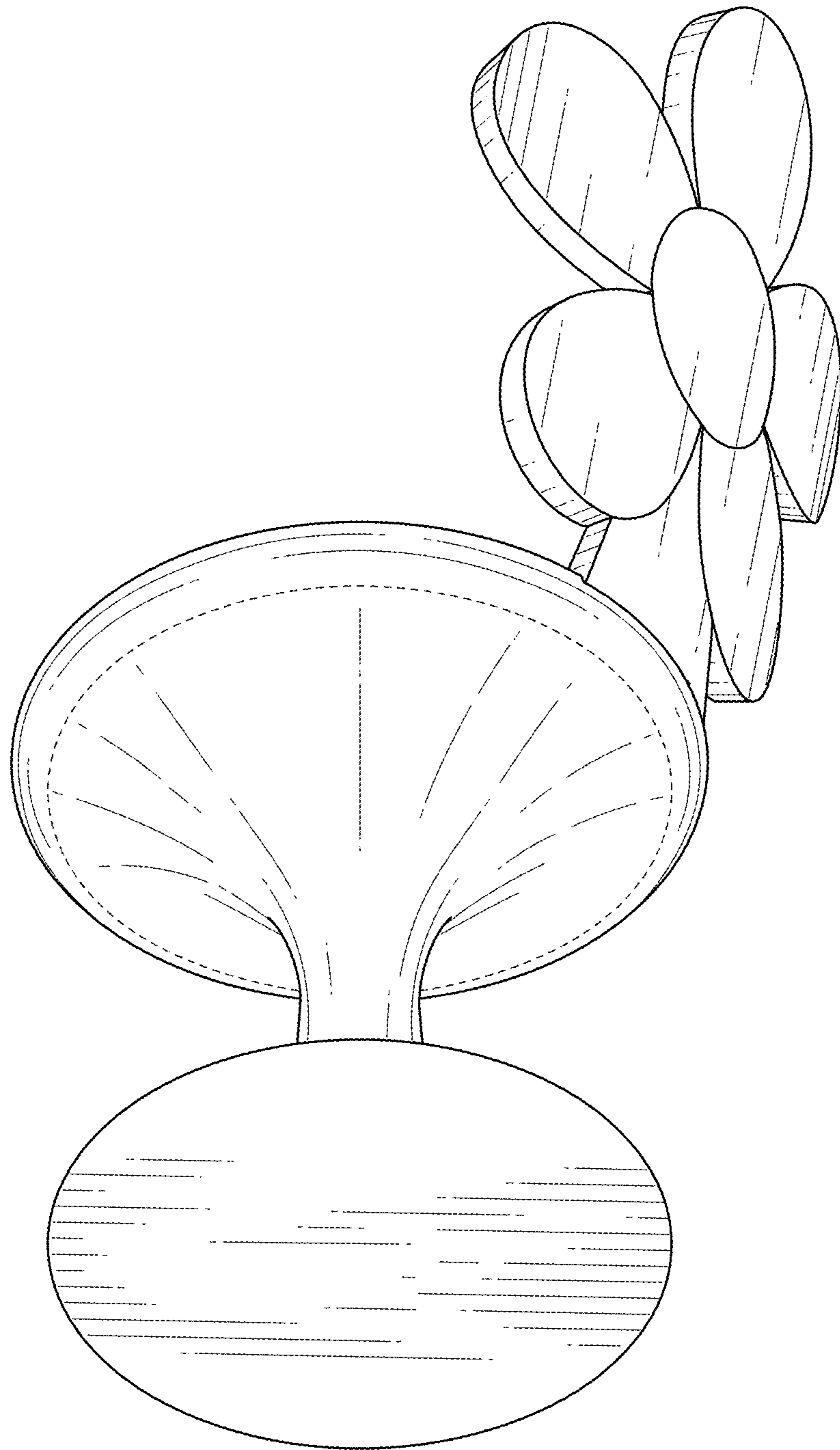

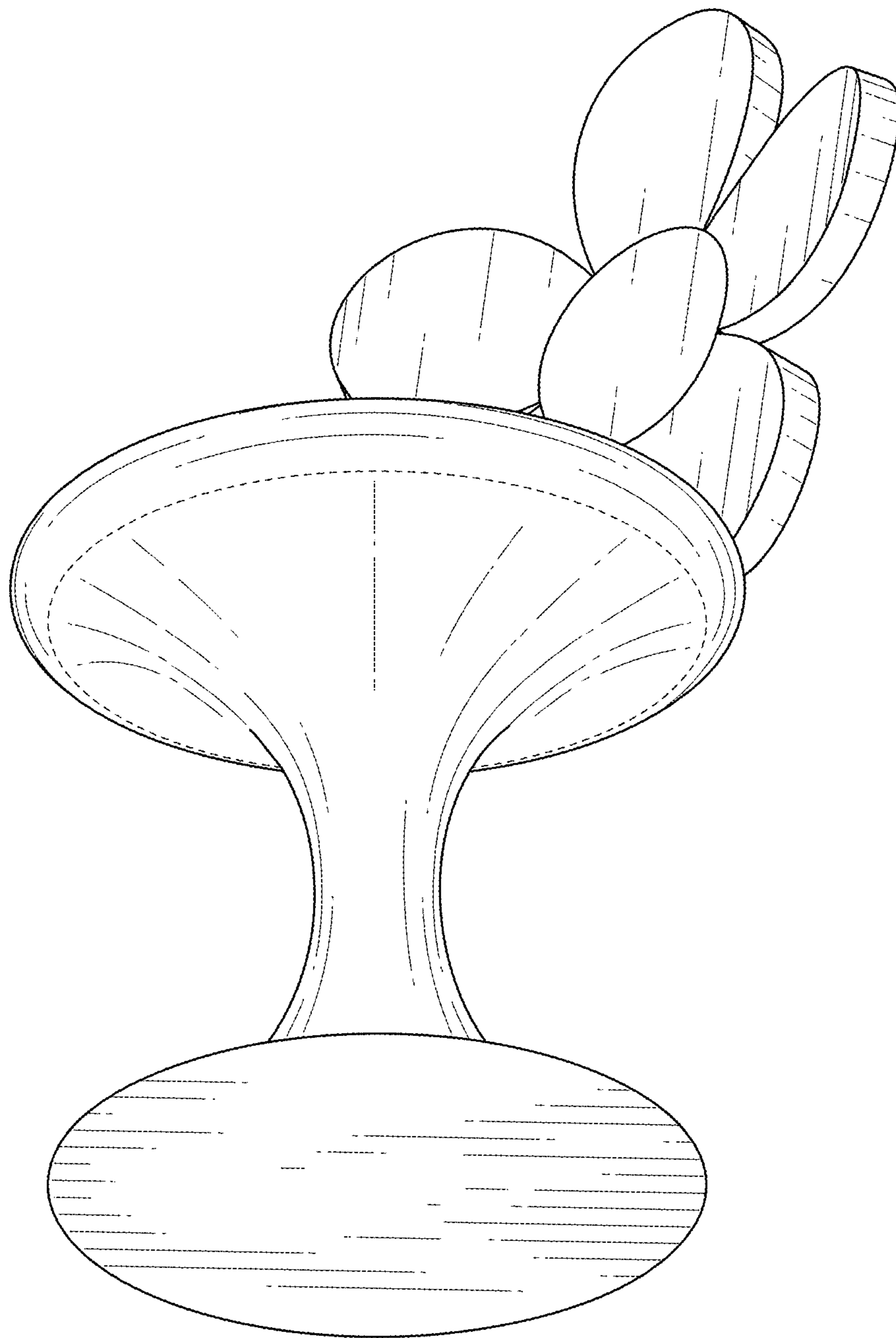
