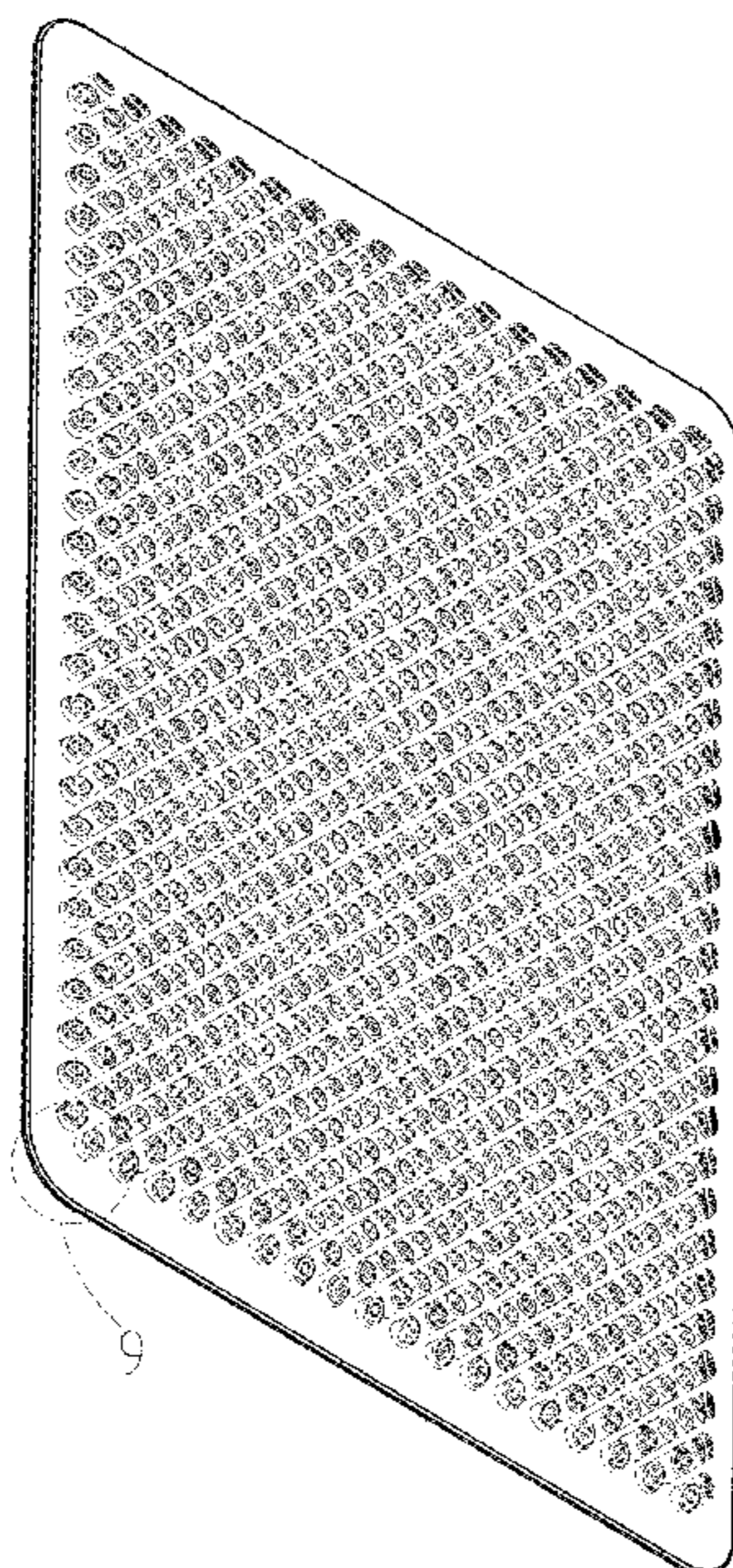
The ornamental design for a floor mat, as shown and described.

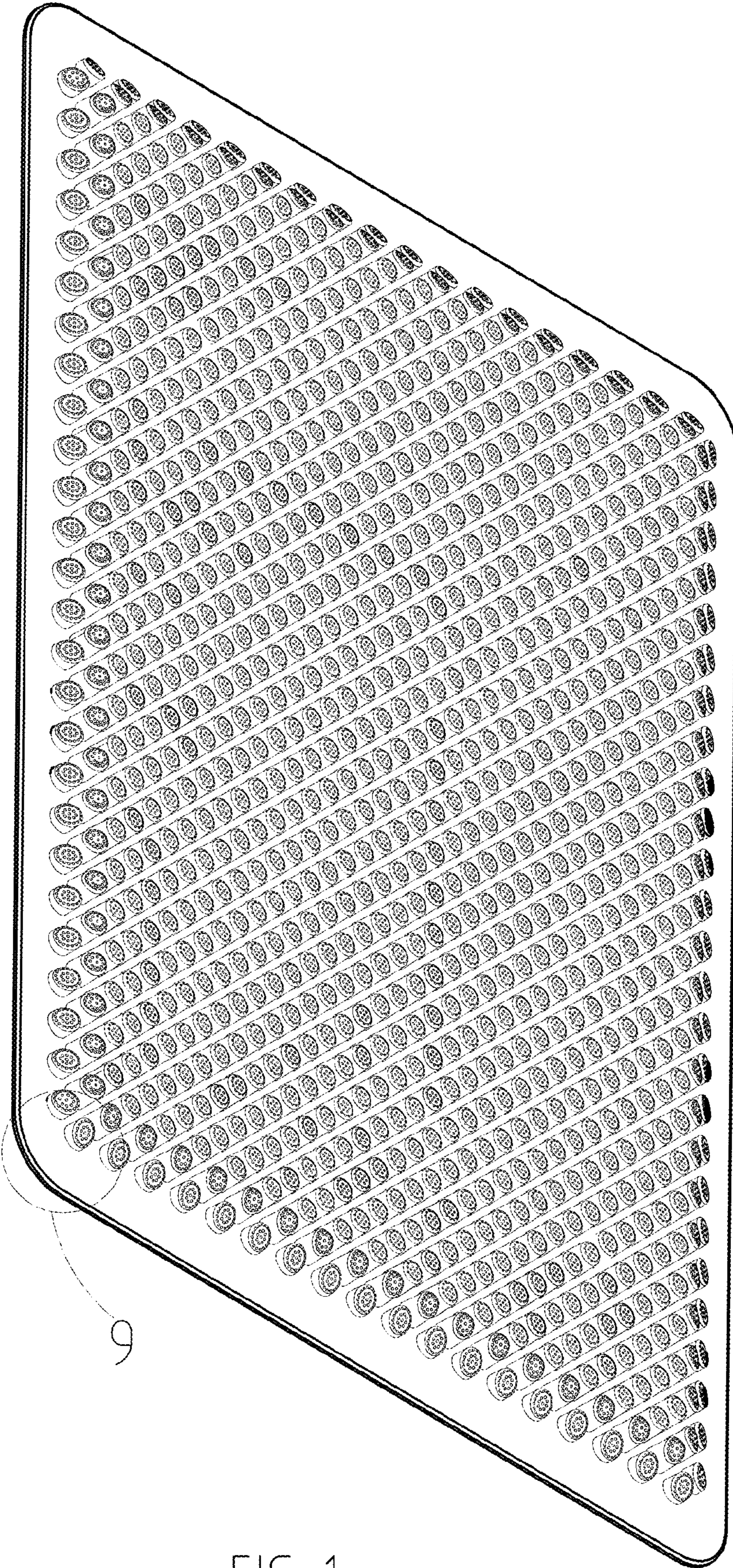

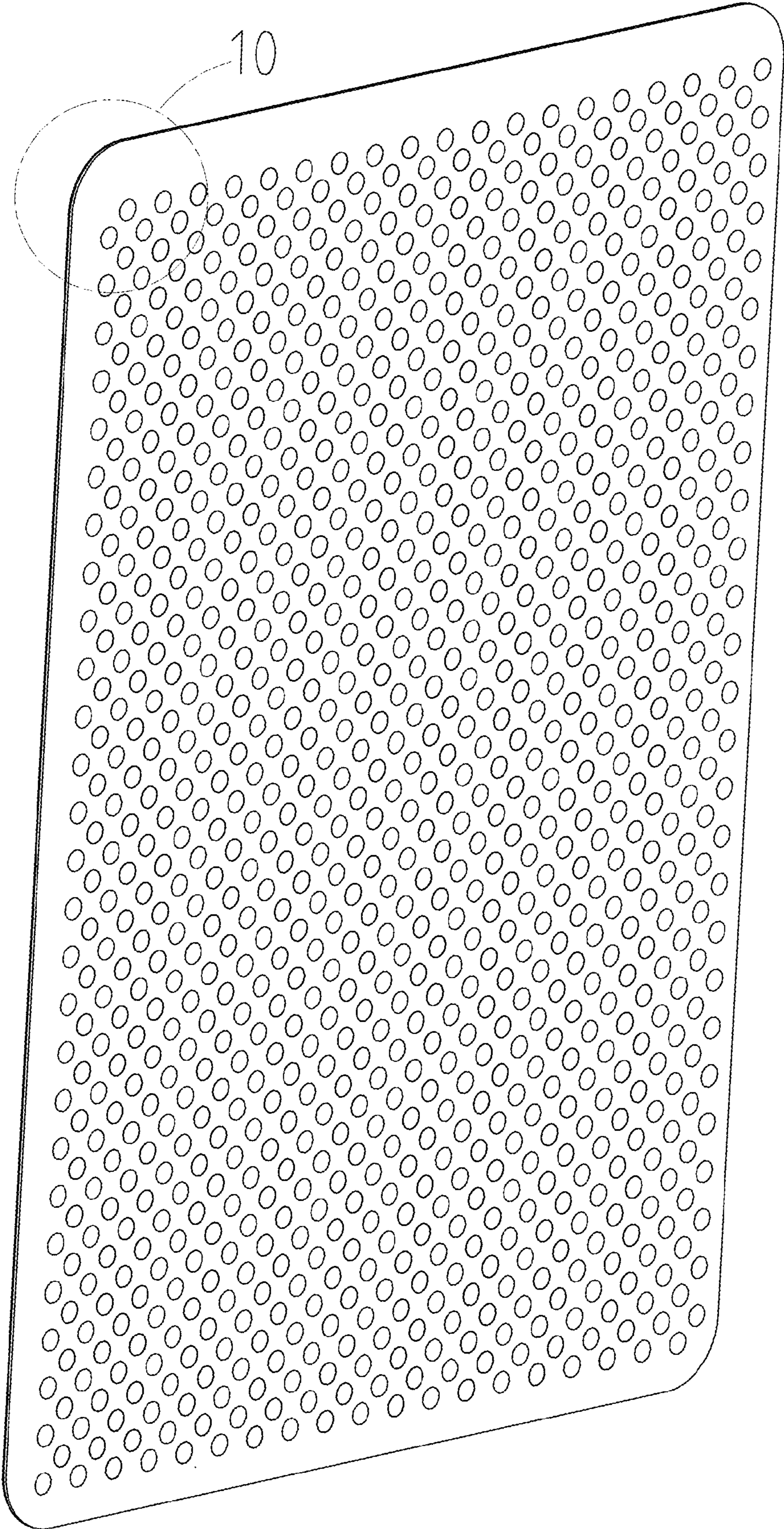

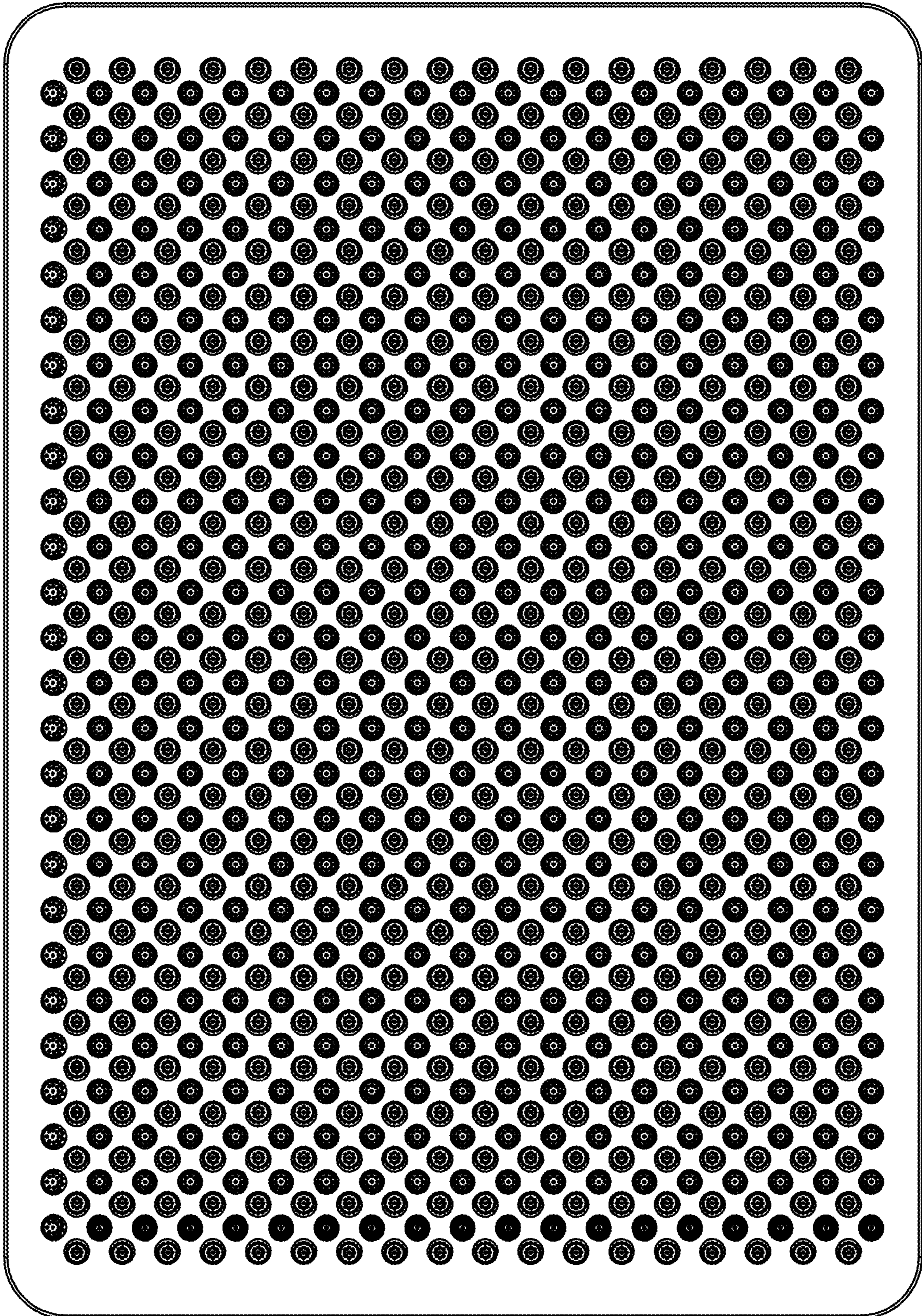

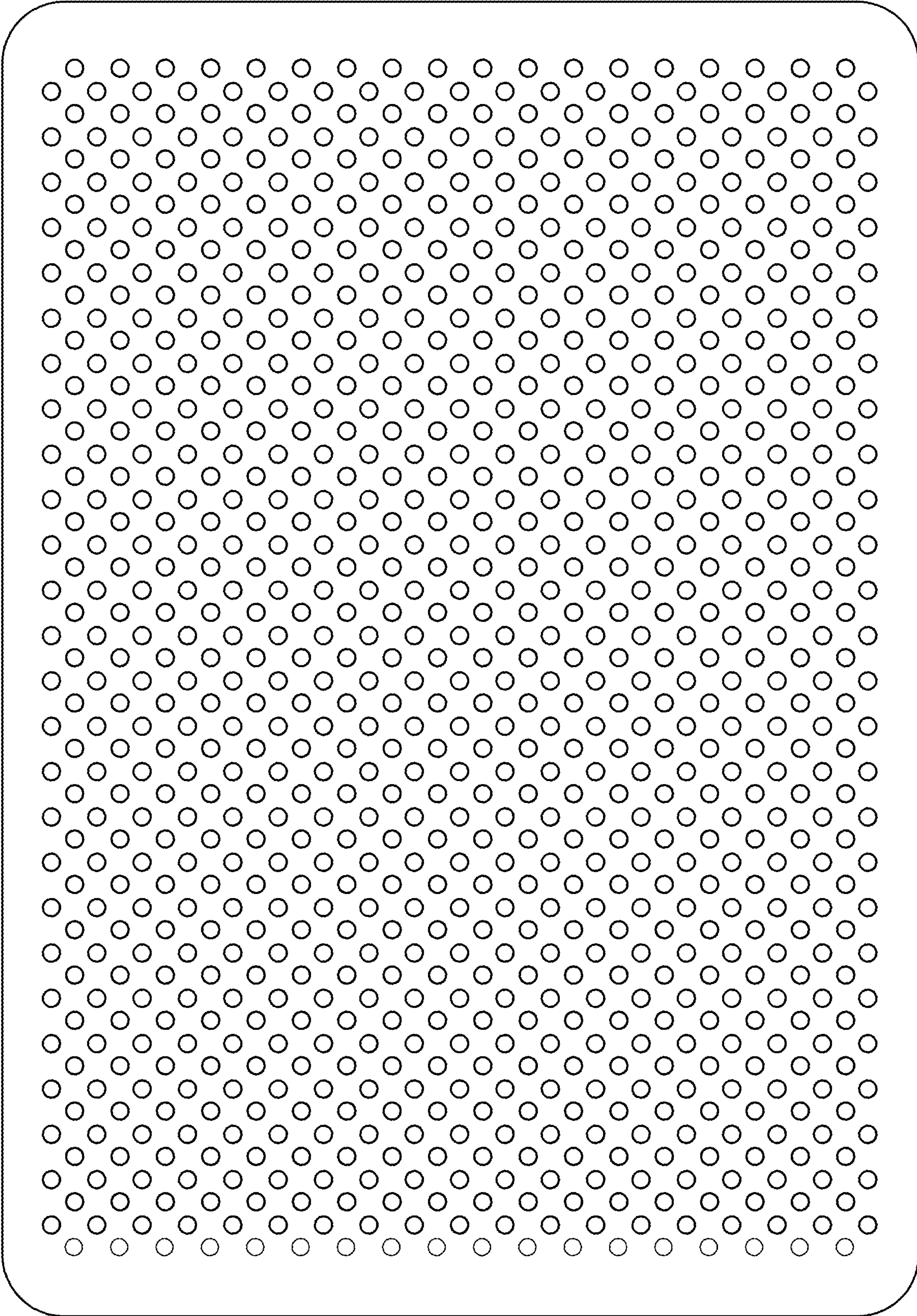

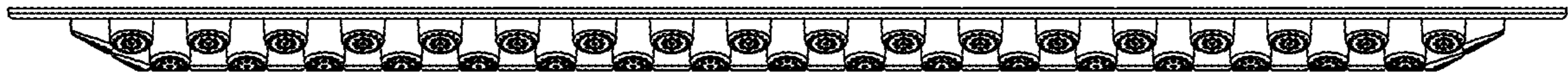

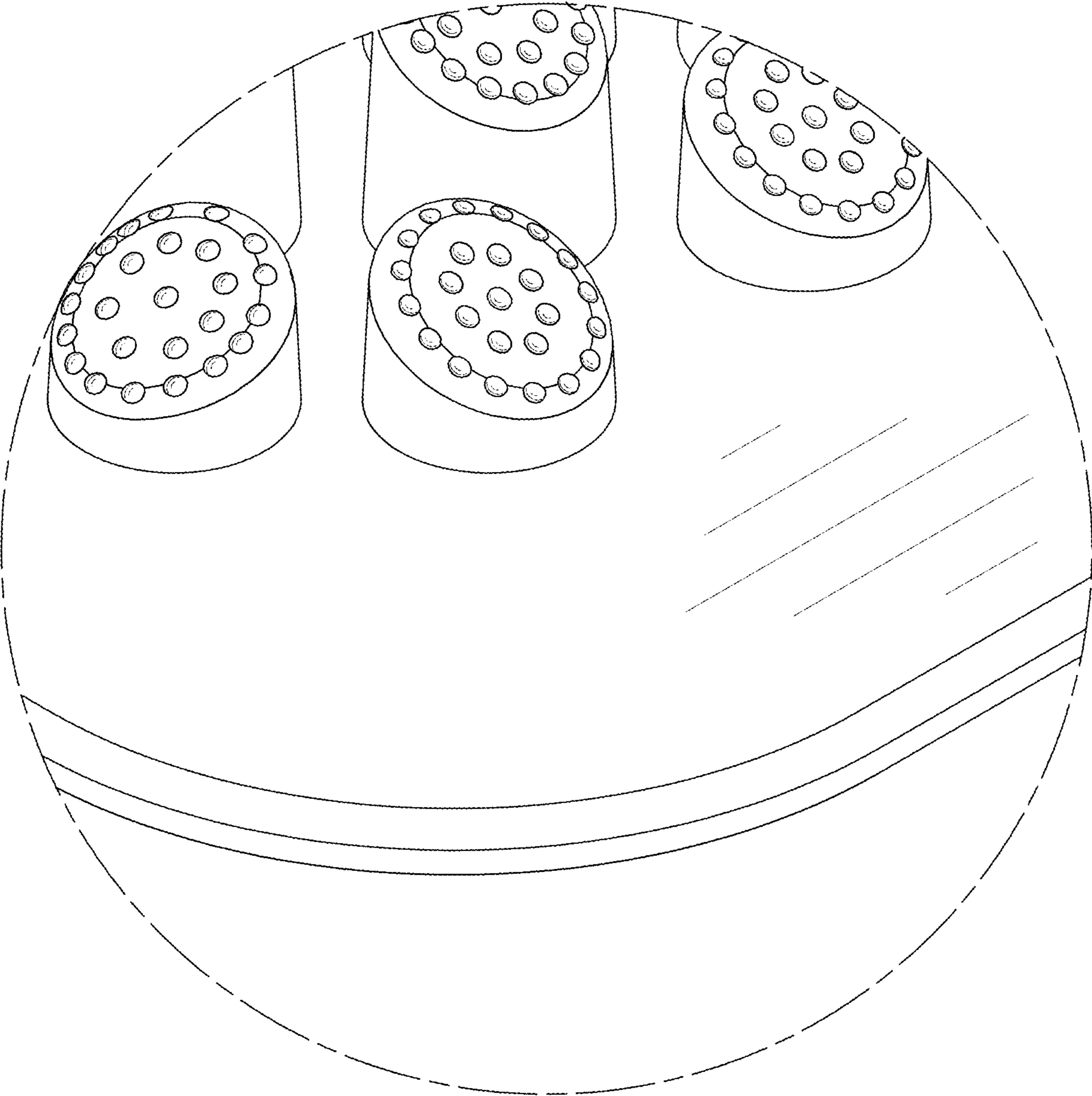

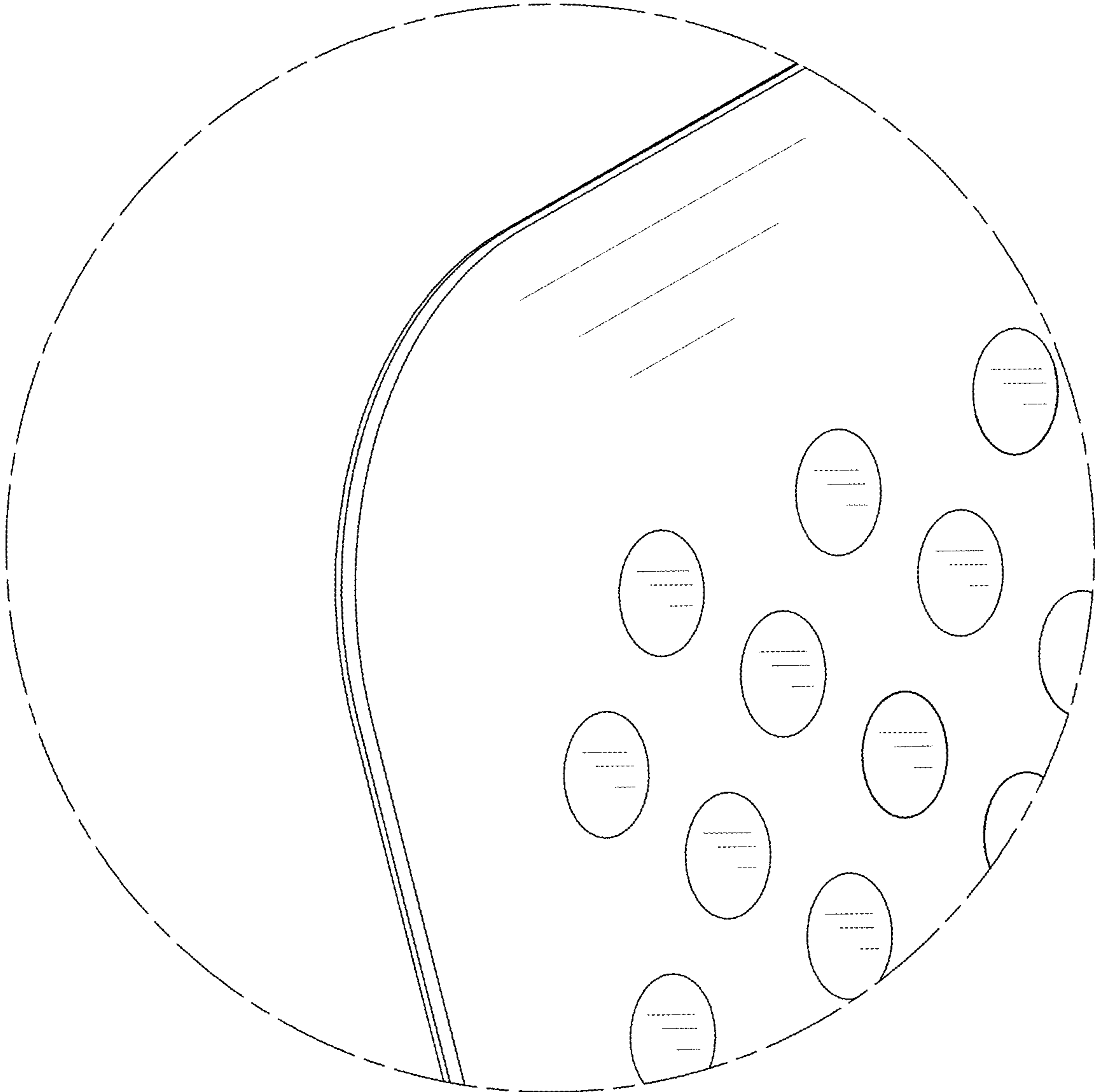
