DESCRIPTION

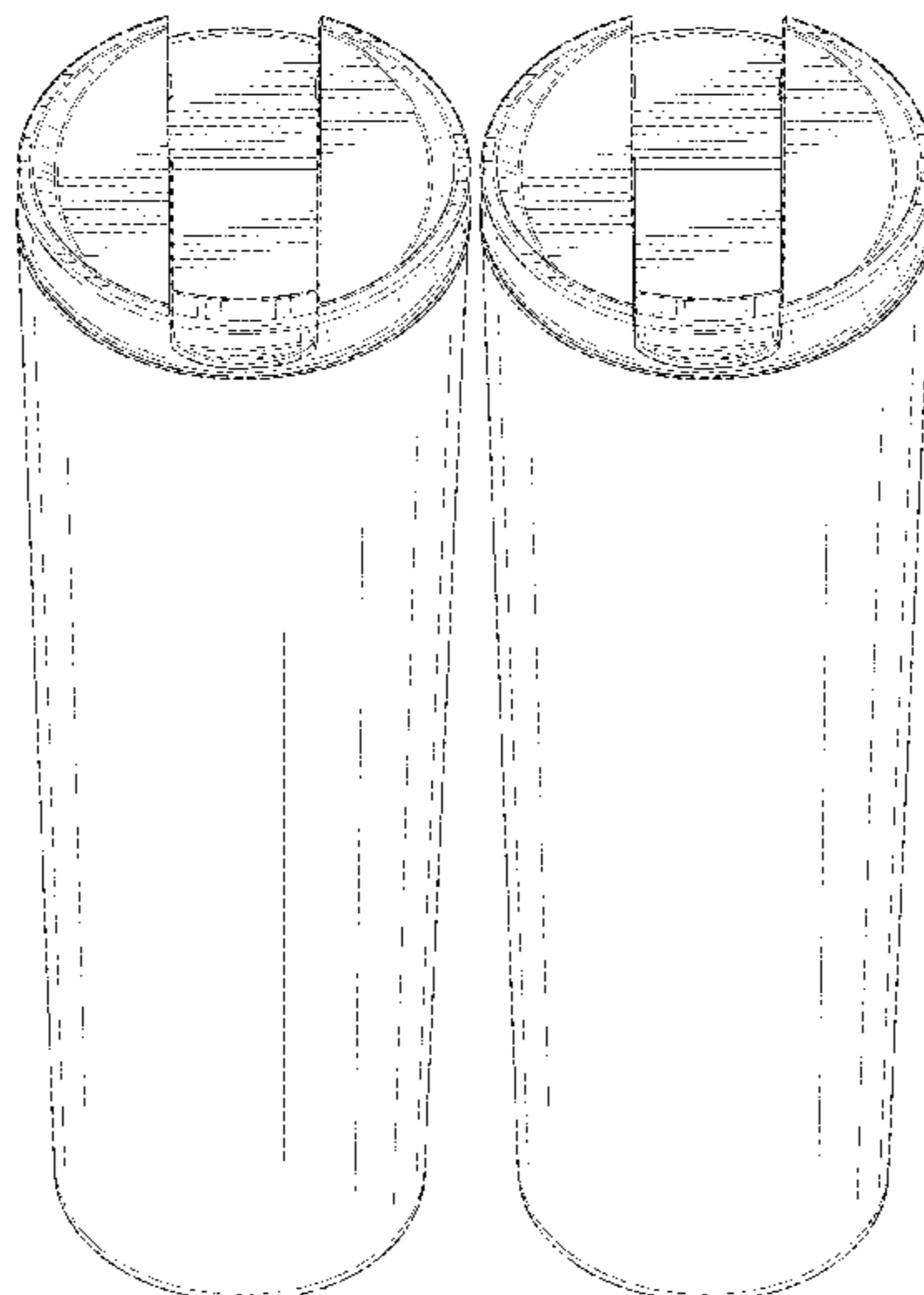
FIG. 1 is a top, perspective view showing a first embodiment of my new design for a tumbler.

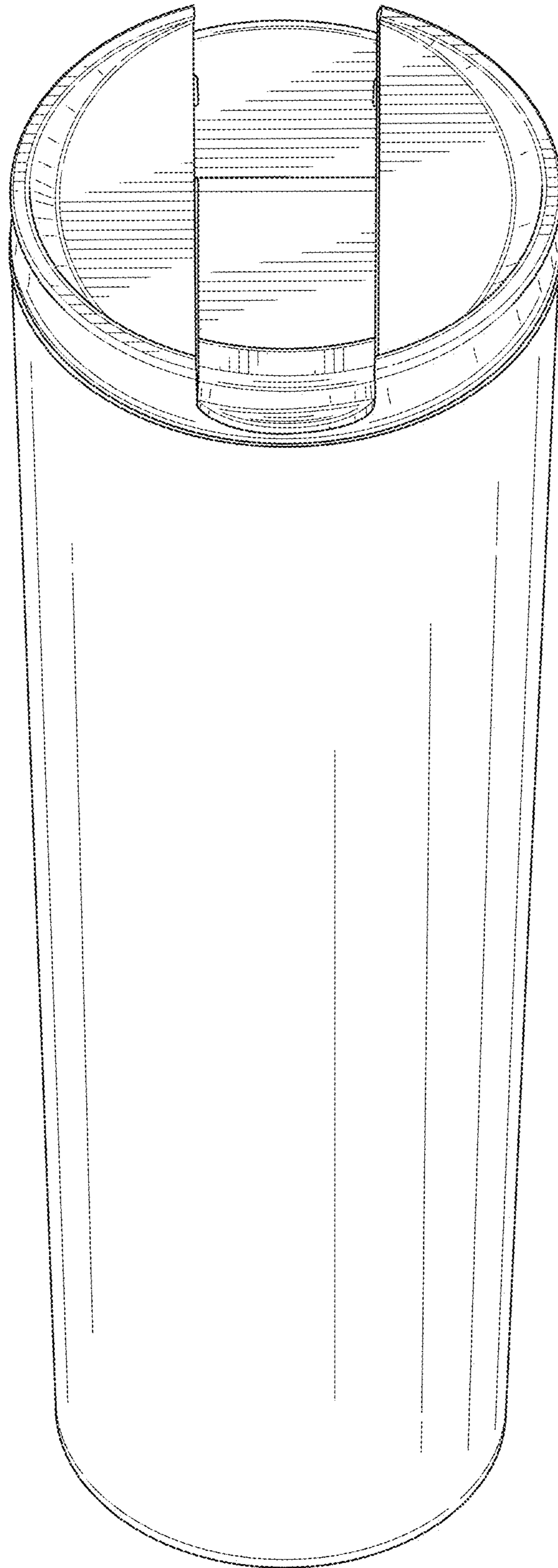

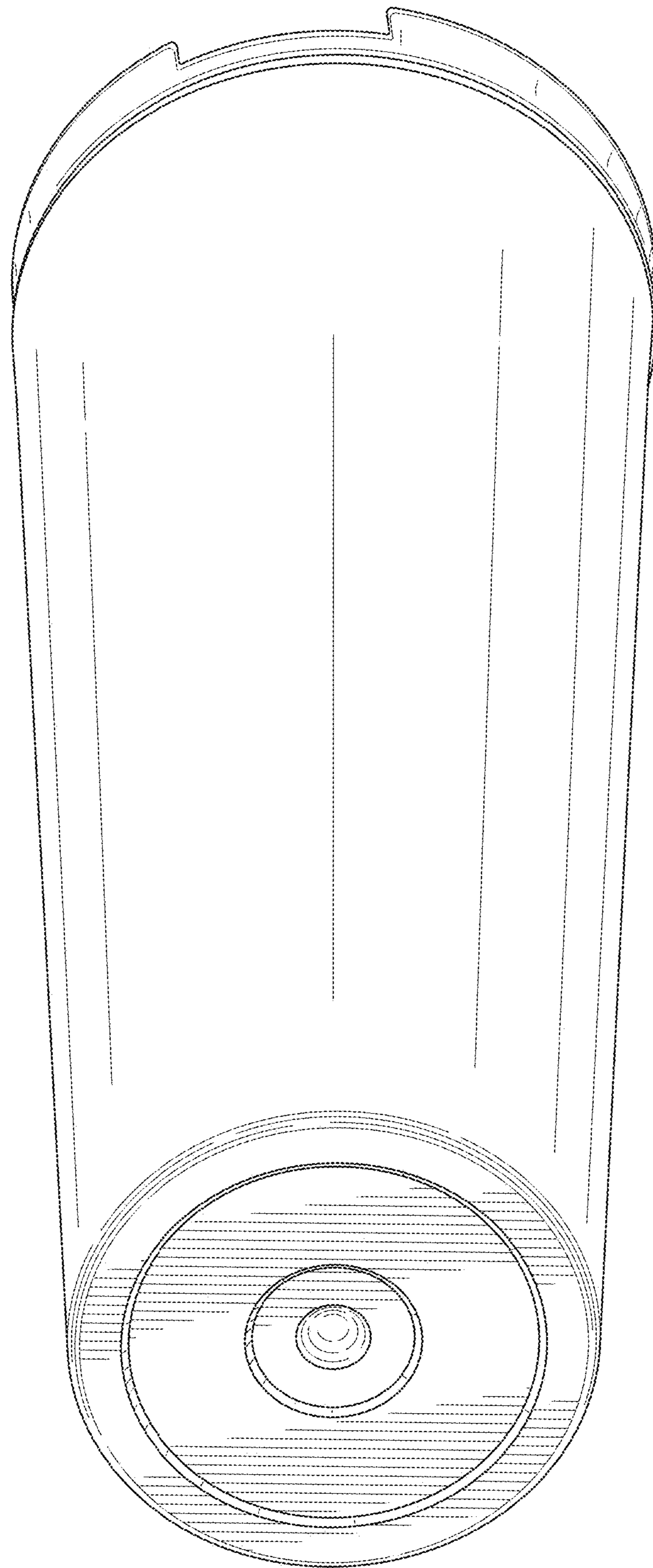

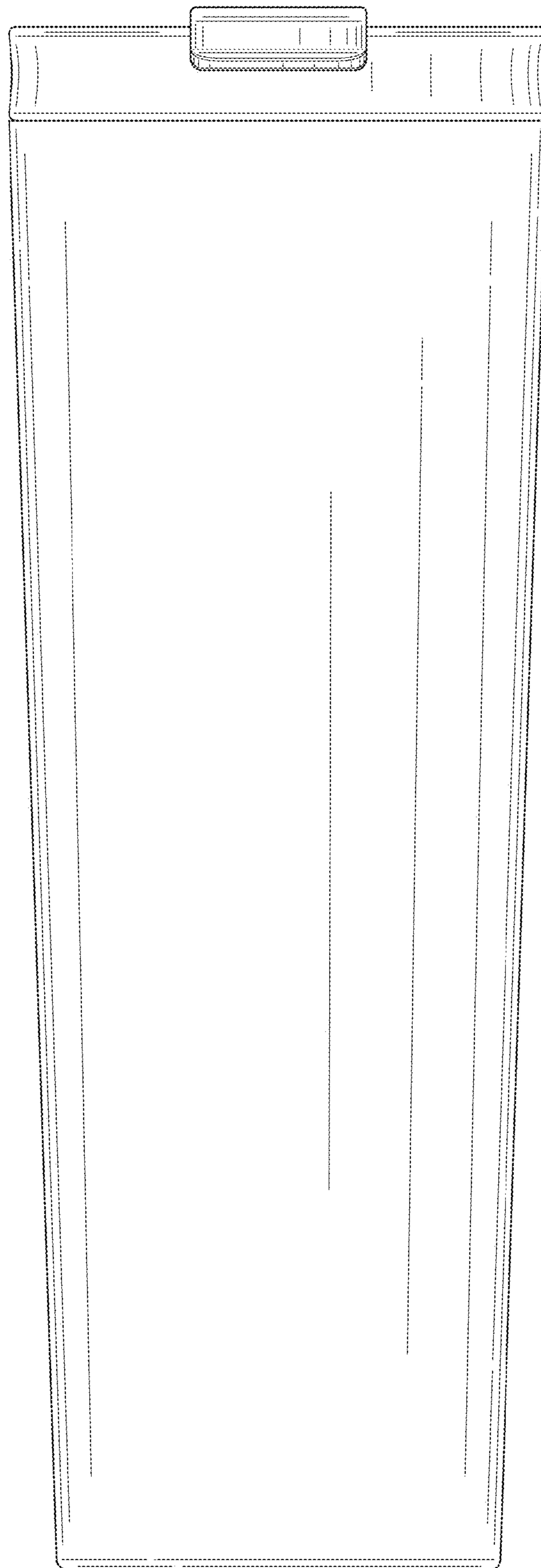

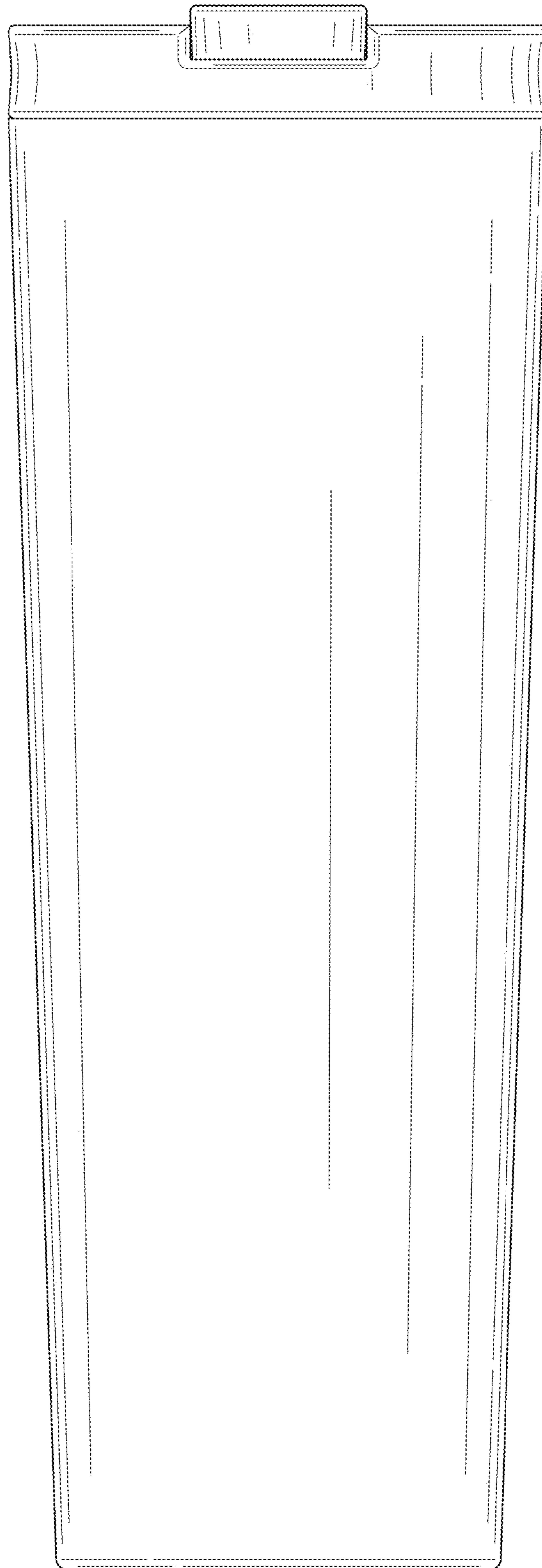

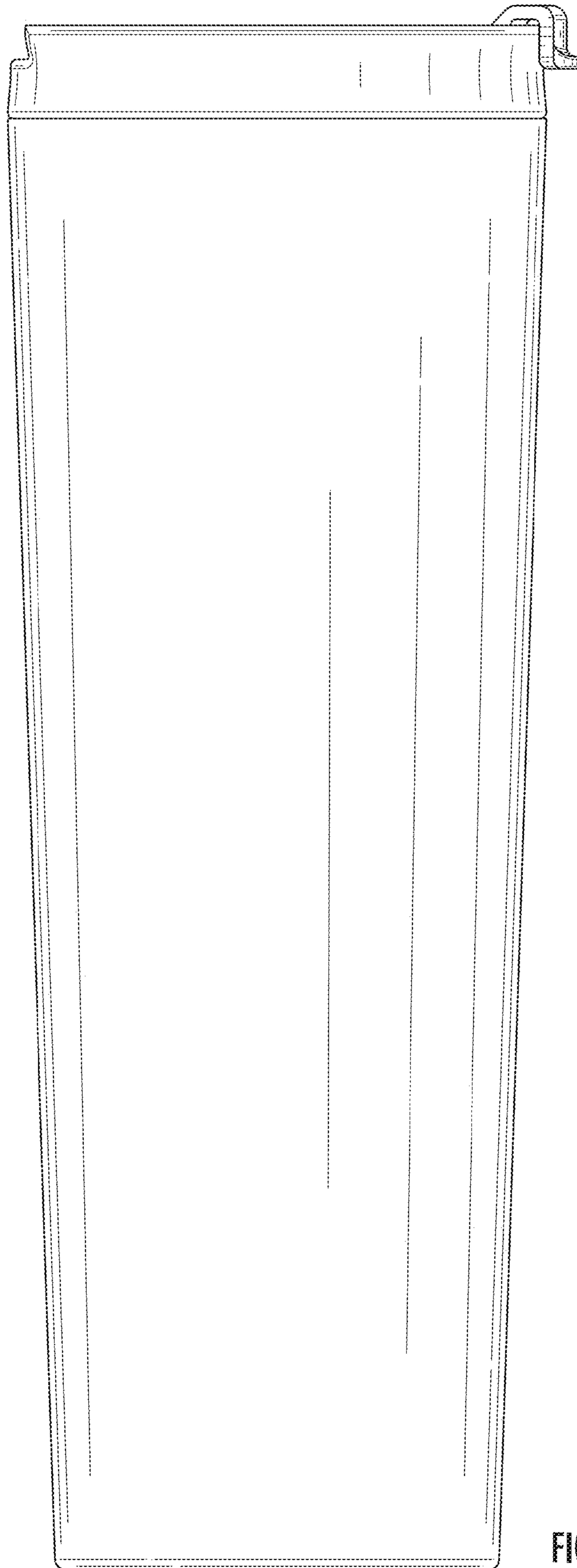

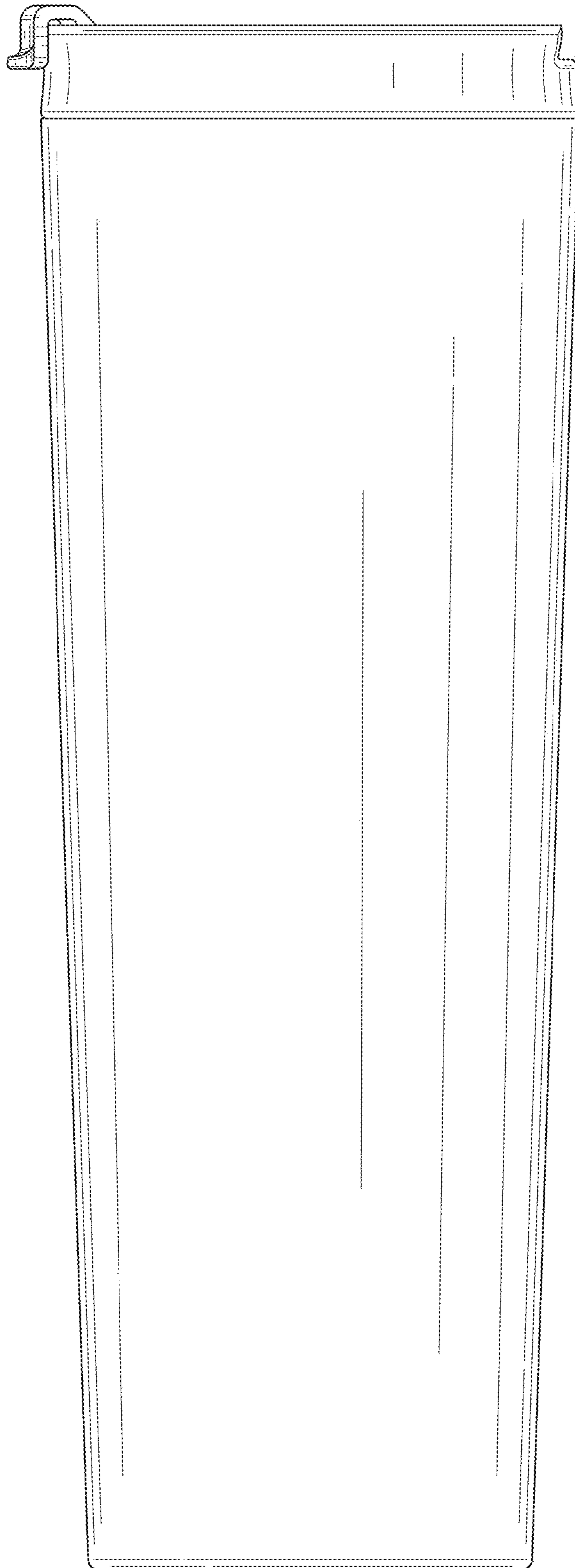

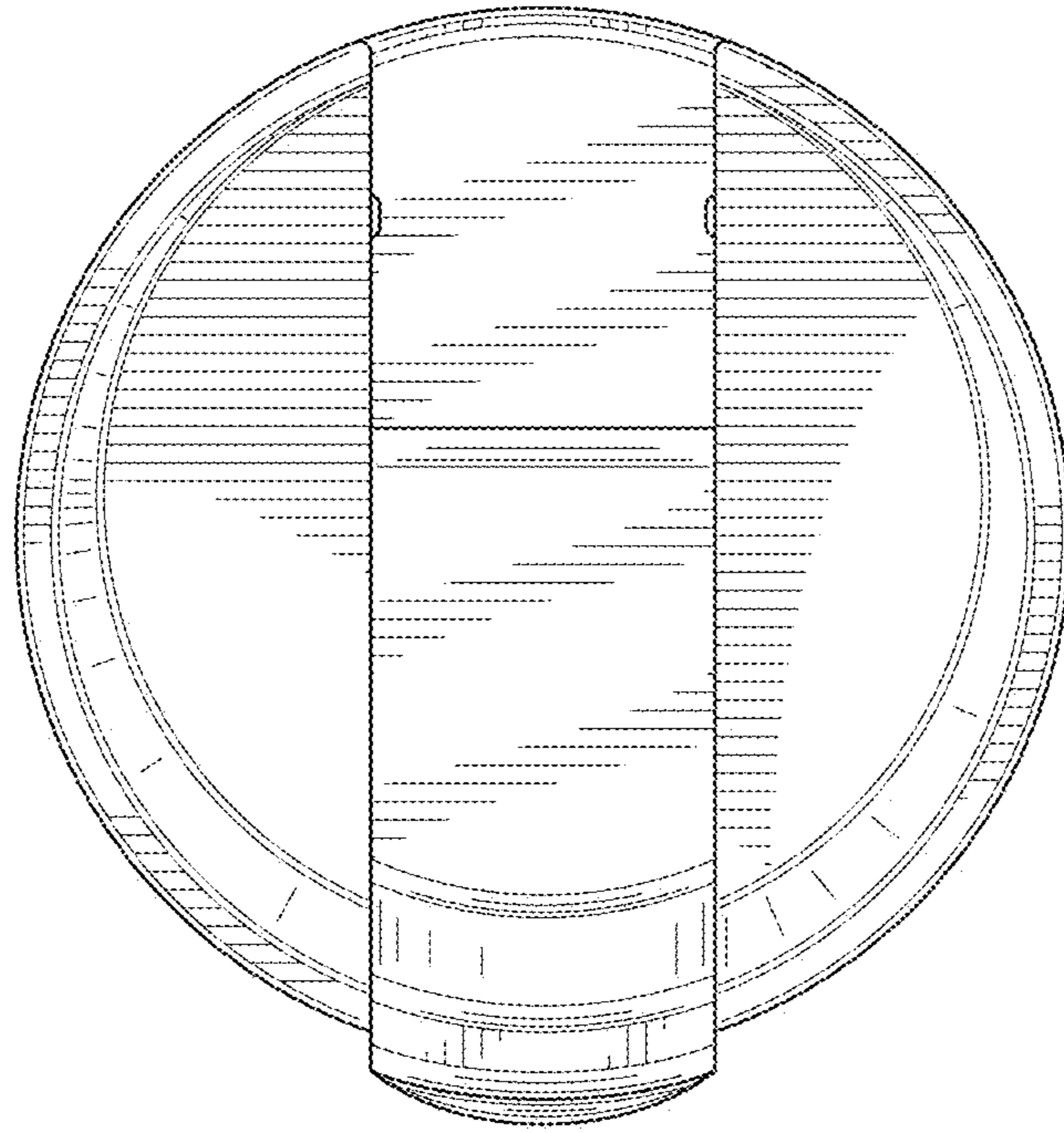

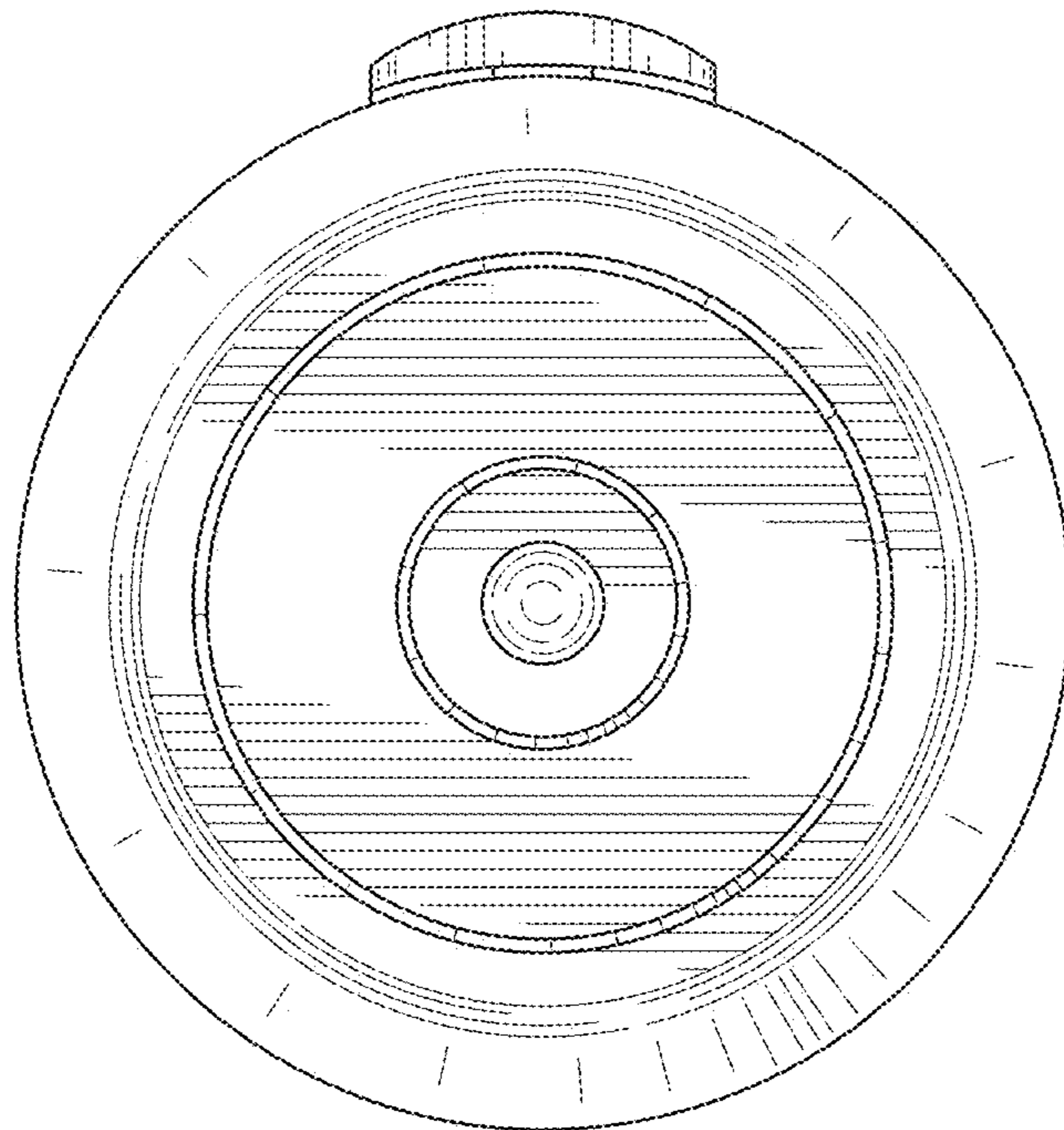

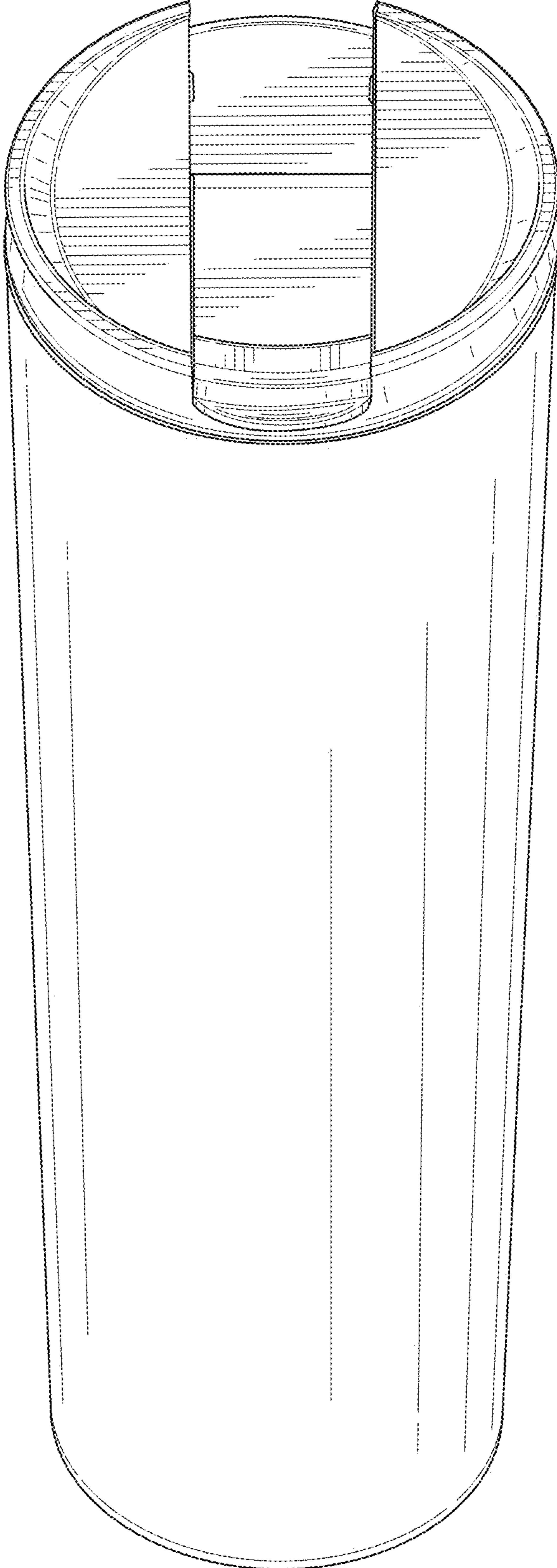

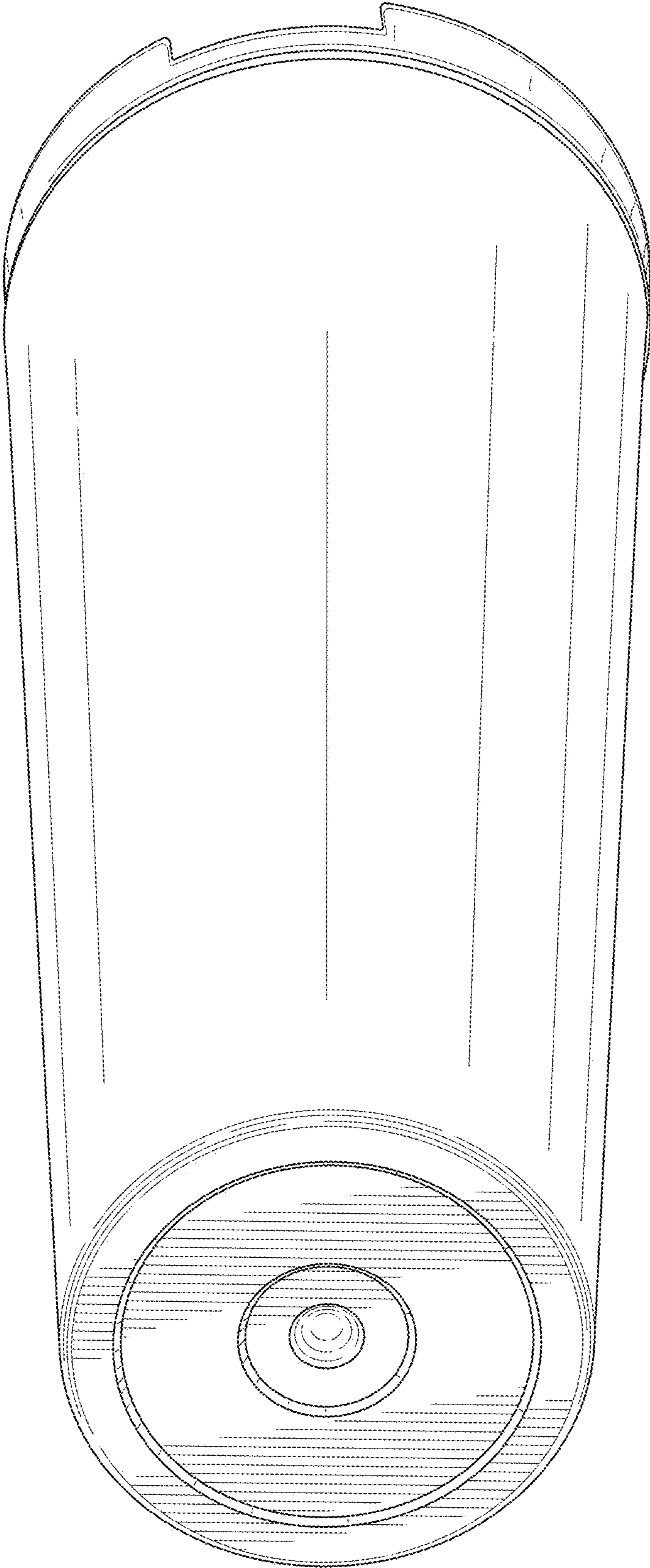

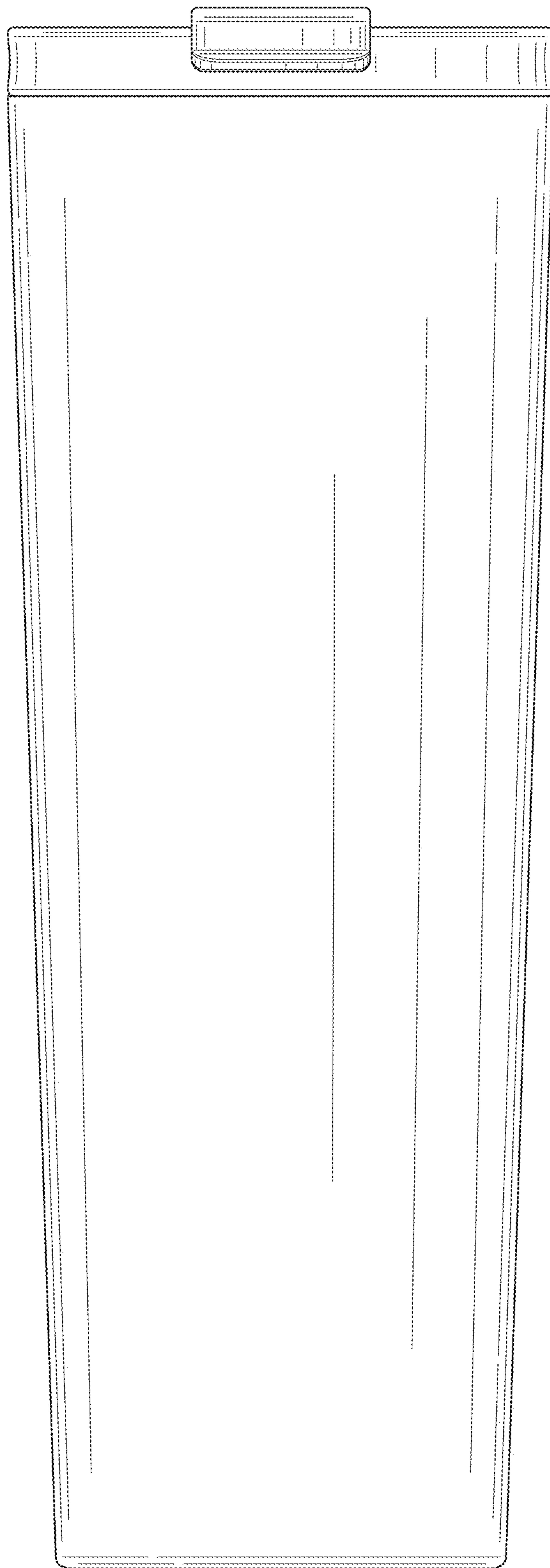

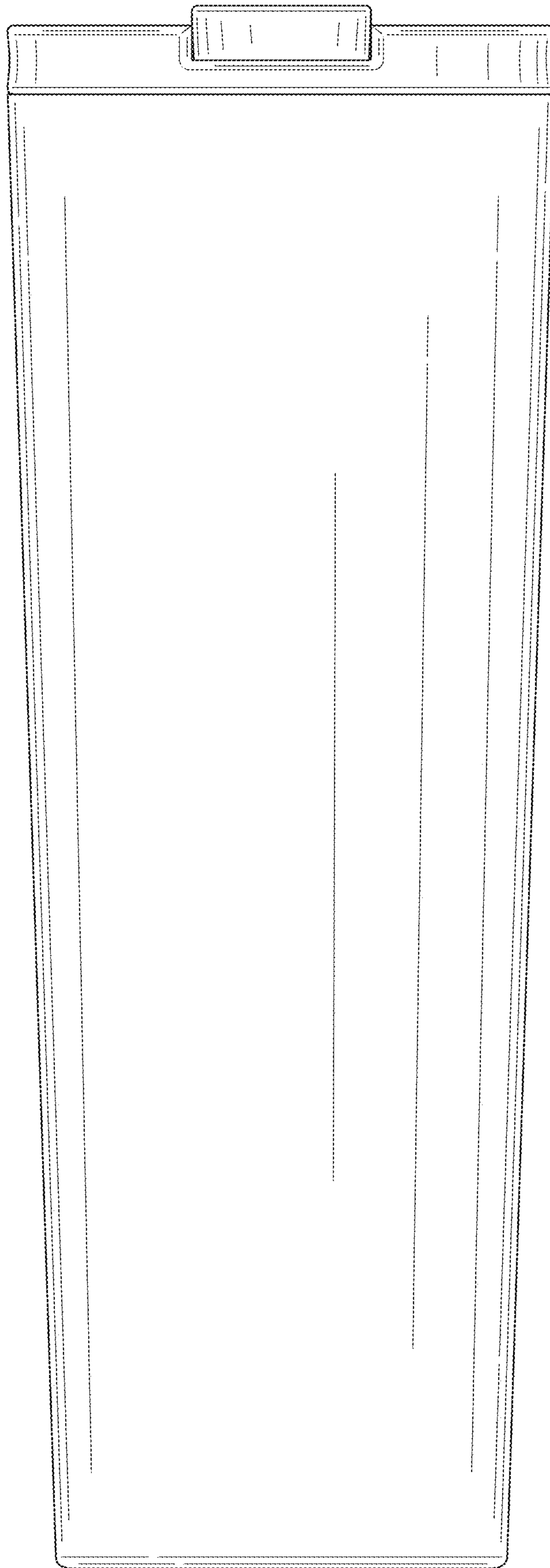

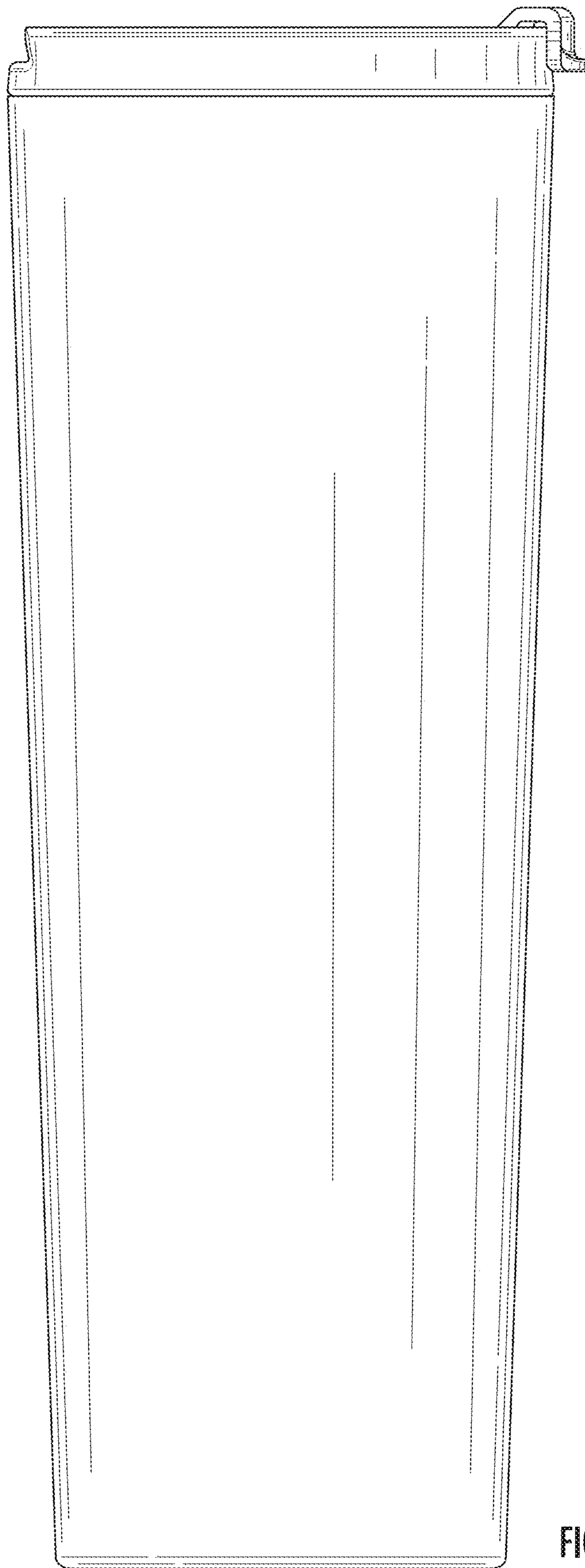

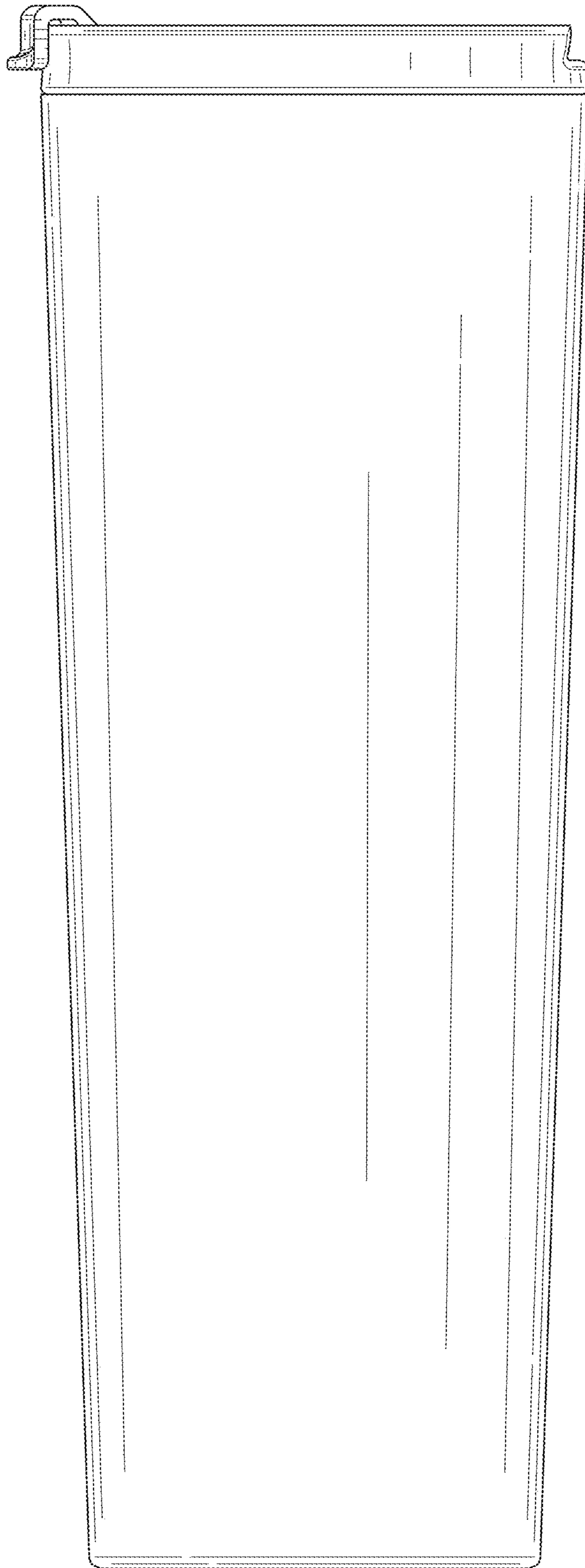

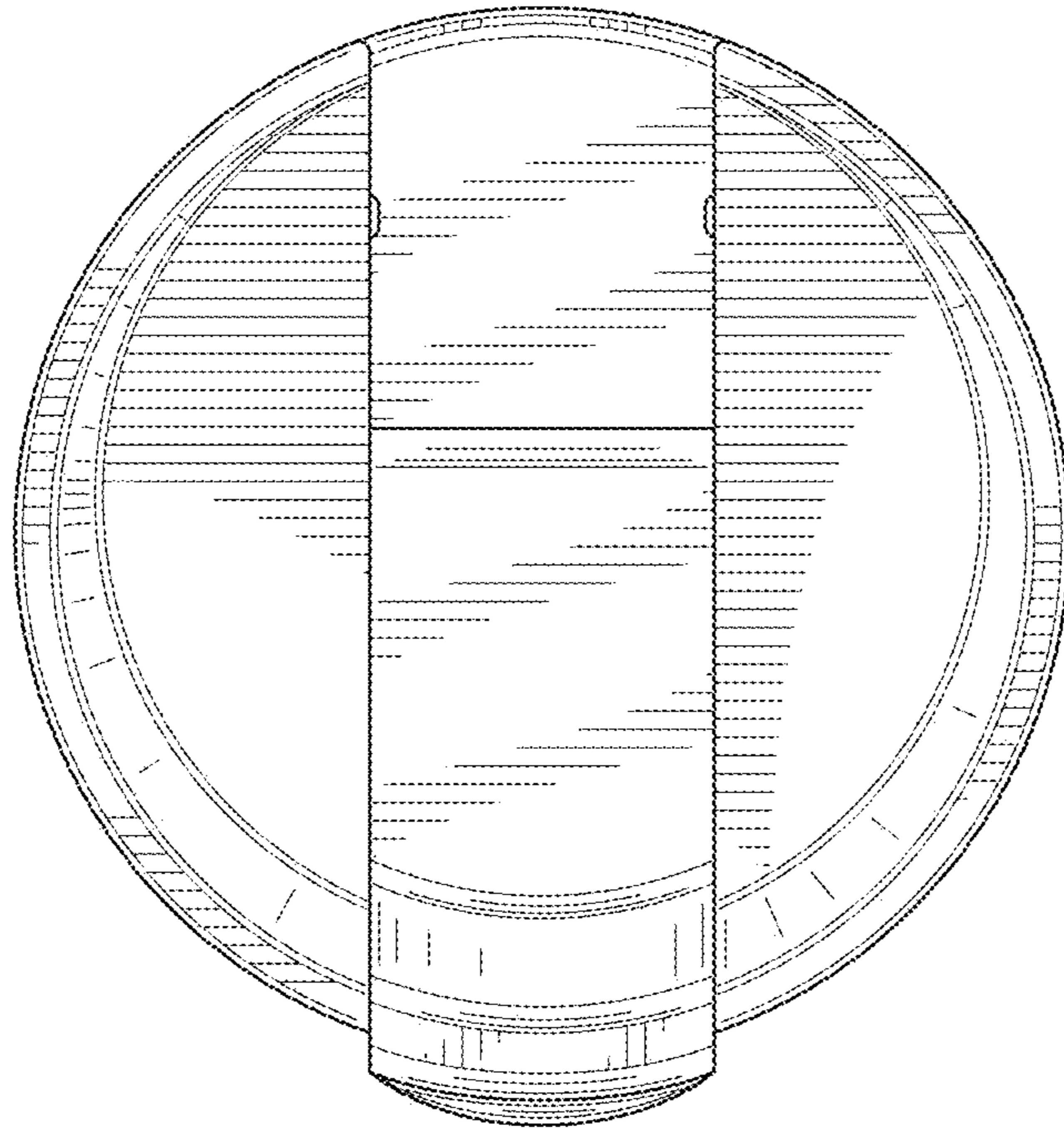

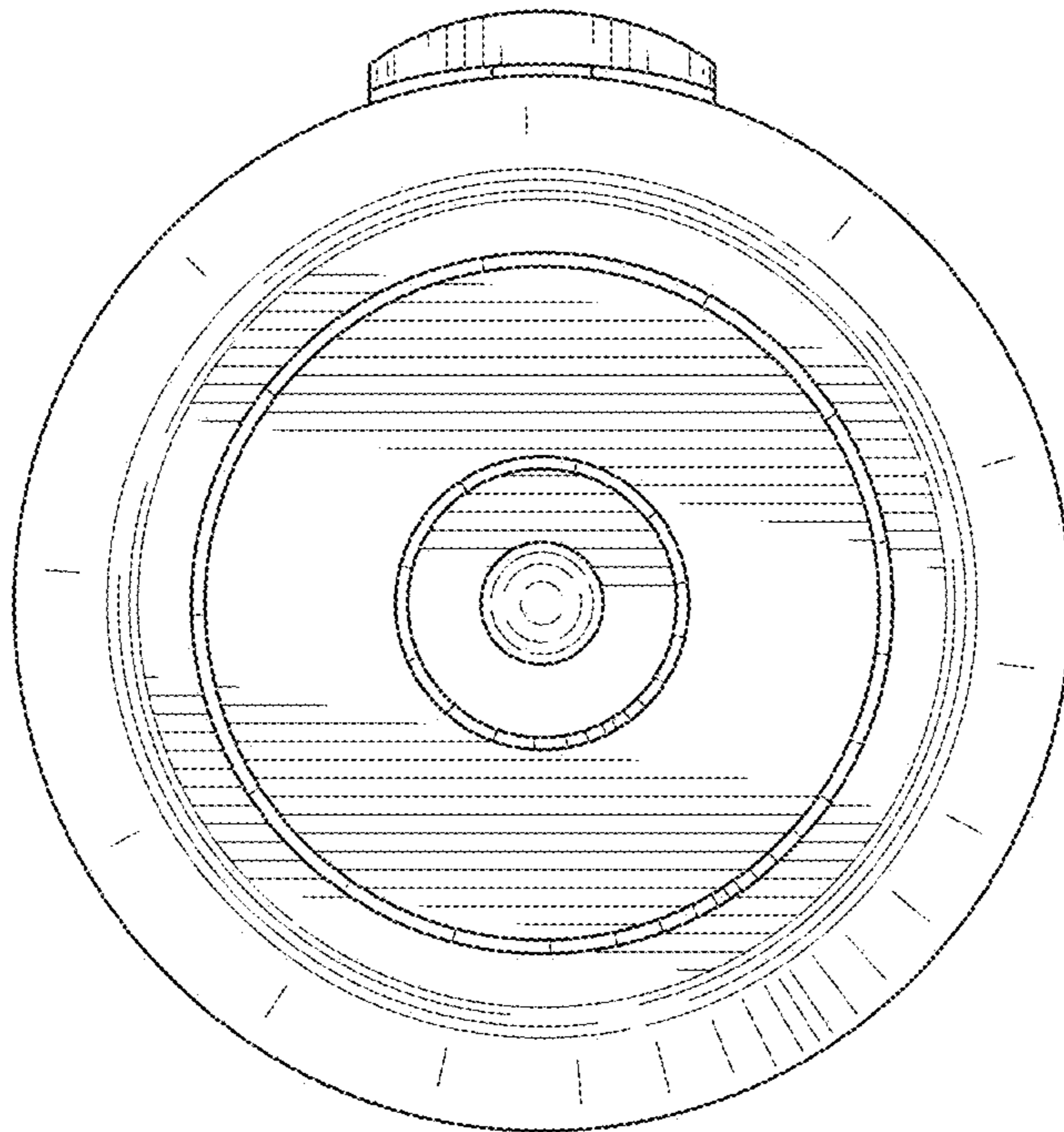
