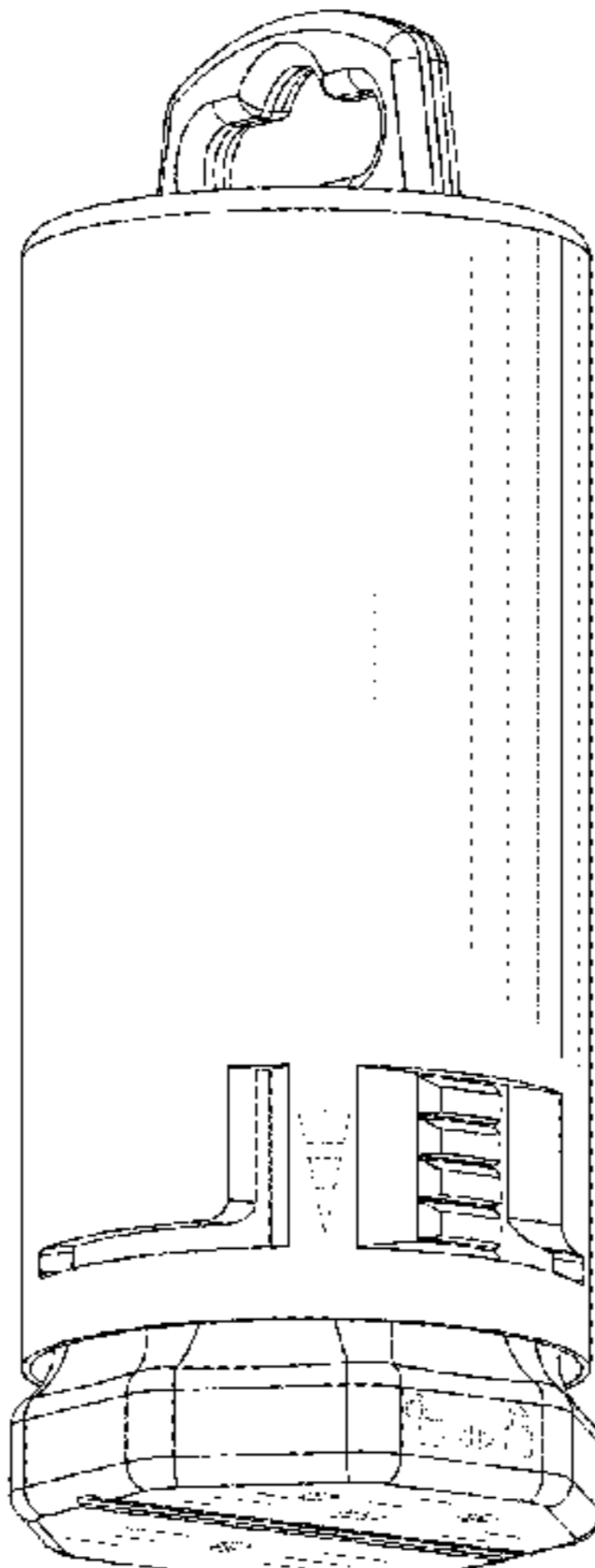
(57) **CLAIM**

We claim the ornamental design for a twist and lock telescoping package, as substantially shown and described.

**DESCRIPTION**

FIG. 1 is perspective view of a twist and lock telescoping package shown my new design;  
FIG. 2 is a front elevation view thereof;

FIG. 4 is a right-side elevation view thereof;

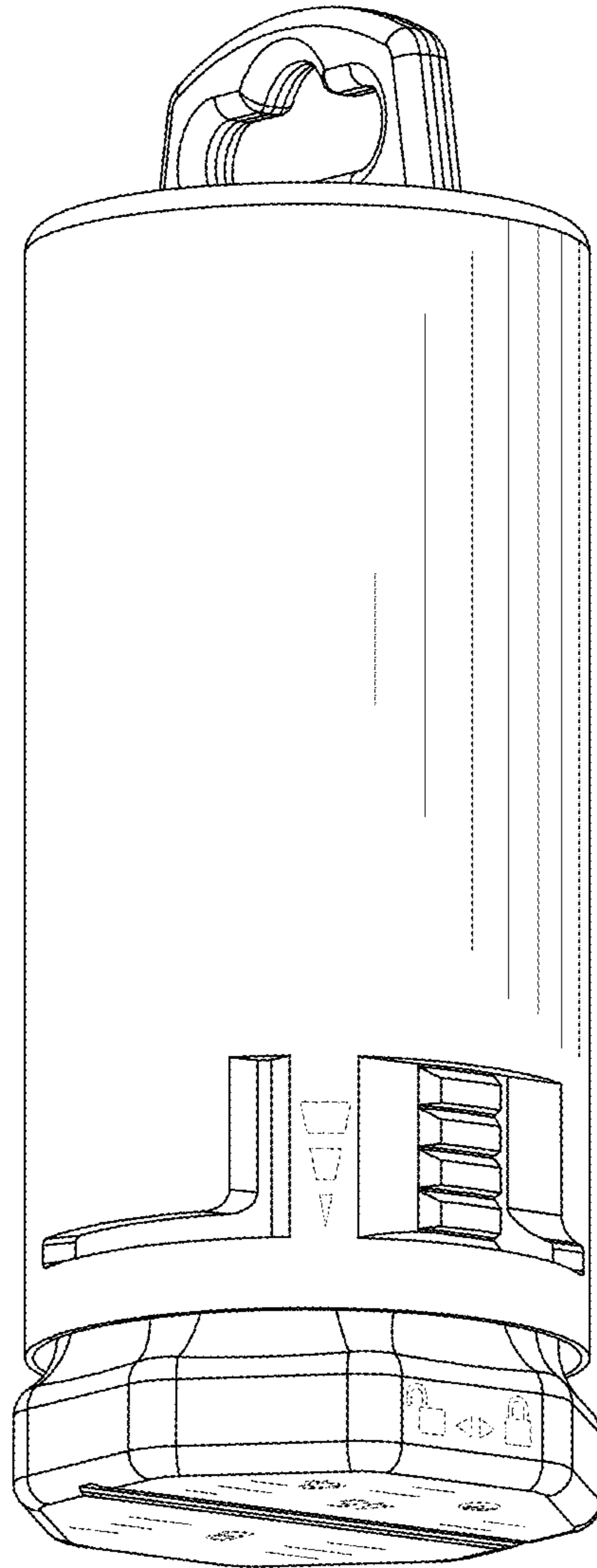

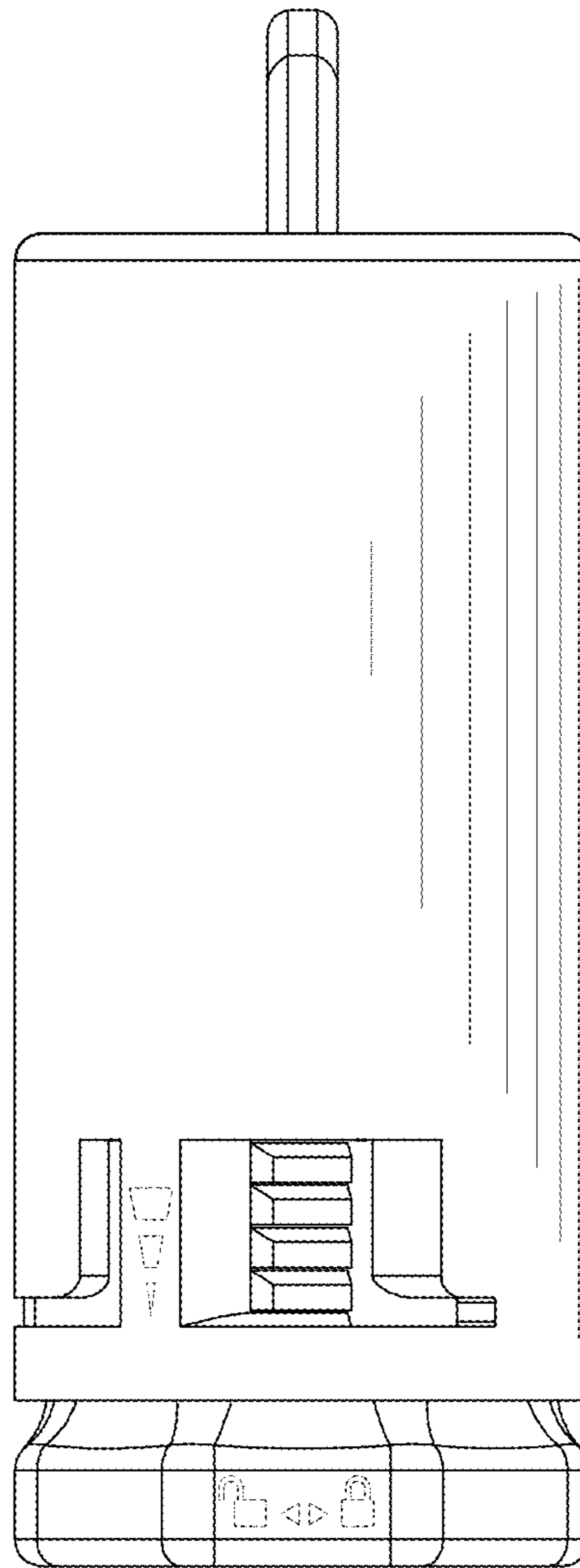

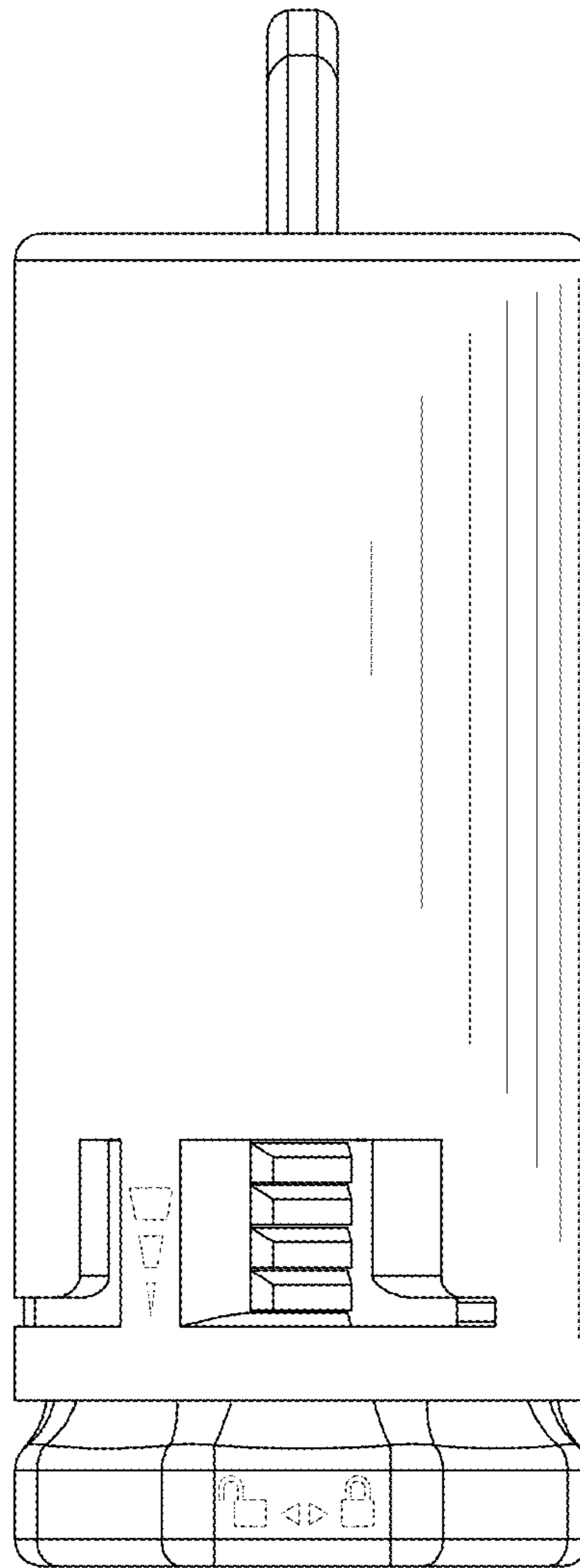

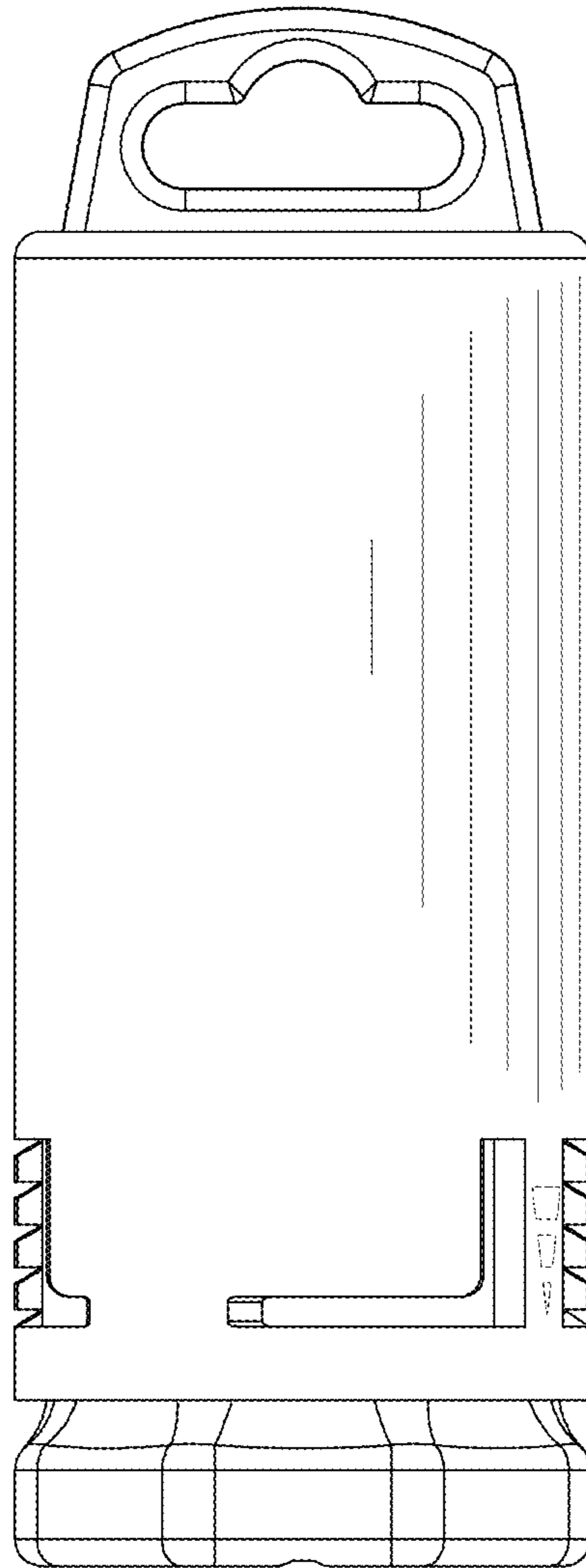

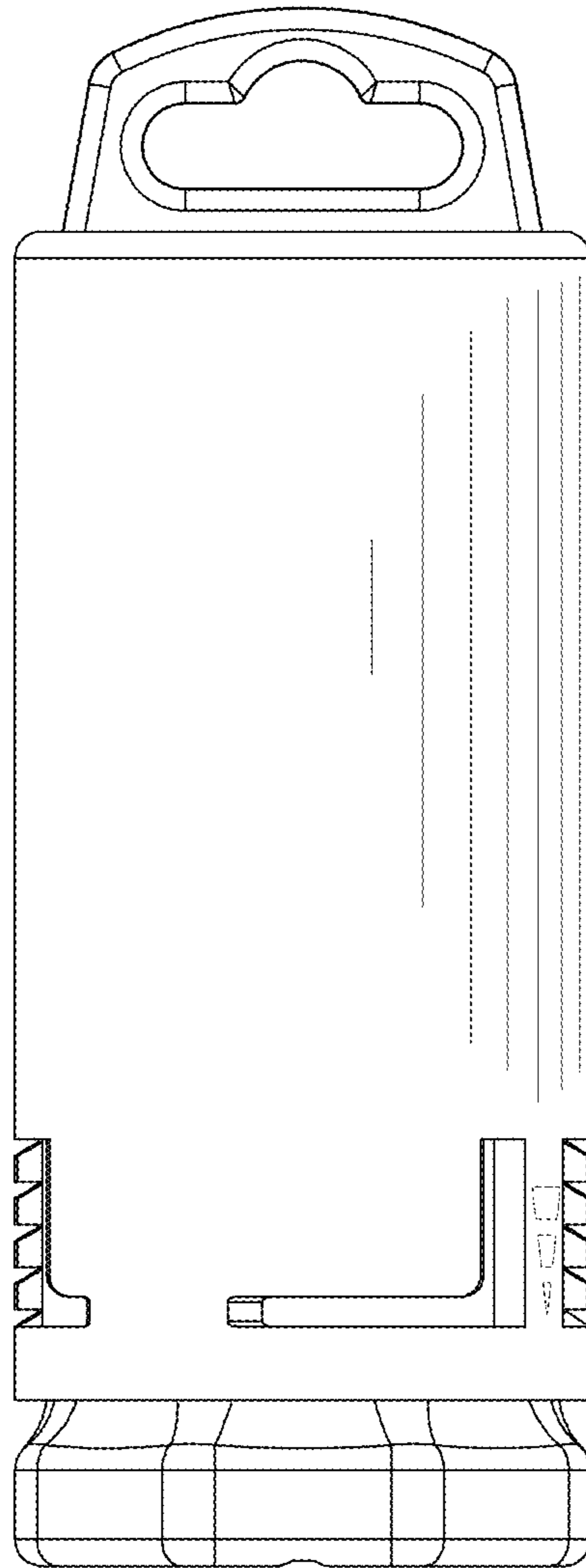

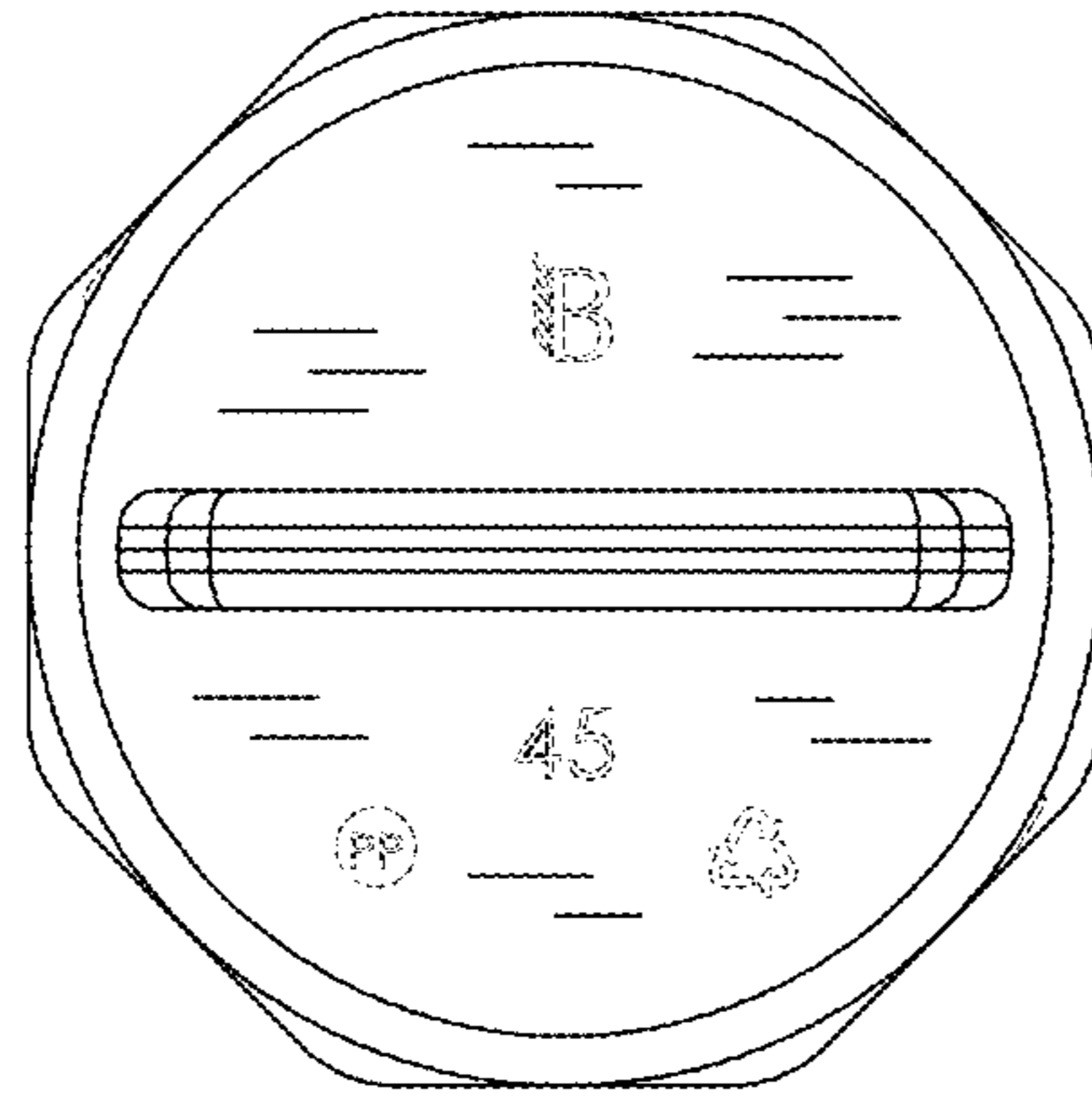

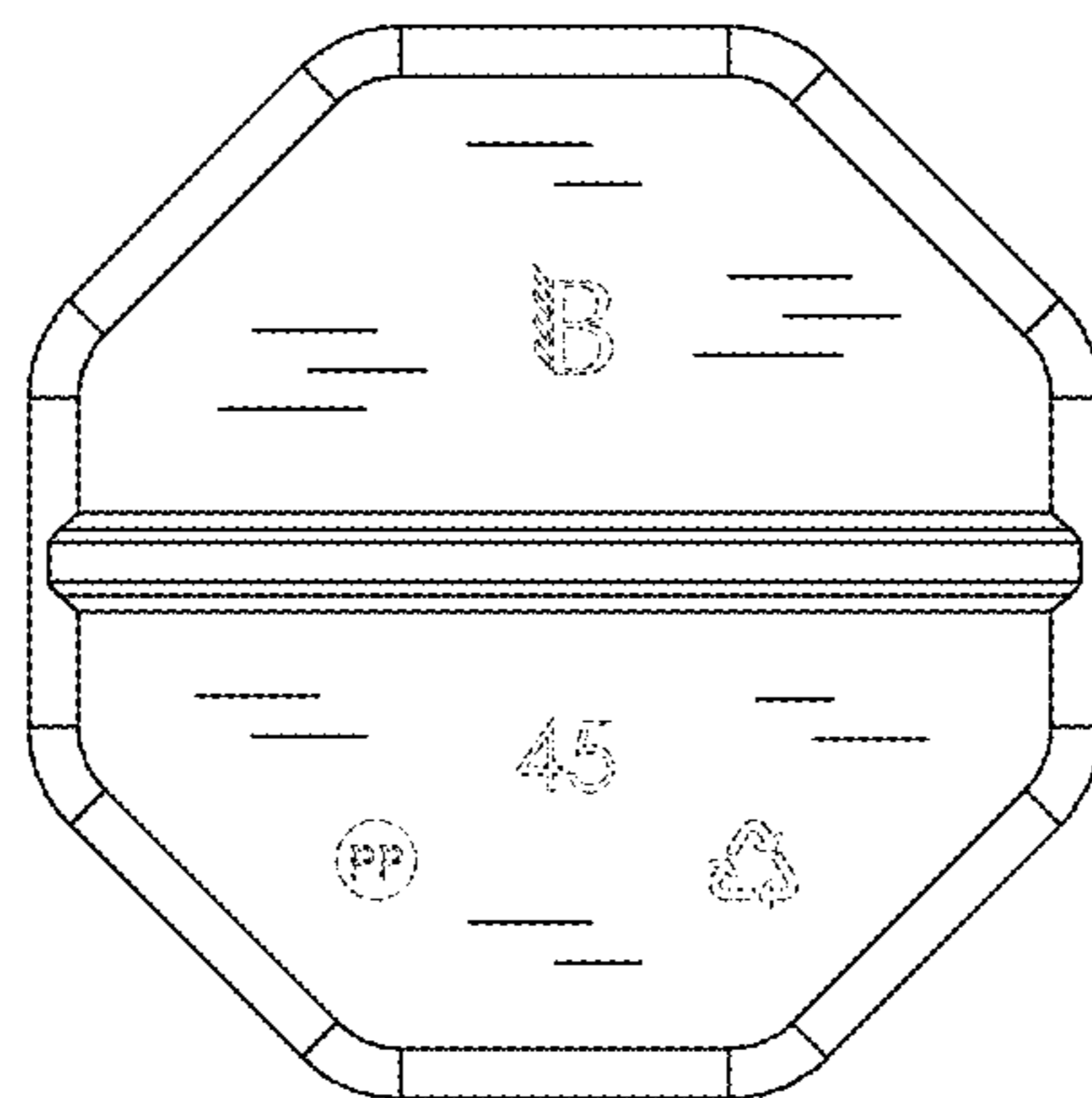

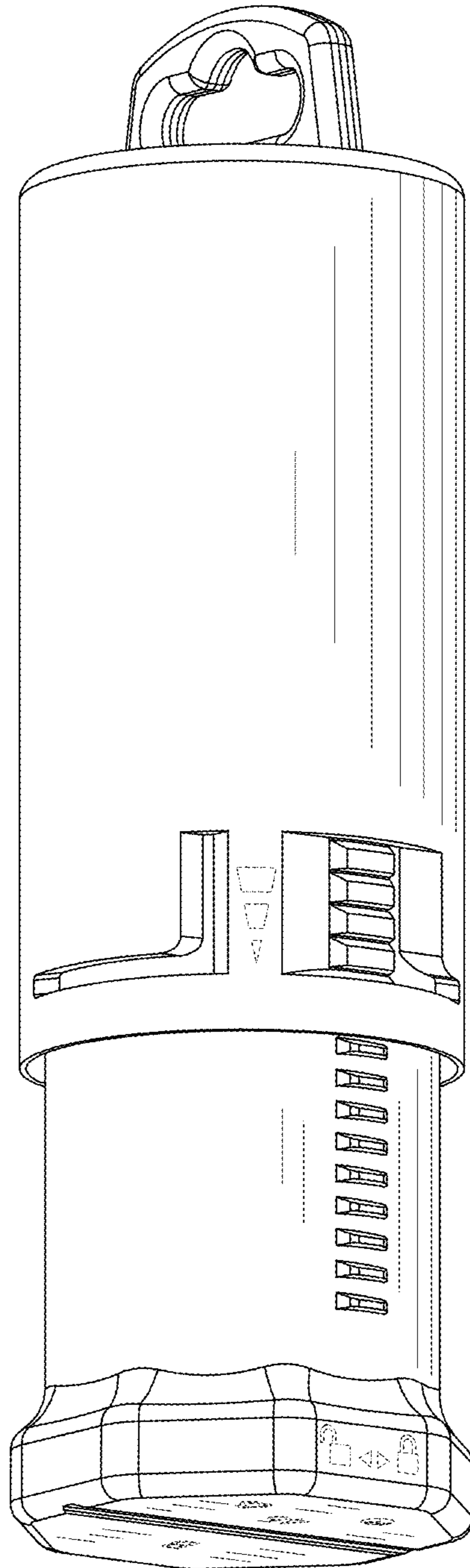

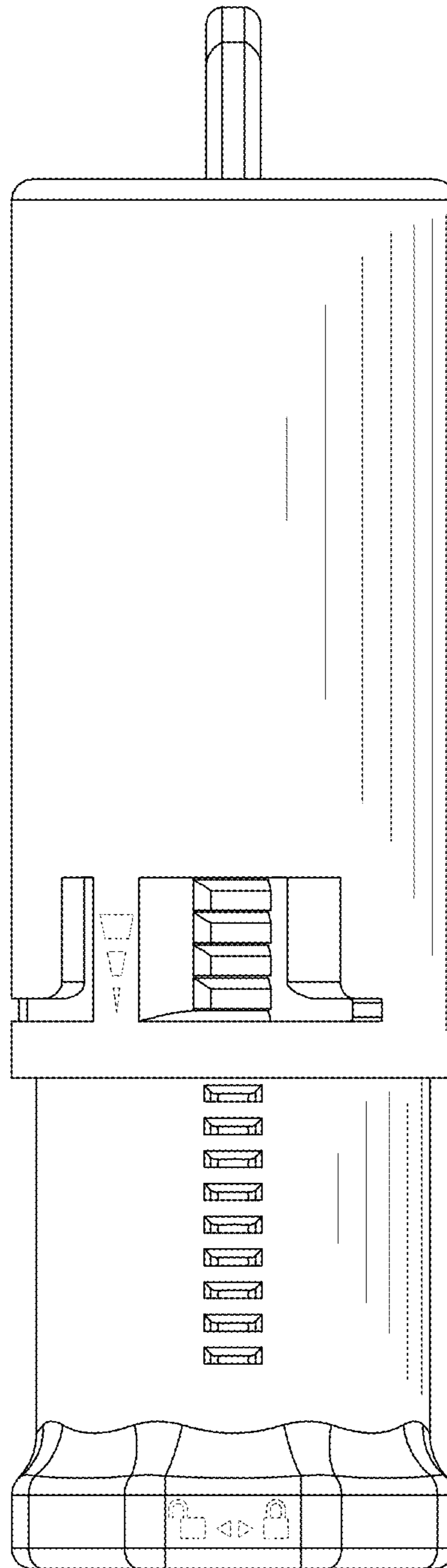

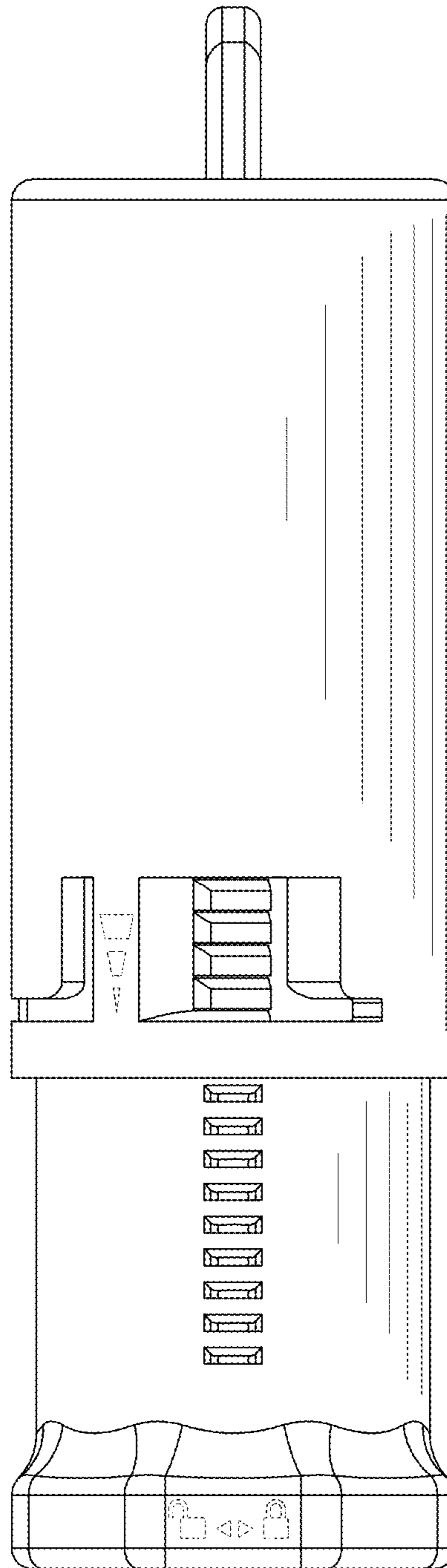

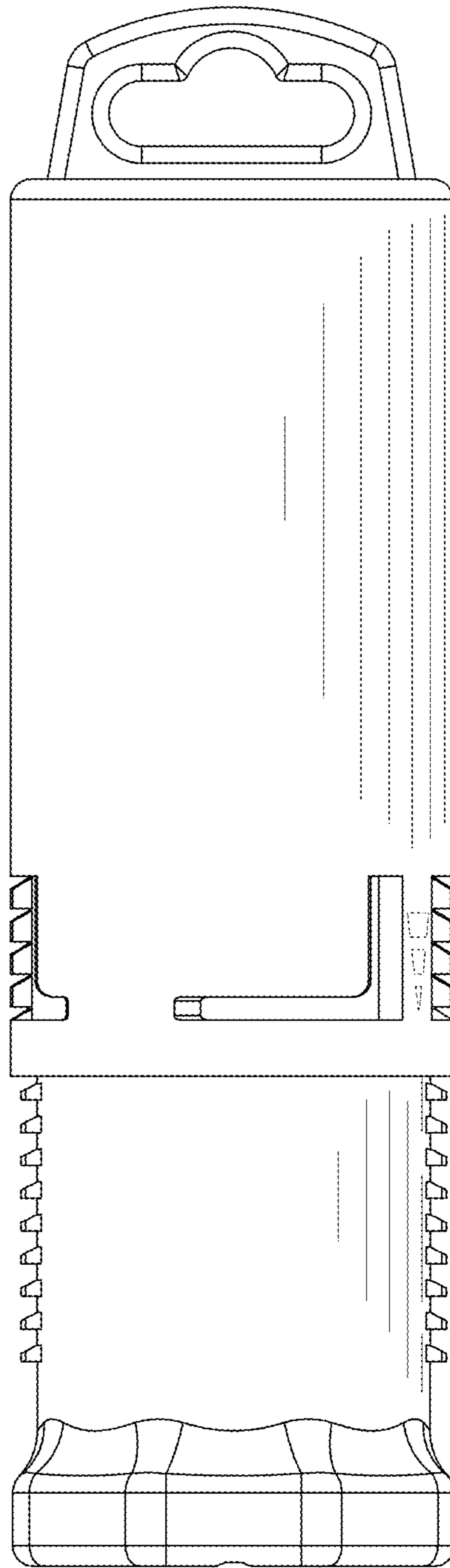

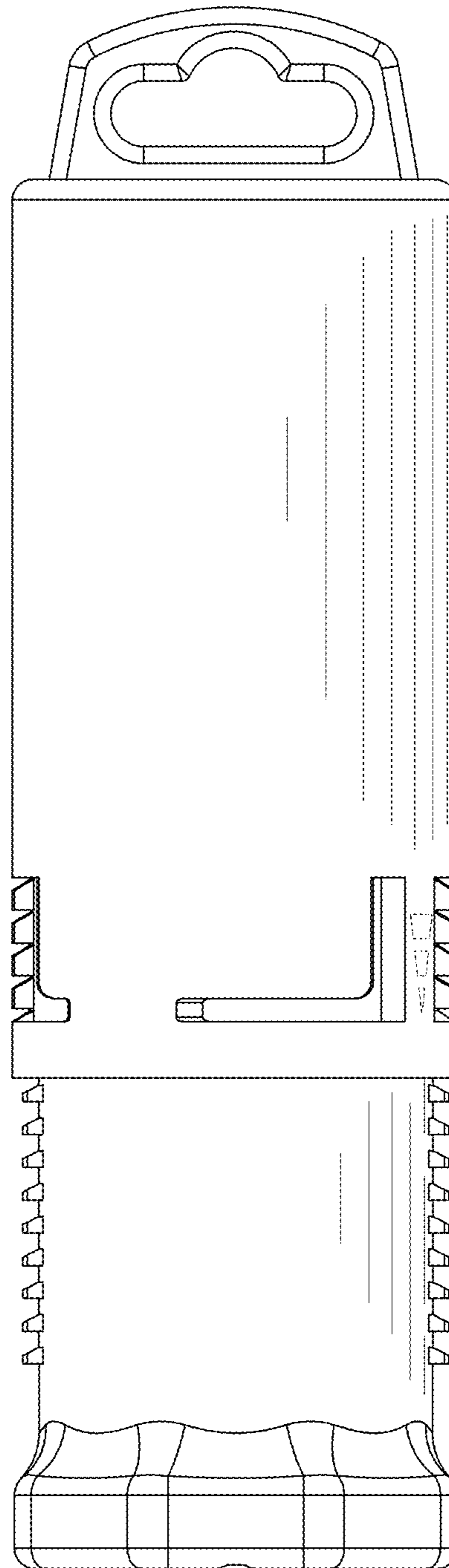

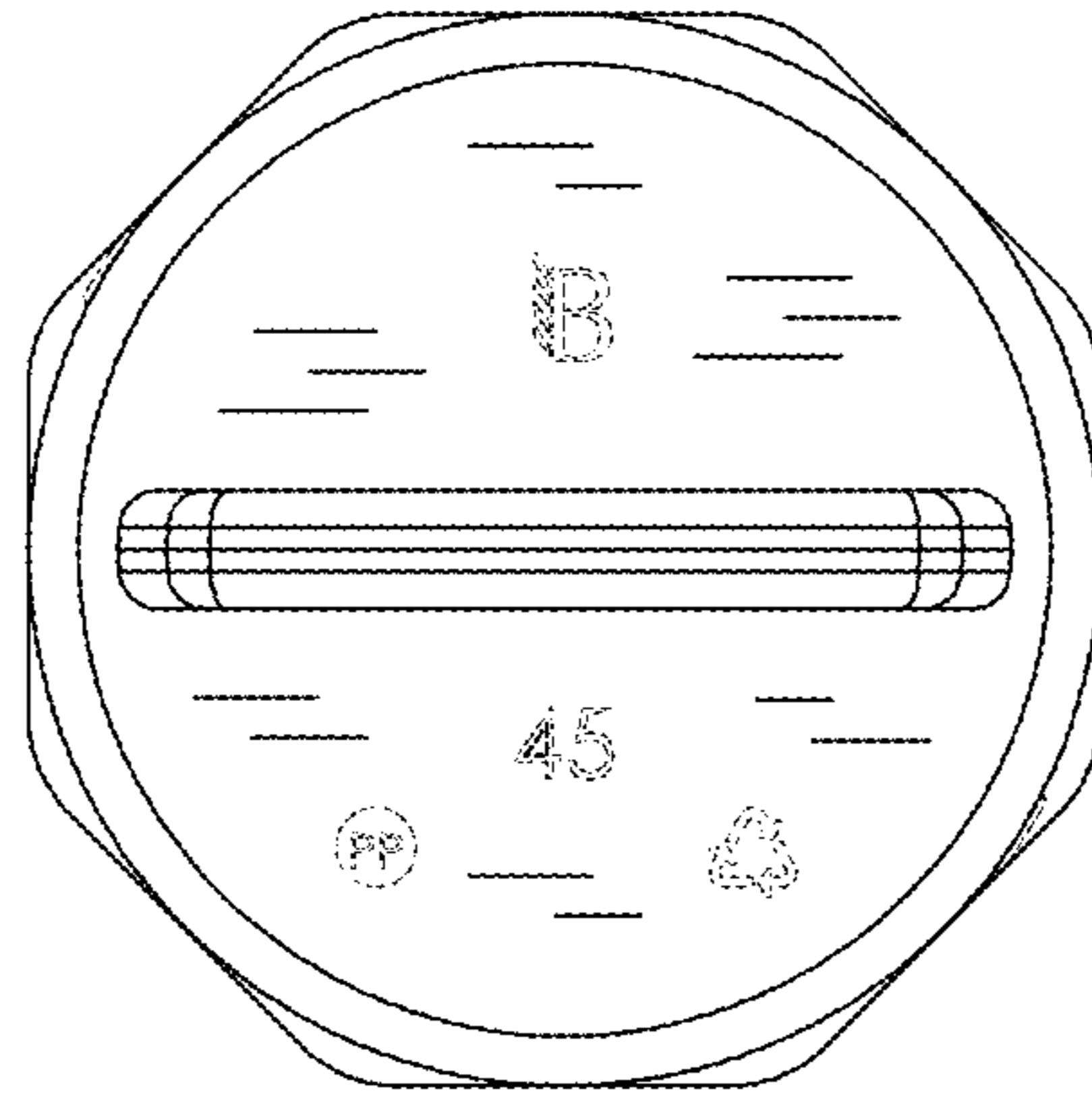

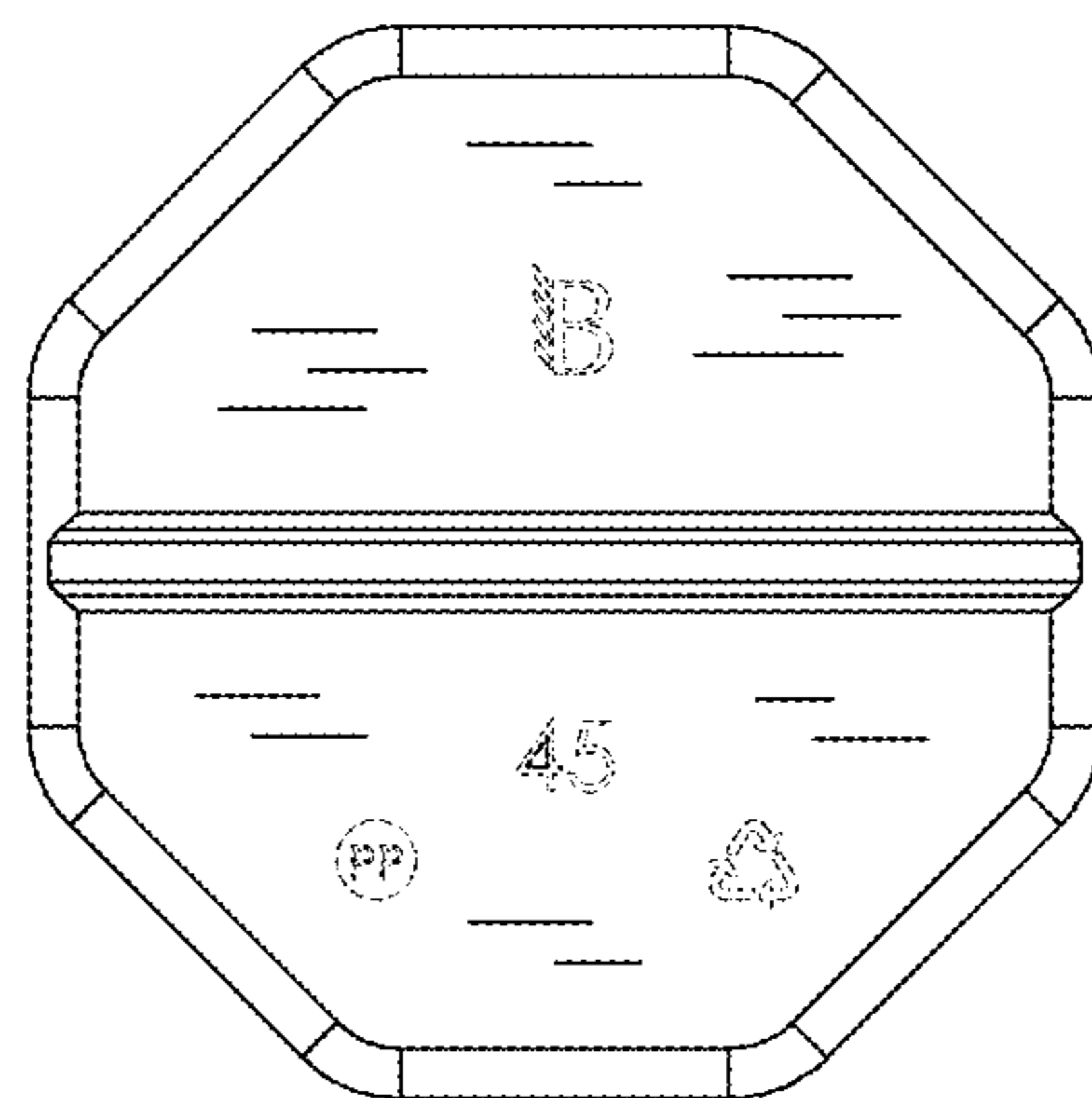

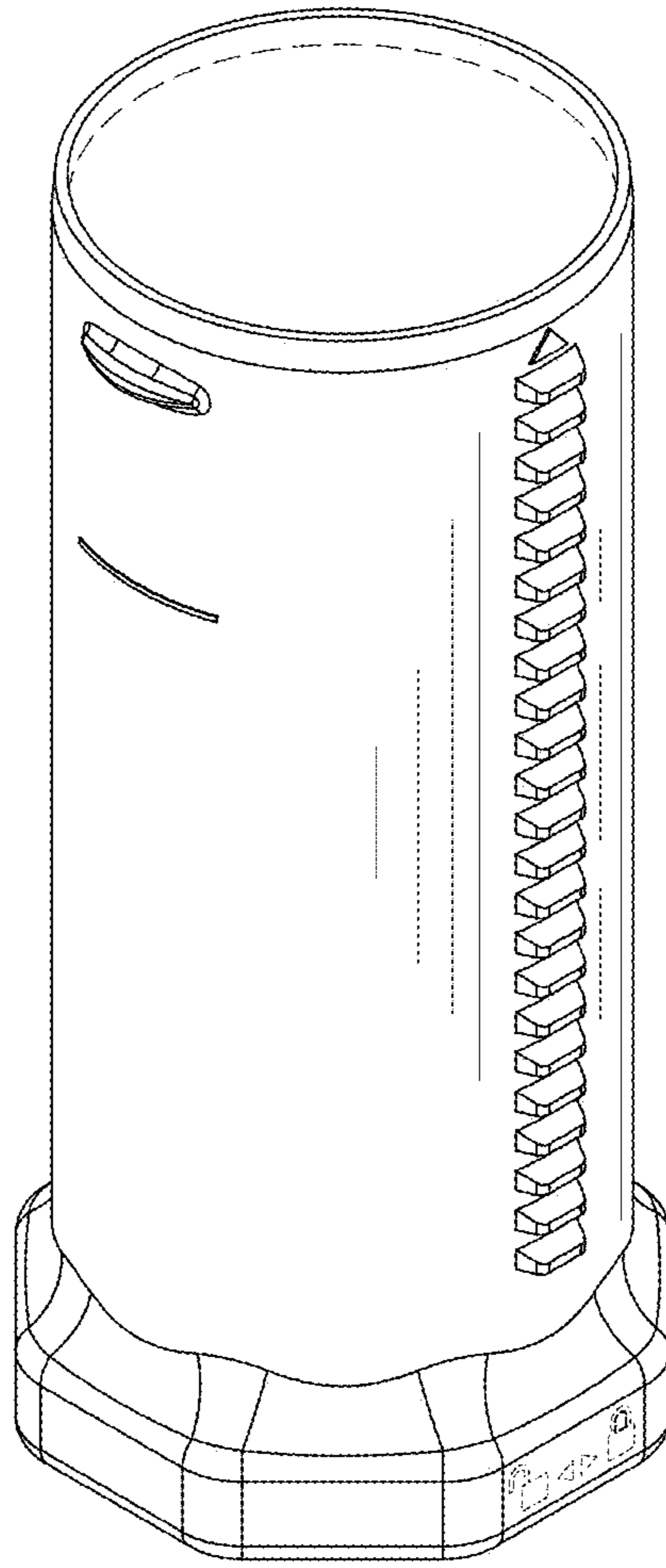

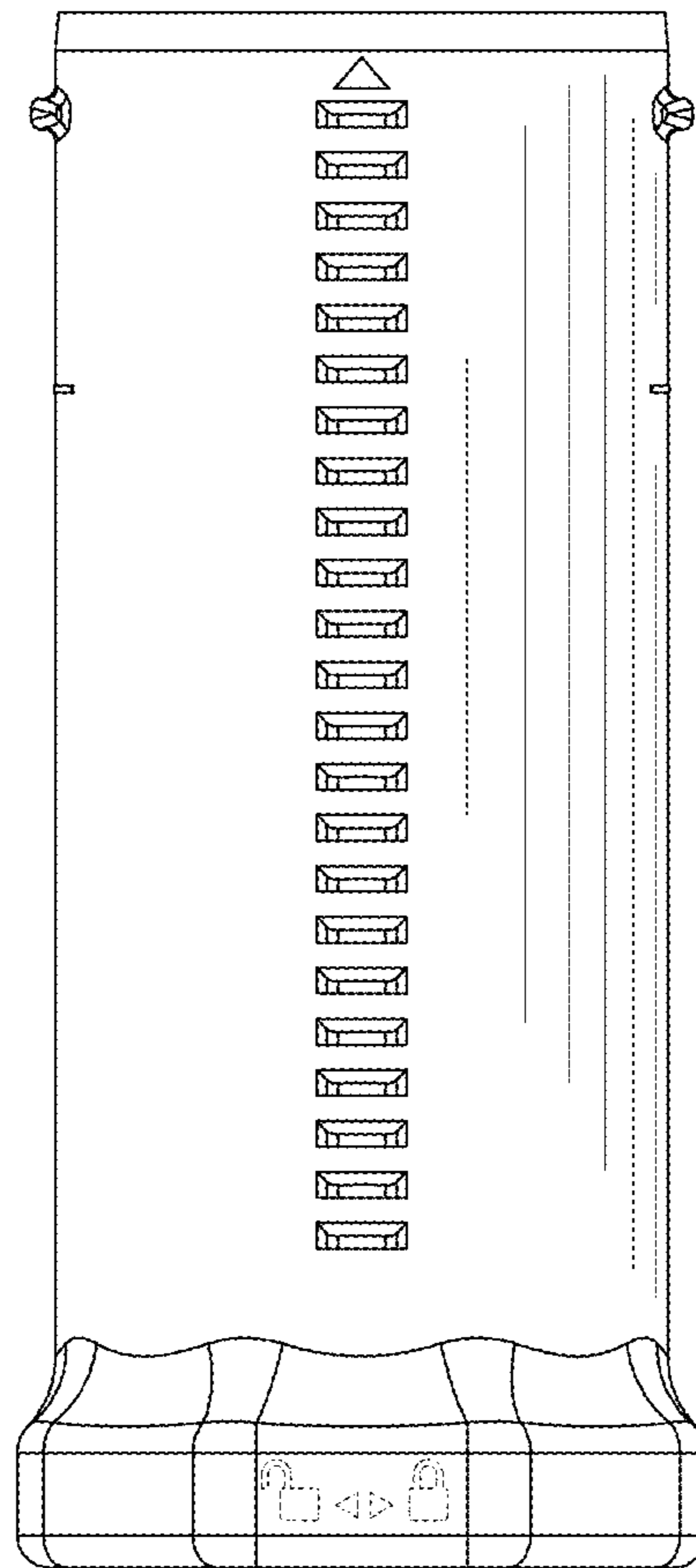

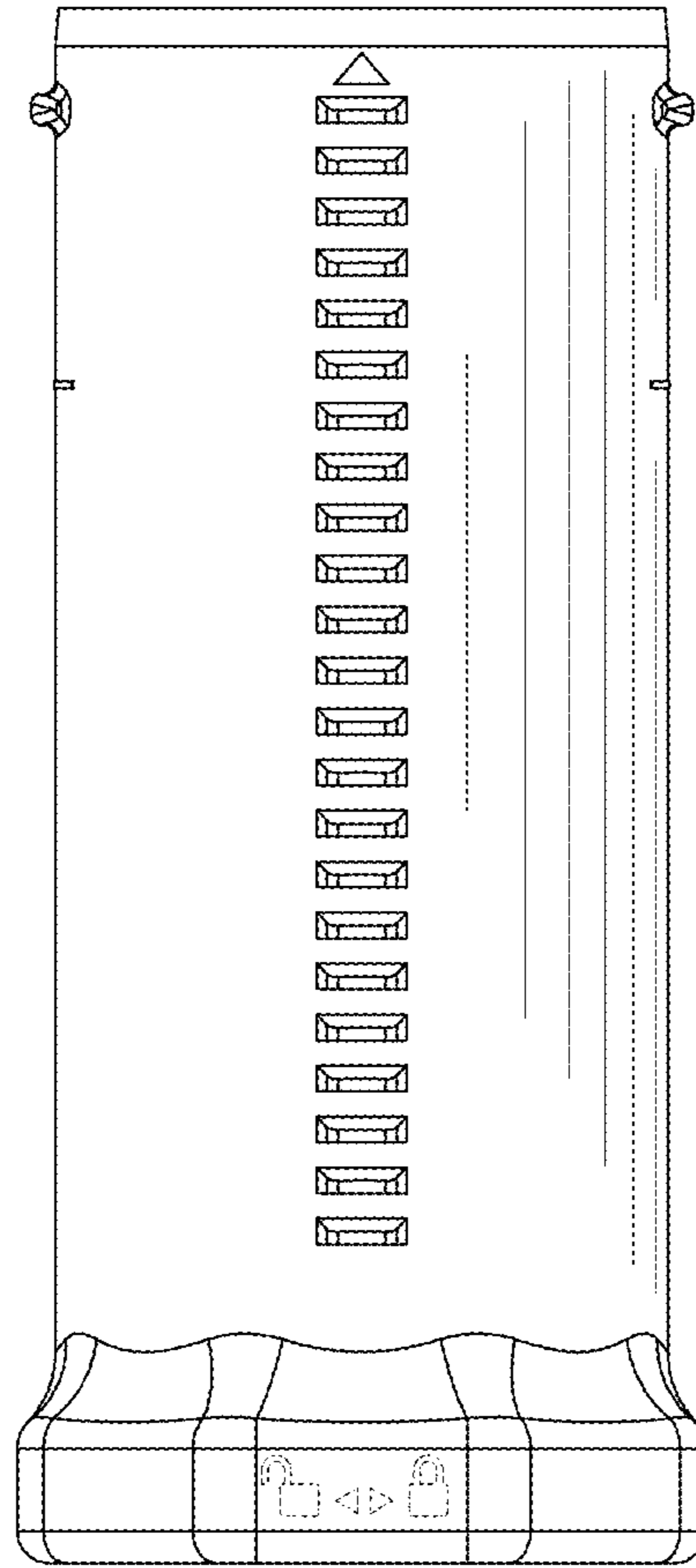

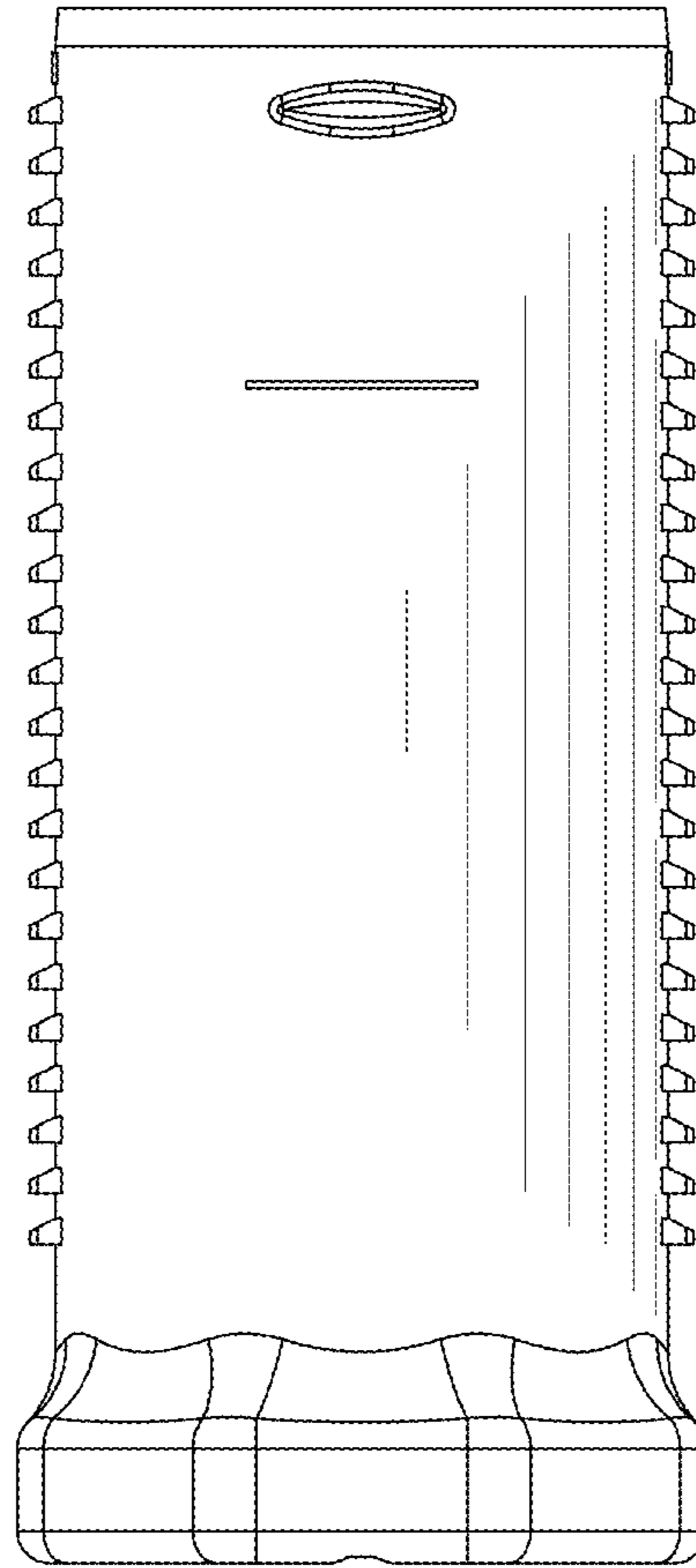

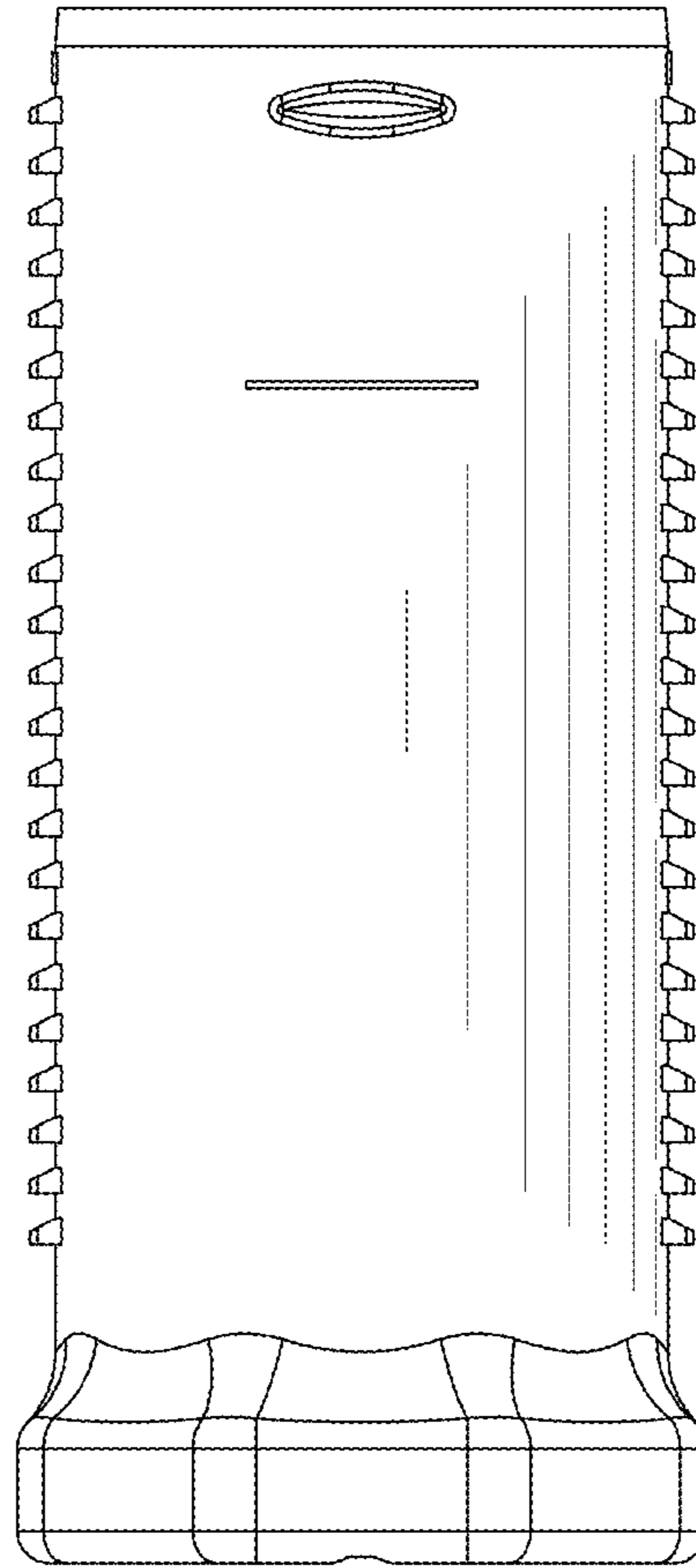

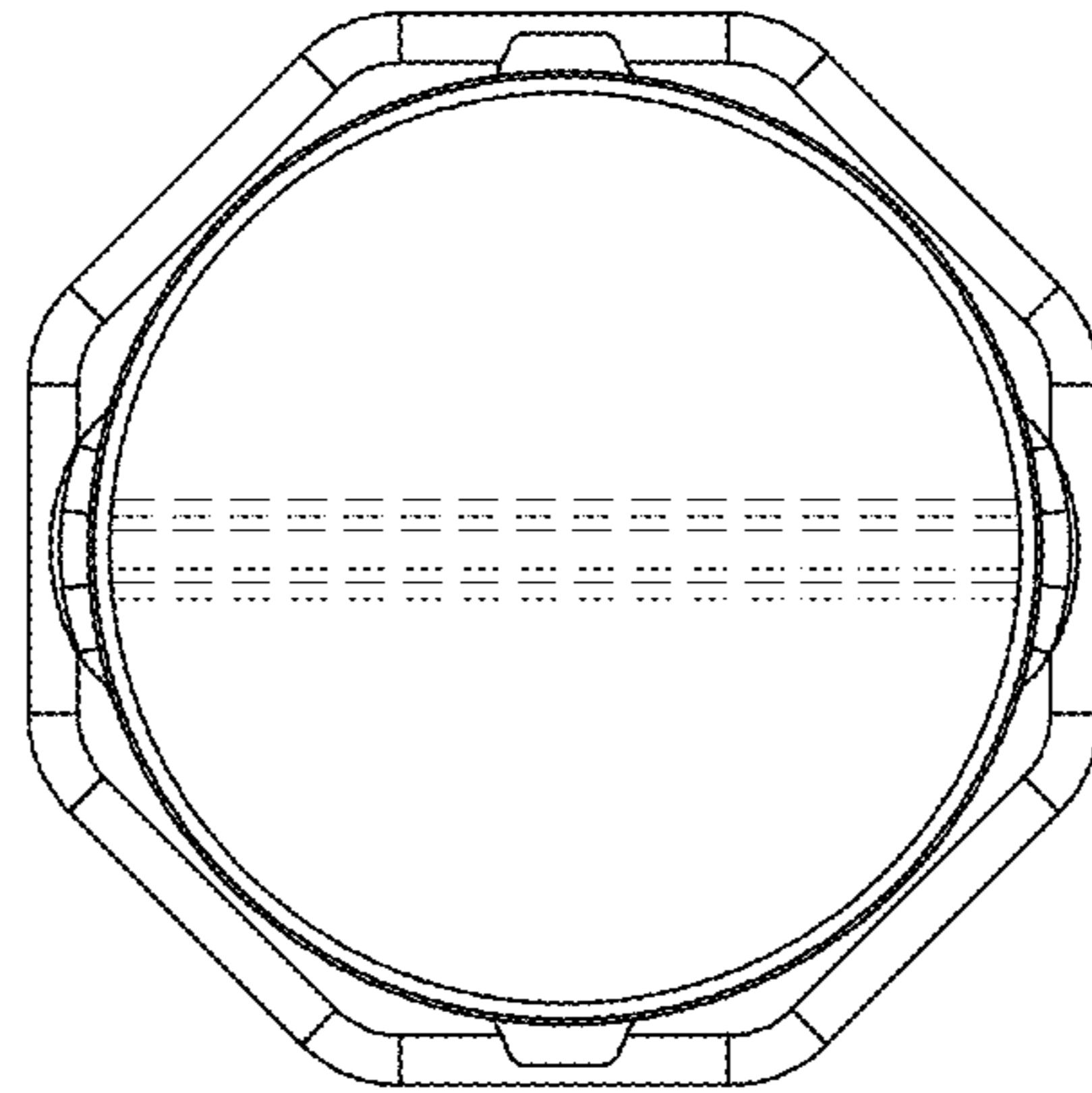

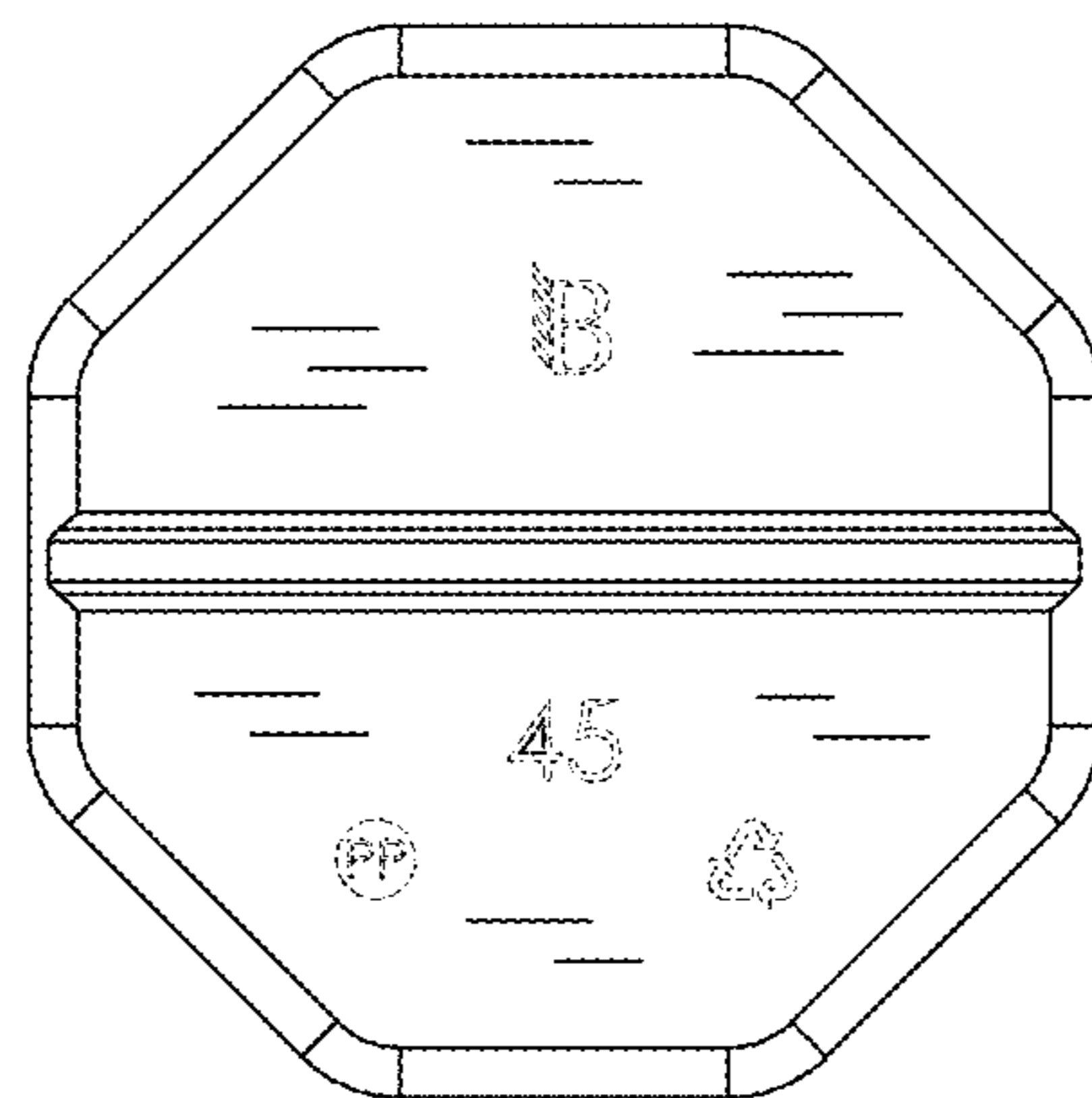

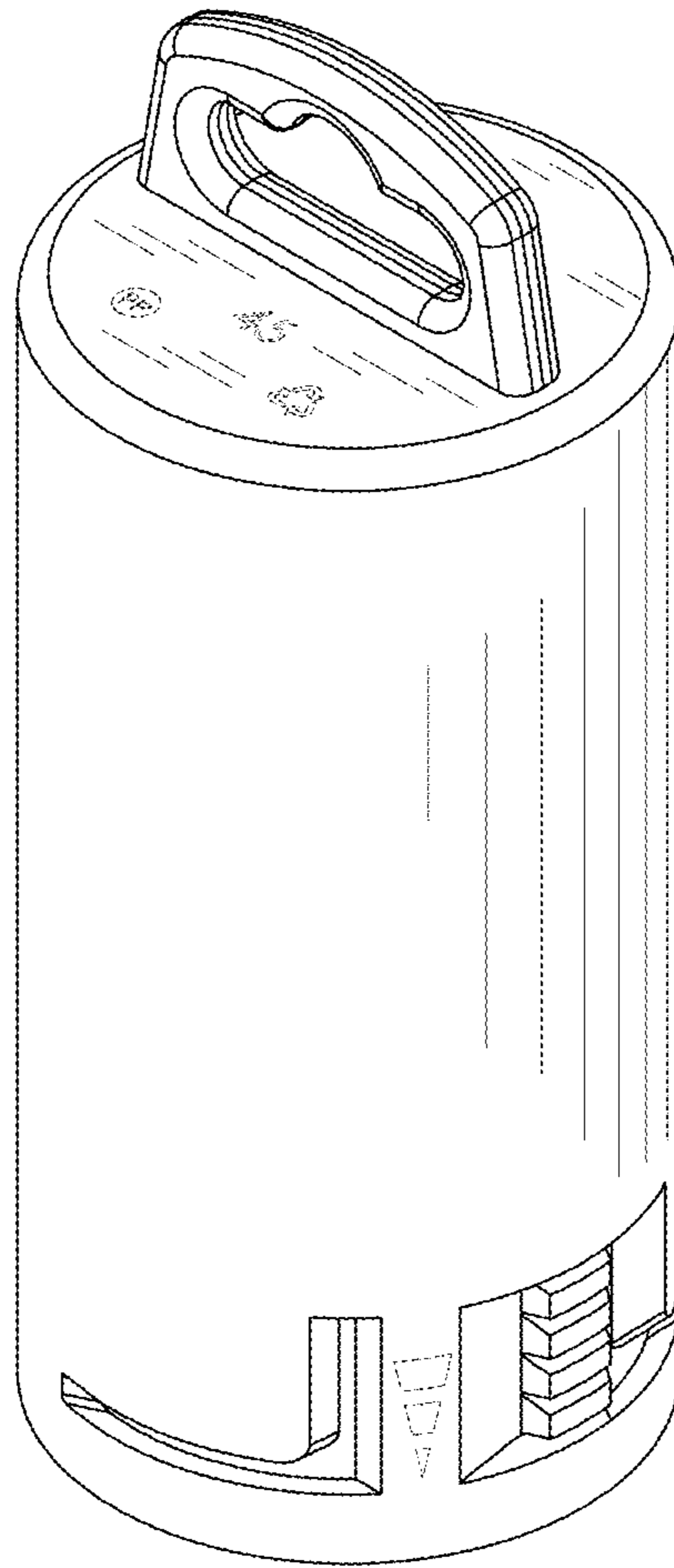

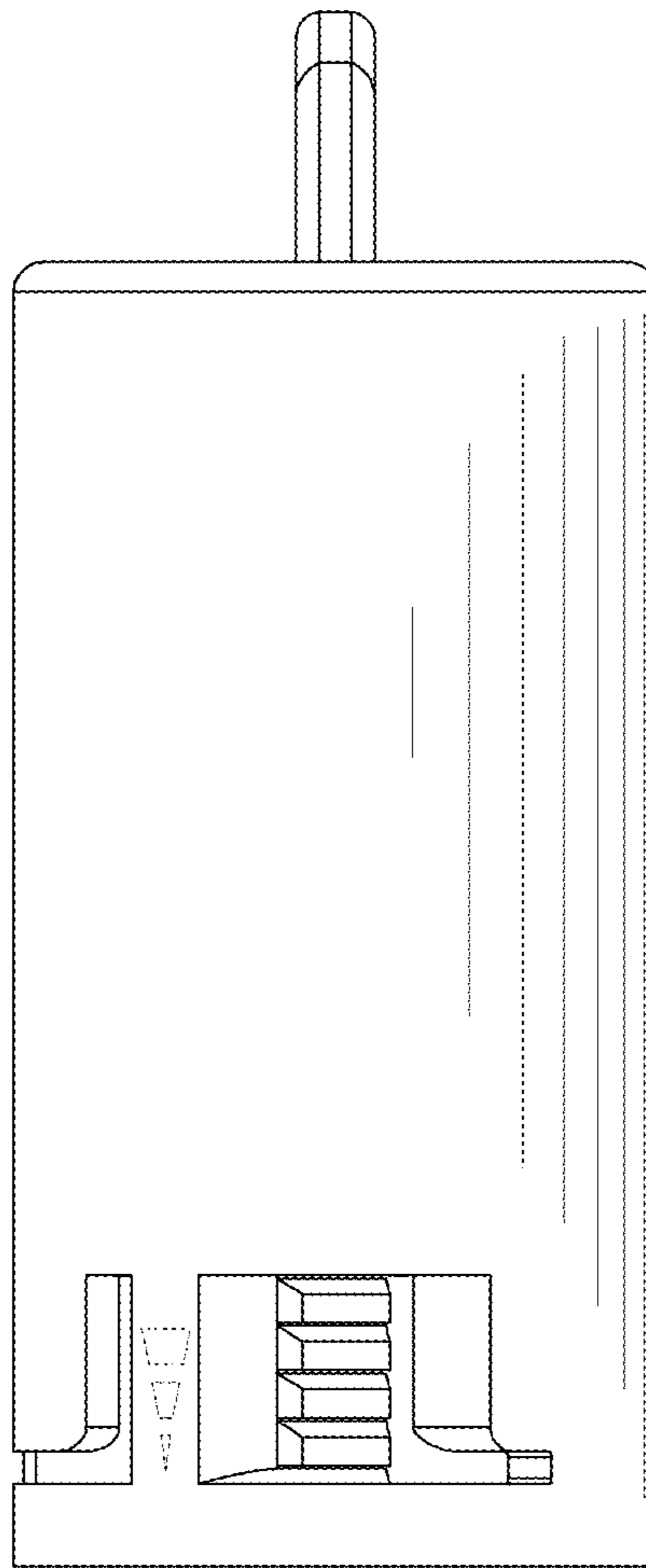

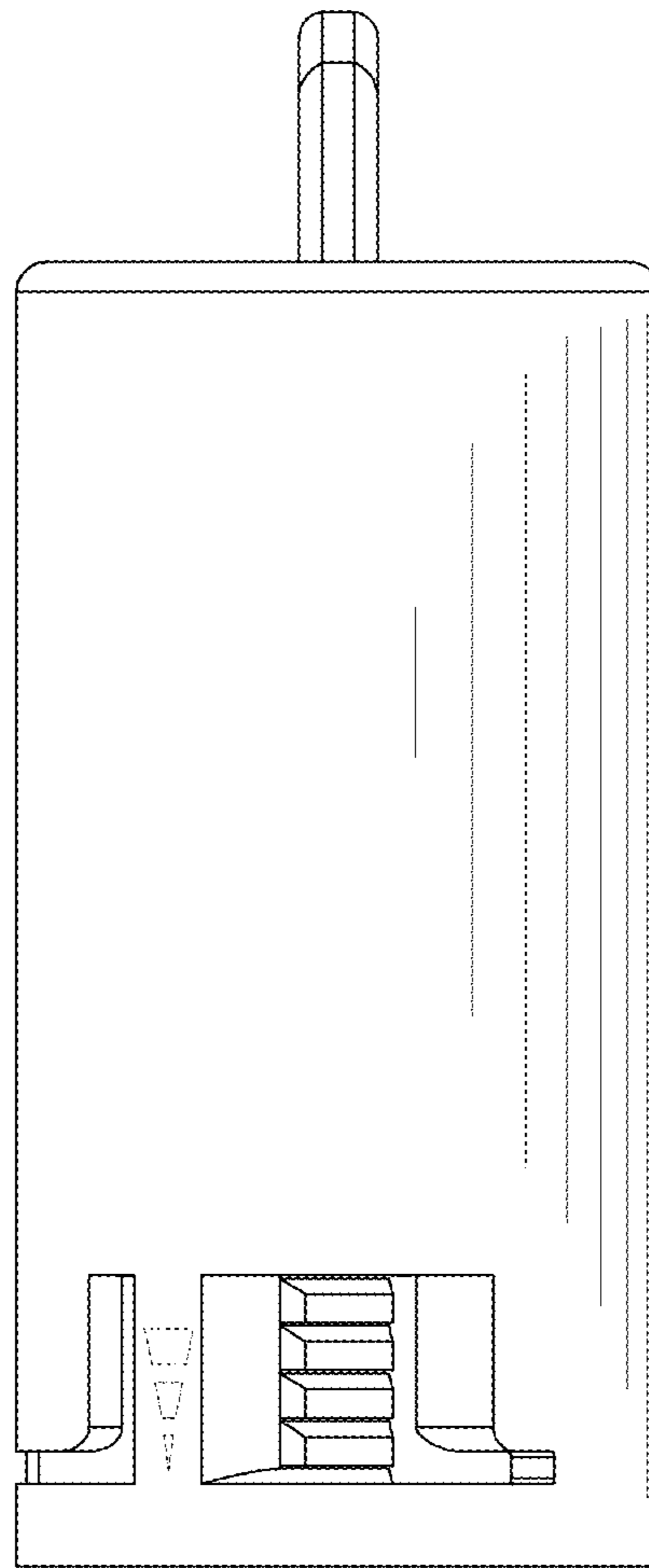

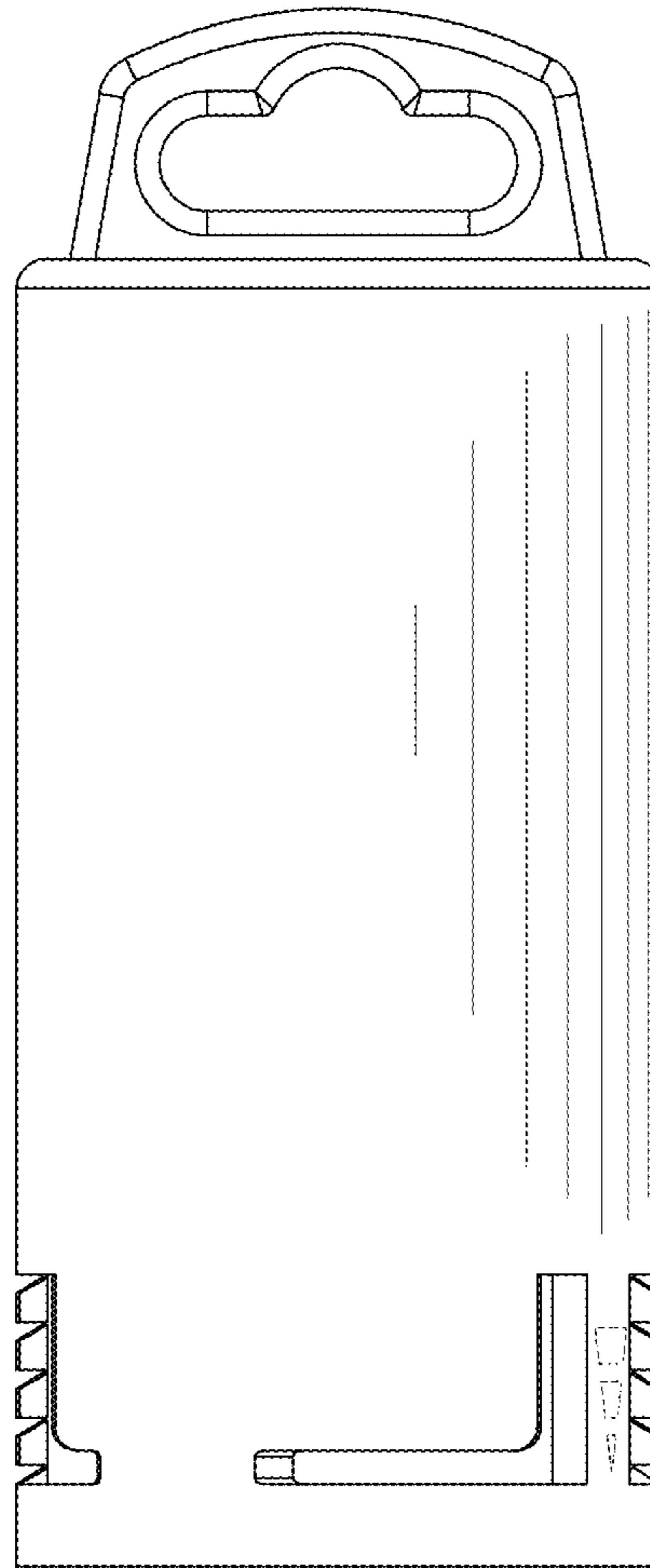

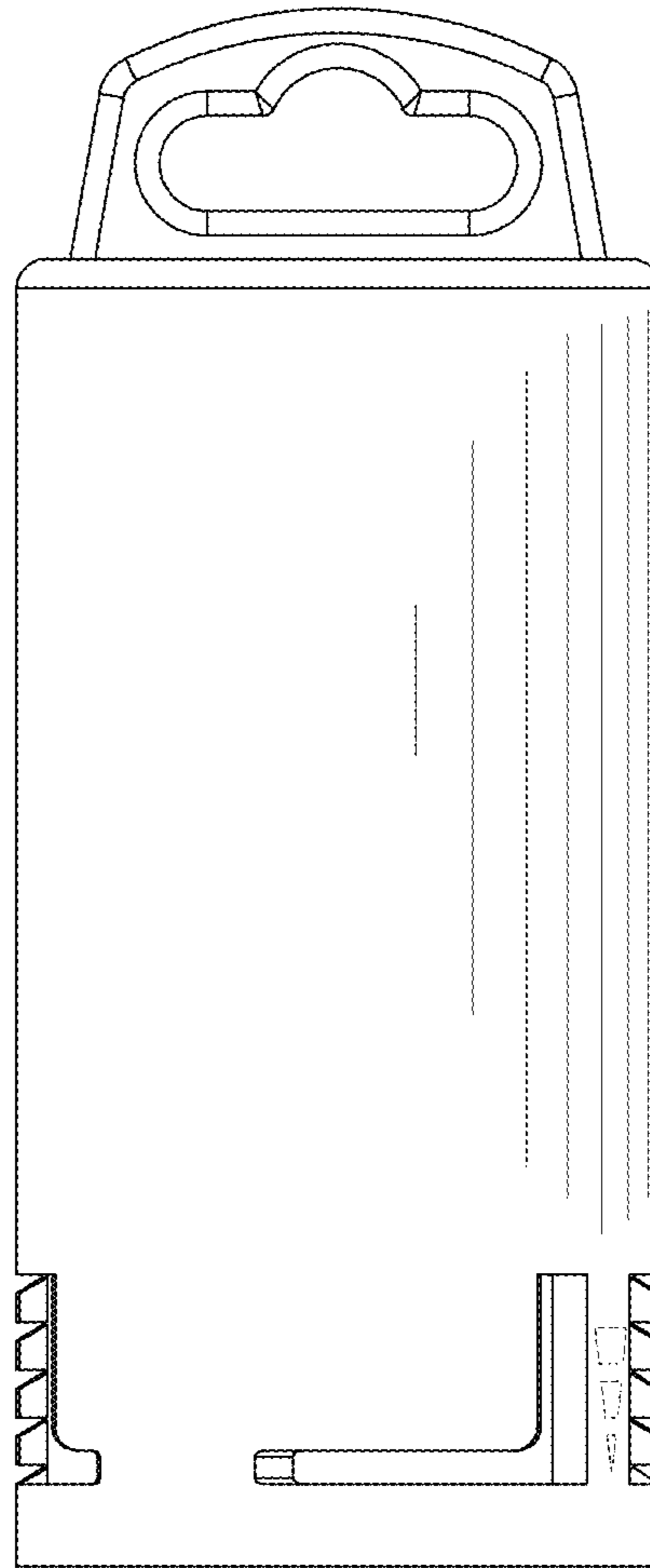

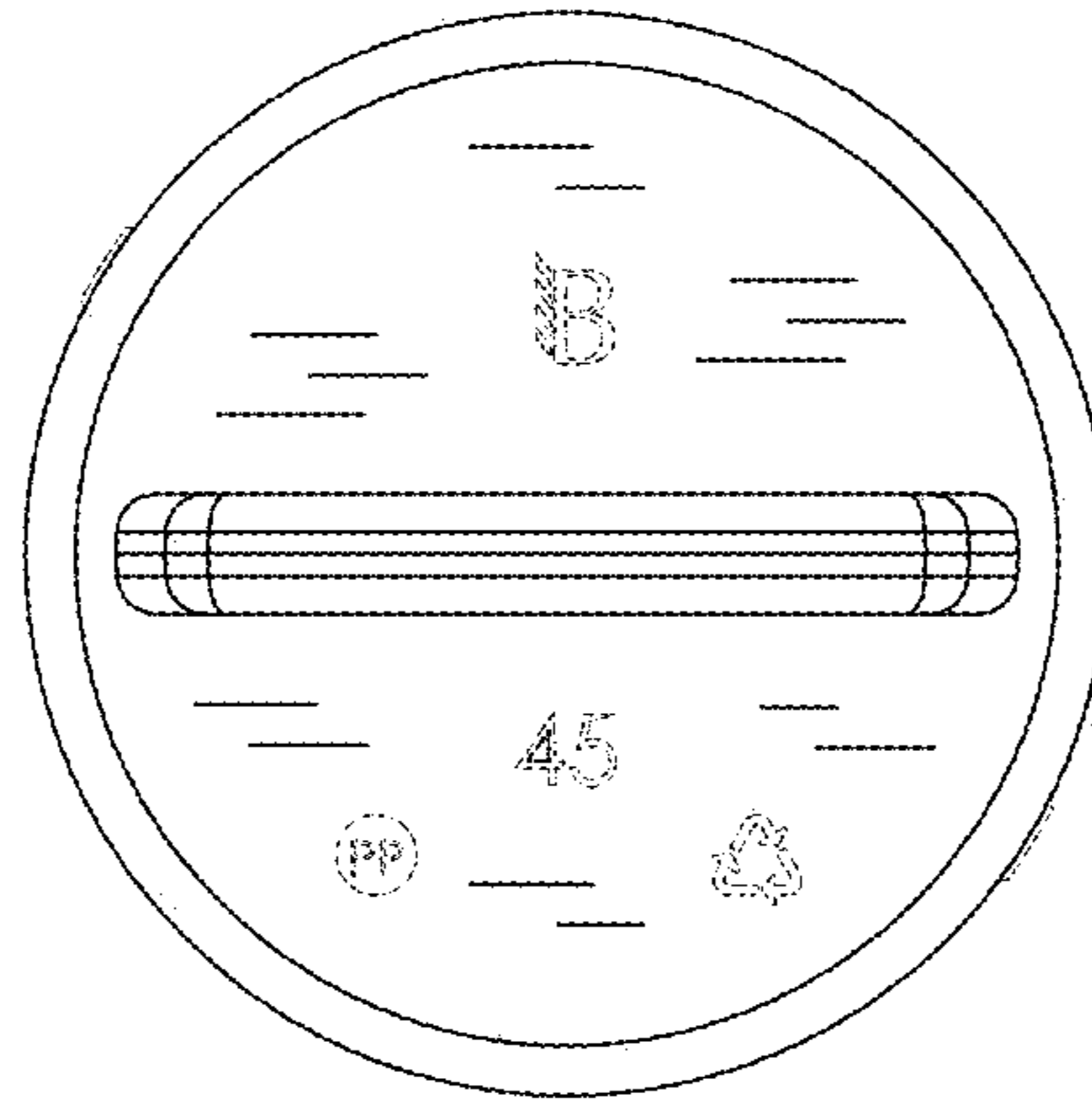

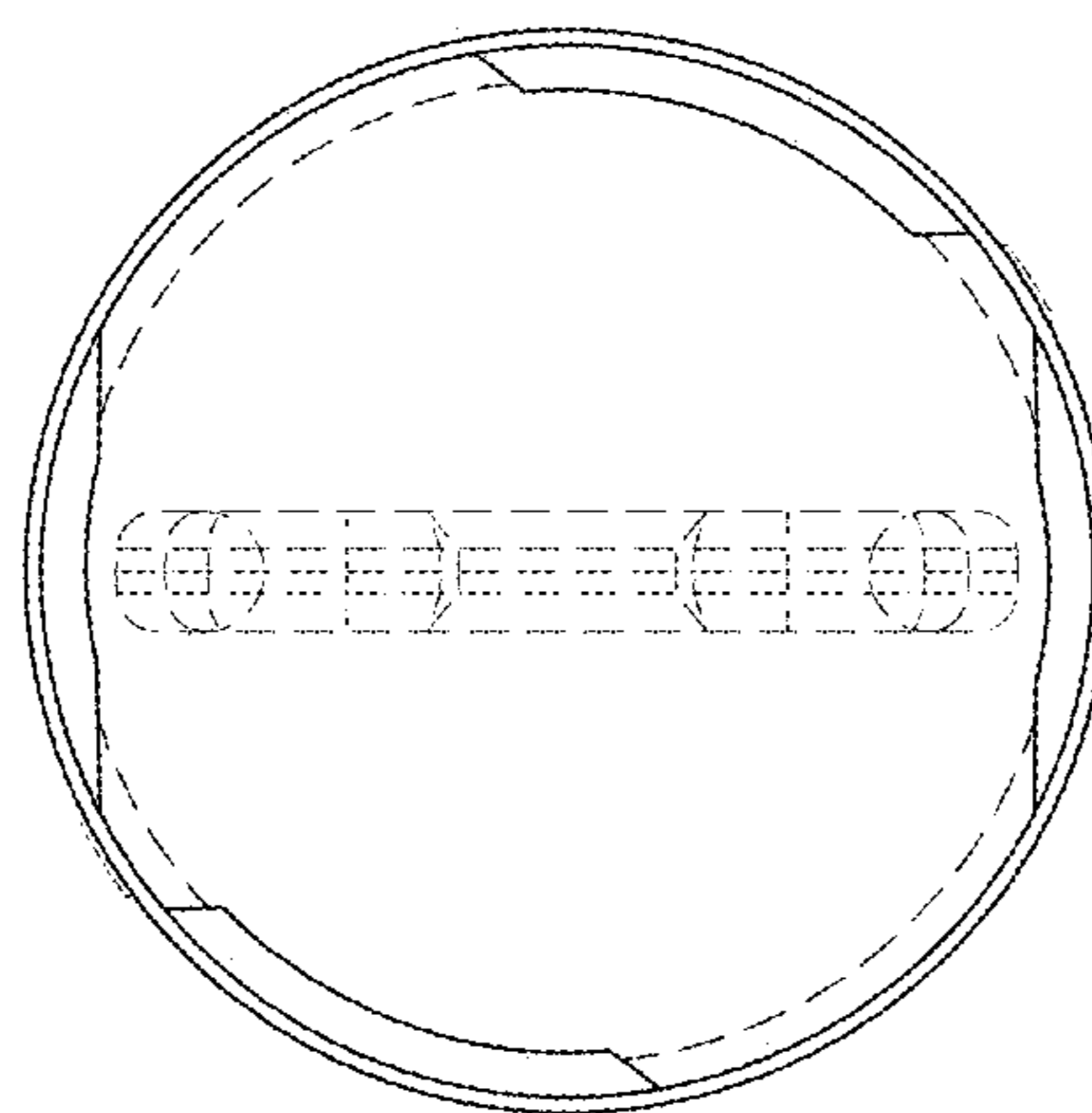
