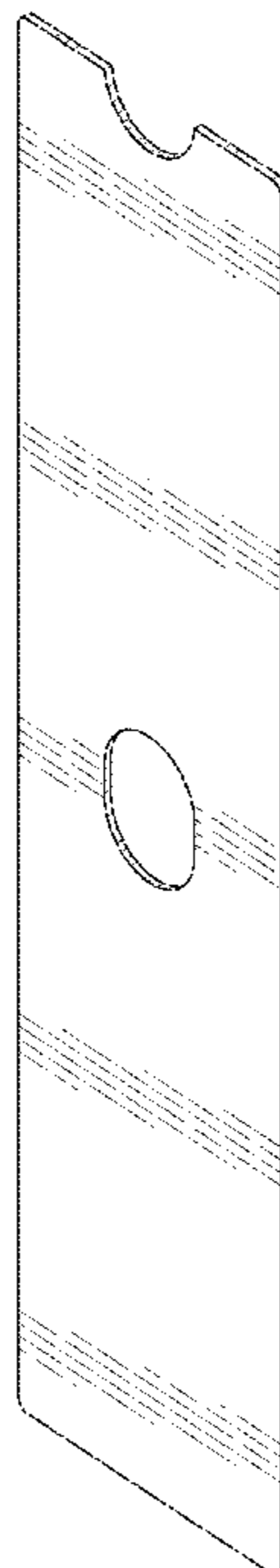
(57) **CLAIM**

The ornamental design for a console slide selector seal, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of the console slide selector seal showing the new design;
FIG. 2 is a front elevational view of the console slide selector seal thereof;
FIG. 3 is a rear elevational view of the console slide selector seal thereof;

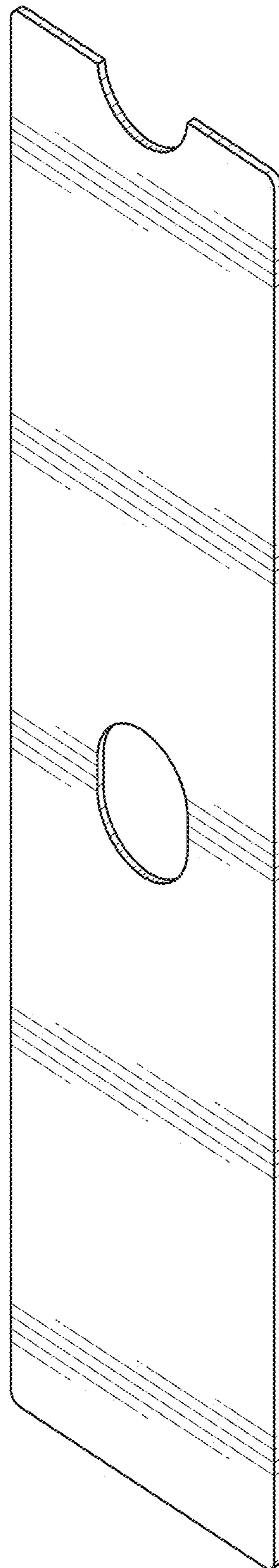

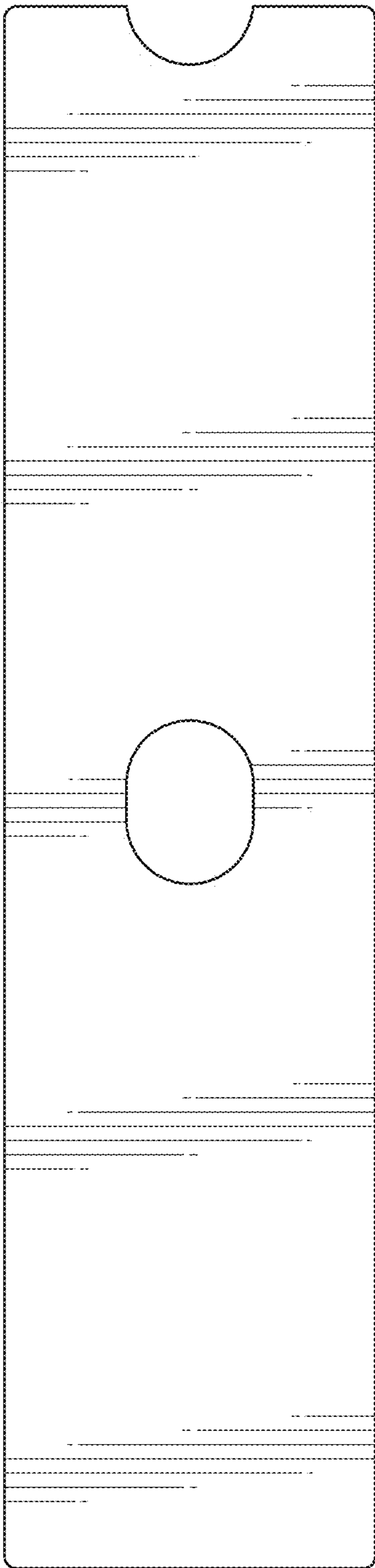

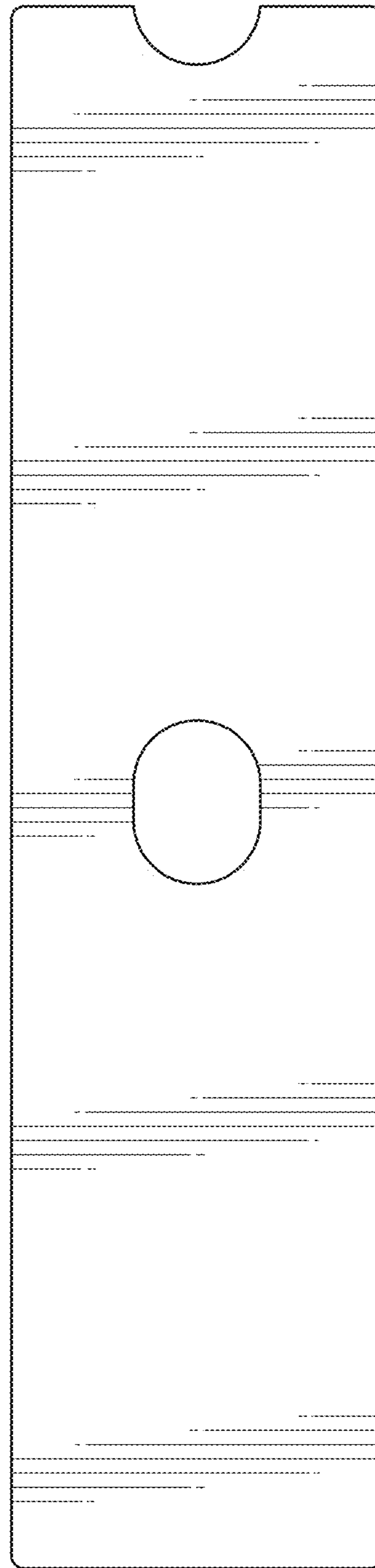

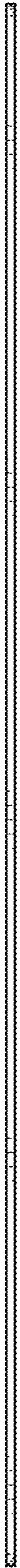

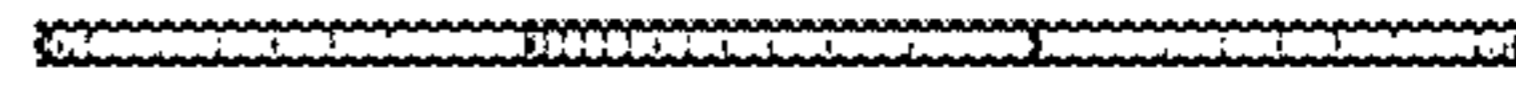
