(57) **CLAIM**

The ornamental design for a boat bumper holder, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a boat bumper holder, showing my new design;

FIG. 2 is a front elevation view of the boat bumper holder in FIG. 1;

FIG. 3 is a rear elevation view of the boat bumper holder of FIG. 1;

FIG. 4 is a left-side elevation view of the boat bumper holder of FIG. 1;

FIG. 5 is a right-side elevation view of the boat bumper holder of FIG. 1;

FIG. 6 is a top view of the boat bumper holder of FIG. 1;

FIG. 7 is a bottom plan view of the boat bumper holder of FIG. 1;

FIG. 8 is a second perspective view of a boat bumper holder, showing my new design;

FIG. 9 is a front elevation view of the boat bumper holder in FIG. 8;

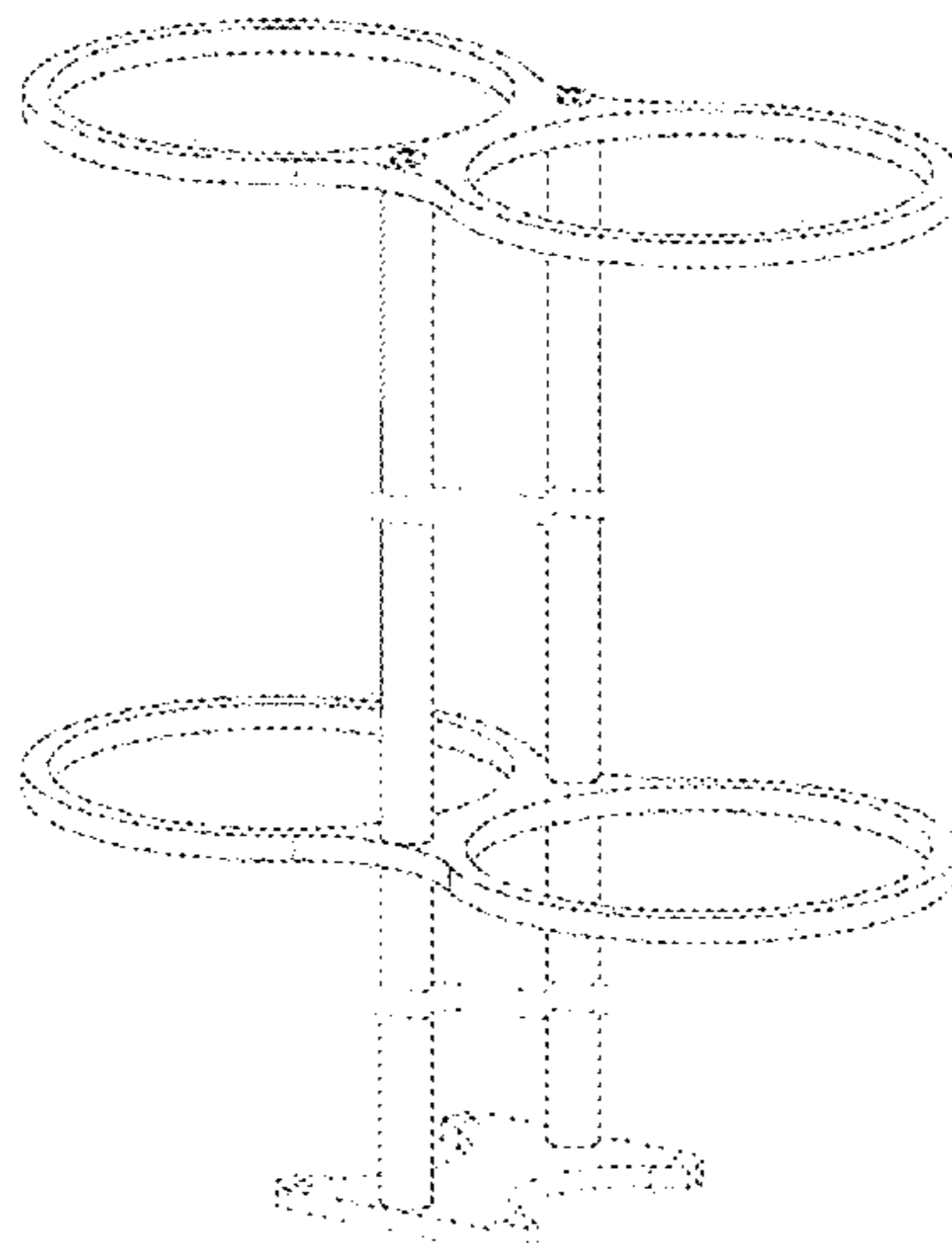
FIG. 10 is a rear elevation view of the boat bumper holder of FIG. 8;

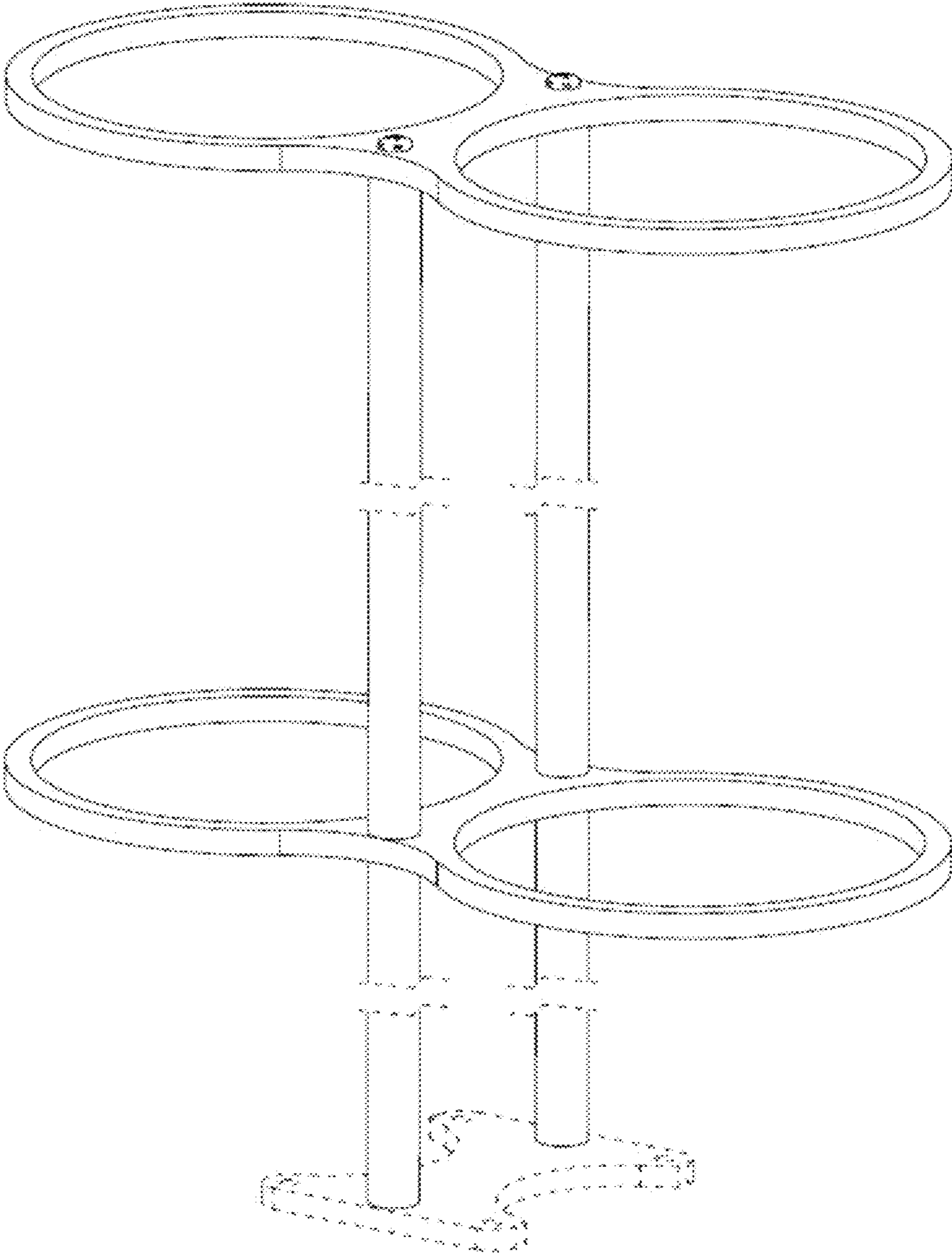

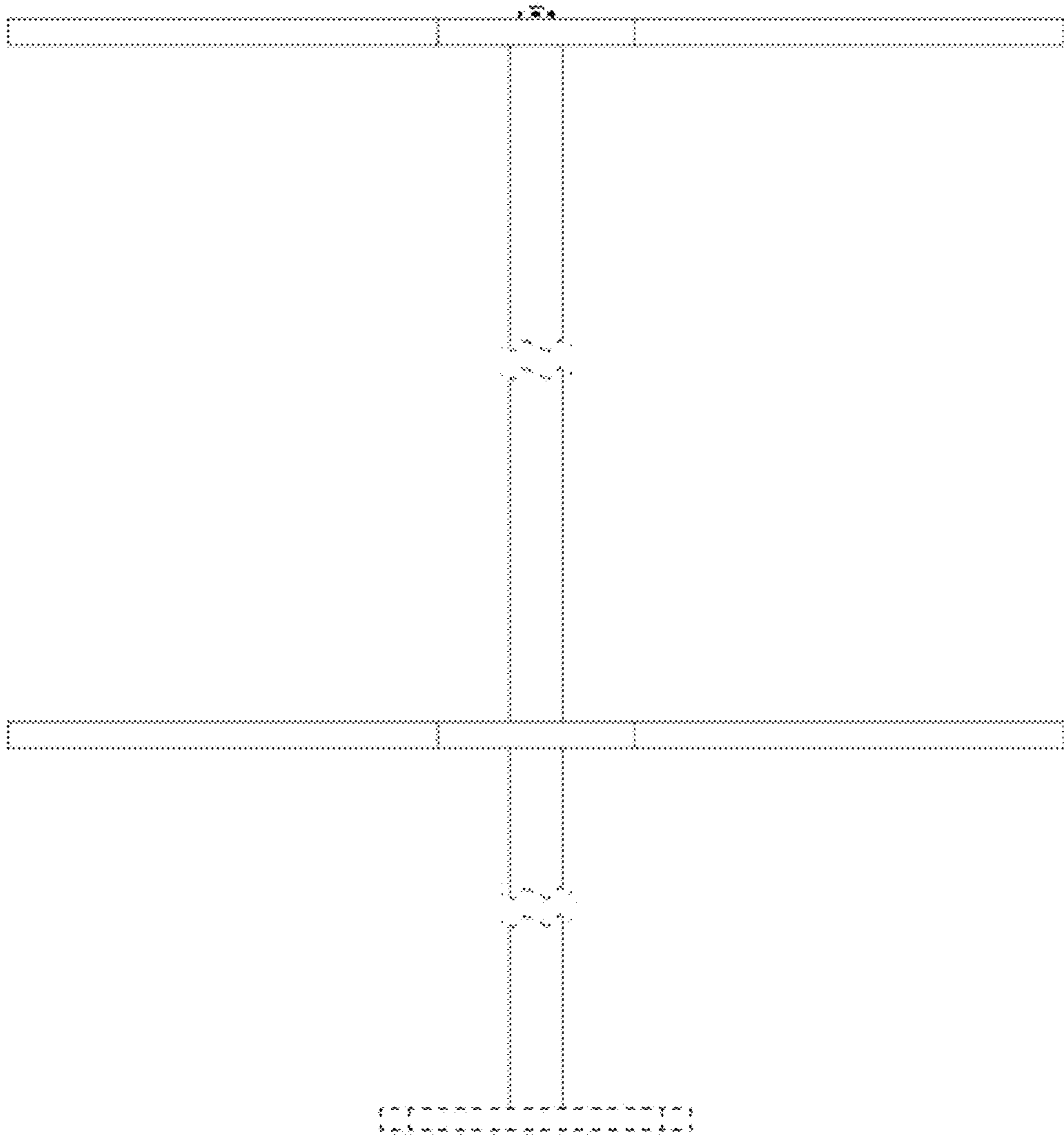

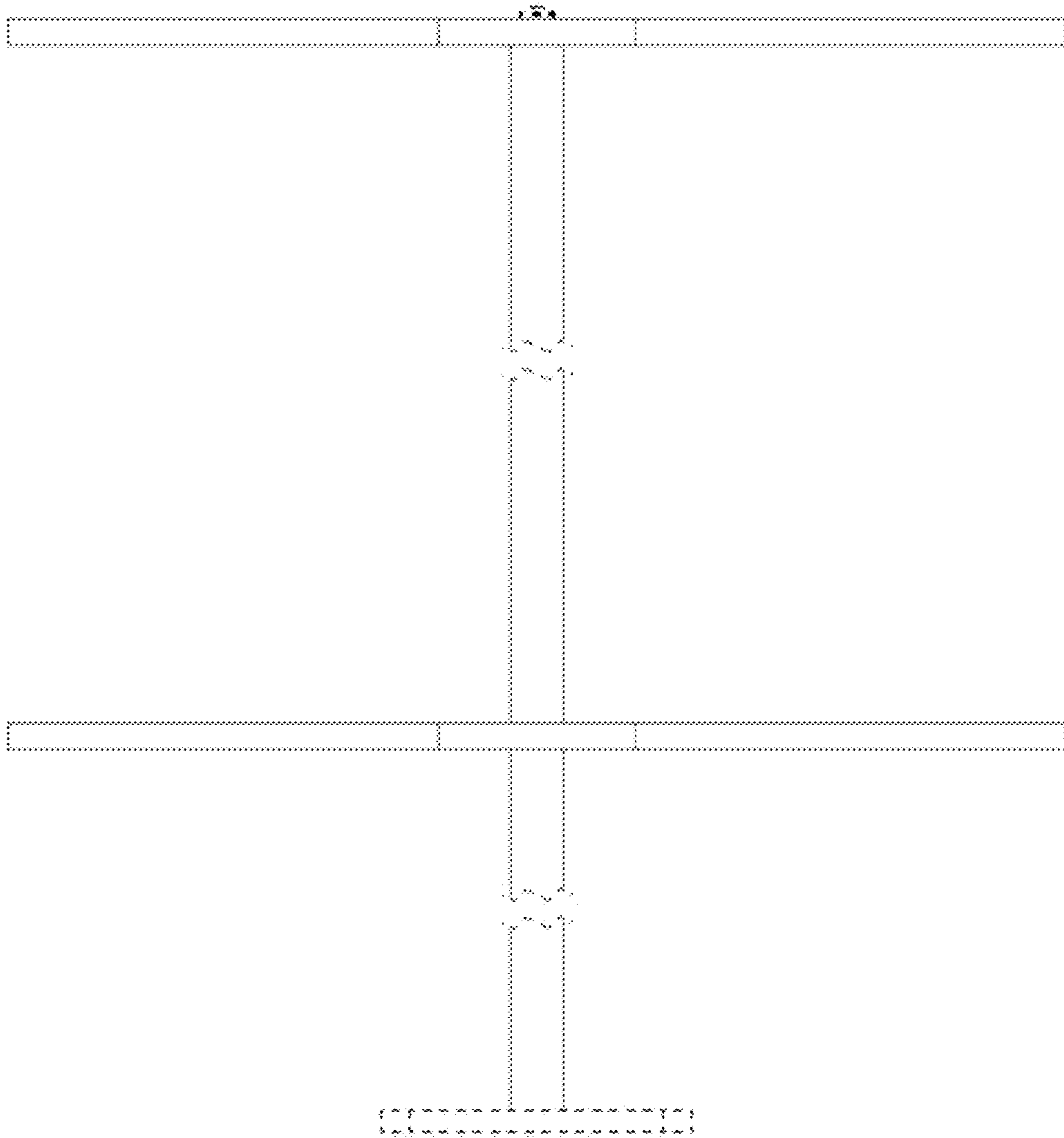

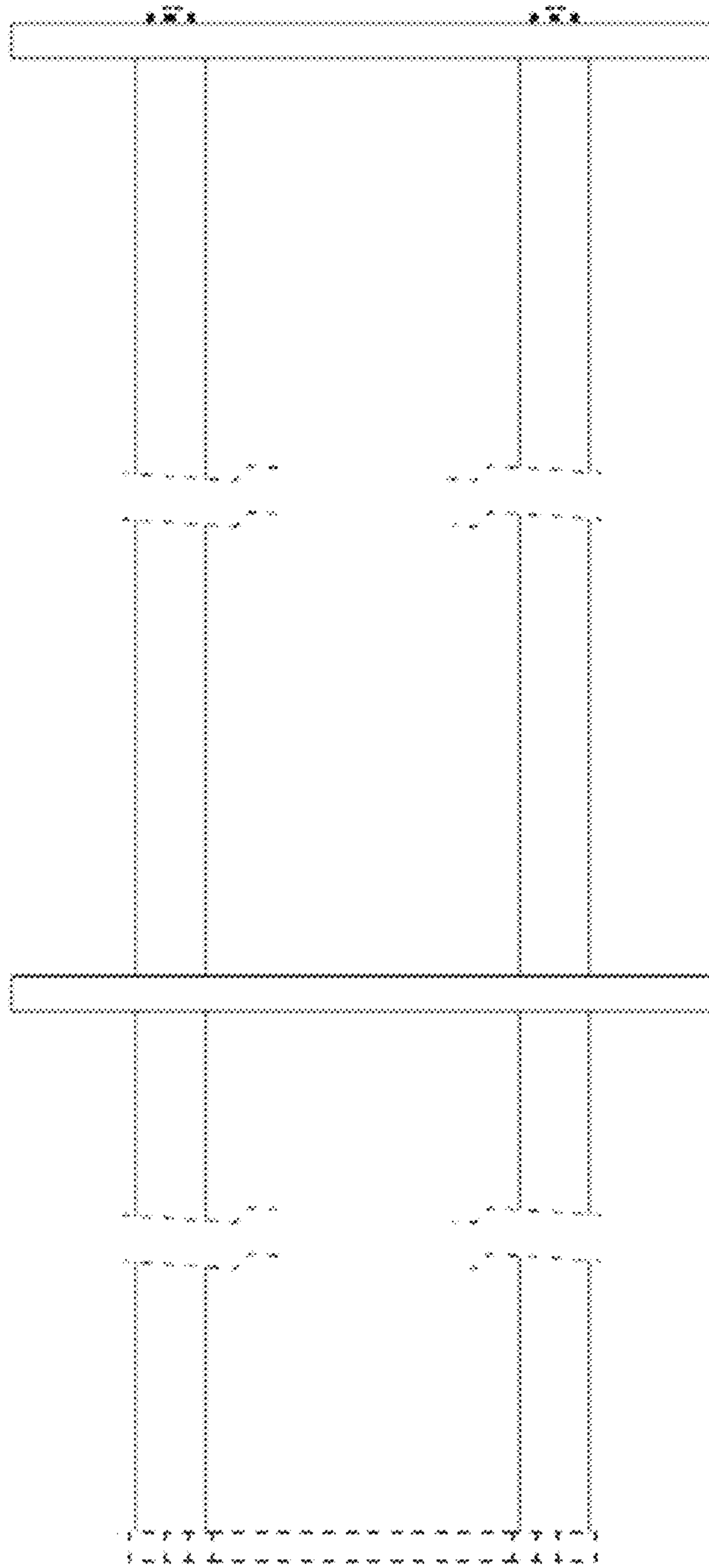

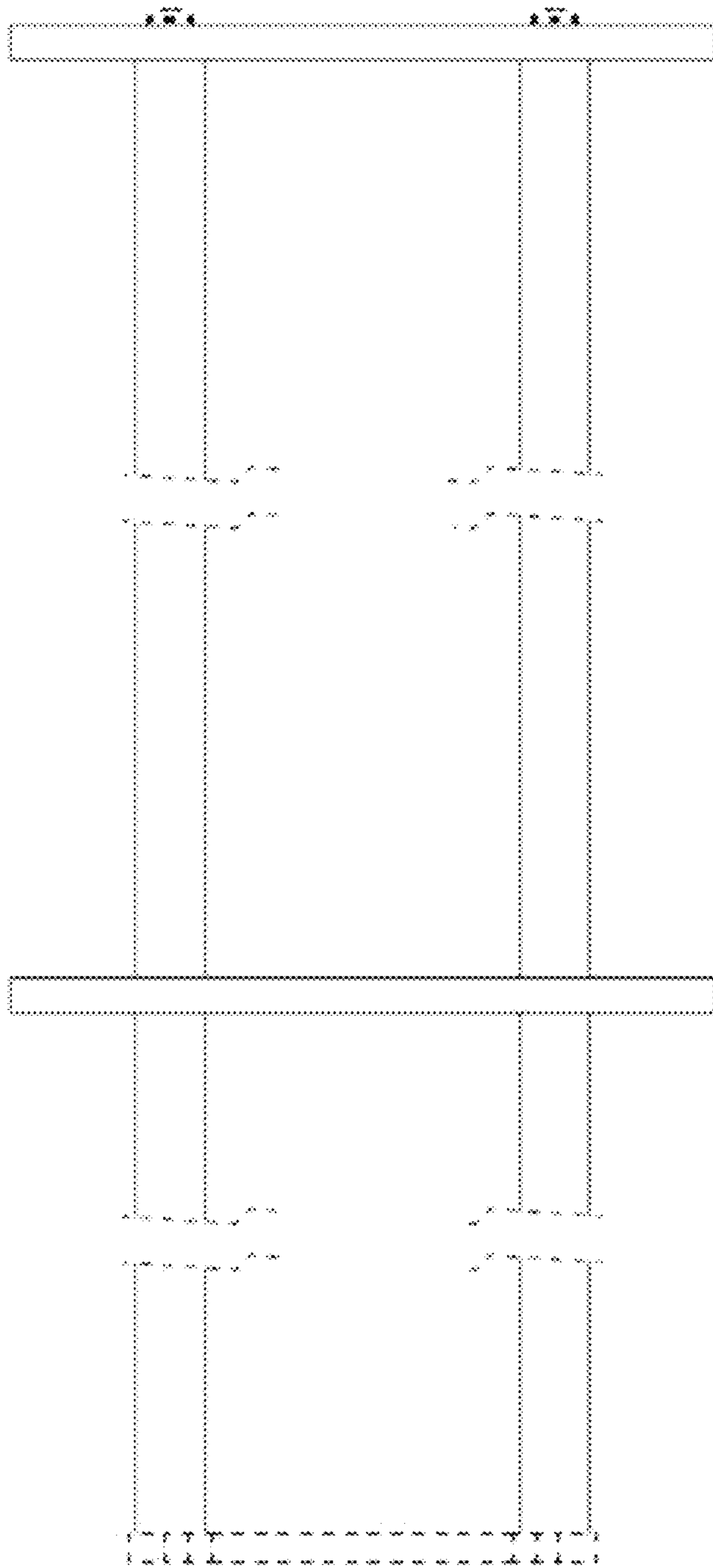

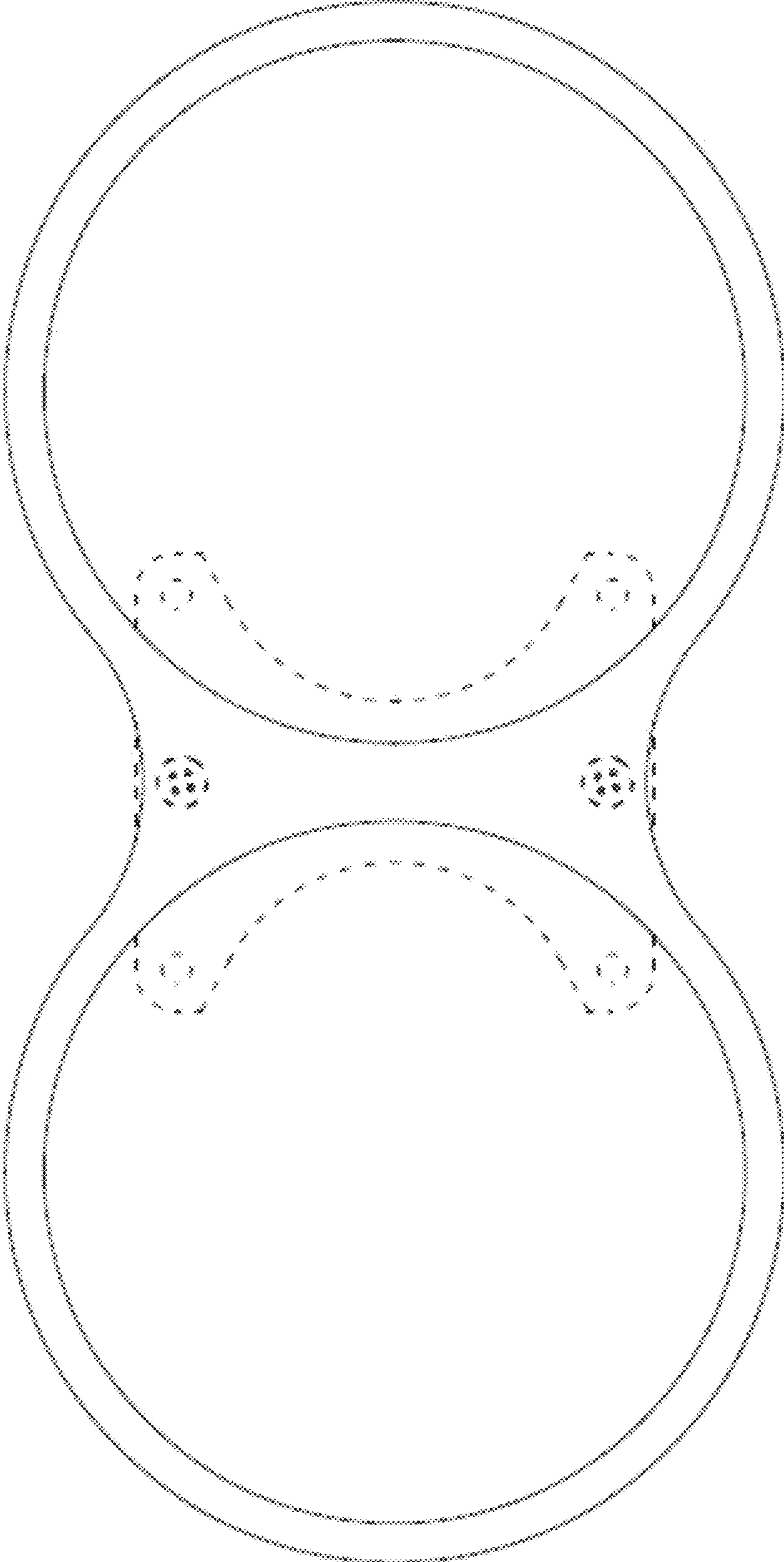

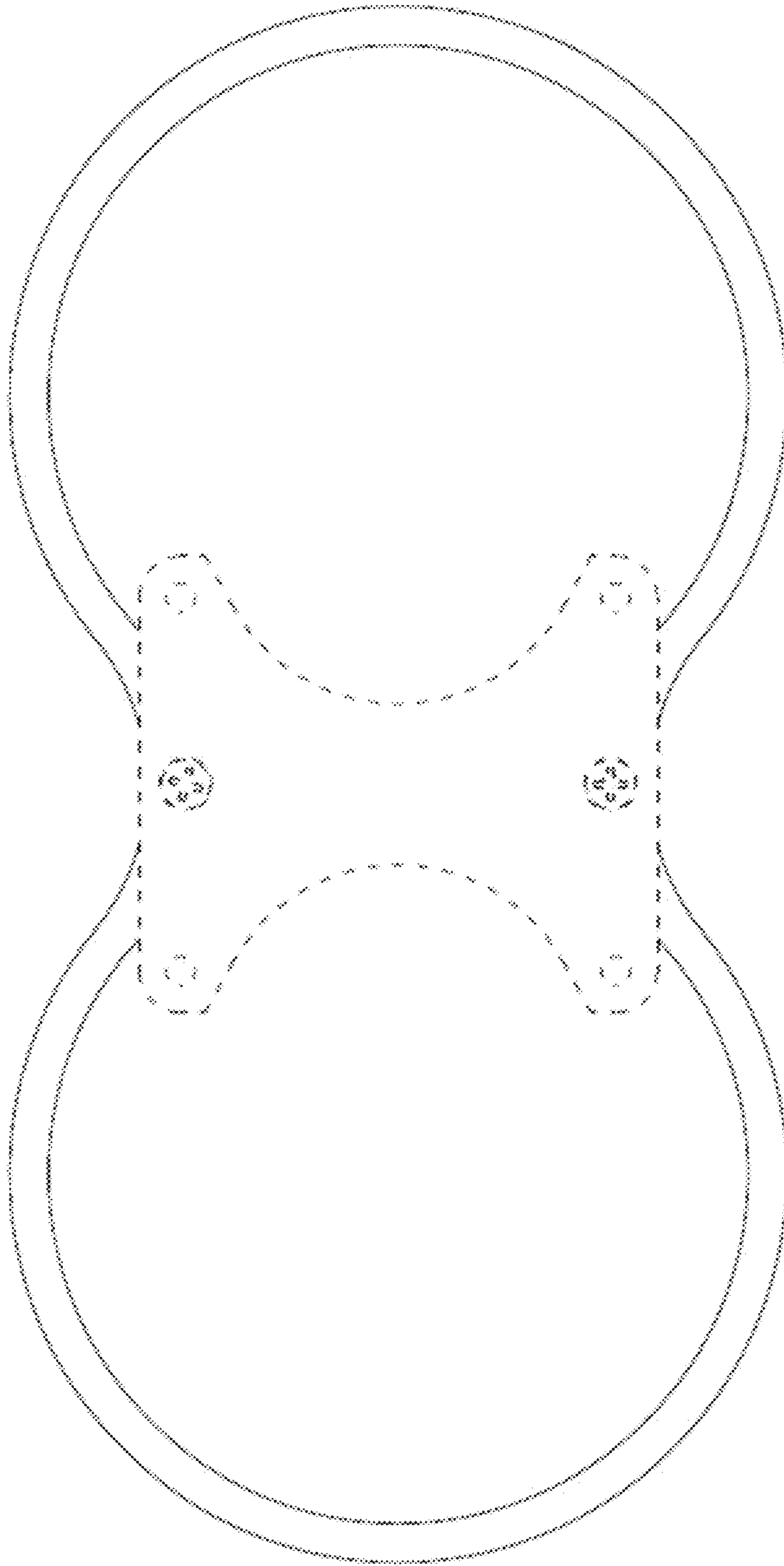

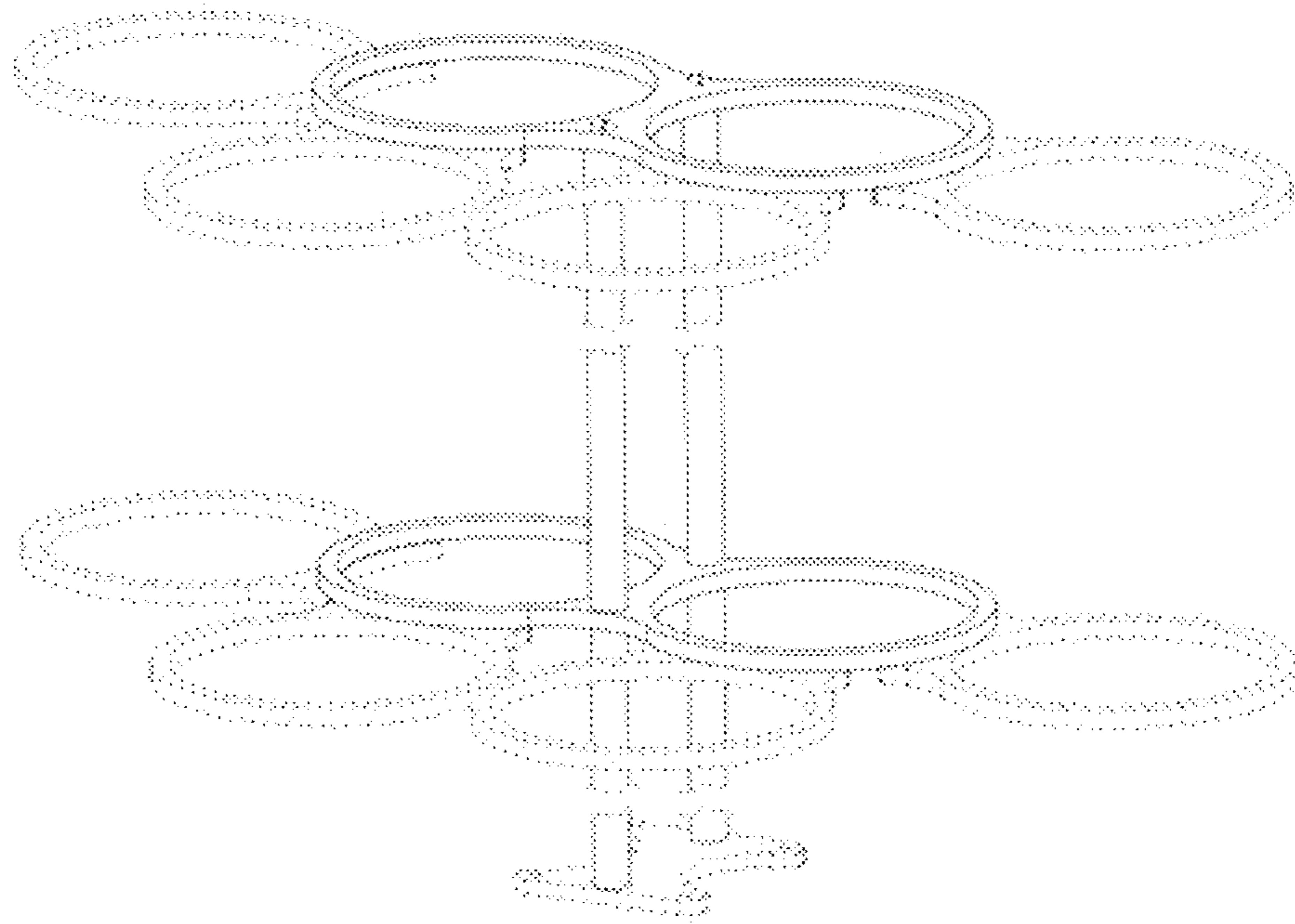

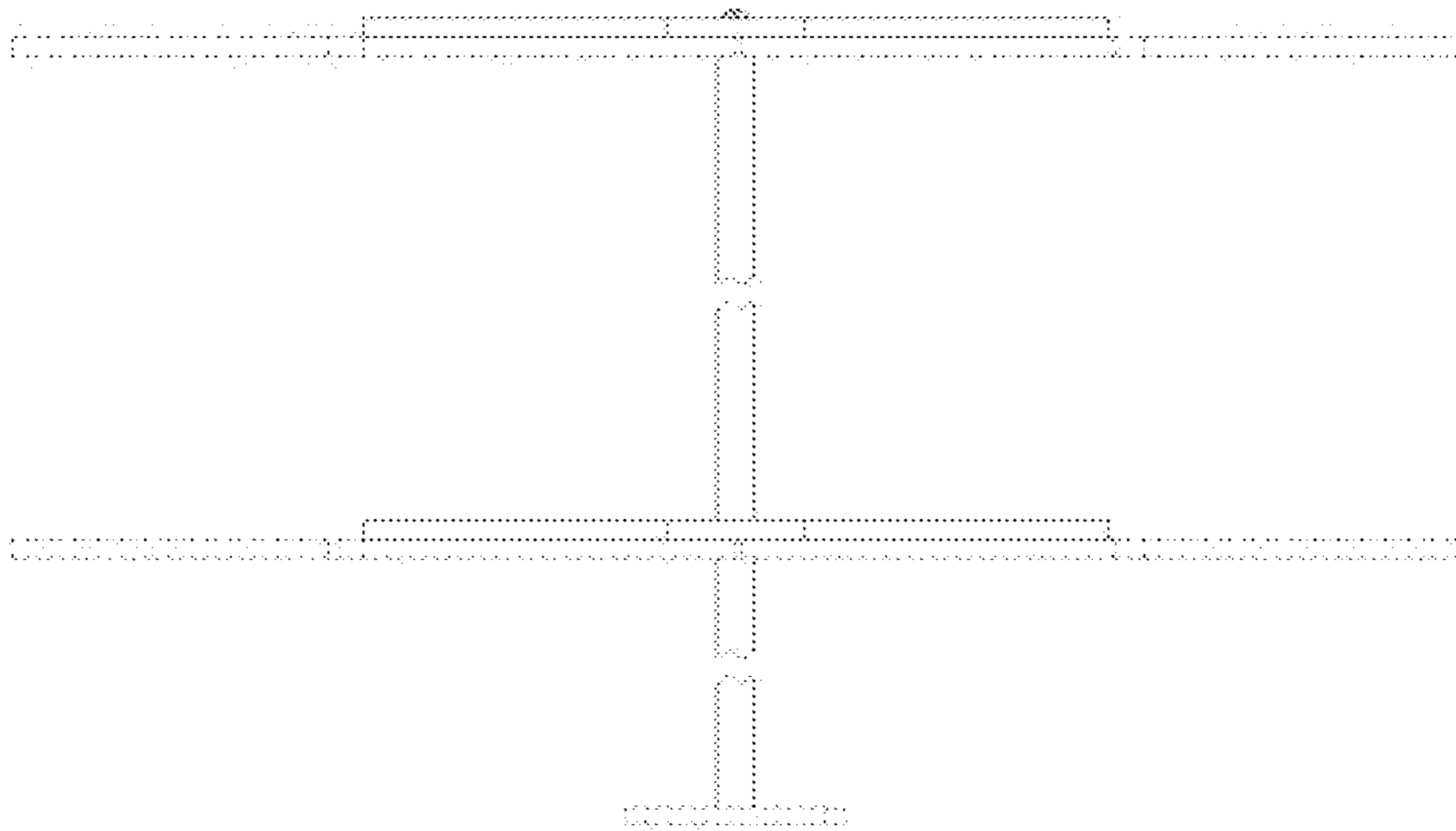

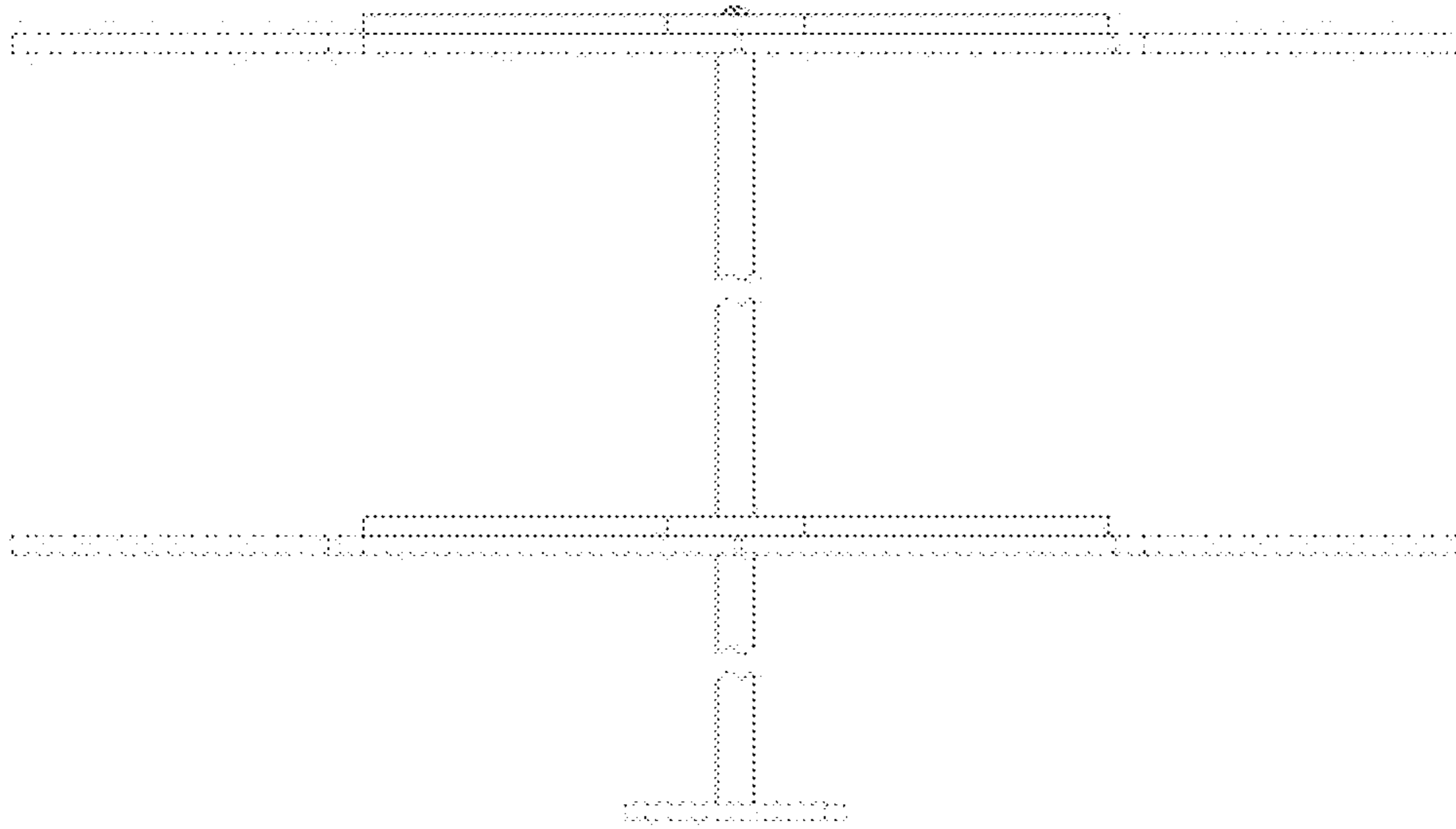

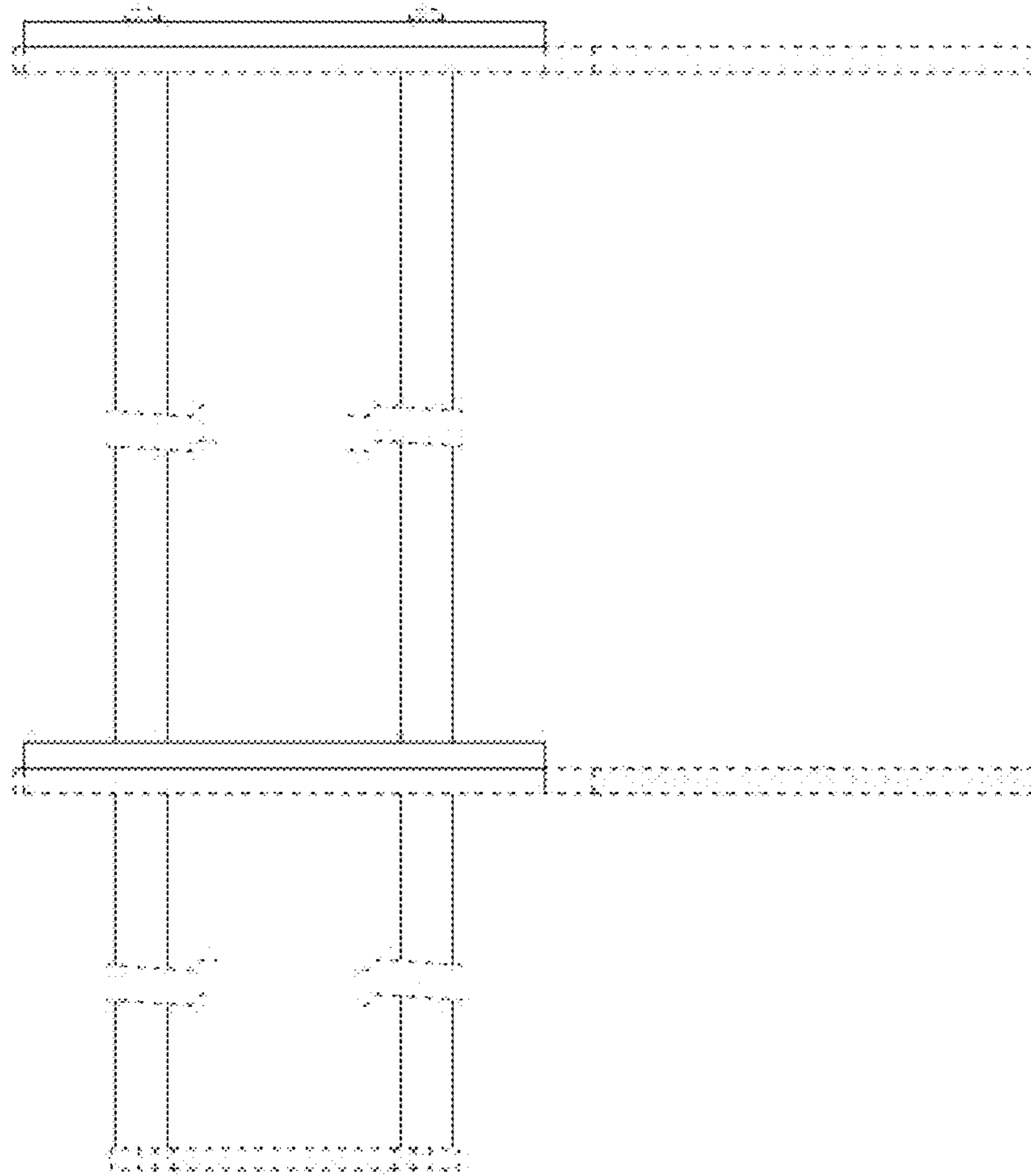

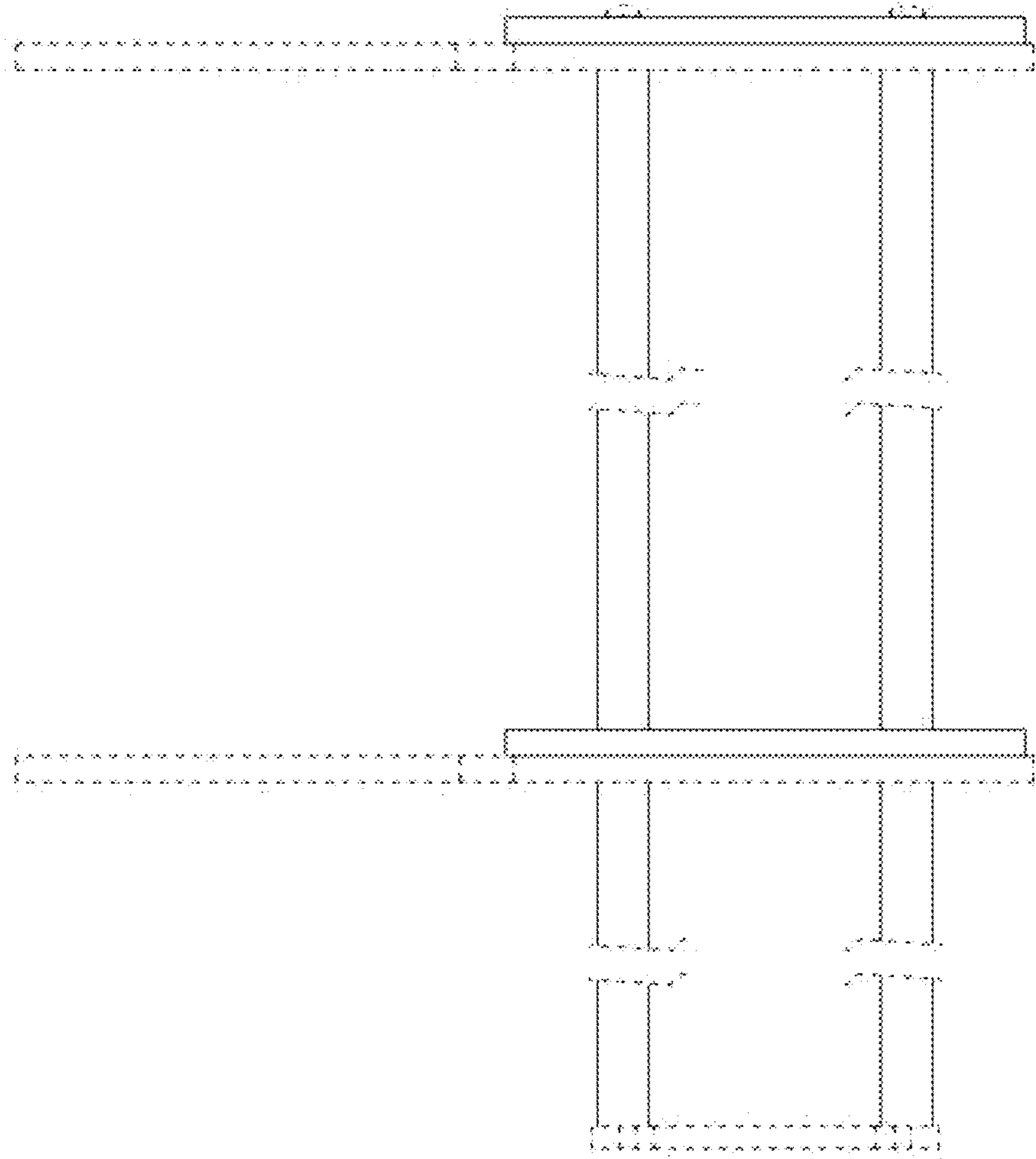

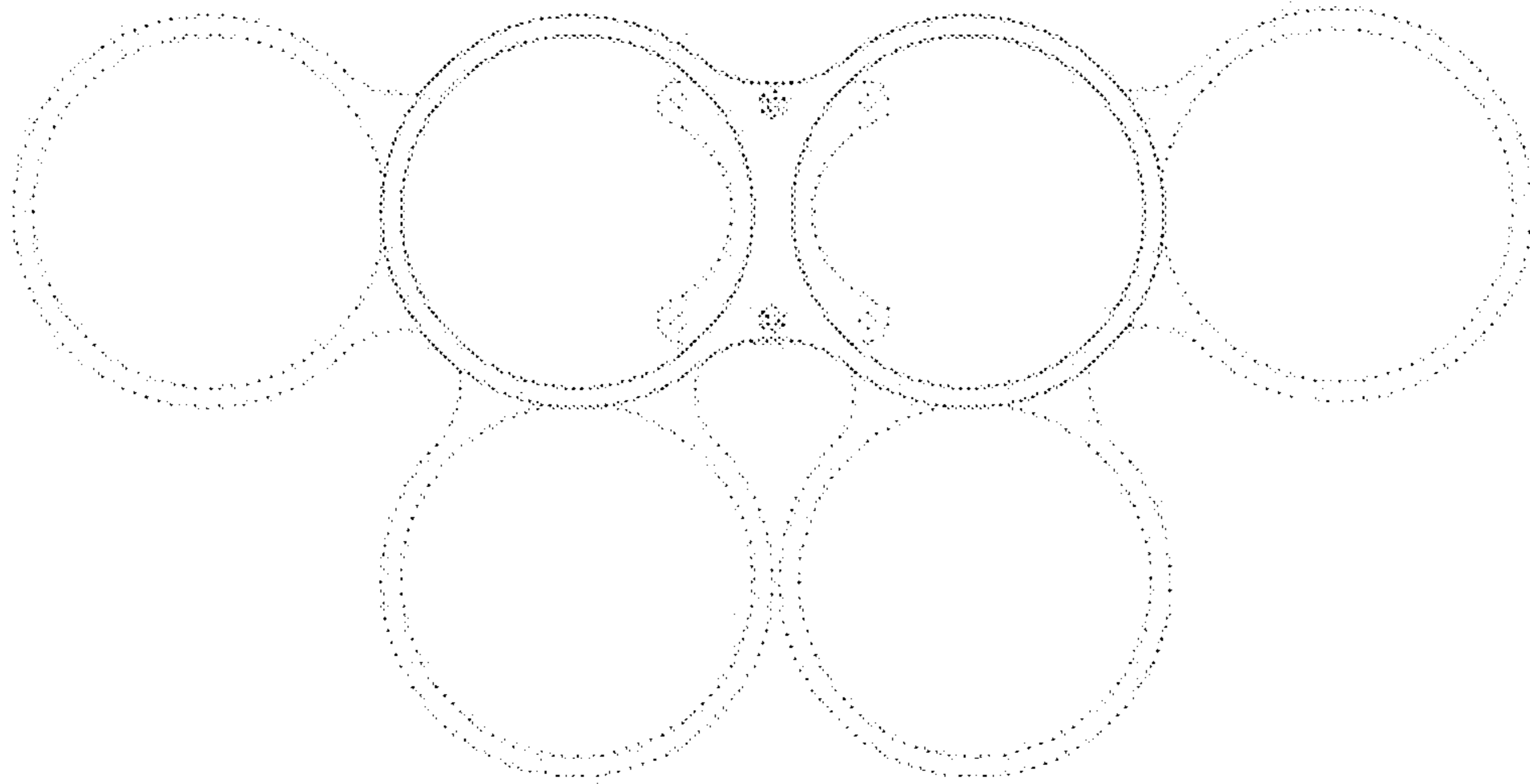

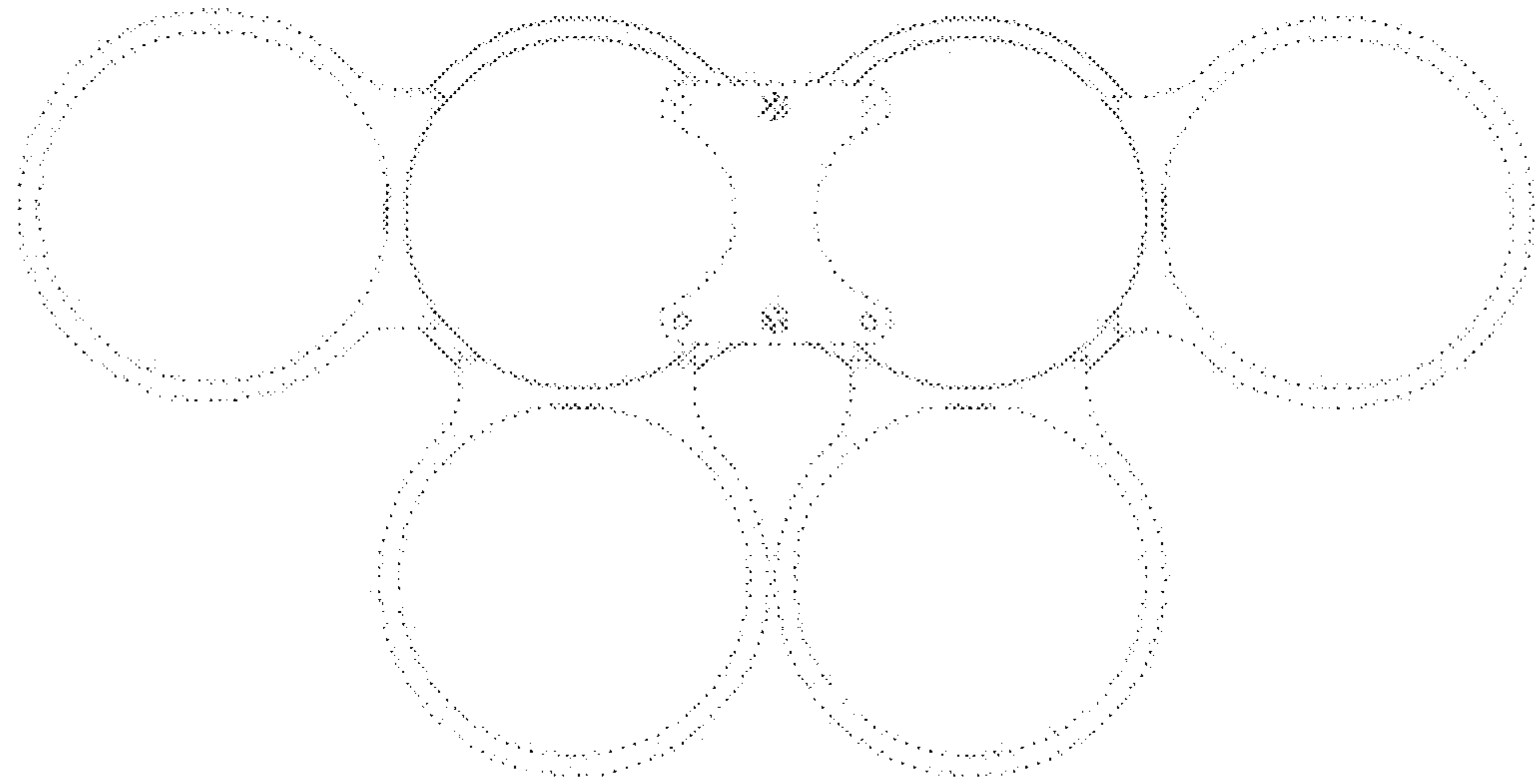
