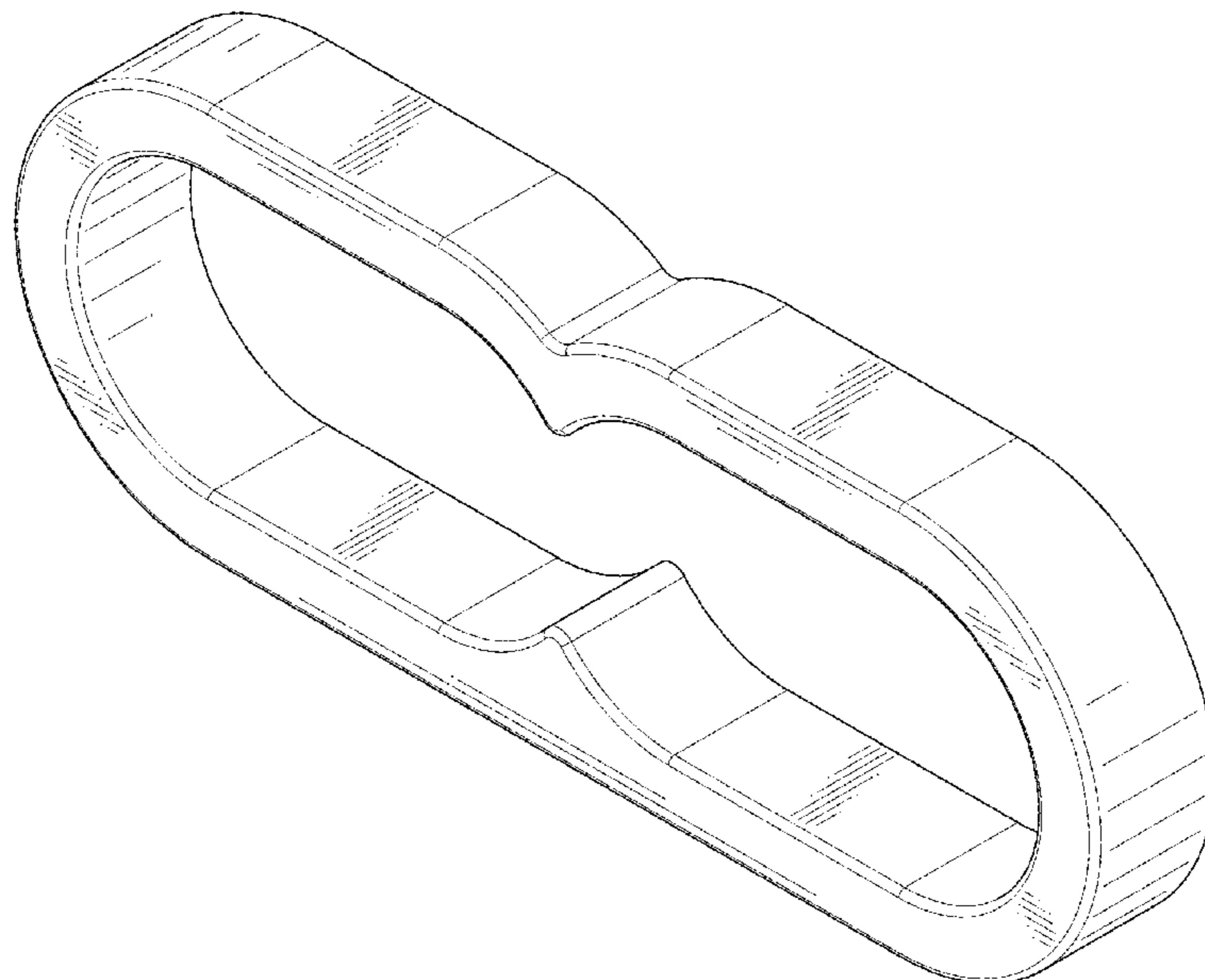
FIG. 1 is a perspective view of a decorative fitting for vehicles, showing my new design;

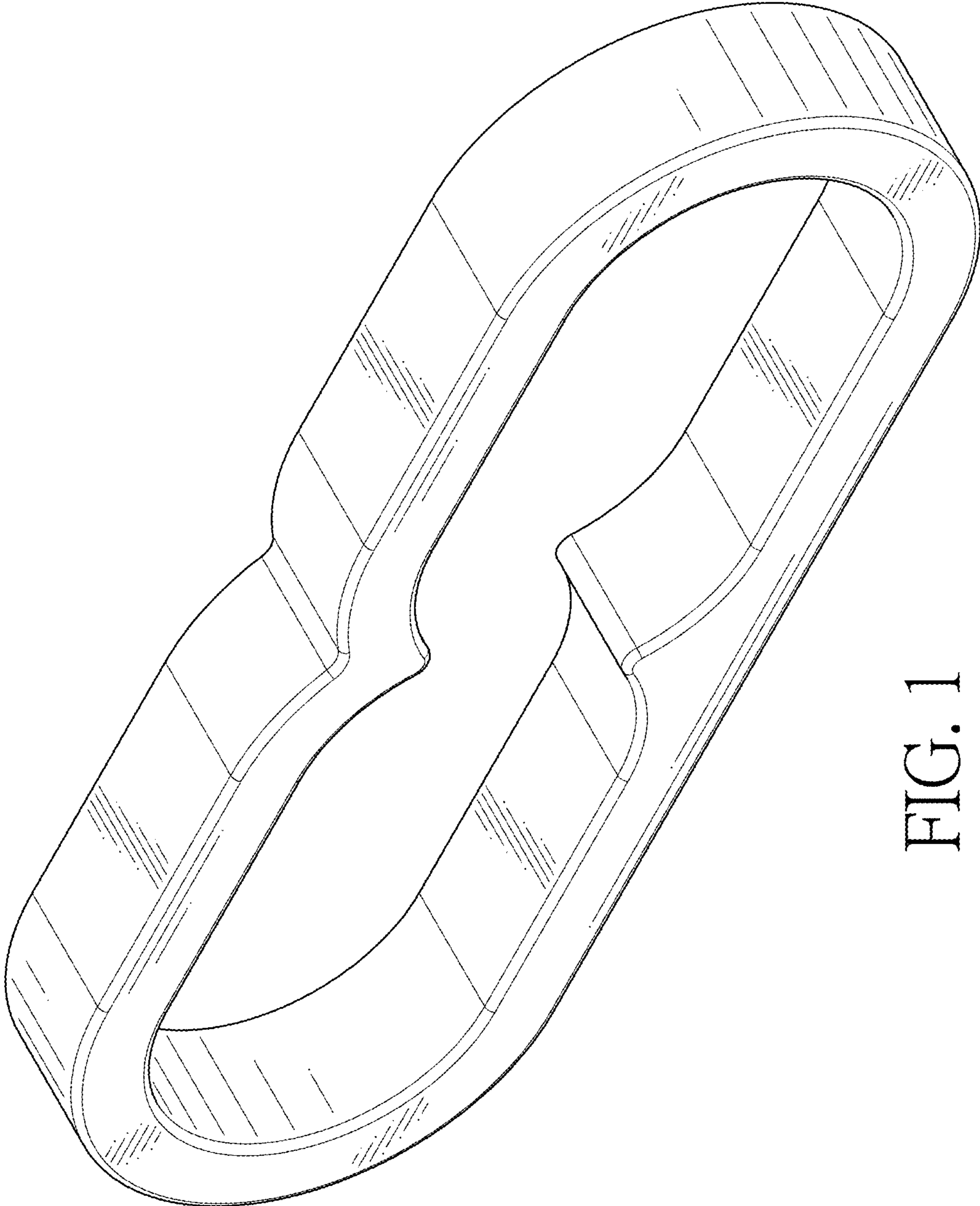

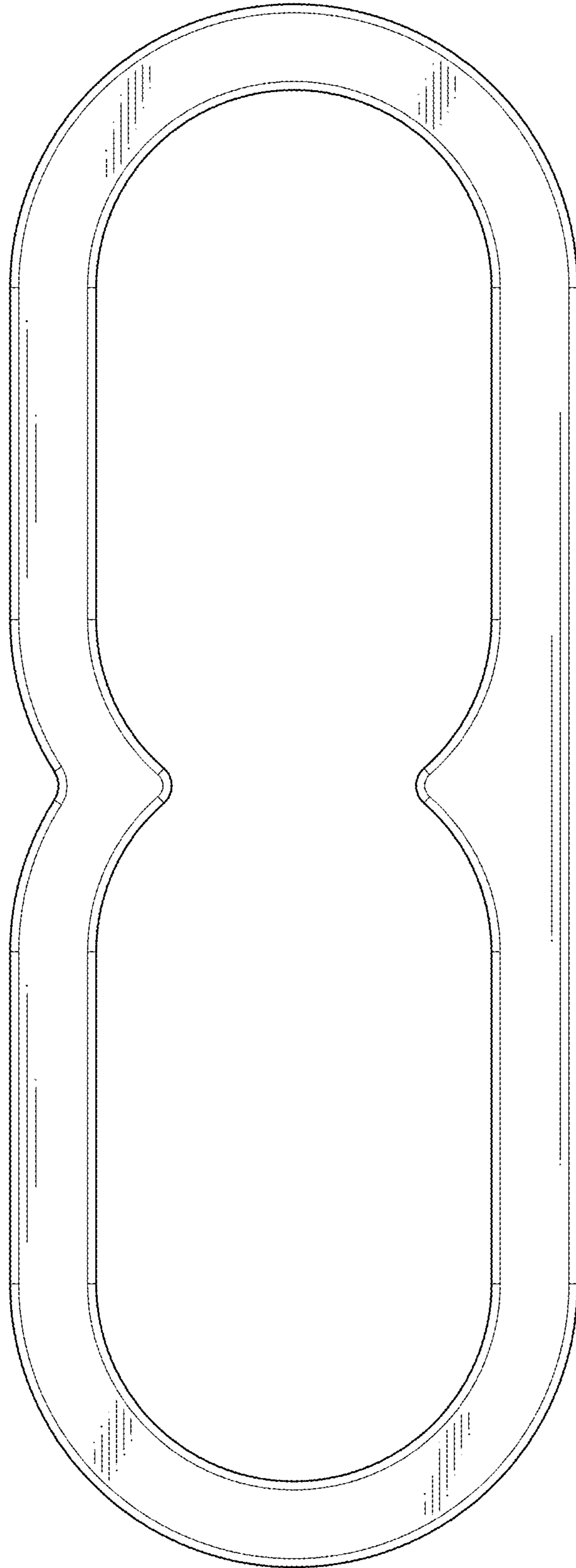

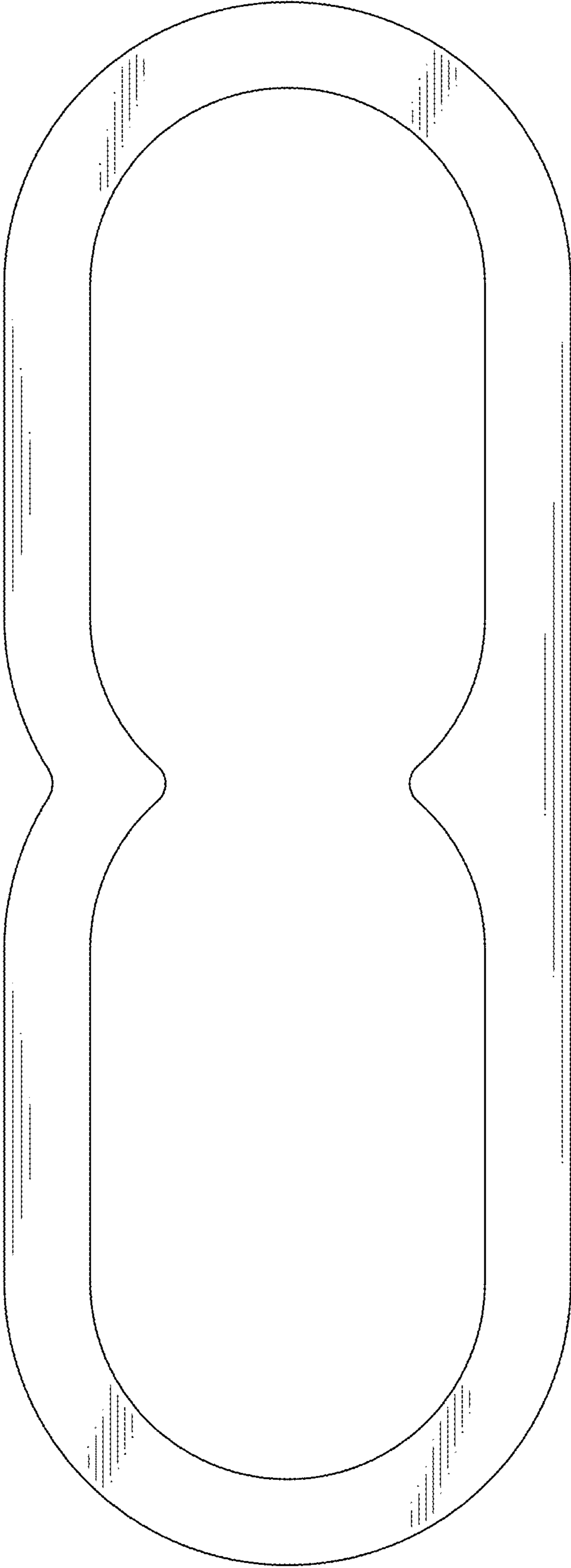

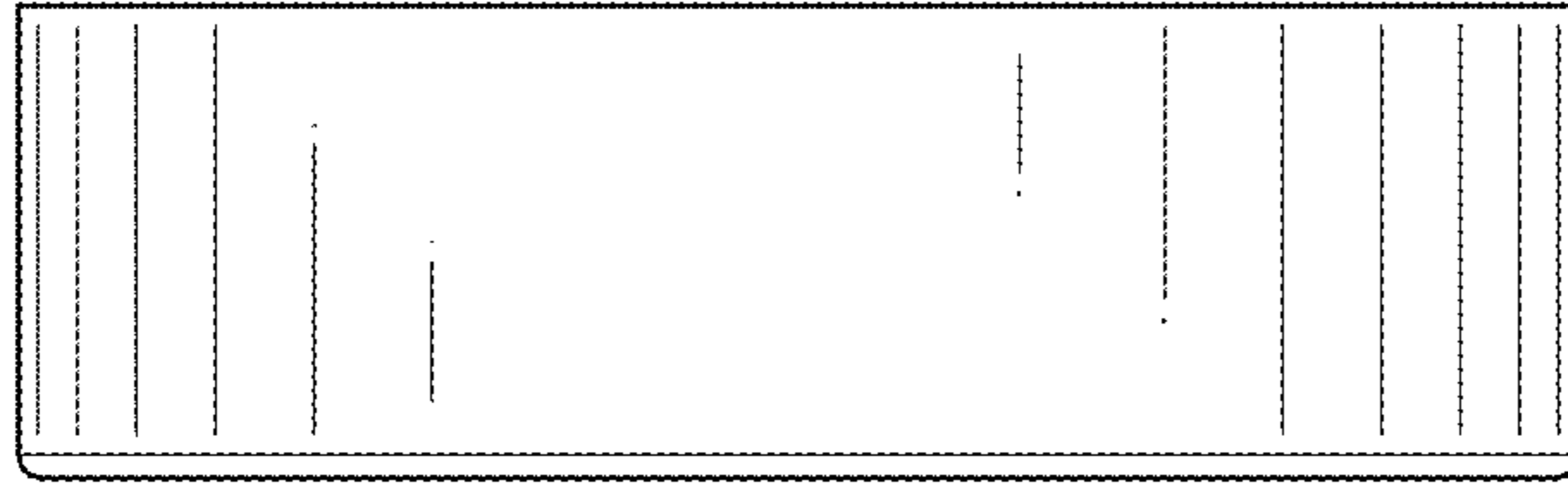

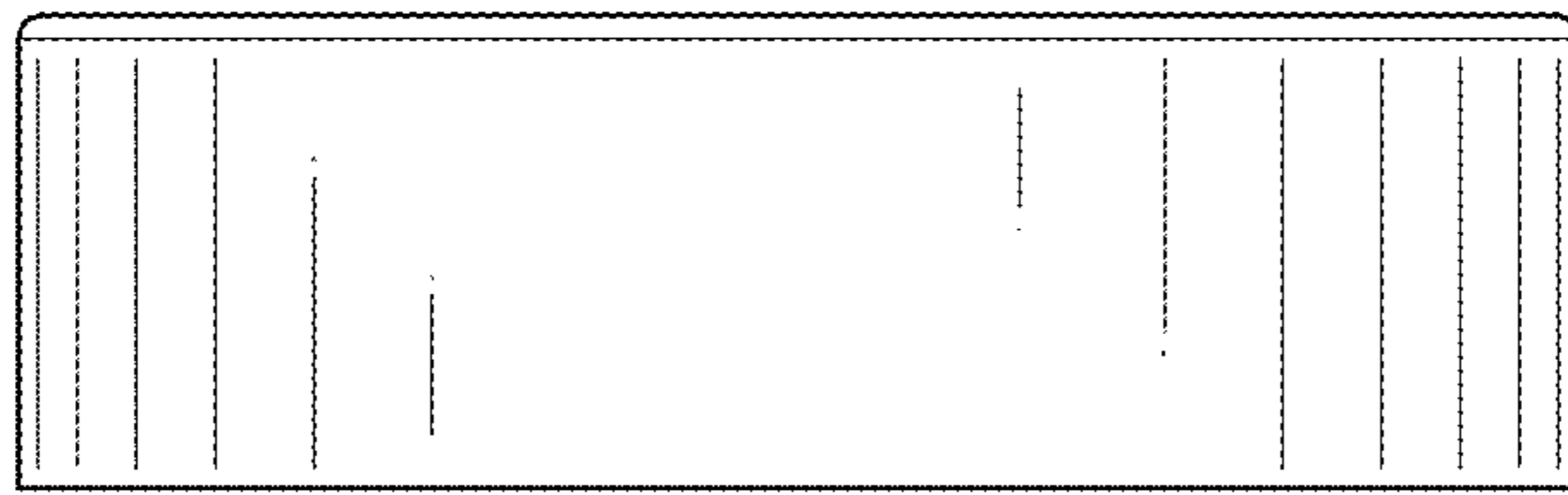

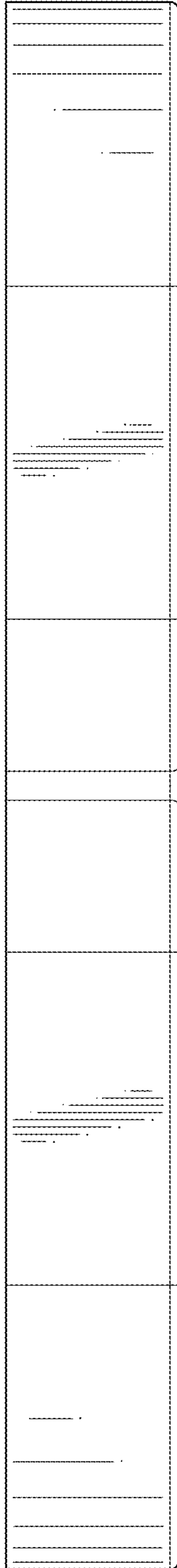

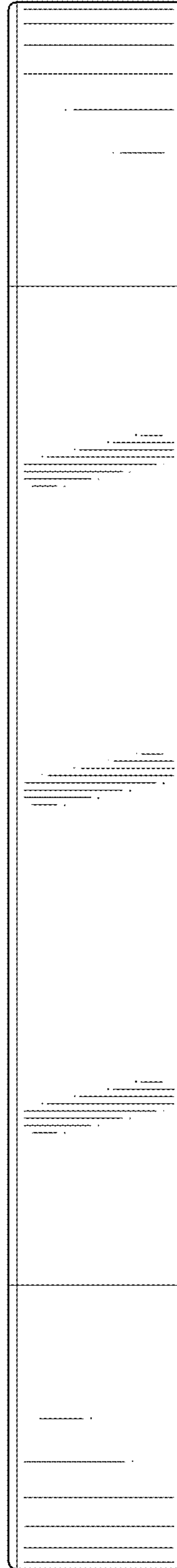

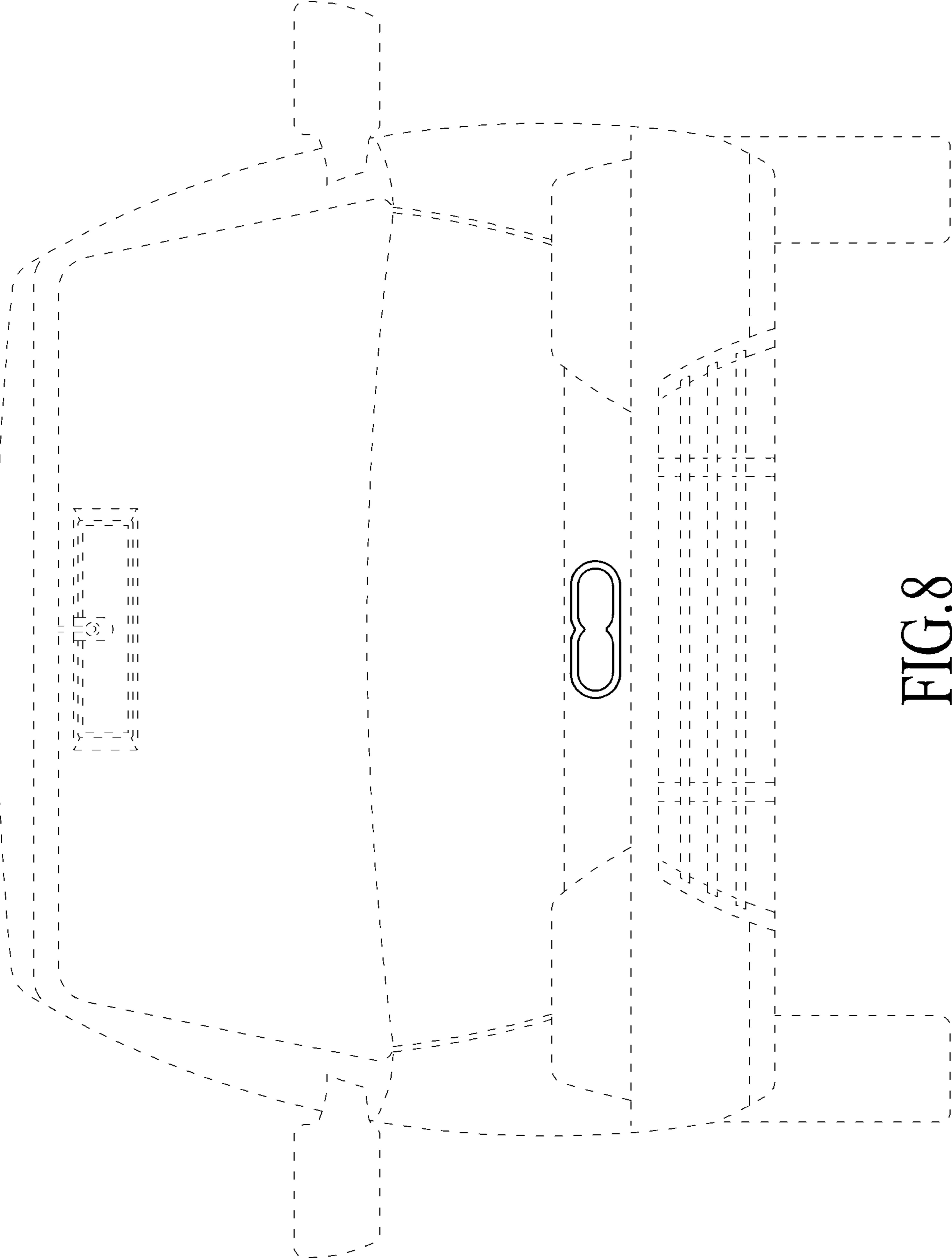
