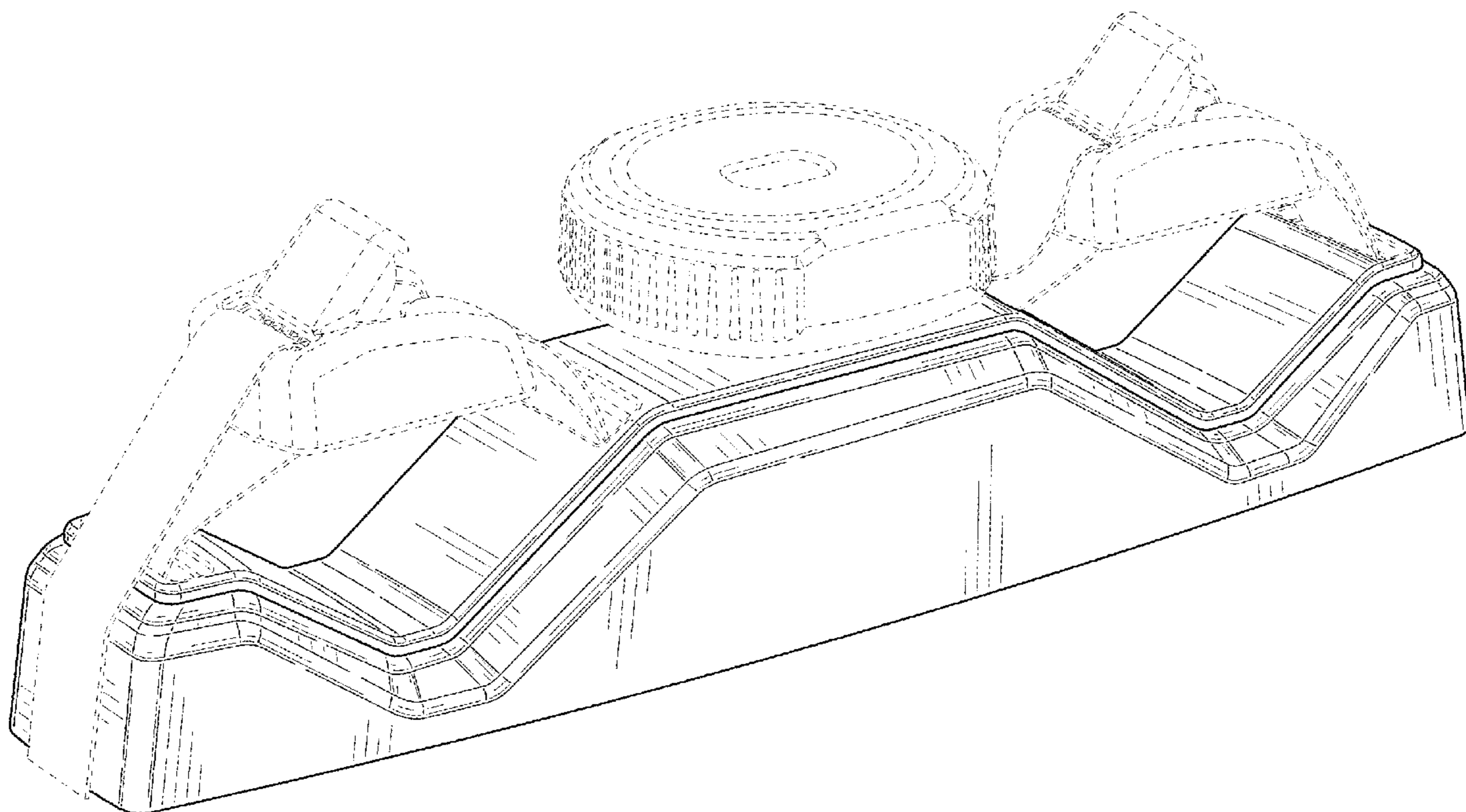
(57) **CLAIM**

The ornamental design for a vehicle roof rack accessory, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a vehicle roof rack accessory showing the claimed design; FIG. 2 is a front view thereof; FIG. 3 is a rear view thereof; FIG. 4 is a right side view thereof; FIG. 5 is a left side view thereof; FIG. 6 is a top view thereof; and, FIG. 7 is a bottom view thereof. The broken lines in the figures show portions of the vehicle roof rack accessory that form no part of the claimed design.

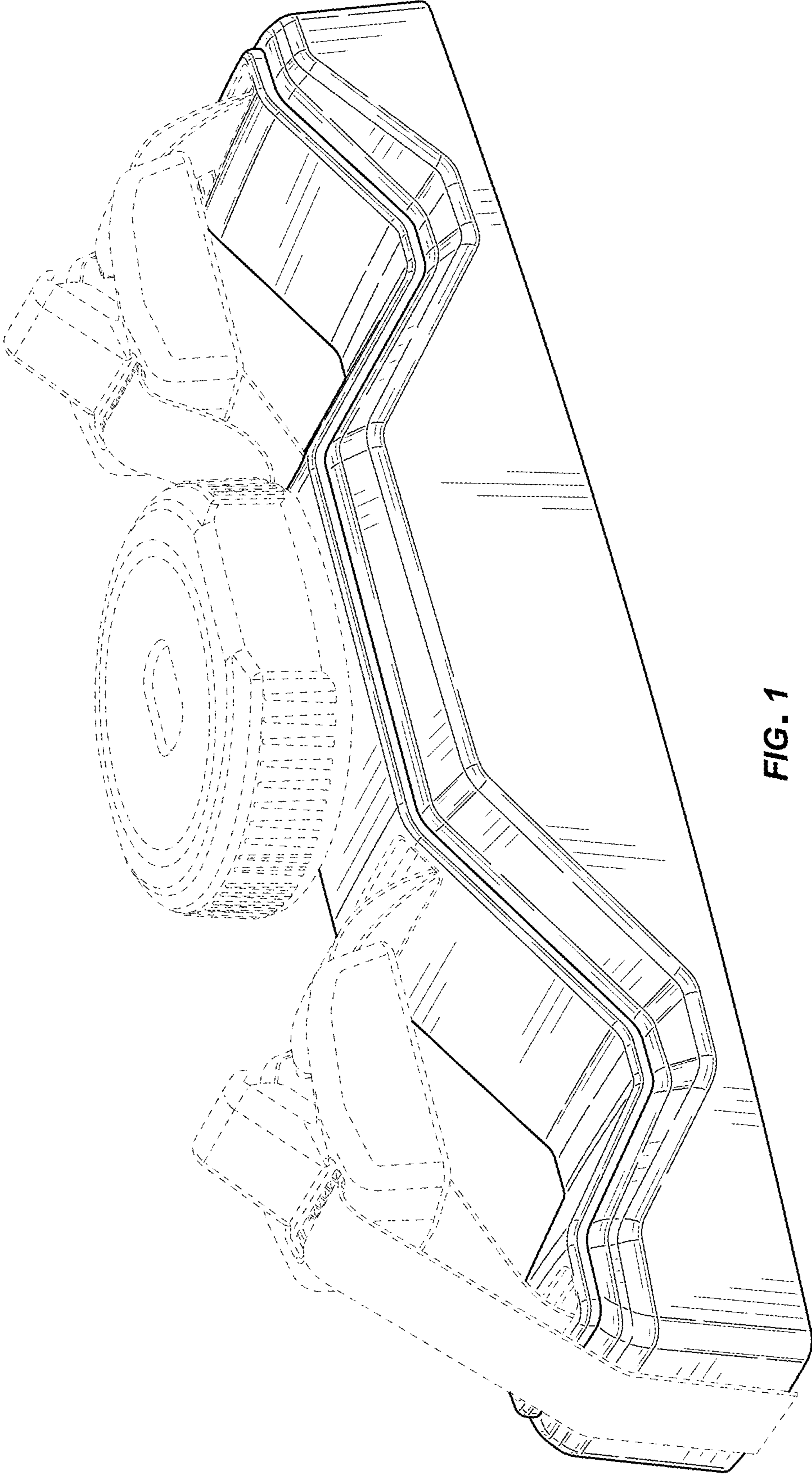

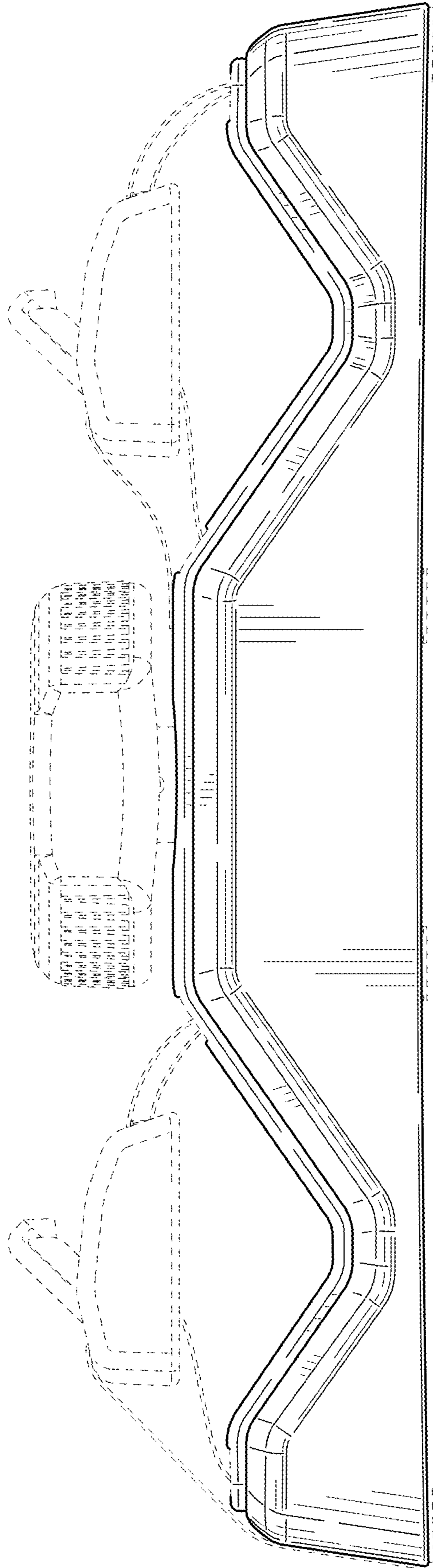

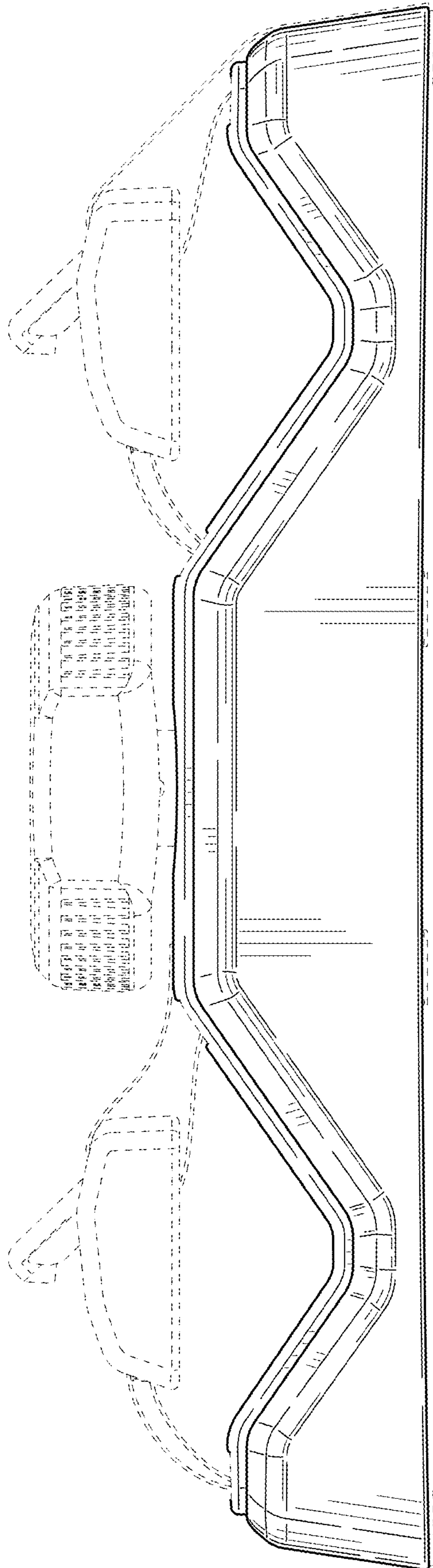
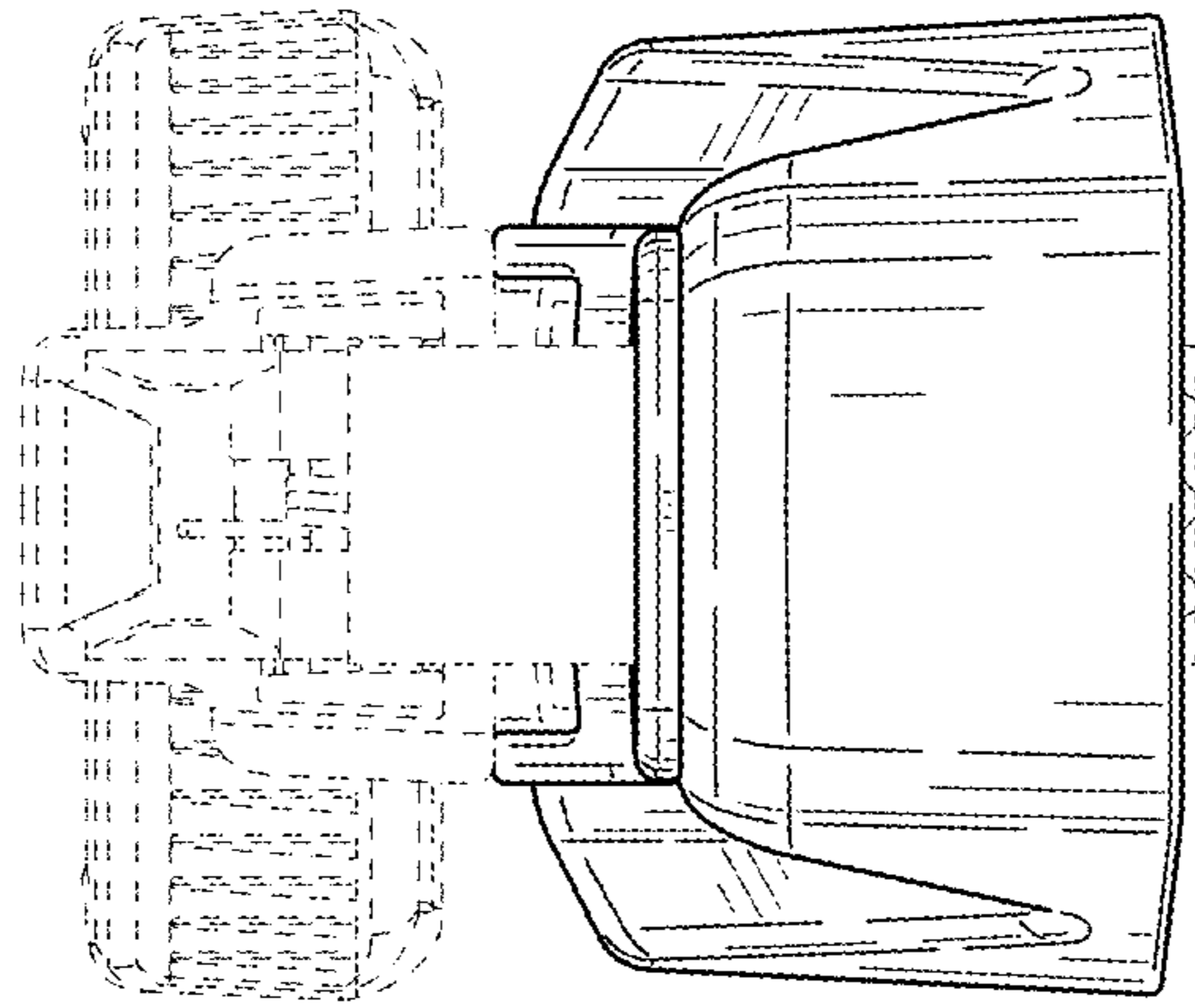

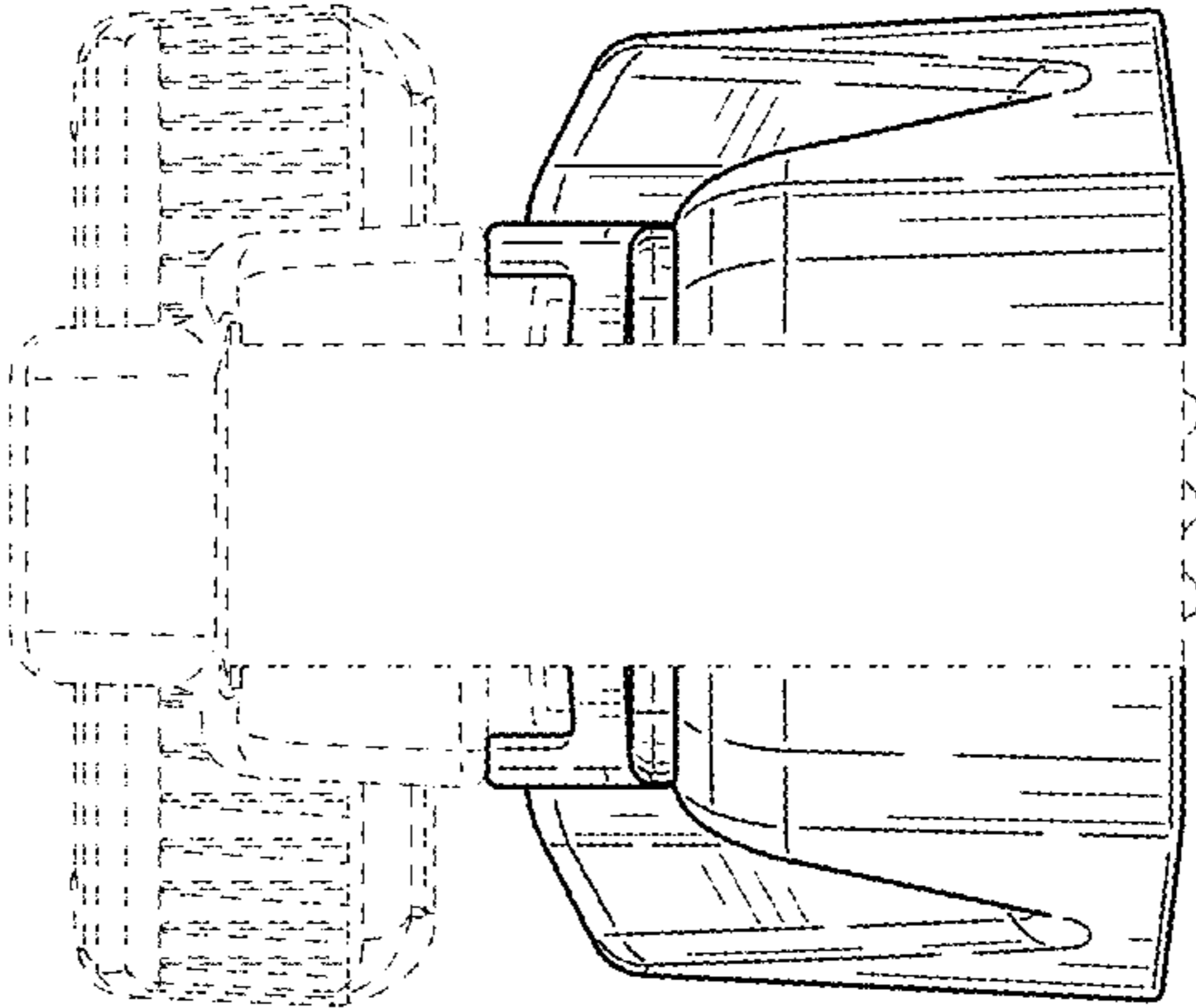

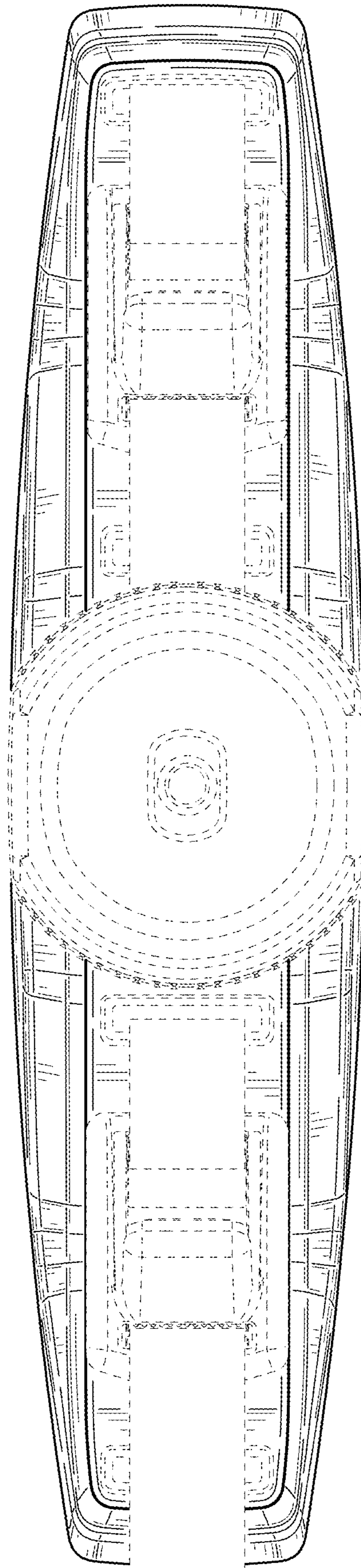

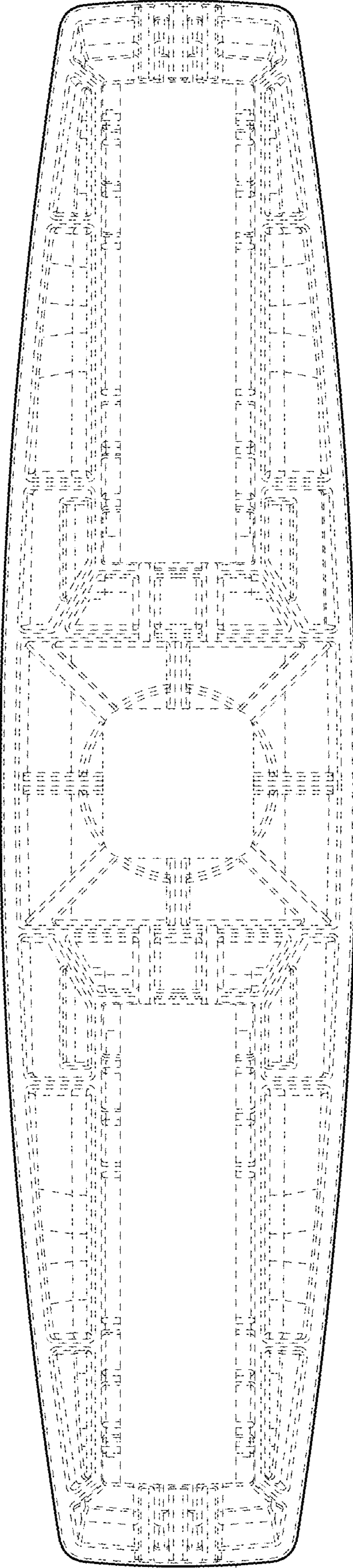
