1.4 is a right side elevation view thereof;

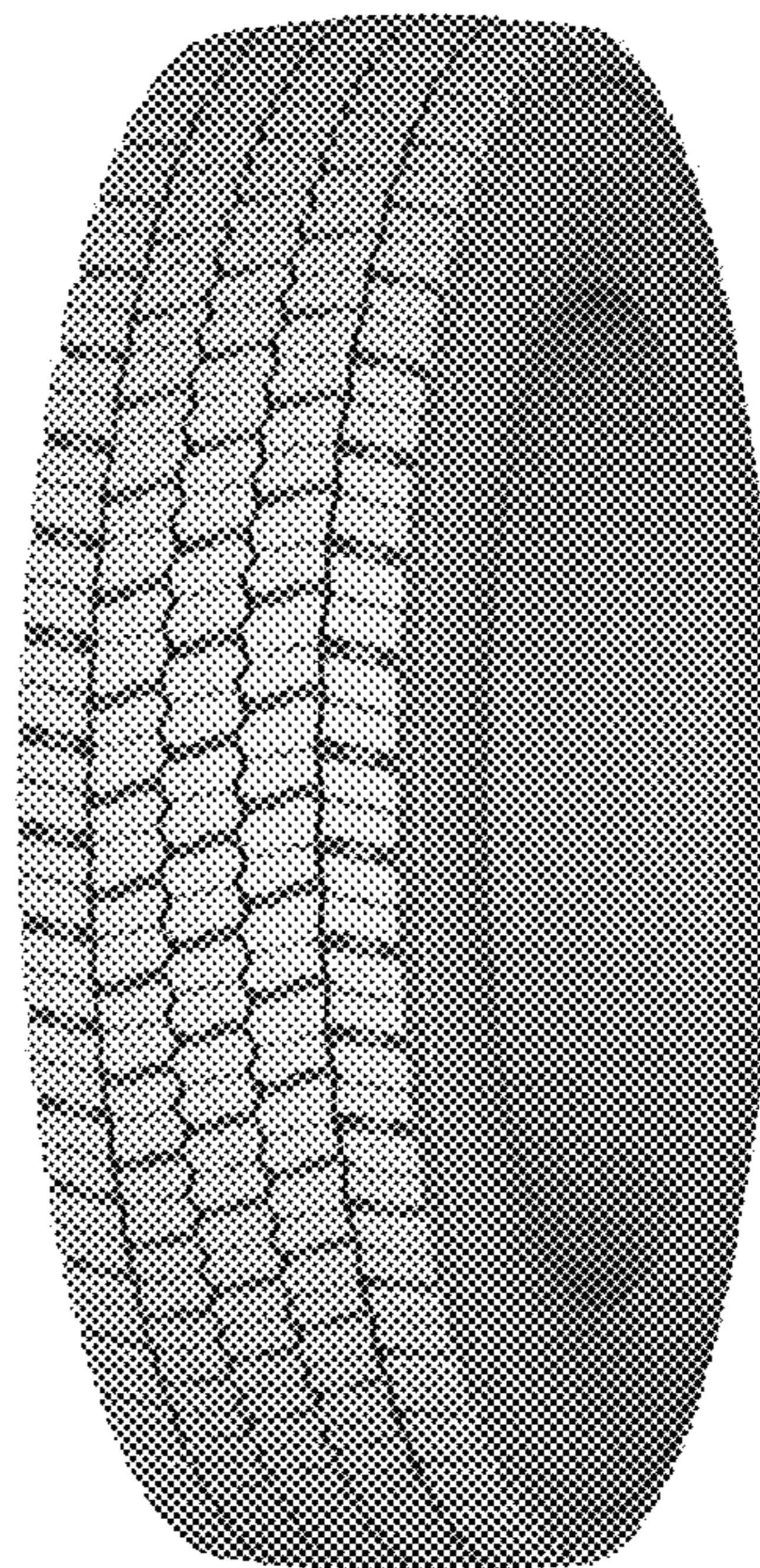
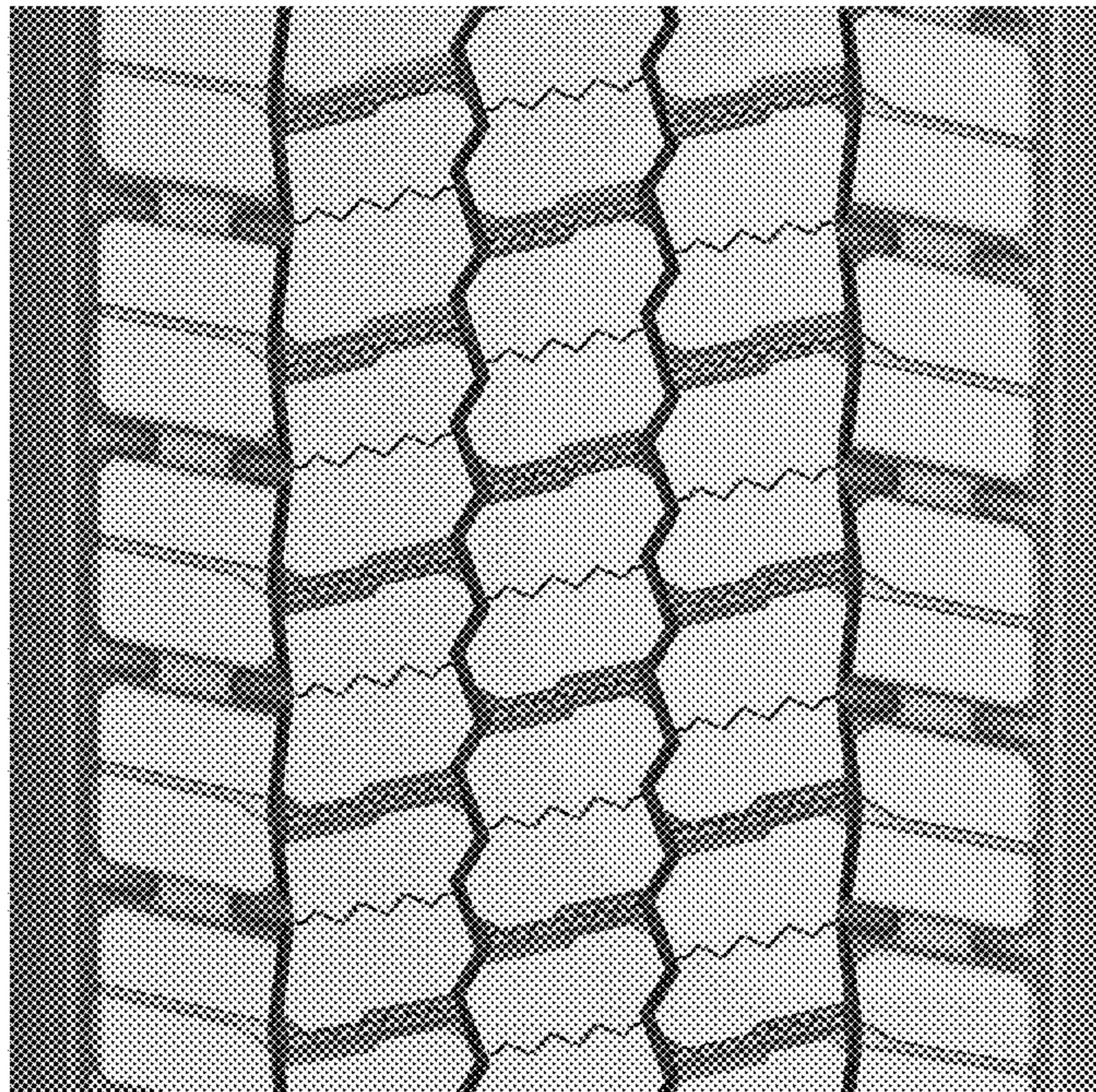
1.5 is a front elevation view thereof; and

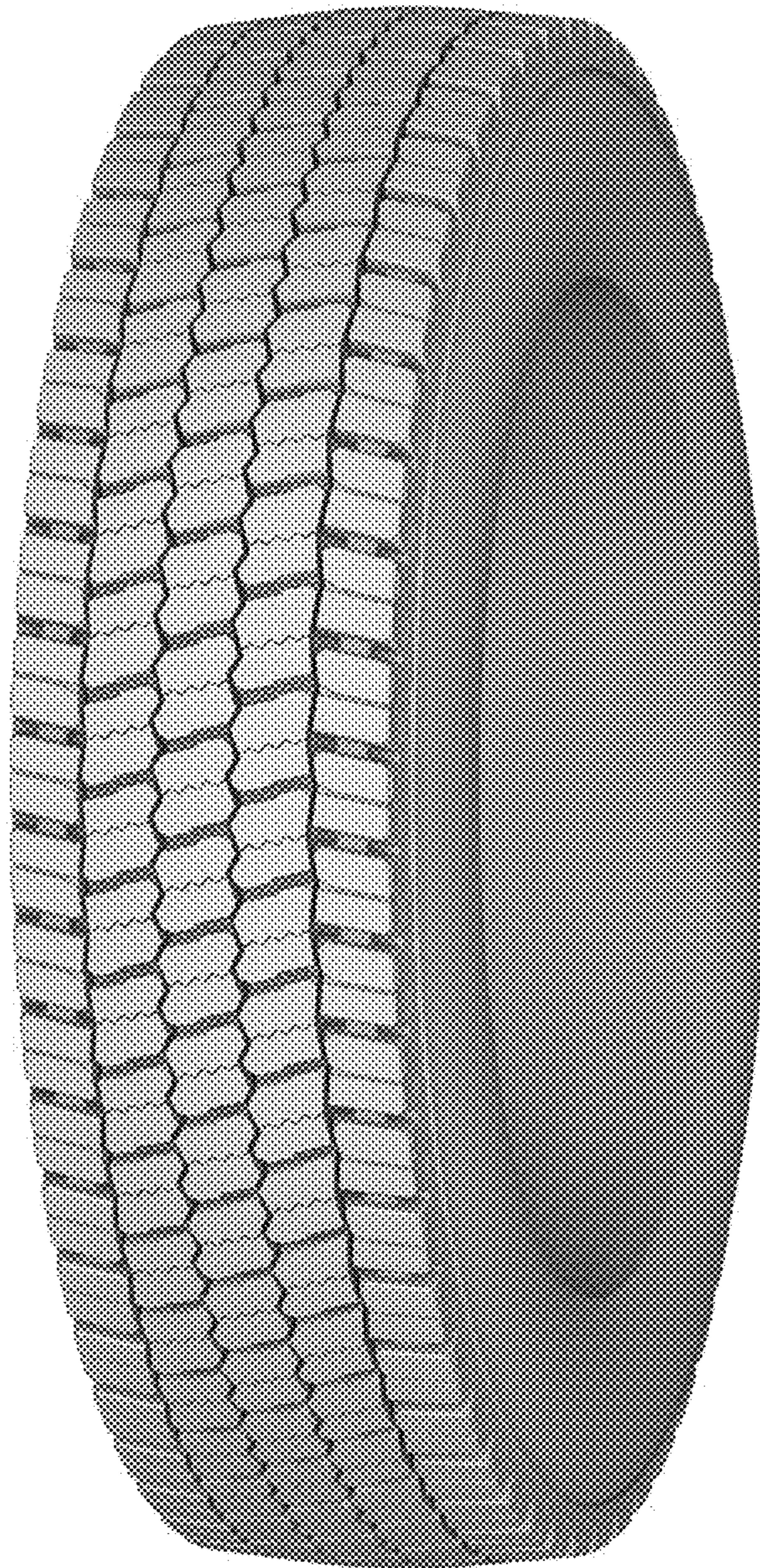

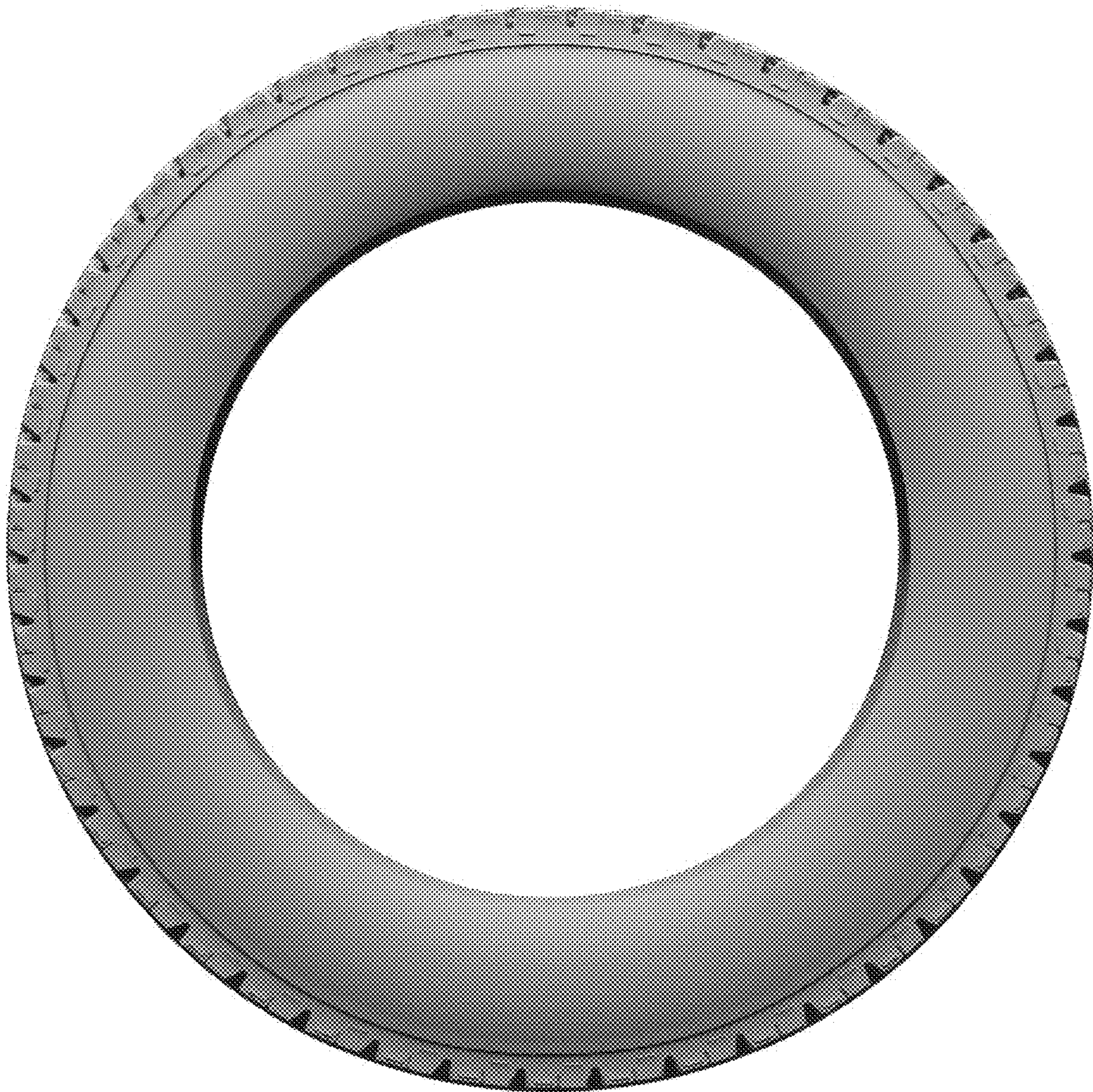

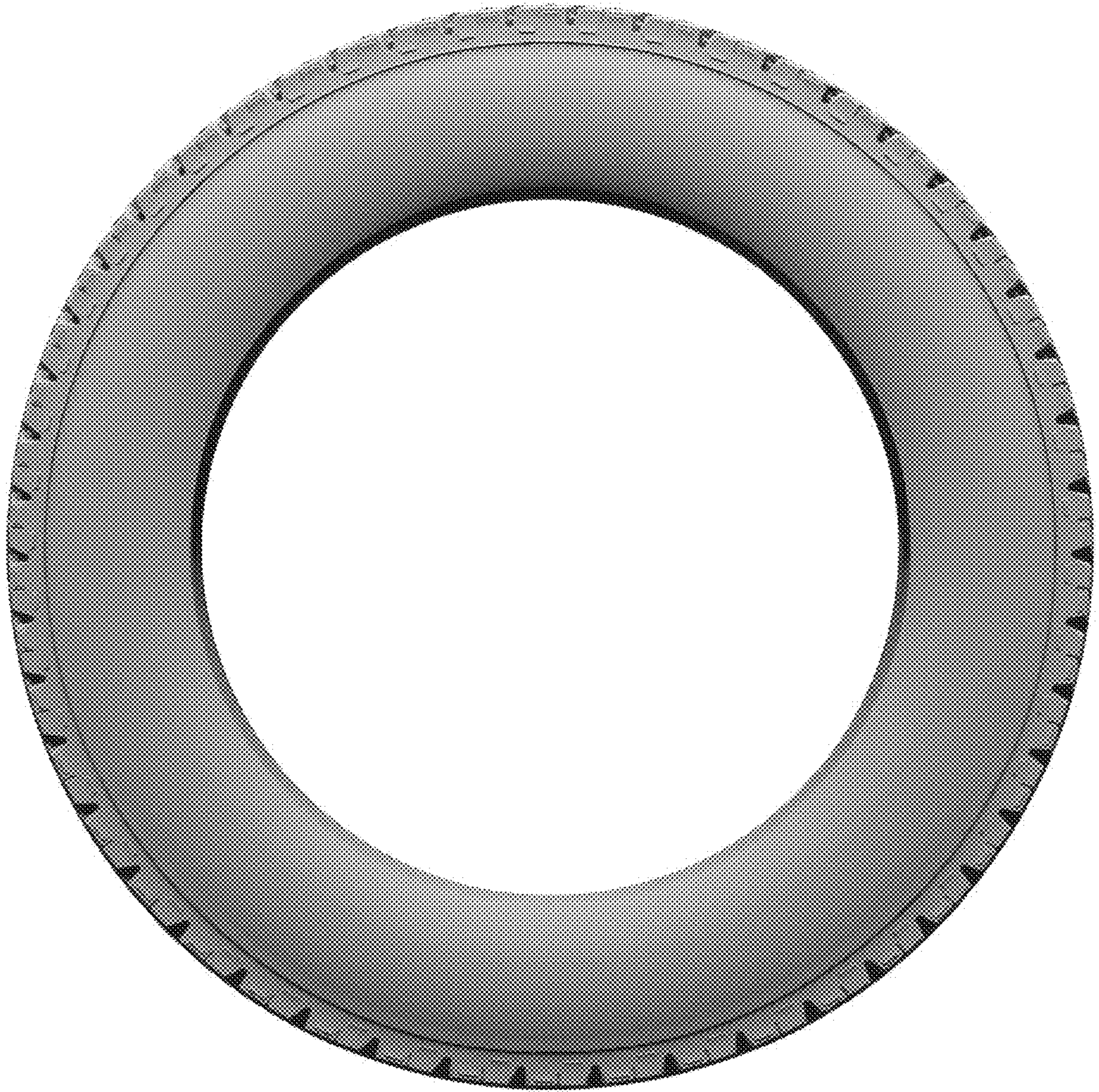

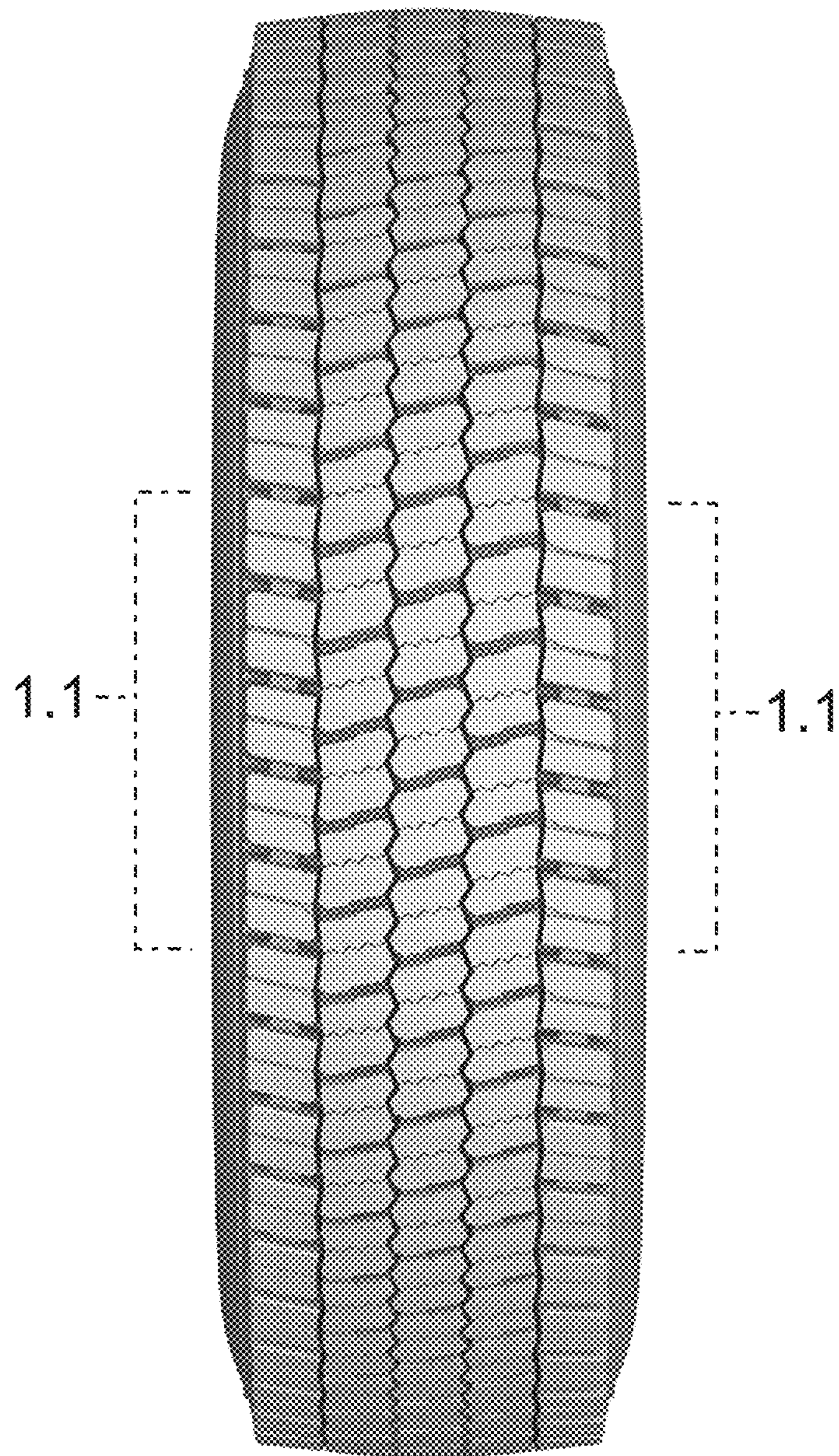
