(57) **CLAIM**

The ornamental design for a desk phone, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a desk phone, showing our new design;

FIG. 2 is a top-left-back perspective view thereof;

FIG. 3 is a bottom view thereof;

FIG. 4 is a top view thereof;

FIG. 5 is a left-side view thereof;

FIG. 6 is a right-side view thereof;

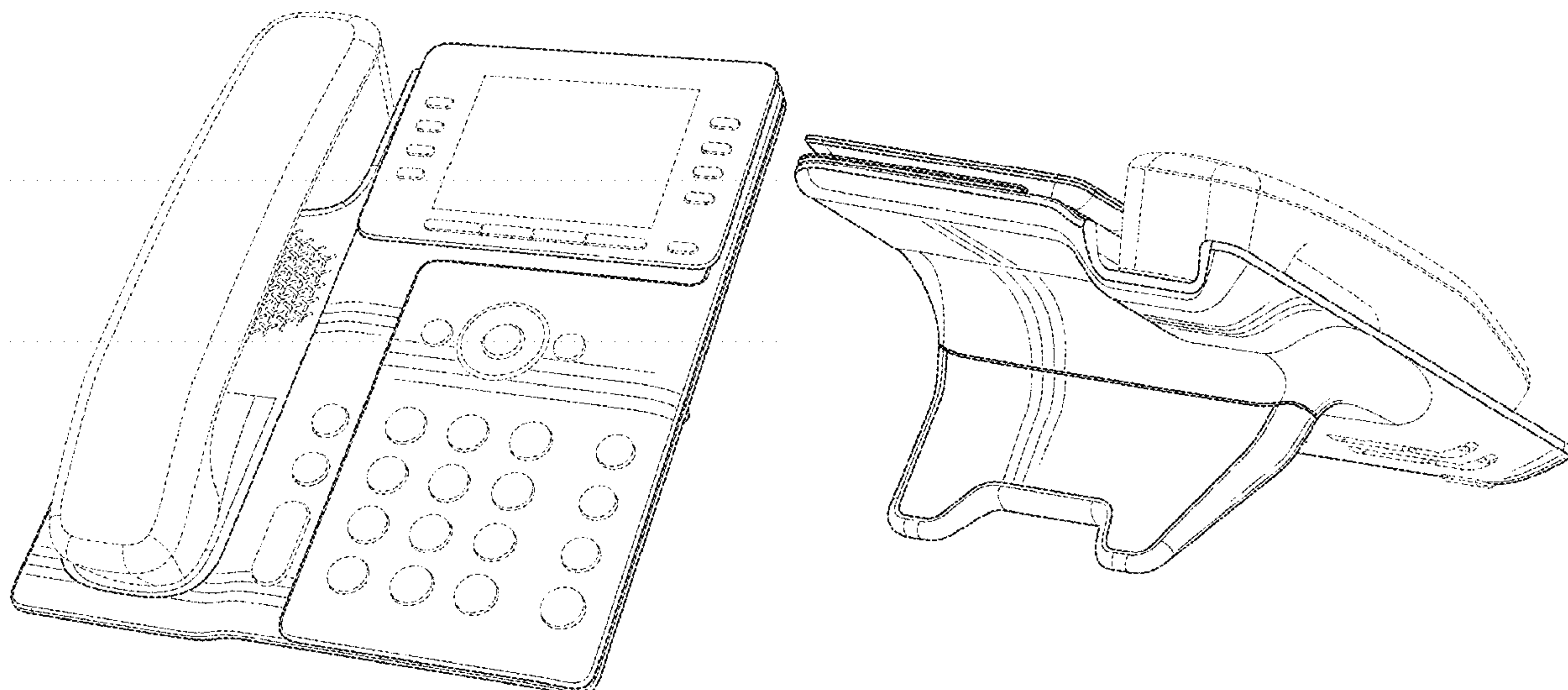
FIG. 7 is a front view thereof; and,

FIG. 8 is a back view thereof.

The broken lines in the drawings depict portions of the desk phone that form no part of the claimed design.

The thin, black lines shown in long dashes with intermittent breaks are shading and/or tangent lines to show contour of the surfaces or curved edges of a desk phone, and do not actually appear on the surface of the device.

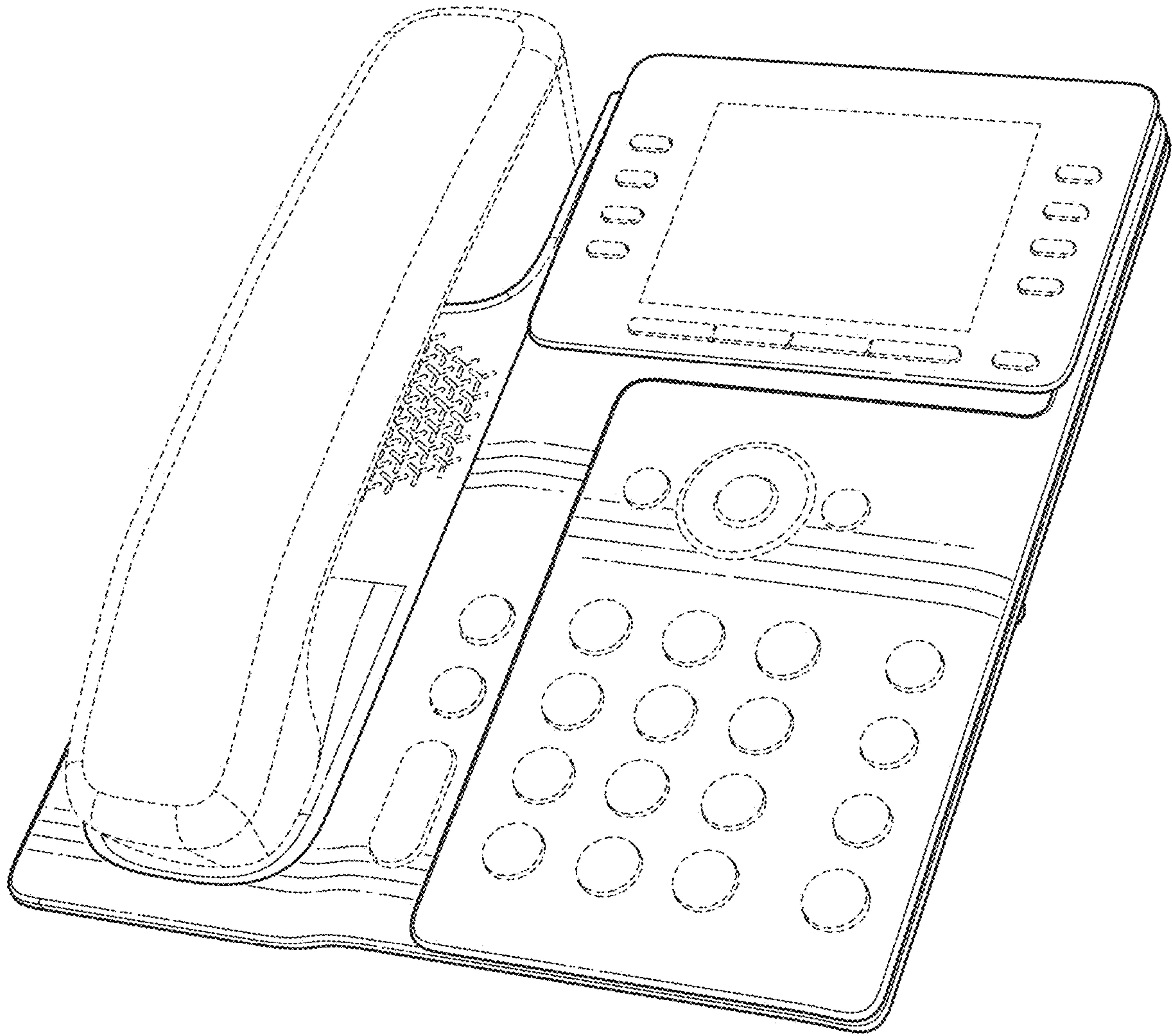

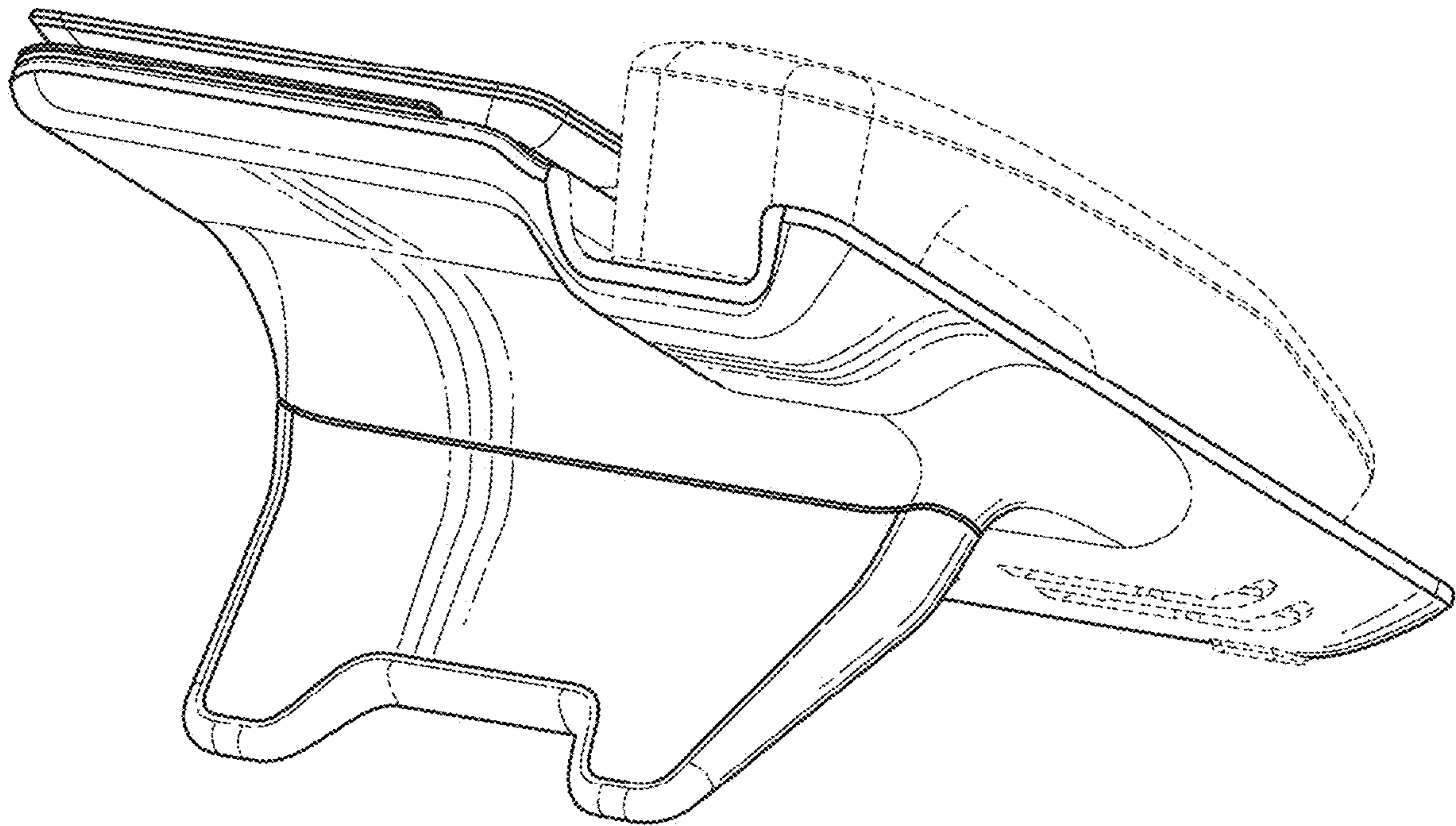

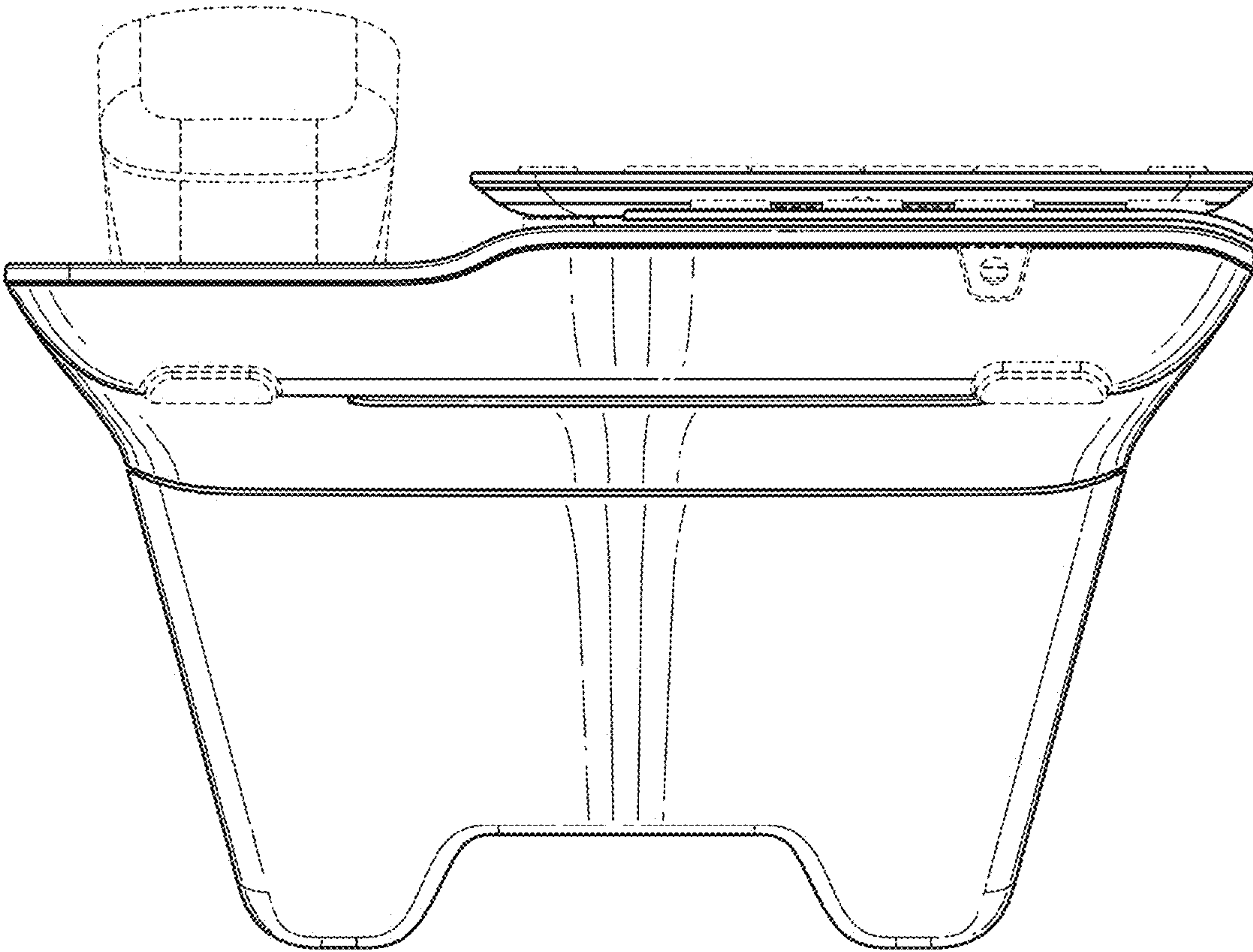

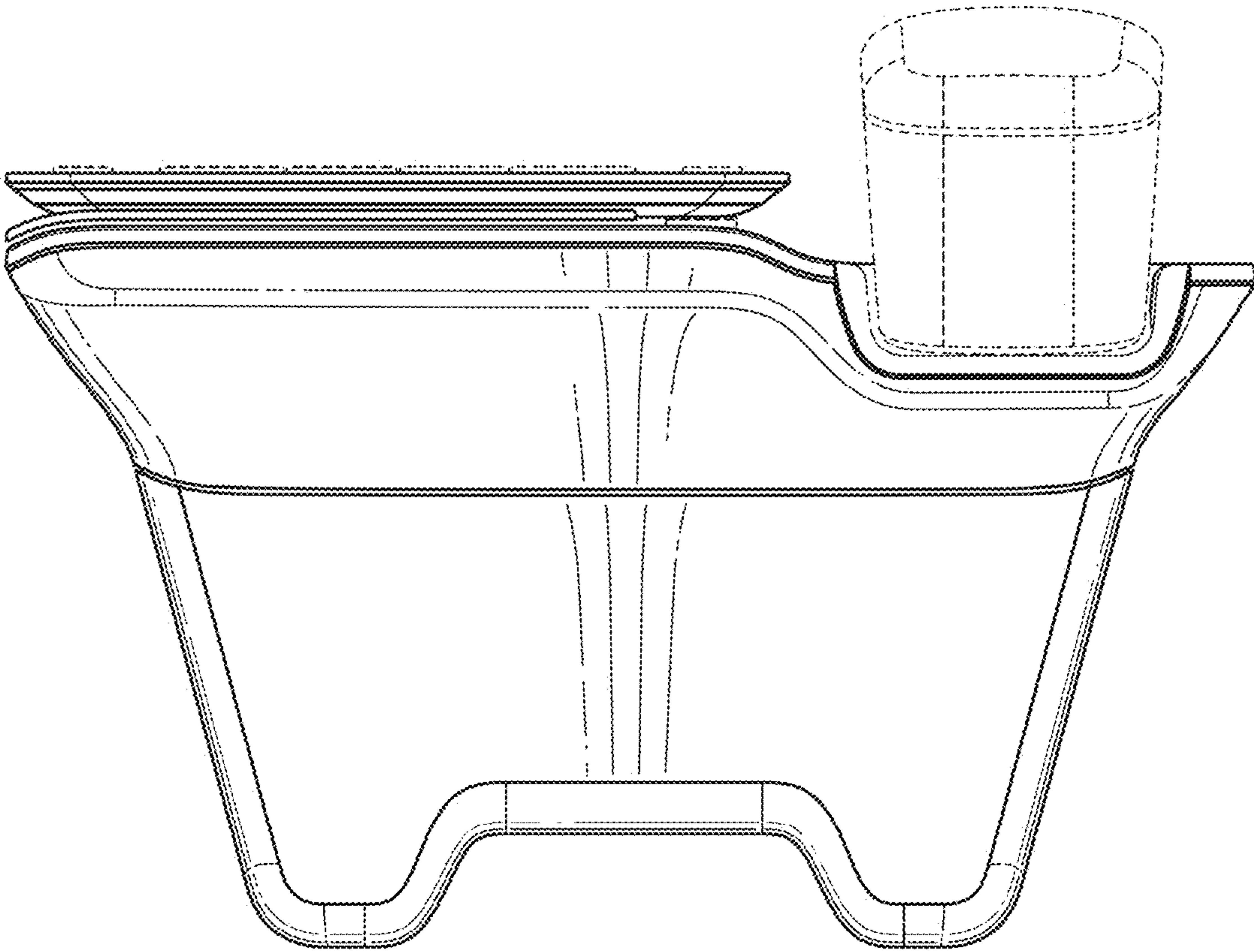

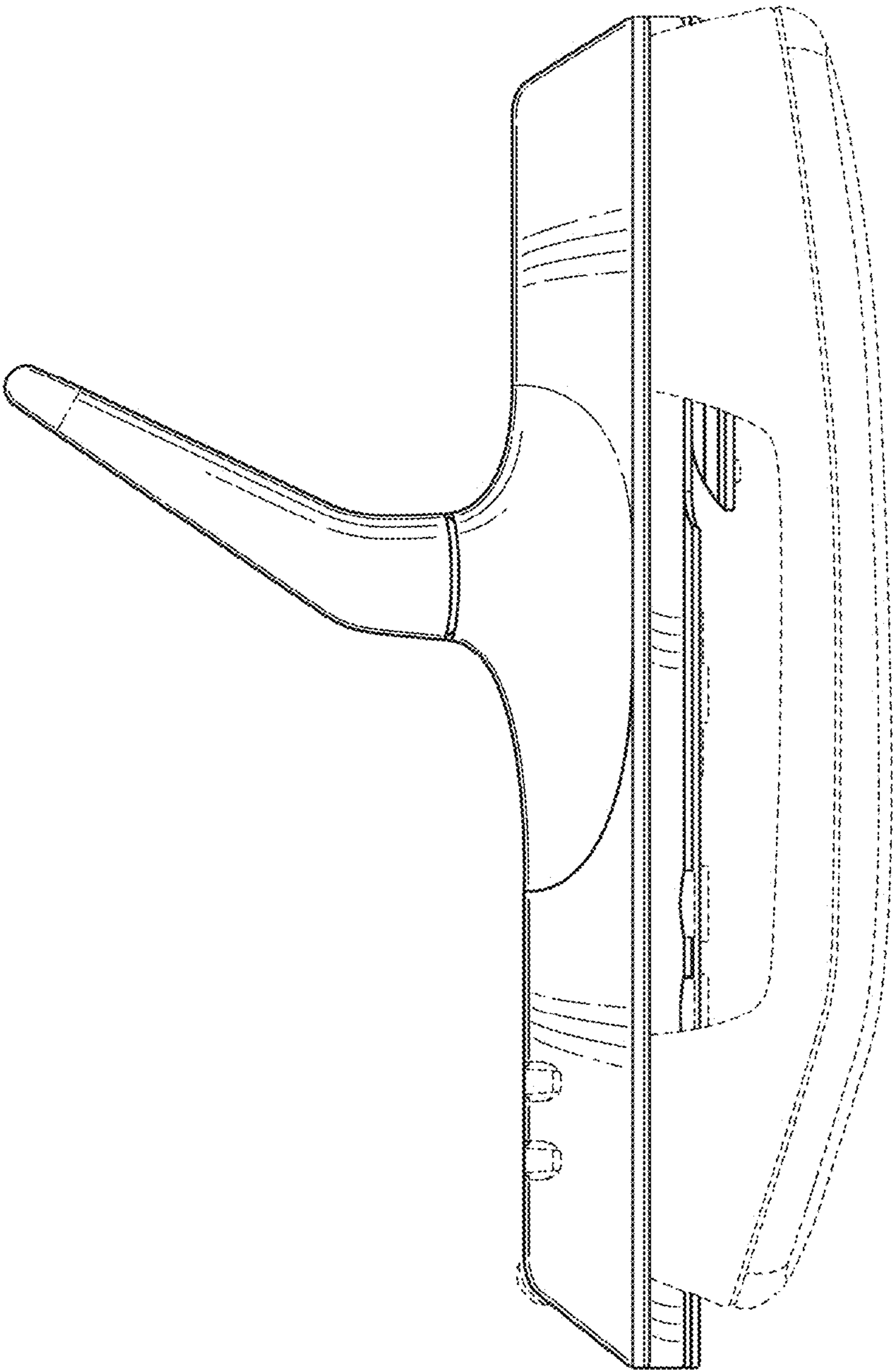

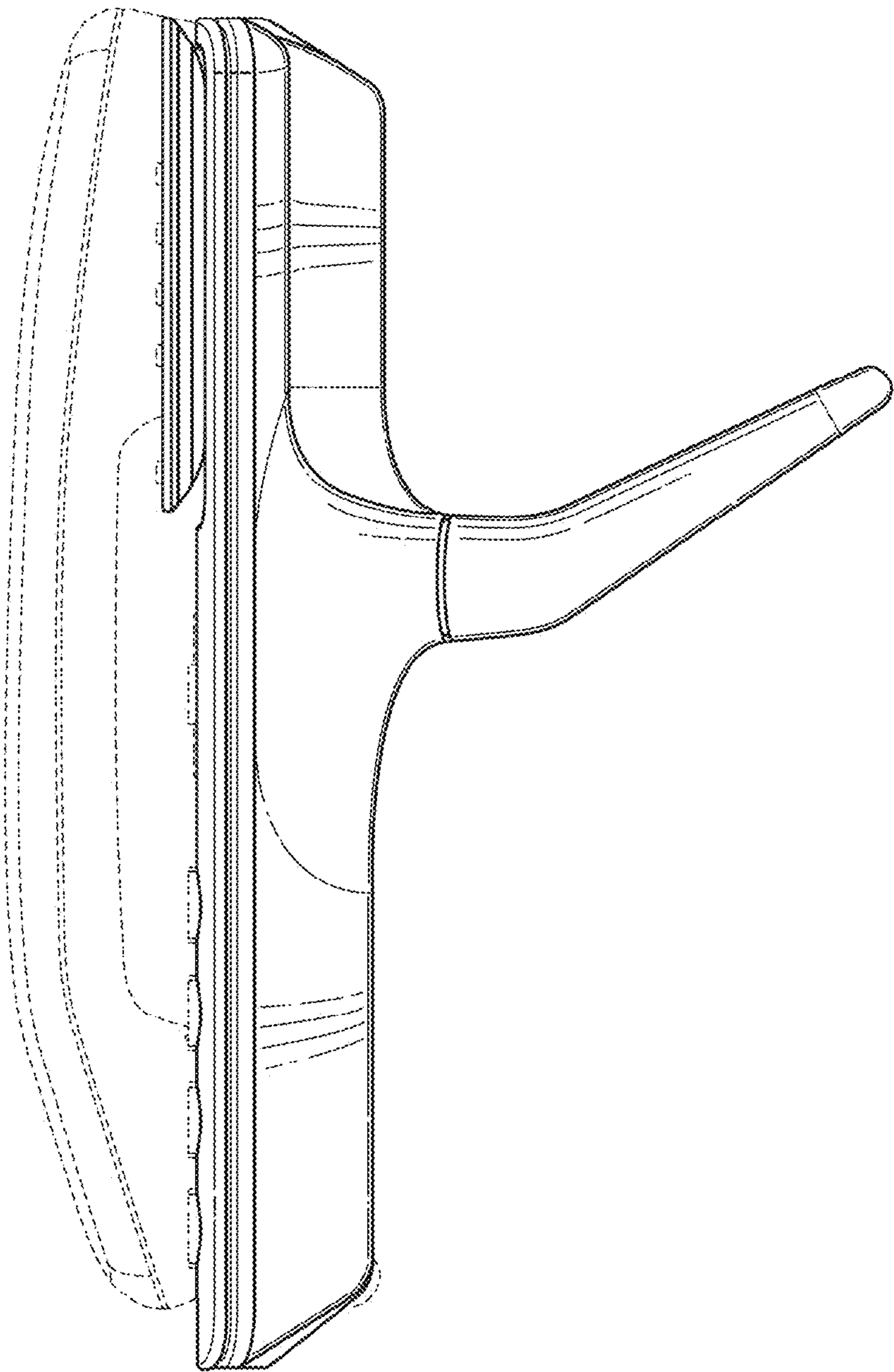

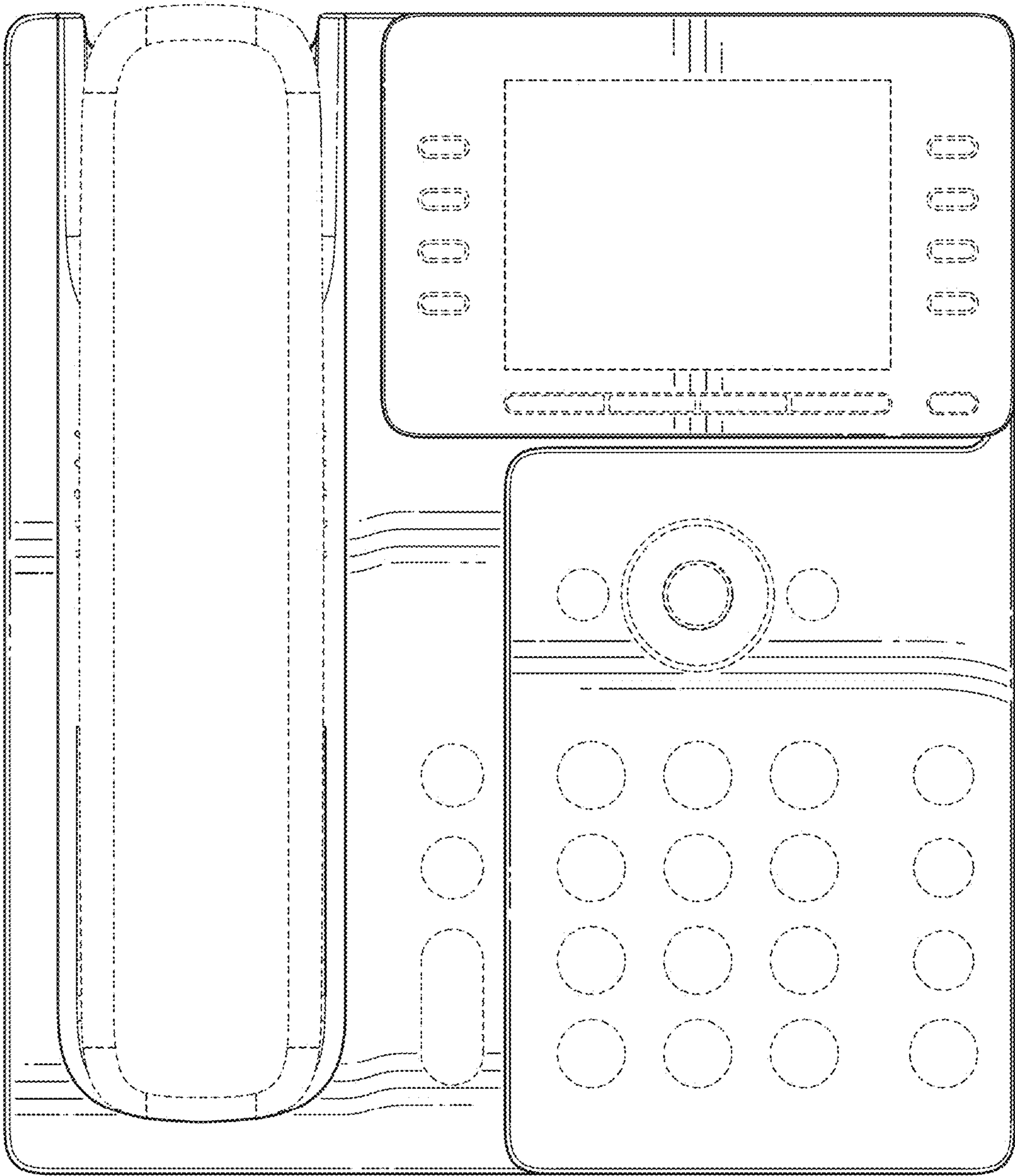

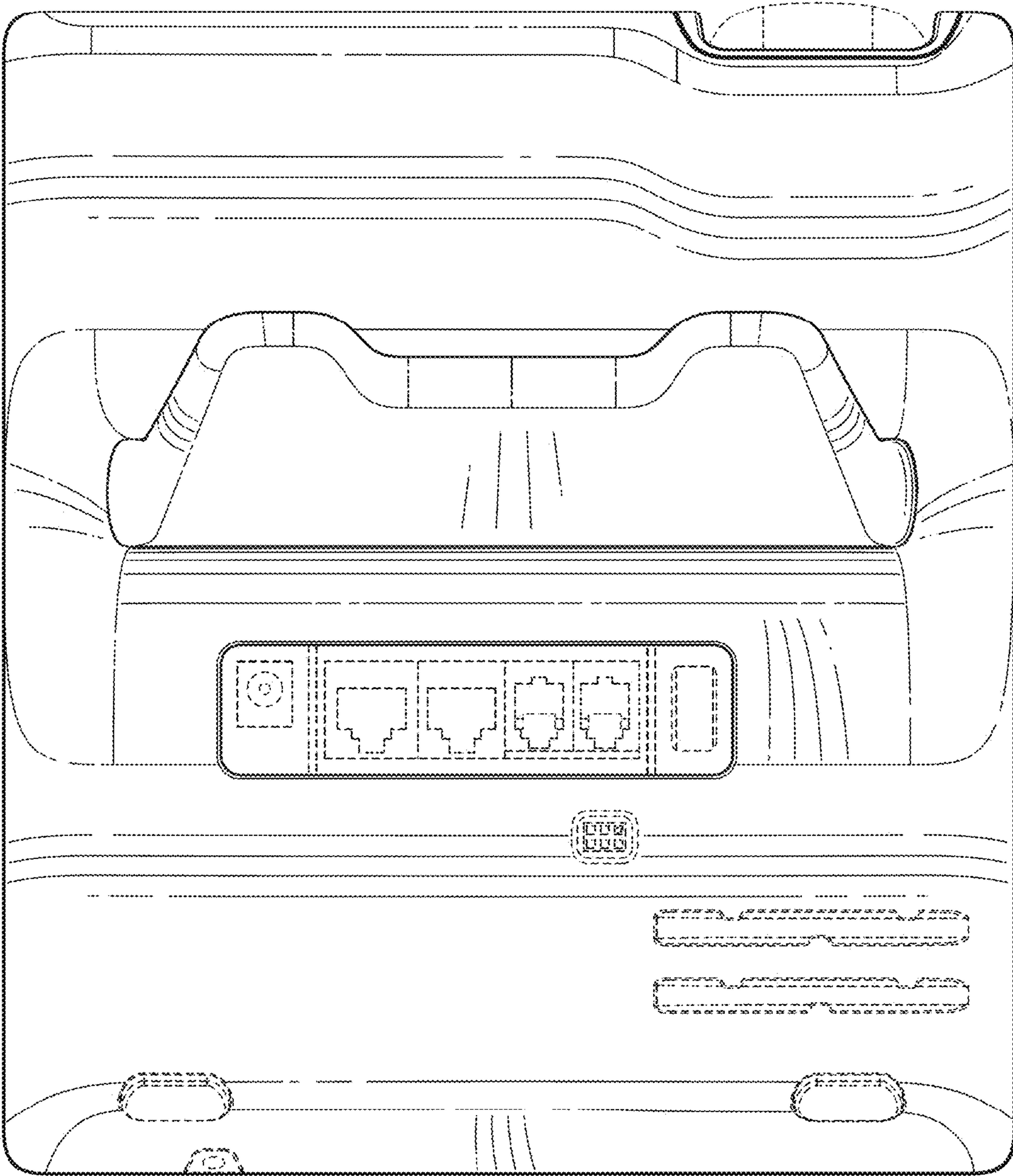
