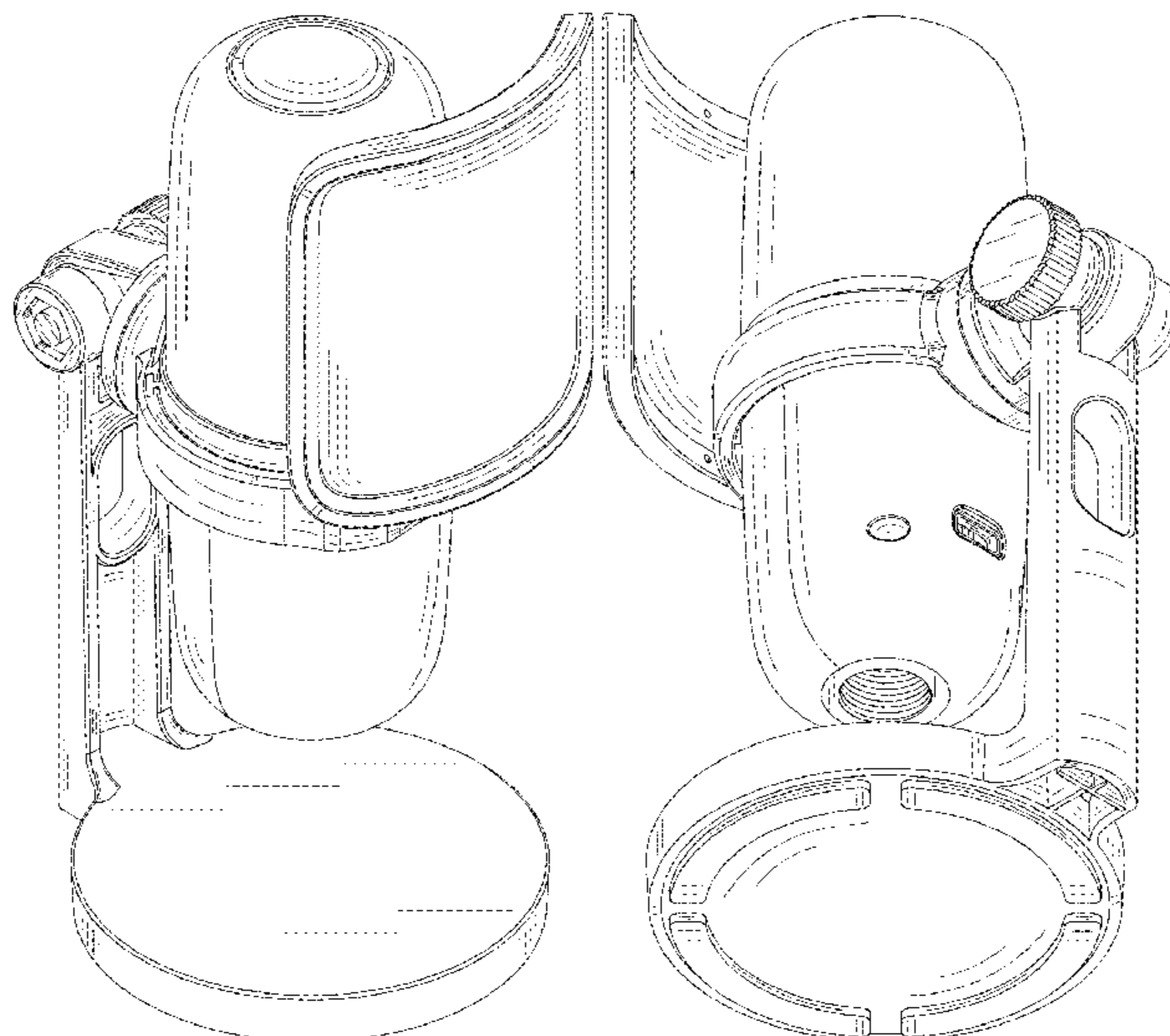
The ornamental design for USB microphone, as shown and described.

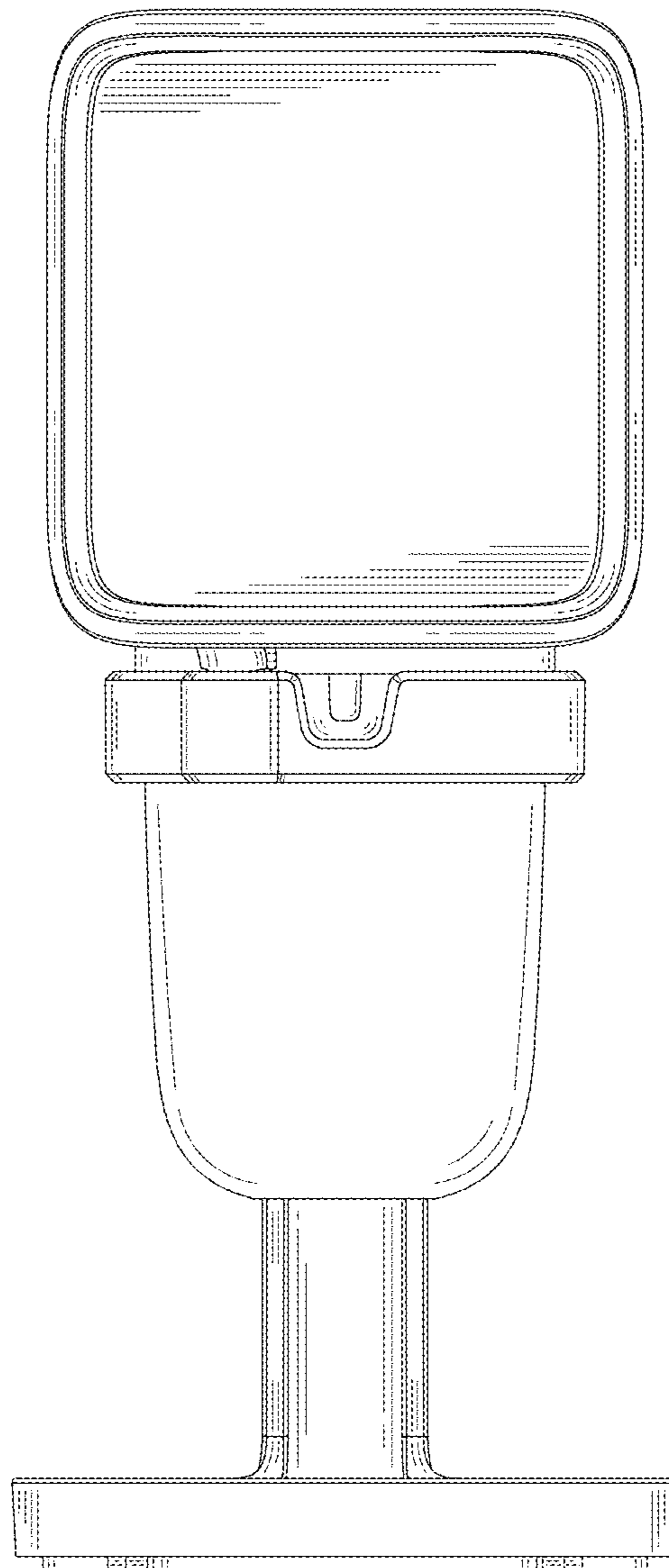

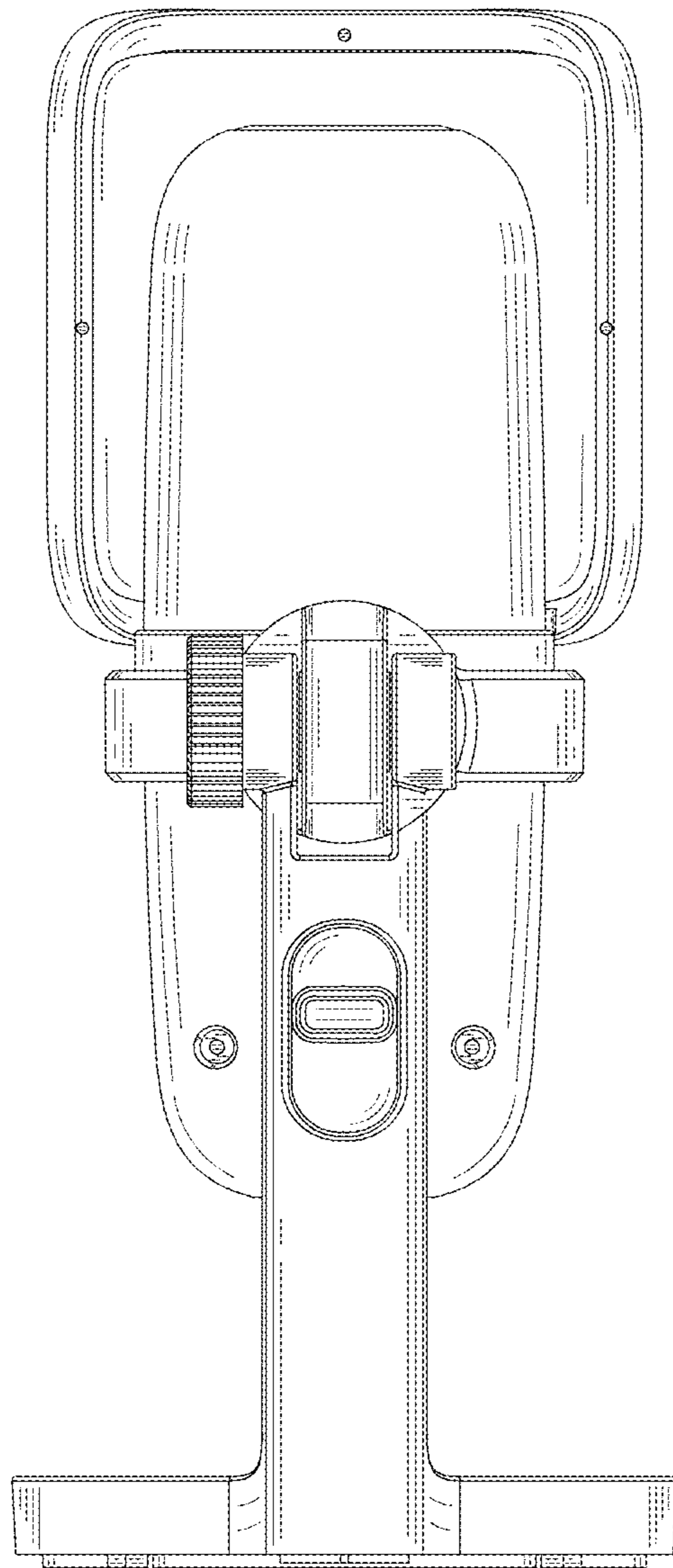

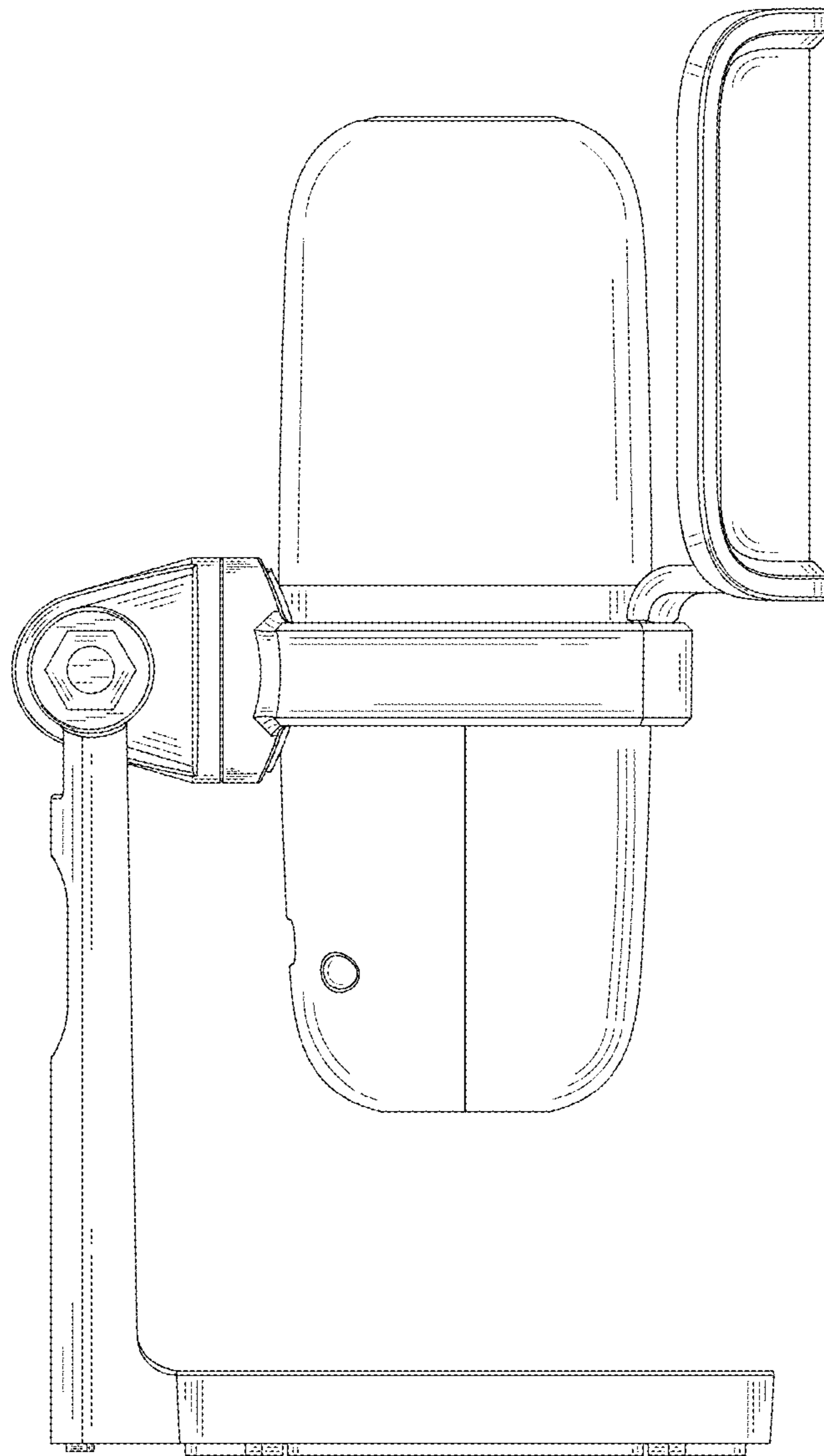

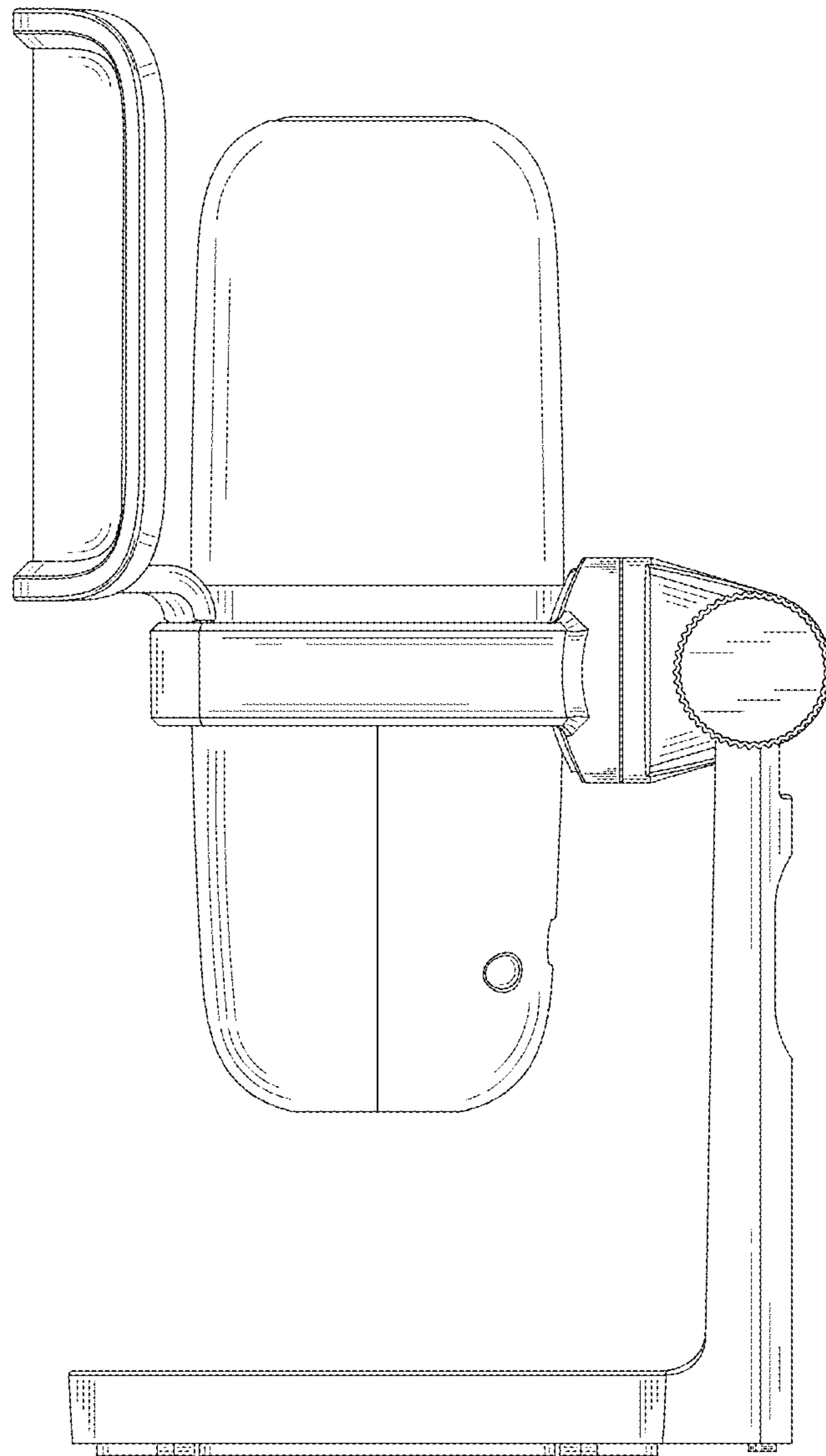

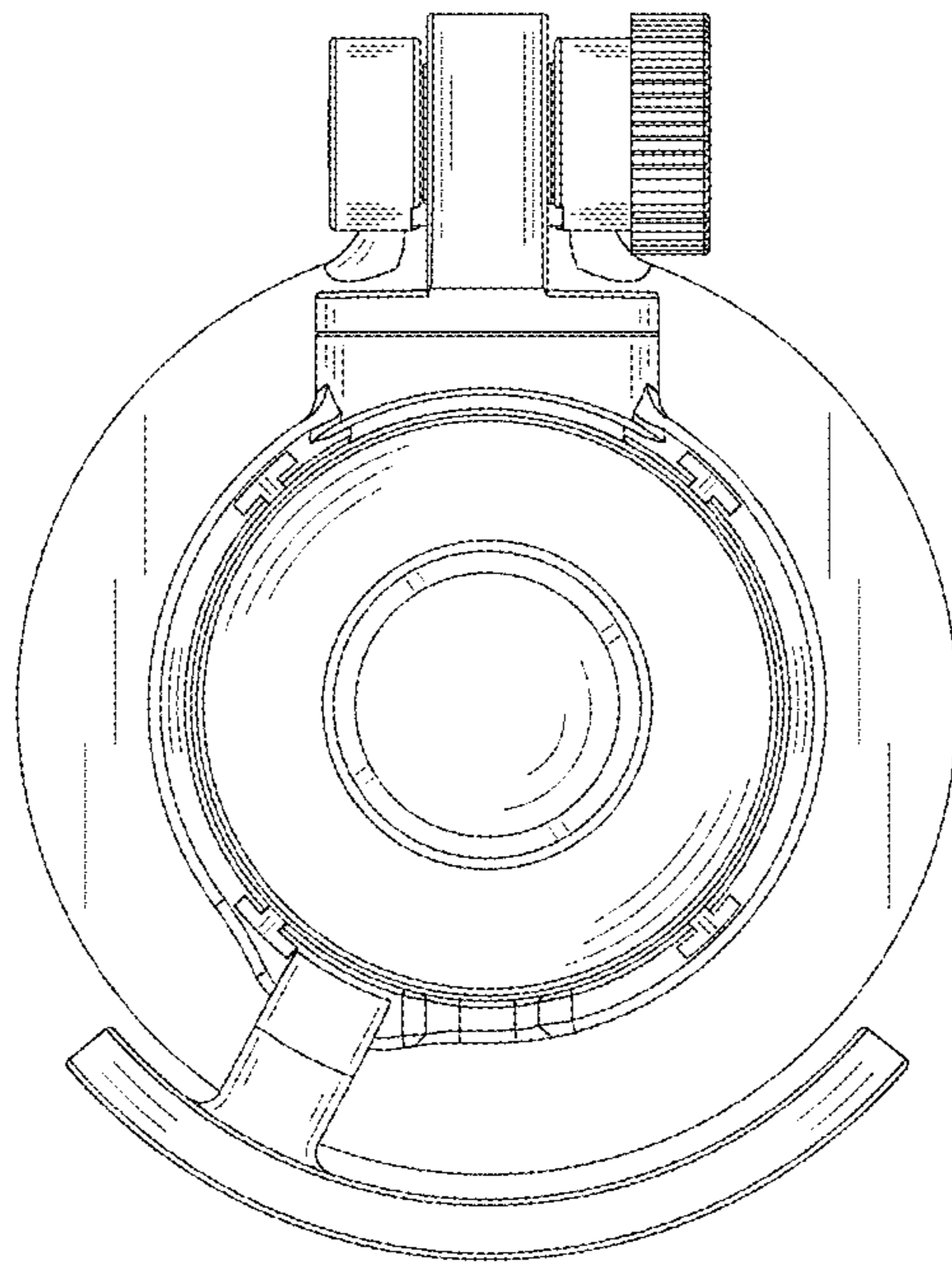

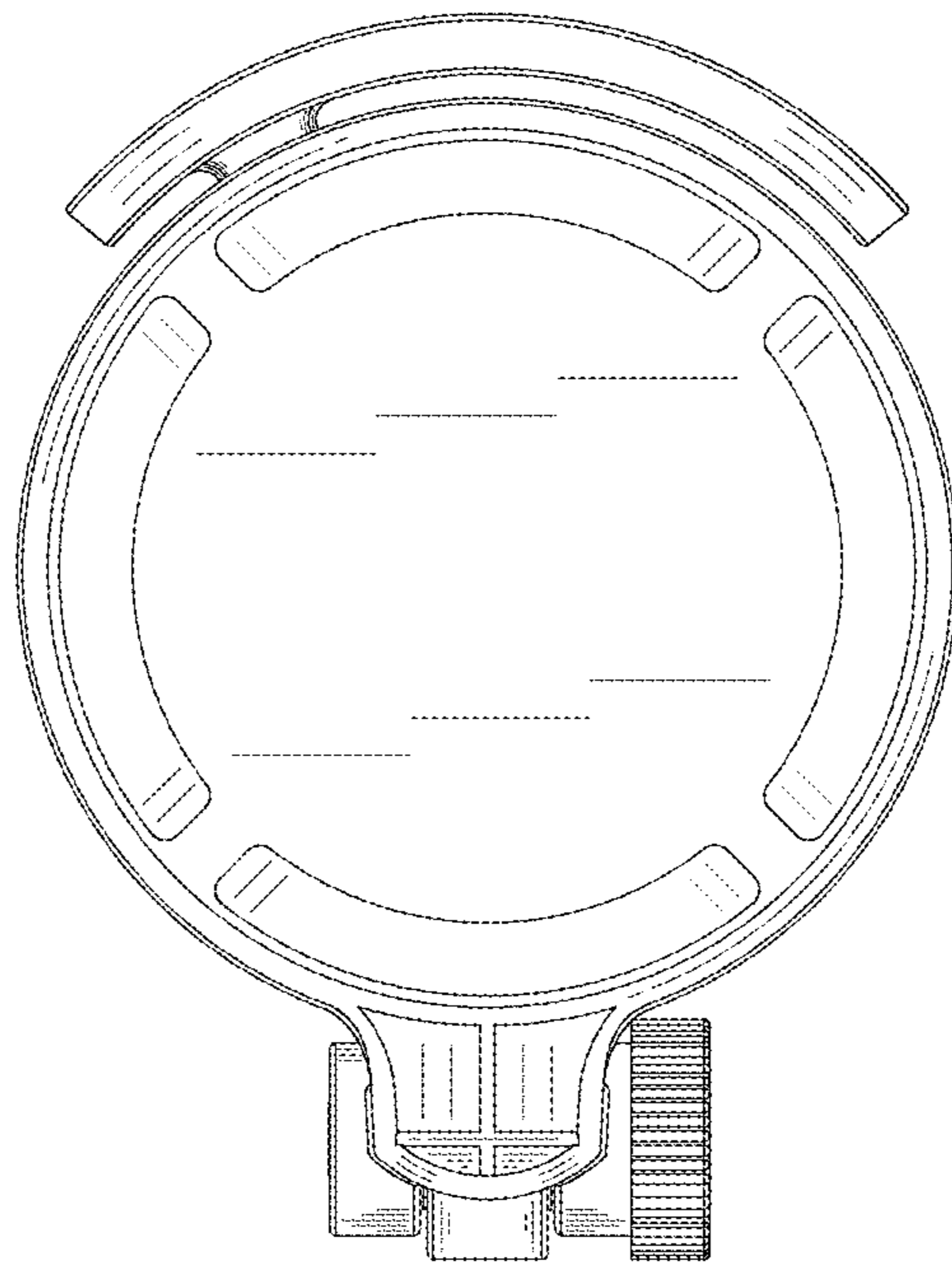

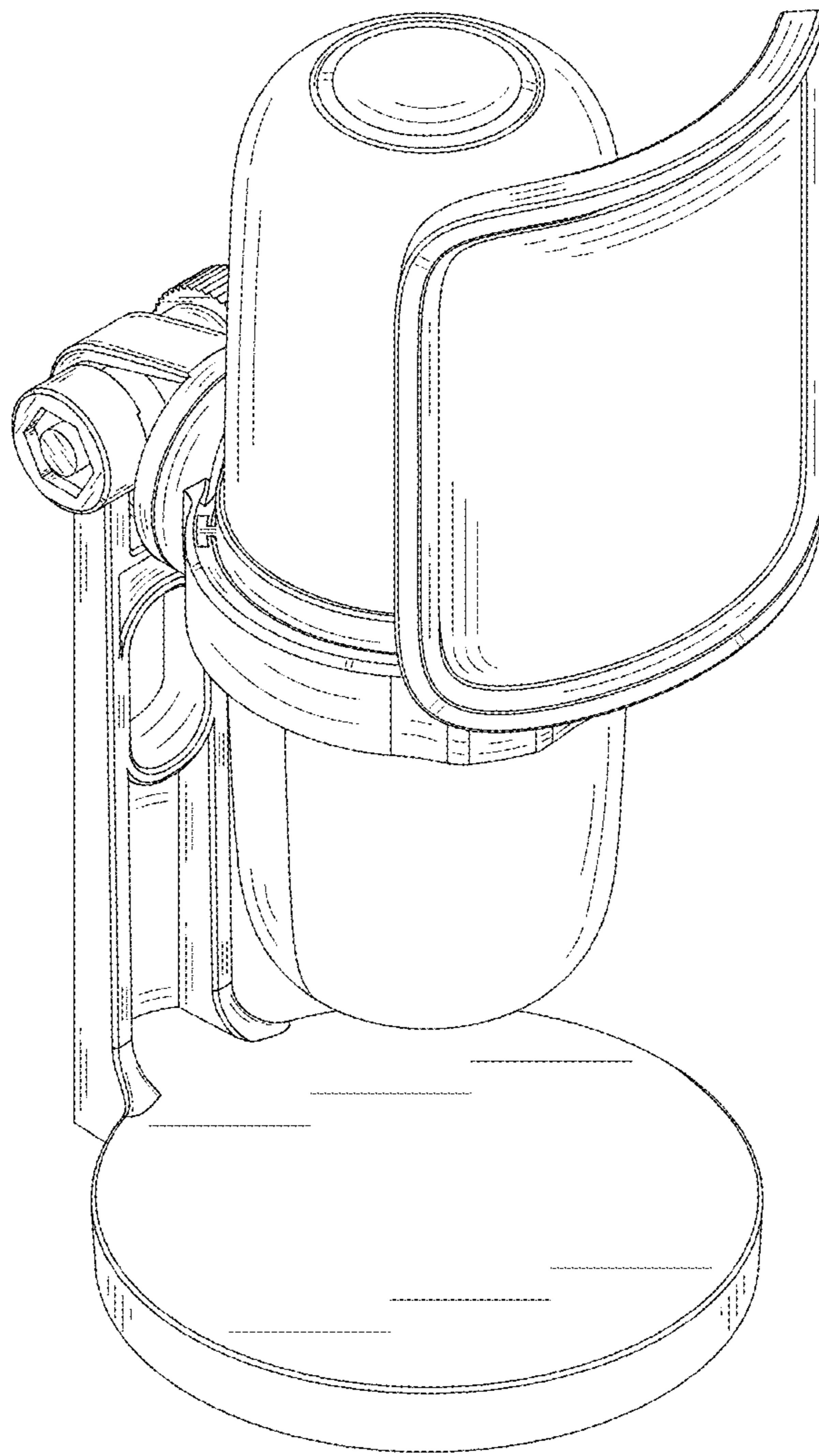

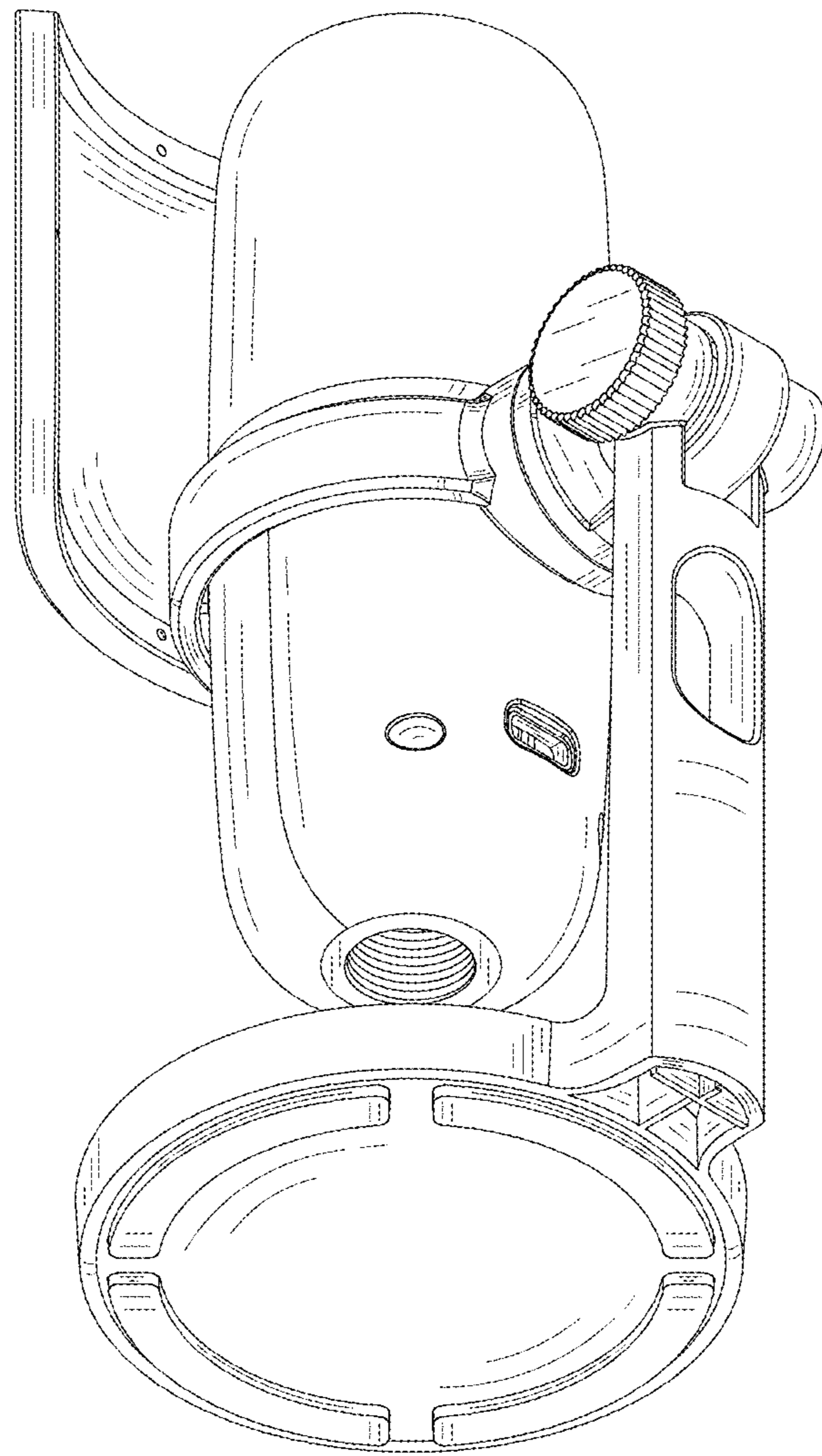
