(57) **CLAIM**

The ornamental design for a portion of a display panel with a computer icon image, as shown and described.

DESCRIPTION

The FIGURE is a front view of the portion of a display panel with a computer icon image showing the new design. The broken line showing the display panel is for environmental purposes only and forms no part of the claimed design. The different hatching patterns of portions of the computer icon image indicate visual contrasts between portions having respectively different hatching patterns.
