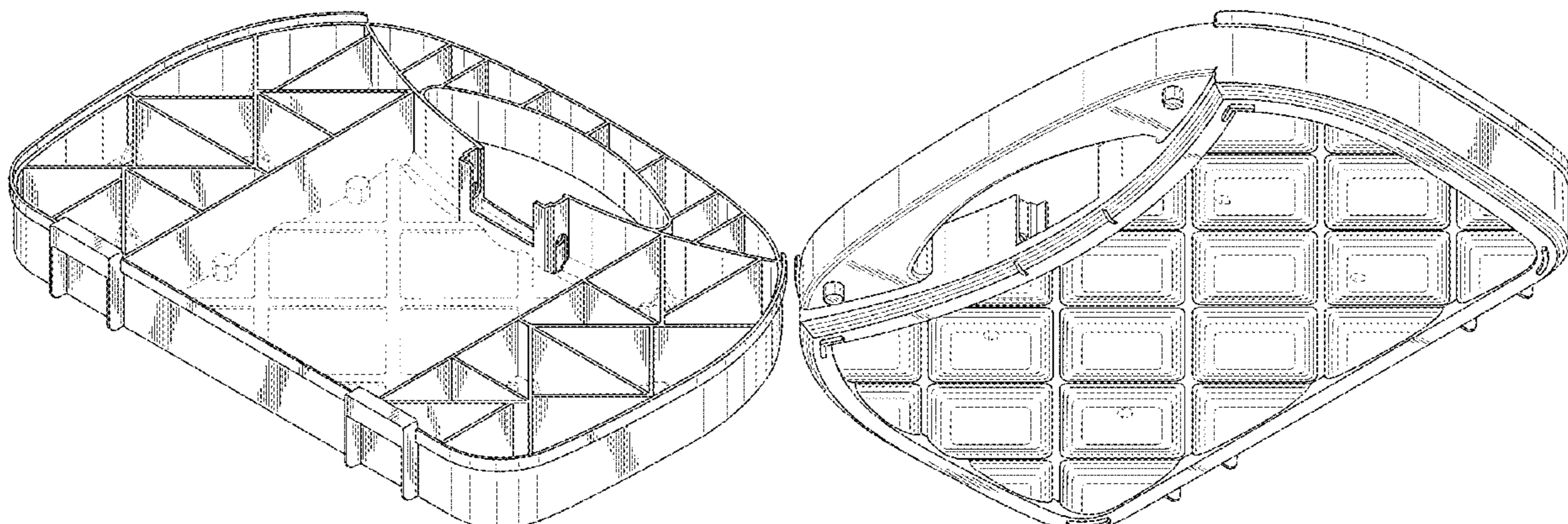
The ornamental design for a case for toy beads, as shown and described.

**DESCRIPTION**

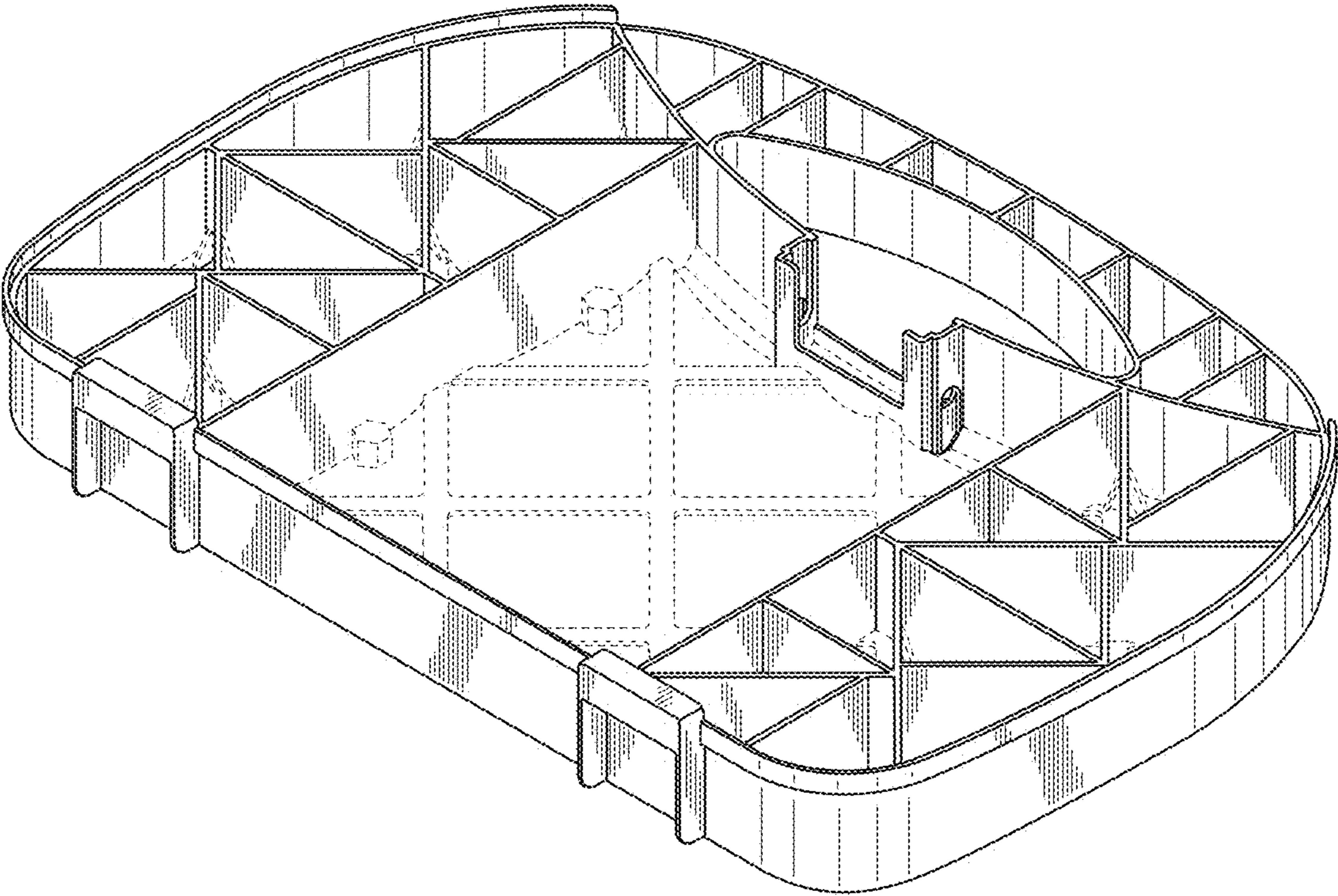

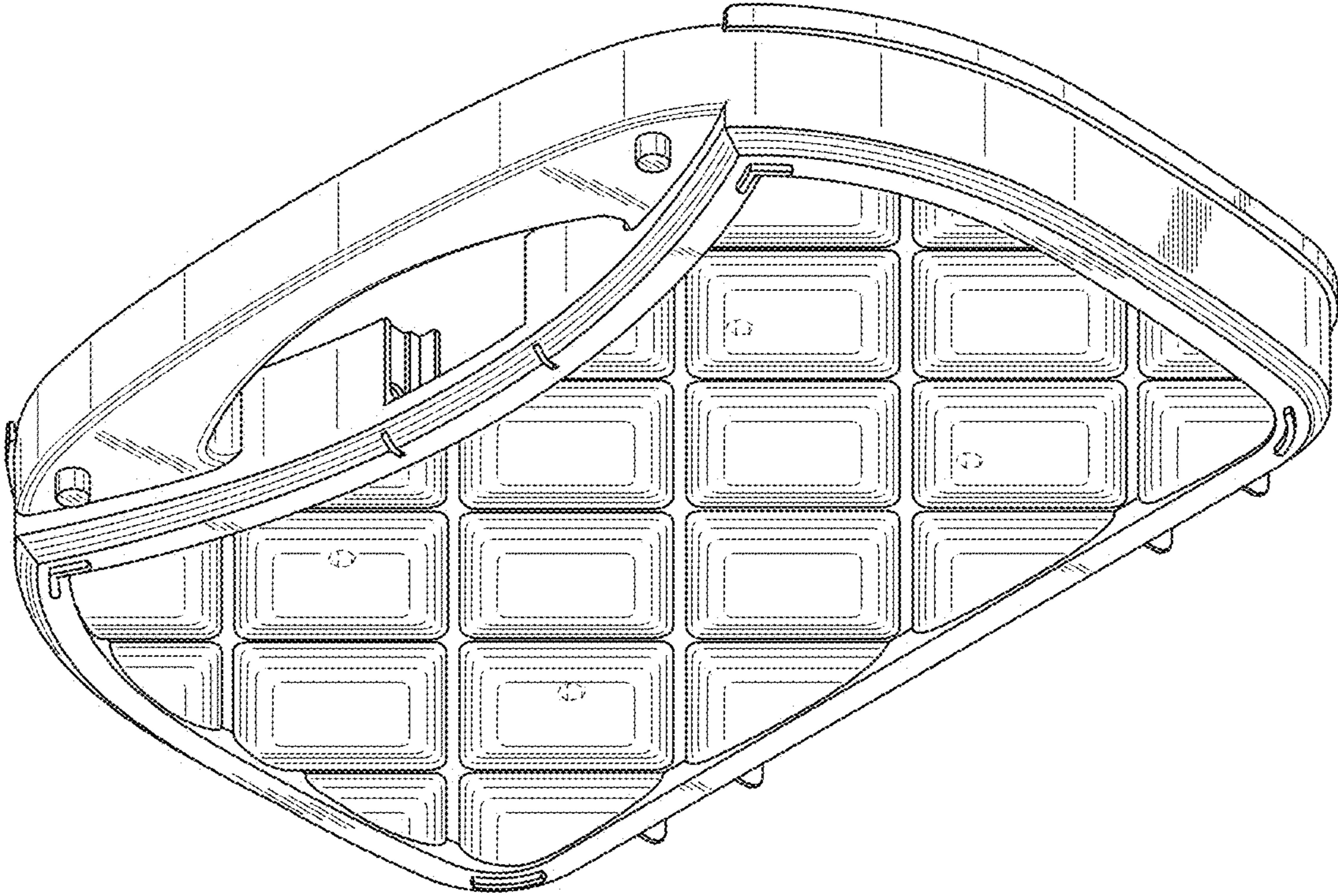

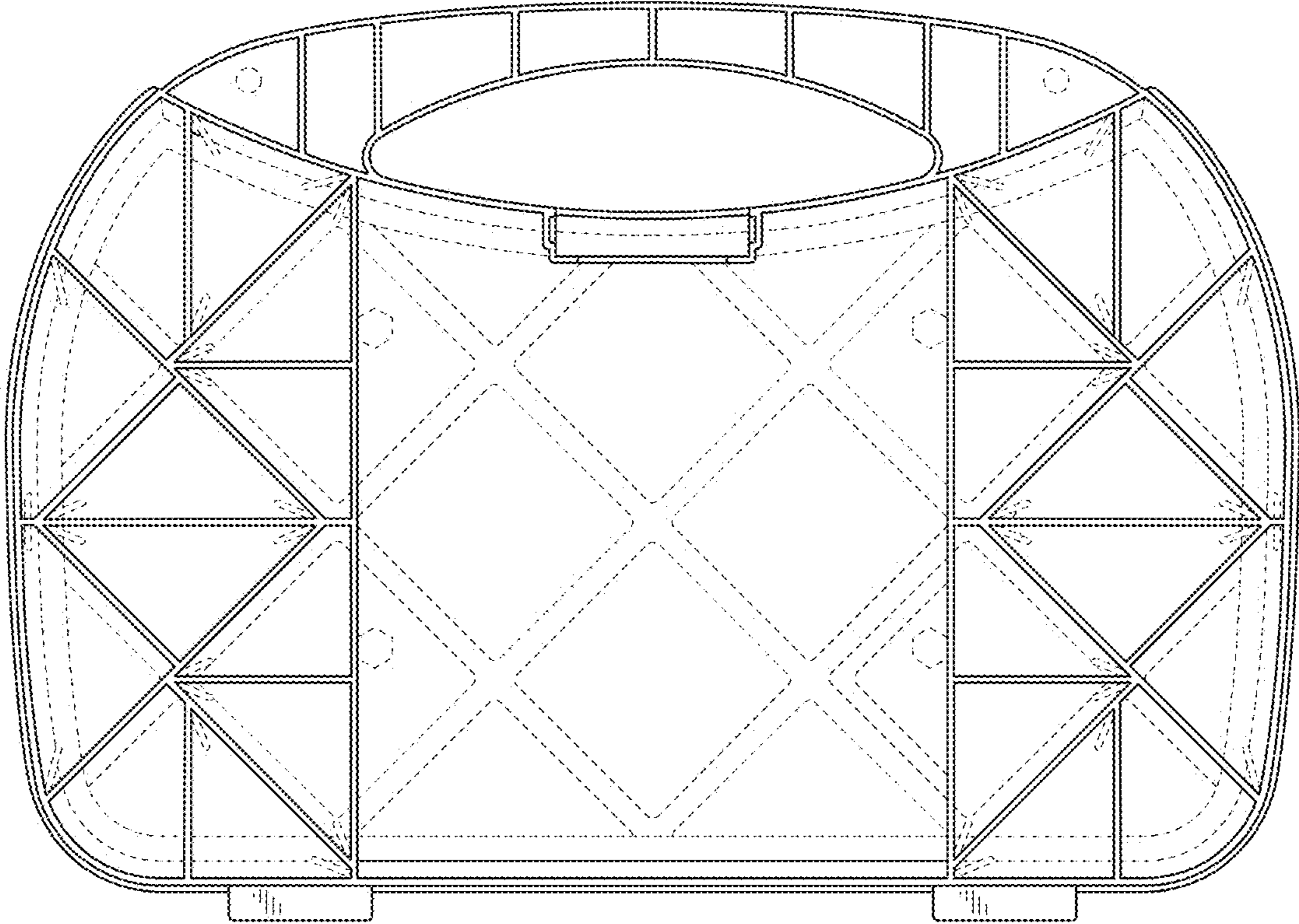

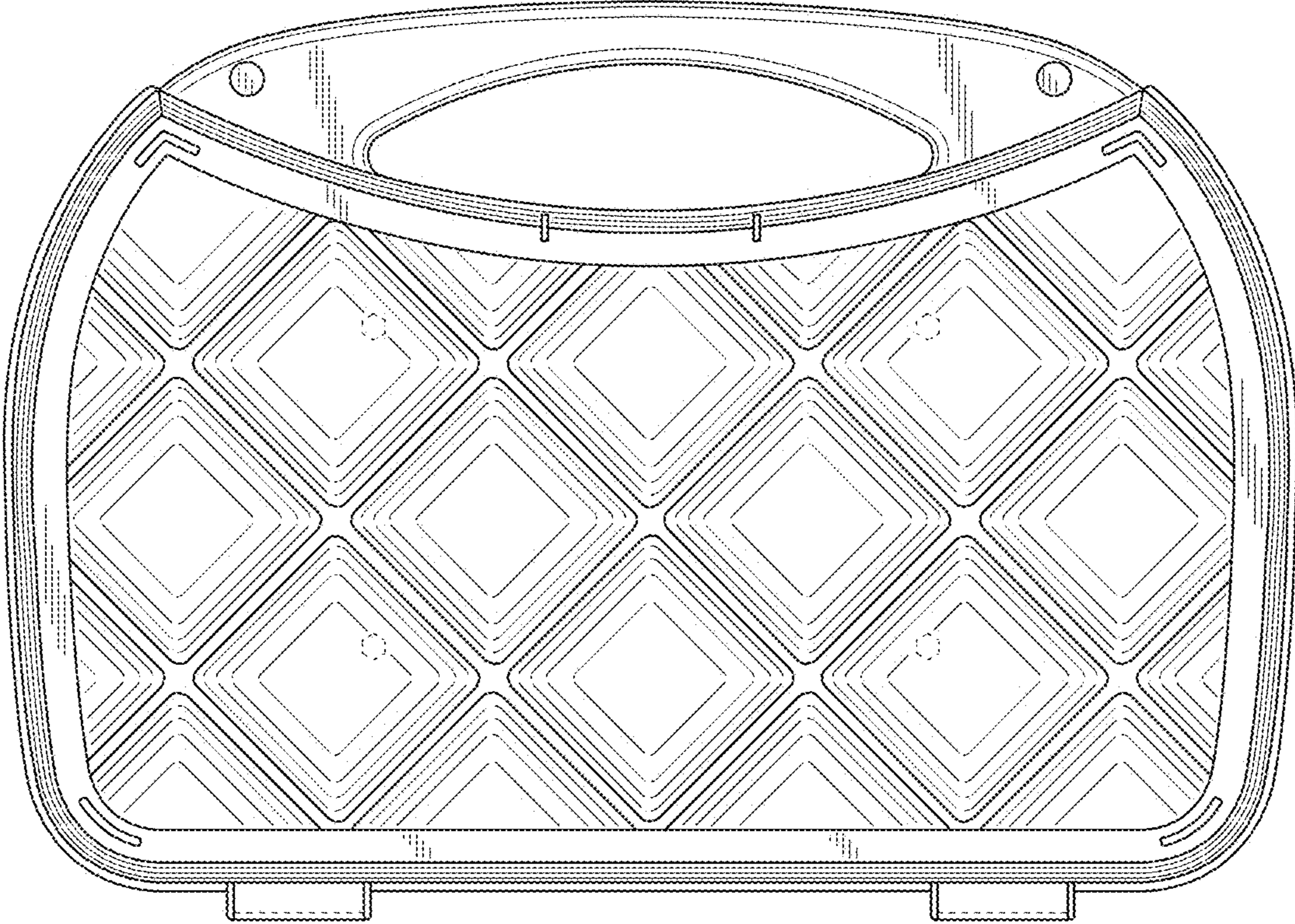

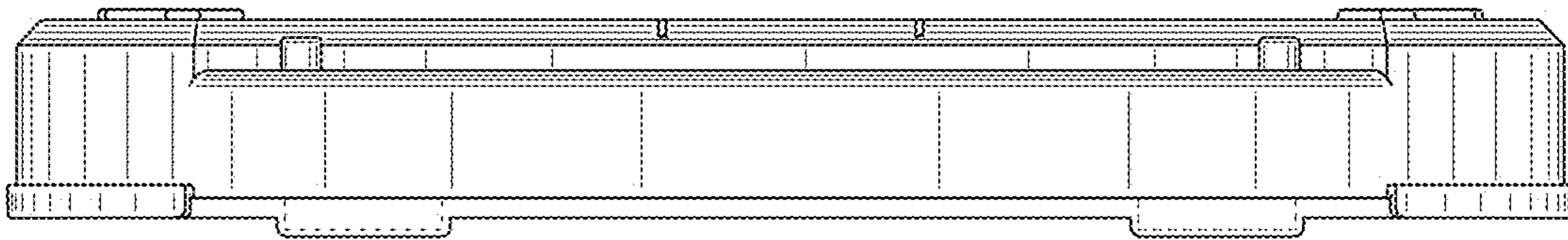




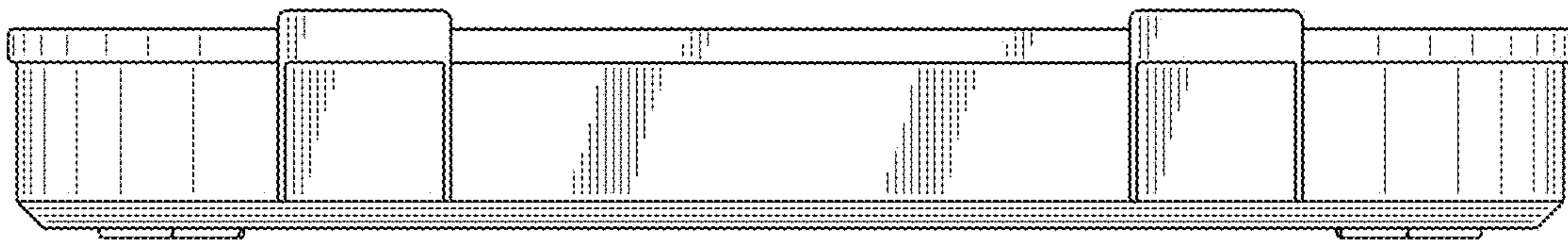

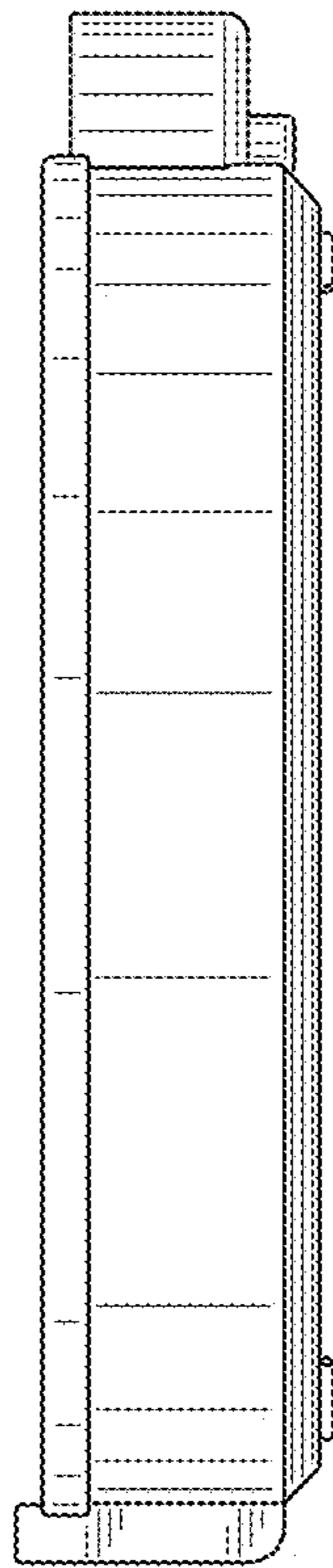

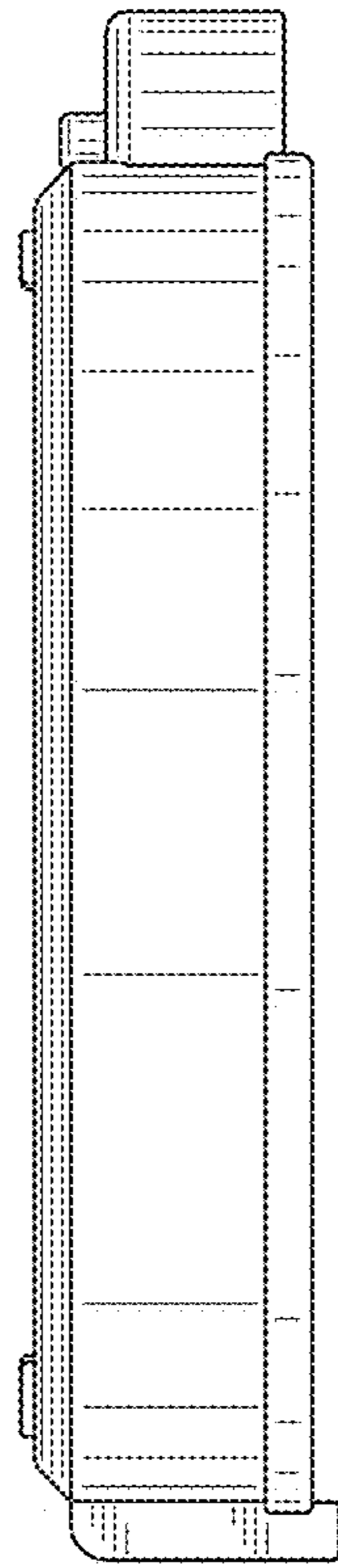
