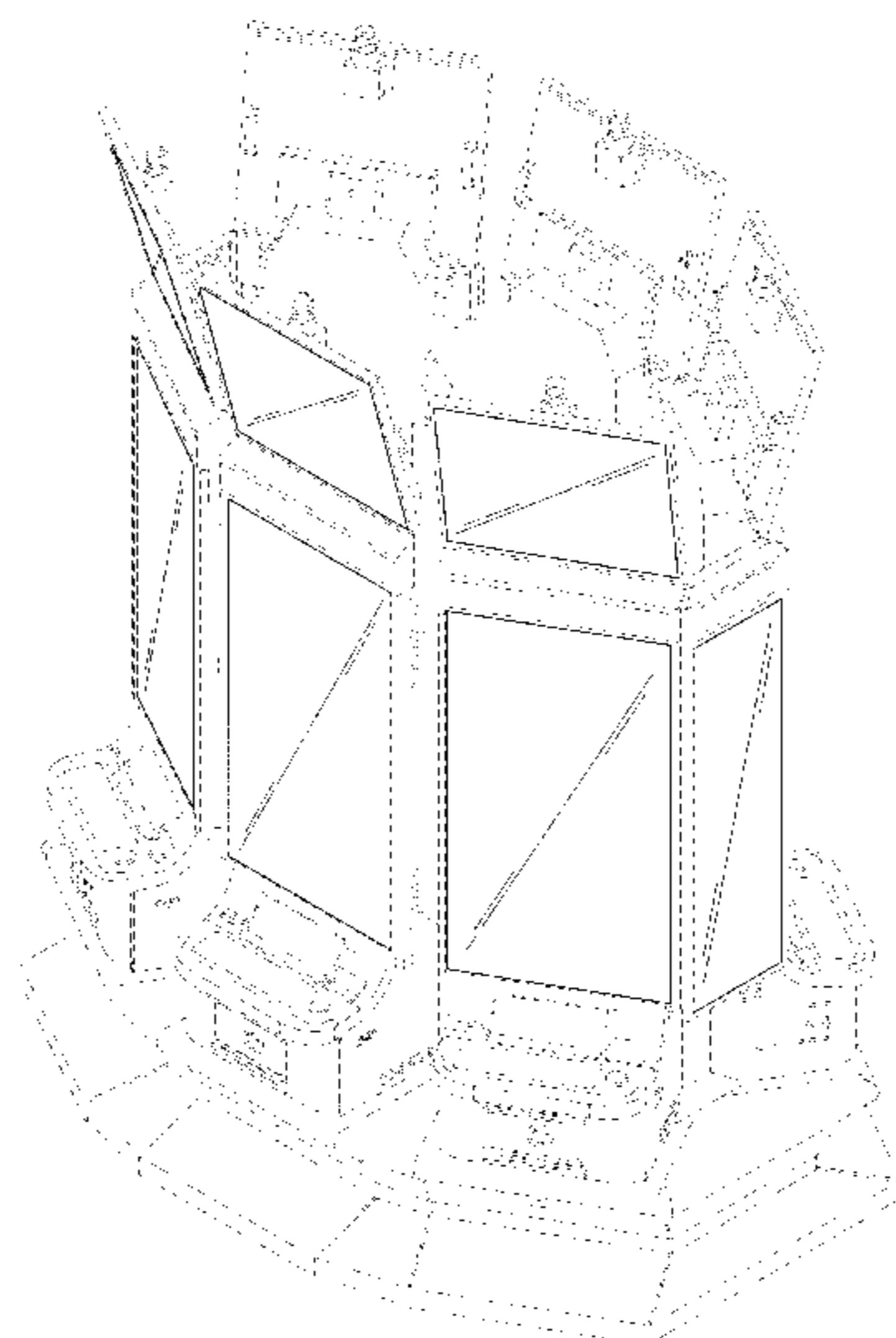
(57) **CLAIM**

The ornamental design for a set of display screens for a gaming machine bank, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the set of display screens for a gaming machine bank, showing our new design. FIG. 2 is a front elevation view thereof, the rear elevation view being a mirror image thereof. FIG. 3 is a left side elevation view thereof, the right side elevation view being a mirror image thereof; and, FIG. 4 is a top plan view thereof. The broken lines in the figures illustrate portions of the set of display screens for a gaming machine bank that form no part of the claimed design.

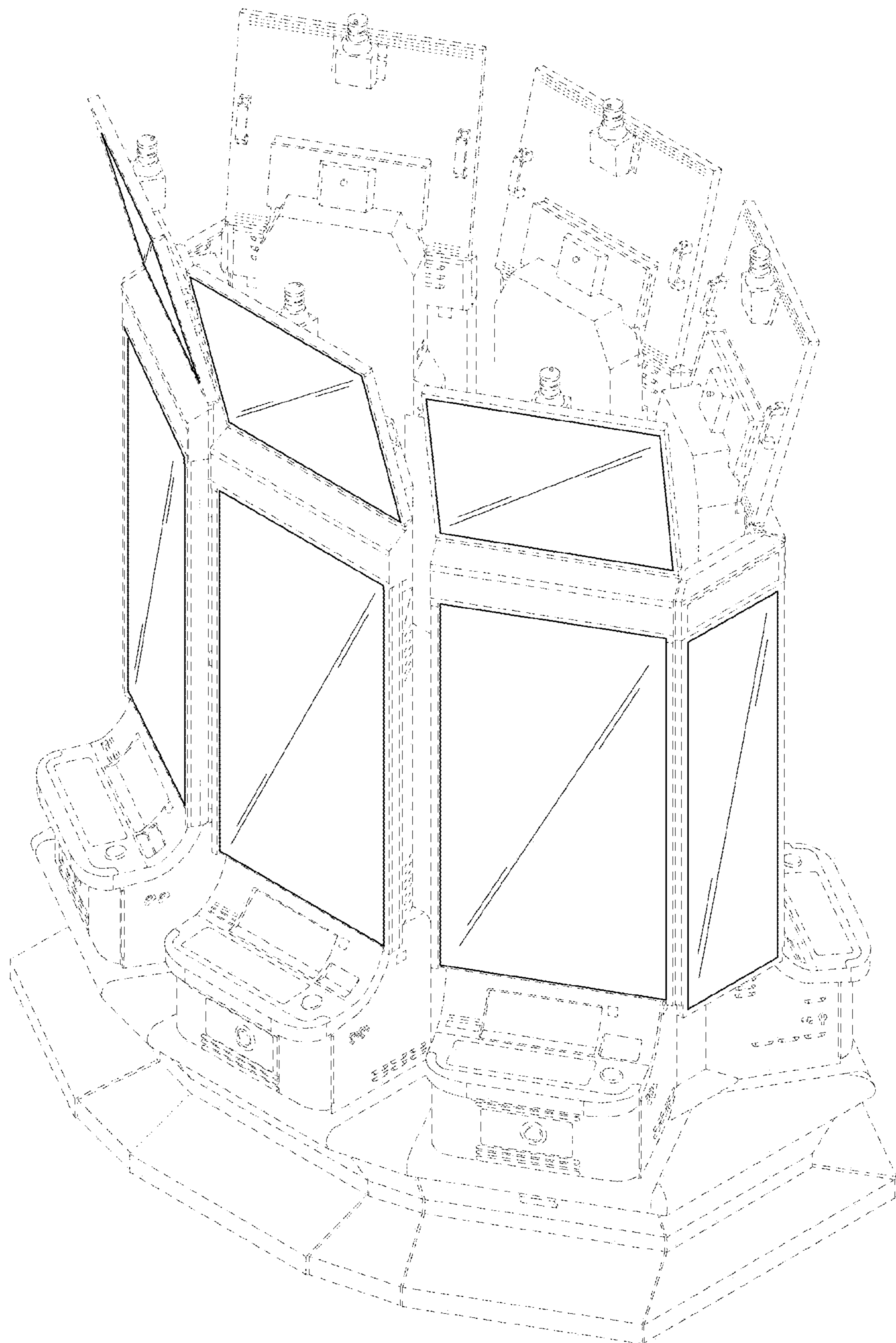

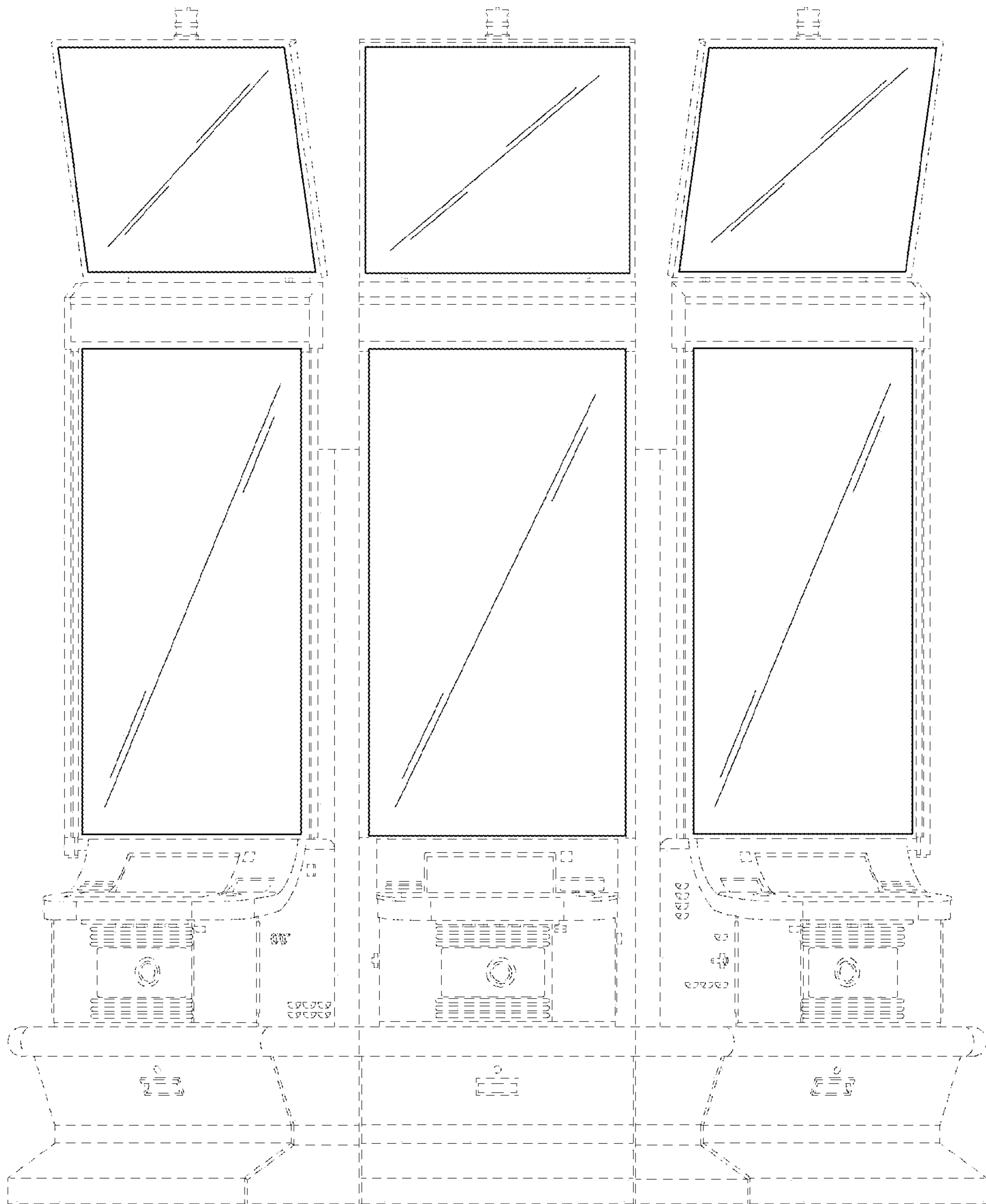

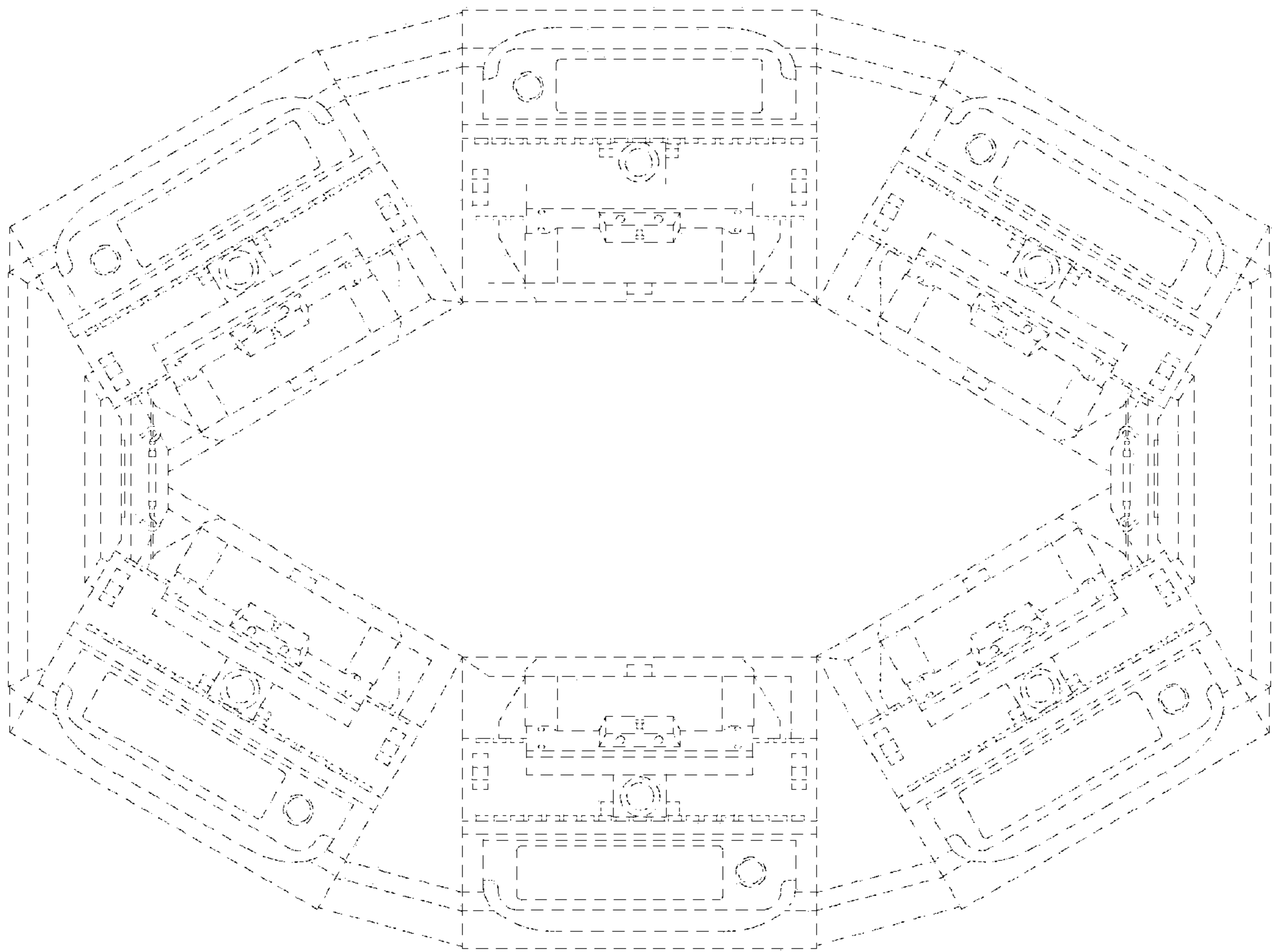
