(57) **CLAIM**

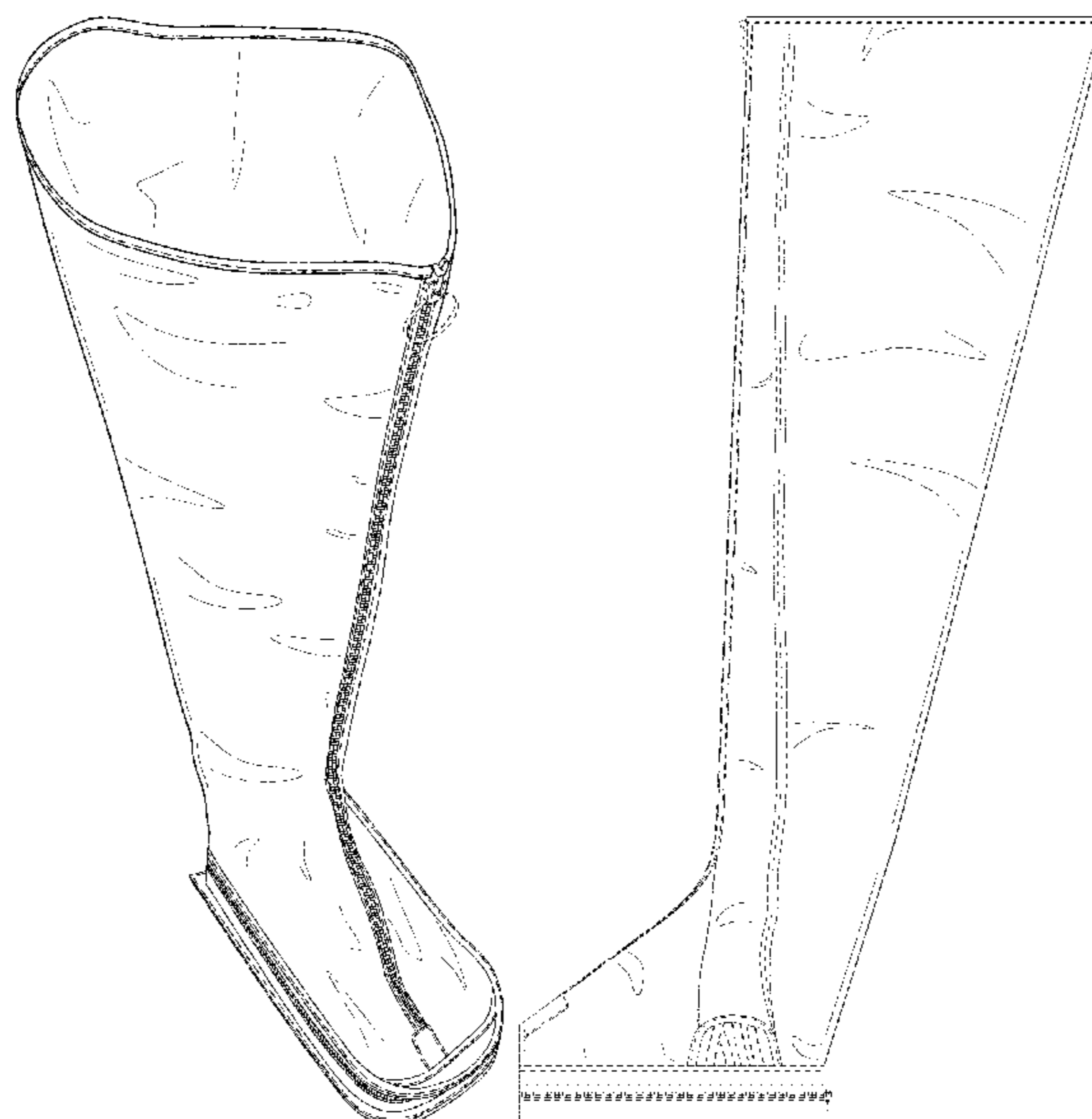
The ornamental design for a compression boot, as shown and described.

**DESCRIPTION**

FIG. 1 is a right side, front, and top perspective view of a compression boot showing the new design;

The broken lines along the seams of the compression boot depict stitching and form no part of the claimed design. The remaining broken lines are directed to portions of the compression boot that also form no part of the claimed design.

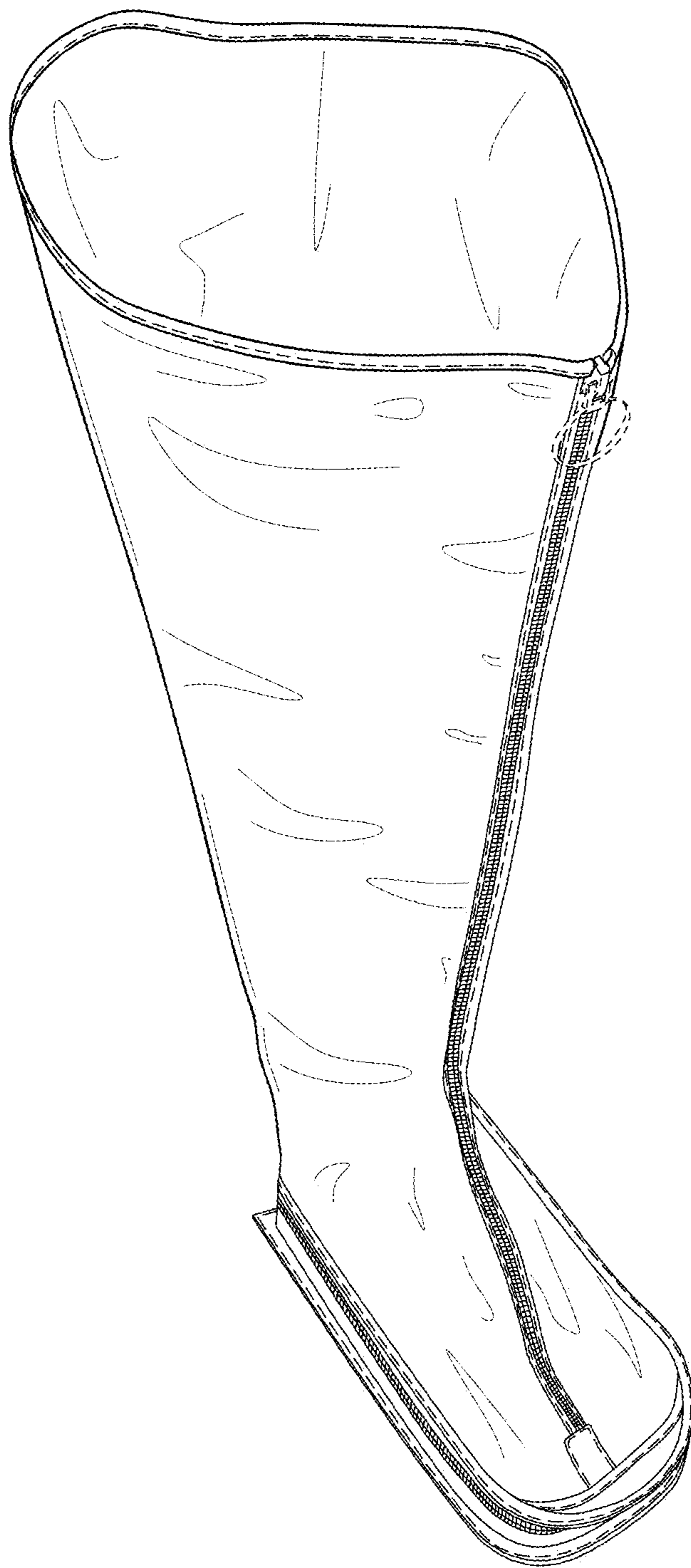

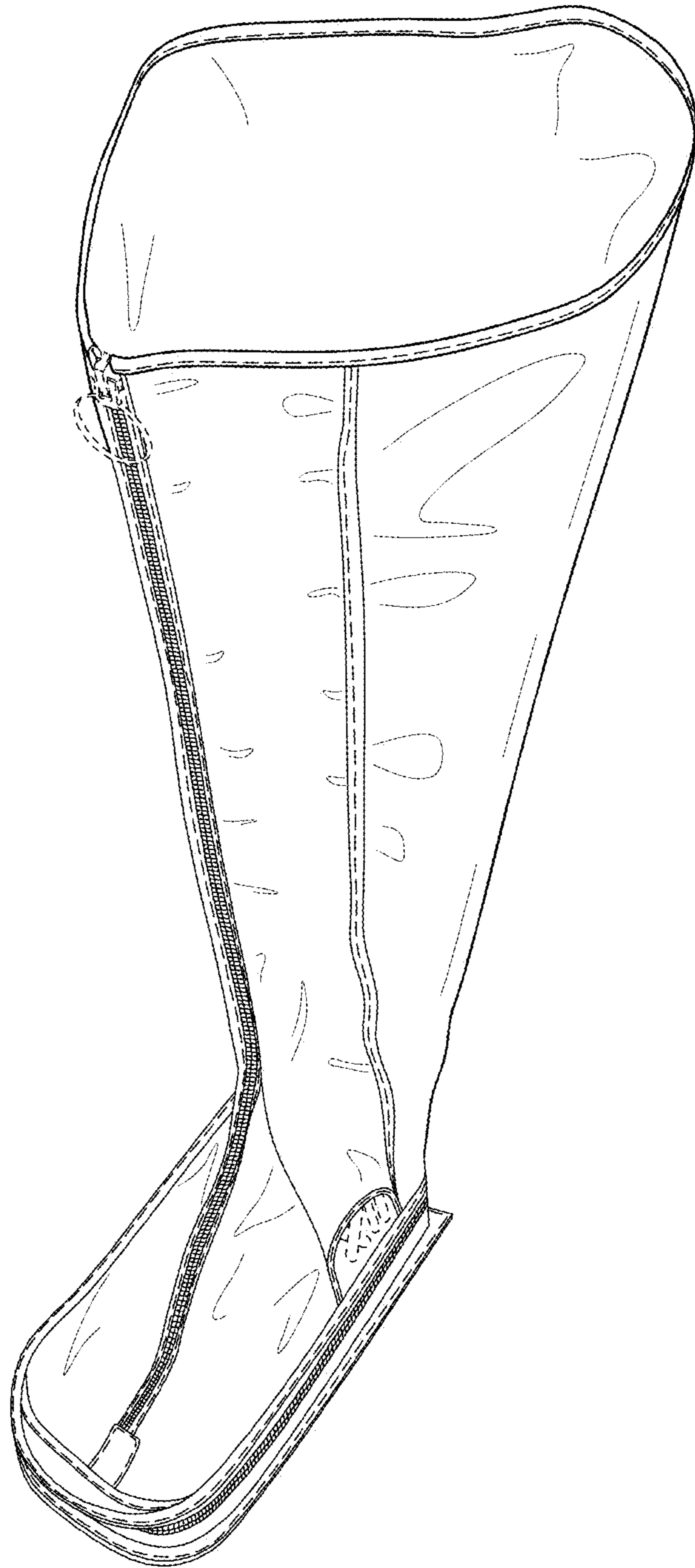

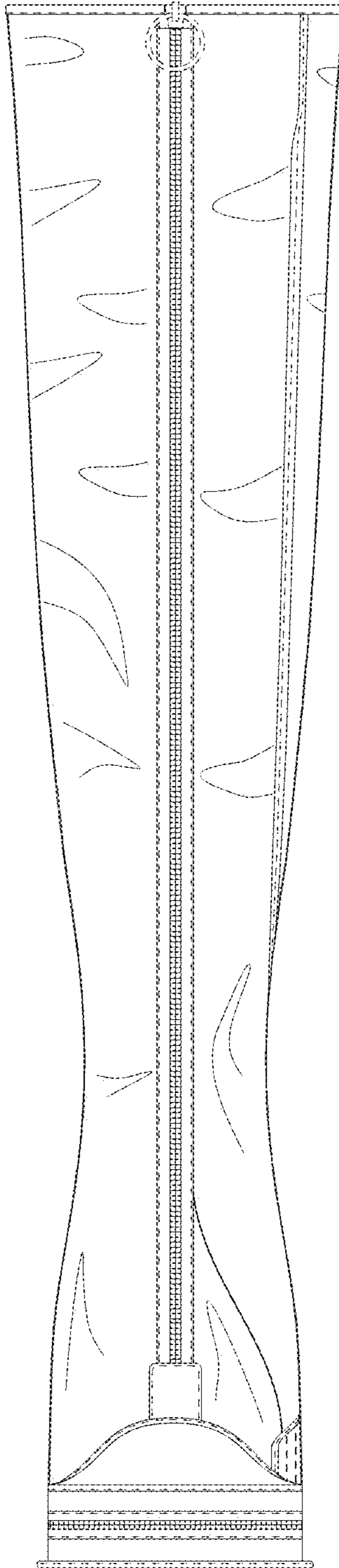

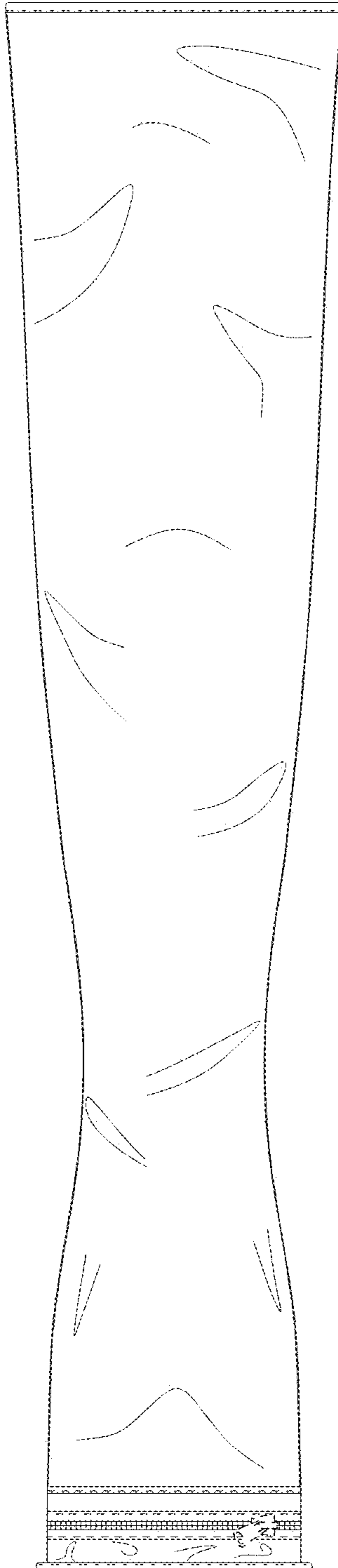

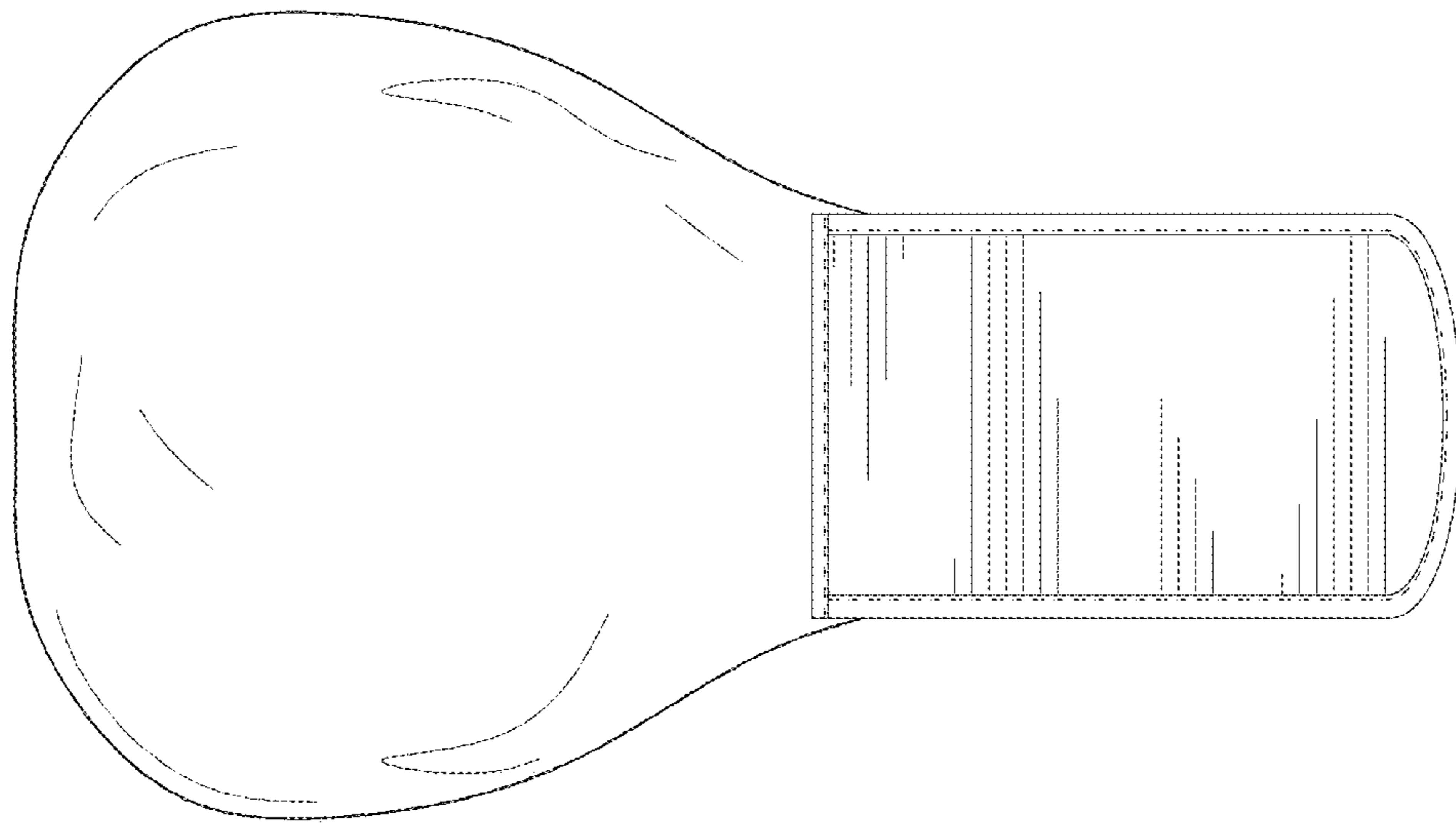

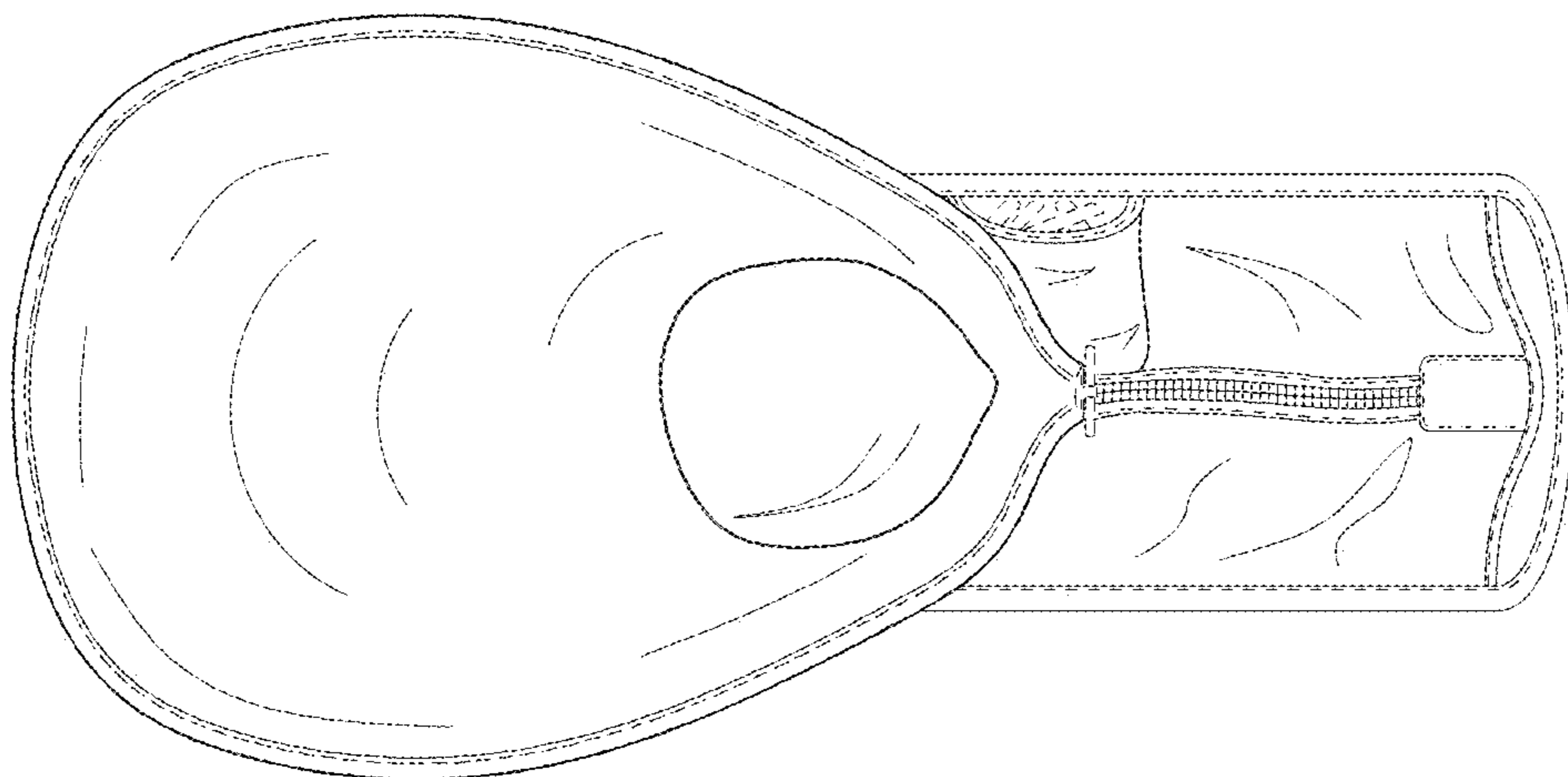

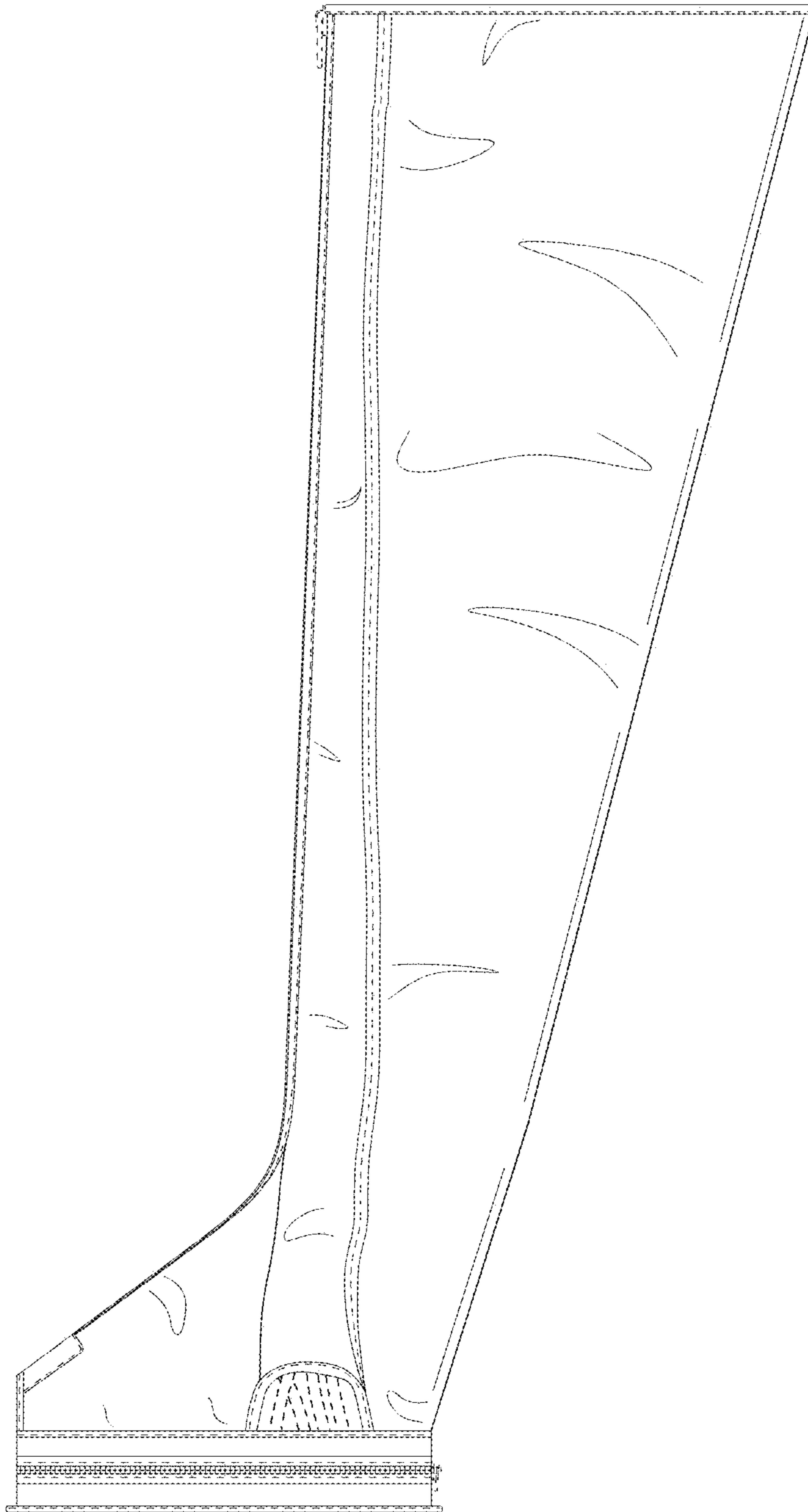

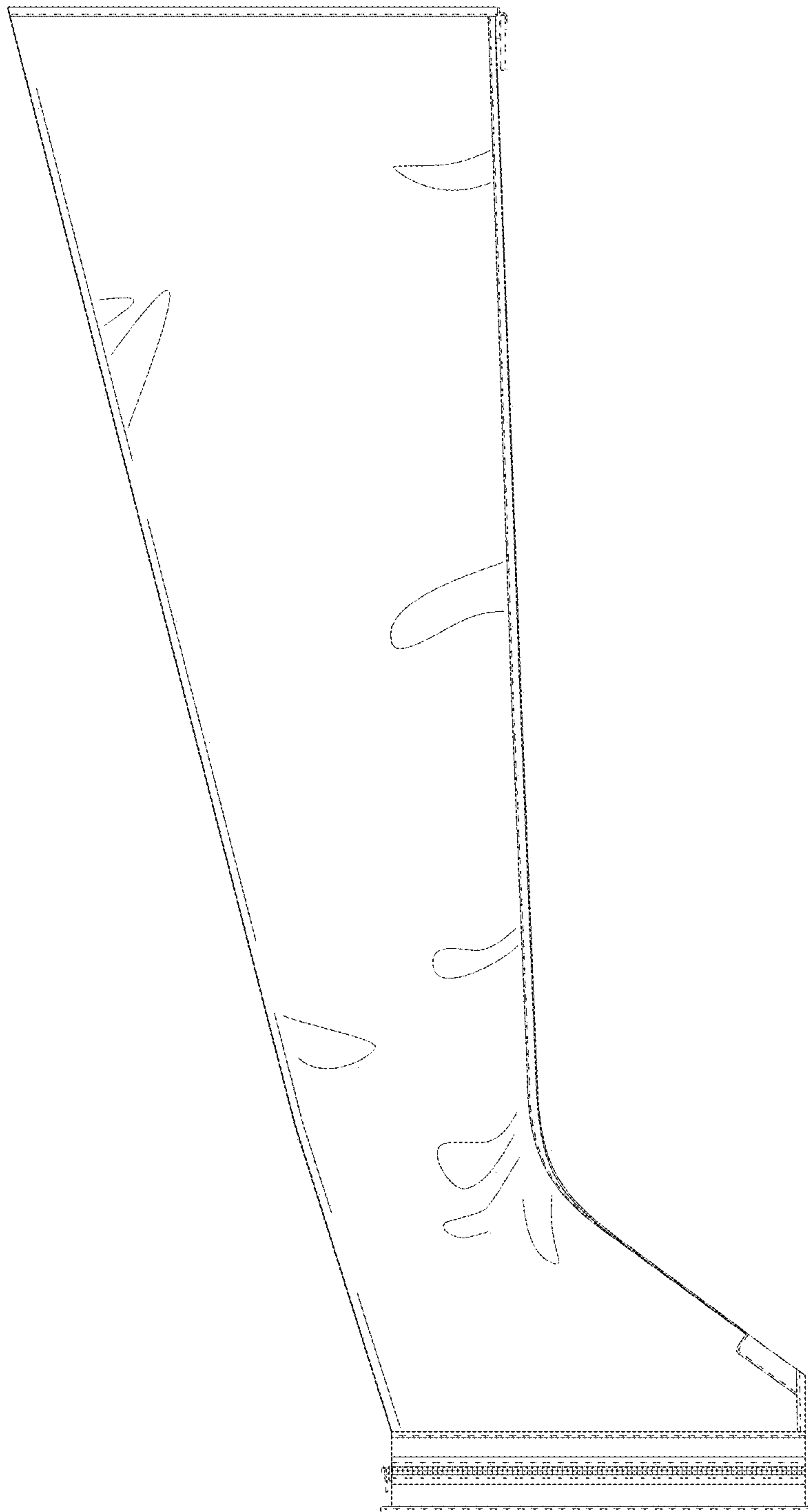

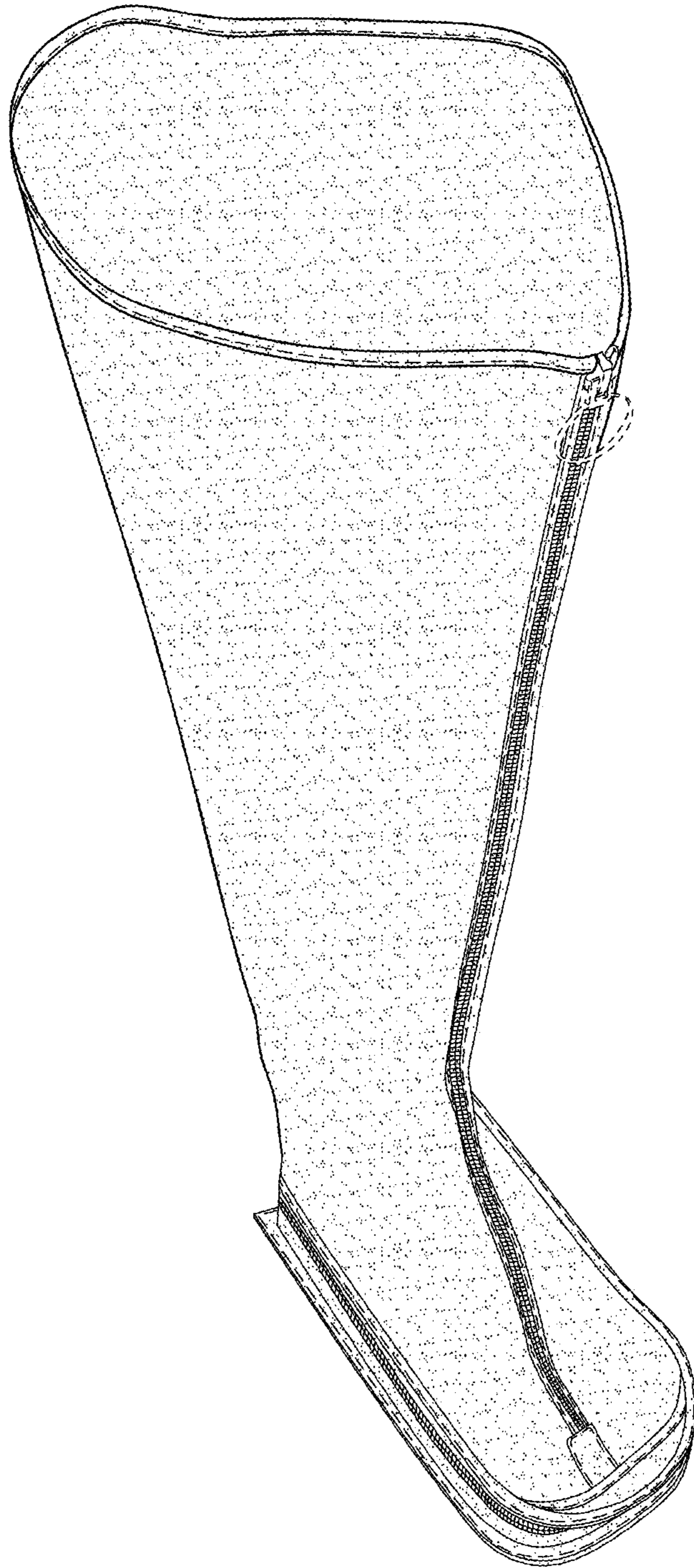

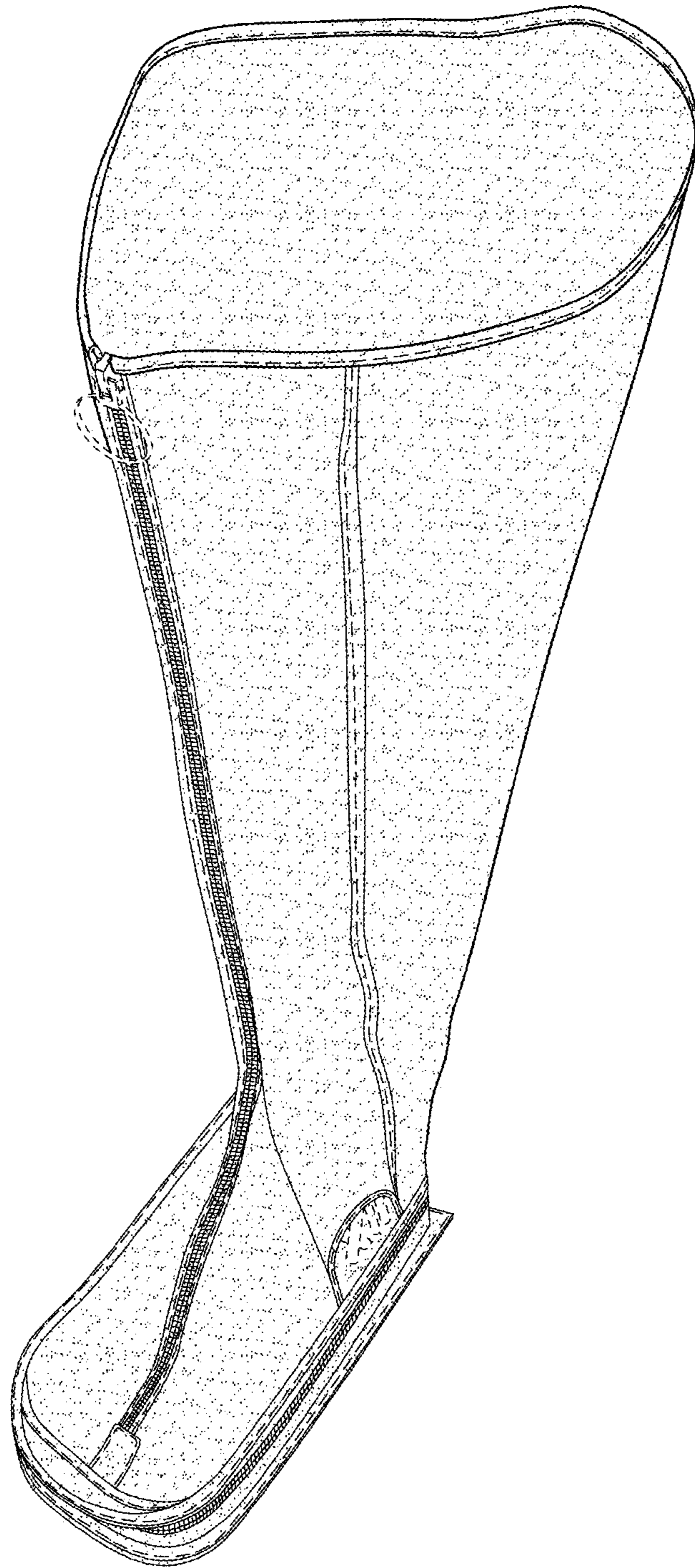

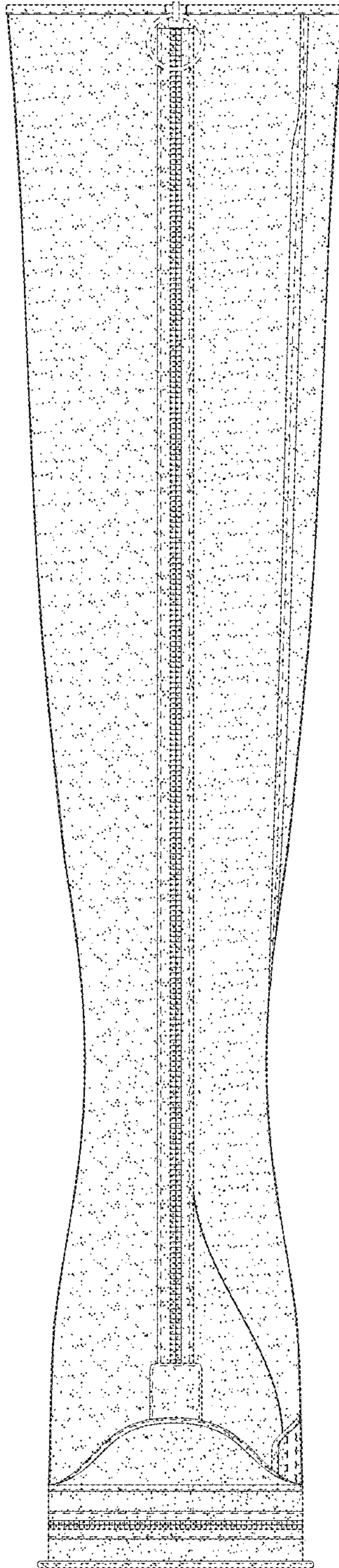

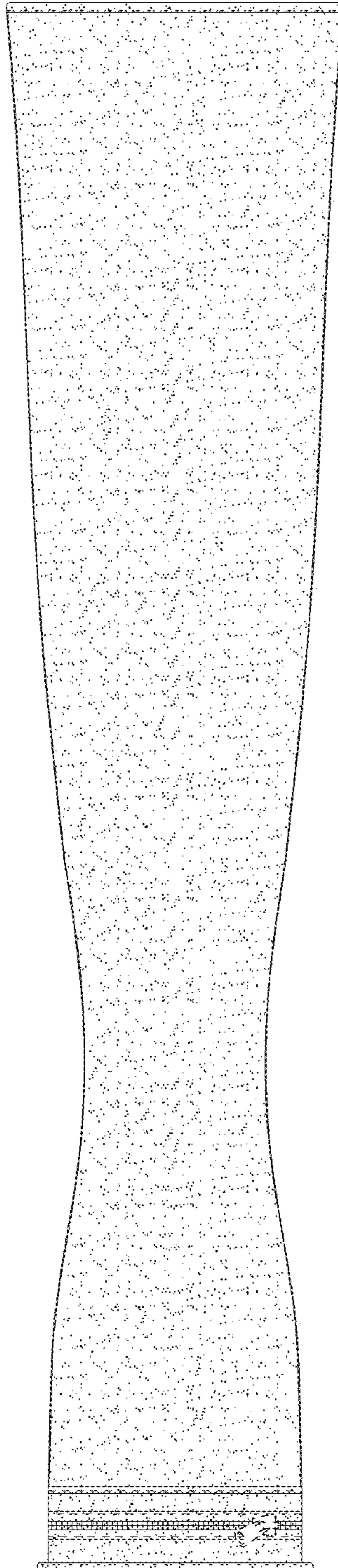

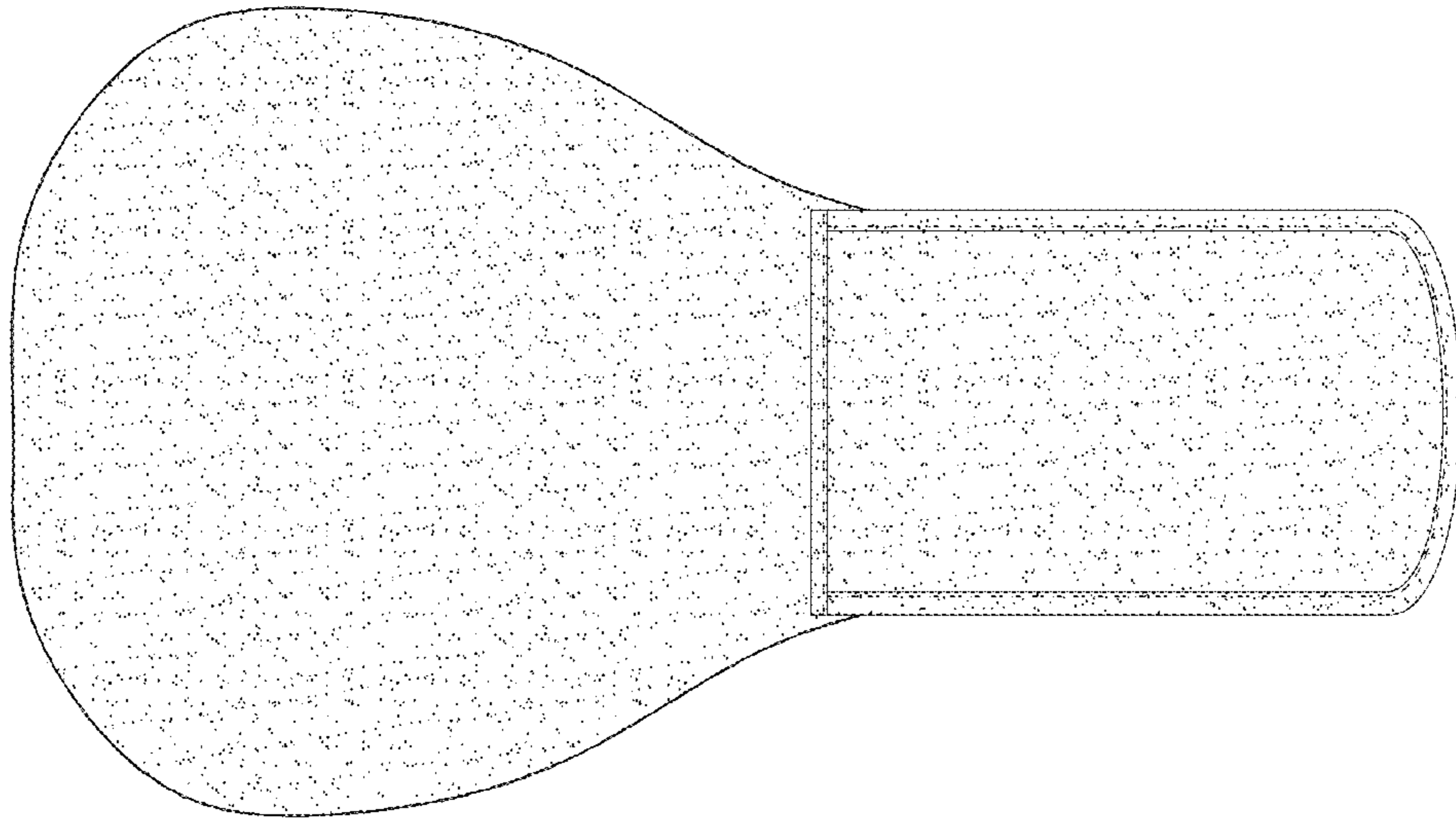

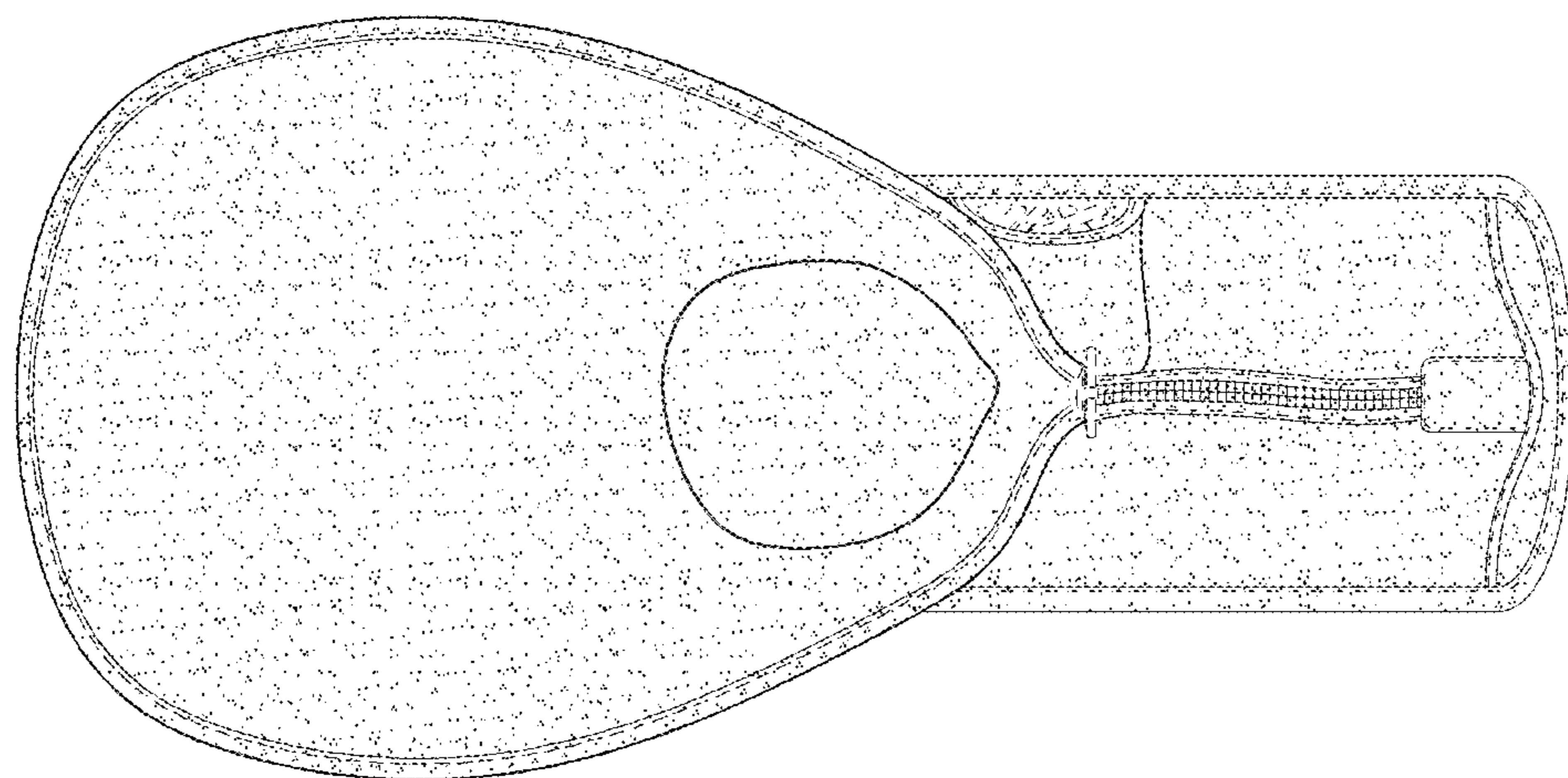

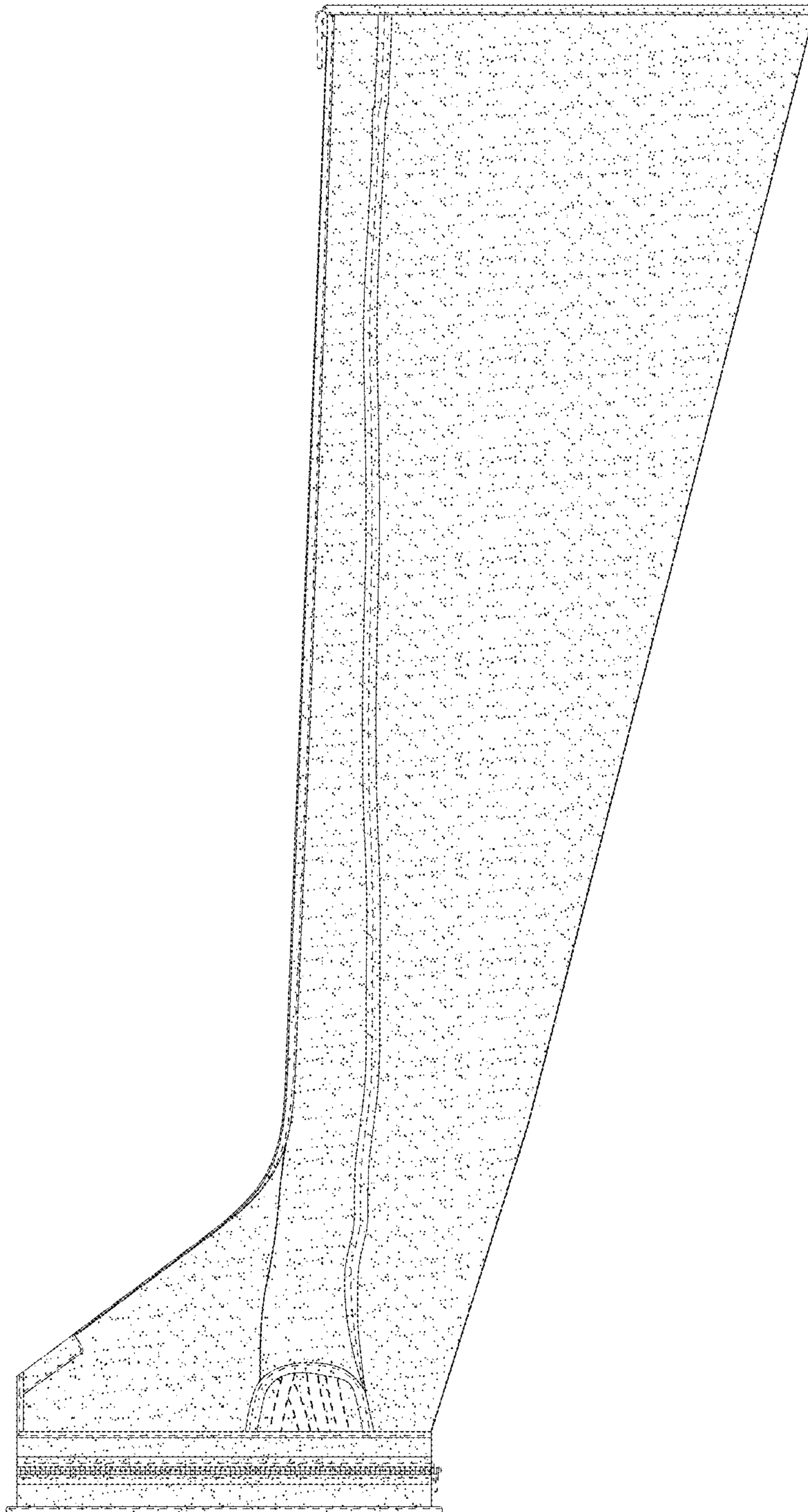

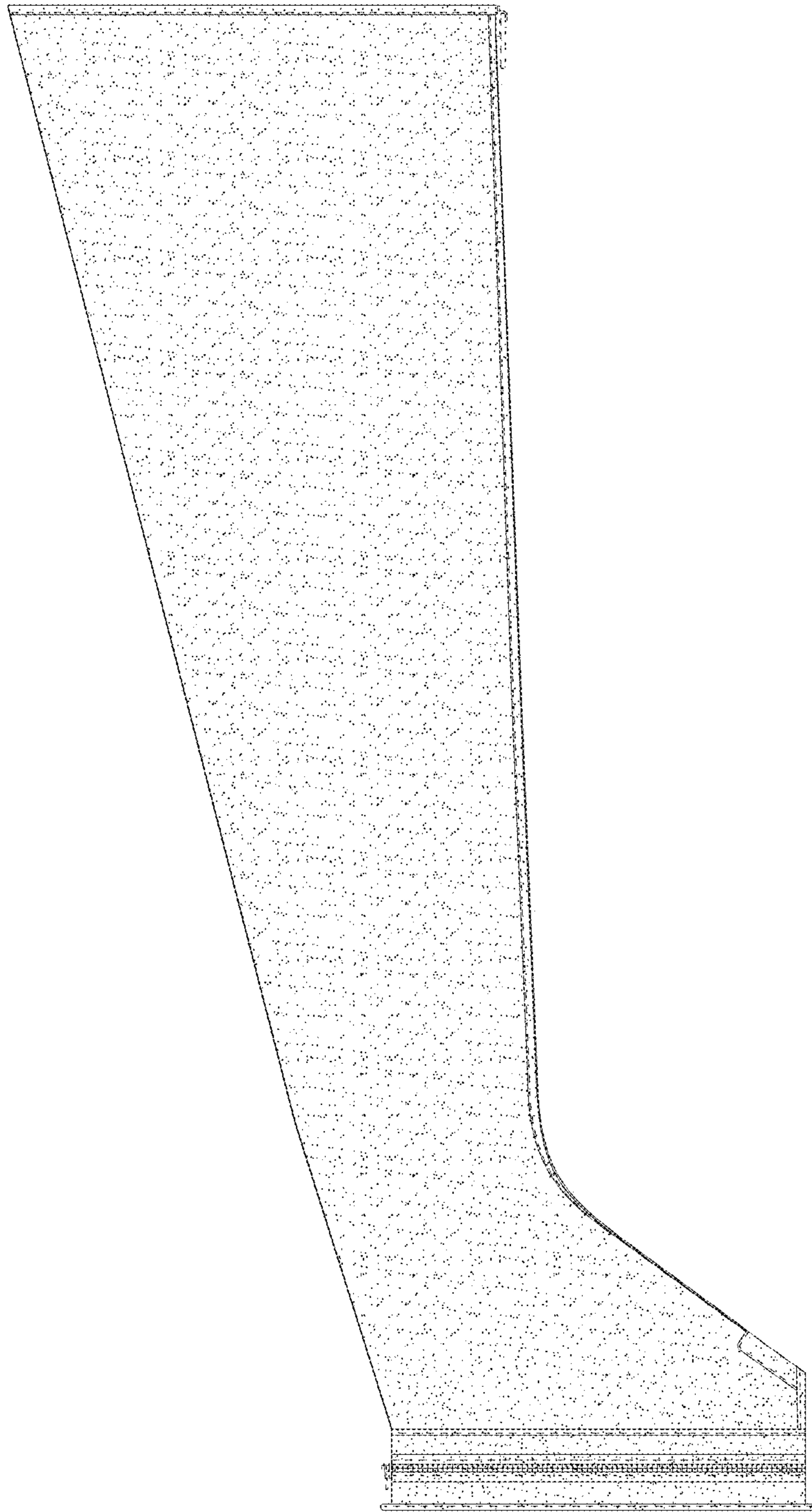
