(57) **CLAIM**

The ornamental design for a combined massage stick and base, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, right and top perspective view of a combined massage stick and base, showing my design. FIG. 2 is a rear, left and bottom perspective view thereof. FIG. 3 is a front elevation view thereof. FIG. 4 is a rear elevation view thereof. FIG. 5 is a left side elevation view thereof. FIG. 6 is a right side elevation view thereof. FIG. 7 is a top plan view thereof. FIG. 8 is a bottom plan view thereof; and, FIG. 9 is another front, right and top perspective view of the combined massage stick and base, wherein the massage stick and the base are separated from each other.

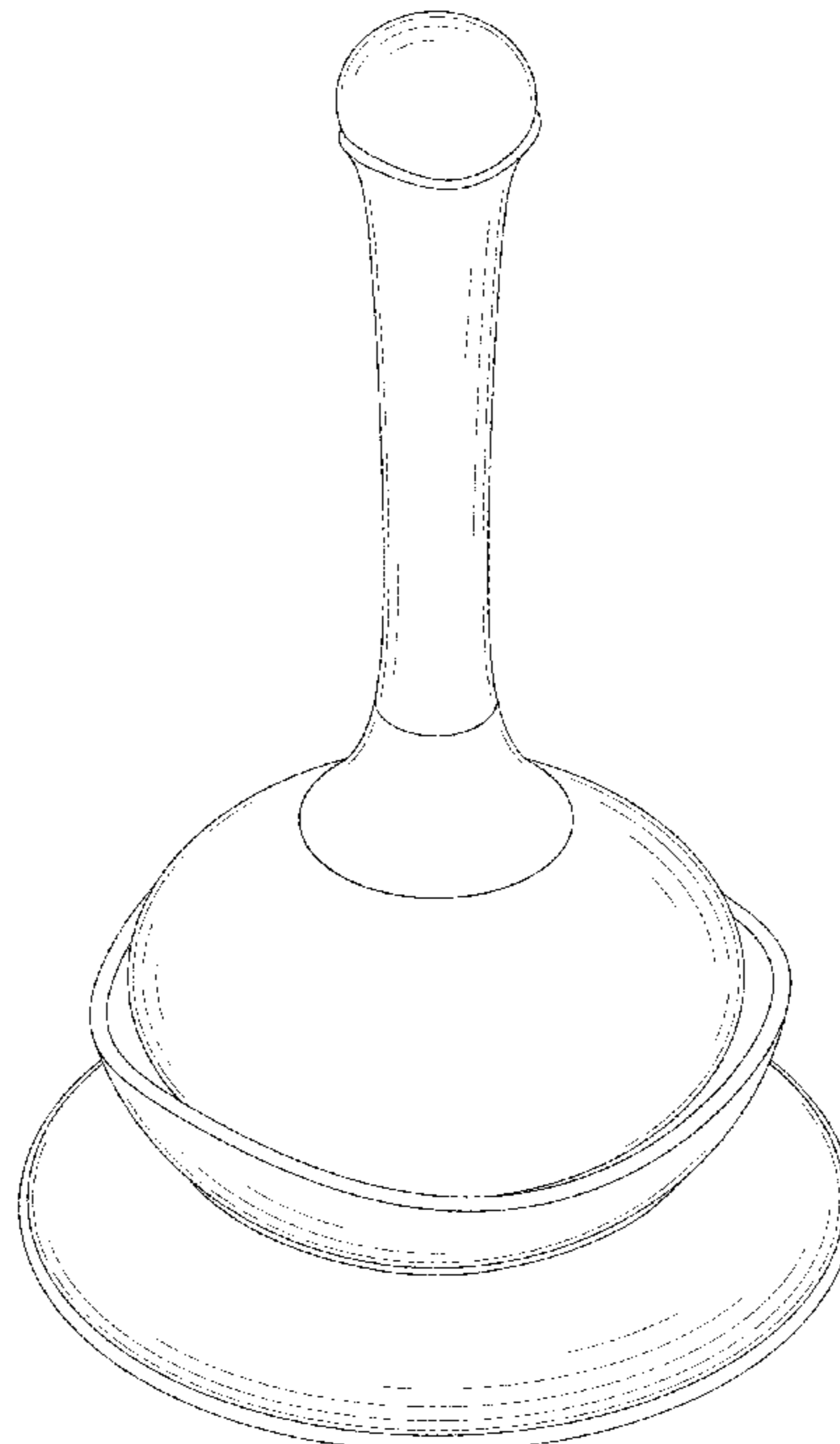

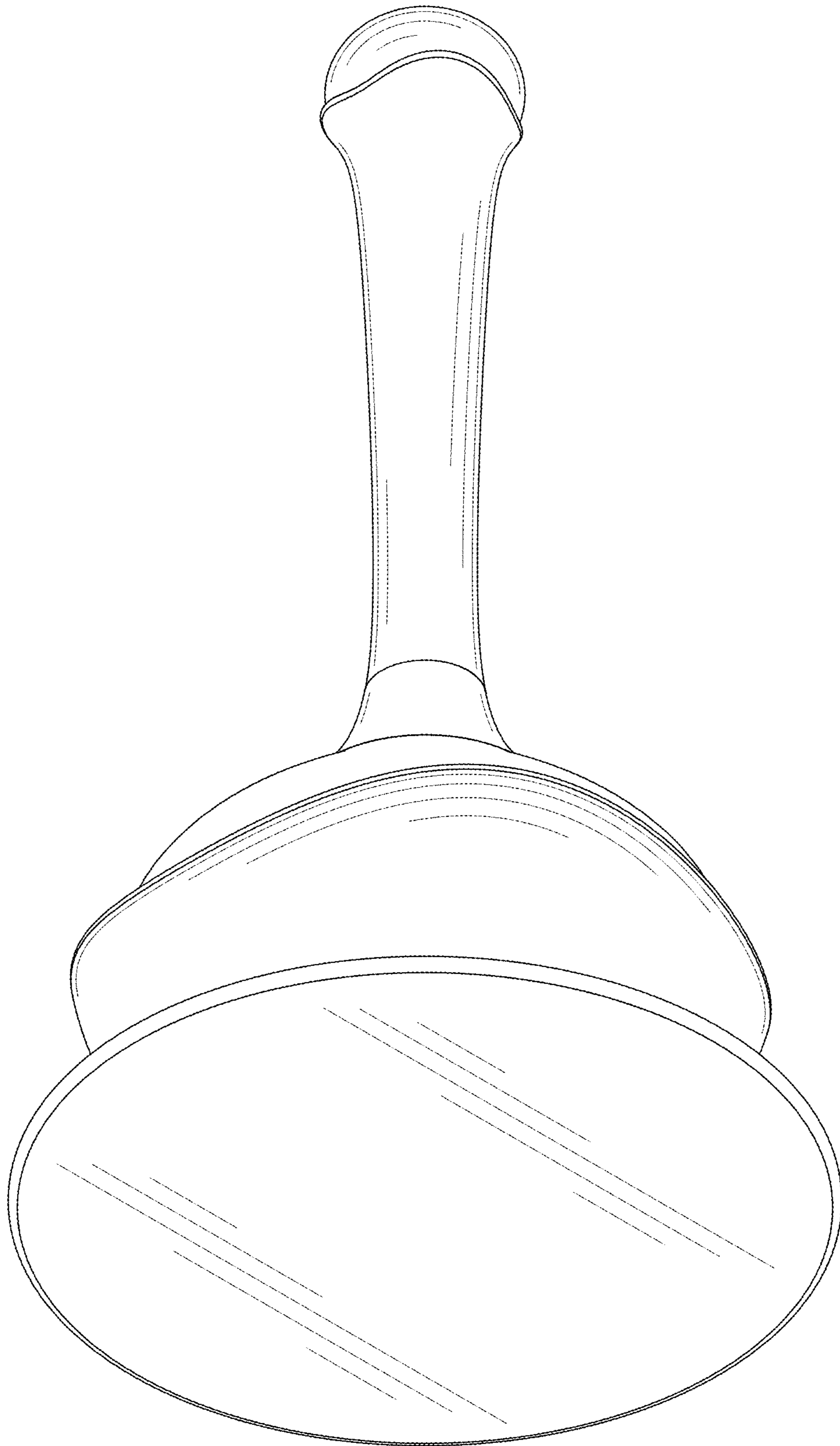

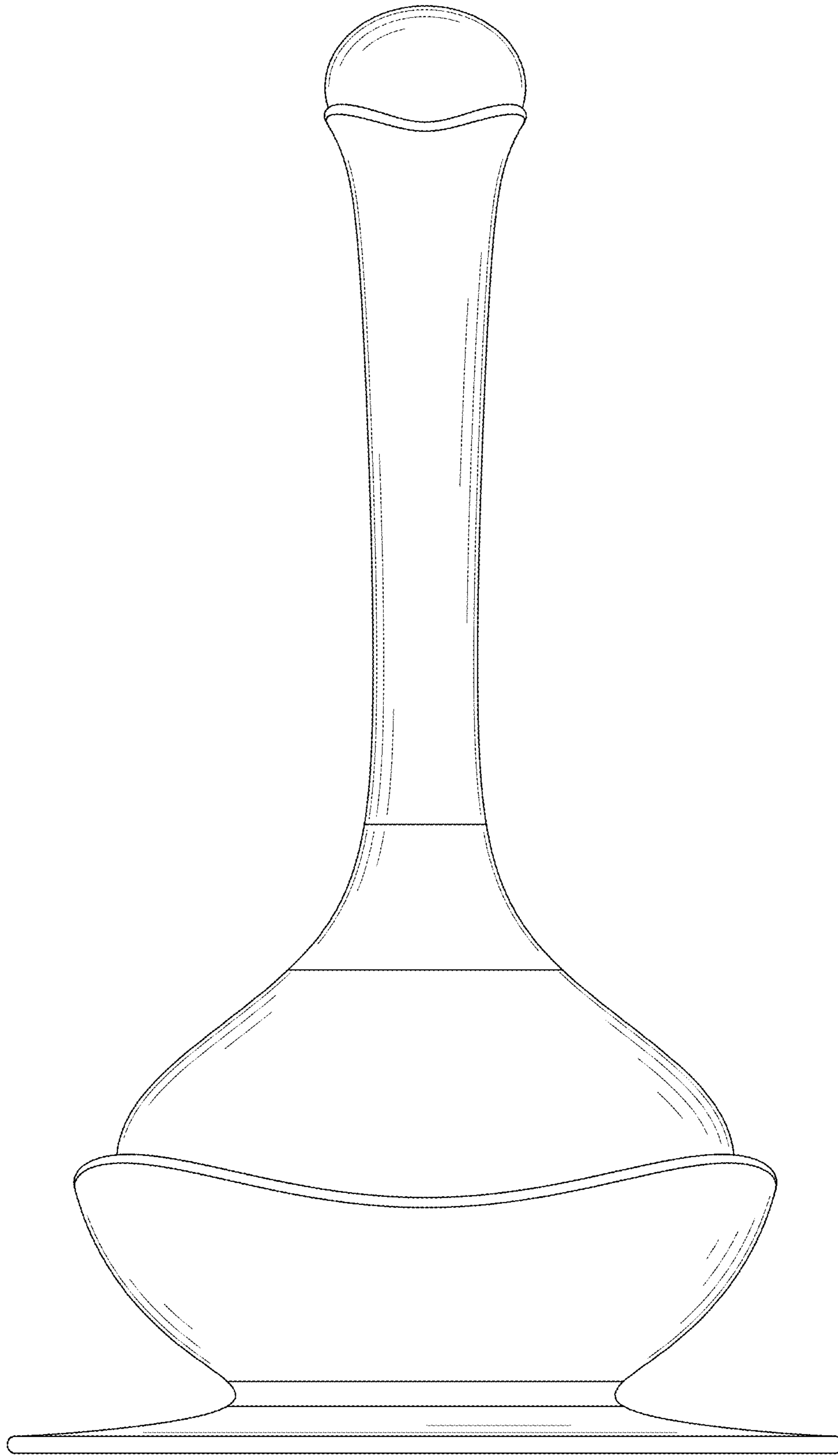

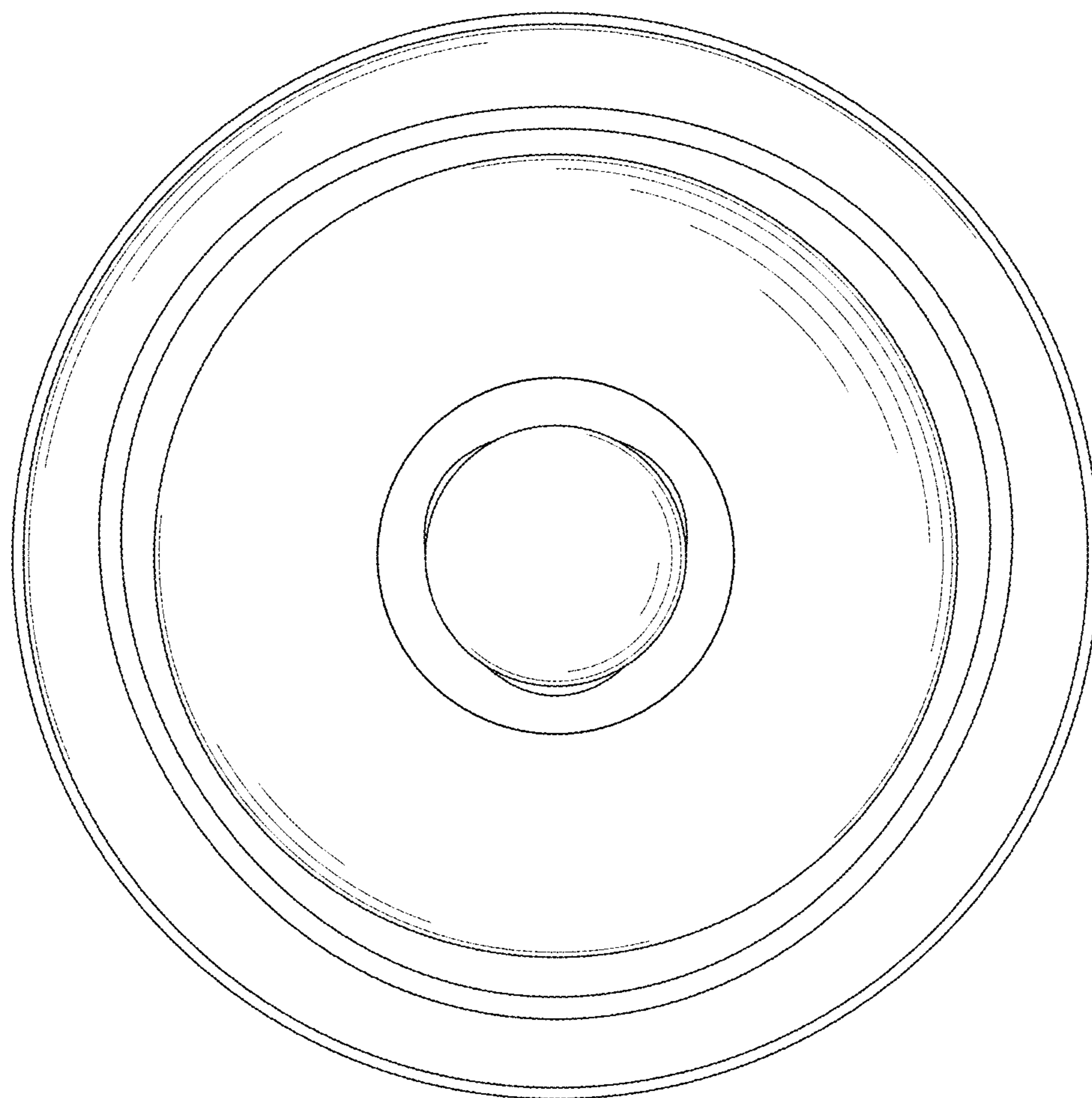

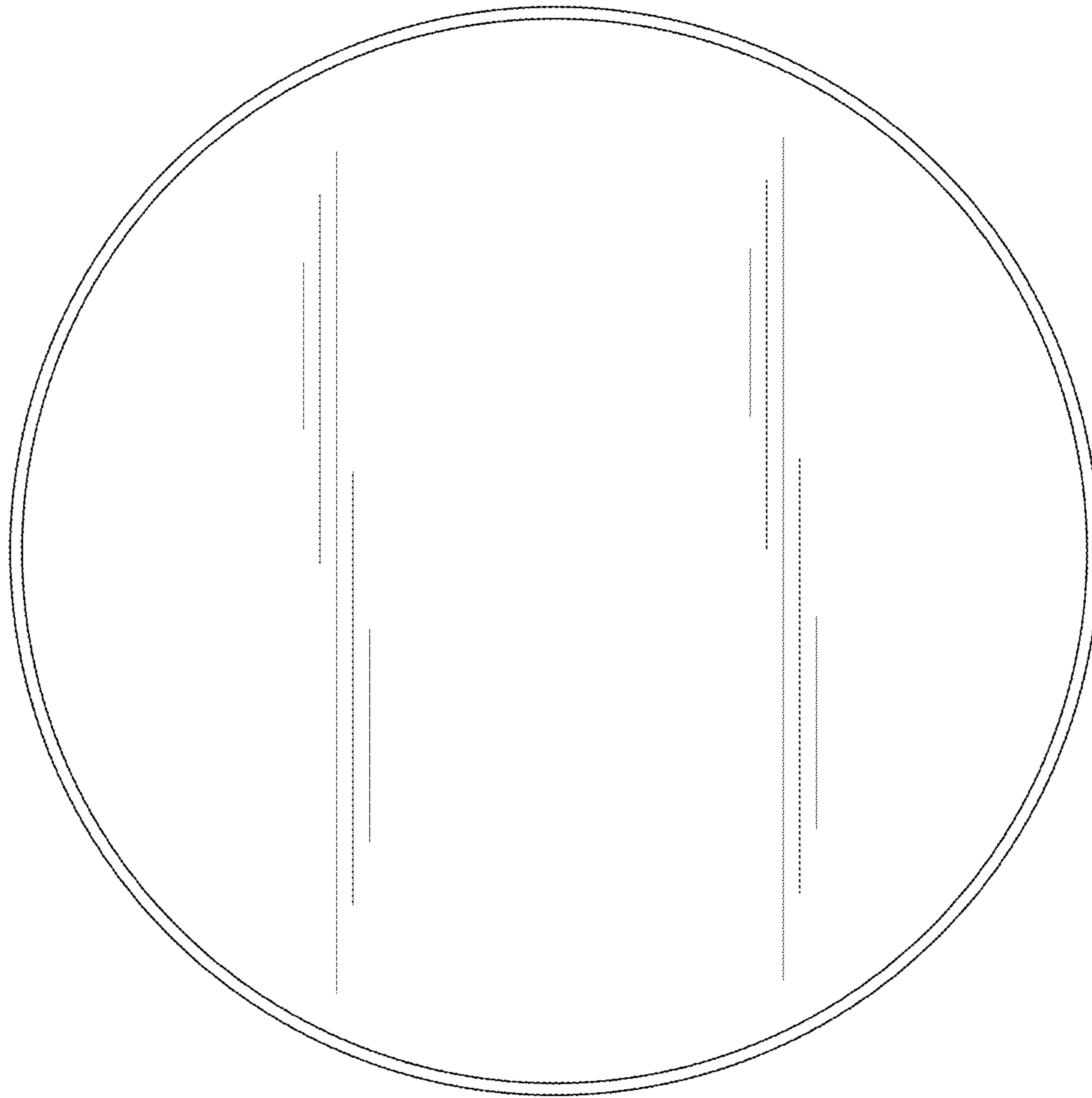

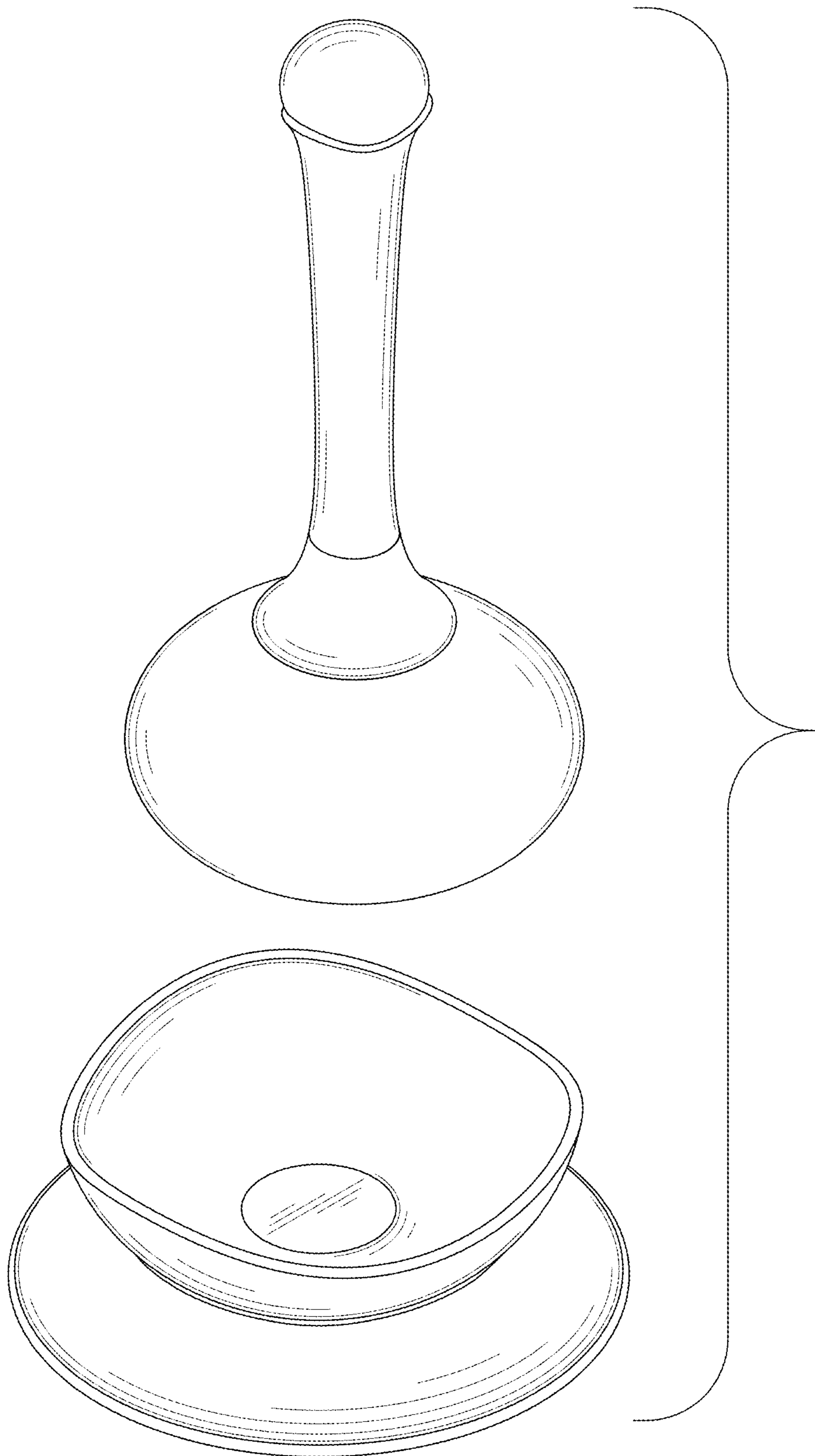
