FIG. 1 is a perspective view of a carrier showing our new and ornamental design;

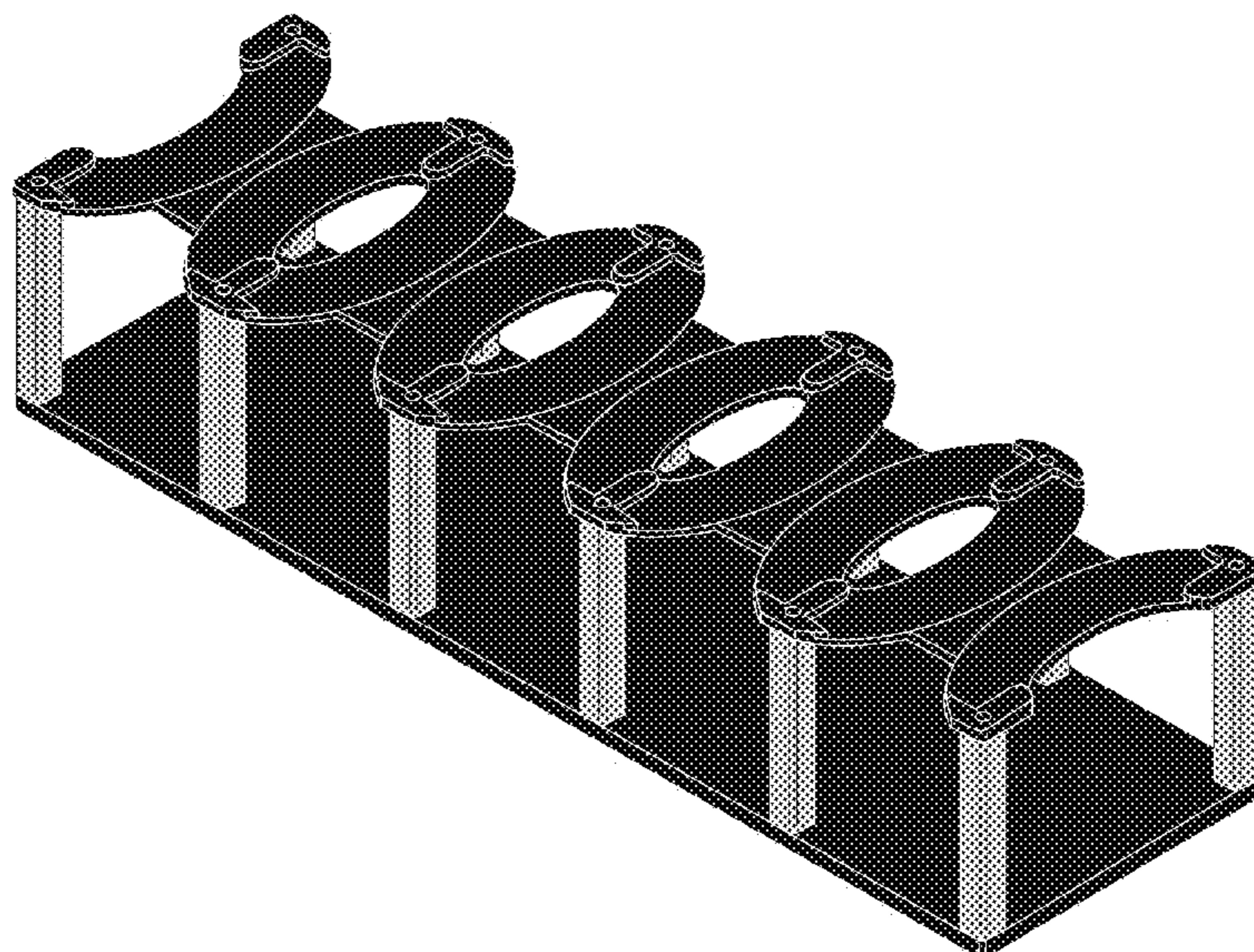
FIG. 2 is a top view thereof;

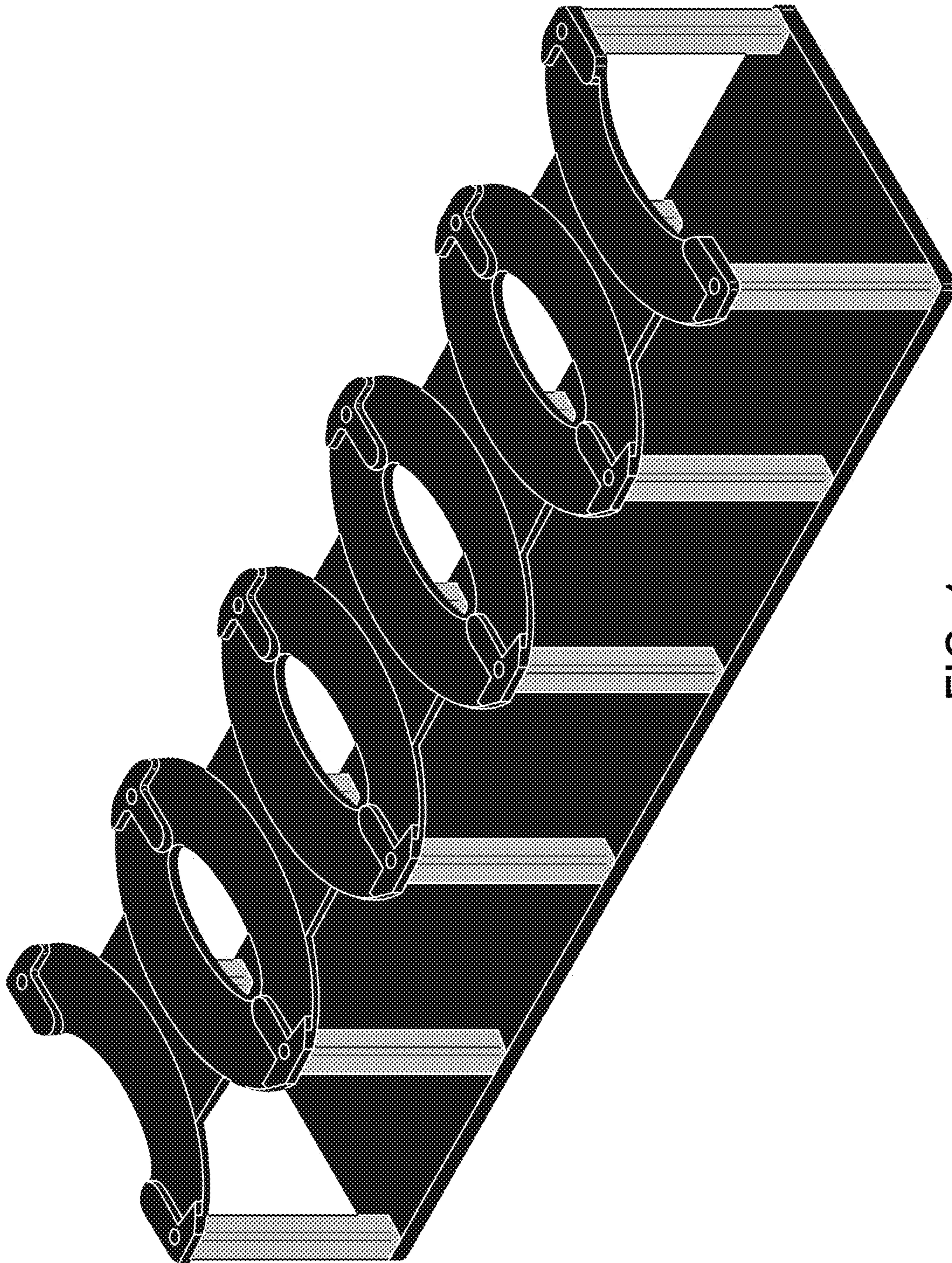

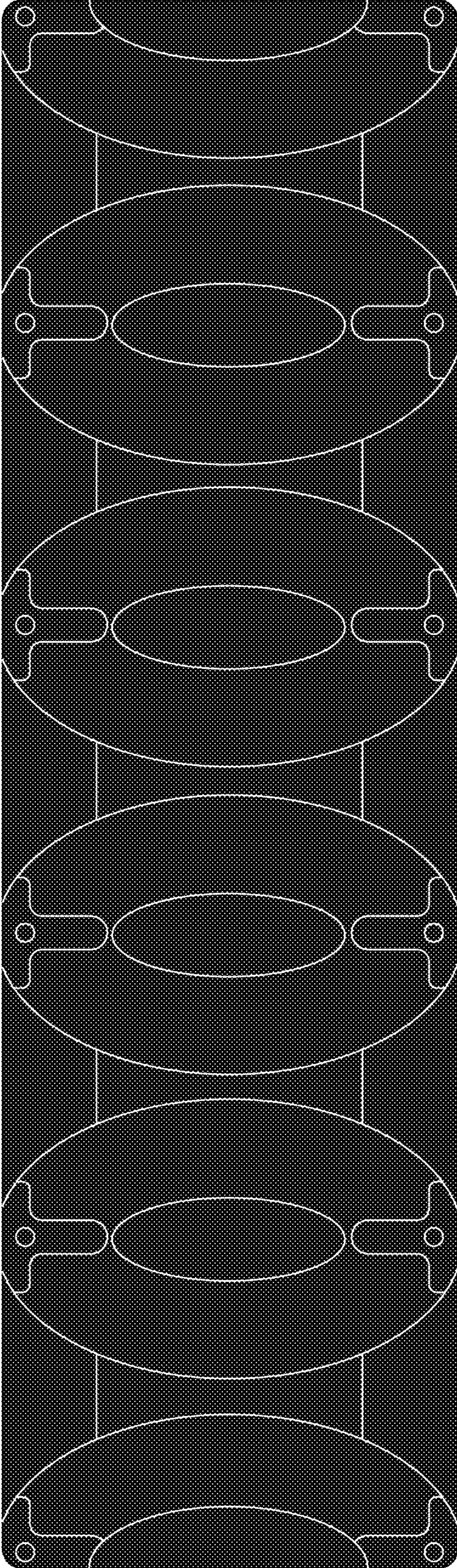

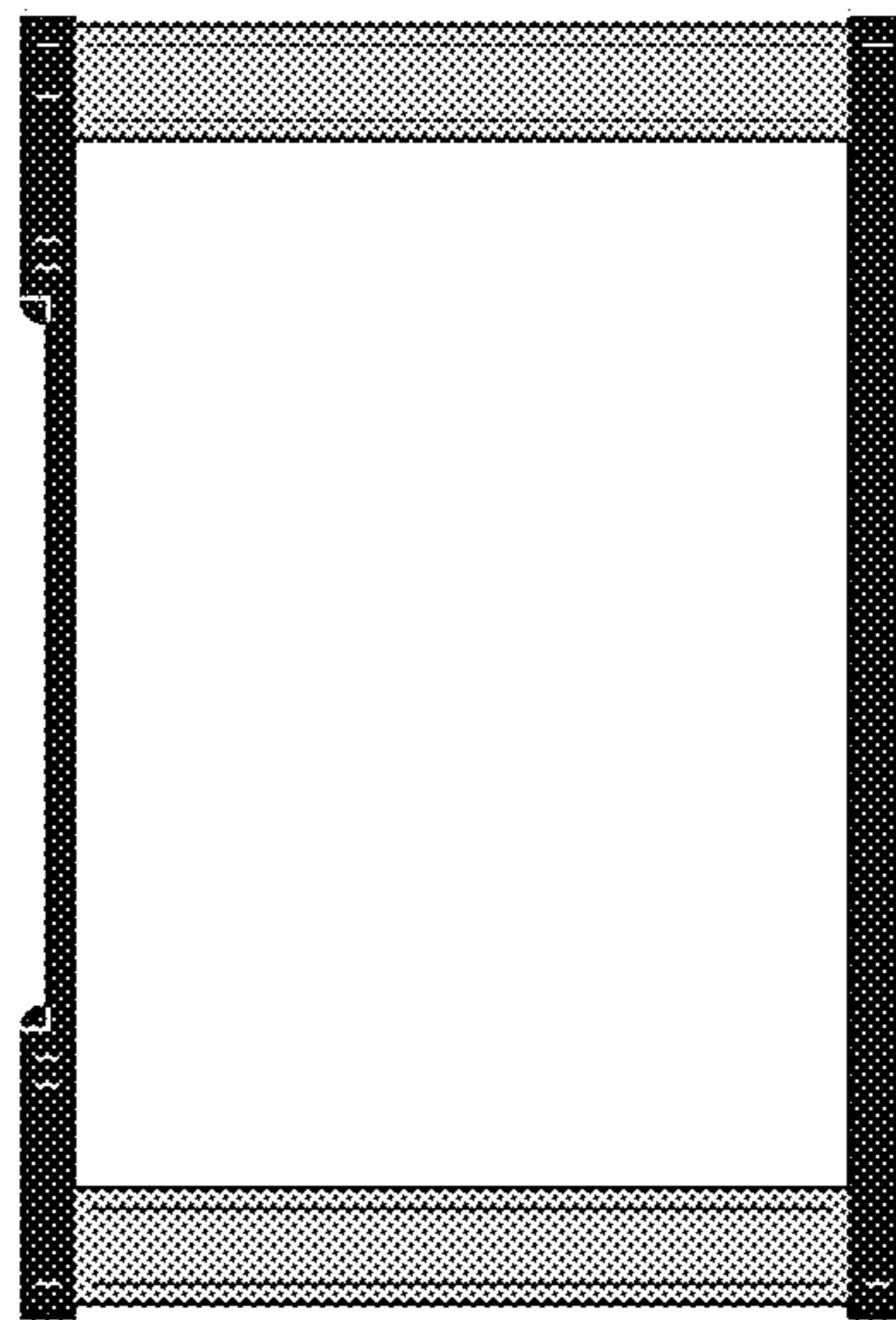

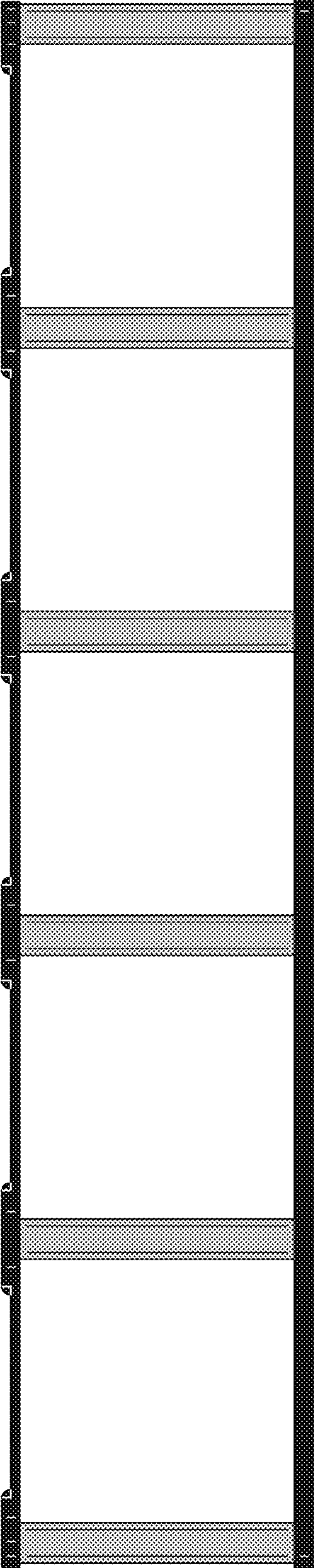
