(57) **CLAIM**

The ornamental design for a ceiling lighting equipment for elevator, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, top and right side perspective view of a ceiling lighting equipment for elevator, showing our new design;

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a top view thereof;

FIG. 5 is a left side view thereof; and,

FIG. 6 is an enlarged end view taken along line 6-6 in FIG. 2, with the internal system omitted thereof.

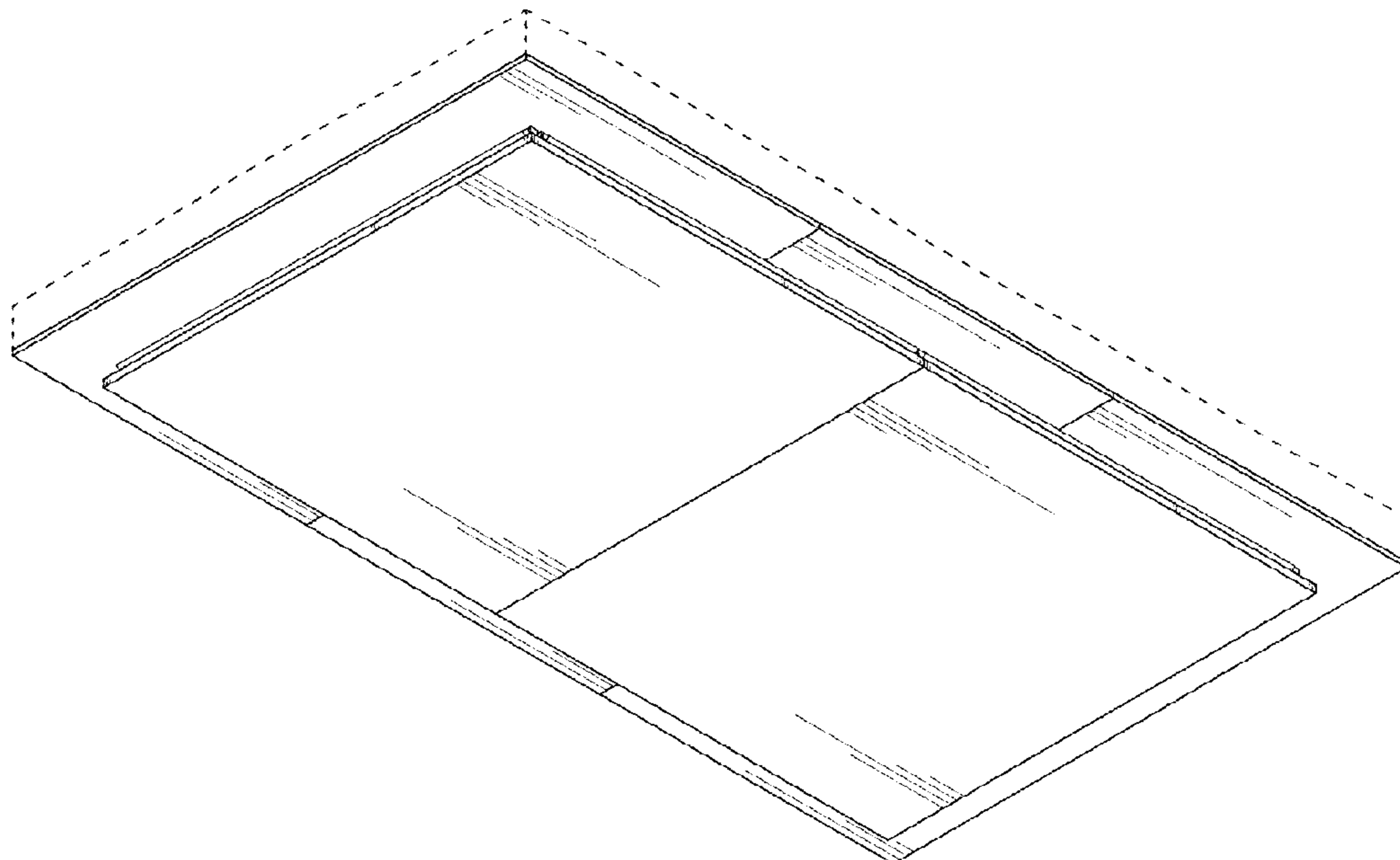

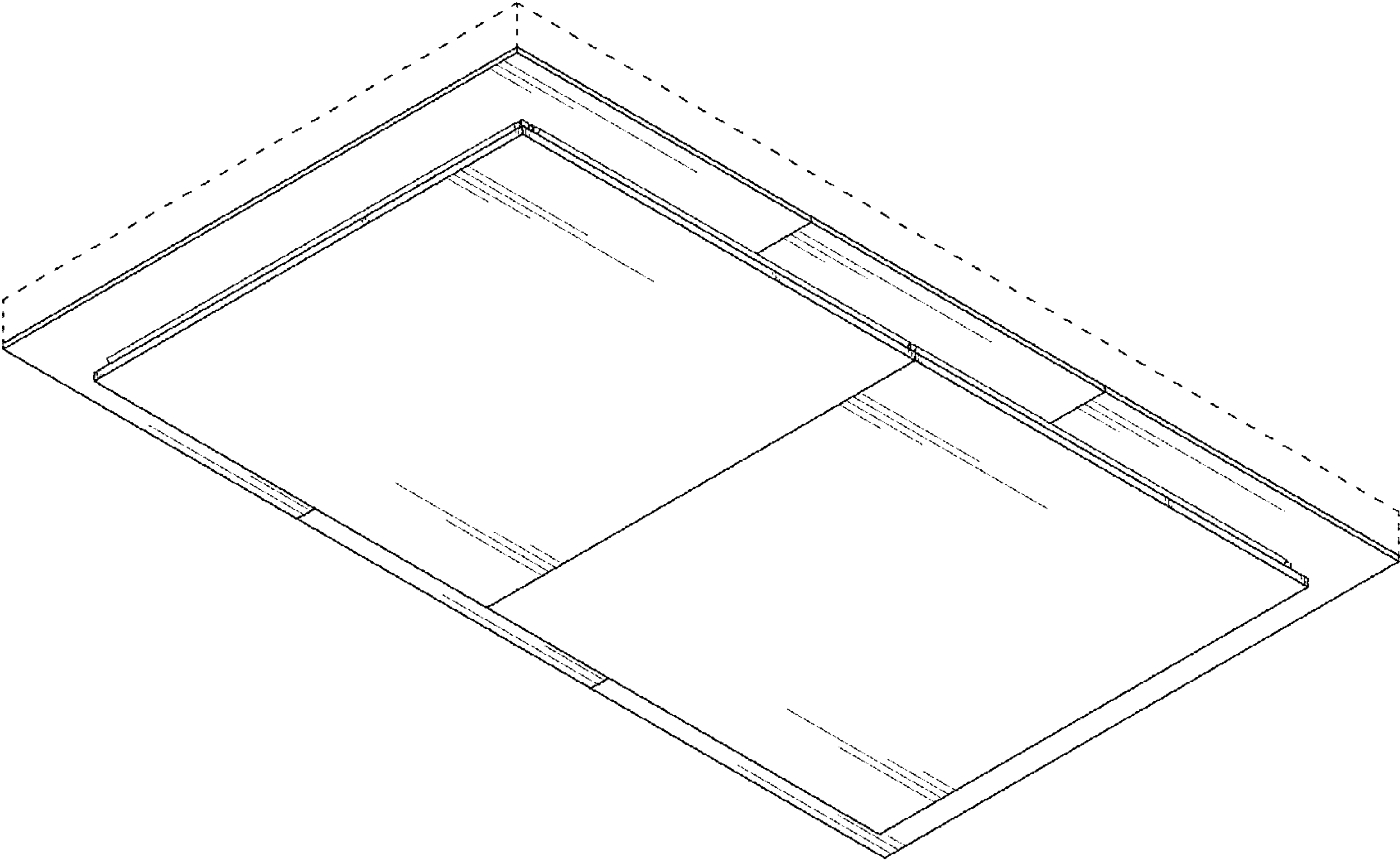
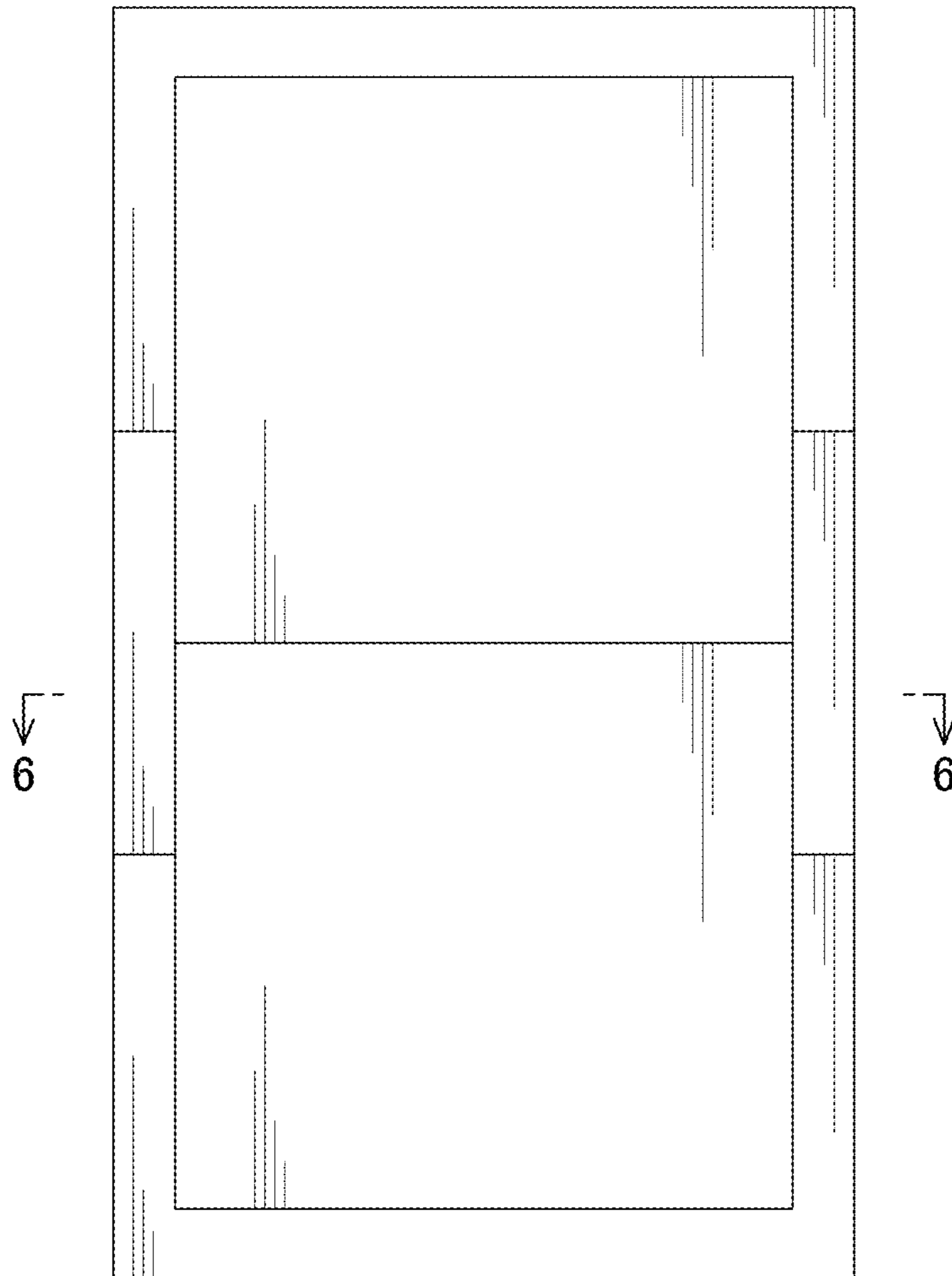

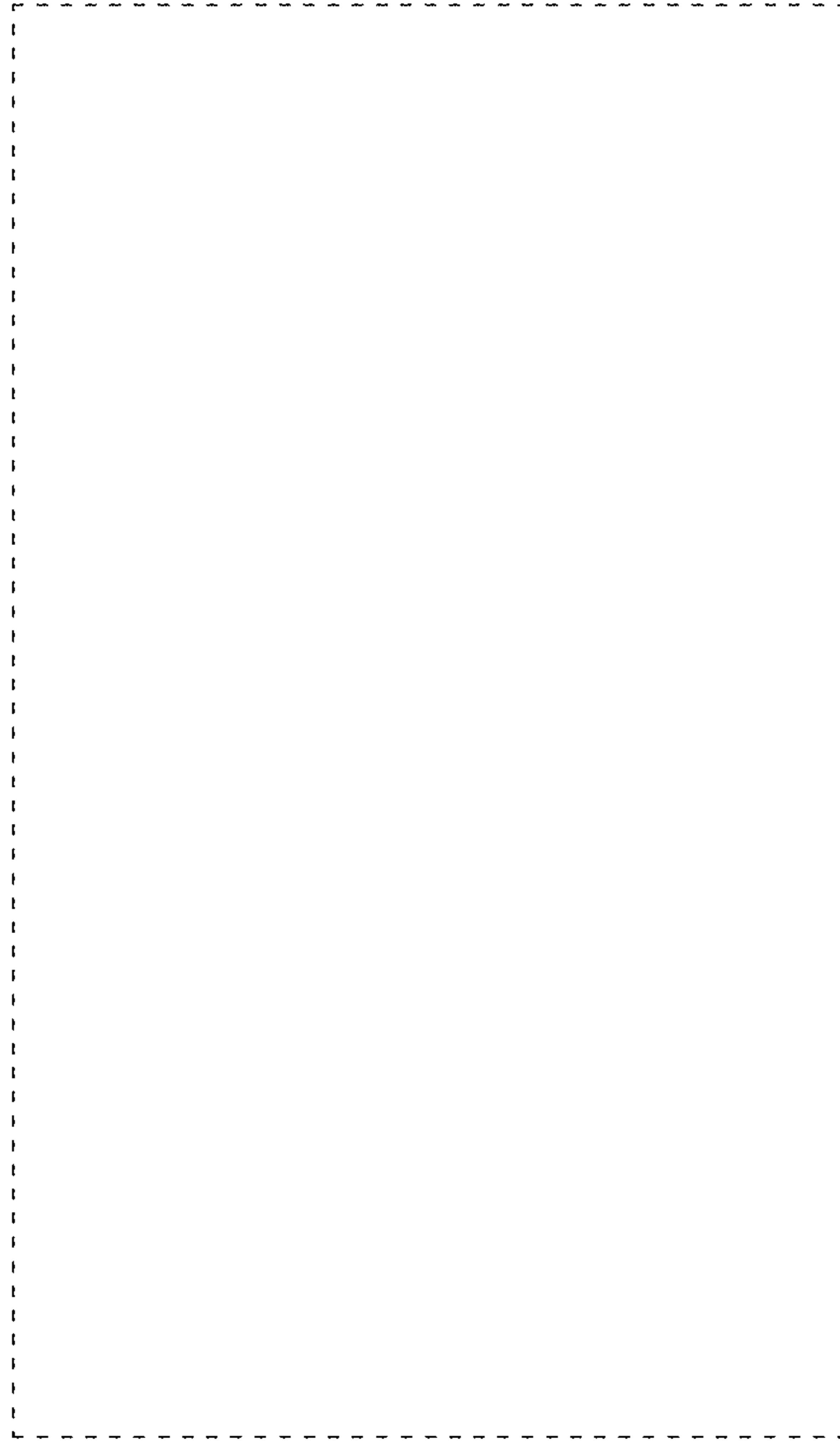

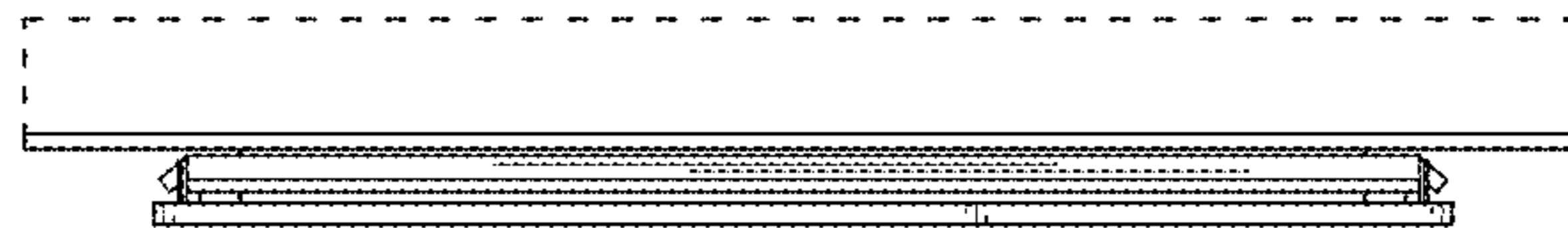

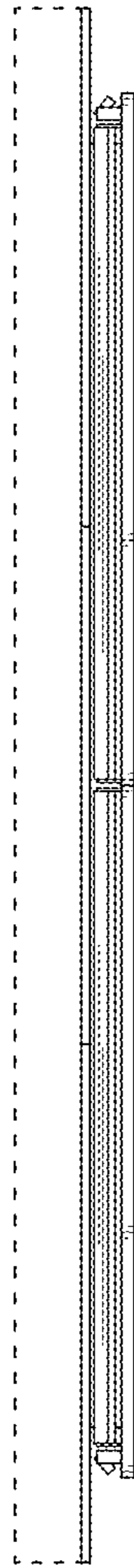
