(57) **CLAIM**

The ornamental design for a ceiling lighting equipment for elevator, as shown and described.

DESCRIPTION

FIG. 1 is a front, top, and right side perspective view of a ceiling lighting equipment for elevator, showing our new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a top view thereof;
FIG. 5 is a left side view thereof;
FIG. 6 is an end view taken along line 6-6 in FIG. 2, with the internal system omitted thereof; and,
FIG. 7 is a reference view showing the state in use thereof.
The parts shown in the broken lines do not form part of the claimed design.

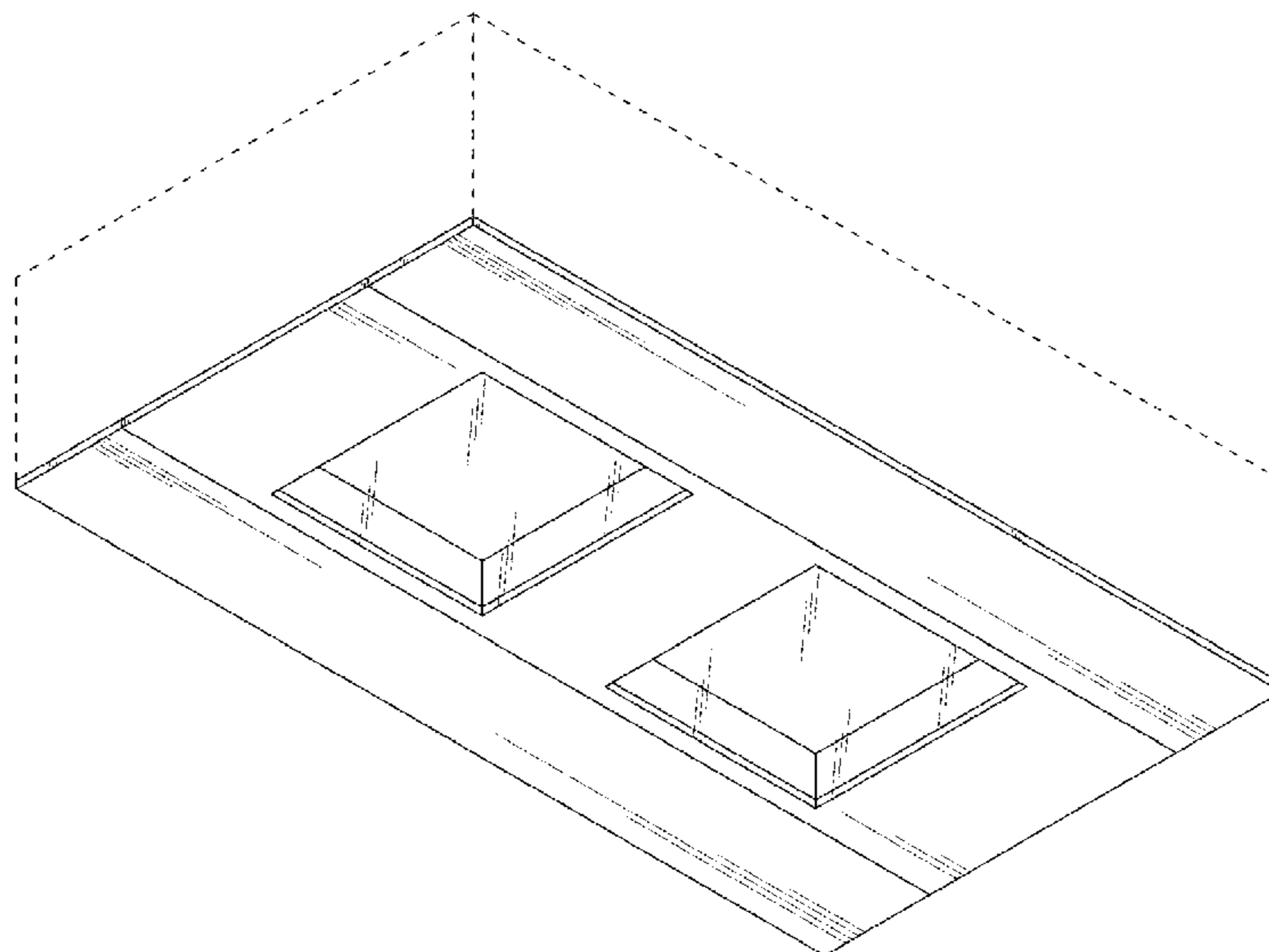

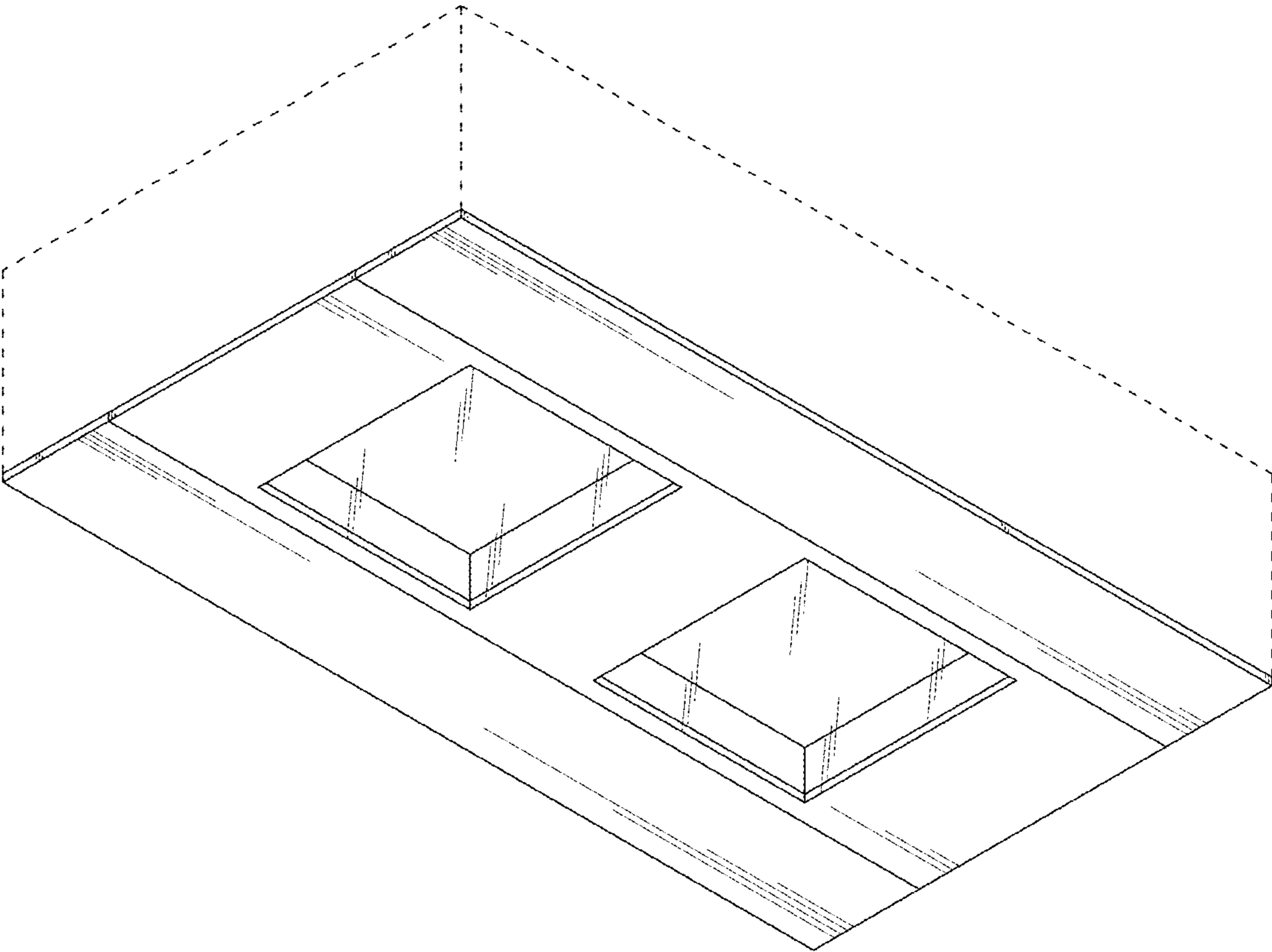

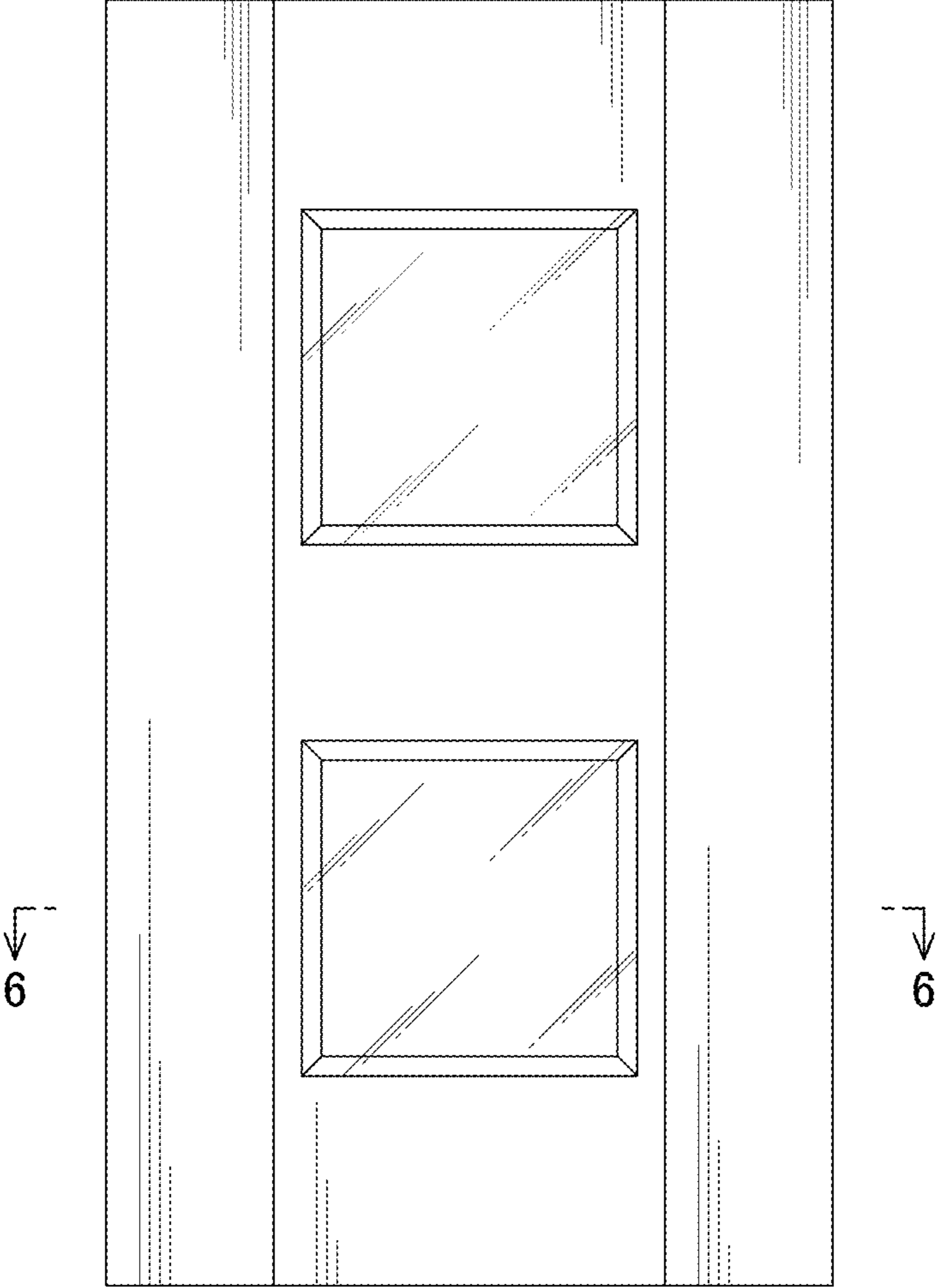

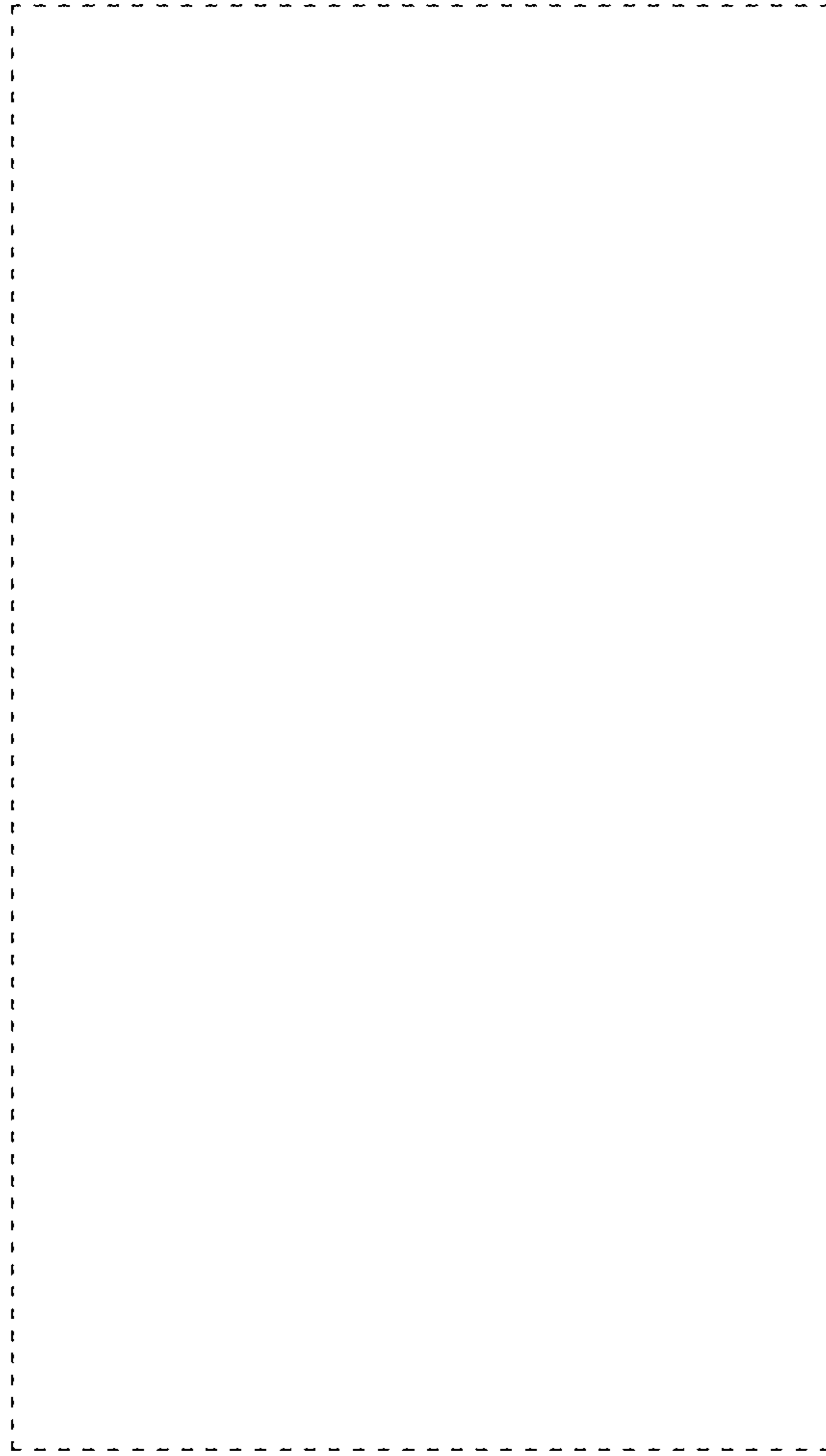

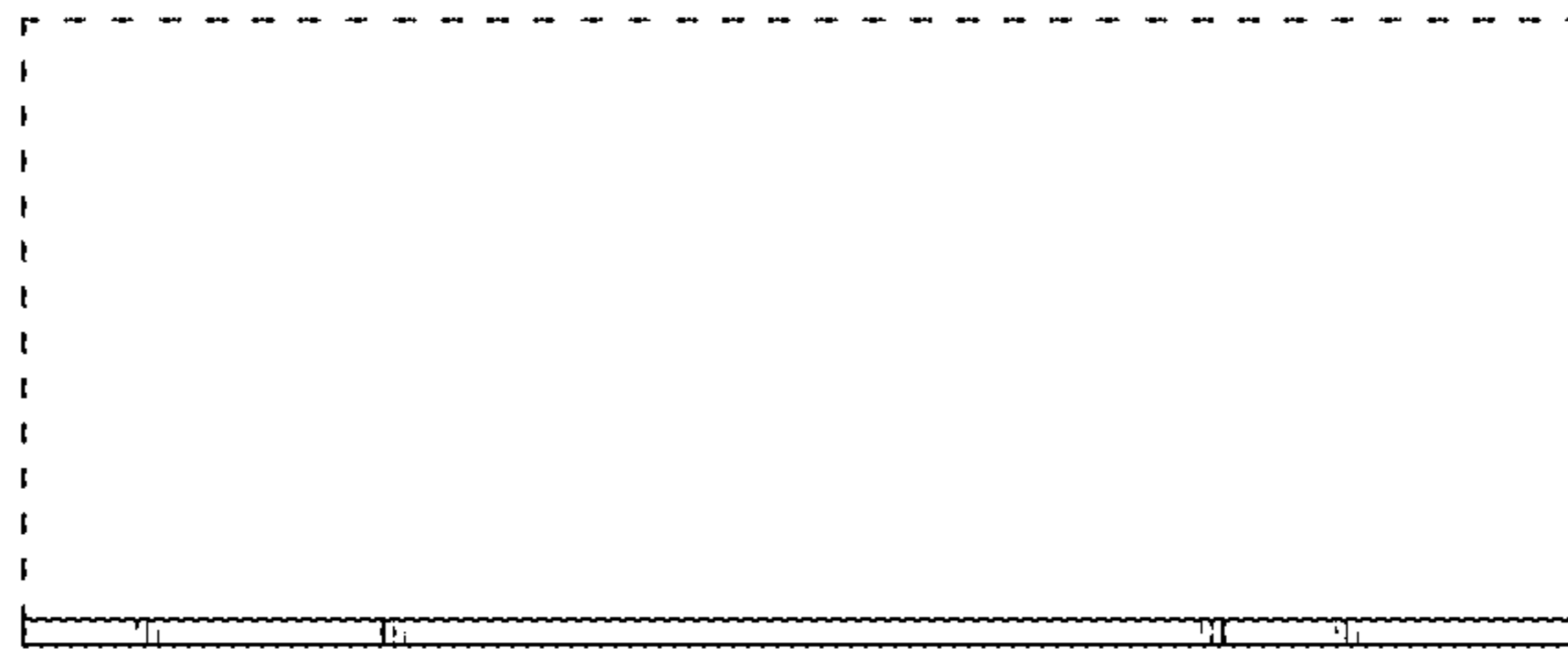

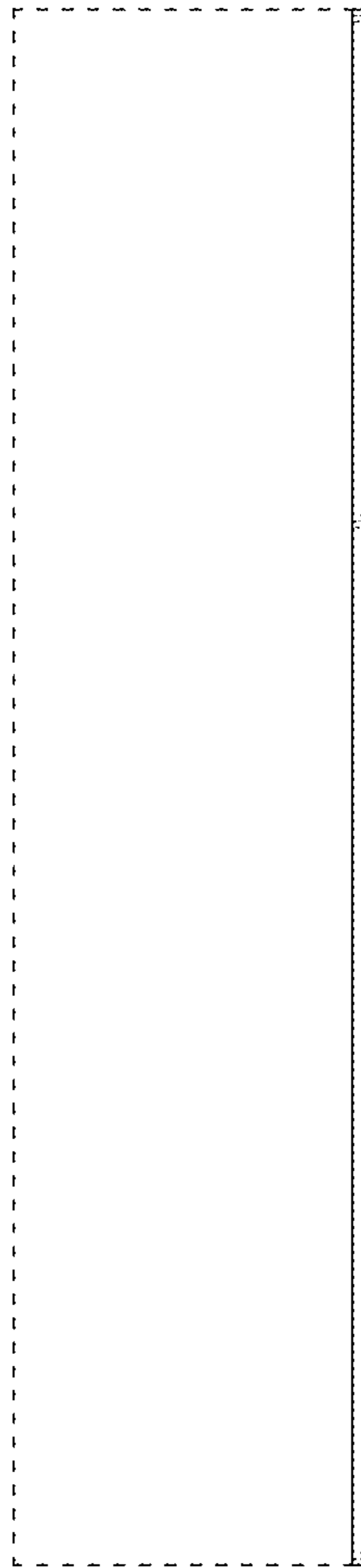

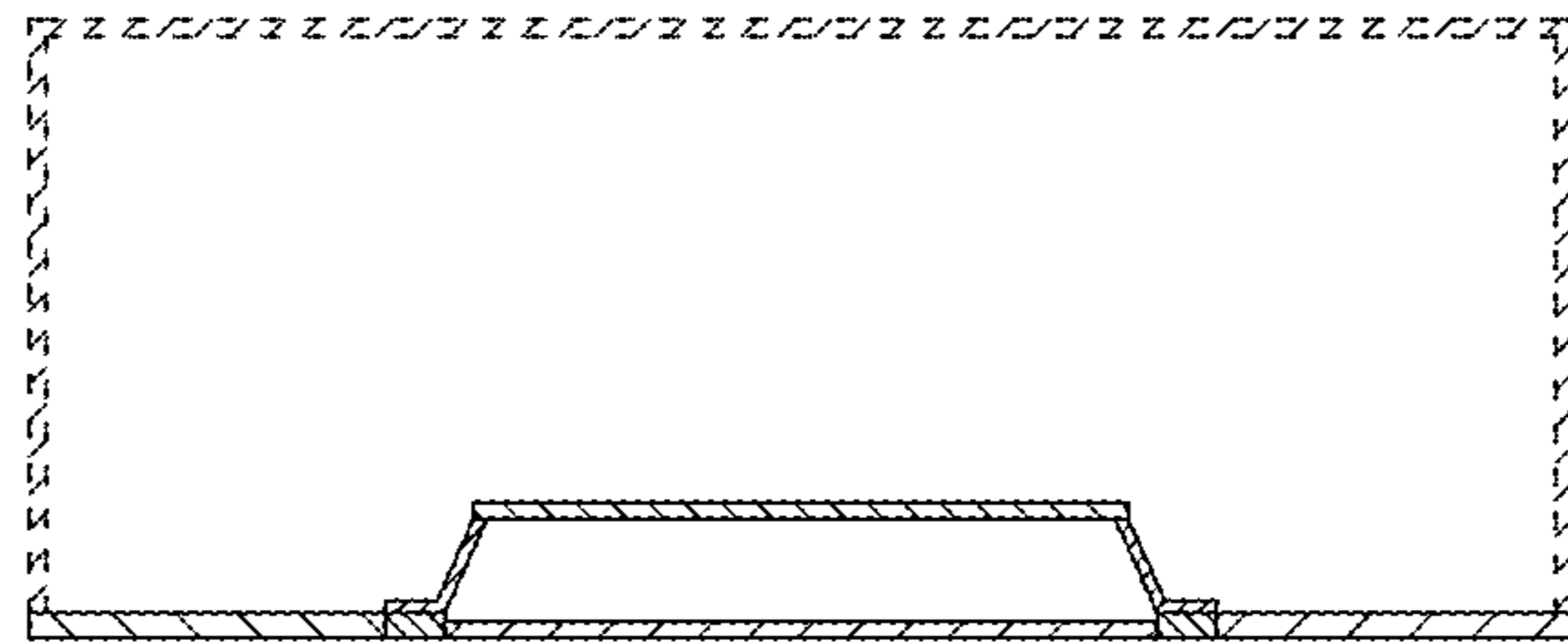
