FIG. 11 is a top plan view thereof.

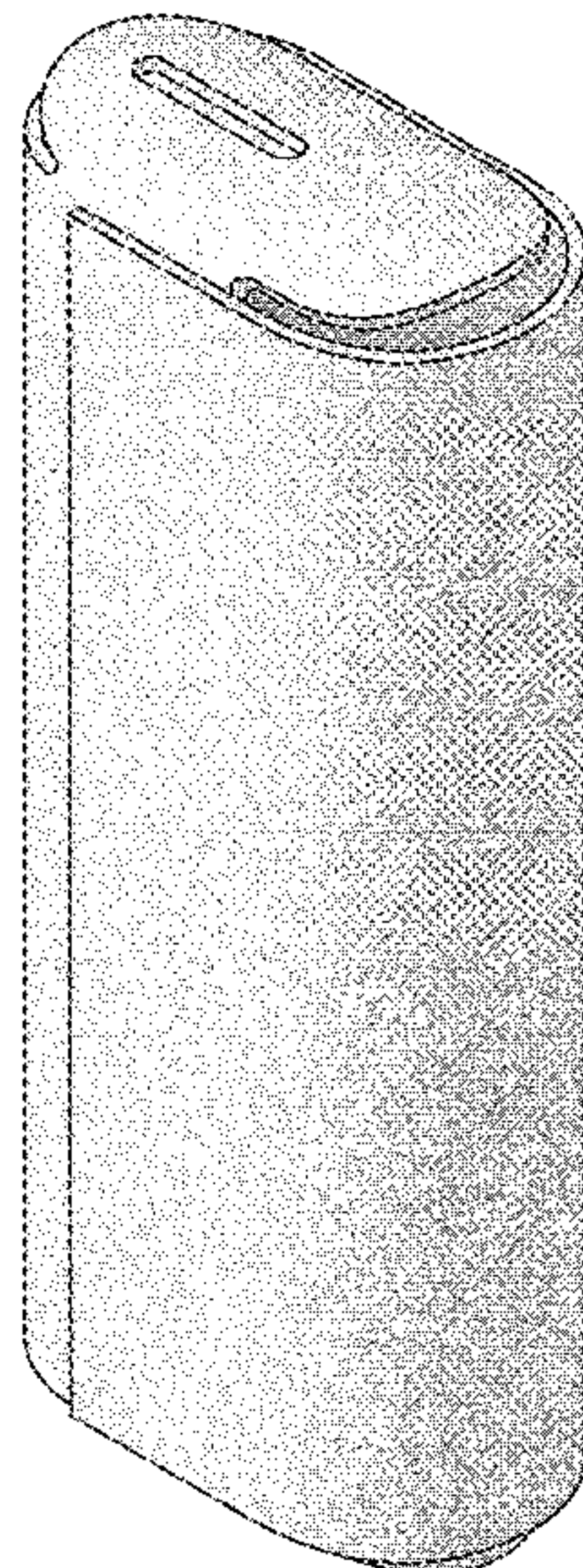
FIG. 12 is a bottom plan view thereof.

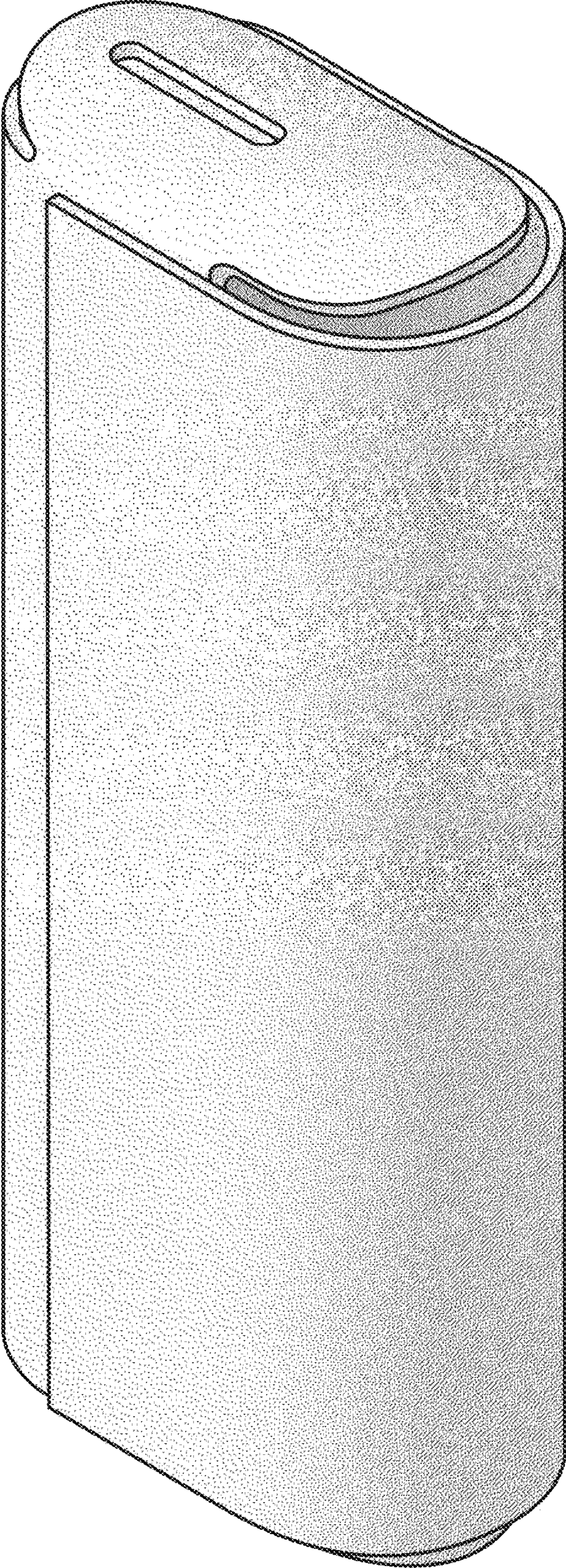

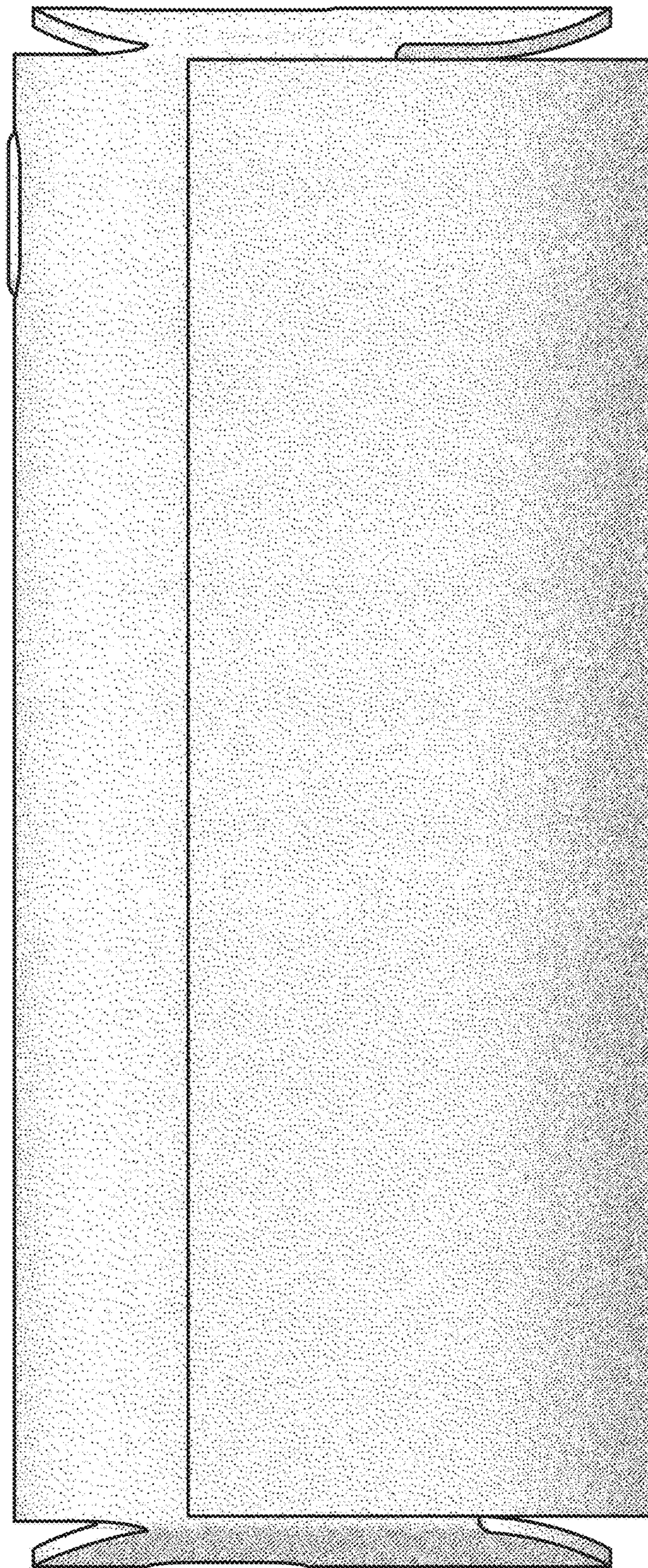

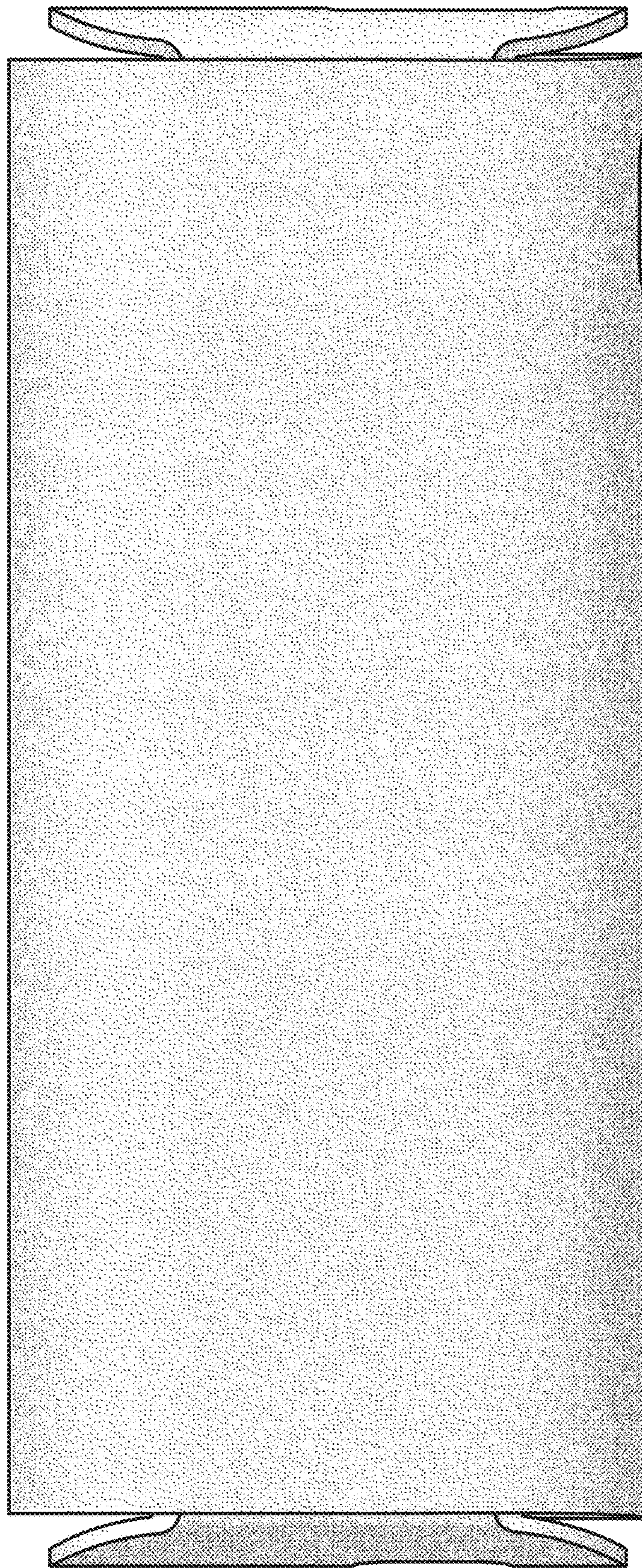

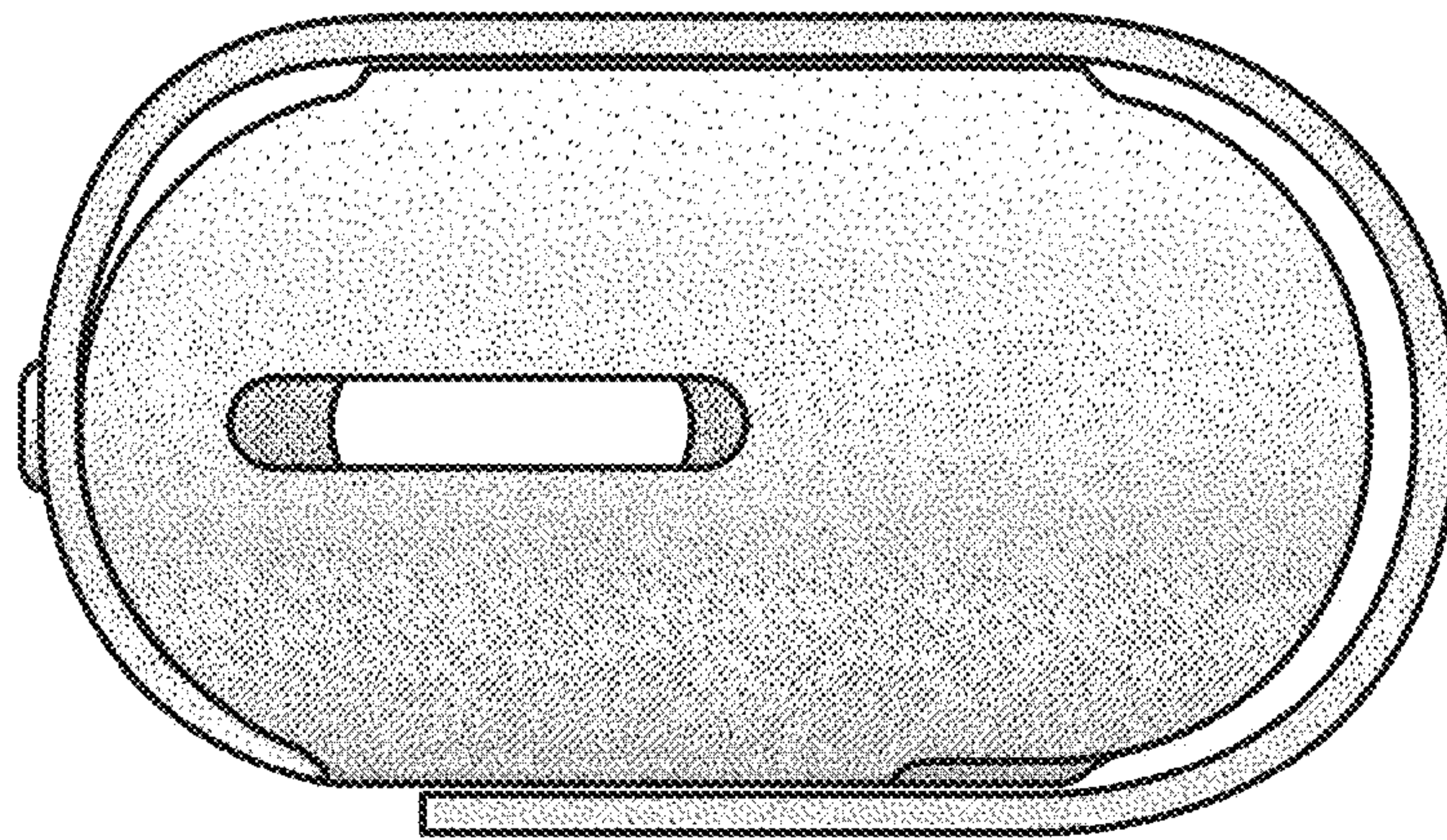

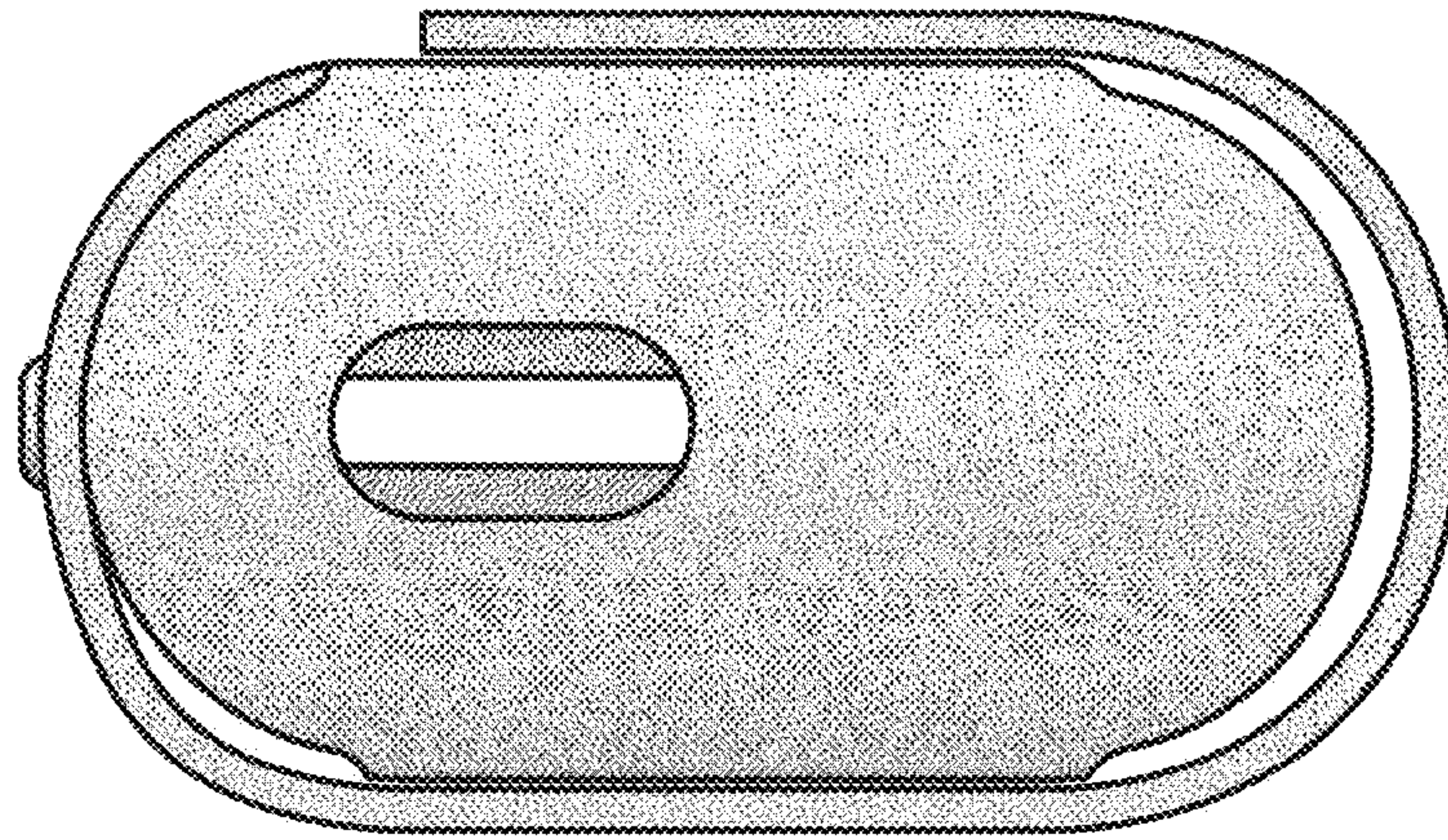

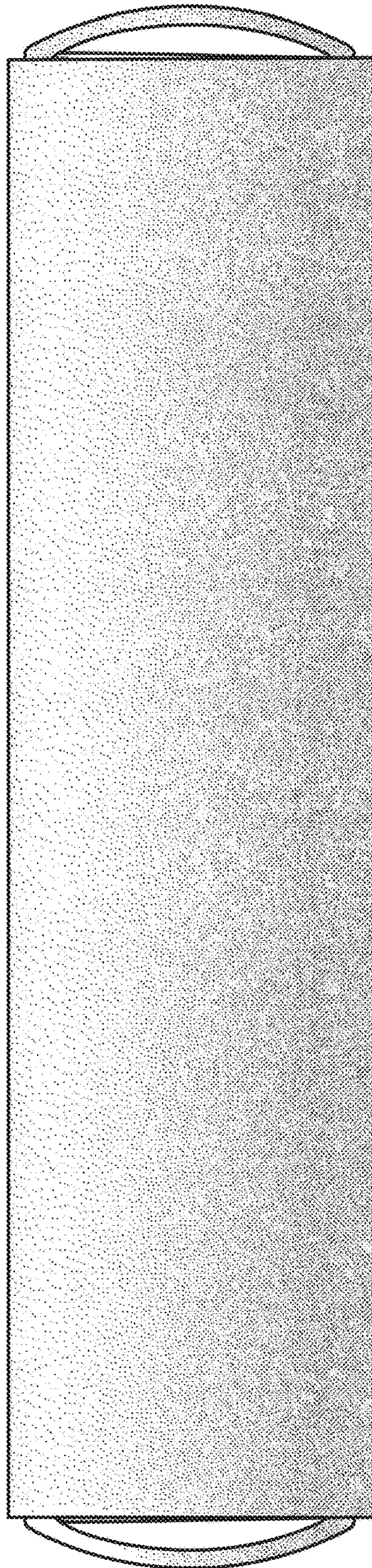

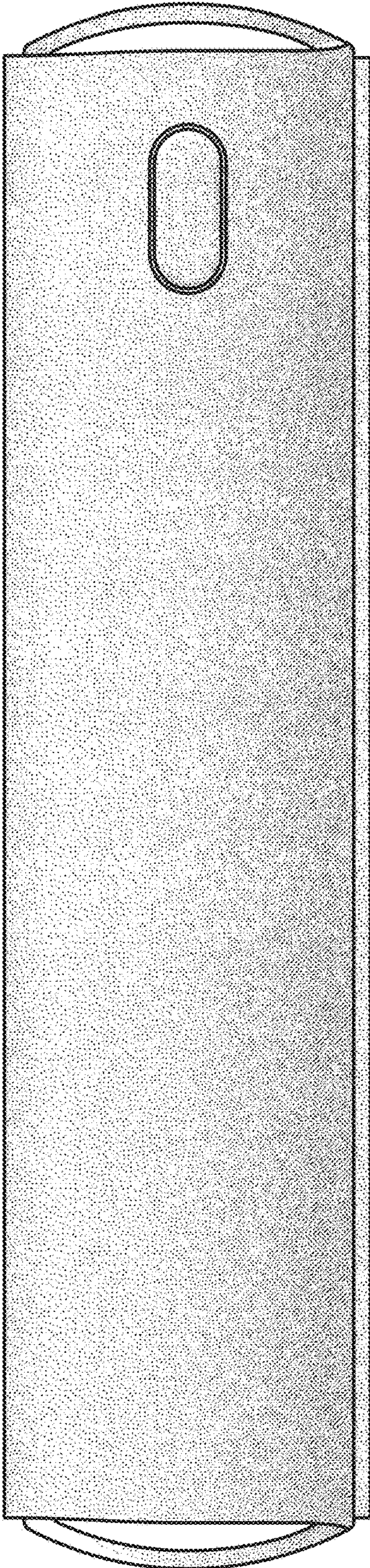

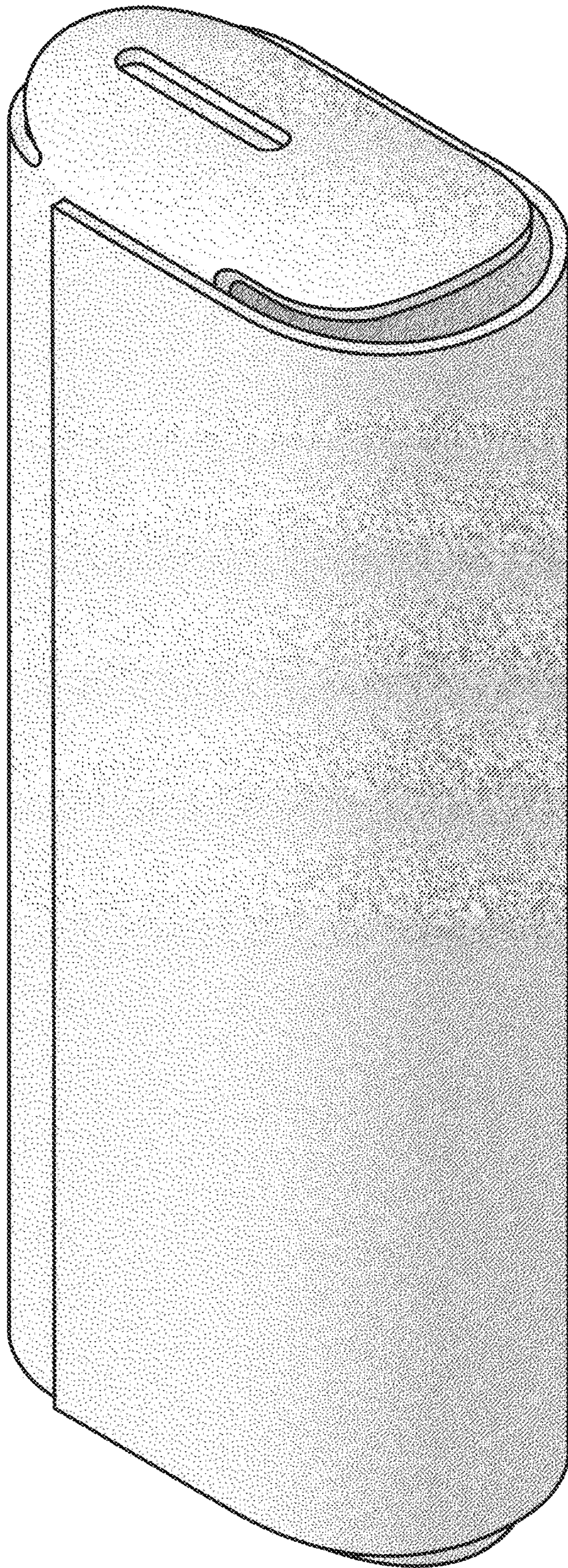

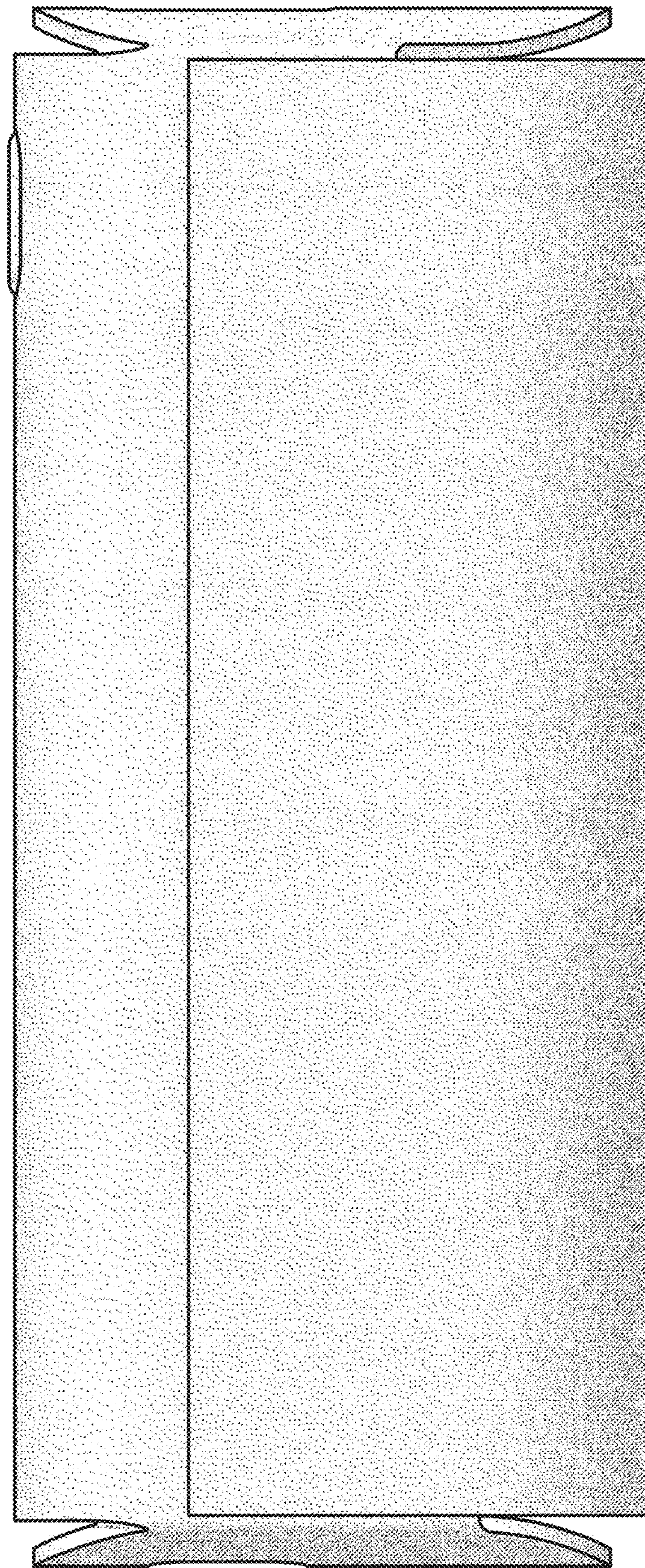

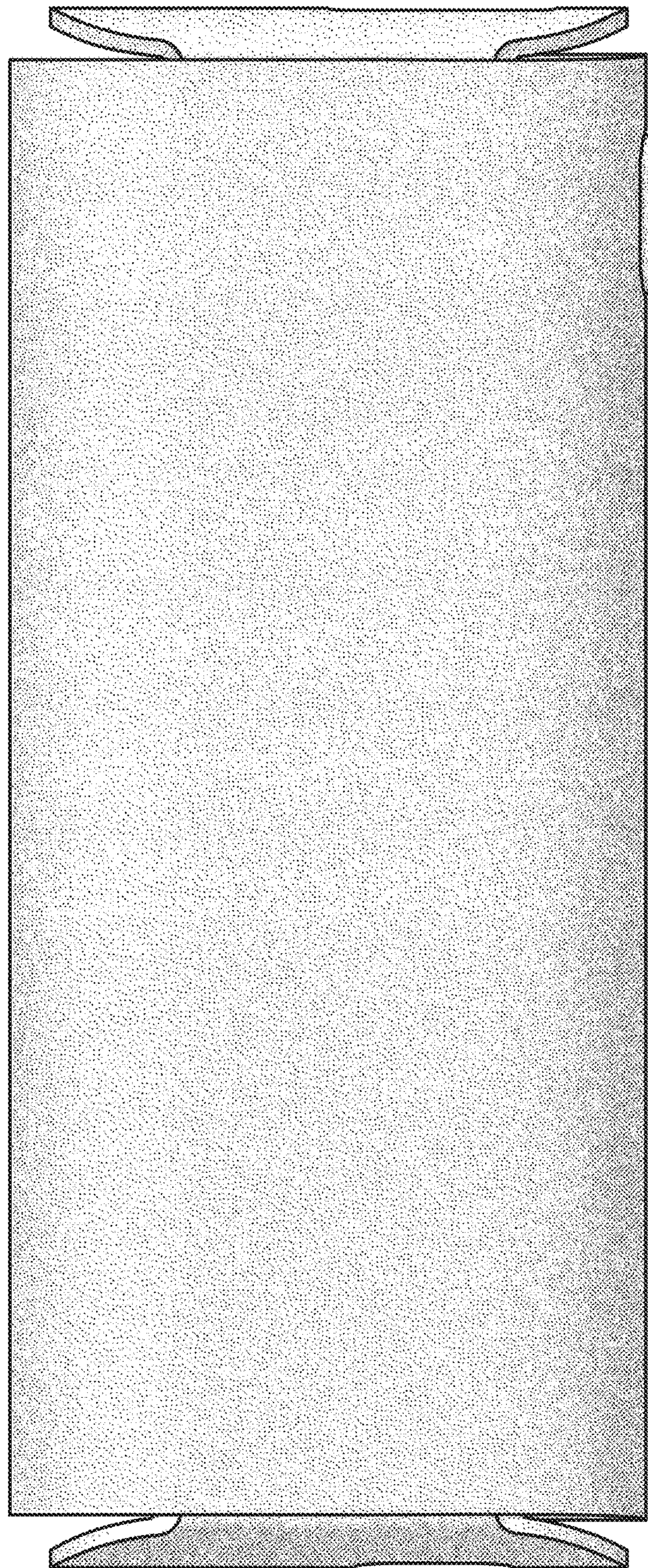

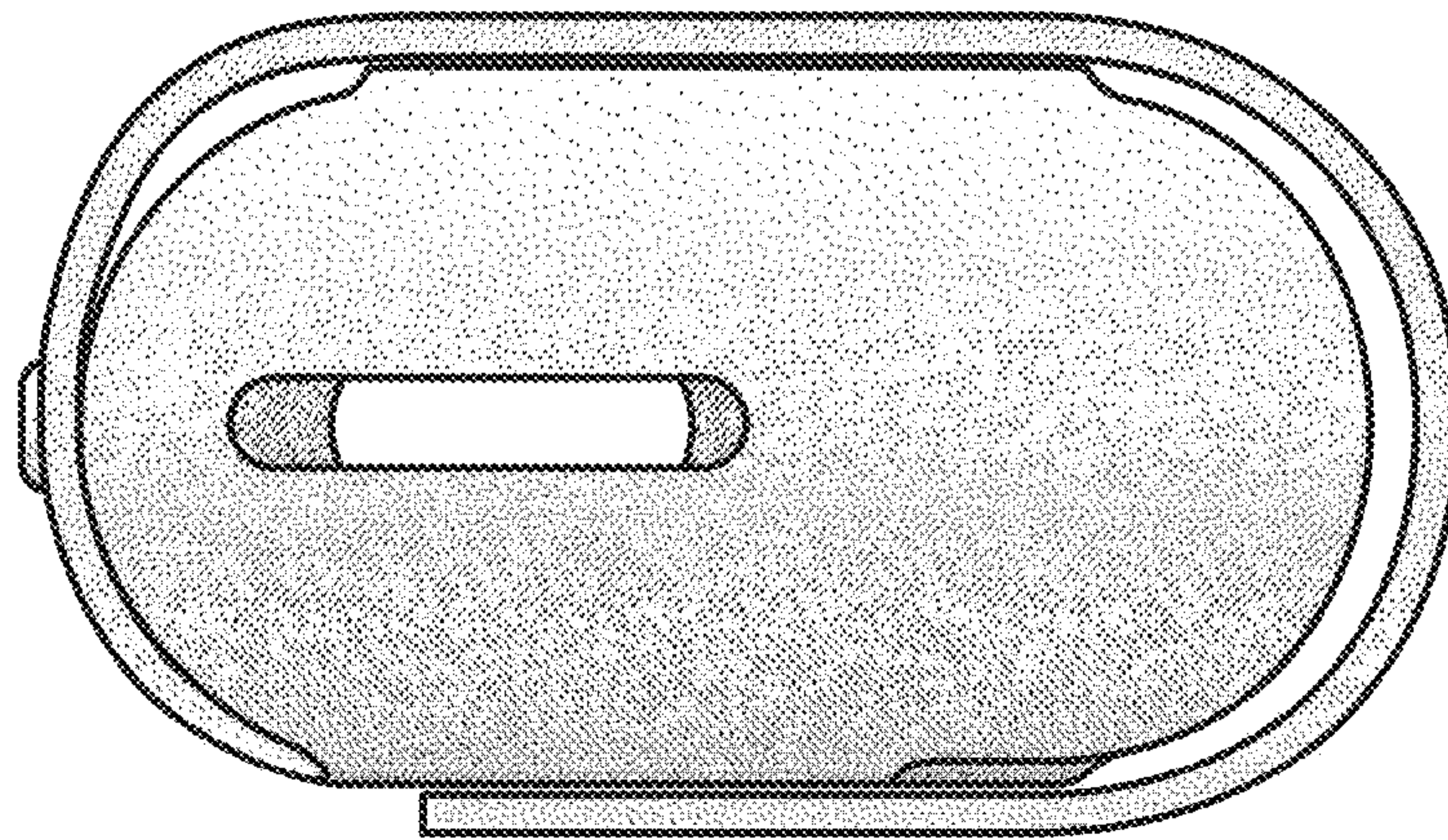

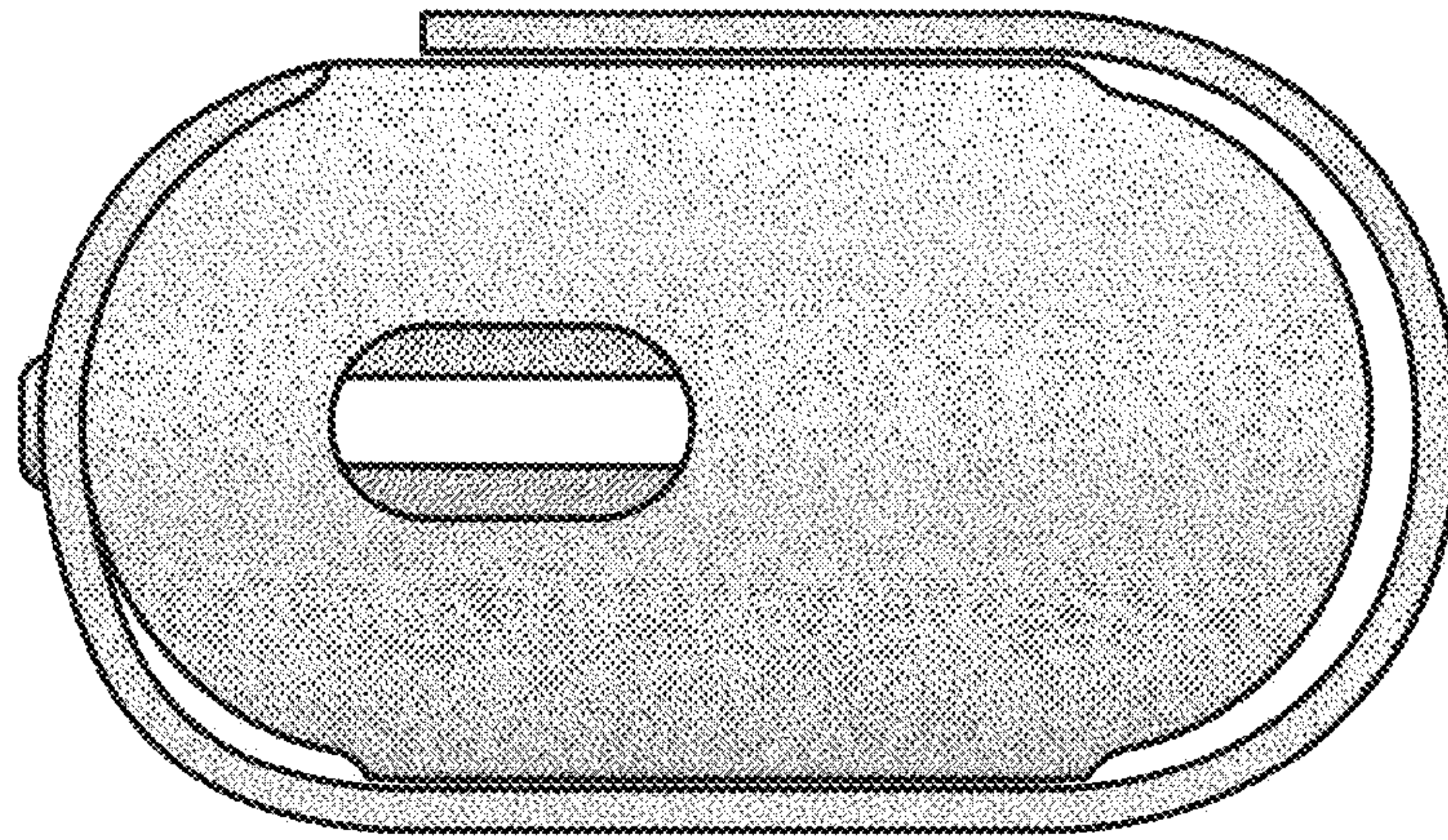

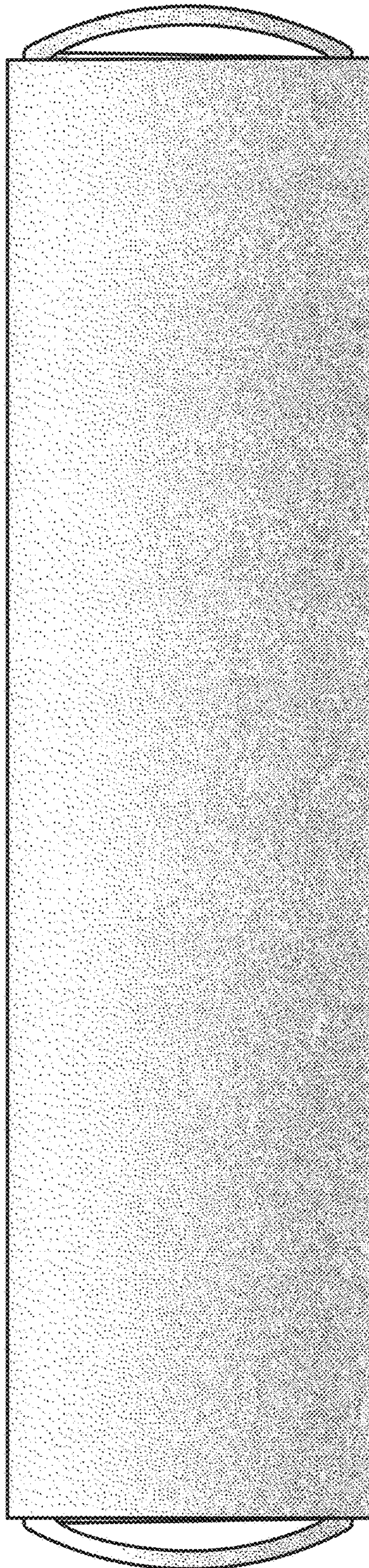

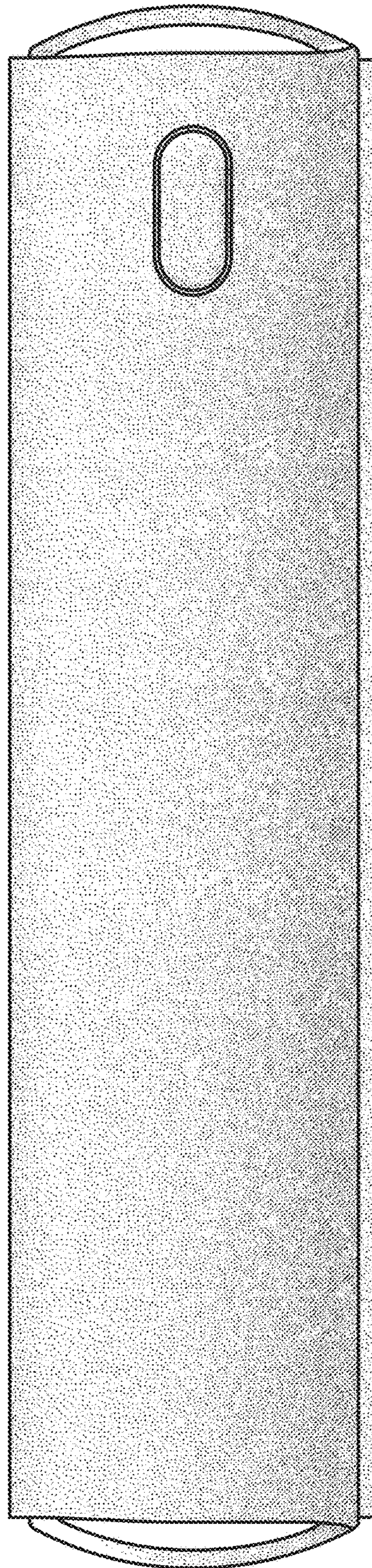

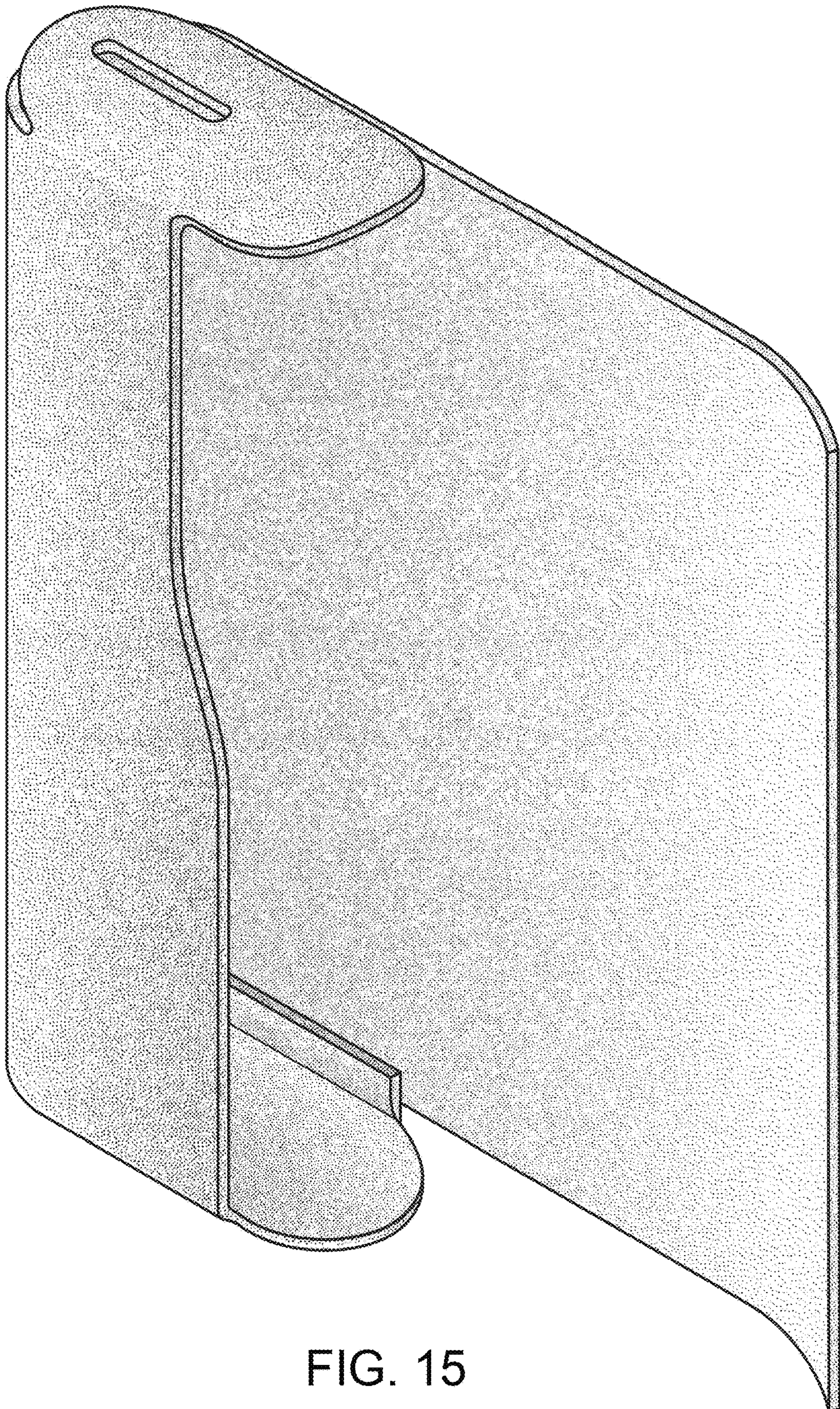
