DESCRIPTION

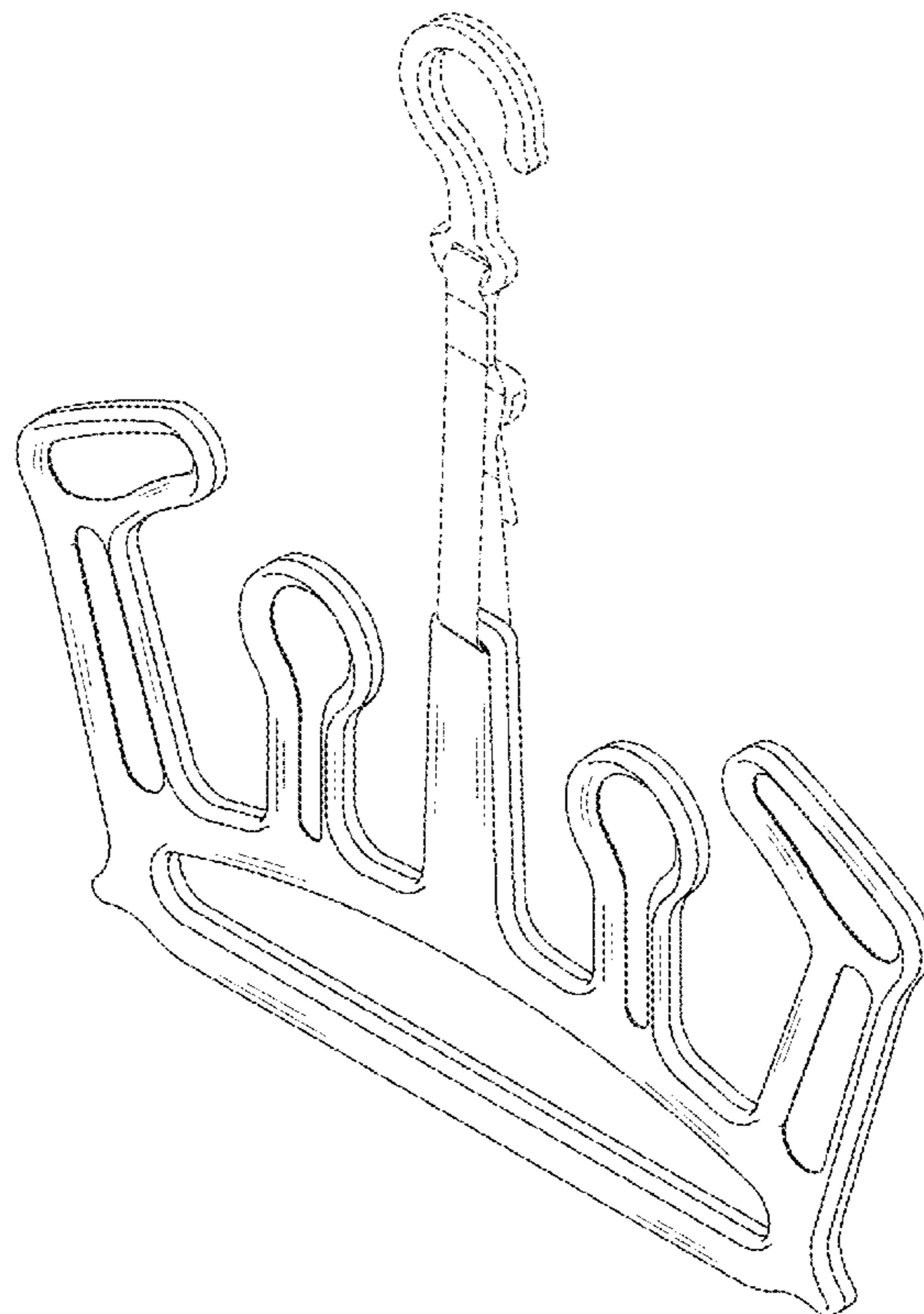
FIG. 1 is a front elevation view of a hanger;

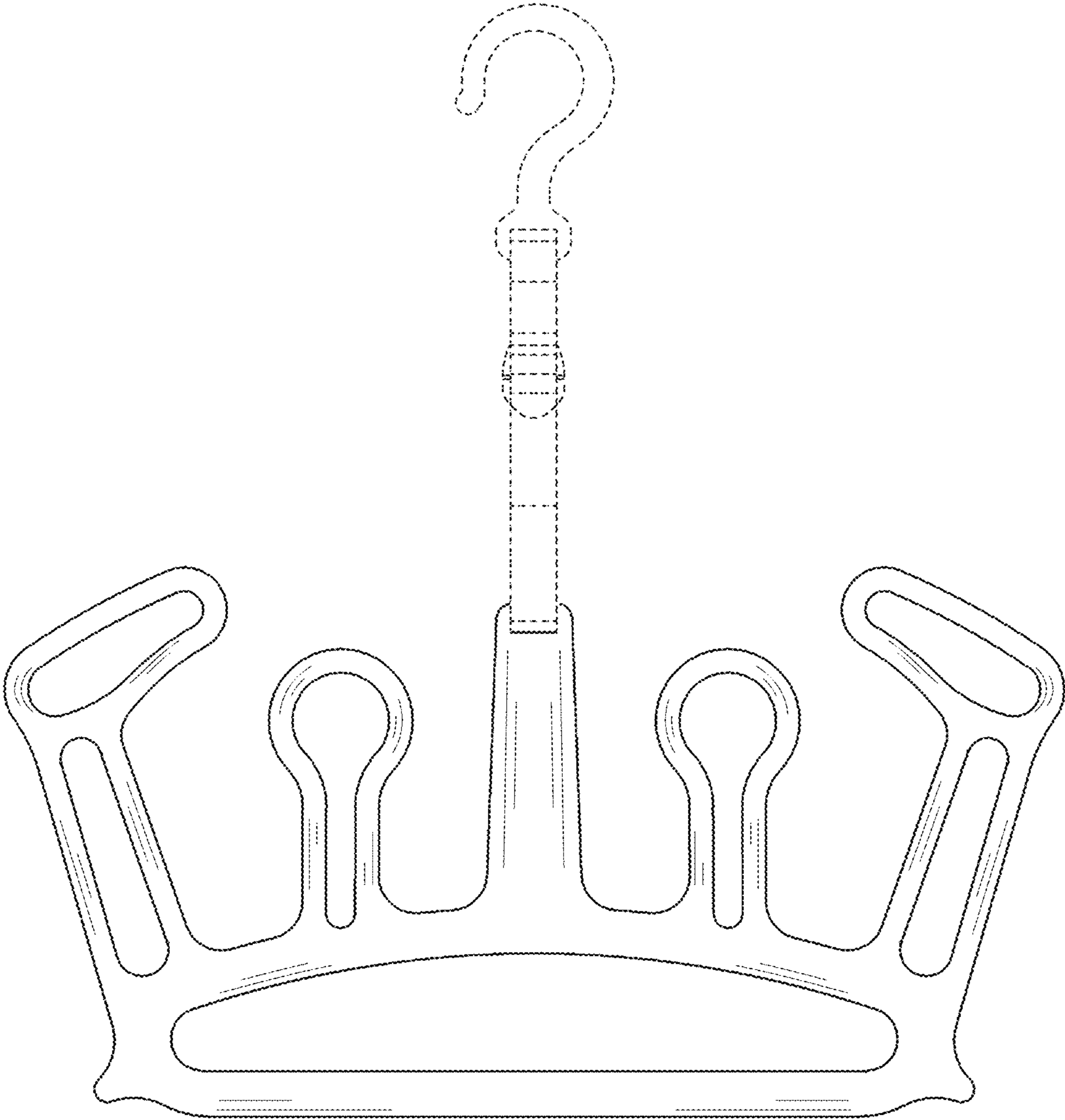

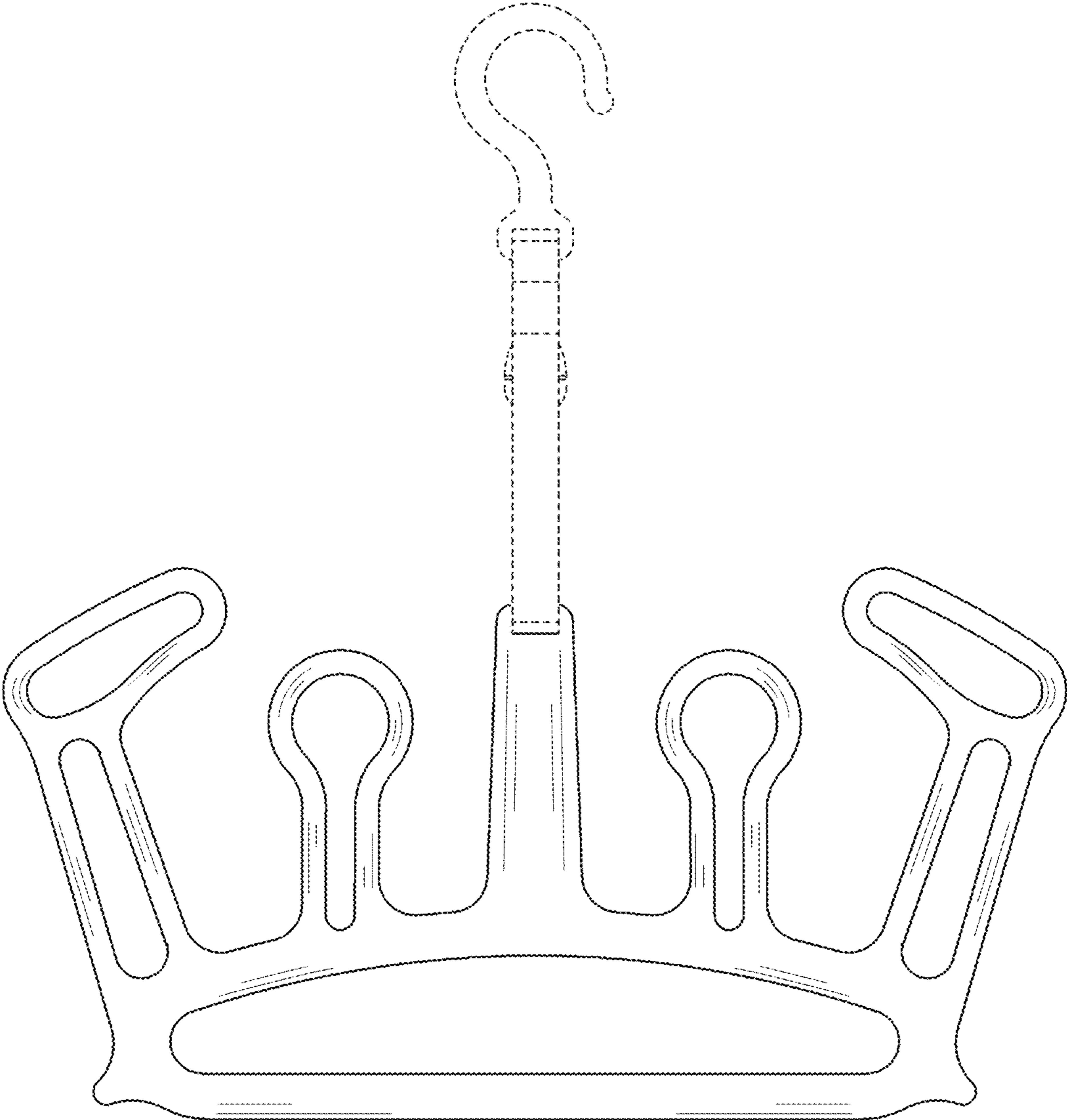

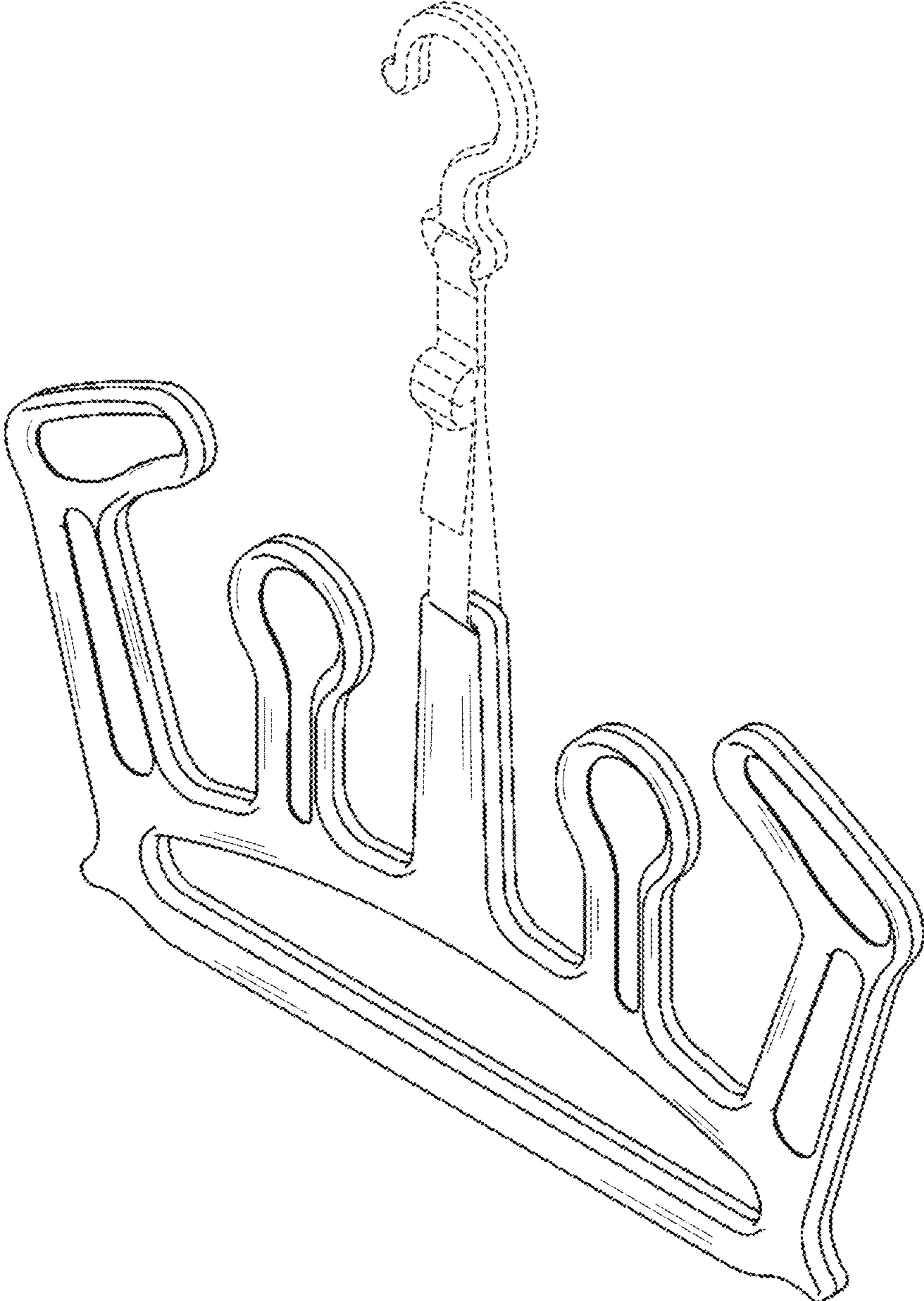

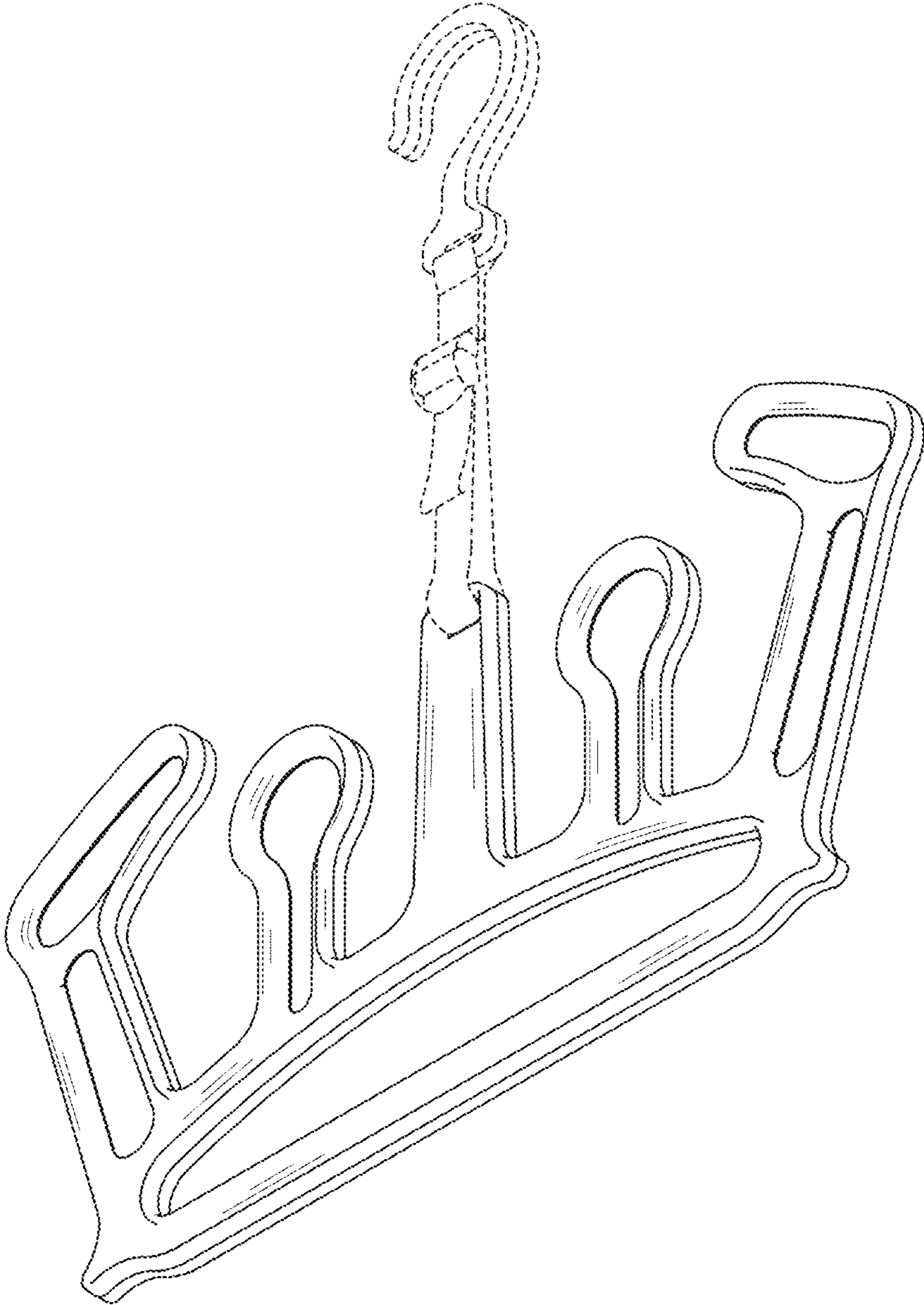

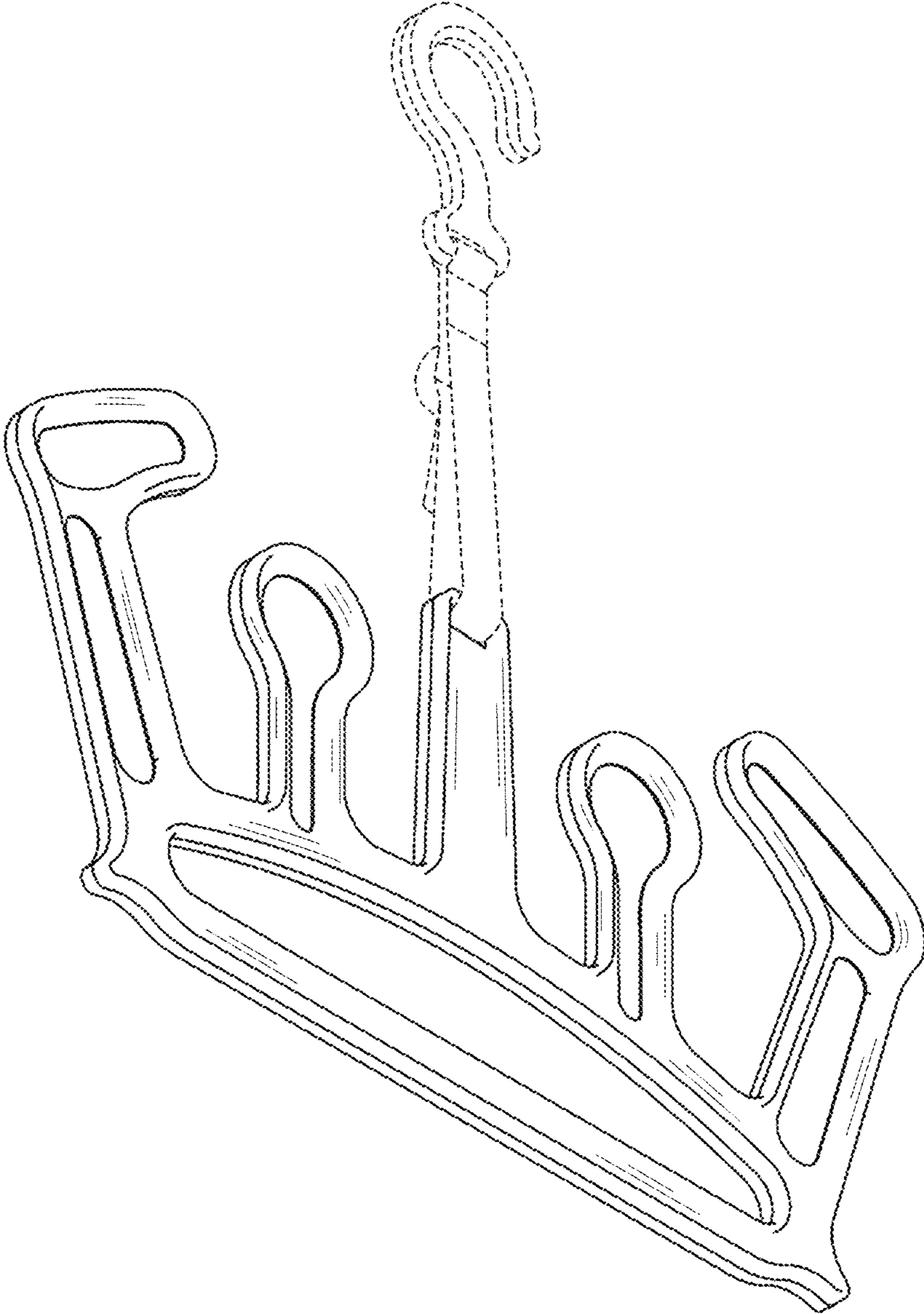

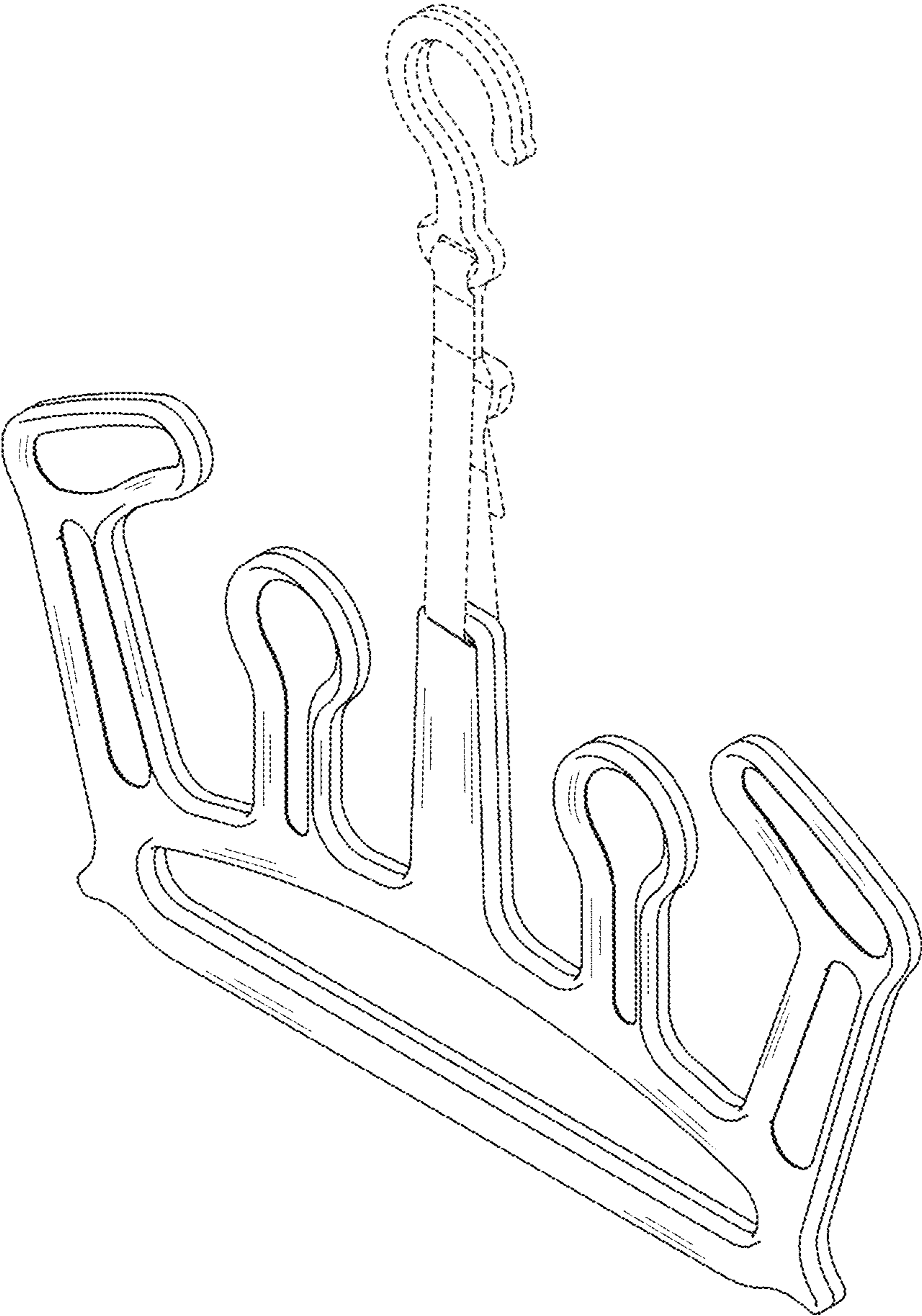

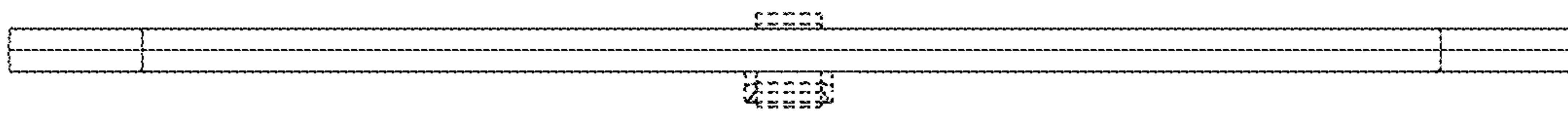
