The ornamental design for aircraft seat, as shown and described.

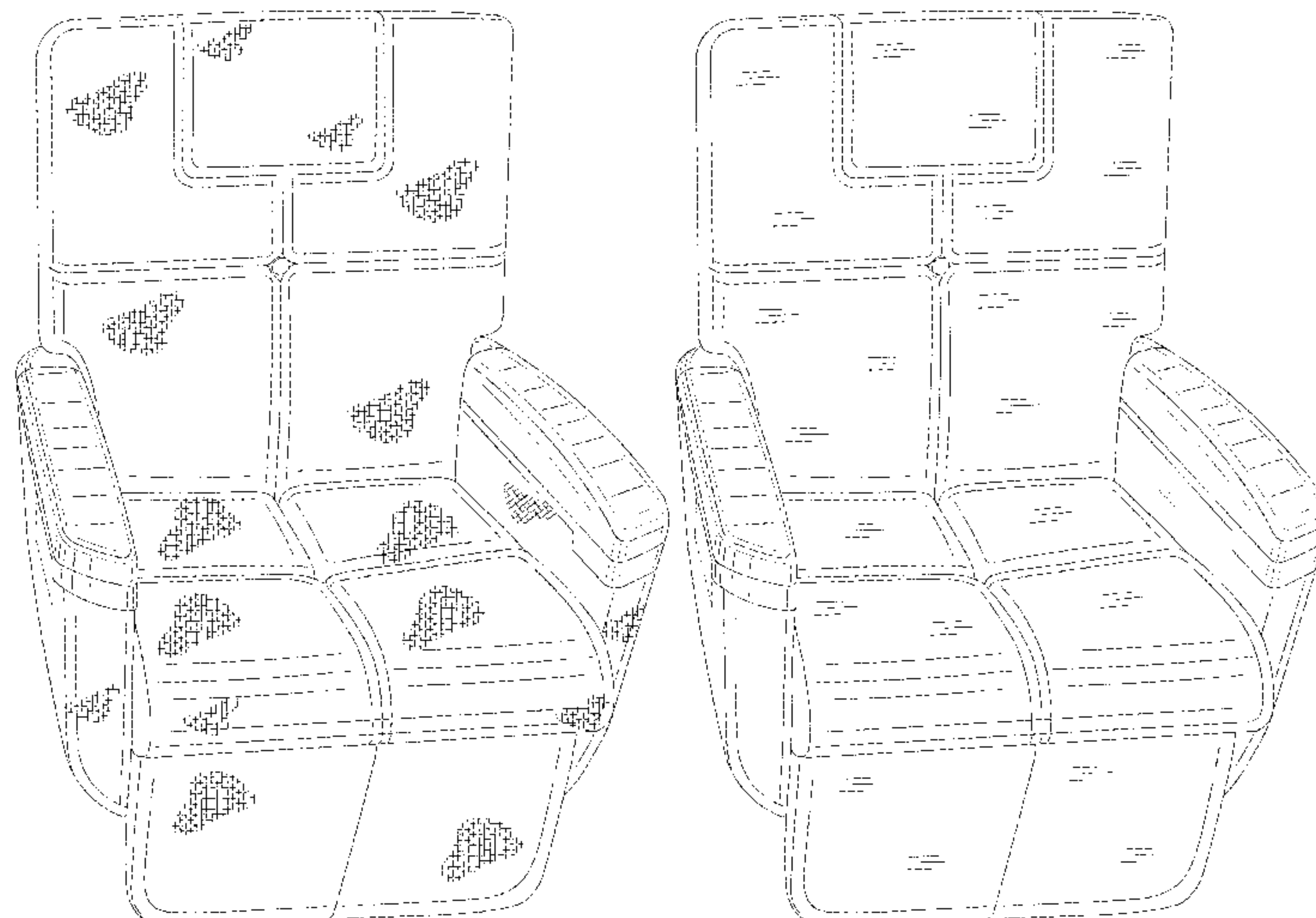
**DESCRIPTION**

FIG. 1 is a front perspective view of the aircraft seat according to a first embodiment; FIG. 2 is a rear perspective view thereof; FIG. 3 is a side view thereof; FIG. 4 is a front view thereof; FIG. 5 is a back view thereof; FIG. 6 is a top view thereof; FIG. 7 is a front perspective view of the aircraft seat according to a second embodiment; FIG. 8 is a rear perspective view thereof; FIG. 9 is a side view thereof; FIG. 10 is a front view thereof; FIG. 11 is a back view thereof; and, FIG. 12 is a top view thereof.

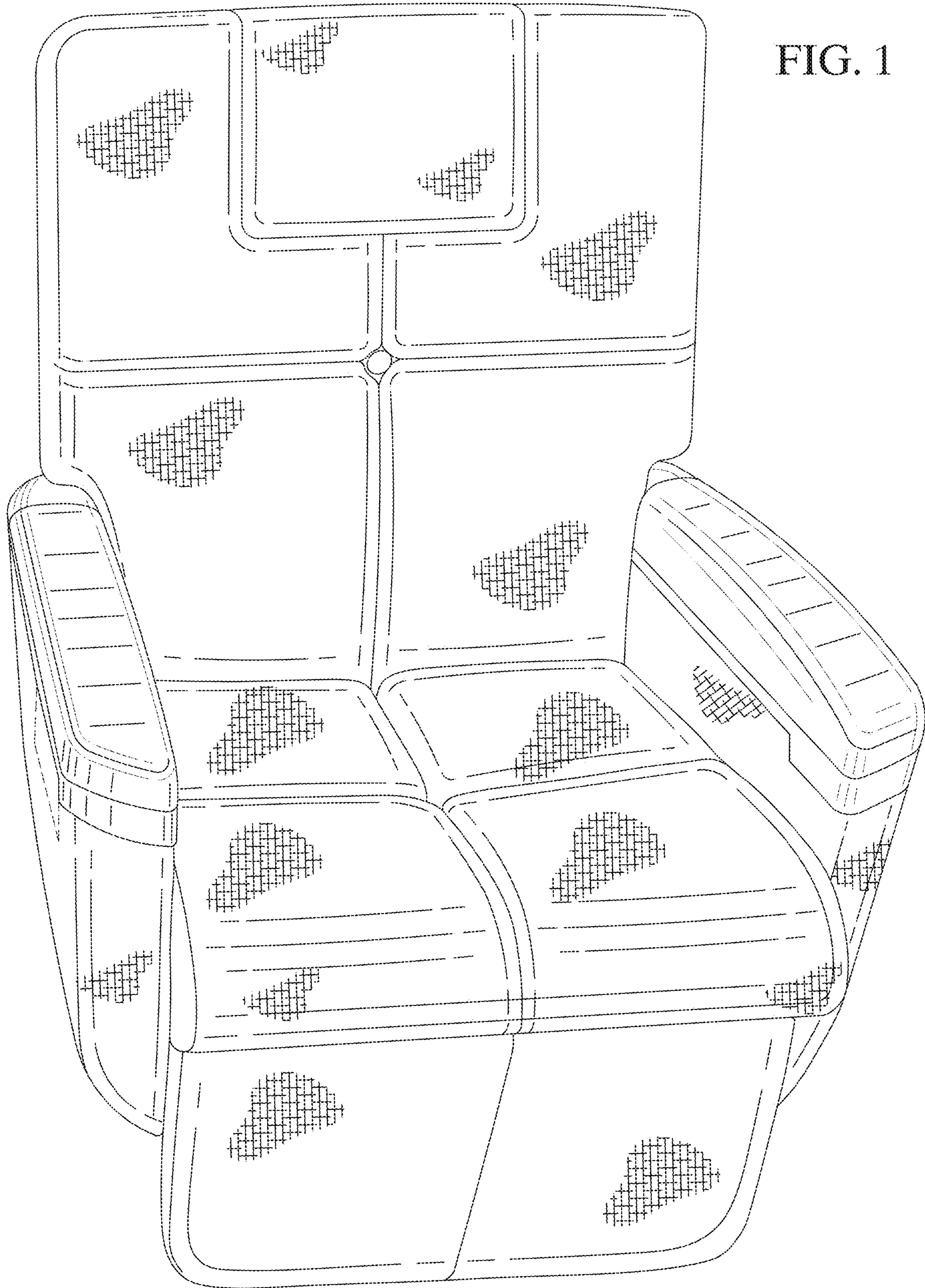

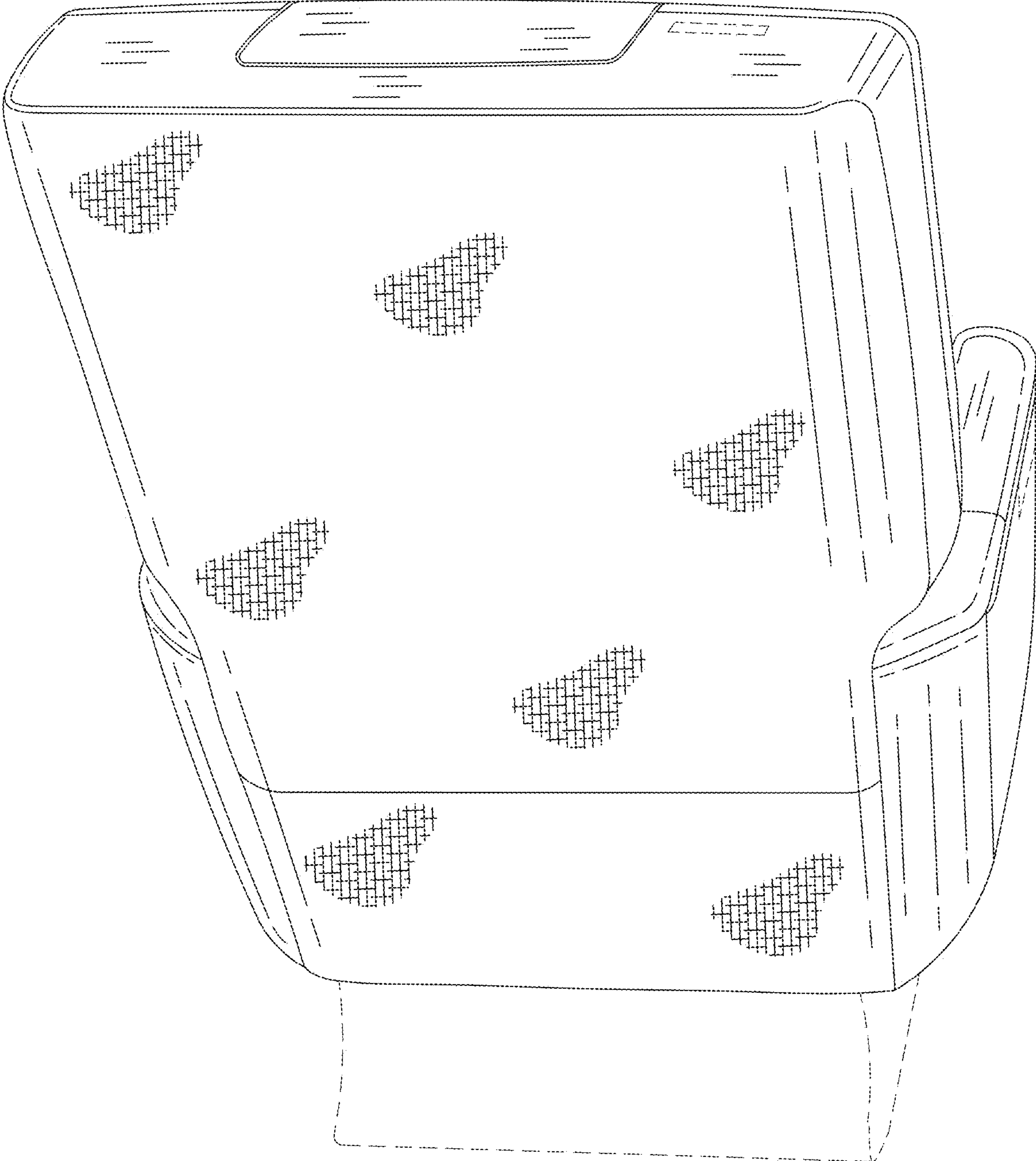

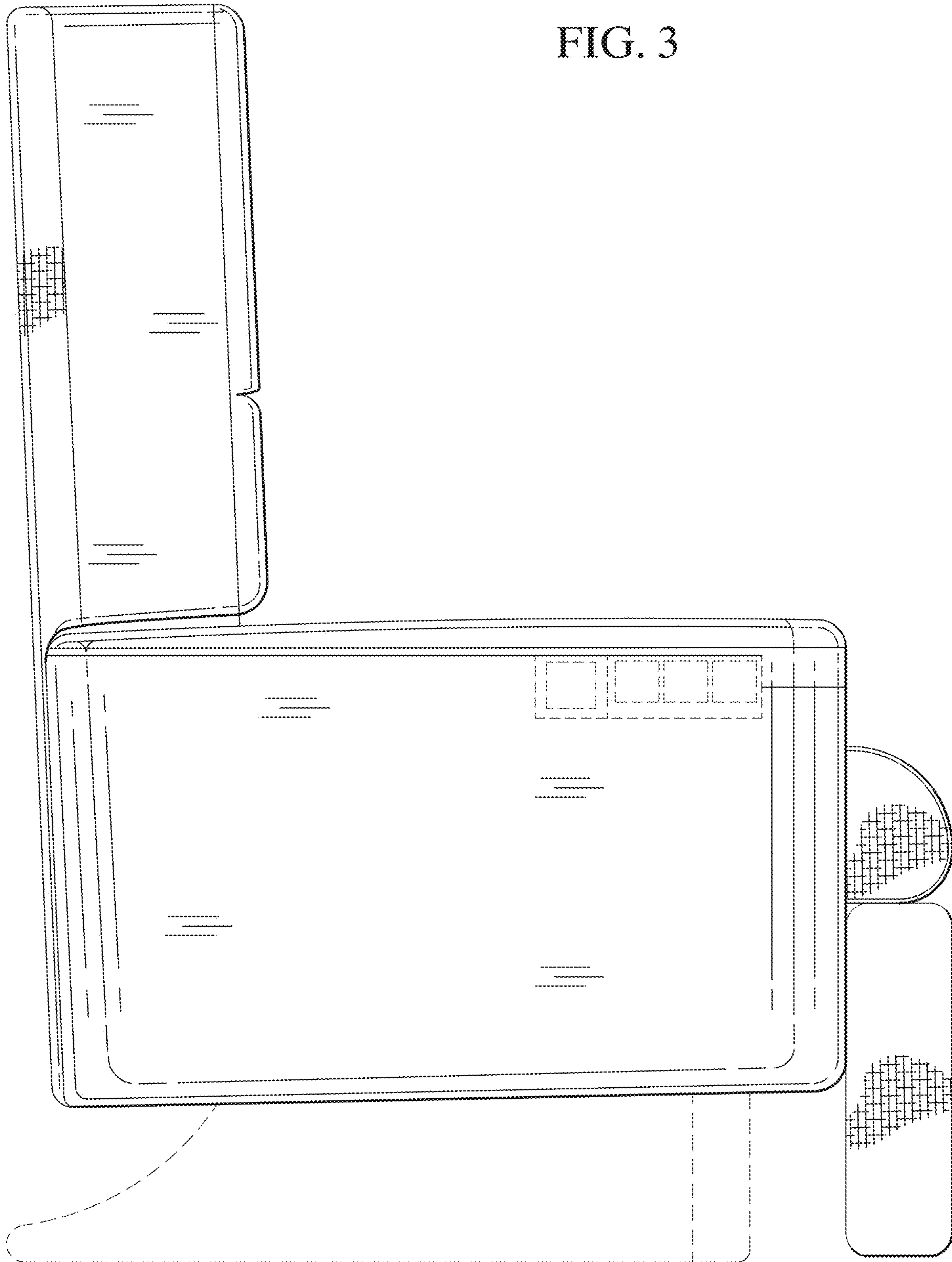

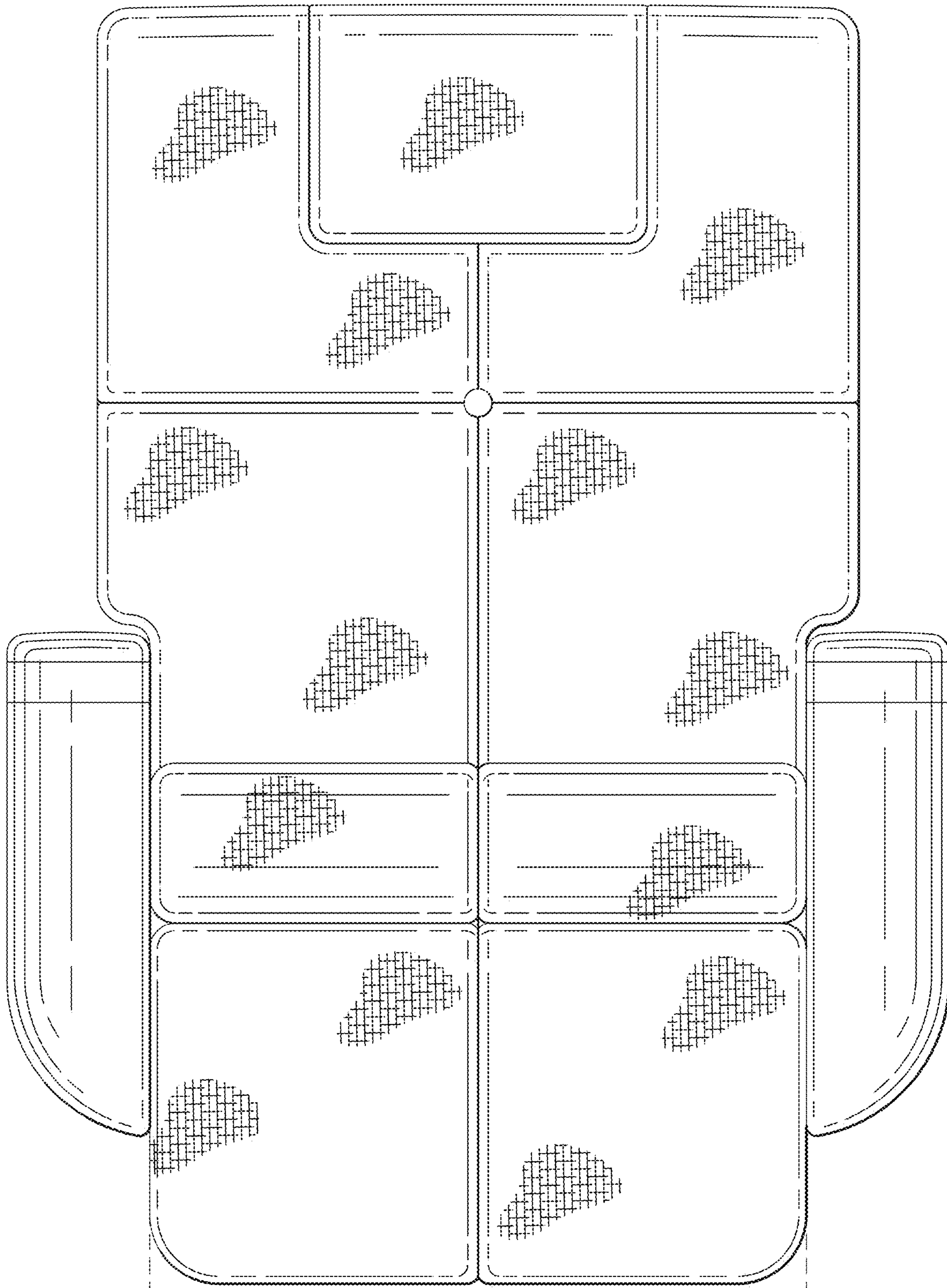

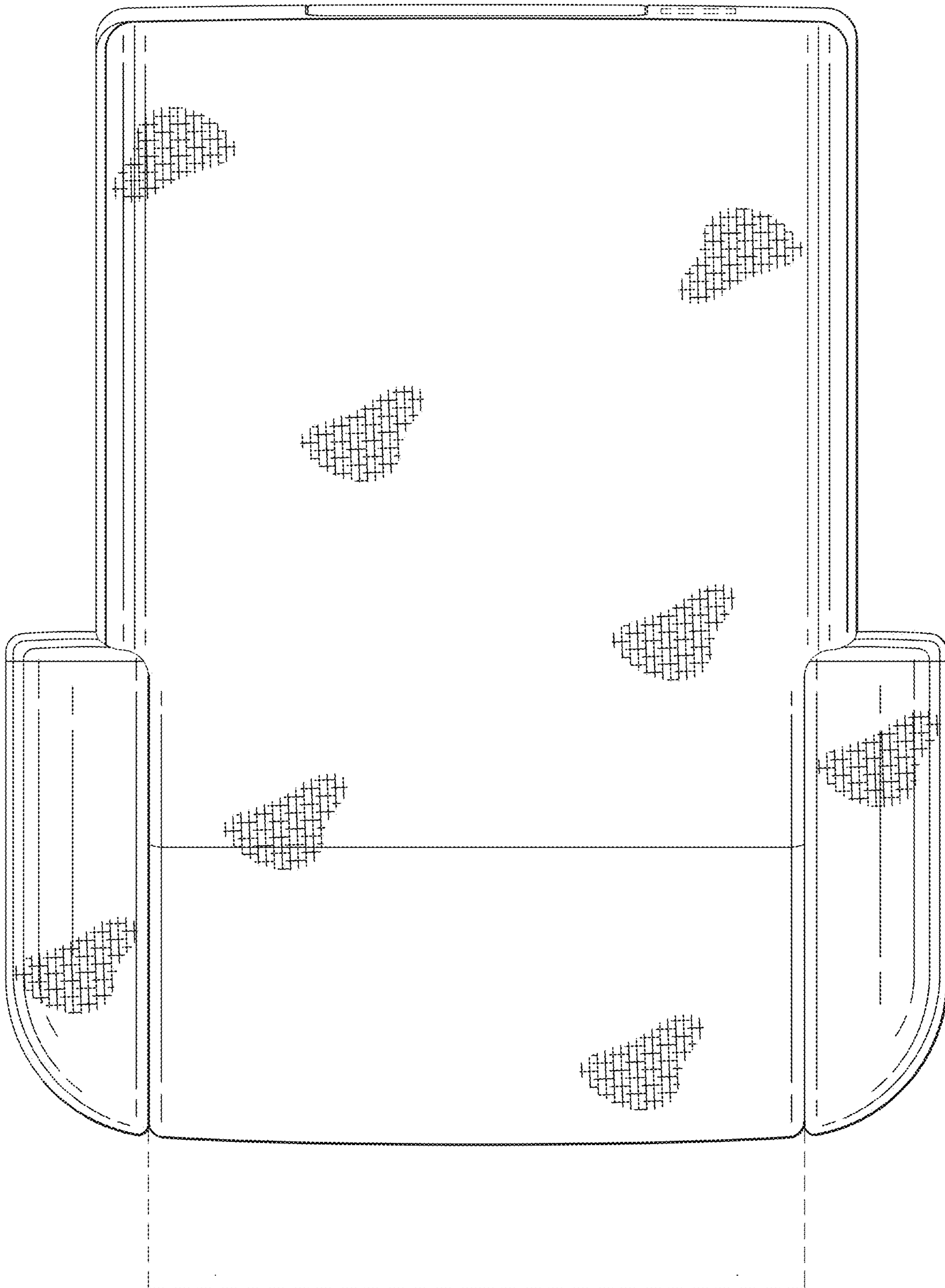
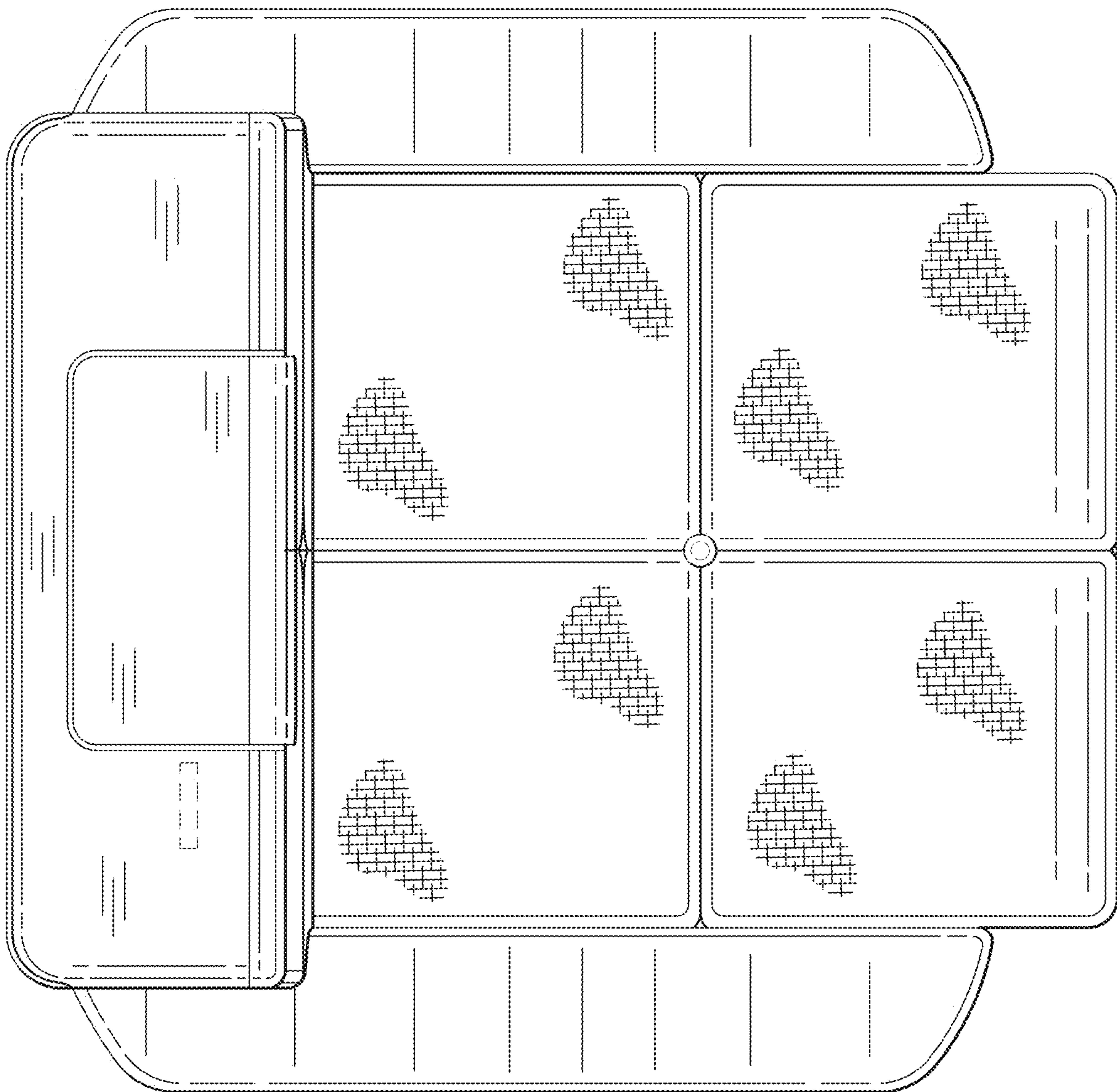

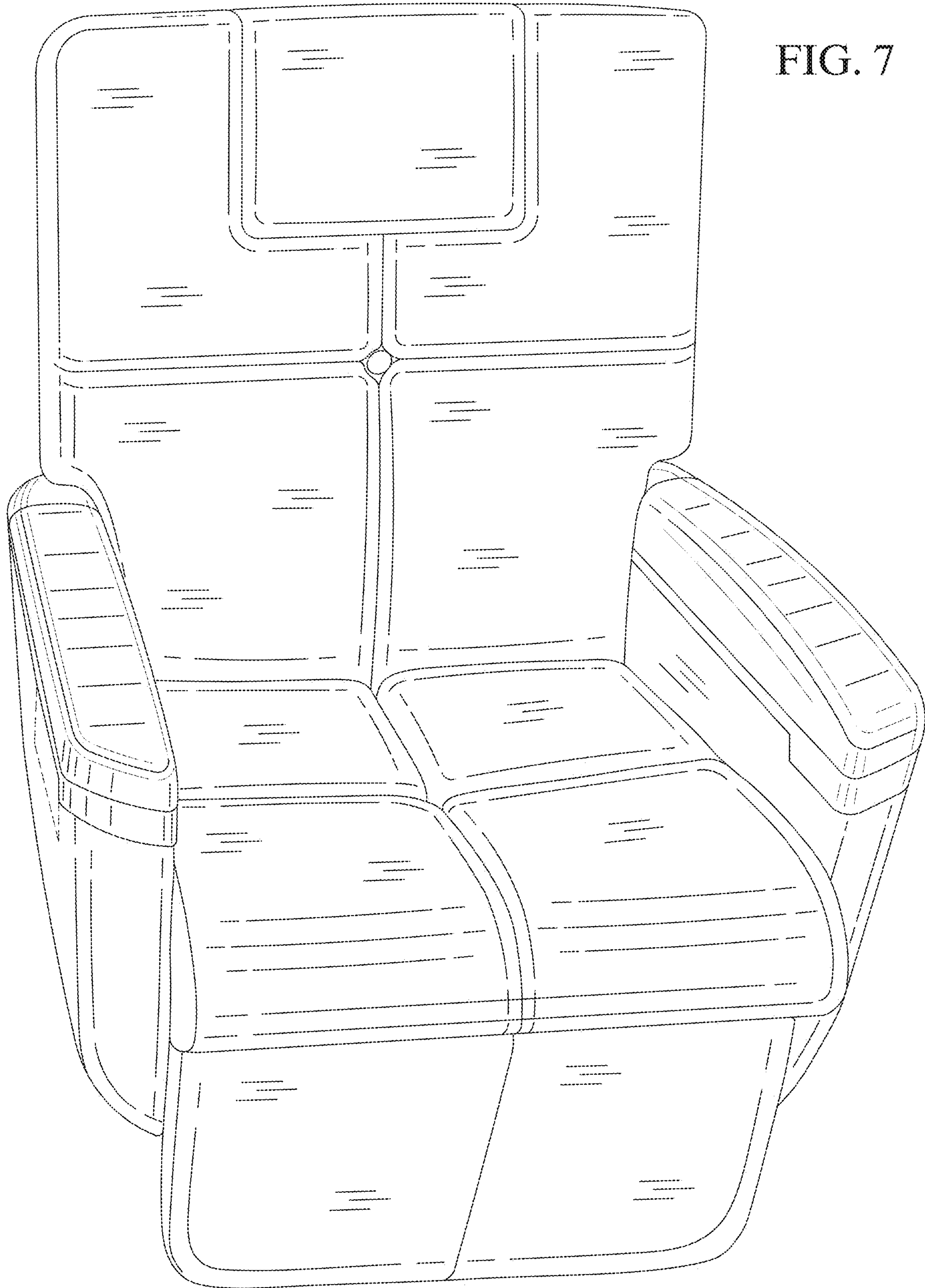

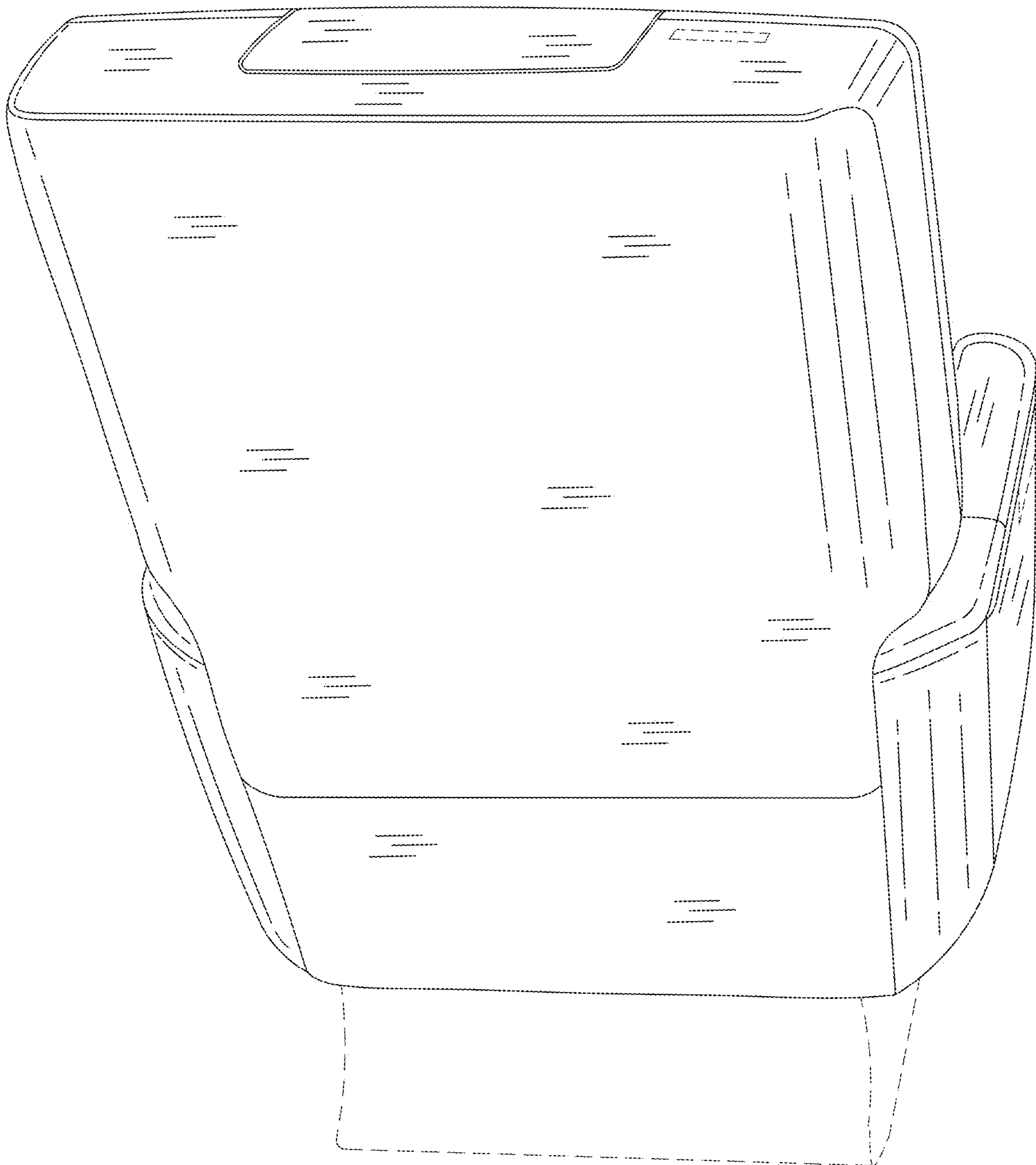

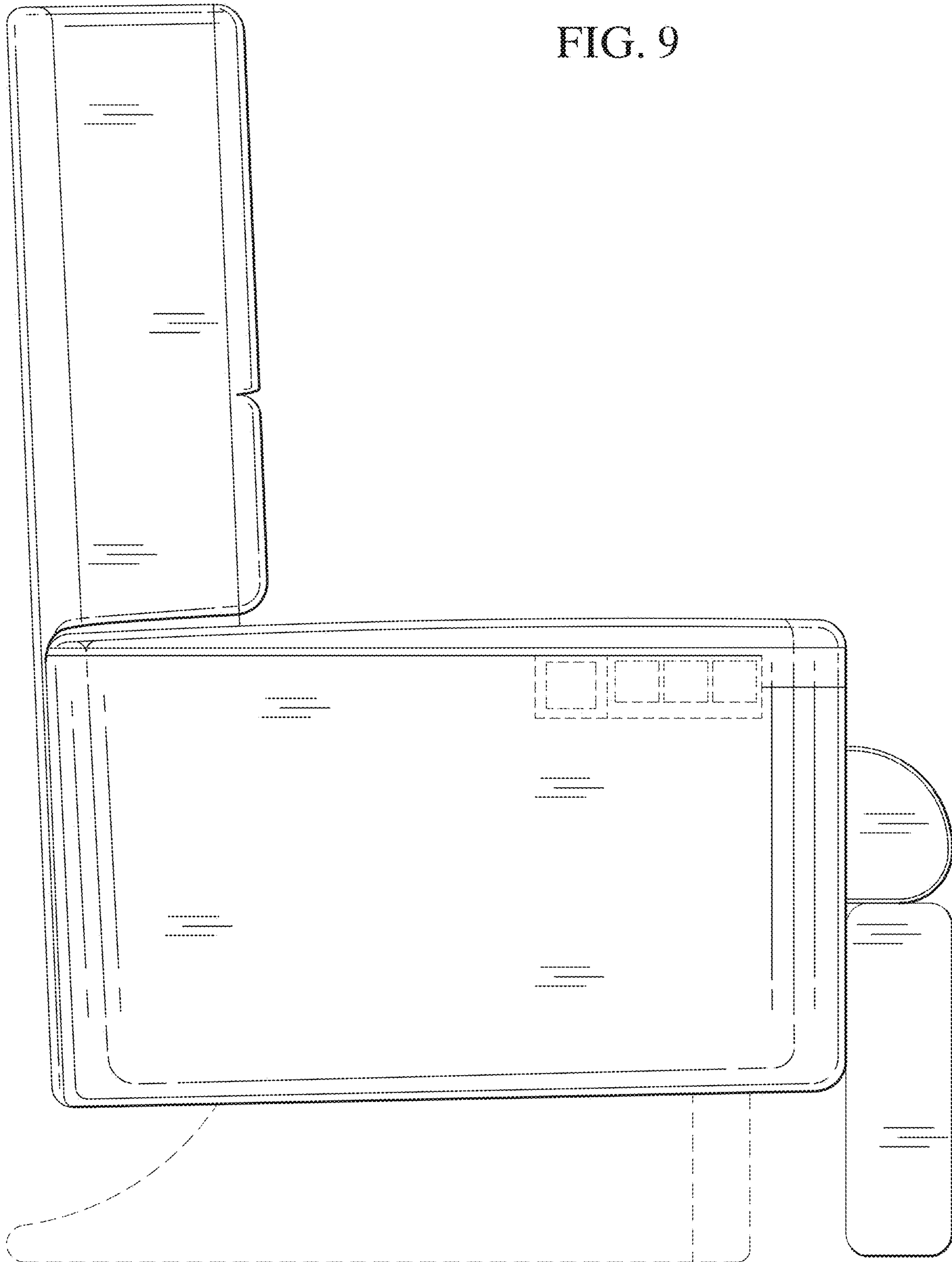

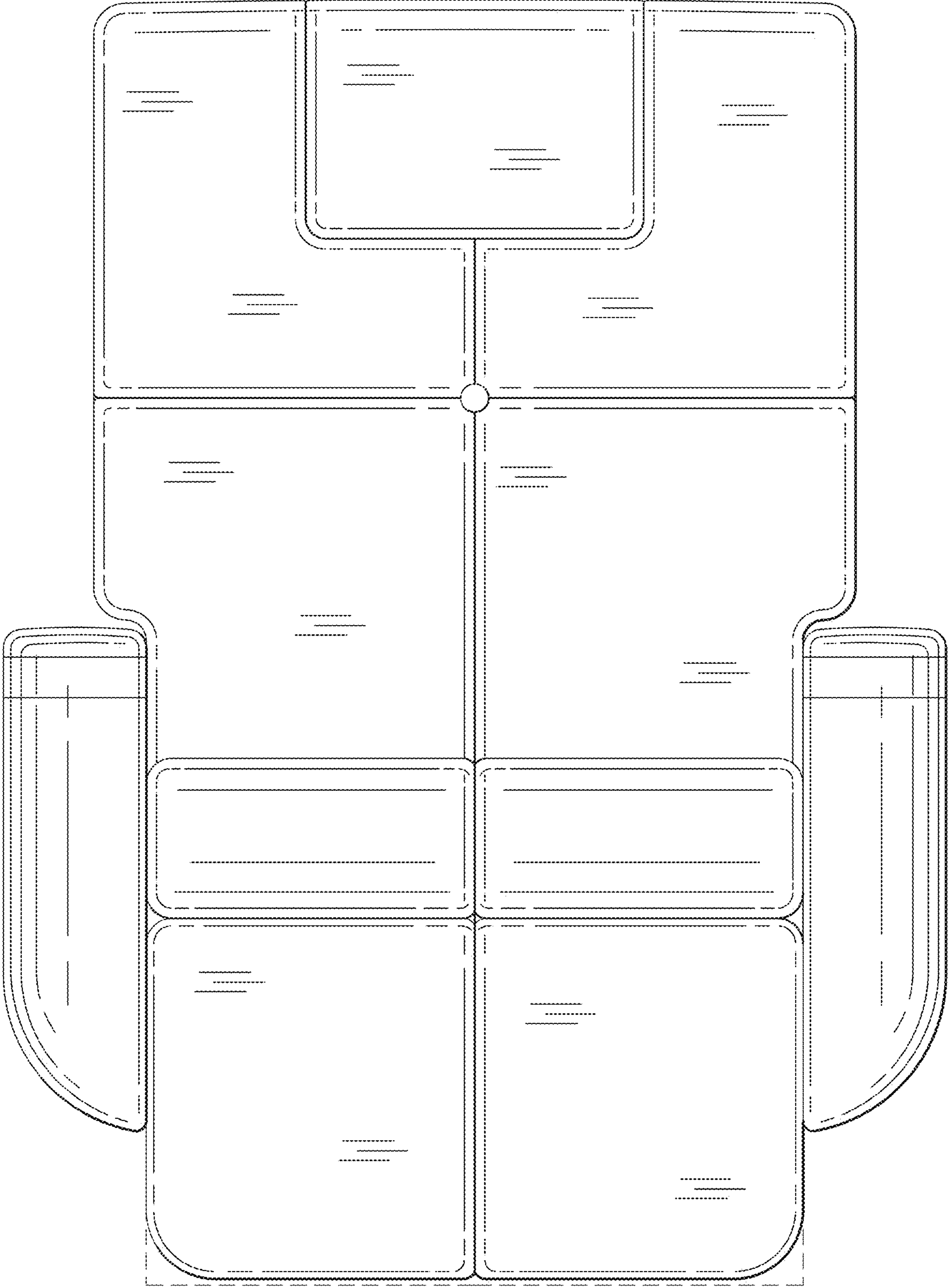

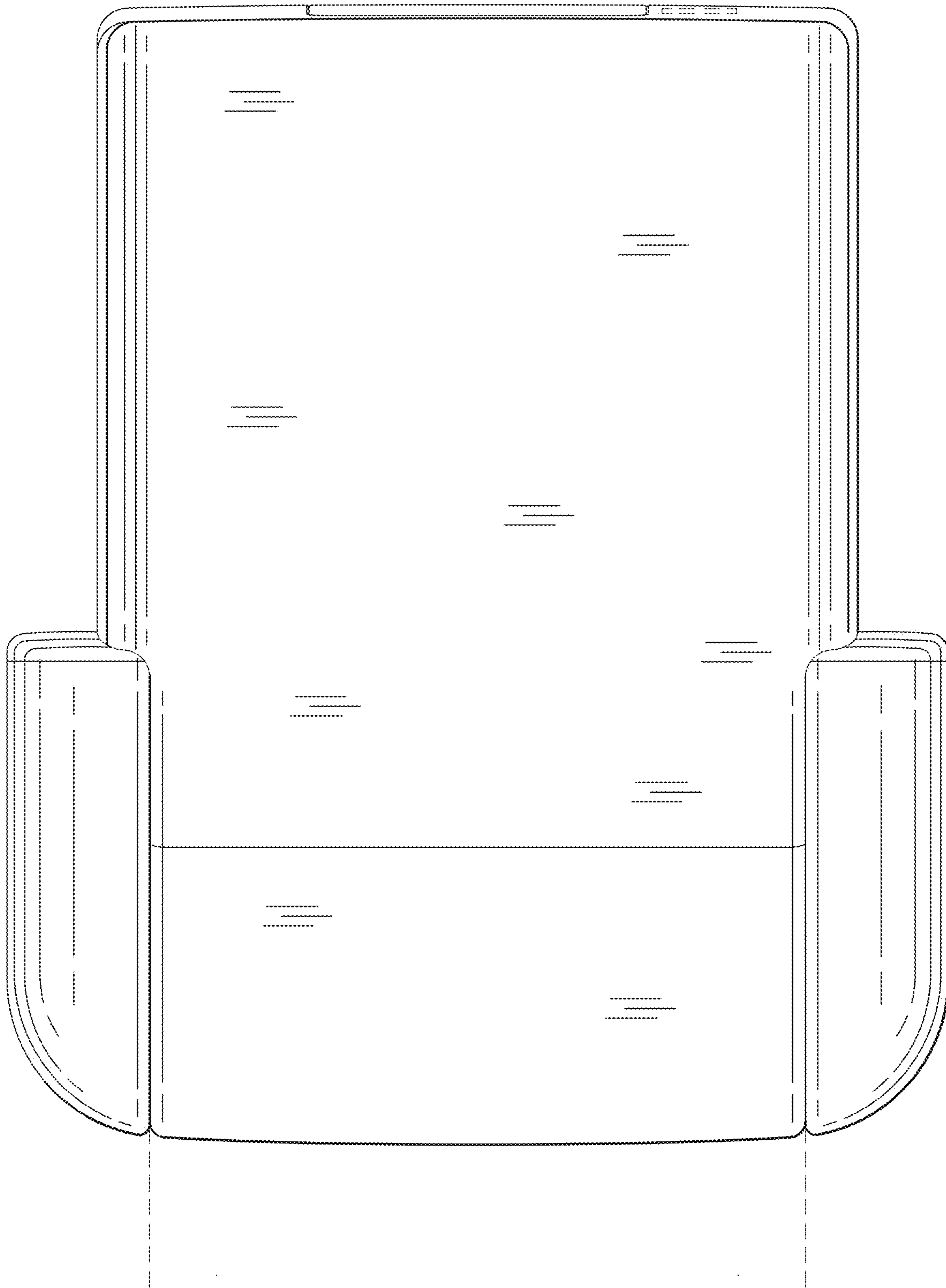
