FIG. 12 is a top plan view thereof.

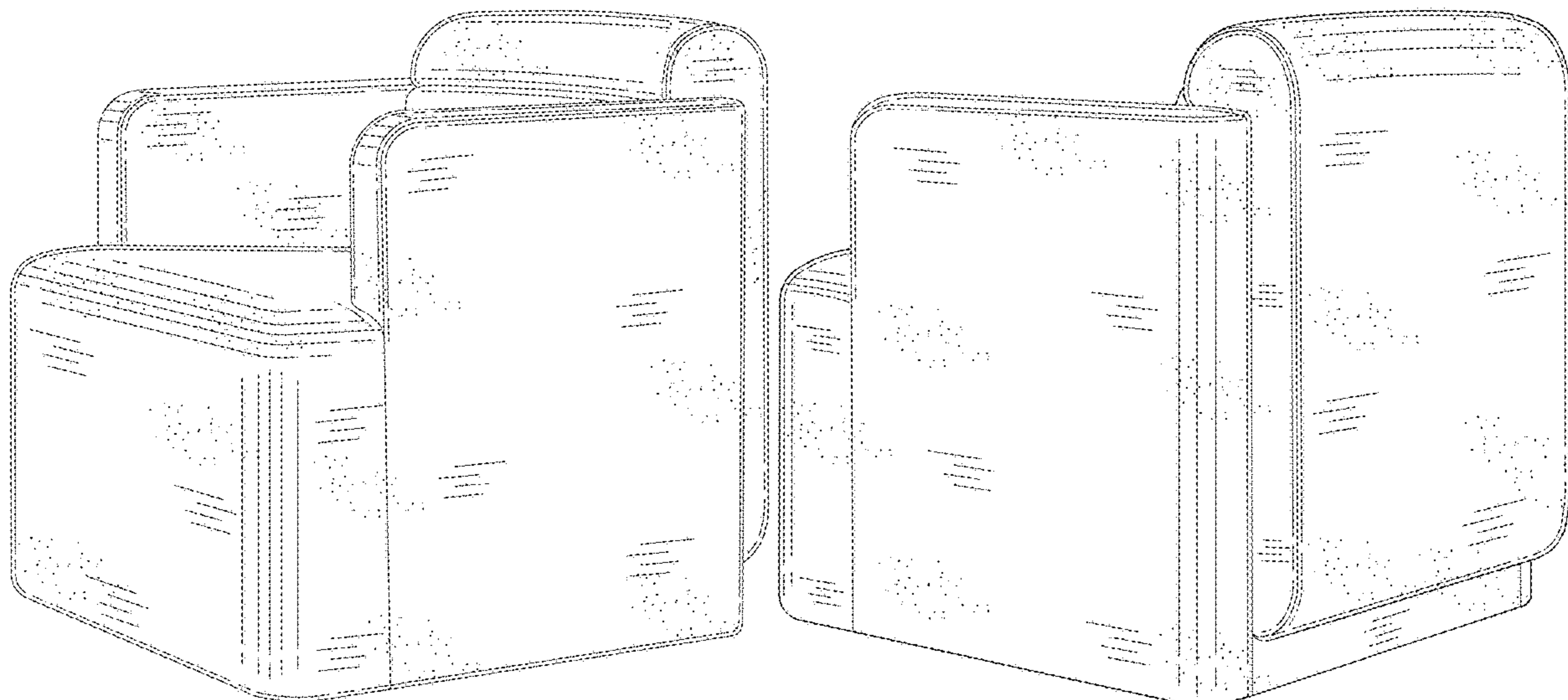

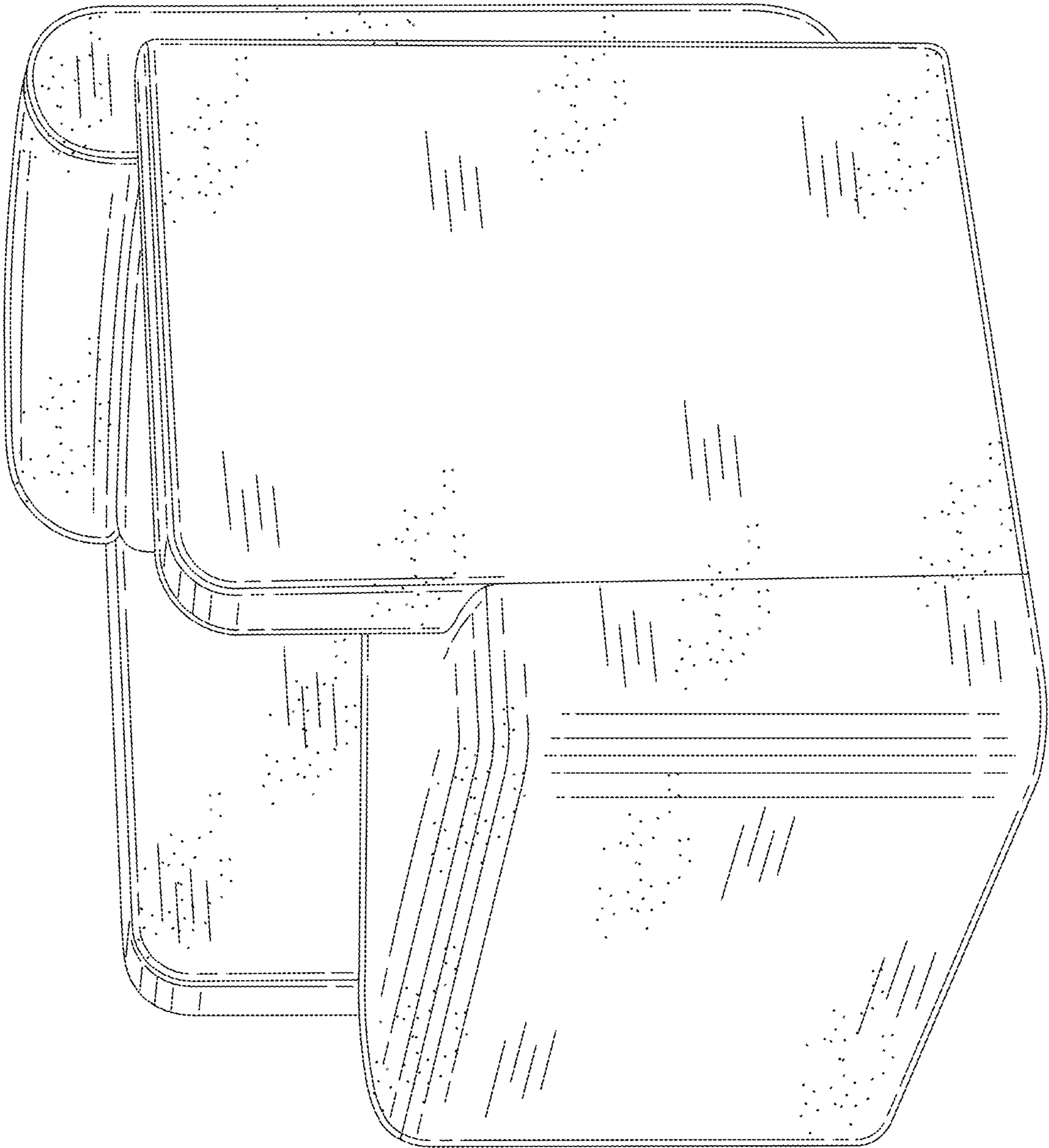

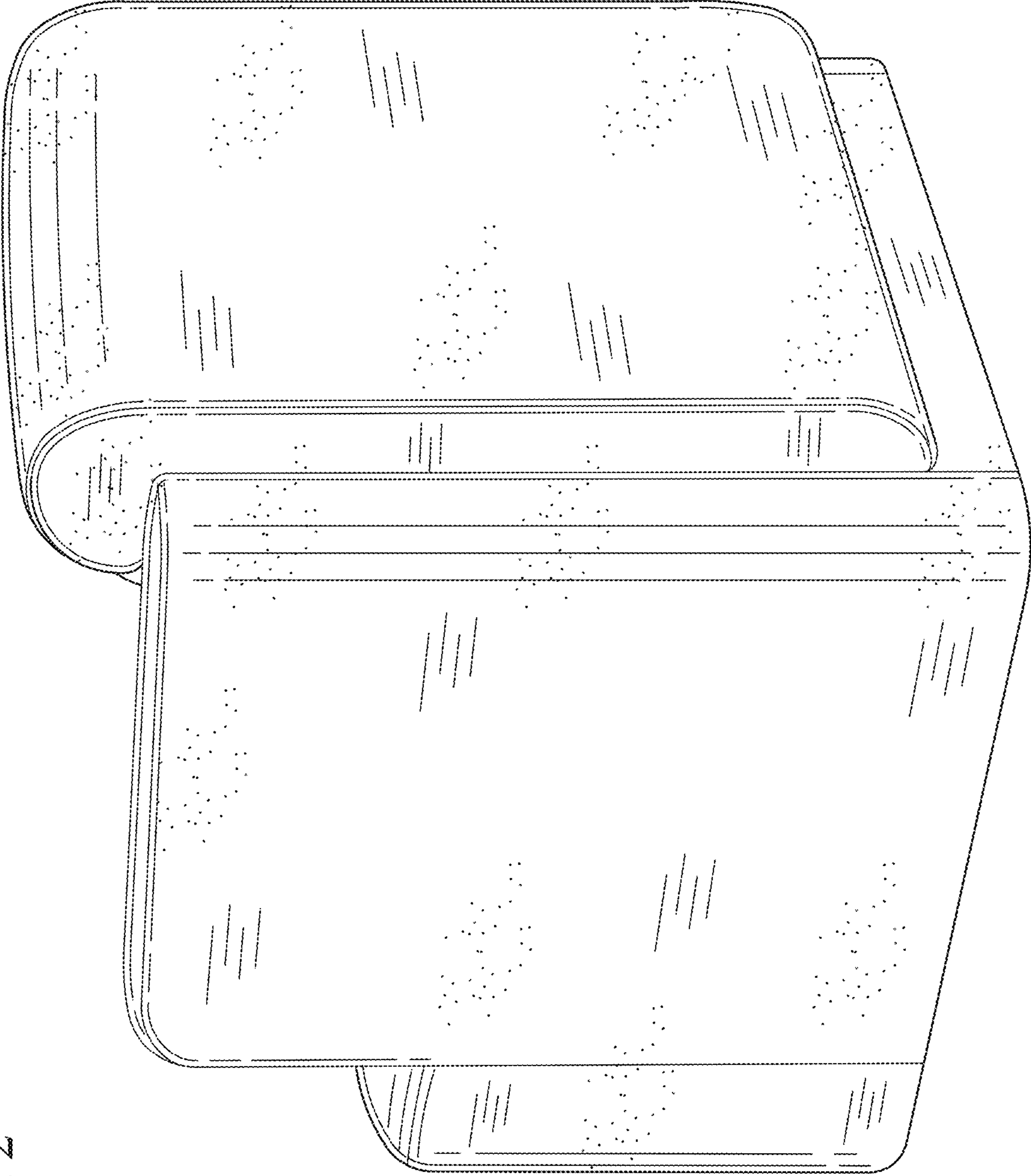

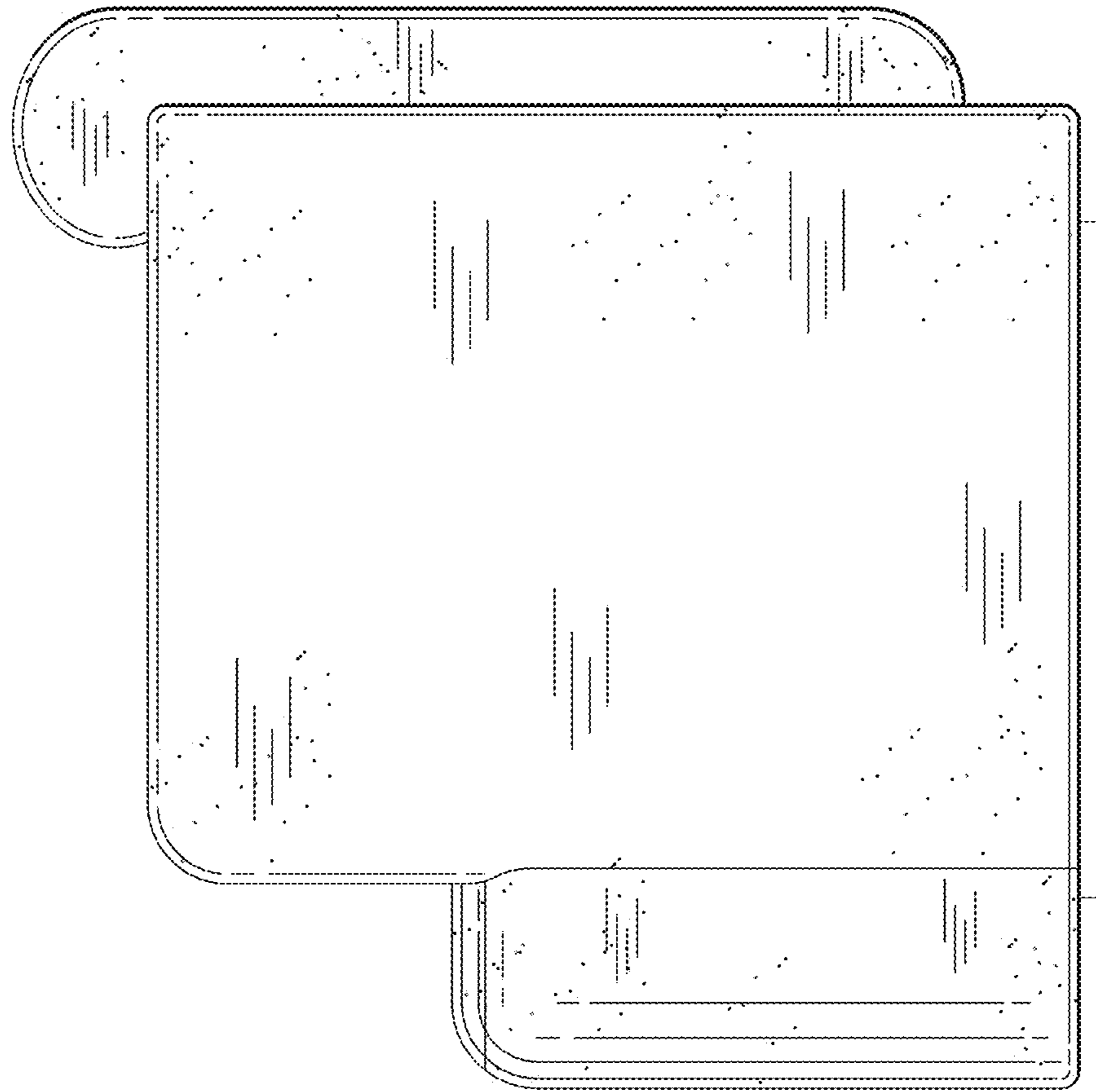

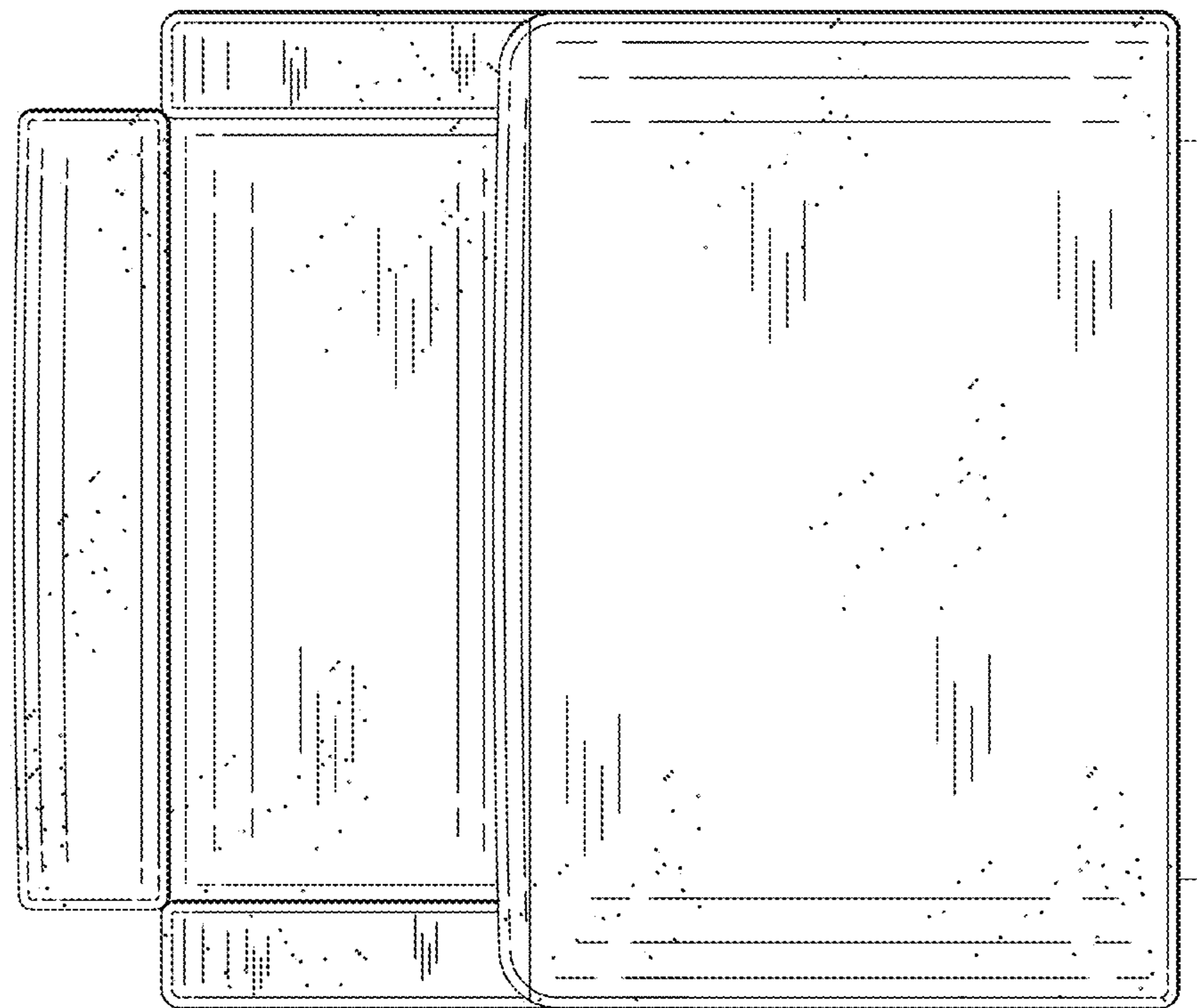

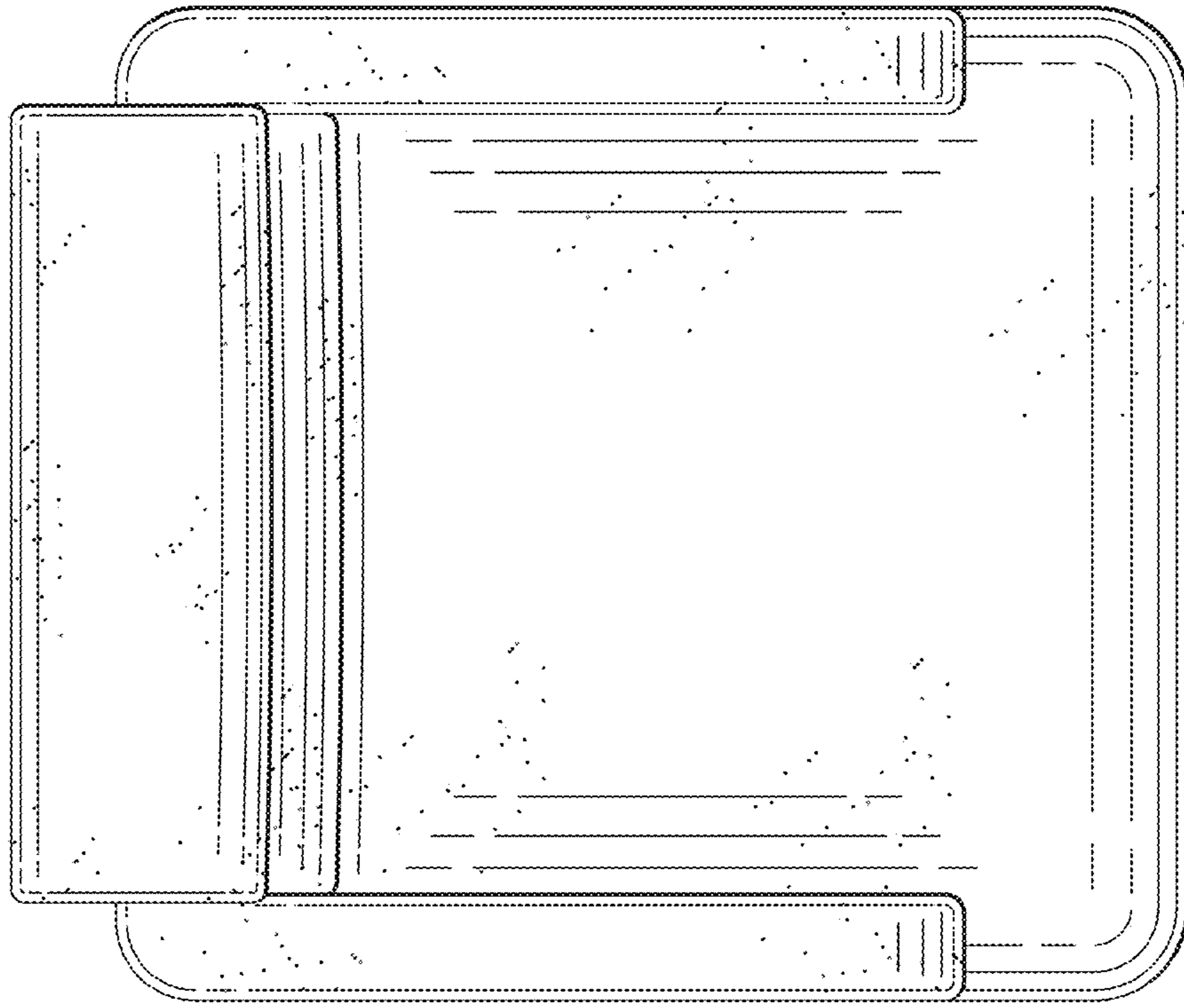
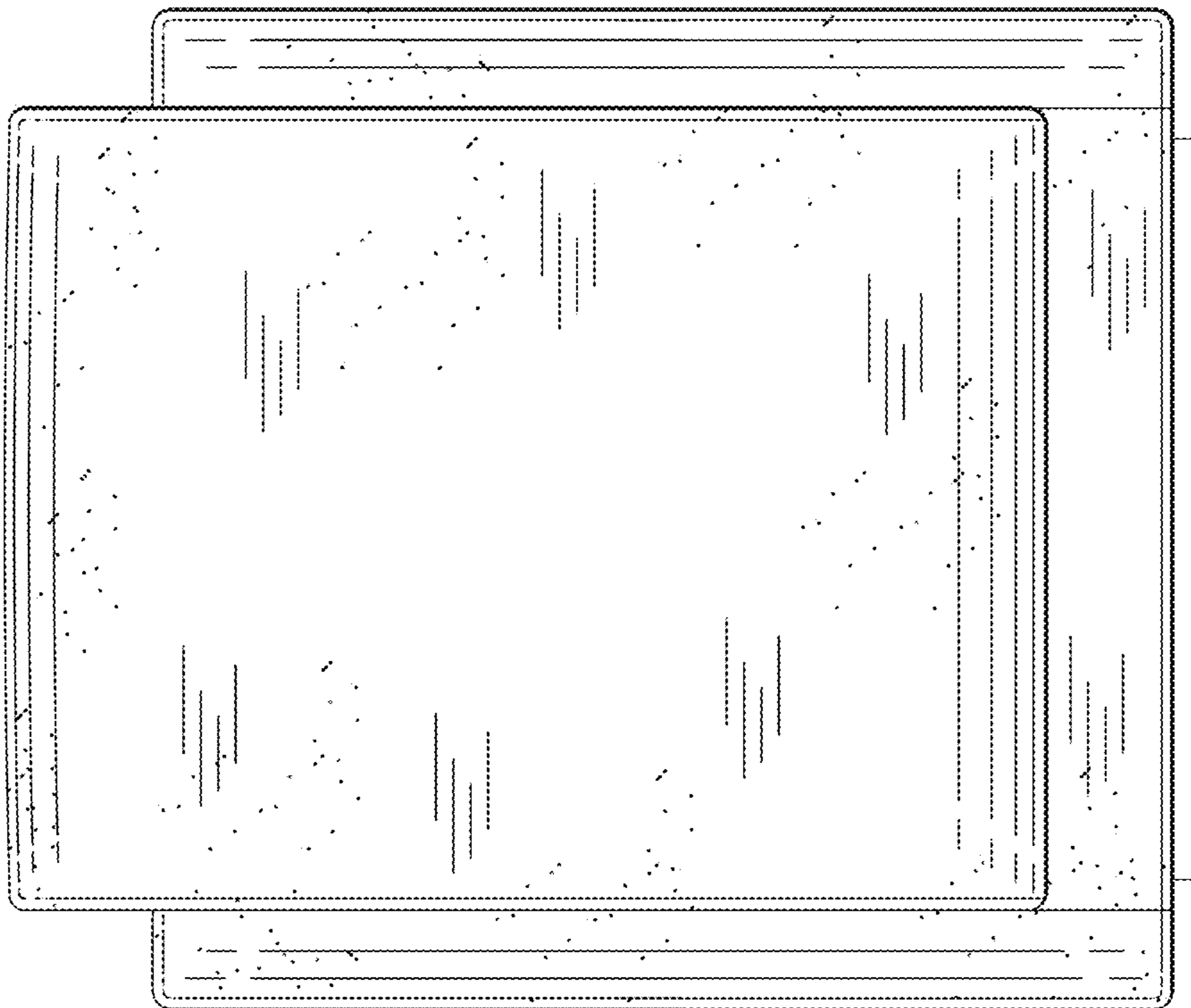

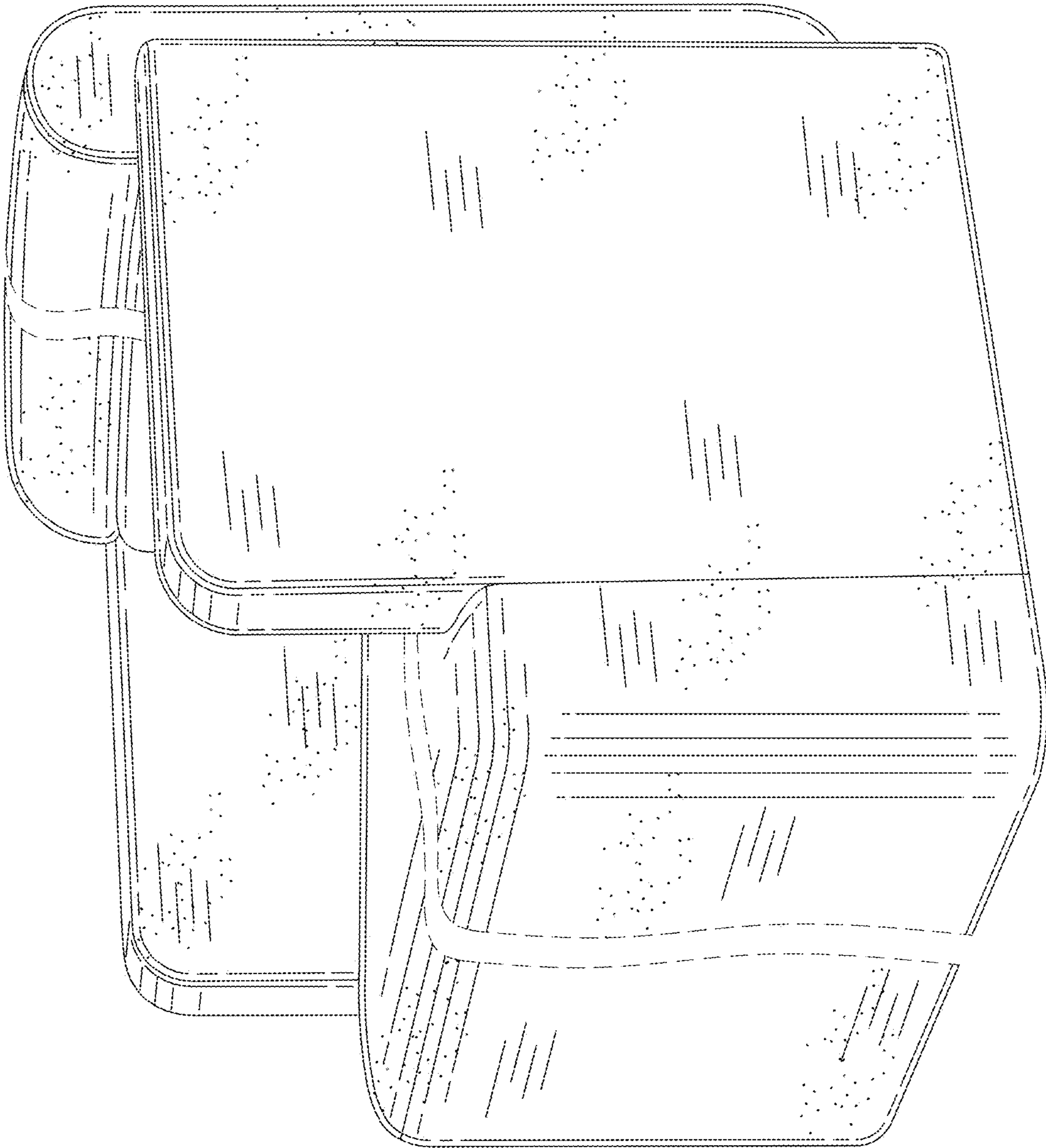

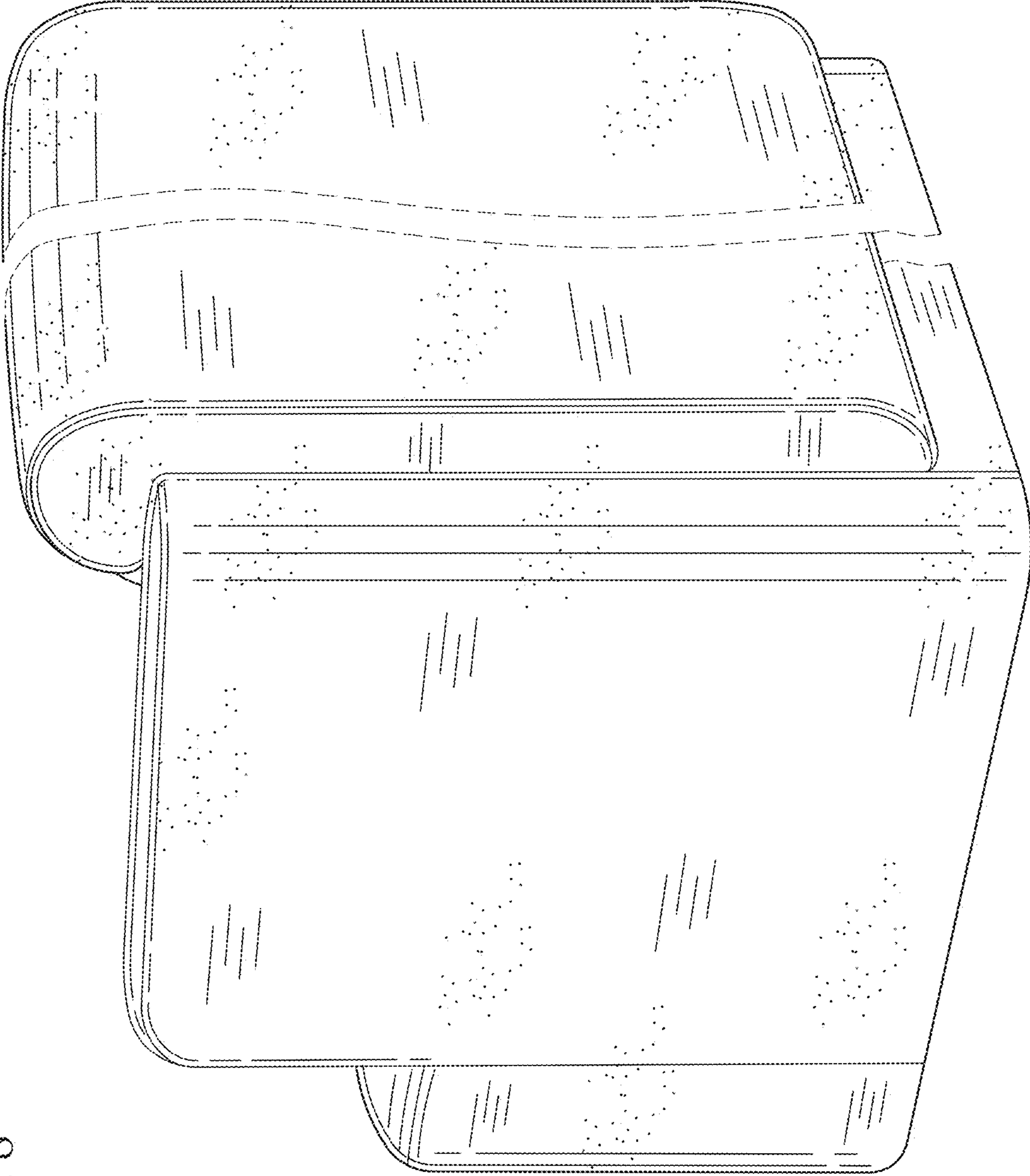

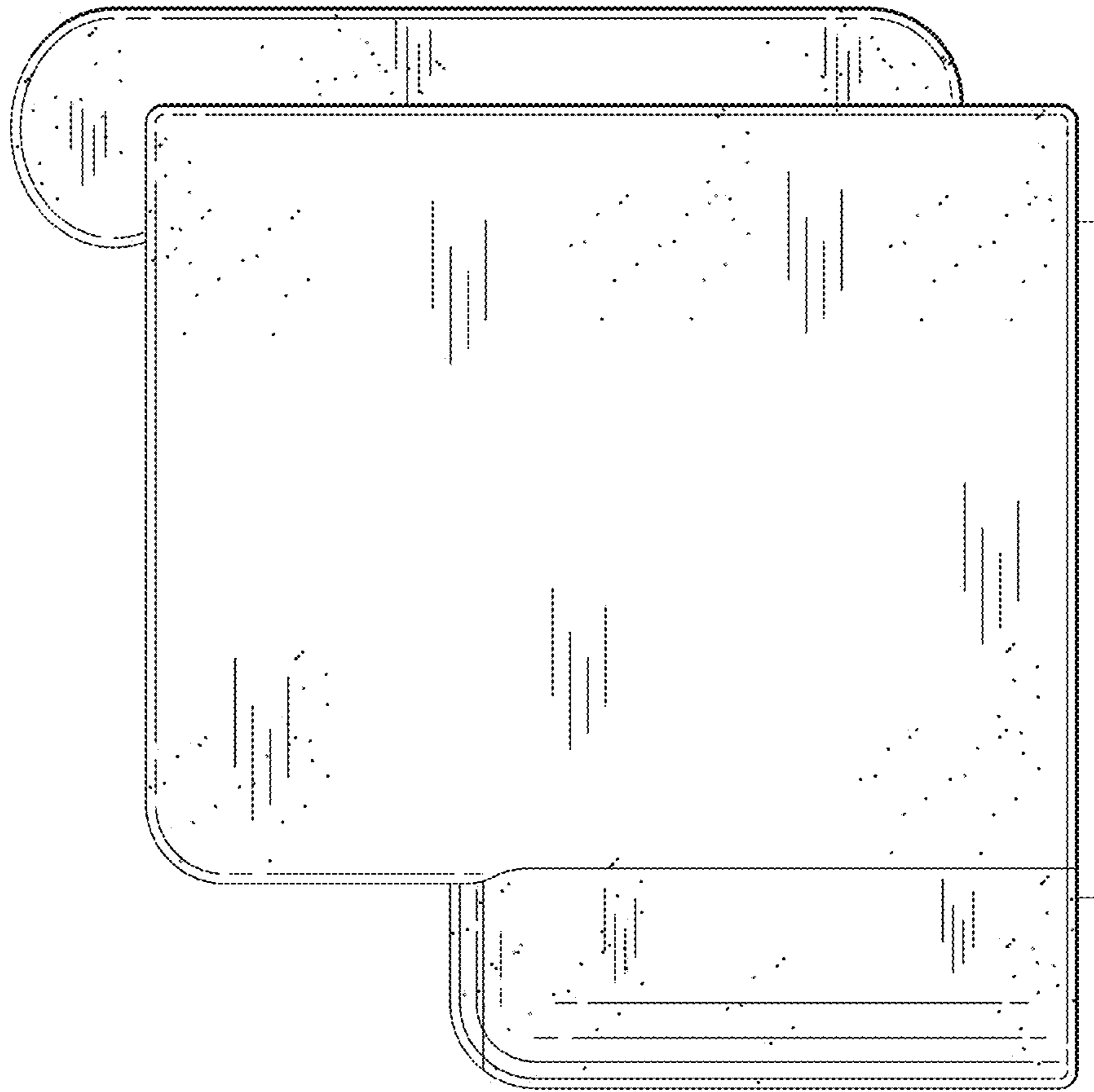

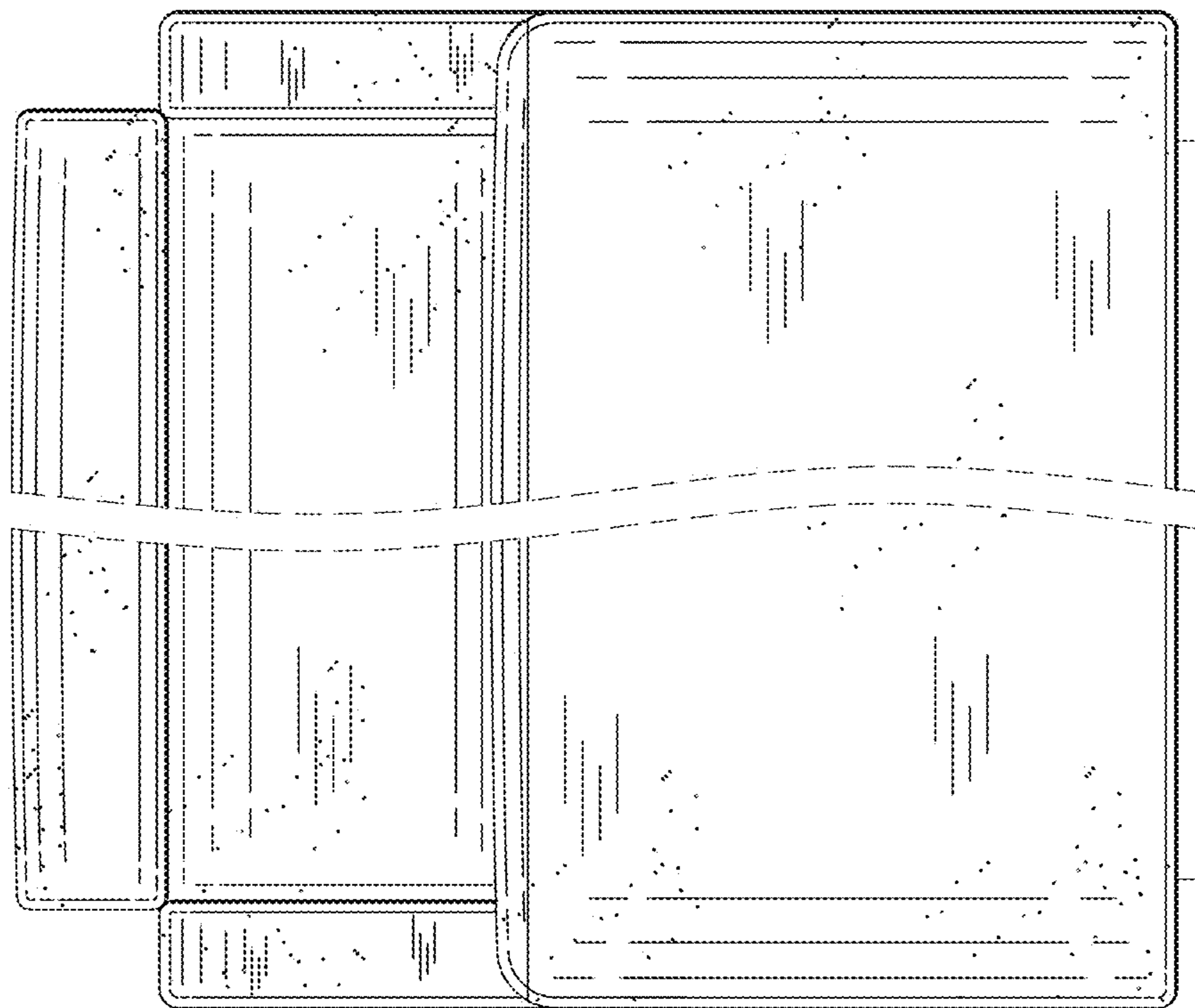

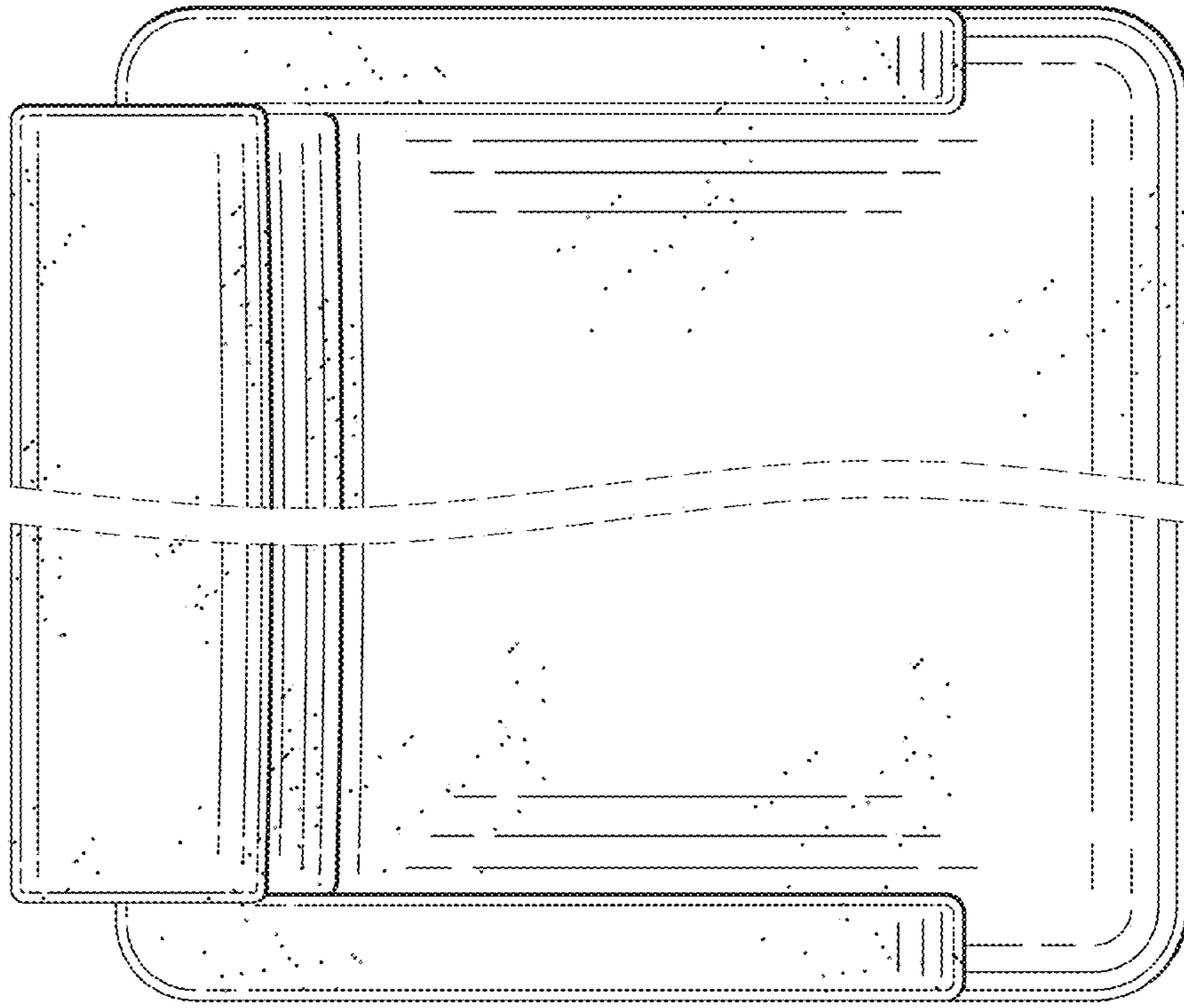
