The ornamental design for a cabinet, as shown and described.

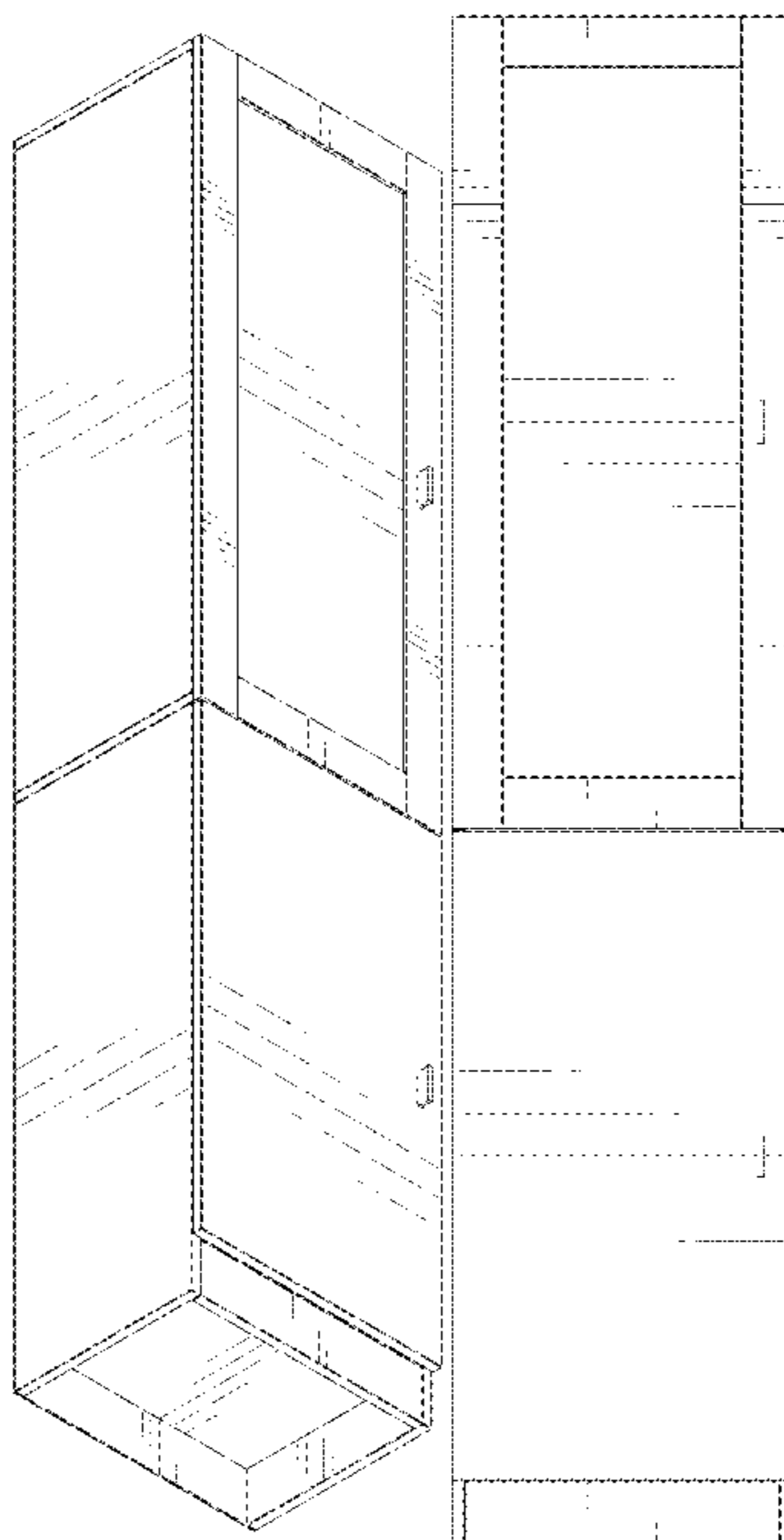
**DESCRIPTION**

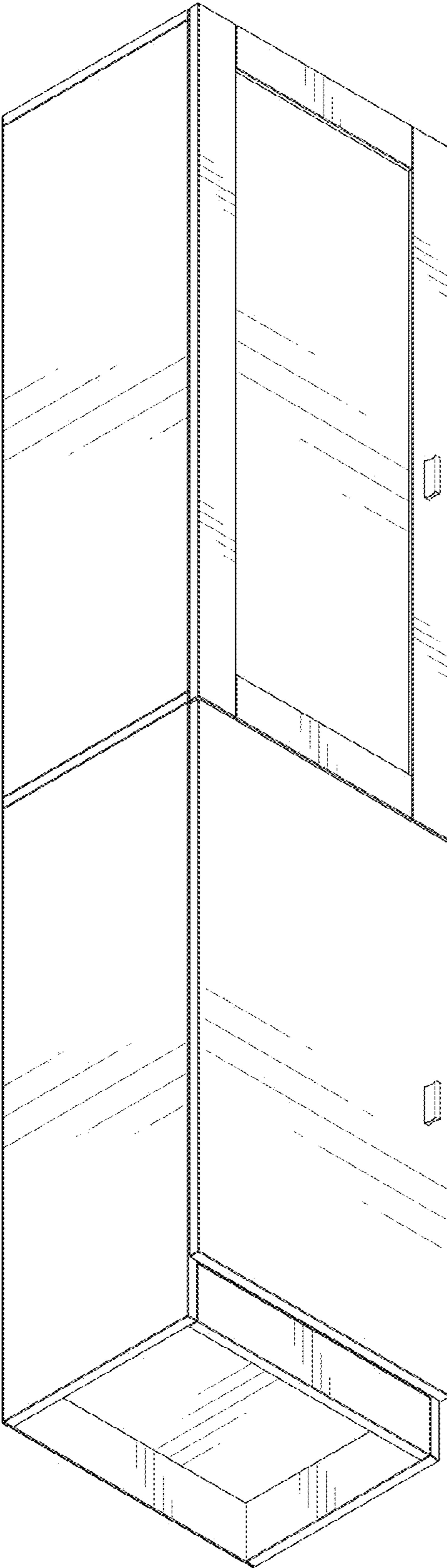

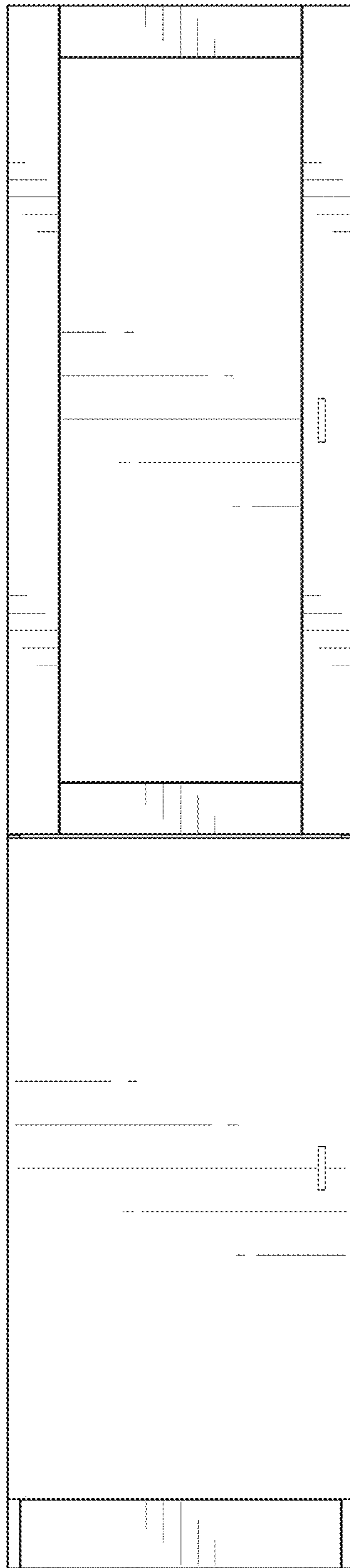

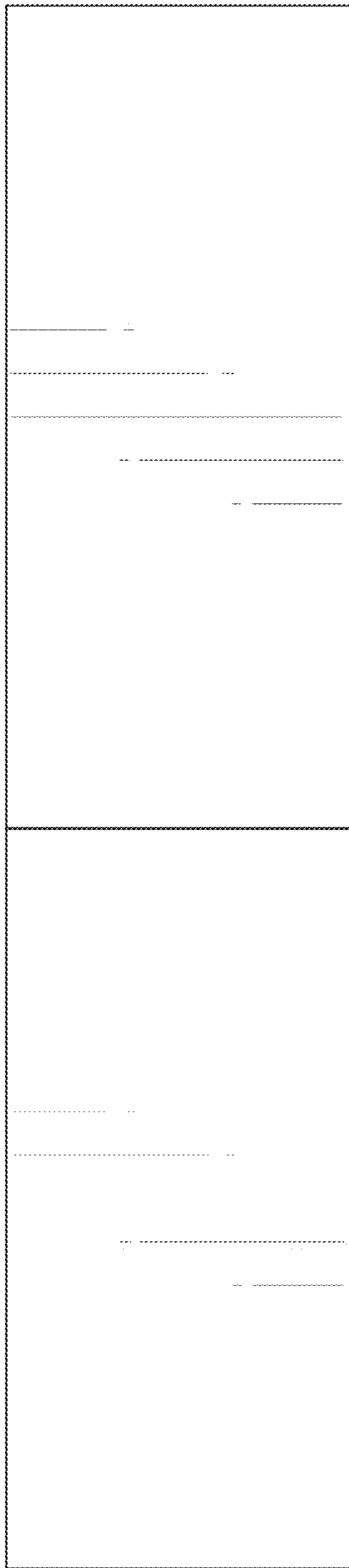

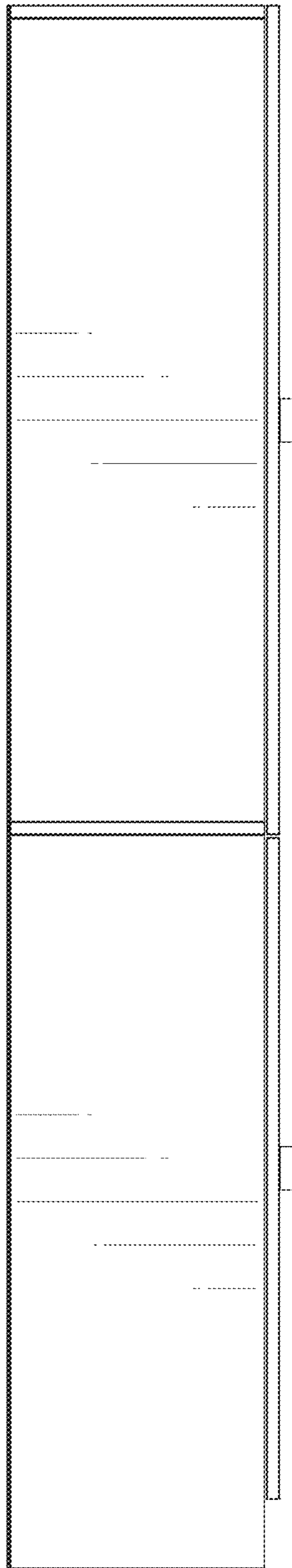

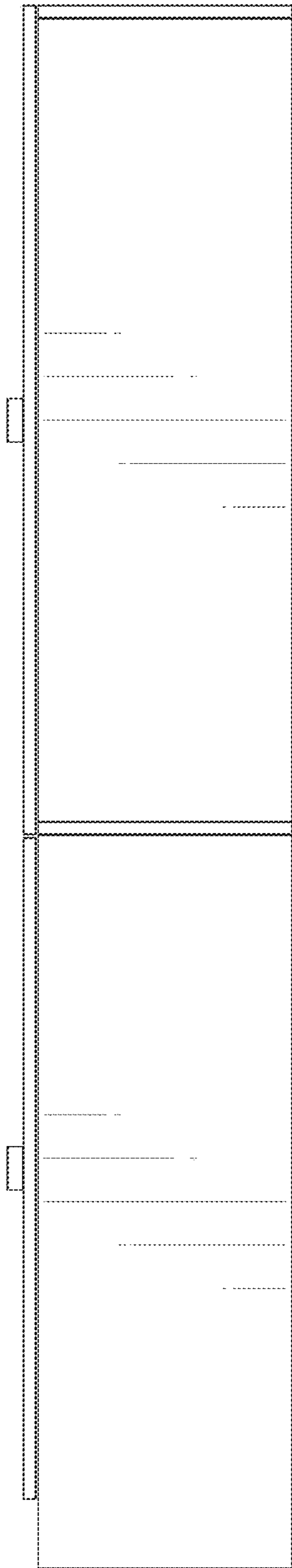

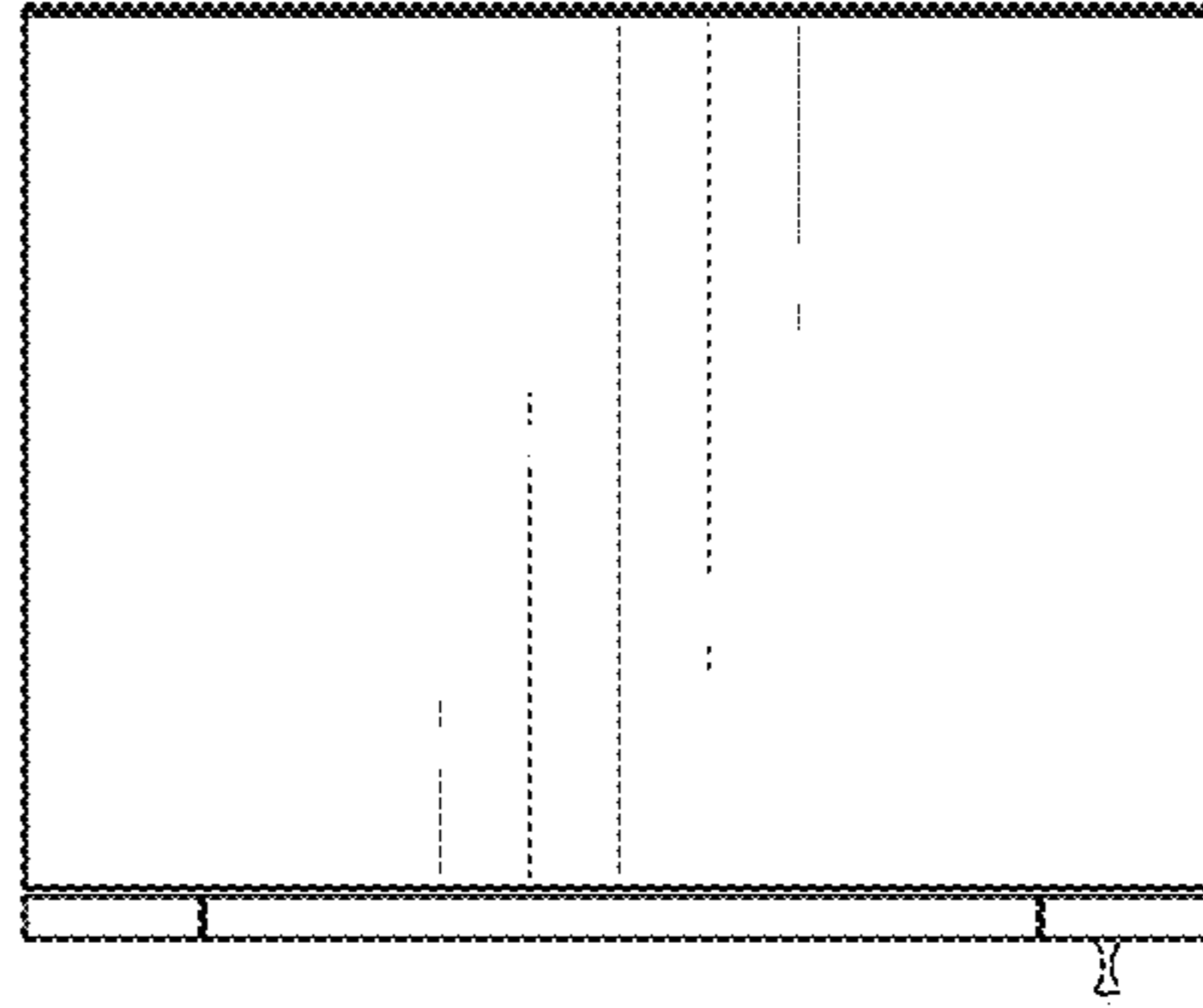

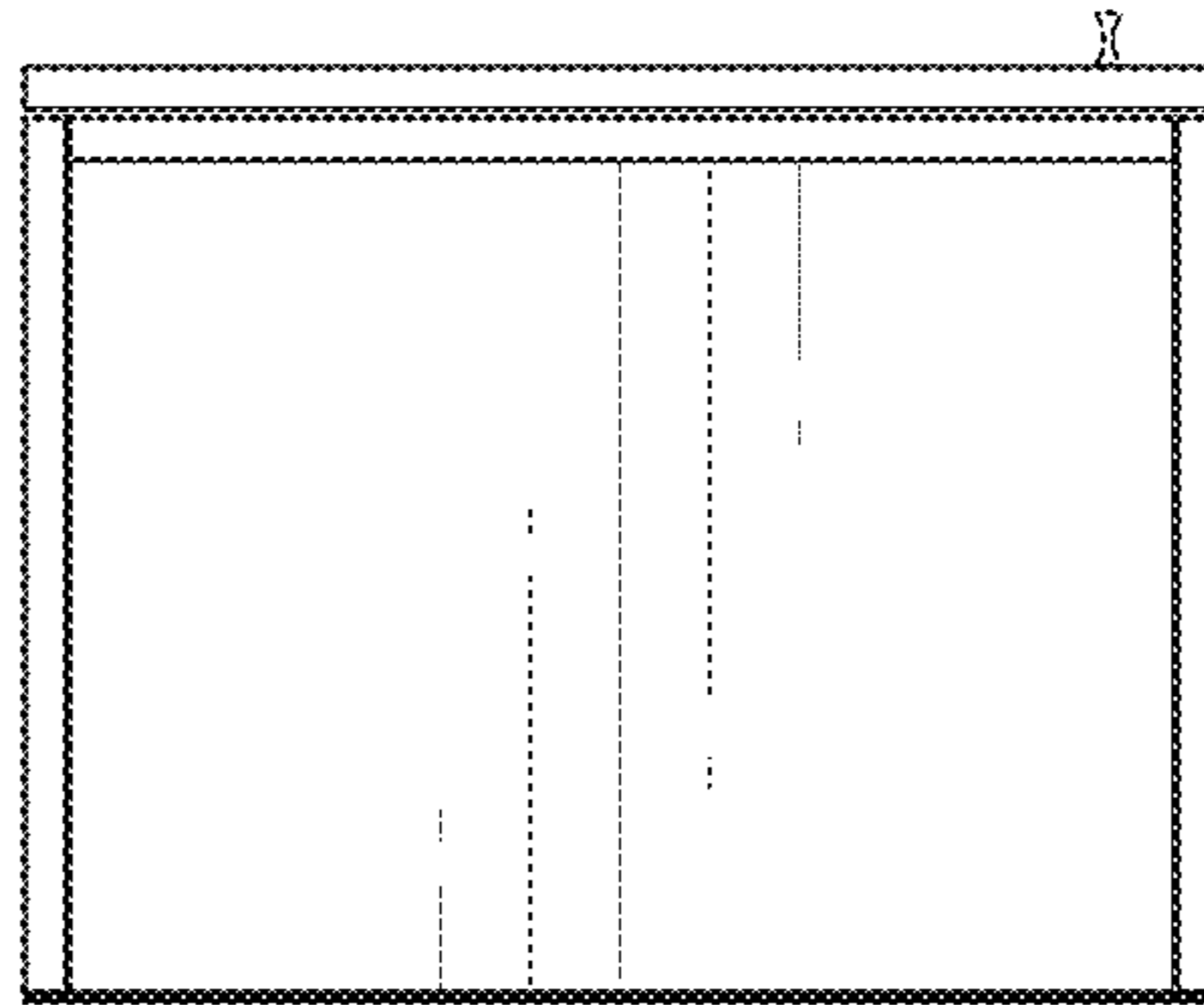

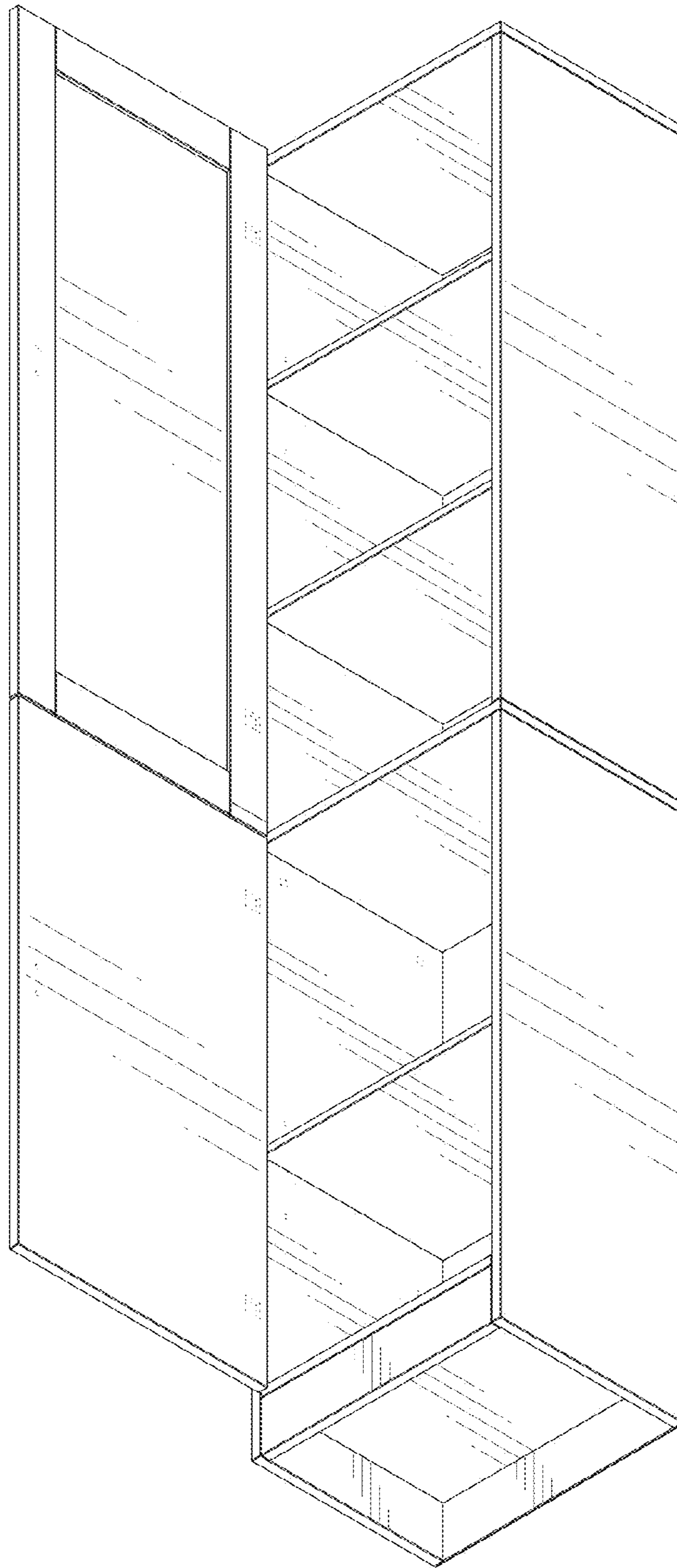
