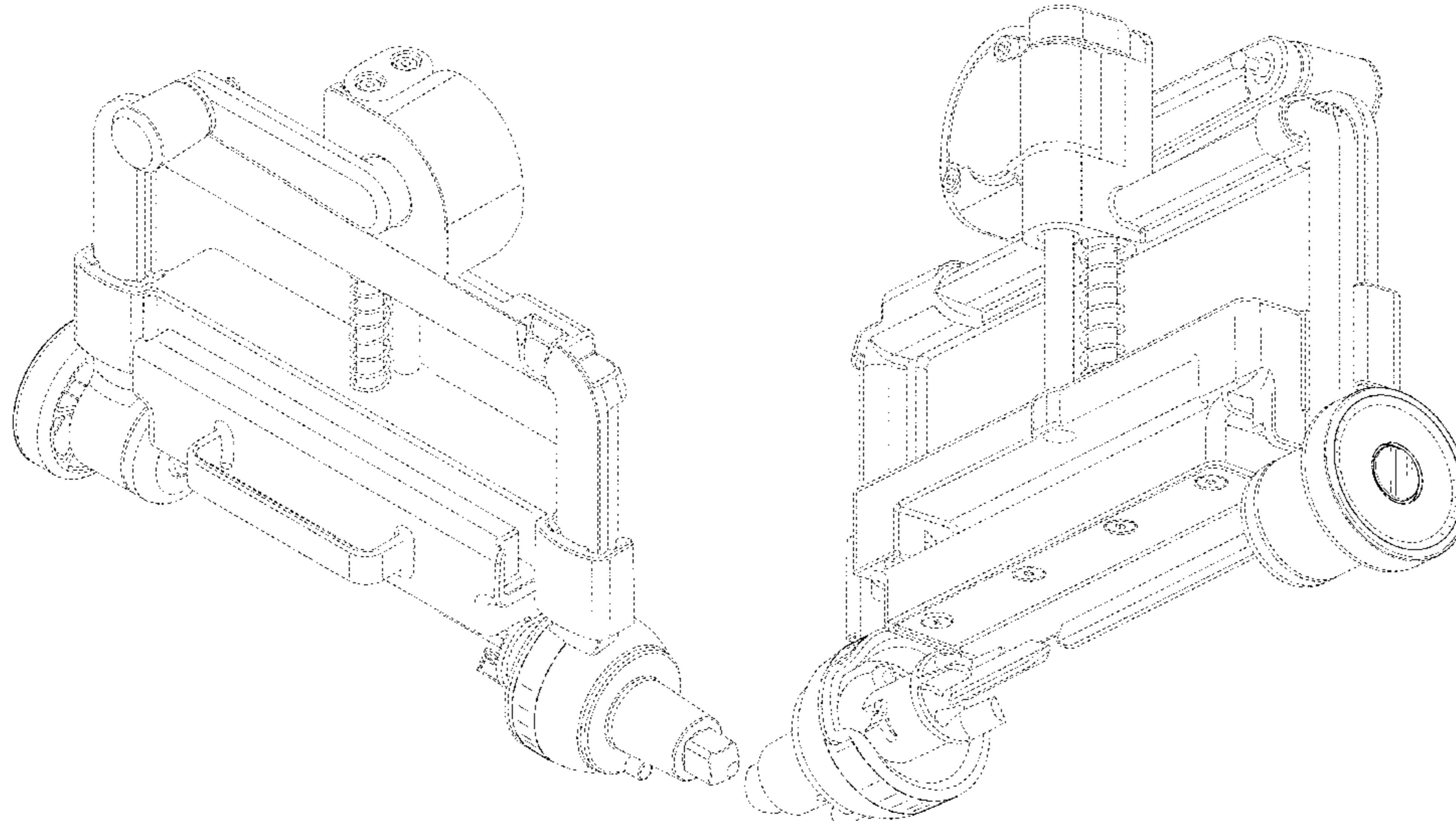
(57) **CLAIM**

We claim the ornamental design for a food processing attachment, as shown and described.

**DESCRIPTION**

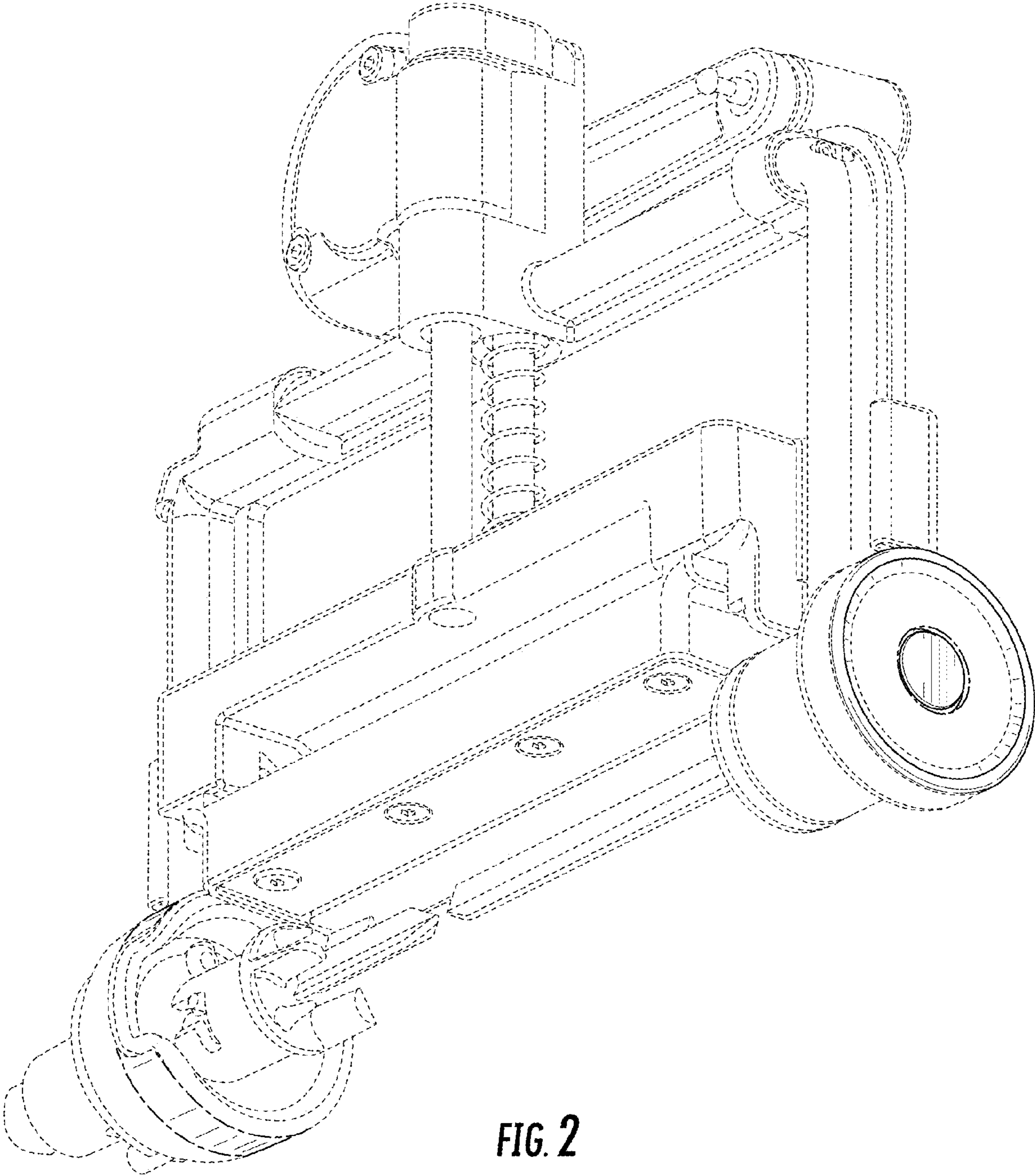

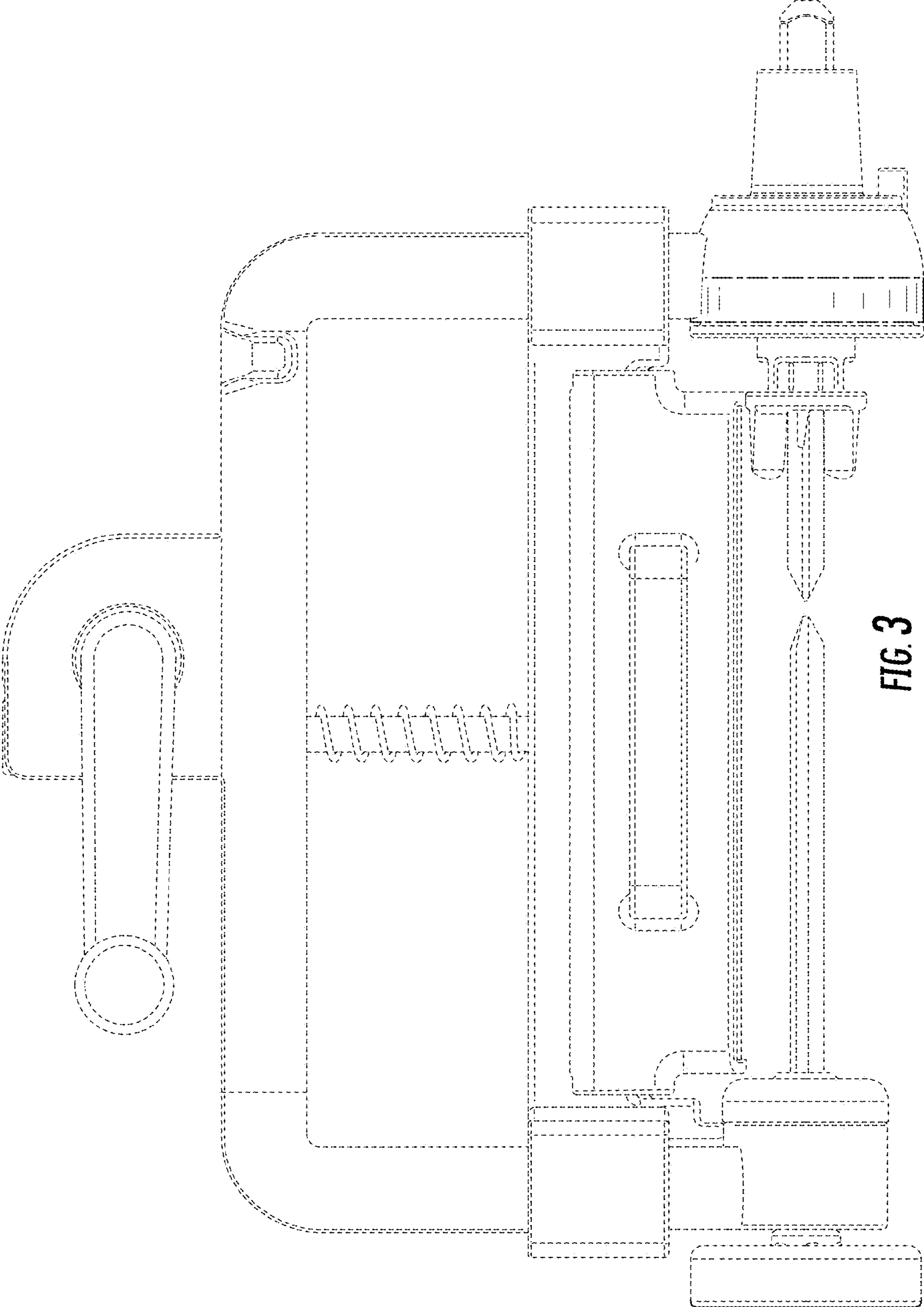

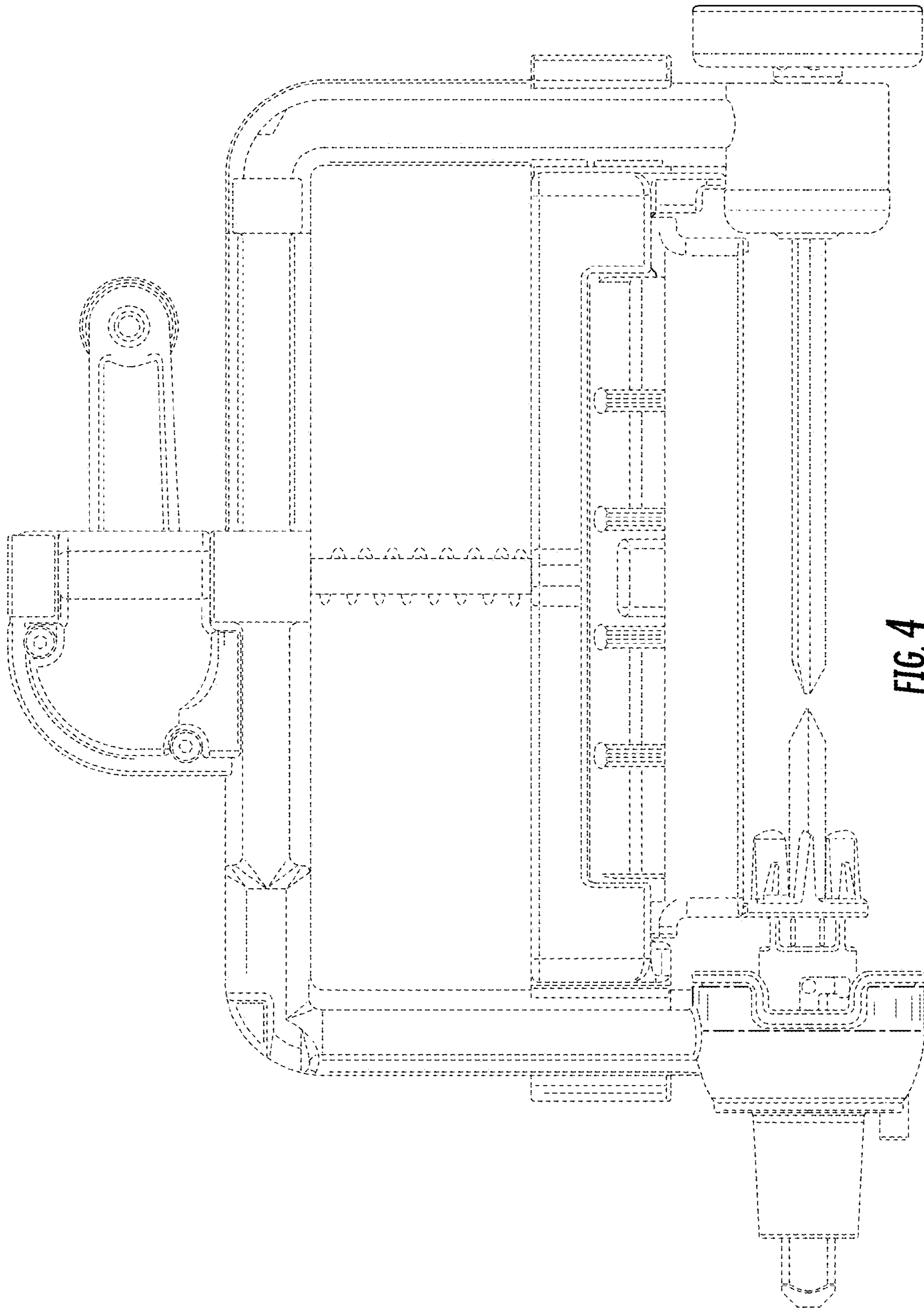

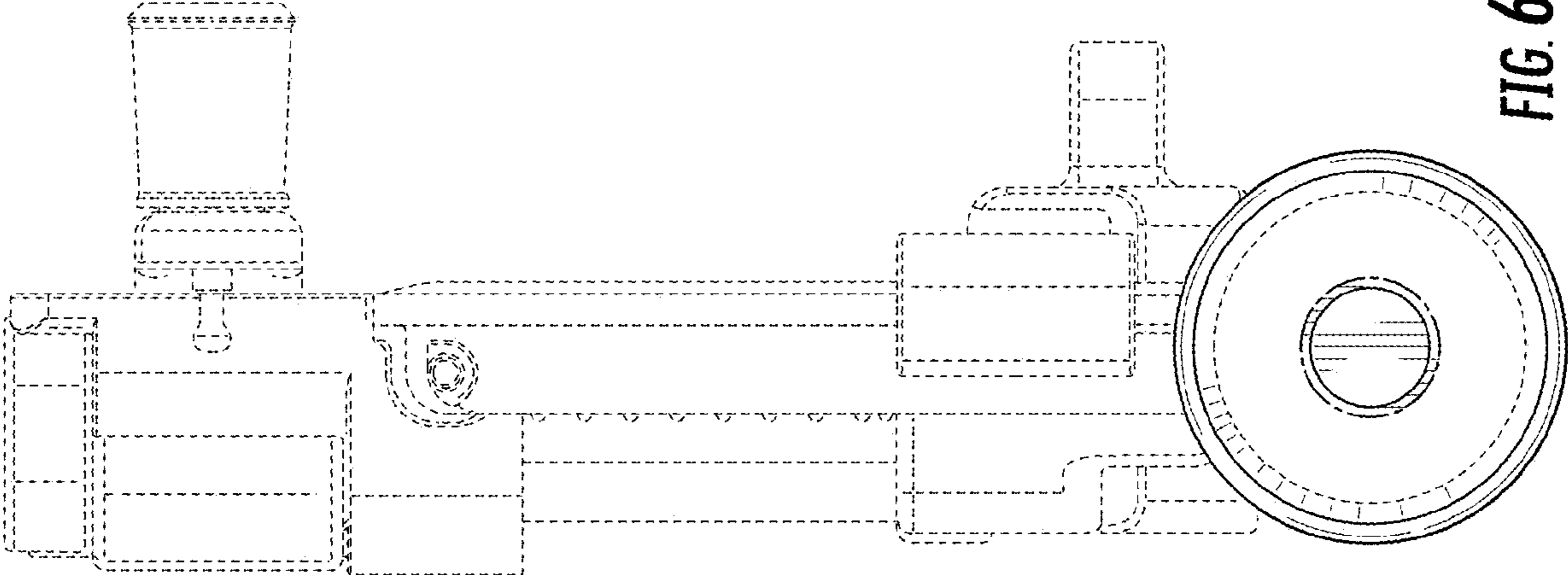

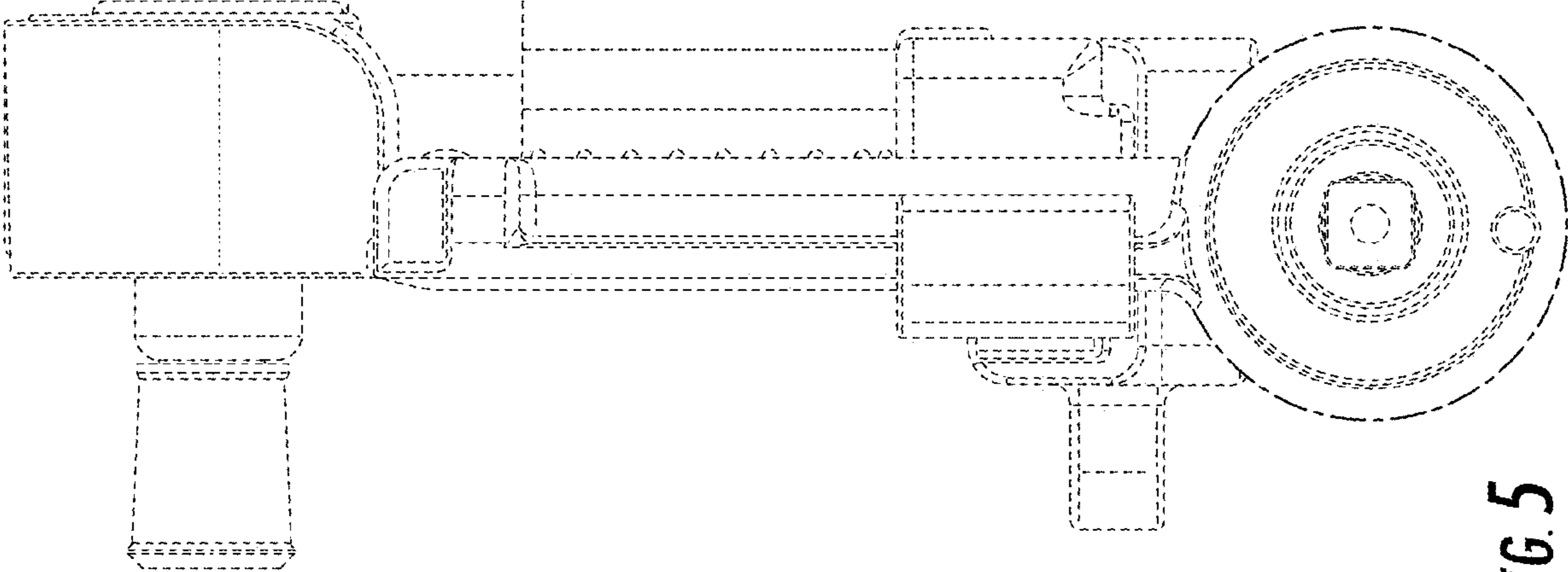

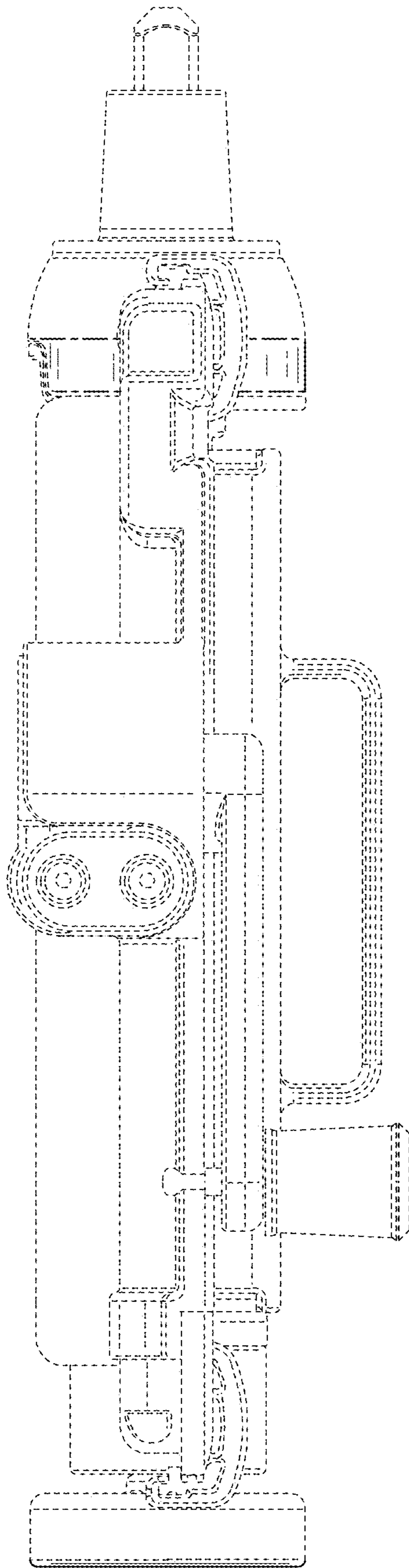

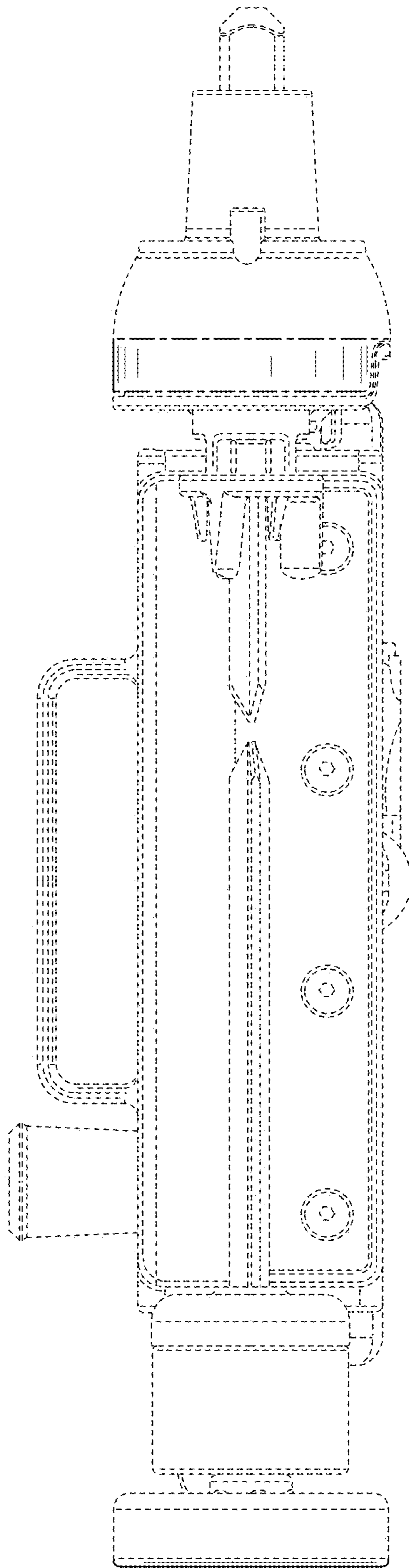
