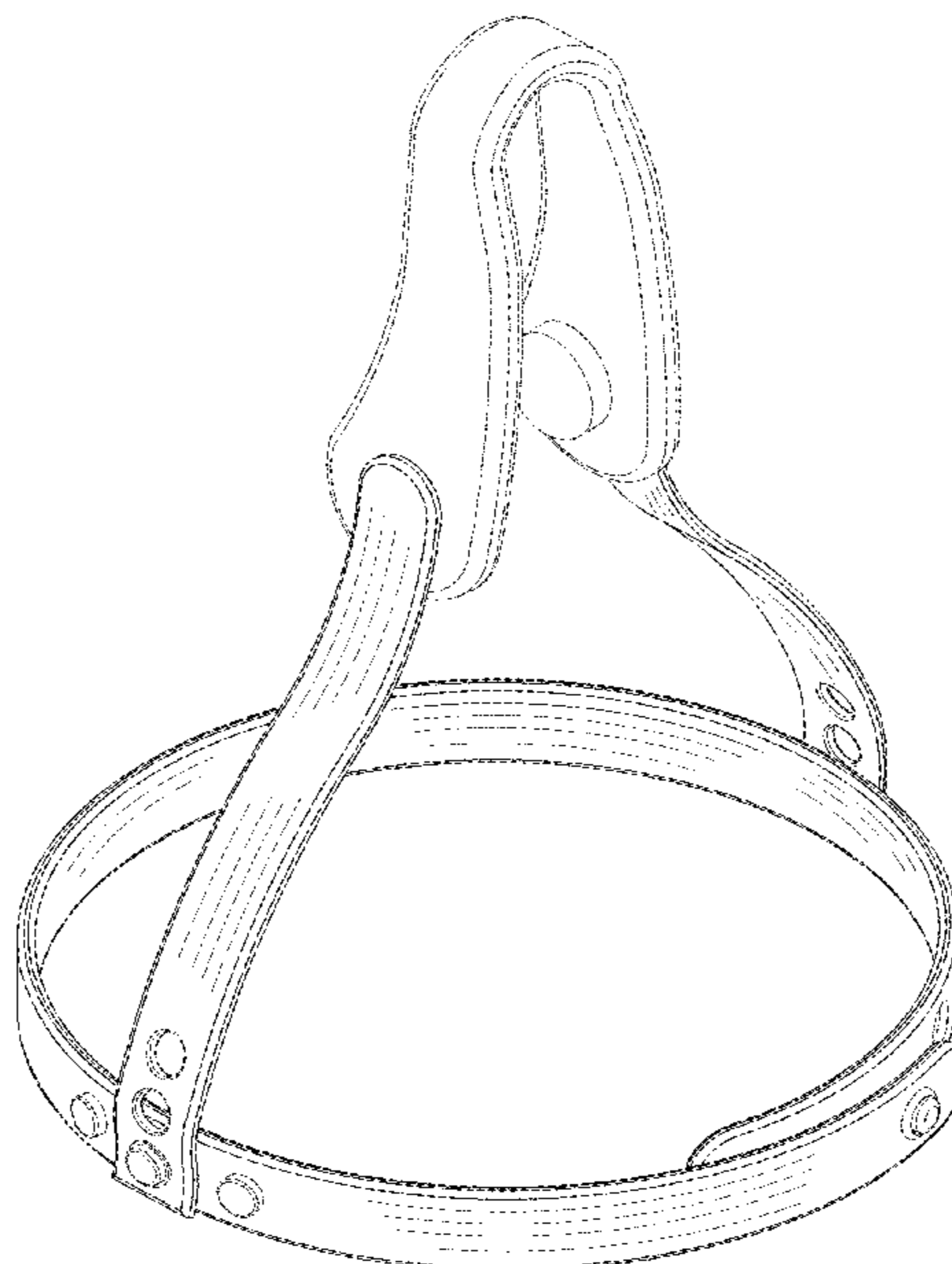

DESCRIPTION

FIG. 1 is a front elevational view of a hand acupoint clip fixing bracelet showing my new design; FIG. 2 is a rear elevational view thereof; FIG. 3 is a left side view thereof; FIG. 4 is a right side view thereof; FIG. 5 is a top view thereof; FIG. 6 is a bottom view thereof; FIG. 7 is a top, front and right side perspective view thereof; and, FIG. 8 is a bottom, left and rear side perspective view thereof. The broken lines in the drawings illustrate portions of the hand acupoint clip fixing bracelet which form no part of the claimed design.

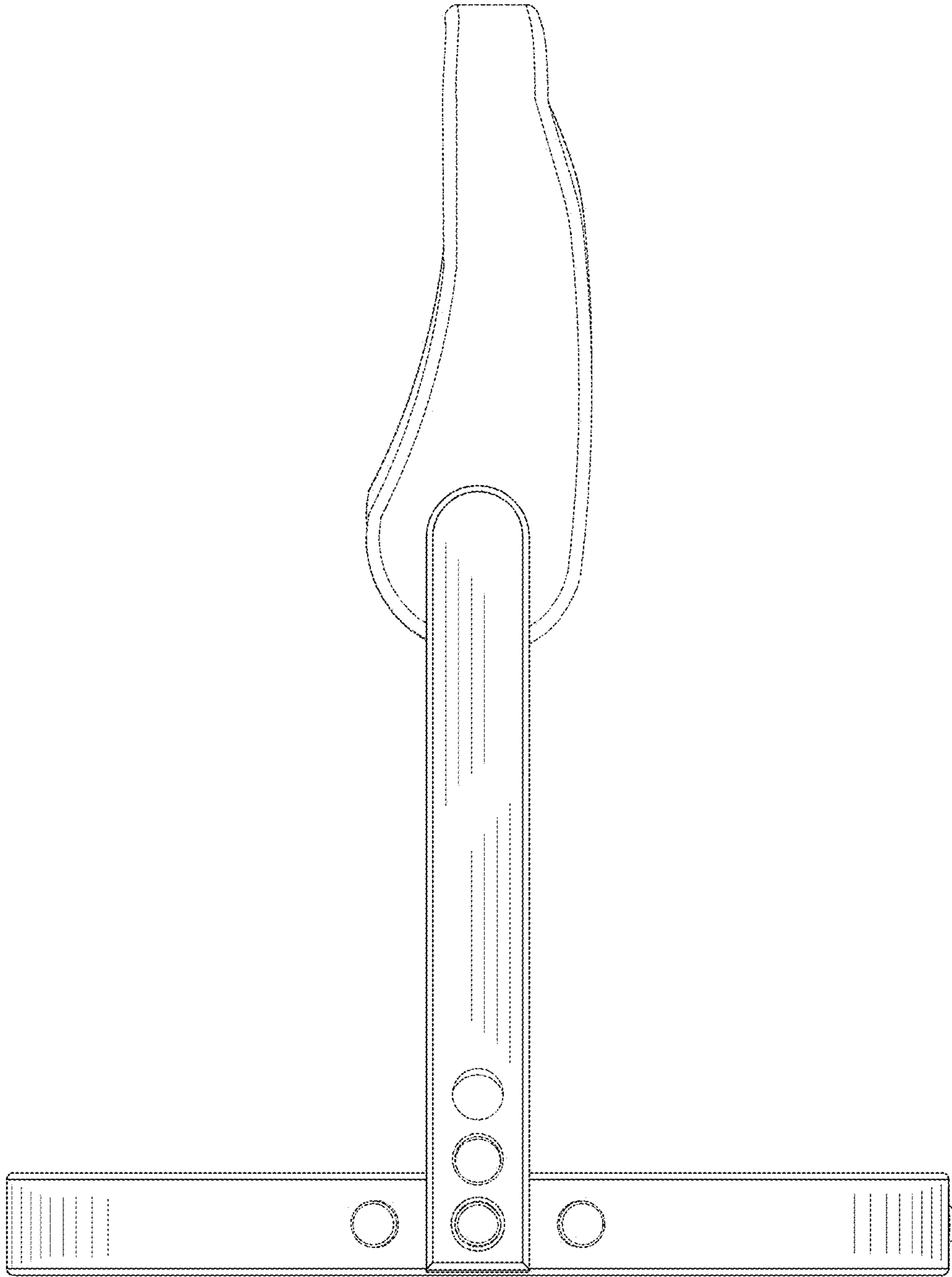

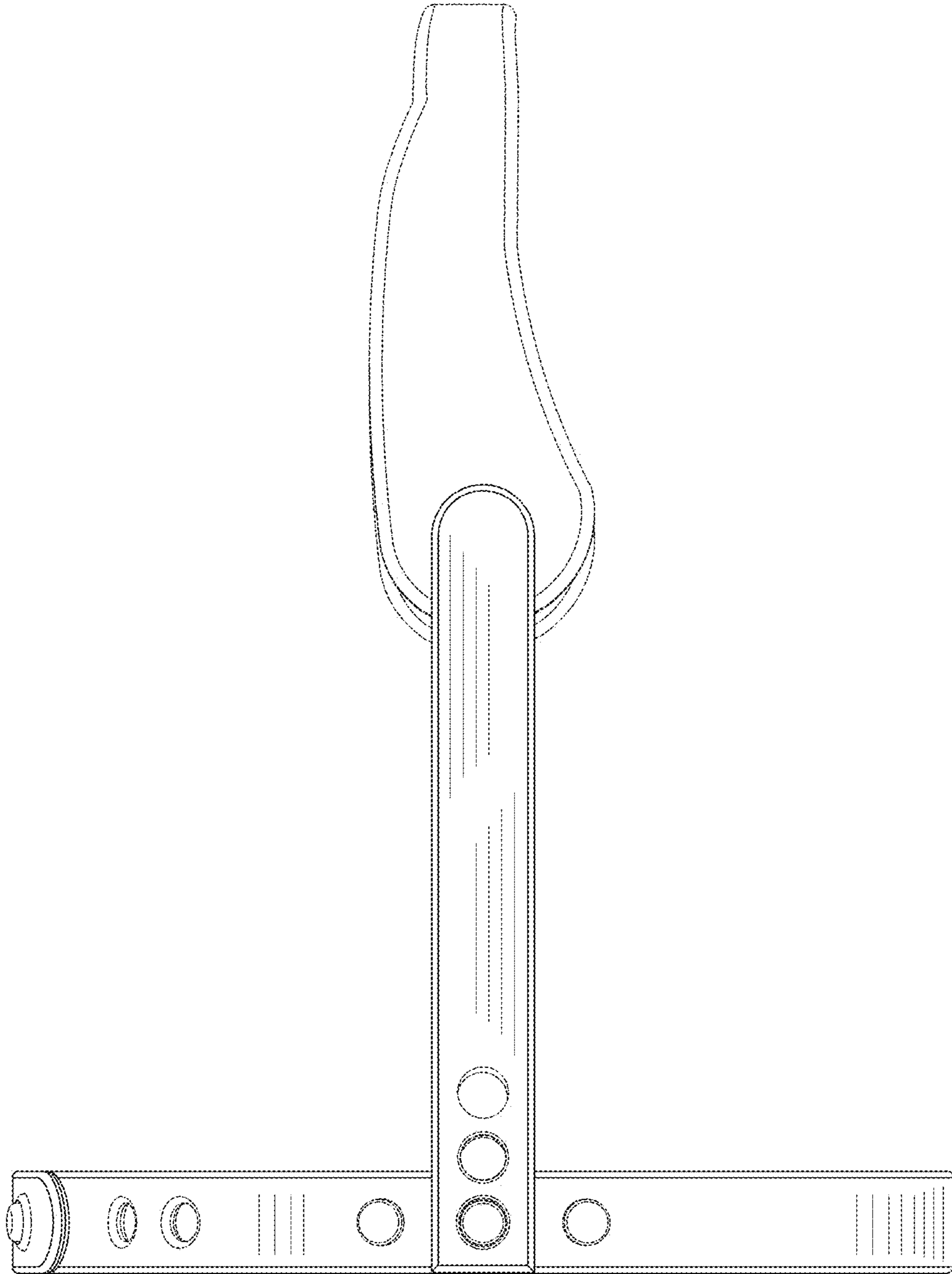

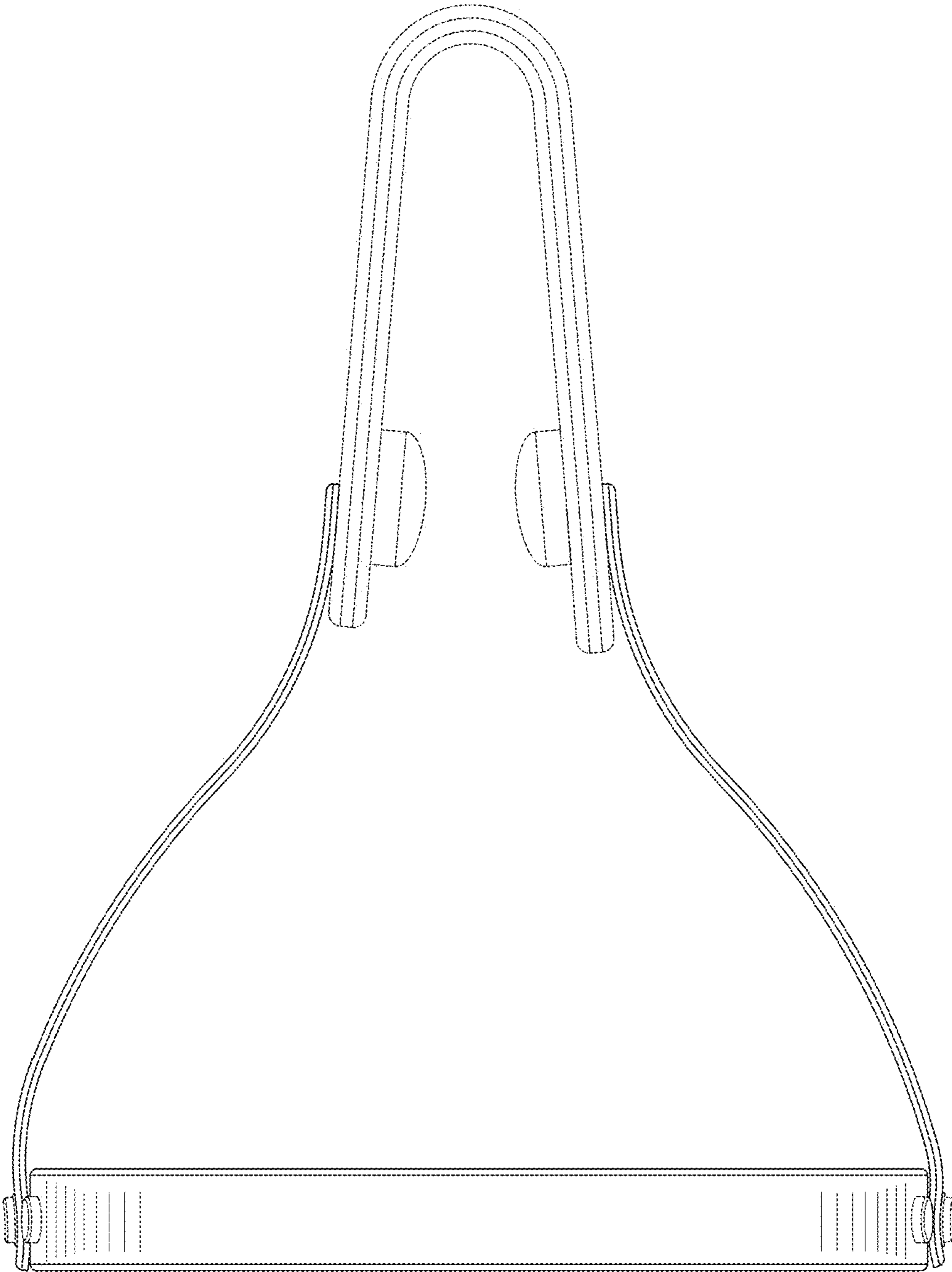

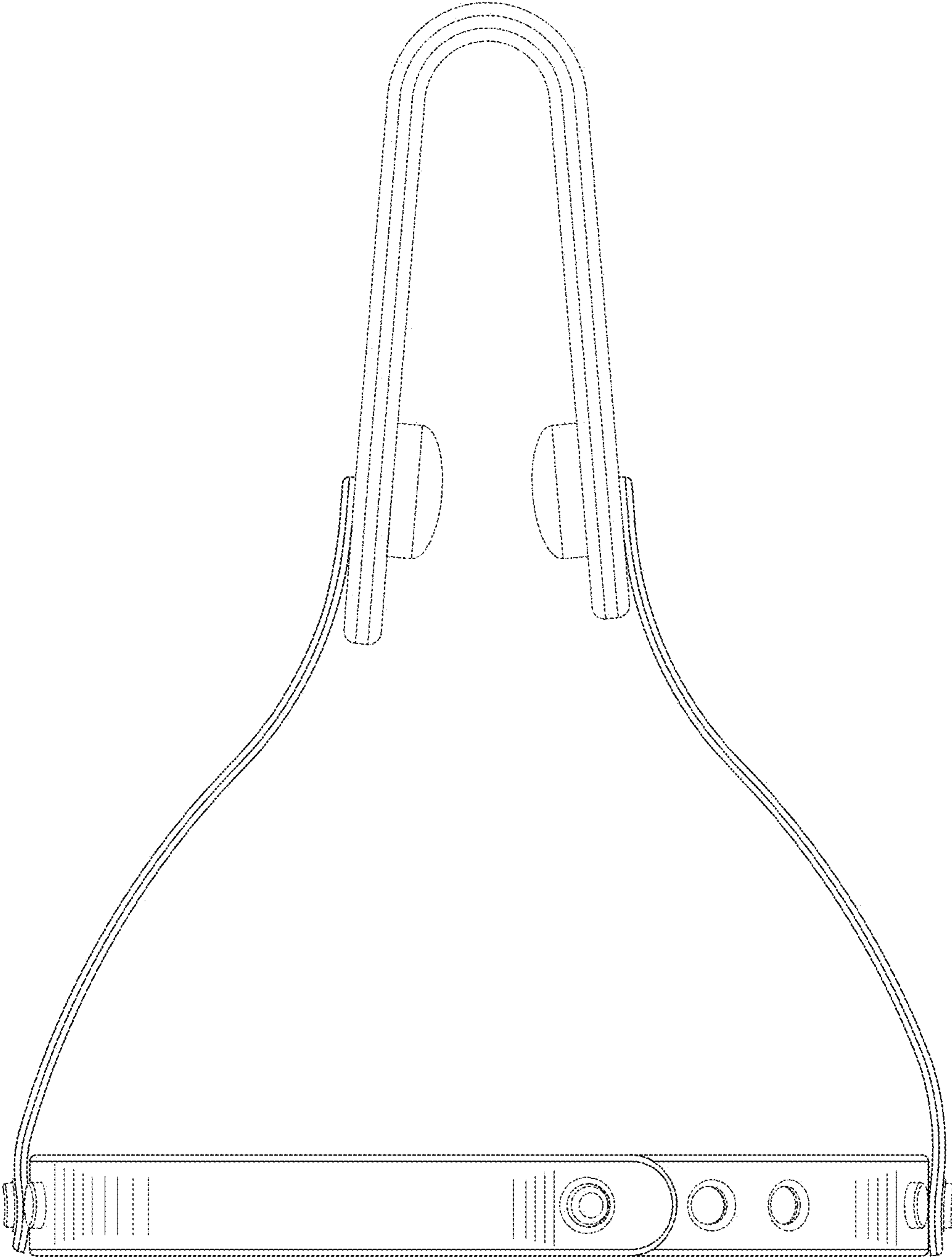

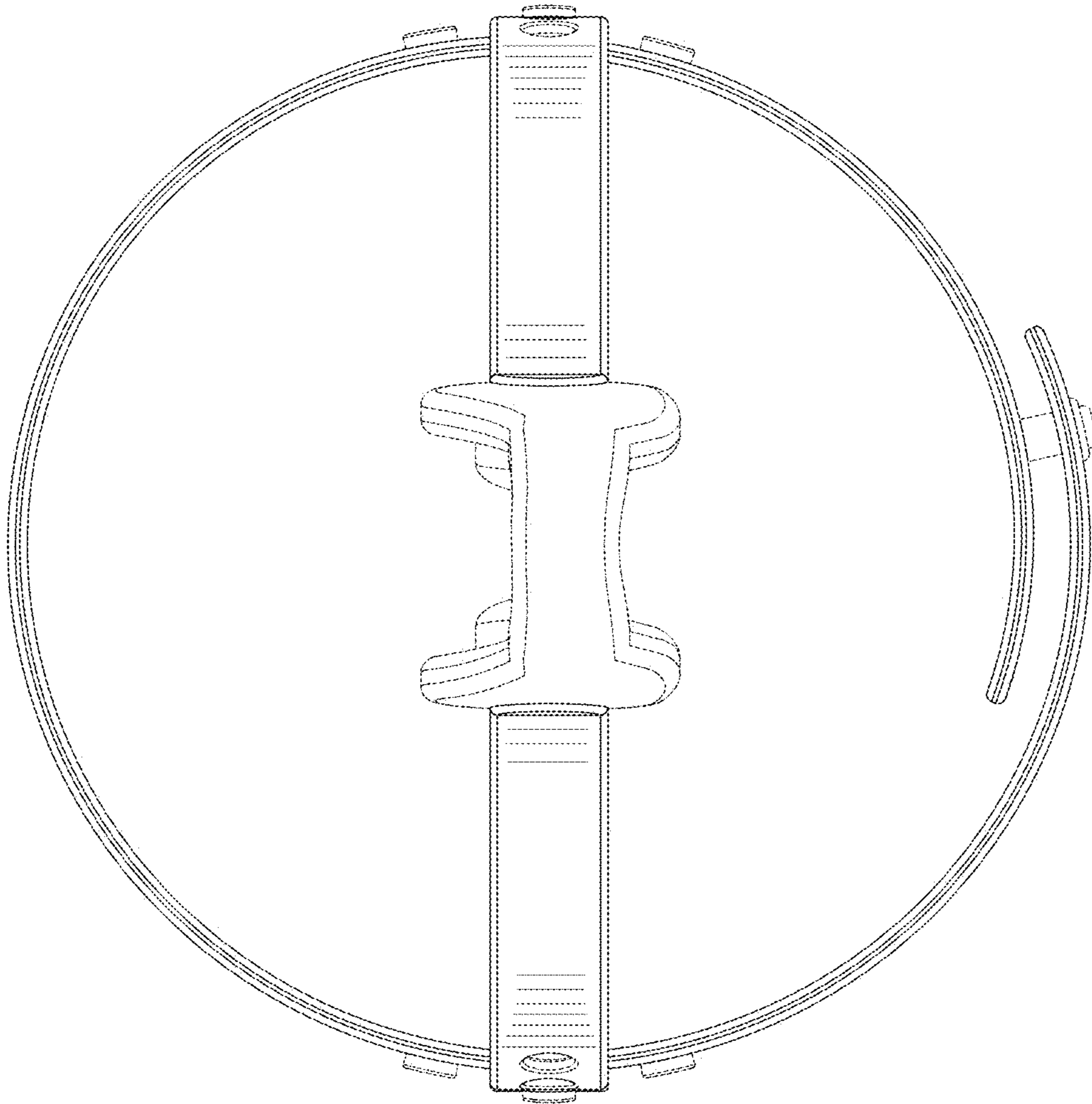

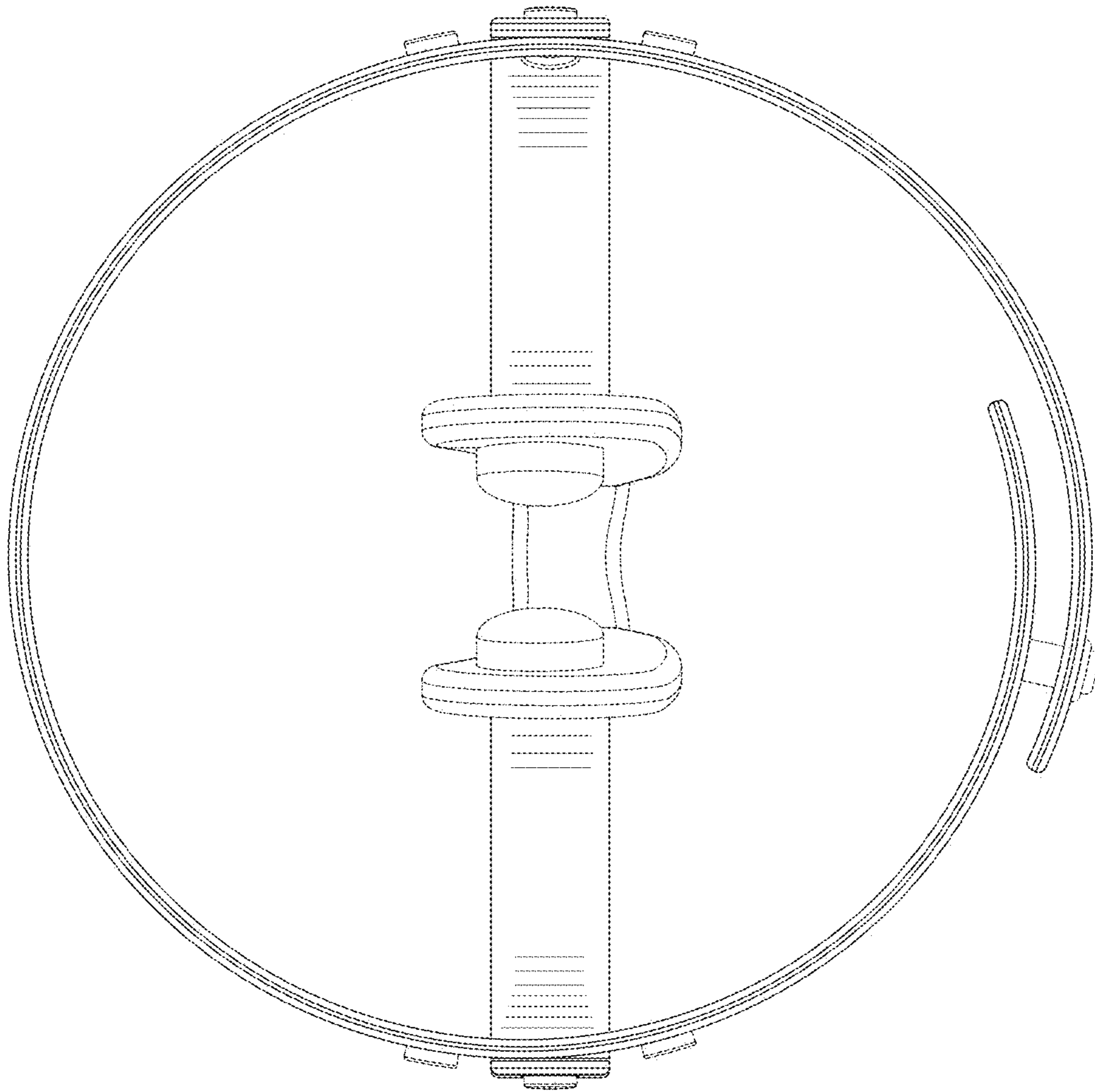

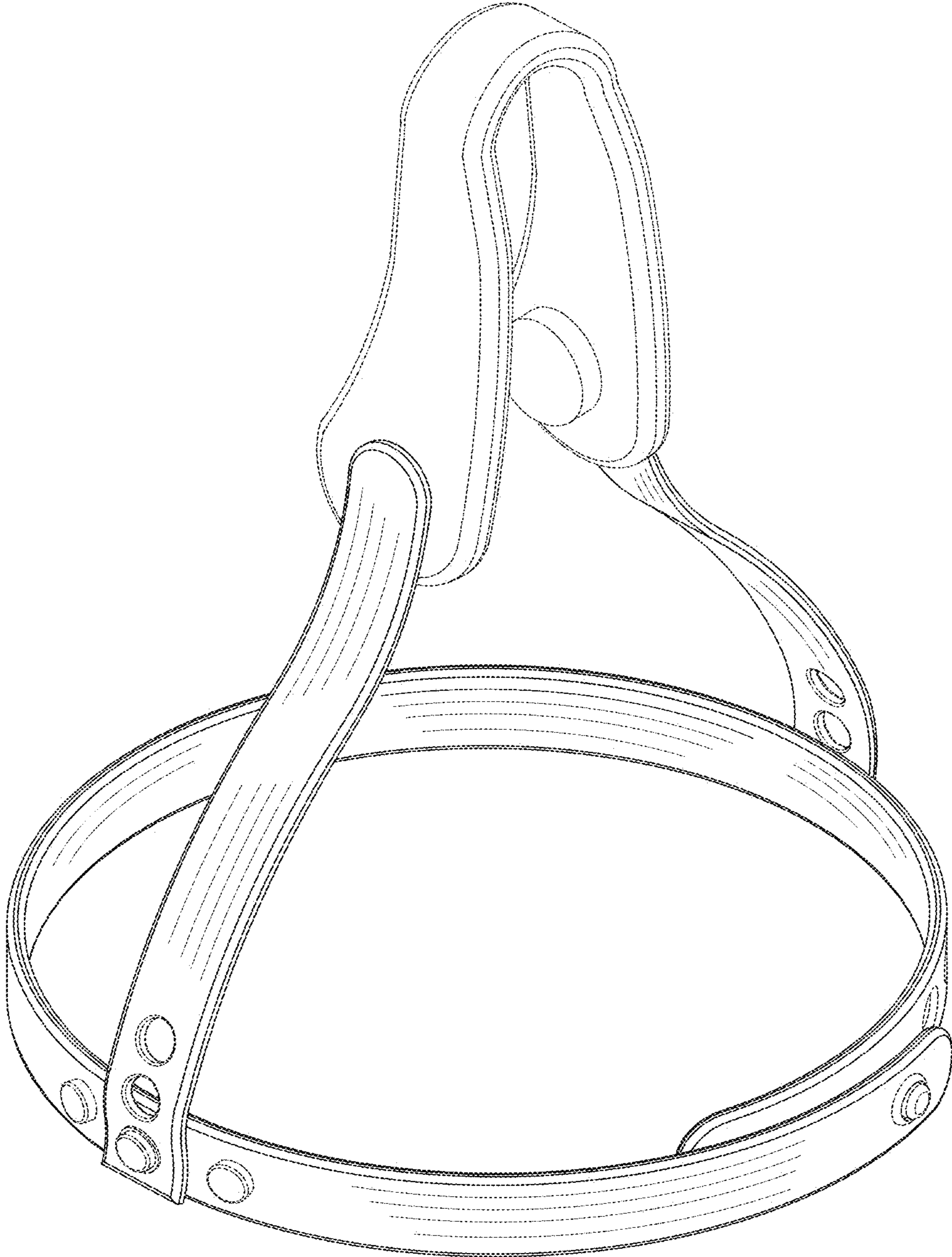

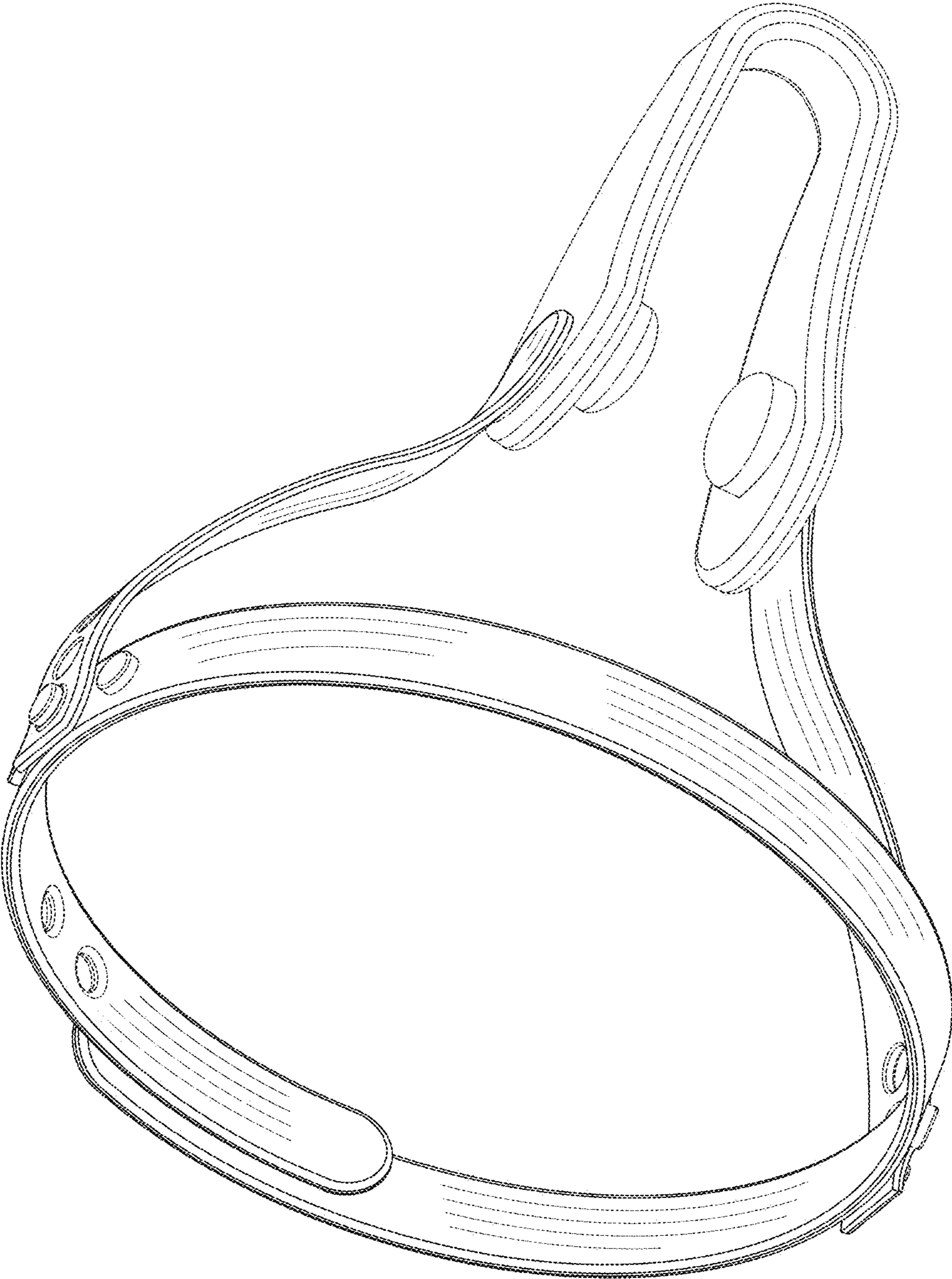
